Hurricane Lashes Gulf As Rebuilding Begins In Florida Territory

Miami Hit As Winter Tourist Season Begins

FOUR DIE FROM RESULT OF STORM

More Than 100 Persons Injured When Hurricane Sweeps Across Florida

Jacksonville, Fla., Nov. 5.—(AP)—The coast guard cutter Sarano reported to headquarters here today it was standing by a Hull line freighter aground off East Miami Beach, and the vessel is in no immediate danger.

The Hull line officers said the Betty was the only one of its boats in the vicinity.

Several vessels were standing by the ship which sent up rockets last night.

Miami, Nov. 5.—(AP)—A coast season Hurricane lashed at shipping in the Gulf of Mexico today as rebuilding began in a \$1,500,000 arc of destruction and death it carved across southern Florida.

Miami—Just opening the winter tourist season—was hardest hit.

Four deaths were attributed to the storm which headed to the mainland after striking the Bahamas Islands.

More than 100 persons were injured in its eight-hour blow from the east shore territory late yesterday to Cape Sable off Southwest Florida.

Two coast guard cutters were rushing to aid an unidentified tanker, which sent up flares 2-4 of a mile off Miami.

Commercial and pleasure crafts were pounded by waves and wind. Several boats were tossed high upon the land.

Homes and business houses lost roofs and windows, opening them up to torrential rains which combined with gale-driven tides to flood streets to a depth of three feet.

A 40 minute lull between the advance gale and the hurricane proper gave residents an opportunity to shutte windows and make their homes more secure thus reducing the human toll.

The fatalities: Duth Levy, 13, crushed by a falling beam.

Herman Thomas, 65, who succumbed to a heart attack while pleins shutters at home.

David Bachrach, real estate broker, also died of a heart attack.

An unidentified sailor about the steamship Harina, reported struck by a flying ventilator.

M. R. Harrison of the disaster relief commission and an observer of the Miami Herald's account damage exclusive of public utilities would approximately be \$1,000,000.

Farmers estimated the loss to citrus and other crops at more than \$500,000.

Bank Calls Issued As Of November 1 For National, State

Call Issued for National Banks by Comptroller of Currency; Hood Orders State Call

Washington, Nov. 5.—(AP)—The comptroller of the Currency issued a call today for the condition of all National banks at the close of business Friday, November 1.

Under the law the comptroller is required to issue at least three calls a year for statements of condition. He may issue as many more as he deems necessary.

RUSSIA ASKS BORDER FORCE

Second Note Delivered To Japanese Government

Moscow, Nov. 5.—(AP)—Russia again has asked the Japanese government to discuss officially a border patrol clash between Soviet and Japanese Manchoukuan soldiers last month.

The Soviet ambassador delivered a second note to the Japanese foreign office repeating an offer to set up a fixed commission to investigate the incident.

Prolonged discussion "must cast an influence on the relation between the USSR and Japan" said the note.

Japanese Foreign Minister Hirota, after receipt of the first note, presented a memorandum on October 25 to the Soviet Ambassador, denying the Japanese Government was involved. It said the protest should have been directed direct to the Manchoukuan Government.

Soviet authorities expressed surprise in the second note at the Japanese action. They said that in as much as the Japanese have taken responsibility for the military program of Manchoukua they should not decline to answer the first protest directly.

Japanese as well as Manchoukuan soldiers were involved in the clash, the Soviet officials declare.

One Soviet officer was killed and another officer and soldier wounded in the encounter. The disorder began, Japanese say, when a Soviet patrol fired without warning on what the contend "invading" troops.

The Japanese have denied their detachment "invaded" Soviet territory because the border line had been fixed by treaties with China and that the treaty was recognized by Manchoukua.

County to Observe Armistice Holiday By Closing Offices

Board of Commissioners Decide to Close All County Business for Day November 11

The county board of commissioners at their regular monthly meeting Monday night acted on a number of routine matters and made plans for the observance of Armistice Day, November 11.

The commissioners voted to observe the day by closing all county offices for the day.

A program of celebration is being arranged by the local post of the American Legion. State Senator Paul D. Grady has an invitation to deliver the principal address and a large number is expected to attend the celebration.

No announcement had been made today as to whether the city offices would be closed for the day.

Mrs. Tripp is survived by five daughters, Mrs. R. L. Moore and Mrs. F. O. Taylor of Greenville, Mrs. W. H. Laughinghouse and Mrs. R. L. Dudley of near Greenville, and Mrs. W. I. Austin of Aurora; two sons, Henry and J. A. Tripp of near Greenville; one sister, Mrs. John Moore of Falkland; one brother, Richard Harris. Fifty grandchildren, forty great grandchildren and one great, great grandchild also survive.

Grandsons will serve as pallbearers, while granddaughters were flower bearers.

A mayor to succeed the late Roy C. Flanagan will be appointed by the Greenville Board of Aldermen at a special meeting Tuesday night, November 19, the board decided in session last night.

Mayor Flanagan died last week. In the interim Mayor Pro-Tem H. H. Duncan will act as the city's chief executive. A number of men have been prominently mentioned to succeed Mayor Flanagan. Among them are Mr. Duncan, M. K. Bloom, Judge Dink James, W. A. Darden, W. J. Bundy, W. E. Hooker, Will Wiedese and others.

The Aldermen, in the special called meeting last night, appointed a committee to draw up a resolution of respect to Mayor Flanagan. The committee is composed of Mrs. J. L. Hassell, L. B. Fleming, Joe Taff and A. C. Tadlock. The resolution of respect will be sent to the family, to the press and to the North Carolina League of Municipalities, of which Mayor Flanagan was honorary vice president.

It is presumed the committee will have the resolution drawn up for approval of the full board at the regular monthly meeting Thursday night of this week.

Mayor Pro-Tem Duncan will preside over the meeting Thursday.

RYAN IN PLEA FOR RED CROSS

Points Out National Organization Came To Aid Of Pitt

Pointing out that Pitt county was one of the few sections the National Red Cross organization sent money into aid in time of distress, Chairman W. A. Ryan of the local Red Cross roll call, today called upon the people of the county to subscribe to the organization.

"Money and help were sent to Pitt county by the American Red Cross early this fall when a terrific storm struck a section across the river from Greenville and destroyed the homes and furniture and 'clothes of helpless tenant farmers," Chairman Ryan said. The county, therefore, should be glad of the opportunity to subscribe to the cause which came to the rescue in time of need.

"The Pitt County Chapter was not called upon to spend any of the money it received from Roll Call in the County last year. National Red Cross is leaving that money in the County to carry on Home Hygiene and Nursing Courses, Life Saving instruction, First Aid courses, and providing first aid kits to the Schools throughout the county.

"In this way Pitt County can feel that Red Cross has come to mean something in Pitt County other than an organization to collect money for helping other sections—as noble as the idea of helping other sections of the country is. We are indebted to Red Cross locally as well as in our national feeling of charity for sufferers that Red Cross—the Greatest Mother of Them All—is helping all over the world," he said.

"This is but a part of what Red Cross is doing the Chairman said for this is only one part of the local angle he insisted. There is much more to tell and he said he hoped he would have the opportunity to tell it.

WEED AVERAGE COUNTY COURT \$23.50 MOND'Y DOCKET HEAVY

Total of 51,538,250 Pounds So Far This Season

With the sales on the Greenville tobacco market to date this season already more than those for the entire season last year, offerings on the local market continued high today.

Yesterday's official average was \$23.50 per hundredweight for 1,261,836 pounds sold. A total of \$296,567.78 was paid weed growers by the Greenville market for the day's sales.

So far this season 51,538,250 pounds of tobacco has been sold here, surpassing the total for last season. The average through yesterday was \$21.35, more than the party price.

The local market has paid out during the season a total of \$11,008,259.85.

While Wilson surpassed the local market last year in number of pounds sold, the local market paid out more money.

Highway Funds Denied Palmetto Road Department

Washington, Nov. 5.—(AP)—South Carolina was reported today in government quarters to have been cut off from further participation in Federal Aid Highway funds as a result of Governor Olin D. Johnson's military control of the state highway department.

An official said no further awards of contracts would be approved until the dispute is settled in a manner acceptable to the Bureau of Public Roads here.

This tied up \$7,000,000 in federal funds that had been allotted to South Carolina.

THE NATIONAL WHIRLIGIG News Behind The News

Washington By RAY TUCKER PATIENCE Secretary Hoover is quietly reorganizing the Department of Commerce so as to make it a go-getter for foreign trade. He is filling key posts with business experts instead of academic economists. It marks a belated recognition by the administration that it must prepare for the international trade for foreign markets.

Mr. Roper has played a rough game. When he took office his department's high-pressure methods of stimulating foreign business were under fire. Our commercial attaches abroad had acted as saboteurs and bill-collectors for American firms. They had won us active ill will in several places. President Roosevelt promptly curbed these activities by vesting almost complete control of foreign commercial activities in Secretary Hull and consular officials abroad.

Secretary Roper, a good political soldier, did not tume and fuss. In fact, he agreed with this policy of soft-pedaling self-assertion methods. He made no protest when inexperienced consuls were given charge of the problem of informing American manufacturers on potential markets abroad. But he bided his time.

CHANGES The administration is curtailing the friendship of business men and manufacturers who seek foreign markets. It recalls that Herbert Hoover nominated himself by placing the Department of Commerce at the service of exporters. It would like to repeat that trick for 1936 as an offset to administration policies which organized business resents.

Mr. Roper represents the administration's only friendly contact with hostile interests. Whereas other (Continued on Page Two)

ATTEMPT MADE UPON LIFE OF HAILE SELASSIE

La Tribuna Newspaper at Rome Carries Story

AMERICAN NEGRO SAID ASSASSIN

Dispatches From Addis Ababa Say Emperor in Capital; No Comment Made

Rome, Nov. 5.—(AP)—The Asmara correspondent of the newspaper La Tribuna reported today that an attempt had been made on the life of Emperor Haile Selassie of Ethiopia.

Haile Selassie was reported in dispatches from Addis Ababa to be in that capital. There was no direct comment on the Tribuna's report.

The Tribuna dispatch said a bomb was found in the imperial palace in Addis Ababa and added: "The news is clearly connected with an order given by the police to various outposts to arrest an American negro who is supposed to have been identified as the assassin."

The report was stated to have been received at Asasmara from caravan from the interior and also from Djibouti.

OMEN SOUGHT IN ELECTIONS

Much Interest Centered In Local Voting Underway

Eager for any omen as to 1936, political leaders fixed attention upon today's scattered states elections, with much interest centered on Kentucky, New York and New Jersey.

An eleventh hour development emphasized a Schism in the Democratic organization of Kentucky. An announcement by Thomas S. Rhea, a power in Democratic politics in the blue-grass border state, that he would gain Democratic Governor Ruby Laffoon in support of the government's gubernatorial nominee, King Swopes instead of A. B. Chandler, Democrat, dashed any hope of National party leaders that the Kentucky breach would be narrowed before balloting began.

New York was filling two vacancies in the National House of Representatives. Philadelphia was selecting a mayor in a race that attracted more than state-wide attention and Virginia and Mississippi were going through an off-year routine of ratifying candidates for the legislature and state offices elected in democratic primaries.

President Roosevelt was at Hyde Park to participate in the ballot box decision as to whether Democrats are to retain the majority of three seats in the state assembly.

Republicans contended a victory for them would be a defeat for the New Deal. "Farley dictatorship and democratic policies, making New York the fifth wheel of the New Deal chariot." They predicted they would win the assembly by 10 seats.

Democrats made no forecasts but James A. Farley, national and state chairman, was represented as feeling the democratic majority would be increased. A total of 150 seats in the assembly was at stake.

New Jersey was electing a legislature of 60 members of the house and eight of its 21 Senators. Republicans now control the assembly 34 to 6.

Former Senator Walter E. Edge, Republican, described the New Jersey election as "the first and most important round in the presidential election of 1936."

DEED OF TRUST ON FILE IN PITT

Virginia Power Company Submits Voluntary Report

One of the largest deeds of trust ever to be filed in Pitt county was received late yesterday by J. C. Gaskins, register of deeds for the county.

The papers were filed by The Virginia Electric and Power Company and were made out to The Chase National Bank of the City of New York, trustee.

The recording fee for the voluminous document will amount to approximately \$250, Mr. Gaskins said.

This, however, is not the largest deed of trust ever filed in the county. Several years ago the Atlantic Coast Line railroad company filed a larger one here.

The deed of trust is for the purpose of securing first and refunding mortgage bonds. A \$37,500,000 initial issue of bonds of Series A, 4 per cent is provided for.

The papers, bound in a large volume, gives detailed descriptions of the various holdings of the Virginia company. Similar papers probably were filed in each county where the power company has holdings, it was pointed out.

Mexican Secretary Avers Argument Is Not Justified

Open Letter to Roman Catholics Says No Basis Contentions for Right of Church

Mexico City, Nov. 5.—(AP)—Silvano Gonzalez, secretary of the interior, stated in an open letter to Roman Catholics that the government considered unjustified the recent argument by Catholic Episcopates for the restoration of the right of the church to hold property and to impart religious education.

He said that no effort will be made to prevent parents from giving religious instruction to their children, but that the church will not be allowed to do so.

The social education which does not teach religious will be continued he added.

Gonzales made this declaration in the name of President Cardenas in reply to the Catholic Episcopates recent appeal for modification of the Mexican law regulating religious worship and socialistic education.

He declared it was absurd for Catholics in Mexico to appeal for freedom of consciences "when the Roman Catholic clergy has condemned such freedom as opposed to its fundamental dogma."

League Committee Called Together To Consider Plans

League Members Said to Hope for Voluntary Statement from Washington on Possible Action

Geneva, Nov. 5.—(AP)—The economic sub-committee of the League of Nations committee was called together today for consideration of a measure calculated to add a squeeze to the boycott against Italy.

A resolution providing for the ban on exportation to Italy of coal, petroleum, iron and steel, was prepared for presentation to the meeting as the first step in cutting off the essentials from the Duce's country.

A first task of the sub-committee, however, will be the examination of the replies from various governments to the League suggestion to cut off these commodities. The resolution will then be passed to the committee of 18 for action tomorrow.

If the committee of 18 adopts the resolution, the entire documentation bearing on the League decision will be forwarded to Washington.

Eastern Field Headquarters Orders Two-Day Halt

MAY TAKE CITY WITHOUT BATTLE

Little Hope for Peace Settlement Until After British Parliament Election

(By Associated Press) Rain, mud and the need for roads halted the Italian offense against Makale in northern Ethiopia today.

From the eastern field headquarters at Asmara, in Eritrea, came orders for a two-day halt in the drive while engineers rushed to work constructing a road.

In their drive through mud and water the Italian columns had reached the heights about Adula, commanding the approach to Makale.

Adula is 15 miles north and slightly east of Makale.

From all indication Makale will fall into the hands of the Italians without a battle. Scouting planes from the invading base have found no heavy concentrations of troops. Straggling forces have been spotted south of Makale.

The invaders were keeping a sharp watch for Ras Seyoum, governor of Tigre province and commander of Emperor Haile Selassie's army in the north. Ras Seyoum is somewhere in the mountains behind Makale with an estimated 150,000 tribe of warriors.

In the advance on Makale the fast invaders have consolidated and "mopped up" an area approximately this.

The western column operating to the west of the Aksum, Aduw, Adigrad sector, has pushed 50 miles forward to Eritrea's border, to the Takkaze river and then marched east and slightly south of Makale.

In the western area the columns under General Maravigna has been occupying the territory from Eritrea down to the Takkaze river pushed the Italian lines 50 miles near to Lake Tana in the north-eastern interior of Ethiopia.

As the forces converged in the Adula sector for the drive into Makale Italy at home went on a six months war diet preparing the aggressor nation for the applications of sanctions laid down by the League of Nations.

While diplomatic actions were continuing, little hope has been held out for any constructive peace proposal until after the British parliament election, November 14.

There was no apparent sign of any specific plan to pursue as a basis for settling the strife between Italy and Ethiopia. Nor was there in Rome any immediate sign of settlement of the friction between Italy and England.

Six Children Hurt When Large Truck Strikes School Bus

None of Injured Critically Hurt, However, in Wreck on Highway 10 Near Thomasville

Thomasville, Nov. 5.—(AP)—At least six persons were hurt, none seriously today as a heavy truck plowed into the rear of a school bus filled with 50 children on highway No. 10, near here.

Ivey Rothrock, 17, driver of the bus, and Mary Pine, 12, and her sister, Bertha 10, school children, were admitted to Memorial hospital here. The hospital also gave emergency treatment for minor injuries to three other children.

Funeral Services Held For Samuel McKeel

Funeral services for Samuel McKeel, 79, who died at his home across the Pitt county line in Greene county, were held this afternoon from the graveside in the family burying ground near the home.

The services were in charge of Joseph Warren, Masonic Lodge No. 92 of Stanonsburg. Mr. McKeel was the oldest living member of the lodge and had taken an active part in Masonic circles for many years.

He is survived by one son, Walter McKeel, former member of the Greenville police force; and one sister, Mrs. Mattie Poole, Walsenburg; three brothers, A. D. and E. H. McKeel, of Walsenburg, and S. W. McKeel, of Asheville.

it won't be long before his grip will be relaxed. Diplomats can't sell. It's beneath their dignity.

NEUTRALITY: The administra-
tion's tacit support of the League
of Nations in the Italo-Ethiopian
dispute may get it into senatorial
trouble.
Although a great admirer of
President Roosevelt, Hiram John-
son has informed friends at Wash-
ington that he does not like Secre-
tary Hull's apparent friendliness
toward Geneva's program. The Cal-
ifornia "irreconcilable" intimates
that he is about ready to attack
the cooperative policy without wait-
ing for the opening of Congress.
"I am watching Washington's
program with anxious eyes," Hiram
in a letter to a friend.

DOUBTFUL: Secretary Ickes is
collecting confidential data about
the PWA "legal services" for which
Arthur Mullen of Nebraska thinks
he ought to be paid \$175,000. It does
not look as if Mr. Roosevelt's floor
manager at Chicago will get all he
thinks is coming to him.
It appears that C. A. Sorenson,
former Attorney General of Ne-
braska, was first engaged to pre-
pare two Nebraska power districts'
applications for federal funds. Mr.
Sorenson, a Norris Progressive, per-
formed most of the laborious legal
work on the ground, which amounts
to 90 per cent of the labor in most
cases. Although the power districts
pay the legal bill the charge must
be submitted to Mr. Ickes because
the costs will come out of federal
funds which he advances. That's
how he happens to have the last
say.
But when the power districts for-
warded their papers to Washington
they felt that they needed political
representation. They dished Mr. So-
renson and hired Mr. Mullen, de-
spite the Ickesan warning that "no
lawyers need apply."

REBUTTAL: American business
men are adjusted to President
Roosevelt's strategy. They are tak-
ing no chances that he will catch
them off guard again.
When the U. S. Chamber of Com-
merce directors assailed his policies
last spring the President retaliated
with the charge that they spoke for
only the top layer of business and
industry. He declared it a conflict
of the "haves" against the "have
nots" and neatly turned the "have
nots" into an asset.
Now the Chamber is taking a
renewed interest in its members on
their attitude toward Rooseveltian
policies. But it has warned its 1,000-
odd member organizations to take
as complete and representative a
poll as possible. It wants legal and
political proof that the butcher, the
baker and the candlestick maker
are opposed to the New Deal.

GRIDEAL: New York conserva-
tives are privately much concerned
about Senator Black's Lobby In-
vestigation Committee. A bill was
introduced at the last session of
Congress to compel the registration
of any person who attempts to in-
fluence or prevent legislation for
pay or "for any consideration." The
bill passed the Senate but not the
House. The proposal was of course
strongly opposed in right wing cir-
cles—but it now develops that the
authority conferred on the Black
Committee shortly before Congress
adjourned gives it far more sweep-
ing powers than those implied in

der contempt proceedings and be-
cause of the adverse publicity and
implication of guilt which accrues
to anyone who balks at a Congres-
sional summons.

OGPU: Insiders are closely fol-
lowing Hugh Magill's effort to keep
the private records of his American
Federation of Utility Investors out
of the Committee's clutches on con-
stitutional grounds. They prophesy
that he will lose out—and then "no-
body will be safe." It's admitted
that Senator Black hasn't been un-
duly hard-boiled to date—but the
worry is that he can be if he wants
to be.
You hear dire predictions that
anyone of prominence who ventures
to oppose an administration mea-
sure for any reason is likely in fu-
ture to be hauled over the embar-
rassing coals of a committee ques-
tioning designed to discredit his
motives. There is much angry talk
about "intimidation" and an "Amer-
ican OGPU."

DISPASSIONATE: Observers remark
that those who are so worked up
about it are borrowing trouble that
will probably never develop. But
watch for a subtle campaign to put
the Black Committee in the worst
possible light with the public.

REASSURED: A little-known
New Deal official—Philip M. Ben-
ton—scored a big hit with invest-
ment bankers at their recent con-
vention. Mr. Benton is Director of
Finance of the Public Works Ad-
ministration and he talked to the
financial leaders in terms they un-
derstood and approved.

He emphasized the point that
PWA—although its primary purpose
is to create jobs—is administered
on strictly business principals. In
token of this he cited its rejection
of one-third of all loan applications
from states and municipalities. He
also registered proudly the agen-
cy's profit of \$2,500,000 on the re-
sale to private interests of munic-
ipal bonds it had accepted a col-
lateral for its loans.
He painted a picture of Uncle
Sam trying to help revive employ-
ment and business activity without
being in the least paternalistic
about it. As a result many bankers
returned from the convention with
the feeling that maybe the Wash-
ington crowd isn't so darned social-
ist after all.

GUESS: New York sharps have
been doing some heavy figuring on
the effect social security taxes will
have on industrial earnings. Their
analyses show that on the average
corporations will suffer a reduction
of earnings between two and three
per cent for each 1 per cent payroll
tax they are forced to pay. Of
course there will be wide variations
in different industries—depending
chiefly on the ratio of payroll to
sales and the ratio of profits to
sales.
On this basis steel, motors, heavy
machinery, retail trade, oil and
agricultural implements will be at

a special disadvantage. The mining
chemical and tobacco industries
will find the burden comparatively
light.

Business leaders are also peering
into the future and trying to dope
out the best method of offsetting
these added costs. It's clear that
they will either have to raise prices
or increase volume of sales—but
the first might boomerang in customer
resistance and the second is tough
in the face of active competition.
They're up against a guessing game
where a wrong guess might prove
fatal and it has them plenty both-
ered.

AXE: Most of the business men
who attend Major Berry's confer-
ence on industrial cooperation will
have suspension of the anti-trust
laws in the back of their minds.
Informed New Yorkers are con-
vinced that any attempt to put
something over on that line will be
crying with fire. Anti-trust activity
is evidently the one thing the gov-
ernment has in mind as a gesture
to appease consumers who kick
about higher prices. So any com-
pany that sticks its neck out in fa-
vor of lax enforcement is inviting
the axe as horrible example A.

Federal Housing Agents Be Here All Day Wed'day

Will Advise Anyone Interested in Building or Modernizing Homes

Aubrey McCabe, field representative of the Federal Housing Administration, will be in Greenville all day Wednesday, Nov. 6, at the second floor of the U. S. Post Office building.

The credit plan of the Federal Housing Administration makes it possible for home owners to modernize or build a home even if they do not have the necessary funds.

The administration itself, lends no money, but insures financial institutions against loss up to 20 per cent for modernization and 100 per cent for the amount loaned for new construction. The financial institution that makes loans in Greenville and vicinity is Guaranty Bank & Trust Co. Under title two (new construction) the borrower is required to own 20 per cent in the complete unit, which consists of the house and lot.

Under title one (modernization) the Federal Housing Administration has insured nearly \$200,000,000 of loans to date and is adding about \$2,000,000 per day.

Of the 1,980 daily newspapers of the country, 1,570 are running Better Housing news stories. There have been 45,000 radio broadcasts on the subject. Nine thousand theatres are showing Better News flashes prepared and distributed by Pathe. In 6,000 communities organized committees have called on 7,000,000 property owners and received pledges of \$326,338,650.00 of modernization jobs to be undertaken at once or in the near future.

Mrs. Hughes was formerly connected with the High Point Country Club and recently has been with the Hylmore in Greensboro. She will have complete charge of the Grill and will direct it according to plans formulated by the Board of Directors.

REESE MAKES ROTARY TALK

Speaks On Rotarian's Motto "Service Above Self"

Word pictures giving several photographs of where men have put service above self were presented by Dr. Edwin G. Reese, author and preacher of Washington, N. C., who spoke at the weekly dinner meeting of the Greenville Rotary Club last night.

As opposites of the Rotary ideal of "service above self" the speaker cited Stalin, Hitler, Mussolini in their dictatorships and the duPonts who have acquired great wealth in this country through wars.

Dr. Reese insisted that "service" was not a hackneyed term as used by Rotarians but as a motto "comes very close to Calvary." It is as broad and deep as the ocean and as wide as the world and benevolent as the Lord himself in its ideal.

The speaker paid tribute to Thomas Edison and his type of service to humanity by telling of the speaker's personal remarking deep appreciation to the great inventor's widow whom he found a most modest, unassuming lady.

After saying real service meant a sacrifice Dr. Reese related the story of a man who wanted to be a foreign missionary. Due to physical disability the candidate was ruled out.

His reaction was to bow to return home and work to send money to those who could go. Today that man is the manufacturer of the well known Welch's grape juice.

Remarking on the soon to come November 11th anniversary the speaker indicted with great feeling his sentiments about war, exhorting his hearers to realize now was the time to work for peace and to avoid wars of the European dictators and to follow the lead of the great peace crusader who died after the World War—Woodrow Wilson—the greatest casualty of the World War.

Those most interested in making war are those who make money from such conflict such as the duPont family, he said.

In conclusion he said that any man who could say service before self and not be deeply affected that something was wrong inside. Kagawa and Gandhi are two men who have their place in the sun because of putting service above self, he added.

The program was opened with a beautiful solo by Mrs. Edwin J. Reese, accompanied by Mrs. Walter Smith, the club pianist. Kinchen Cobb, chairman of the club service committee, was in charge of the program. Bill Lee, president of the club, presided. Leon Powell won the attendance prize given by Gerald Mitchell. Final Test Of Liquor Act Before Primary Doubtful

Raleigh, Nov. 5.—The conviction is growing in many circles here that neither the United Drys nor the long-wolf drys have any great burning desire to have the State Supreme Court rule on the constitutionality of the county liquor laws passed by the 1935 general assembly.

While the Supreme Court in its decision last week held that the drys had not followed the proper procedure in seeking a ruling on the constitutionality of the county liquor control laws, under which 17 counties are now operating more than 50 liquor stores, and thus practically effectually blocked the possi-

bility of any opinion on the validity of these laws until after the Democratic primary in June, 1936, it did point out the manner in which the drys can test the constitutionality of these laws.

The court suggested that the proper manner for the drys to bring a test case was to have some person indicted, arrested and tried for violating the state prohibition laws, after this person has made a purchase of liquor from one of the county liquor stores.

But so far there is no indication that any move has been made or is even under consideration to bring a test case, despite the fact that thousands of persons are, making county liquor stores every day, any one of which could be indicted by the drys for the purpose of bringing a test case. Or there are plenty of others who would gladly volunteer to buy a pint or a quart in order to give the drys an opportunity to get out an indictment and bring a test case, especially if the drys would furnish the money for the purchase of the "evidence."

There are two principal reasons, however, for the belief that the drys do not want a test case brought before the Supreme Court any time soon. The first is that the dry leaders are now inclined to agree with the wets that if the question of the constitutionality of the county liquor control laws should be submitted to the Supreme Court, it would hold them constitutional, probably by a four to one decision, with Associate Justice Heriot Clarkson the only member dissenting. This in turn would result in an immediate movement from the other counties who want similar laws for an extra session of the general assembly to pass either similar laws for them or to pass a state-wide liquor control law under which any counties which might want liquor stores could elect and have them if the people so voted.

The second reason for the belief that the drys do not now want to test the constitutionality of the county liquor laws is that they prefer the present scrambled-egg system of liquor control in only 17 counties, with the admittedly wide-open bootlegging system in the other counties, to any state-wide system of liquor control and liquor sales or even to any extension of county liquor control in other counties. For most of the drys con-

cede that if the Supreme Court should hold the present laws constitutional, such action would immediately result in a demand from other counties for similar laws, with the result that this demand might bring about a special session of the general assembly. But the drys do not want a special session because they are hoping that conditions will become so bad in these 17 counties that have liquor stores that they can arouse public opinion sufficiently against the liquor store system by time for the 1937 session of the legislature, to block any further liquor control legislation.

Even most of these who favor legal sale of liquor in the state through liquor stores, favor a state-wide controlled system rather than the county systems of liquor stores and agree that there is much more danger of the county liquor boards and systems becoming involved in local politics than if these stores were under the control of a central state board.

But the dry forces deliberately defeated the better, state-controlled liquor stores system during the general assembly and thus forced the enactment of the admittedly poorer system of county liquor stores, by refusing to compromise.

This was an indication to many that the drys were determined that if there was to be any liquor legal-ly sold, it was to be under the least desirable system, with the exception of the bootleg system. It is now believed they are holding these same views.

Campaign to Create Memorial to Will Rogers Gets Underway Through Nation This Week

Raleigh, Nov. 5.—A campaign for funds to help create a worthwhile memorial for Will Rogers will get underway throughout the nation and North Carolina expects to cooperate to the fullest extent, according to Carl Goerch of Raleigh, who has been appointed state chairman of the Will Rogers Memorial Commission. Mrs. J. M. Hobgood of Farmville, has been appointed chairman of the woman's division, and Governor Ehringhaus is honorary chairman.

In outlining plans for the drive in North Carolina, Mr. Goerch said that he plans to enlist the cooperation of the various newspapers throughout North Carolina. In view of the fact that Will Rogers was so closely allied to the newspaper fraternity, Mr. Goerch said that it was both fitting and proper that the members of that profession should take the lead in this matter.

Local chairmen are being appointed and their names will be announced within a few days. Practically every bank in the state has expressed a willingness to serve as a depository for the Will Rogers Memorial Fund. Wholehearted cooperation on the part of the public generally is expected.

Will Rogers had hundreds of intimate friends in North Carolina and visited this state on numerous occasions. Many thousands who never saw him were acquainted with him through his writings in over fifteen different newspapers in the state. There is no question but that the response for a memorial fund will be liberal.

The Will Rogers Memorial Commission is a national organization of which Vice-President John N. Garner is chairman. Captain Eddie Rickenbacker, American war ace, is in charge of operations. State organizations have been completed in practically every state in the union.

"The people of North Carolina from time to time have been asked to contribute to various funds," said Mr. Goerch, "but I don't think that there ever has been a drive which will meet with more wholehearted endorsement than this campaign to raise money for a Will Rogers Memorial. He was one of the most lovable characters that this country ever has produced and millions of people were made happier through his writings and talks. In view of his popularity throughout North Carolina, I am confident that this state is going to do more than its share."

UNC Hopes Against Upset At Hands Of Underdog Elevers

Chapel Hill, N. C., Nov. 5.—Although Carolina is rated favorites to topple the Flying Squadron of Keydets from V. M. I. Saturday here, Tar Heel followers are warned to expect anything. This year seems to be the "Season of the Underdogs."

Upsets galore have diminished the ranks of the nation's outstanding teams during the past several weeks. This past Saturday Mississippi State rose to its heights to topple unbeaten Army. Little De Paul in the Mid-West did the same thing to put the first blotch on Catholic University's record. In the past weeks such surprises occurred as Carnegie Tech over Purdue, Miss. State over Alabama, and Georgia Tech over Duke.

The questions arises: Will Carolina fall from the unbeaten ranks before the onslaught of an underdog as others have done? The fast improving Keydets are in an excellent position to crush the aspirations of the Tar Heels. Said the Soldiers catch Carolina's off-balance, over-confident and expect an easy scrap, the many things may happen to Carolina that happened to Army, Navy and Catholic U. this past week.

Each Snately fears over-confidence. However, he has plenty of work to keep the Tar Heels busy at football. Besides preparing for the Keydets who robbed William and Mary of its Virginia State championship hopes last Saturday, the Tar Heels will have to start planning for the all-important game with Duke the following week-end. The running attack was decidedly off against State, possibly because it was up against the Wolfpack's powerful line. The defense was good. The Carolina forward wall held the fast-stepping State backs to less than half as much net yardage as the Tar Heels obtained. Passing was the main factor as Carolina came out of the brawl on top by 35-6.
