WPA Workers Threaten To Revolt In This State Because Of Delay In Pay

Men Said to Be Too Hungry to Continue at Work

COAN PROMISES EASE SITUATION

State Administrator Says Red Tape Delaying Pay Checks To Be Dispensed

Raleigh, Dec. 11.—(AP)—Men who said they had not been paid for work done on works program administration projects three weeks ago, men who laid down their shovels with the acquiescence of four men "because they are too hungry to work," today threatened a widespread revolt against the WPA in North Carolina.

The alleged delays ranged from two days in Raleigh to "several days" in Gastonia and Wilmington and "three weeks" in Wilson. J. E. L. Wade, Commissioner of Public Works at Washington took up the cudgel for the workers themselves as in 25 WPA employes there had reported for work too weak to attend their duties for lack of food and that it was the same at the other points.

Gastonia county workers marched on the city hall at Gastonia threatening a strike after they had learned a similar situation had been met by a project sponsor at nearby Charlotte with "tidings over" payments pending receipt of checks from Raleigh. Headquarters at Wilson were besieged by complaints that workers had not been repaid for the last three weeks' work. Hunger was the cry—hunger of women and children at home, as well as of men who dropped out of the lines on their jobs.

George W. Coan, Jr., state administrator, promised action—immediate action to relieve the need of the moment and permanent action to prevent repetitions.

He said the time keepers on the projects hereafter would work with the financial division instead of the engineering section thus eliminating red tape in handling reports, vouchers and other exchanges before a man can be paid.

Appeals Taken From Court By Drunken Drivers

Two Defendants Fined and Ordered Retrain From Driving Appeal Their Cases

Two cases of drunken drivers heard in County court yesterday afternoon which resulted in convictions and judgments of fines were appealed to the Superior court.

J. T. Timberlake, charged with operating a motor vehicle while under the influence of liquor, was fined \$50 and costs, had his license revoked for 12 months and given a sentence which was suspended upon the provision other terms of the judgment were met. The defendant appealed to the Superior court.

Willie Manning, convicted on a similar charge and given the same sentence, also noted an appeal to the higher court.

Isaac Jackson, charged with careless and reckless driving, was ordered to pay half the costs of the case. He appealed from the judgment and bond was set at \$200.

Archie Ruffin, convicted of stealing chickens from Charles Laughlinhouse, was ordered to pay half the costs and also to pay the prosecuting witness \$10 for the stolen chickens.

Johnston County Begins Hearings In Murder Case

Smithfield, Dec. 11.—(AP)—The Johnston county grand jury today began a probe of the case of Odell Stancil, alleged slayer of his brother, Dewey, Stancil, and a coroner's inquest set for this morning in the case was indefinitely continued by Coroner E. N. Booker of Selma.

County officers said after an investigation of the slaying of Dewey Sunday that he died of wounds received when his brother hit him over the head with a piece of wood during a fight. HEAD OF CUBA RESIGNS POST

Successor May Be Another "President for Day"

Havana, Dec. 11.—(AP)—Cuba's turbulent political situation precipitated the resignation of President Carlos Mendiolata today and placed Secretary of State Jose A. Barnet into his office apparently clearing away obstacles to the holding of the national elections.

Mendiolata, yielding to the insistence of powerful political factions which refused to participate in the election unless he first stepped down, presented his resignation to the cabinet as his "patriotic duty."

Barnet, 71-year-old veteran of the diplomatic service, automatically became president—the Republic's seventh since a revolt caused the downfall of Gerardo Machado on August 13, 1933.

The possibility arose immediately that Barnet might be another of Cuba's "presidents for a day."

After reappointing all members of Mendiolata's cabinet, he called the ministers and the council of state to meet later in the day in a joint session which the law provides must elect a provisional president in 48 hours.

A background of unsettled political activities, army activity against kidnapers and a radio on a radio station accounted for the swift turnover in the government. Mendiolata, explaining his resignation, announced:

"Subordinating all personal interests for the interest of Cuba, whose welfare depends at the present on holding general elections and my remaining power being a motive for the refusal of some political parties to participate in the election on the pretense of non-existence partially on my part I have, I believe, complied with my patriotic duty in presenting my resignation as president."

PITT GINNINGS SHOW DECLINE

Figures to December 1, 1438 Bales Below Last Year

A report of the Bureau of Census of the Department of Commerce revealed today that 8,782 bales of cotton were ginned in Pitt county from the 1935 crop prior to December 1, as compared with 10,220 bales ginned to December 1, last year.

Ginnings in the month this year were 1,438 bales below the figure for the corresponding period last year, the figures showed.

Ginnings for the state, prior to December, were 534,127 bales, while those for the United States to that date were 9,362,343 bales.

Demonstrations For Saving Timber Are Set For Friday

Assistant County Agent Griggs to Be Aided by Extension Specialists in Timber Program

Two forestry demonstrations for the purpose of showing landowners and tenants the necessity of preserving timber lands have been set for Pitt county Friday.

At 9:30 o'clock the first demonstration will be held on the Dew farm of John T. Thorne, between Falkland and Fountain. In the afternoon another is set for the Webb farm of J. E. Winslow, three miles northeast of Patactus.

C. D. Griggs, assistant county agent, has made arrangements for the meetings, which will be attended by a specialist from the forestry extension division of N. C. State college.

In announcing the meetings, E. F. Arnold, county agent, said that all land-owners are asked to attend one of the demonstrations and bring their tenants.

The county agent declared that the preservation of timber lands is one of the major programs of the administration in its efforts to aid farmers on a long time basis.

Two miles of acorns were planted at Pratt, Kas., to provide seedlings for government shelterbelt projects.

PEACE PLANS FOR ETHIOPIA MEET REBUFF

Claim Selassie Would Lose Throne If He Accepts

TIGRE PROVINCE MUST BE KEPT

American Missions in Addis Ababa Protest Bombing of Hospital By Italians

(By The Associated Press)

Ethiopia said "no" to the latest efforts to end its east African war with Italy by negotiations.

Scarcely had peace terms, agreed upon by Great Britain and France before the empire's minister in Paris announced his government was unalterably opposed to any proposal for settlement of the Italian-Ethiopian war which would reward Italy's aggression.

Ethiopia, he said, will adhere to the principle of its territorial and political integrity.

The program of Great Britain and France for peace in East Africa encountered an early obstacle today, Ethiopian officials asserting Emperor Haile Selassie would lose his throne if he dared to accept the proposal.

The Addis Ababa government authorities said northern Tigre province must be kept by Ethiopia lest native chieftains ordered to resent rise in revolt on grounds that they could have defended the province successfully.

These officials described the peace plan and its reported provisions for exchange of land between Italy and Ethiopia as a "reward for Italy for breaking covenants and another device to delay further sanctions."

Rome was silent. Whether Mussolini, whose recent utterances have been more conciliatory than heretofore, would discuss the proposed basis for eventual peace negotiations or drop an explosive "No" into the European diplomatic ranks remained a question.

The Franco-British program was framed not only to end the African warfare, but to liquidate finally the European crisis arising from the conflicts as well diplomatic spokesman foresaw long and difficult negotiations and anticipated objections to the peace program by some smaller powers as offering a "premium for aggression."

An offshoot of the Ethiopian crisis was a government crisis in Cairo today. Premier Nessim Pasha offered the resignation of his cabinet, a high authority reported, and it was accepted by King Sued.

In Addis Ababa the head of all three American missions in Ethiopia and other members of the American colony presented a signed statement to Cornelius Van H. Engert, United States charge de affaires, protesting the Italian bombing of Dessie, Haile Selassie's field headquarters.

"There was never a more deliberate insult to the American flag than Italy's bombing of the American missionary hospital property at Addis Ababa and the consequent endangering of many lives," the statement said.

Greenville Mart To Close Season With \$21 Average

An official season average for the Greenville Tobacco market above the 21 cent per pound mark is assured with the figures at the close of sales yesterday being \$21.04 per hundredweight and only two more days remaining after today.

The season will close here Friday. Offerings on the local mart for the year through Tuesday's sales were 60,241,130 pounds. This figure surpasses early season estimates when forecasters guessed the season's total at 60,000,000 pounds.

Farmers selling tobacco on the local market have received a total of \$12,675,794.46 for their offerings. Only 66,450 pounds were sold yesterday, bringing \$7,528.66 for an official daily average of \$11.33 per hundred pounds.

CUMMINGS TO ARGUE CASE OF NEW DEAL

Attorney General To Appear in Holding Company Suit

TO ASK COURT TO STOP ACTIONS

Claims Constitutionality of Holding Co. Act Already Being Tested in Case

Washington, Dec. 11.—(AP)—Attorney General Cummings revealed today he will personally argue in the District of Columbia Supreme Court tomorrow the government's motion to hold up injunction suits of seven holding companies challenging the utility laws' constitutionality.

The decision served to emphasize the importance placed by the administration on the controversial New Deal law which has promoted scores of legal actions.

It will be the first appearance of the Attorney General in a Federal District court since he took office.

The Attorney General will ask the District court to stop all judgments in seven suits to enjoin the securities commission from enforcing the holding company law.

Cummings' argument will be based on the government's contention that the new law already is being tested in the securities commission's suit against the Electric Bond & Share Co., and five subsidiaries now pending in New York and that "no public interest will be served by pressing a decision of this issue in a multitude of suits."

The New York financier, star witness in the Senate Bank Committee Stock Market investigation a few years ago, will be called for questioning in connection with financing the allied forces. Whether he will open the inquiry or be called later has not been determined.

The events preceding American entry into the conflict will be studied as a preliminary consideration of new neutrality legislation.

Members of the munitions commission contend American trade with the allies developed an irresistible current which dragged this country into war. They want a new law which will prevent such a current in future years.

J. P. Morgan and Company was the principal American bank agency for the allies. It floated millions in loans for them and to a large extent they financed American trade with the belligerents.

Japan's Demands Are Presented By Admiral Nagano

London, Dec. 11.—Admiral Osami Nagano placed Japan's demand for a navy as large as that of any major world power squarely before the delegates to the International Naval Conference today.

The admiral was the only speaker and the session was adjourned until tomorrow when the American and British delegations will reply to the Japanese demands.

The Japanese thesis was that a tonnage limit should be set, but with the "great naval powers" granted equality. "Offensive warships" abolished or drastically reduced, and a "state of non-menace and non-aggression" achieved.

SEAL RESULT IS FAVORABLE

No Figures Available Yet On Christmas Seal Sales

While no figures were available on returns from the first day's canvassing of the city to sell Tuberculosis Christmas seals, officials of the campaign expressed satisfaction with the results.

Mrs. J. H. B. Moore, city chairman, and Dr. N. Thomas Ennett, county chairman, praised the workers and said when tabulations are made they expect the receipts to come up to all expectations.

The workers took the field yesterday for the first time in the 1935 drive. Letters had previously been sent to some business houses, but work in the drive yesterday was the first time canvassers had made personal solicitations of business firms.

Homes will be reached through the various women's clubs, churches and schools. No workers will canvass the homes, leaving the sales there to the various organizations.

Dr. Ennett said one gratifying result of the work was that more people are purchasing the seals. The county chairman has emphasized throughout the campaign the idea was to secure voluntary buyers, and not to all the seals through high-pressure salesmanship.

Solicitations were not completed yesterday, and the workers will clean up their work today and during the remaining part of the week. Booths to sell the seals will be established in various sections of the city at a later date.

Remains of James H. Freeman Found Near Ayden

And unless Joe Louis is at least three times better than any fighter whose punches he has sampled, Paulino figures he has little to fear so far as being put on the canvas by a punch for the first time in his career is concerned. To his own way of thinking Joe Louis can't be that good.

Brix Deposits
Lou Brix, Paulino's American representative, goes all the way back to Jack Johnson, Jim Corbett and Bob Fitzsimmons to prove his point that Uzcudun has a chance of upsetting the Bomber's well laid plans. He points out that Corbett was 34 when he was more than holding his own against young Jim Jeffries for 23 rounds. Fitzsimmons was a least 38 when he knocked out Gus Huhlin and Tom Snarkey. Johnson beat Frank Moran in a 20-rounder after he had celebrated his 35th birthday. Brix doesn't try to tell you that Paulino belongs in the same class with the trio mentioned, but at the same time he does rate the Basque and his chances of scoring an upset very highly.

Paulino is not the shopworn fighter pictured by most of the experts, Brix insists. To prove his point Lou argues that the Basque had fought only 69 times in a career that covers a period of 13 years. An average of five fights a year, but at the same time evenly spread out. Add to that the fact that few if any present day heavyweights take as good care of their physical conditions day in and day out as does Uzcudun. Just for good measure Brix points out that Paulino's lunging, aggressive attack and odd doubled-over style of milling annoy Louis. The sensational Negro may encounter considerable difficulty landing damaging blows as long as Paulino fights behind a shield of elbows as he has on past occasions. The Basque's elbows are mighty tough and present a hazard for the hands of any hard puncher.

Lucky Thirteen
When it was pointed out to Joe Louis that his engagement with Paulino was scheduled for Friday December 13, the Negro heavy-weight merely smiled and insisted that he was not superstitious. And if he were inclined to believe in the number as an omen it would be one of good luck.

Louis pointed out that his birth-

day was the 13th day of May—he was born in 1914. His present knock-out streak began on April 13, 1935, when he stopped Roy Lazar in Chicago. And just to show that he is unworried about the number being an omen of ill fortune he announced that he had enjoyed 13 hours' sleep the night previous as is his usual practice.

The Bomber has picked up little additional weight since he knocked out Max Bear, just about enough to give him something to work on.

Spilman brought to the College students yesterday morning at the Assembly hour a message full of wisdom and sound advice, based on his forty years of experience working with college students and on a lifetime of companionship with the wise man, whom he referred to as "my good friend, Solomon."

His talk was rich in bits of wisdom, flashes of wit, and catchy illustrations. Dr. Spilman's advice on how to build a sound, wholesome philosophy and how to avoid the dangers of a foolish philosophy that leads to disaster, was vividly presented. He pointed out the danger of a philosophy that makes one say he is willing to try anything once, giving one example after another, showing its folly. When experimenting, he said, one should do so intelligently, not foolishly adventuring too far. "Judgment," he said, "is one of the latest of all intellectual qualities developed."

The person who knows how to learn from another, he pointed out, is much wiser than one who learns only from his own experience.

He gave the Ten Commandments as the basis upon which to build in deciding what not to experiment with. These point out the things in life one should not trifle with, such as falsehood, impure life, and murder.

The pertinent point he made was that one must work out his own life and not the other person's. In one story he held of a man whom he considered wise who said he spent half his life attending to his own business and the other half in not attending to the other fellow's affairs.

Dr. Highsmith also said that these 47 high school dropped by the southern association of secondary schools, will remain on the accredited list of the State Department of Public Instruction, as in the past.

It was further pointed out that graduates of North Carolina high schools and of high schools in almost all other states have always had to pass entrance examinations to get in all the larger northern colleges and universities, so that the action by this association means virtually nothing.

RAPIST MAY GET REPRIEVE

Negro Scheduled To Die In Gas Cham- ber Friday

Raleigh, Dec. 11.—Friday, the 13th of December may not prove to be an unlucky day for Jake Johnson, alias George France, negro rapist from Rockingham county, now under sentence to die in the state's new lethal gas chamber Friday morning. For present indications are that a temporary reprieve will be granted Johnson unless the State Supreme Court should this afternoon hand down a decision in the Ed Jenkins case, which will decide the identical question involved in the Jake Johnson case—as to whether both Johnson and Jenkins were properly sentenced.

Both Johnson and Jenkins committed their crimes before the new lethal gas execution law was enacted, but were tried and sentenced after its enactment, with the re-

sult that they were sentenced to be executed by lethal gas.

The Judges who sentenced both Jenkins and Johnson evidently believed the law applied to all tried and sentenced after enactment of the lethal gas execution law and accordingly sentenced them to death by lethal gas. But attorneys for Jenkins did not agree with this interpretation and appealed to the Supreme Court. Johnson did not appeal, however, with the result that his death warrant now calls for his execution Friday morning at 10:30 in the new lethal gas chamber in Central Prison here.

But Warden H. H. Honeycutt wants to be sure of the law and that Johnson was properly and legally sentenced before carrying out the execution. Accordingly, he has asked Attorney General A. A. F. Seawell to advise him whether to proceed with the execution. But Attorney General Seawell is not yet sure as to how to advise Warden Honeycutt, since the Supreme Court has not yet passed on the Jenkins case. He is hoping the Supreme Court will hand down a decision in this case this afternoon. If it does not, he may advise Warden Honeycutt to ask the Governor to grant a reprieve to Johnson until after the Ed Jenkins case has been decided. If he does that, it is believed a temporary reprieve will be granted for Johnson.

So whether the new gas chamber will be used for the first time

Friday and whether Johnson will be its first victim, now rests with the Supreme Court or the Govern-

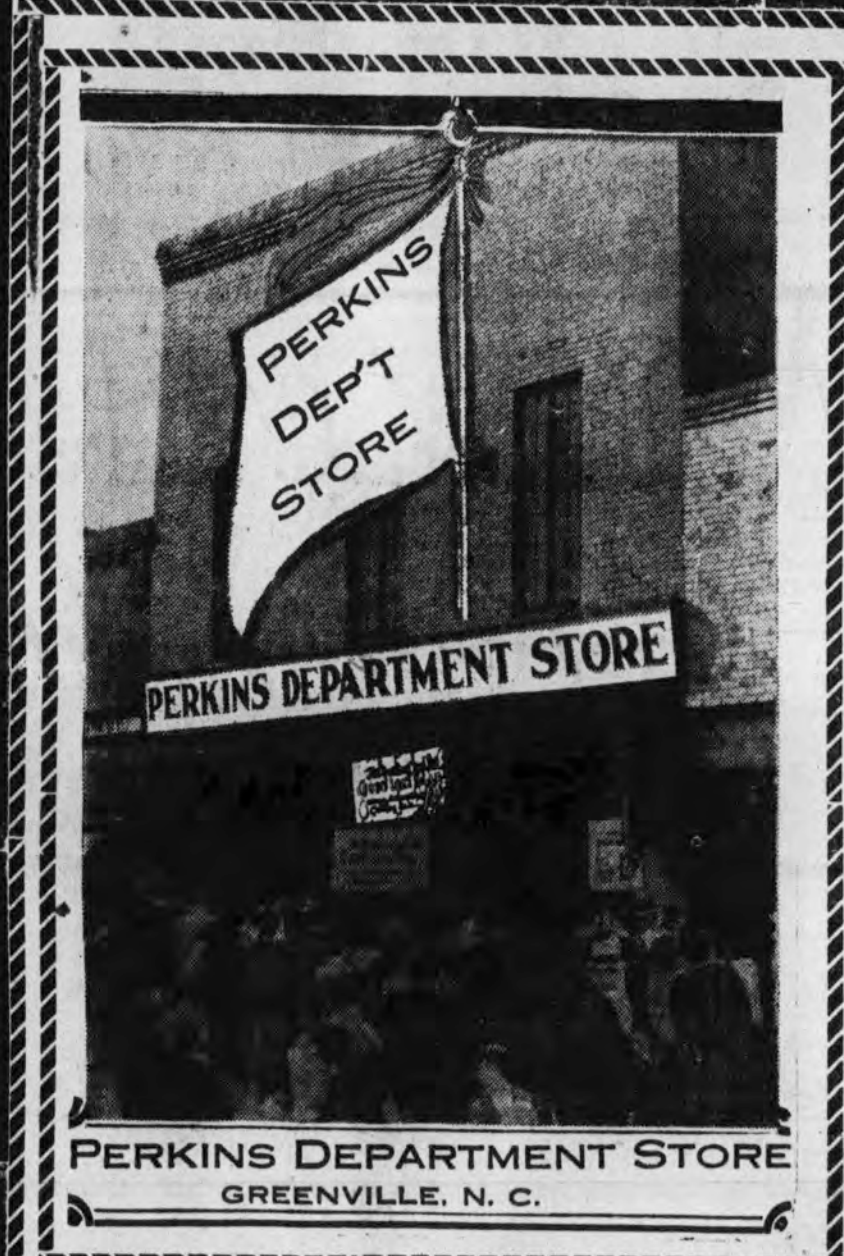

to stave off Japanese penetration of Northern China.

The teamwork has not been perfect and the two collaborators have had to camouflage cooperation. But what happened is that the United States took the lead in applying pressure on Italy, only to see London and Geneva hang back. When London besought us to swing on Japan, too, Mr. Hull backed away. The 10 Downing street protested to Tokyo, and Mr. Hull simply issued a cautiously worded statement expressing the pious hope that Japan wasn't stealing jam while the world wasn't looking. Mr. Hull doesn't intend to take on all Great Britain's troubles single-handedly, if that's what Mr. Chamberlain wants.

ADJUSTED: Wise buyers of liquor for the holidays should purchase only enough to wassail them through New Year's Day. Prices ought to drop sharply after January 1, when the Canadian treaty becomes effective and lowers duties on booze from abroad.

Alcohol Administrator Hoyt recently spread the glad tidings, although he couched it in technical language difficult for the lay drinker to comprehend. Mr. Hoyt has au-

thorized distillers to make rebates to retailers on goods bought before January 1 but remaining on their shelves after the new year. Thus when retail prices are forced down local vendors may recoup from the distillers.

Dealers were refusing to stock up with fancy brands in the face of large losses after January 1. They told Mr. Hoyt of the threat of a cheerless Christmas and the former children's judge relented.

PREPARING: FDR has told friends that he will lose no sleep or votes—over the NAM's warning that he is hearing the nation toward the rocks. He didn't count on their support and he can't use their enmity.

In fact, NAM insiders confide that they were aiming at Roosevelt only indirectly. They discovered long ago that it was a waste of breath and white paper to beseech him to revise his policies to suit their ideas. They have frequently chuckled as they watched Dan Roper tie up their colleagues on the advisory council in administration apron strings. Most NAM members resigned from that body in disgust.

What the Bardo-Lund-Emery leadership did was to warn the GOP that it must not flirt with liberals of the Gorah brand. The Senator's recent display of popular strength has frightened them. Though they hope to break Roosevelt next year, they prefer to lose to him than to win with a maverick Republican. They want no compromise with the New Deal, hoping to smash it in 1940 if not in 1936. They think such a blessed event is worth waiting for.

New York

TARGETS: The National Association of Manufacturers have baked themselves a loaf of bread. Now the question is whether they can slice it. Most New York conservatives agree heartily with the association's anti-New Deal premises, but a surprisingly large percentage

of financial leaders characterize its smashing assault on the entire list of Roosevelt policies from social security to the securities act as the poorest public relations they have seen in a long time. A big-time banker puts it: "It's fine to have strong convictions and act of them—but why yell your head off when you can get much better results by whispering? Can you imagine the average voter rushing to the polls to give the country back to business just because business says he should?"

What the manufacturers really did was to take Ed Hutton's advice—which Hutton himself later hedged—to gang up. Critics contend that by doing so publicly they have played squarely into Roosevelt's hands. He doesn't have to draw the issues now between the "haves" and the "have nots." The "haves" have drawn it for him so sharply that large numbers of voters who aren't sure whether they like FDR or not but are darned sure they don't want big business back in the saddle will automatically be forced into Roosevelt's camp.

Another point stressed by New York observers is that if the business drive fails and Roosevelt is reelected he has ample excuse to crack down harder than ever on the big industrialists. He can say that he offered them the cooperation of a permanent breathing spell and got kicked in the face for his pains. Why should he bother about their viewpoint any longer? Meanwhile Senator Black's lobby investigation is likely to make life decidedly uncomfortable for the boys who have set themselves up as such conspicuous targets. They asked for it—and they'll get it.

LISTEN: A striking contrast in method is shown by Secretary Roper's Business Advisory and Planning Council. Most of the Council's members are probably as firmly opposed to New Deal policies as the manufacturers' association—but they aren't going to advertise it

with a foghorn. On the contrary, they are going to be sweet as pie to their Washington playmates. Earlier storm clouds have been dispersed. The new system of rotation in office will ease out those who are really disgruntled at the end of the year without embarrassing the government by public resignations. However, a large majority of the present members have assured Secretary Roper that they will go along with him and accept reappointment for next year.

Moreover the Council has revised its own conception of its functions. There will be no more arguments about the Council's right to issue reports adverse to the administration. In fact, no reports will even be drafted except at the specific request of the President or Secretary Roper.

Only a few weeks ago most of the Councilors were privately fed up with the utility of it all and ready to quit. How come this sudden change of heart? Because it suddenly dawned on the dissenters that if they walked out conservative business would lose its last inside contact with the New Deal. So they decided to stick around and act as industry's scouts within the enemy's portals (though they would never dream of expressing it so crudely). Unlike the manufacturers' association, they will be listening—not talking—but that doesn't mean they'll be any the less useful to their cause.

COAL: For once John Lewis of the United Mine Workers is waging a battle which even New York conservatives might be considered justifiable. Informed sources admit that the anthracite coal industry hasn't used very good judgment in its dealings with labor.

The industry has been quite prosperous right through the depression. Moreover it has maintained high prices and a high margin of profit instead of reducing prices

and trying to increase consumption—which would have made as much money for the companies and employed a good many more men a good many more hours.

This is the main reason for the startling development of a bootleg anthracite business which now produces an estimated two to two and a half million tons a year—almost 5 percent of official production. The bootleggers incidentally are becoming something of a menace to life and limb on highways leading

east through Pennsylvania. They drive rickety uninsured trucks at a crazy pace. Insiders say the only way they can be eliminated is to give company employes a decent amount of work.
