MISSIONARY MEETS DEATH IN ETHIOPIA

American Is Killed While Handling Italian Bomb

LITTLE HEADWAY PEACE PROPOSAL

Fascist Newspapers Point Out Ethiopia's "Stubbornness" Toward Peace Plans

The death of an American medical missionary in Ethiopia punctuated the threatful aftermath of the attempt by Great Britain and France to formulate terms for peace between Italy and Ethiopia.

Dr. Robert W. Hockman was killed while handling an unexploded Italian bomb at Daggah Bur on the southern front.

Dr. Hockman who was a United Presbyterian missionary to Ethiopia, had removed the detonator and supervised the taking out of the unexploded projectile. He had made a hobby of studying bombs.

The Franco-British peace proposal meanwhile, appeared to have produced only a protracted wrangle over the plan between its advocates and those nations aligned solidly against it on grounds that it threatened the foundation of collective security.

Britain was in the middle of a political crisis incident to the formulation of the peace plan.

Advices from Rome said the Fascists intended to turn the League of Nations against Ethiopia for its denunciation of the peace plans.

Various Italian newspapers asserted Ethiopia's "stubbornness" in appealing to the League against the proposal for an exchange of his territory with Italy marked it as blameworthy for the East African conflict.

The British government, it is expected to result in the cabinet falling, but the nation wonders how Stanley Baldwin would be able to support his government action before the critical Laborites and Liberals.

Public dissatisfaction with the peace terms threatened to Anthony Eden, the "white knight of the League" but the preponderance of speculation centered on the future of Sir Samuel Hoare, the British foreign secretary. Some sources suggest that he had no alternative except to resign.

J. E. Winslow Named Head of Pitt County Agriculture Planning Agency to Study Farming

J. E. Winslow was named chairman of the Pitt county Agriculture planning agency at a meeting of the group in the county agent's office last night. John R. Carroll was named secretary.

The committee, named by a group of county farmers at a meeting earlier this week, went over the work it is faced with making a review of what kind of long-time farm program the county should have.

This data will be gathered and furnished state and federal agencies in their attempts to map out a program for the county.

The committee also is seeking to find out what is the best course to take should the Supreme court hold the federal farming program unconstitutional.

Local Weed Market Closes With Average Above \$21

Yearly Average of \$21.02 for This Year to Be Above Official for Entire State; 60,354,582 Pounds Sold For A Total of \$12,689,063.23

The Greenville tobacco market closed its 1935 season yesterday with an official average of \$21.02. During the period 60,354,582 pounds of that weed were sold for a total of \$12,689,063.23.

In the 1934 season 51,185,000 pounds were sold for a total of \$1,077,000, or an official average of \$21.02.

Although the average for the season just closed was below that of last year it was greater than any other year since 1928 when the official figure was \$21.05 per hundredweight.

K. W. Cobb, supervisor for the local market said he was "fully convinced the tobacco sold on the Greenville market, grade for grade, sold as high as on any other market in the state."

"Our average for the season last year was above the 27-cent per pound average for the state, and the \$21.02 average here this year probably will be above the state figures, which we feel is a good record considering the conditions," he added.

The highest weekly average during the present season was reached for the week ended October 24, when a weekly average of \$24.39, except for the last few weeks of the season nearing and only poor grades of weed offered the average was brought down.

The Greenville market still boasts two records there is little fear of being broken in the near future. One is the one set last year when the market paid out more money than has ever been paid out in a season by any market in one year.

The other, set a few years ago, when, with only four sets of buyers, the market sold over 60,000,000

of tobacco in 60 selling days, a daily average of quarter million pounds per cent of buyers.

GAINS SHOWN IN BUSINESS MAKE RECORD

Highest Level in Five Years Reached, Index Reveals

ALL LINES MAKE BIG RECOVERIES

Power Industry, Steel Mills, Cotton Manufacturers and Construction Improve

New York, Dec. 14.—(AP)—Business slammed a heavy foot on the recovery accelerator this week and reached the fastest clip since June 1930.

In reaching the highest level in five years the Associated Press adjusted index of industrial activity topped its peak of 86 last week to finish at 86.7, compared with 69 in the like 1934 week.

Records were crowded off the board to make place for new ones—by the automobile production index which soared to the pinnacle last reached in November, 1929, and by the coal mining which jumped to the highest mark since November 1931.

The power industry made history by grinding out the greatest amount of electricity ever generated in one week—1,969,662 kilowatt hours, 13 per cent ahead of the corresponding week a year ago.

Steel mills struck their best mid December average since 1929, although some slackening occurred in line with the usual slowing down of operations at the end of the year.

Cotton manufacturers, which last week tilted ahead to a new 1935 high, held its place, steadfastly.

Construction—one of the steel industry's pillars of hope—reported the sharpest advance over last year scored in 1935, while home building showed a rise of nearly 100 per cent over 1934.

A famous triple play, industry to payroll to retail trade, brought a throxy roar from the Merchandising division which turned in the heaviest and most widely spread gain this season in many years. Estimates of Christmas buying led last season by over a half a million dollars.

RELIEF DRIVE GETS BIG SUMS

State WPA Administrators Given Latitude in Spending

Washington, Dec. 14.—(AP)—Leaders of the relief drive announced today that to date Comptroller General J. R. McCarl has released \$1,068,344,963 of the four billion dollars.

Job funds for expenditure by state officials of the work progress administration.

McCarl is the arbiter of government spending. His approval is necessary before any of the four billion dollar is released. Besides giving the "go ahead" sign in the \$1,068,344,963, which is to be expended by states he also approved funds for some nation-wide projects under the four billion dollar program, including the \$40,000,000 youth administration.

State WPA administrators will have latitude in choosing projects to prosecute with the \$1,068,344,963. McCarl has already approved projects totaling four times that amount so the administration may have leeway in adjusting WPA work to employment opportunities created by other agencies.

The report of McCarl's release showed New York City has received more than any state. With a WPA quota of about 225,000 jobs, it has been allotted \$121,426,872, compared with \$50,875,779 for the remainder of New York state. Pennsylvania with \$110,024,064 received the next largest allotment and the smallest went to Nevada, which received \$1,296,416. Other allotment included North Carolina \$8,226,437.

Pair Wanted For Murder Being Held In New York

Andrew Cogdell and Marvin Taylor Said to Have Confessed

OFFICER SENT RETURN THEM

Pair Charged With Murdering John Lee Smith, Another Negro, in Grifton

Sheriff S. A. Whitehurst was informed today that two negroes wanted in this county for the murder of another negro in Grifton in November were being held in New York.

Two deputies were sent to the city to get the two alleged slayers Andrew Cogdell, alias Sampson Whitfield, and Marvin Taylor, after securing necessary papers from the offices of the governor.

Cogdell and Taylor are charged with murdering John Lee Smith on the night of November 9. Smith is alleged to have been calling on Cogdell's sweetheart in the town of Grifton, Cogdell, becoming enraged went to the home and called Smith out and shot him in the chest. Taylor, who accompanied Cogdell to the house, is alleged to have hit Smith in the head with a brick as the latter lay on the ground after being shot. Sheriff Whitehurst said physicians who examined the body declared that the lick on the head would have killed the man, even if the shot had not.

The men are not expected to fight extradition, Sheriff Whitehurst declaring that his information from New York said the negroes had made a full confession of the murder. They will be brought here to face a court trial.

Negro Bound Over To Superior Court For Stealing Auto

Other Cases Heard This Morning in Police Court Resulted in Defendants Being Held

Otto Rivers, negro, was bound over to Superior court today in Police court on a charge of larceny of an automobile.

The car was stolen from here Tuesday and recovered in Raleigh yesterday. It belonged to J. A. Conway.

Carl Walker was ordered held for Superior court on a charge of breaking and entering. He was also ordered held for County court on a charge of larceny of a suit of clothes. He was given 30 days on the roads for assault upon a woman. Walker also is a negro.

Fred Taft, another negro, was bound over to County court on a whiskey charge, as was Joe Griffin on a similar charge.

PAY INCREASE WPA WORKERS JANUARY 2ND

Ten Percent Increase in Towns Over 5,000 Population

RURAL PROJECTS TO REMAIN SAME

Wage Rate Said Satisfactory in Rural Sections; Increase Be Competitive

Raleigh, Dec. 14.—(AP)—Workers on Works Progress Administration projects in cities and towns of over 5,000 population in North Carolina who were residents of sub-communities December 14 will receive a 10 per cent increase in pay effective January 2.

George W. Coan, Jr., state WPA administrator estimate the increase would apply to 30,000 of the 40,000 persons now on WPA jobs and increase the monthly payroll by about \$100,000.

There has recently been much complaint over the state about slowness of PWA payrolls and the low wages paid some workers.

The increase was not applied for rural workers "for the simple reason the wage rate is satisfactory in those rural sections and any increase would be somewhat competition with private employment and with agriculture," Coan said.

Workers living outside of municipalities with population of over 5,000 but working in the towns or cities and those working within one mile of the limits of such municipalities will get the increase.

Work time for all WPA workers is to be reduced from 140 to 120 hours per month on December 18, Coan announced. He said the policy of paying employers for time lost on account of weather, he believed the WPA wages will compare favorably with prevailing wages now being paid, in various classes of workers according to their skill.

The pay increase was ordered by authority of an executive order of Pres. Roosevelt allowing state administrations latitude in fixing the wage schedules.

MOVES MADE BY BRITAIN

Cultivate Closer Relationship With German Ruler

London, Dec. 14.—(AP)—A well informed source disclosed today that Great Britain has suddenly moved to cultivate closer relationship with Reichsfuhrer Hitler of Germany.

The move was not explained in official quarters although it came about after six months of European turmoil over the Italian-Ethiopia hostilities.

Sir Eric Phipps, the British ambassador to Germany, was assigned to take the initiative in Berlin for conferences with Hitler in a general discussion of all Anglo-German problems.

The new move gave rise to various conjectures including reports Great Britain was taking the initiative to negotiate a four-power aviation pact.

There were indications that Sir Eric's visit was allied with direct reference made by Sir Samuel Hoare, foreign secretary, to Anglo-German problems in his speech of December 5 in the house of commons.

Sir Samuel stated the British government was already to seize any opportunity which offered itself for an aviation pact and the reduction of air armaments which he claimed are more urgent needed than ever.

The flame of resentment against the government for its Italo-Ethiopia peace for war was banned by the publication of a "white paper" showing that the Foreign Secretary had instructed the British minister to Ethiopia, Sir Sydney Barton, to press Emperor Haile Selassie urgently for a favorable consideration of the plan and "on no account" to reject it.

College Trustees Forbids Teachers To Seek Offices

Plans Discussed by Board for Offering Commercial Work at East Carolina Teachers College

The Board of East Carolina Teachers College at their meeting on Thursday, acted on several matters concerning the policies of the college. One resolution passed is as follows: "That no teacher or employee of the College may run for an elective office while employed by the College. If any one announces himself a candidate for any public office, he is expected to resign his position with the College."

The plans for offering commercial work leading to a degree in commerce were heartily approved. The members of the Board realize that there is great demand from the high schools in the State for commercial teachers with standards on the same level as those of other subjects, and feel these teachers should be trained in a teachers college. Work in this department will be offered in the winter term, which will begin on January 2.

The president was instructed to fill any vacancies that may occur on the staff with persons that hold Ph. D. degree whenever it is possible to do so.

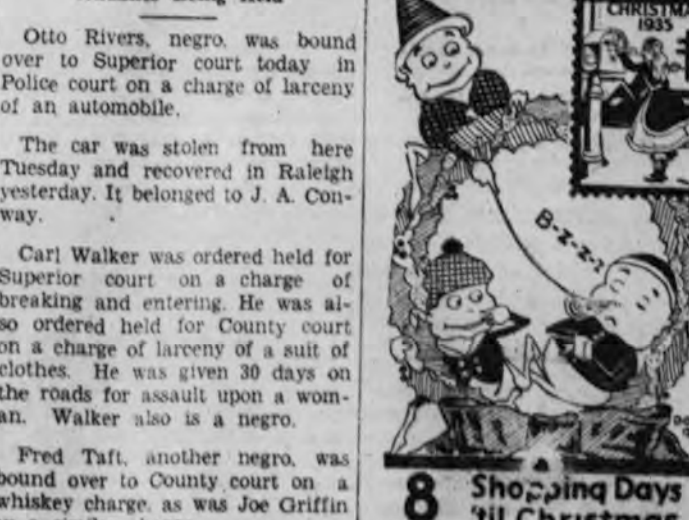

"Pardon me," he said. "Feel that last one."

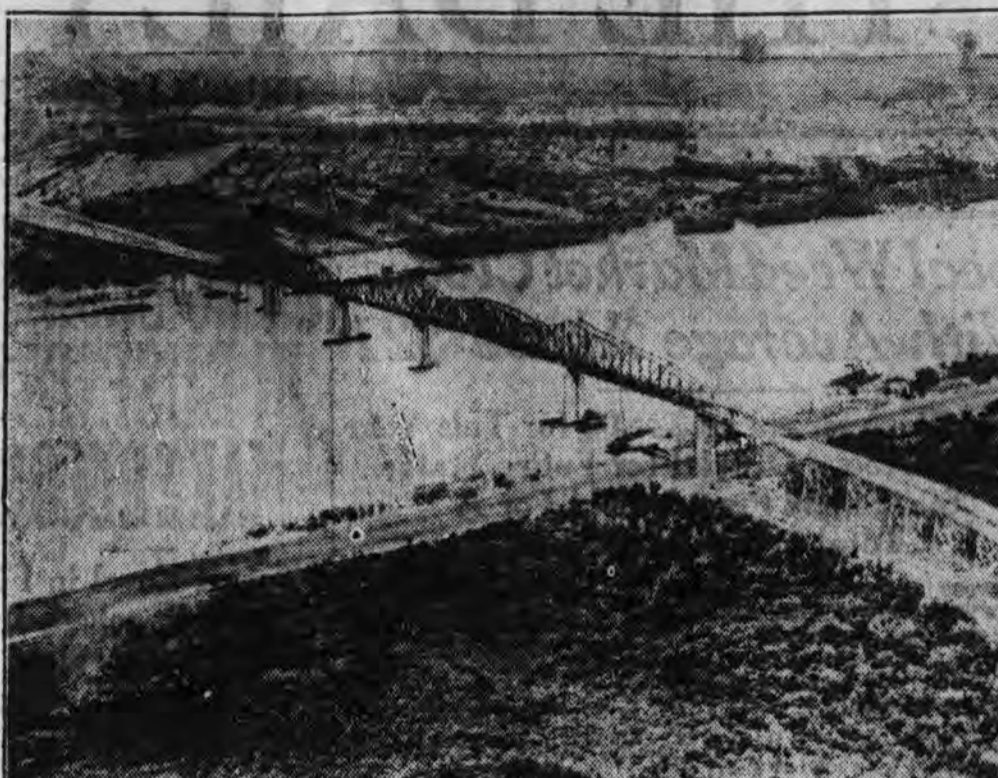
Allaire wouldn't let him shake her. She knew what she wanted, had known ever since her return from South America.

CHANDLER TO HAVE BEARING ON SENATE RACE

Political Gossip Still Says Kentucky Governor Goming

CHIEF PURPOSE AID McDONALD

Much Speculation Is Heard As to Who Will or Will Not Sit on Platform with him

Reflector Bureau, Sir Walter Hotel. Raleigh, Dec. 14.—The visit of Governor A. B. "Happy" Chandler of Kentucky to North Carolina, if reports are correct that he will come to Raleigh early in January and make a speech in behalf of Dr. Ralph W. McDonald of Winston-Salem and thus more or less officially open his campaign for the Democratic nomination for Governor, may also have considerable bearing on the campaign of Senator Josiah W. Bailey for the United States Senate; some observers here believe.

The whole thing is going to depend upon who will sit on the platform with Governor "Happy" Chandler, Dr. McDonald and the others who by that time will be willing to be openly identified with the McDonald faction, it is maintained here. Those who want to get the benefit of the McDonald vote for other offices are expected to be only too willing to accept invitations to sit on the same platform with the youthful Governor of Kentucky who won the governorship of that state by running on almost the same platform that the youthful McDonald is now seeking the nomination for Governor in this state—and anti-sales tax and anti-administration platform here in the state, but strongly pro-Roosevelt and New Deal.

But what will be the attitude of Congressman Harold D. Cooley towards the McDonald-Chandler pep meeting? Will he be friendly in the hope of wooing some of the McDonald supporters, or will he choose to turn the cold shoulder? These questions with regards to the attitude of either the Bailey or Cooley forces will depend very largely upon whether or not Chairman Phillip Whitley, of the Wake county Democratic Executive Committee, is among those present on the platform if and when Governor Chandler speaks here, political observers here maintain. For in addition to being chairman of the Wake county Democratic committee, Whitley is likewise District WPA Administrator for this district, which to many signifies that he has the stamp of approval from Senator Bailey, since if any one worth mentioning has gotten one of the more desirable or important jobs with the state WPA organization without bearing the Bailey O. K., no one here knows anything about it. In addition, Whitley was also campaign manager in Wake county for Cooley in his campaign for the Congressional nomination against George Ross, Pou almost two years ago. Accordingly, he is regarded as being just as close, if not closer, to Cooley than to Bailey.

Those here who know Senator Bailey and who still regard him as being fundamentally a conservative, do not see how he can possibly have anything in common with either McDonald or Governor Chandler. Accordingly most observers here are not expecting Bailey or any of his aides to make any overtures of friendship to the McDonald forces, as much as he would like to get some of the McDonald votes. On the other hand, it is pointed out that Cooley was elected to Congress by virtually the same element in Wake county and the other counties in the Fourth Congressional District which is now backing McDonald—the dissatisfied, disgruntled, anti-existing order element.

If County Chairman and District WPA Administrator Whitley does not choose to sit on the platform as one of the welcome of Governor Chandler and Candidate McDonald, it will be regarded as an indication that neither the Bailey nor the Cooley forces wish to cultivate the McDonald supporters, it is maintained here. But if County Chairman Whitley is among those present on the platform among the welcome, it might indicate that both Bailey and Cooley are willing to get some of the McDonald votes, or that only Cooley is in a receptive attitude. There is much expectation.

Highway Legends For Road Markers Been Completed

New Group Brings to 13 Total Furnished Manufacturers; First Shipments Expected Soon

Reflector Bureau, Sir Walter Hotel, Raleigh, Dec. 14.—Seven additional legends for historical markers to be erected along the highways of North Carolina have been completed by the special committee of historians and have been forwarded to the manufacturers; it was announced today at the Department of Conservation and Development.

The new group of texts brings to 13 the total furnished the manufacturer. Following are the sites to be marked: Riverside Cemetery, Asheville; Home of Nathaniel Macon, Warrenton; Constitution House, Halifax; Home of William R. Davie, Halifax; Battle of Bentonsville, Johnston county; Joel Lane House, Raleigh and the Stanley Home, New Bern.

Previously completed legends include the following: St. Paul's Episcopal Church, Edenton; Home of John Penn, Granville county; Green Hill Place, Franklin county; Cavalry Episcopal Church, Fletcher; Birthplace of Zebulon B. Vance, Buncombe county; and First English Colonies, Dare county.

The first of the completed plates are scheduled to be shipped by the manufacturer in the next few days, according to word received by the committee, and others are expected to arrive at intervals thereafter.

An appropriation of \$10,000 is available for the current biennium for the erection of the markers, and the project is being carried out cooperatively by the State Historical Commission, the State Highway and Public Works Commission, and the Department of Conservation and Development.

The markers will be rectangular in shape with an ornamental top in scroll effect with the State seal outlined in the center. Width of the plates is 42 inches and the depth 36 inches. Black enameled letter rest on an aluminum colored background. The markers are of cast aluminum. The design has been copyrighted.

Officials hope that available funds will permit the erection of about 100 of the markers during each year of the biennium.

Sudden Death Rides With State Highway Patrolmen

Men Are Often Injured By Careless Drivers

FORCE MEMBERS DISCOUNT FACT

Dangers Attached to Duties of Patrolmen Do Not Keep Them From Carrying On

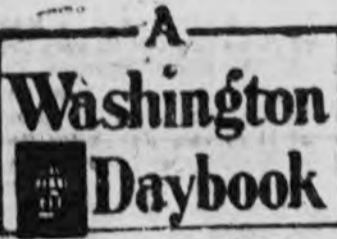
Reflector Bureau, Sir Walter Hotel, Raleigh, Dec. 13.—There are two riders of every highway patrol motorcycle, and additional, leaning passenger in every highway patrol car. You do not see them extra rider or passenger when a patrol motorcycle or car zooms past you pursuing a reckless driver or answering an emergency call.

The invisible rider or passenger is Sudden Death. The same hollow-eyed, perpetually leaning, noseless and toothless old fellow also rides unseen at the elbow of the reckless and careless driver, the speed fiend and the drinking driver. It is the duty of the highway patrolmen to try to stop and warn these drivers not to heed the promptings of the boney-fingered mentor who constantly urges them on to greater speed and recklessness. But in trying to save others from Sudden Death, the patrolmen constantly are forced to take risks and chances that make their invisible companion rattle his bones and emit a hollow cackle of glee.

But the boys on the patrol laugh in his face and carry on, although they well know that old Sudden Death is on their trail day and night. It is just part of the days work—or night's work with them.

Sudden Death has been cheated by the patrol so far this year—but only by the skin of his skinless teeth. The boys know that any minute, any hour he may get his man—or men. He almost got one of them Wednesday night.

Patrolman Henry T. Timberlake of Youngsville is now lying in Rex hospital, an incongruous mass of bandages and plaster casts with both his legs broken between the ankles and knees and with other injuries and lacerations as the result of an attempt by Sudden Death to "get" him. But Timberlake was too quick for him and is still living. But it will be a long time before he will be able to don his uniform again or straddle a roaring motorcycle.

Washington—The widely publicized meeting between Borah of Idaho and McNary of Oregon, Republican floor leader of the Senate, upon their return to Washington, probably is more significant for what was not revealed afterward rather than for what was made known.

Reading between the lines of the published versions of their meeting McNary certainly seems to have given Borah very reassuring word as to his 1936 Republican presidential nomination hopes—if any.

The Oregon senator seems to have implied also, however, that in his judgment the Republican nomination might not be worth very much to anyone.

The Oregon senator seems to reputation as being able to tell just about as accurately as any man in Washington what may happen, expressed the opinion the Idaho senator could get the nomination if he

went after it in earnest, is not denied. What he said about the chances of the Republican party, generally, in '36, however, seems to have been contingent upon the course of events during the coming months.

According to McNary chances for a Republican victory in November would be lessened if: (1) If prosperity continues; (2) If the President does not put further burdens on business; and (3) If the President compels a short session of Congress, devoted to supply bills.

What appears not to have entered into the Borah-McNary discussions at least in the version given reporters, is what effect pending Supreme Court decisions on "new deal" mechanisms will have.

That is a major omission in any attempt to cast a 1936 political horoscope at this stage of proceedings.

There is another uncertainty to be reckoned with and that is Senator Borah's actual objective. If one could dismiss the Borah presidential nomination talk as merely the Idaho senator's personal political ambitions, it would be simple. But like the Hoover enigma, it is by no means certain that Borah's principal goal is obtaining the nomination himself. Wrestling party control from the hands of the eastern Old Guard may, in his own mind, be of greater importance.

Much depends, therefore, on what Borah actually wants.

If it is western liberal control of the Republican party, the most important observation McNary made to him was that he could get the nomination if he really went out for it.

Acceptance of the theory that he couldn't beat Mr. Roosevelt in 1936 merely would mean renunciation of any hope for the Presidency for himself. The nomination nevertheless would give great hope for the dream long cherished by Borah—western liberal dominance of the Republican party.

SMALL CARS MAY BE USED Highway Patrol May Do Away With All Motorcycles

Reflector Bureau, Sir Walter Hotel.

Raleigh, Dec. 14.—The gradual replacement of all motorcycles now being used by the State Highway Patrol with roadsters is being considered by Department of Revenue officials, both to reduce the number of accidents to patrolmen and to reduce maintenance costs. For experience is showing that most of the accidents in which patrolmen are injured involve patrolmen on motorcycles, also that the cost of maintaining the motorcycles is considerably more than the maintenance of the roadsters used by the patrol.

Since September 1, when the enlarged patrol of 120 men went on the roads of the state, 26 patrolmen have been injured, some very seriously. A majority of these patrolmen were injured while riding motorcycles, usually caused by careless automobile drivers cutting out in front of them, or coming out of alleys or side streets. One patrolman is in Rex hospital here with both legs broken as the result of being forced off the pavement by a speeding motorist who was driving on the left side of the road. Others have sustained fractured skulls, collar bones, shoulders, injured knees and feet and other injuries. Since all highway patrolmen and state employees come under the Workmen's Compensation Act, with the state as self-insurer, the state must pay the doctor bills, hospital bills and compensation for these injuries to the patrolmen. If a patrolman should be killed while on duty or die from injuries sustained in an accident while on duty, the state would have to pay his family or dependents \$6,000. So these accidents are becoming an expensive item in the maintenance cost of the patrol.

Accordingly, serious consideration is already being given to the replacement of the 86 or more motorcycles with roadsters, such as are now used by the commissioned and non-commissioned officers of the patrol. The original cost of the roadsters is only slightly more than the cost of the motorcycles, the upkeep cost is considerably less and they are considered to be much safer and if anything, more effective on the highways.

Fletcher States North Carolina Not to Share in Benefits

Reflector Bureau, Sir Walter Hotel.

Raleigh, Dec. 14.—Although a fund of \$49,000,000 will be available January 1 from which the Federal government will grant old age assistance to all persons over 65 years old not to exceed \$15 a month each if the states in which they reside will match whatever the government puts up, those older in North Carolina — between 12,000 and 15,000 of them — who could qualify for this assistance are not likely to get any of it, in the opinion of Commissioner of Labor A. L. Fletcher.

The Federal old age assistance law specifies that this \$49,000,000 will be distributed only to those states which pass cooperating state laws and which will match the Federal funds dollar for dollar. "The Federal act does specify that the money used to match the funds which the government will give may be appropriated by counties, cities or towns instead of by the state," Commissioner Fletcher said. "But it also specifies that this money provided by the counties, cities and towns must be raised under a uniform state law, applying alike to all the subdivisions. But at the present time, every county or city raises whatever funds it provides for poor relief according to a different plan and according to its own needs. So it would seem that despite the fact that the various subdivisions are raising hundreds of thousands by various methods for the relief of the poor and aged, that none of this money can be used to match allotments from the old age assistance fund."

Accordingly, indications are that unless a special session of the general assembly is called, the 12,000 to 15,000 old people in the state who are more than 65 years old and without any income or means of support, will have to go without this money which the Government has placed almost within their reach. This in turn means that the counties, cities and towns in which they live will either have to assume the full cost of caring for them, since the Government has stopped direct relief for unemployables or else let them become dependent upon volunteer charity, it is pointed out. But as yet there is nothing to indicate the likelihood of a special session.

Filipine Leaders Appear Confident Americans Dubious

By EDWARD F. ROMAR

MANILA (AP)—The Filipino leaders are confident they will make a success of the Philippine Commonwealth government, established November 15, when the outlook for complete independence 10 years hence, but some well-informed Americans and foreigners are pessimistic.

While all public expressions are of the sweetness and light order, privately even some of the outstanding Filipinos admit qualms.

"The odds are heavily against the commonwealth," a high American official said privately. "But there still is a chance for success.

Disorder Threats Seen.

"Every surface anxiety is favorable. The budget is balanced and right at the outset of the new regime there is a \$12,500,000 windfall from the United States, representing nine months proceeds of the 1934 American excise tax on Philippine coconut oil. This is about half the insular government's annual budget."

The problems, as outlined by another American official who because of his position could not permit the use of his name are chiefly economic, but also involve public order.

"Everybody who knows the real situation is worried over the possibility of violence from extremist followers of General Emilio Aguinaldo because of their belief they were defrauded in the September 17 election," he said earnestly.

Anti-Quezon Plots Feared.

"We know there have been one or more actual plots already to assassinate President-elect Manuel Quezon.

"Aguinaldo and Bishop Gregorio Aglipay polled a third as many votes as Quezon in an election shot through with frauds, yet they have not a single voice in the national assembly of 98 members.

"That is a dangerous political situation. And there is no new assembly election for three years and the next presidential election is six years hence.

"The Filipino are undertaking to organize an army, under the direction of General Douglas MacArthur. That may cost millions.
