LONG AWAITED HEAVY BATTLE NOW GOING ON

Ethiopians Make The Gains In First Engagement

ITALIANS ROUTED AT WAR FRONT

First Announcement In Which Fascist Government Admitted a Retreat

Asmara, Eritrea Dec. 17.—(AP)—Reports of fighting along the northern front today indicated Ethiopian forces were swooping down on Italian outposts.

Sporadic fighting was known to have occurred today along the front in Tigre province.

It was apparent from the nature of the fighting that the Ethiopians were sending forward closely connected advance guards.

Italian officers said they believe the Ethiopians were testing the Italian resistance prior to mass attacks.

They said that in most cases the Ethiopians swooped down on Italian outposts and engaged in "breast battles" then retired quickly before counter attacks.

Rome, Dec. 17.—(AP)—The long awaited general battle in Ethiopia towards which the Italian and Ethiopian armies have been maneuvering for weeks appeared to be underway today with the first engagement resulting in an advance for the Ethiopians.

The Italian government announced today that Italian troops had retired before an air attack of about 3,000 Ethiopians on the northern front.

This announcement, the first of a retreat, was made in an official communique.

There were considerable losses among the Italian forces including four Italian officers killed and three wounded, nine Italians killed and several dozen Eritrean allies killed and wounded.

Confidence Vote Given By Deputies To Premier Laval

Vote Comes on Franco-British Peace Proposals for Ending Italo-Ethiopian War

Paris, Dec. 17.—(AP)—The Chamber of Deputies, by a vote of 306 to 252, assured Premier Laval today of its confidence in his proposal to settle the Italo-Ethiopian war.

The vote of confidence came after the premier had dared the Chamber to overthrow his government, declaring he refused "to go to Geneva under humiliating conditions."

The Deputies voted on the premier's demands that interpellations of the government on its plan on handling the Italo-Ethiopian dispute be postponed until December 20.

A tumultuous session preceded the vote many spectators joined in the cheers for Laval by his adherents, while the premier's leftist enemies booed and shouted invectives at his supporters in the galleries.

As a result of his success, Laval will go to Geneva to debate the Franco-British proposal for termination of the war, in what he discussed as "a last effort at peaceful settlement."

Expect Winterville School To Reopen Earlier Than Rest

Been Closed Since December 6 While New Deep Well Being Dug To Furnish Good Water Flow

D. H. Conley, Pitt county school superintendent, said today it is hoped the Winterville school will be reopened December 30 after having been closed since December 6 while a deep well is being dug.

The school was closed two weeks earlier than the regular Christmas holiday was scheduled to start because of the water situation. The board of education ordered the digging of a deep well to insure a pure flow of water.

By opening a week earlier than the rest of the schools in the county after Christmas holidays, the school will be only one week behind. Mr. Conley said this time would be made up at the regular end of the term.

Robert Ernest Pittman, 20, Is Killed In Auto Wreck

Young Greenville Man Dies Early This Morning As Automobile Fails to Make Sharp Turn Six Miles From Rocky Mount

Robert Ernest Pittman, 20, Greenville tobaccoist who had been employed on the Rocky Mount, market during the past season, was killed early today as his automobile failed to make a sharp curve six miles from Rocky Mount.

Funeral services will be held tomorrow afternoon at two o'clock from the Memorial Baptist church here. Rev. A. W. Fleischman, pastor, will be in charge. He will be assisted by Rev. R. C. Grady, pastor of the Presbyterian church, and Rev. H. M. Wilson, pastor of Falkland and Farmville Presbyterian churches.

Burial will be in the family plot in the Falkland cemetery, by the side of his father. Pittman left here yesterday to go to Rocky Mount on a personal visit. Highway patrol officers here quoted Patrolman Burdette, who investigated the fatal wreck, as saying the boy left Rocky Mount shortly after midnight last night and started home.

POLICE STUDY COUNTY COURT DEATH OF STAR HEARS CASES

Circumstances Baffling In Death of Thelma Todd, Actress

Hollywood, Dec. 17.—(AP)—The death of Thelma Todd, lovely blond film comedian, baffled investigators today.

She died of carbon monoxide poisoning Dr. A. F. Wagner county surgeon reported after an autopsy. But the circumstances of the death remained a strange mystery, complicated by the autopsy surgeon's report she died at dawn Sunday and Mrs. Martha Ford's statement she talked by telephone with the actress Sunday afternoon.

The body of the 30-year-old actress was found behind the wheel of her big touring car in the garage about 10:30 a. m. yesterday by her maid, May Whitehead. Miss Todd's face was bloody.

Her expensive mink coat, her jewelry — three large diamond pieces — and her purse were untouched. The ignition key was in the lock of her car and it had been turned on.

Three questions puzzled police: How did she get there? Why did she go to the garage? What happened here before she died of monoxide poisoning despite the fact that the doors were open when she was found.

Men Of Same Name in Automobile Wreck

Highway patrolmen today were investigating a wreck last night on the Vanceboro road between two automobiles driven by men of the same name.

They reported that cars driven by Dr. B. E. Moore of New Bern and B. E. Moore of Greenville collided, apparently caused by a trailer on the New Bern car, turning the Greenville car over and damaging it considerably. The other car was not damaged to any extent and none of the occupants of either car was hurt.

Dr. Moore was accompanied by his wife, while there five persons in the Greenville Moore's car. In the trailer on the New Bern car was a mule. The animal also escaped injury.

SEEK DEVISE SOCIAL PLAN

Social Security Office Coming To N. C.

Washington, Dec. 17.—(AP)—The office of Senator Robert R. Reynolds of North Carolina was advised today that Thomas H. Elliott, general counsel of the Social Security Board, expected to go to Raleigh shortly to try to work out a plan for the state to benefit from the federal unemployment insurance when it becomes effective Jan. 1.

Elliott, it was said, probably will go to the North Carolina capital after Christmas to confer with Gov. Ehringhaus and Attorney General A. A. F. Sewell who are seeking to have upheld and enabling acts passed by the 1935 legislature. The counsel expressed considerable doubt whether the board could sustain the act regardless of any rules and regulations that may be submitted by the state.

Wesley McDonald, secretary to Senator Reynolds, said Elliott told him the North Carolina statute made no provision for payments of benefits, making a solution to the problem most difficult.

McDonald said the counsel "stated emphatically the question did not have to be disposed of by the first of the year."

NORMAN DAVIS SAYS NO NEED NEW TREATIES

Declares that Neither Countries To Take Offensive

JAPAN REFUSES RETREAT A STEP

Admiral Nagano Replies Modern Ships And Weapons Endangering Japan

London, Dec. 17.—(AP)—The U. S. delegates to the international naval conference promised today they would study British proposals for a naval agreement in a "friendly spirit" on the definite understanding, however, that the proposal would not contain a major variation from the principal of existing treaties.

The British plan is that each naval power — Great Britain, United States, Japan, France and Italy — should make a unilateral or individual public declaration of its naval building program for a period which the British suggested should be about six years.

London, Dec. 17.—(AP)—Norman H. Davis, the U. S. chief delegate to the International Naval Conference today told the Japanese delegation that in as much as neither the United States nor Japan has any intention of taking the offensive against the other there is no reason to change the existing relative power of their two navies.

He made this statement to Admiral Osami Nagano, the chief Japanese delegate, directly across a private conference table. Davis told the assembled conference that the usefulness of the Washington treaty of 1922 — which set the British-American and Japanese navies on a 5-5-3 ratio — had been fully demonstrated and that there was no reason to change the existing system.

Admiral Nagano, however, did not retreat a single step from Japan's demands for equality with the United States and Great Britain in sea power, declaring that Japan had made great sacrifices in the Washington treaty ratio.

He said these sacrifices would not be repeated in as much as modern ships and weapons had rendered Japan's position more dangerous.

In informed quarters it was stated that the American-Japanese conference could be regarded as resulting in a draw.

After the meeting, the American delegation went to the British admiralty to thrashout the details of the Japanese plan with the British. The British are standing solidly with the United States against the Japanese demands for parity.

Nevertheless, the British delegation proposed a compromise for fleet tonnage limitations.

The suitable novel crop is especially good this Christmas. For those who can take their reading rough-hewn, there is Vardis Fisher's "We Are Betrayed," in which a man's tattered soul batters against life. These have their place also:

"A House Divided" (Pearl S. Buck); "Lions Starve in Naples" (John Fabrics, and one of the "Forgive Adam" (Michael Easter, "Forgive Adam" (Michael Easter, of which the same is true); "Of Time and the River" (Thos. Wolfe); "A Few Foolish Ones" (Gladys Haslett Carroll); "Europa" (Robert Briffy); "A Day at Intellectual Snobs"; "Claudius the God" (Robert Graves); "Roll River" (James Boyd); "I Can't Happen Here" (Sinclair Lewis' best in years; "Vein of Iron" (for Ellen Glasgow's admirers); "The Wind Blew West" (Edwin Lanham, strong novel of Texas); "Honey in the Horn" (H. L. Davis, strong novel of Oregon).

For the slightly more literary, what could be wiser than Vincent Sheean's "Personal History," or Francis Hackett's "Francis the First," or south of the Mason-Dixon line, Douglas Southall Freeman's "R. E. Lee"?

Two of the best personal stories, besides Mr. Sheean's are William Seabrook's "Aylmum" and Walter Duranty's "I Write as I Please." Those who delve into the past should be given Will Durant's "The Story of Civilization" volume one, which is about the Orient. Or perhaps Harry Elmer Barnes' "History of Western Civilization." Walter Mills' "Road to War" is a grace to any shelf.

We may be wrong, but some of the best humor, conscious and unconscious, seems to have been in the blood-and-thrills literature this year. Those who can take murder with a guffaw will delight in Edwin Greenwood's "The Dandy Dagger," or Richard Hull's "The Murder of My Aunt." Intended seriously, but quite funny nevertheless is "Vidocq," the Personal Memoirs of the First Great Detective.

Gerald Bullett's "The Jury" is a grand crime story; the stories of a number of real life murders may be found in Fletcher Pratt's "The Canning Mulatto, and Other Cases

of Ellis Parker, American Detective.

For your communist friend, Franz Mehring's "Karl Marx; the Story of His Life"; for your musical friend, "A Musical Companion," edited by John Erskine; for your scientific friend, "Outposts of Science," by Bernard Jaffe; for your literary friend, "The Life of Washington Irving," by Stanley Williams; for the children "The Turcutter's Donkey," by Patricia Lynch; "The Bear Twins," by Inez Hogan; "Adventures in Puddle Muddle," by Mary Graham Bonner.

Talk of Pinchot.

The progressives contend that for the party to go into the control of the conservative east, allied with the monopolistic interests, would have a decidedly unfavorable reaction in the west and that the west must be carried if President Roosevelt is to be beaten.

As a development in the plans of the progressives to dominate the party, it is reported that Gifford Pinchot, twice governor of Pennsylvania, may toss his hat in the ring in the fight for the presidential nomination. Pinchot's friends in the west are said to be urging him

## SCOUTS WANT OLD LICENSES

### To Be Used in Roofing On Cabin To Be Built

With the hopes of building a cabin in the spring, Greenville Boy Scouts today asked the people of the city not to discard their old 1935 automobile licenses, but to save them to be used as a roof for the proposed building.

The Scouts will make a canvass of the city and gather the outdated plates and keep them until they are ready to use them this spring.

They have asked that the license plates be left at filling stations if convenient to the car owner, or if not keep them about home until a later date when arrangements will be made to gather them up.

The Boy Scouts are trying to erect a cabin at an small cost as possible and conceived the idea of using the old plates for the covering of the building.

## EMPLOYMENT ON INCREASE

### Regular Seasonal Losses Bring Gains Down, However

Reflector Bureau, Sir Walter Hotel, Raleigh, Dec. 17.—Employment in North Carolina decreased seven-tenths of one per cent in November, based on reports from 251 firms and industries, according to figures released today by the State Department of Labor. With the exception of a slight decrease in industries always showing a seasonal decline in employment, there was a general increase shown in most others, the figures show.

A gain of 1.1 per cent was shown in employment in the merchantable industry in November, of 4.8 per cent in miscellaneous manufacturing industries and of 7.9 per cent in the laundry industry. There was an increase of 1.7 per cent in the furniture industry and of one-half per cent in the hosiery industry of 1.8 per cent in the baking industry and of 2.6 per cent in the industries reflecting an increase in the building industry.

The largest decrease was in the tobacco industry with a decrease of 4.8 per cent caused largely by the closing of warehouses and drying plants in sections where the tobacco sales season has ended. The textile industry showed a decrease of only two-tenths of one per cent while the lumber industry showed a drop in employment of 1.5 per cent.

The reports from the 151 industries which reported to the Department of Labor in November showed a total of 21,867 employed as compared with 21,935 in October. "Since the slight decrease in employment in November was caused almost entirely by the decrease in employment in the tobacco warehouses and drying plants, the report as a whole actually indicates a substantial increase in most of the major industries," Commissioner of Labor A. L. Fletcher pointed out. "We think it significant that the decrease in employment in the textile industry was only two-tenths of one per cent and that there was an increase of one-half per cent in the hosiery industry."

## PENSION PLAN IS SUPPORTED

### Sentiment Growing For Some Plan In State

Reflector Bureau, Sir Walter Hotel, Raleigh, Dec. 17.—Sentiment for some sort of old age pensions that will apply in North Carolina is not only growing rapidly among the older people of the state who would be eligible to such pensions, to the younger element as well, it is pointed out here by those who get cut over the state and hear what people are talking.

It is also conceded that Dr. Townsend and his pension plan are getting more and more support and that the oldsters are already organizing in some sections. The Townsend plan would give a pension of \$200 a month to every man and woman 70 years old or more, provided each person receiving this pension spends every bit of the \$200 each month. Dr. Townsend claims that this plan will put money into circulation, take oldsters out of jobs thereby creating more jobs for younger people, and thus end the depression.

Few of the more thoughtful observers here believe however, that there is any chance for the Townsend plan to be enacted, since it was overwhelmingly rejected by the last session of Congress and because it would be entirely out of keeping with the present trend of the Roosevelt administration towards less spending for relief, instead of towards more spending. So only the more idealistic have any hope of the Townsend plan ever being put into effect.

There is a definite belief, however, that the state should and can participate in the Federal old age assistance fund of \$40,000,000 which has already been set up and under which those over 65 years of age could get up to \$15 a month in Federal funds, provided the state or its subdivisions will put up an equivalent amount. It now seems, however, that North Carolina will not be able to share in this fund since there is no cooperating law for the state to participate in it. There is already a strong sentiment for a special session of the general assembly to enact and co-operating law so that this state can share in this old age assistance fund.

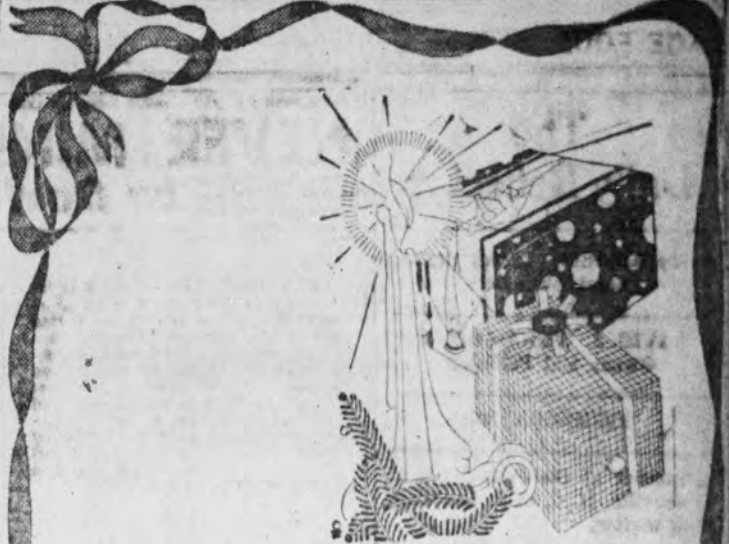

turbed them. They figure the airman fell into the ocean and not, as some suggest, into the clutches of foreigners eager to learn our aerial secrets. "Bnk," they say of "reds" and spies. "If any turn up in our outfits, the non-coms beat hell out of 'em." The Navy doesn't trust to direct action; it will press Congress to pay an anti-spy and anti-red law at the next session.

LONDON: Republican Old Guardsmen aren't putting all their 1936 eggs into any one candidate's basket. They would throw their arms around anybody—even "Bill" Borah of "Ham" Fish—who submeats a sworn statement that he can defeat FDR.

But it is known in inner circles that their original entry was Col. Frank Knox in the presidential derby. It was at the bosses' urging that he went out to make a political name for himself and to try his water wings. But the results have not been entirely satisfactory to his wishful sponsors. His candidacy has met indifference in the east and west. He has bungled the issue which will give the GOP a head-start next year—the AAA.

The president-makers' new favorite is Governor Al Landon of Kansas. Despite his fairly liberal background, he impresses the easterners as a safe-and-sane bet. GOP-ers coming into Washington for the executive committee meeting are talking him up.

BITTER: Securities Exchange Commission sleuths note a sudden flurry of publicity favorable to repeal of the holding company law now before the courts. It presages a strong demand for wiping the legislation off the books at the next session.

Perhaps the most effective good-will gesture fell under radio talks and in letters to members of Congress it is setting forth the practical benefits of its tieup with the Electric Bond and Share. The propaganda started soon after the SEC filed suit against the parent corporation—an offspring of General Electric—in New York.

The Florida company contends that it could not have repaired damage caused by the recent hurricane unless its rich connection had financed the insurance. It cites that as dramatic evidence of the need for a holding company setup. But SEC-ers point out—and will do so publicly soon—that the local corporation paid \$135,000 annually in insurance premiums and assessed it as an operating charge against the customers. Behind the scenes the fight is growing more bitter every day.

New York By JAMES McMULLIN TRADE: One of the most important phases of the prospective settlement between Britain and Italy hasn't yet been mentioned out loud. It probably won't even be incorporated in the peace agreement—although it will be a vital factor in inducing Mussolini to accept terms. It will consist—confirming our prophecy—of substantial financial assistance to Il Duce for the dual purposes of relieving his domestic

But underneath the words the most careful observers note that the conservative trend continues in Washington policy. Reviling New Deal enemies is one thing, interfering with recovery quite another. Continued recovery is still Mr. Roosevelt's safest for reelection.

BURDEN: Keen analysts say that the New York City sales tax is weighing heaviest on persons of modest means. The point is that the tax is not paid on total purchases but on the total purchases in each department.

For example, ten different purchases on the same day in different departments of a five and ten cent store—the poor man's store—may work the tax up as high as ten cents on the dollar.

The same reeling applies to the more expensive department stores and specialty shops—with a resulting increase in the average burden.

# LIFE IN 1935

(Editor's Note: This is the first in a series of 12 stories showing how the events of 1935 have affected the man in the street.)

The "average citizen," looking over the family budget had a hard time deciding how 1935 had affected his personal fortunes and what the year's economic developments portended.

John Smith heard the farmer was doing better, industry was producing more, the stock market trend was upward, the movies were showing millions into productions, the Baer-Louis fight gave Broadway its first golden evening in years, football attendance was up 10 per cent. Many unemployed.

Was the depression really behind? He heard also that an army of unemployed numbering millions remained at the year-end, that the cost of relief was running into billions, that the attack on major "new deal" legislation continued.

Was there trouble ahead? John Smith could get any answer he wanted, depending upon what politician he asked, what statistics he consulted.

He was told that in the first eight months of 1935, the total income of workers rose 5.6 per cent, but labor economists argued that during the same period living costs went up 5.9 per cent.

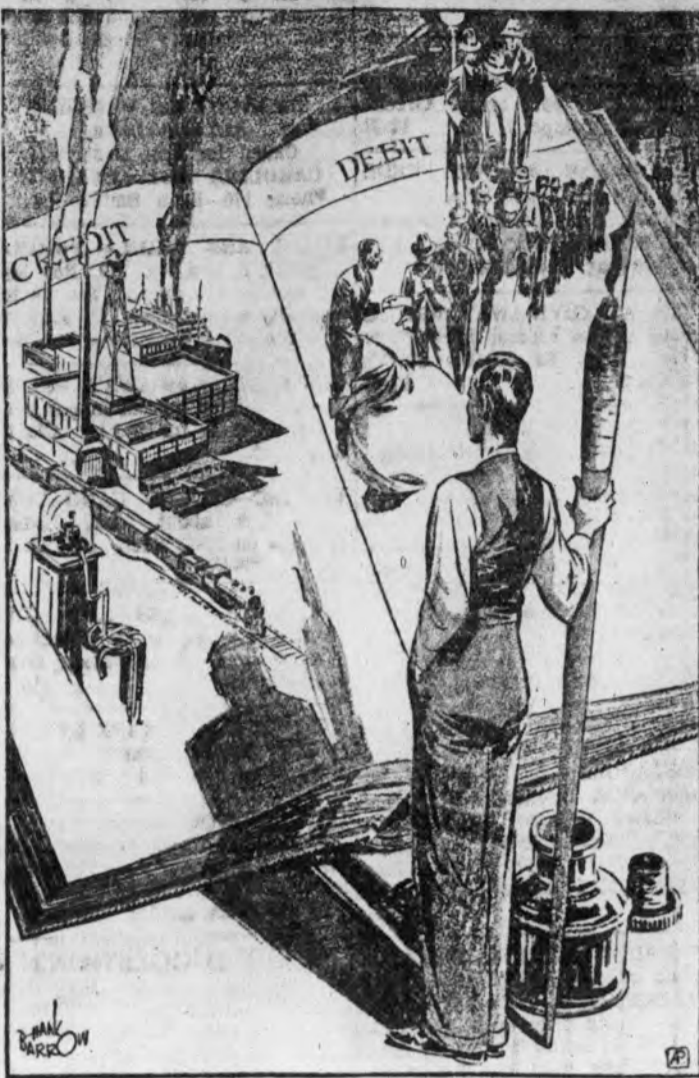
On November 5, retail food costs for the country as a whole were 6.5 per cent higher than on that date a year ago. Rental costs were up slightly said the department of labor, but there was little or no change in clothing prices.

Employment was up, too. The government's bureau of labor statistics said the factory employment index reached in October was highest in five years, and the factory payroll index the highest in four and a half years.

Industries Gain. But John Smith was told the earlier introduction of new automobile models this year accounted for some of the October gain.

Most important fall employment gains were in these industries: automobile blast furnace, steel, rolling mills, machine tool shops, furniture and knit, woolen and worsted goods. Employment figures remained low in brick, tile, marble, granite, slate and cement industries; in railroad repair shops, in locomotive building, in hardware, in lumber.

There were more jobs, but still far from enough to go around.



At the start of the year, the relief population numbered 20,669,647 persons, an all-time high. In September it fell to about 16,000,000, but a new climb was expected during the winter.

Record Relief. The record relief population, including about one of every seven persons, may not have startled John Smith, used to big figures these years. But the sum to provide work, announced by President Roosevelt and appropriated later, may well have taken his breath away. It was \$4,880,000,000.

The new program was designed to provide work for 3,500,000. Industry, it was figured, would absorb another 3,500,000. Part of the appropriation would be used for tapping in the debt.

In December officials announced the job-creation goal had been

reached, that federal direct relief was over, that henceforth state and local governments would be responsible for the 4,000,000 unemployed as well as any able-bodied needy man then working. Industry, however, had not absorbed anything like 3,500,000. From October to October the increase in private payrolls was estimated at only about 900,000 persons.

Answers In 1936. Would the 9,000,000 jobs registered with the United States employment service in November ever get work in private industry? Would a large part of the administration's recovery and reform program be set back on constitutional grounds as was the NRA? For the answers to such questions John Smith had to look ahead.

## OLD LINERS GROW TIRED DISSIDENTERS

### Regular Democrats Peevish at Anti-FDR Talk

### SAYING LITTLE OUT IN OPEN

### Are Irritated at Under-Cover Campaign Being Waged by Liberty Leaguers

Reflector Bureau, Six Walter Hotel. By J. C. BASKERVILL

Raleigh, Dec. 17.—Not much is being said about it out in the open, the rank and file of the "regular" Democrats in the state who are still for President Roosevelt and the New Deal 100 per cent, are getting good and tired of the under-cover, gum-shoe campaign against the Roosevelt administration being carried on in the state by the Liberty Leaguers, assisted by a good many of the big banks and industrialists in the state.

They are especially peeved at those who still maintain they are Democrats and will vote the Democratic ticket but who already are announcing that they will not vote for Roosevelt again.

So far, not much has been said or heard about this anti-Roosevelt campaign in the state, although it has been going on for months, well ciled with money from disgruntled capitalists in the North many of whom—always have been and still are—Republicans, it is maintained. But not only are some of the "regular" Democratic leaders becoming irritated by these anti-Roosevelt activities—the ranks and file of the voters who are stronger backers of Roosevelt now than ever before, are becoming irritated. Some are even threatening reprisal. It would not surprise some observers here to see a definite movement develop for the election of a complete "New Deal" administration for the state government, including a majority in both houses of the general assembly by the pro-Roosevelt Democrats if the anti-Roosevelt forces do not call off their dogs here within the state. That the pro-Roosevelt forces can do this, if they once get aroused and mad, is freely admitted, since it is agreed that the Literary Digest poll shows that North Carolina is still approximately two to one for Roosevelt.

During the past week or so a group of officials of a large industrial organization known to be greatly out of sympathy with the New Deal, visited a group of busi-

ness men and merchants in a neighboring smaller town in an effort to get their support in opposition to Roosevelt, according to a report heard here today. After the meeting—held behind closed doors—one of the visiting industrialists walked up the street with one of the local Democratic leaders and business men.

"You were here about three years ago, weren't you?" the local business man asked the visitor, who agreed that he was.

"Do you remember how many vacant store buildings were on the main street here then?"

"Yes, it seems there quite a number—about 15, if I remember rightly," the visiting official said.

"You have a pretty good memory—except there were 17 vacant buildings here then—and as I remember, neither you nor any of your associates came here to offer us any help or assistance then—You, like the rest of us, were wondering how much longer you could hold on or pull through. Your backs were to the wall, just as ours were. Do you see any empty store buildings here now on this street?"

"No, there are no empty stores or buildings on this street now—and the merchants are doing a good business—but not because anything you or the corporation you represent have done, but because of what President Roosevelt and the New Deal have done for the farmers and the working people.

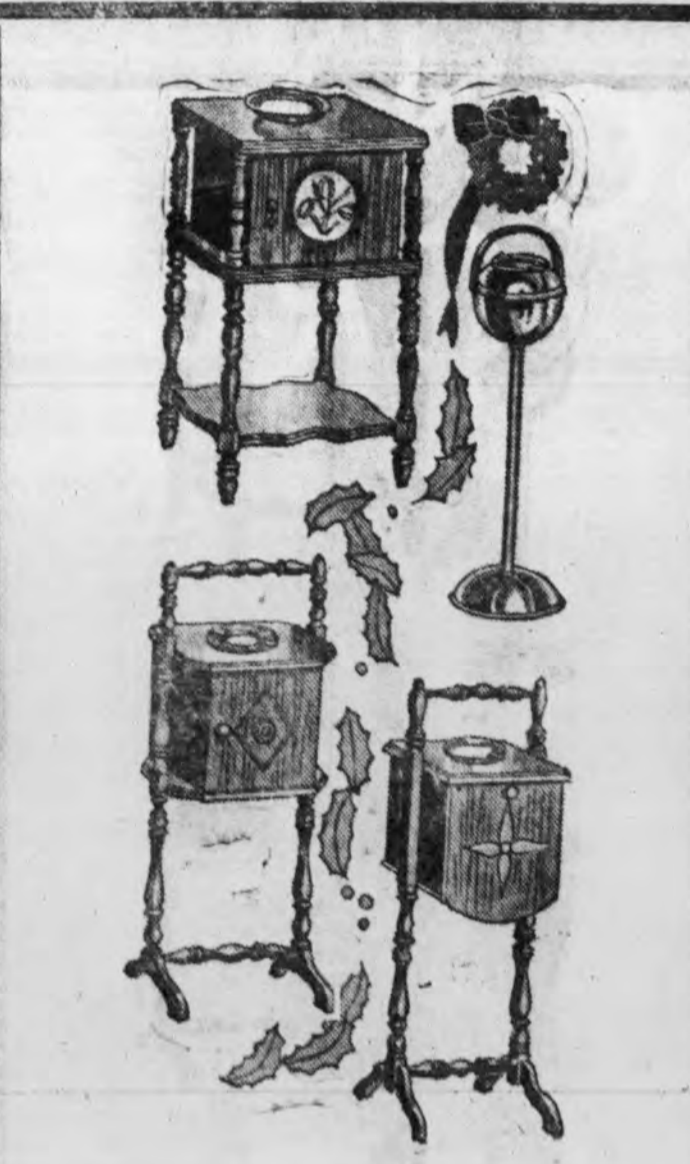
"My advice to you is to go back and not make any more visits or hold any more meetings trying to drum up opposition against Roosevelt—for the rank and file of the people believe in him and the New Deal a whole lot more than they do in you and your organization."

This is just one incident, that has passed a few days ago—but it is typical of feeling in all sections of the state, according to most observers here. For while the people now making \$50,000 a year are peevish and sore because they are not making \$100,000 a year, the rank and file of the people of small and moderate means—and they are the ones who have the votes—know they are better off than they were three years ago and are willing to give Roosevelt the credit, it is maintained. So unless the corporations and wealthy want to get socked even more than in the past—and by the state government this time—they had better soft pedal their opposition to the New Deal, many political observers here agree.

WASHINGTON DAYBOOK

By HERBERT PLUMMER Washington—The predicted drive for economy in government during the coming session of Congress is beginning to take on the appearance of reality. A thin-lipped Texan, with bushy hair and a determined jaw is sending shivers up and down the spines of bureaucrats around Washington since his arrival in town the other day. He is James P. Buchanan, chairman of the House Appropriations Committee, the key man in the forthcoming battle over government expenditures. "Economy-bent Buck" is the sobriquet already given him on capitol

itol hill and it doesn't bother him at all. Pledged to bring the federal budget within \$800,000,000 of balance next session, he has adopted as his slogan—"Reduction all along the line."

Why Not Cut?

Consider Buchanan's attitude, for example, on the social security act passed in the last session providing for old-age pensions, child, blind and health aids. Operating funds for the vast program were held up when the bill carrying the appropriation was filibustered to death in the closing hours of the session. The social security board has operated since on a shoestring.

Shrewd Trader

As chairman of the Appropriations committee, Buchanan is in a position to go far toward having his way in the matter of economy. Not only is he master of his committee which controls the purse-strings of the nation, but because individual members of the House hesitate to alienate a committee from which they may seek favors later, he usually comes out on top where expenditures are concerned. He has demonstrated his ability to hold his own with the Senate on the matter of spending, too. When it comes to adjusting differences between the two houses, Buchanan is a shrewd trader. Circumstances may force him to sponsor additional emergency expenditures in the coming session. He'll do it if convinced it is absolutely necessary. That's how "regular" he is. But he is "economy bent" and although he expects "a devil of a fight," he's ready for it.

Contracts Issued in November Up 95 Per Cent

Raleigh, Dec. 17.—Building permits issued in November in 20 cities of the state of more than 10,000 population amounted to \$587,156, representing an increase of 95.3 per cent as compared with the building permits issued in these same cities in November, 1934, according to figures compiled by and released today by the State Department of Labor. These figures represent an increase of 302 per cent over the building figures for November, 1933 which amounted to only \$140,173. The building permit total for November, 1934 was \$300,662.
