GOV. HOFFMAN SAYS KIDNAP YET UNSOLVED

Declares Ultimate Solution Not Been Reached

"STANDS GUILTY AS CONVICTED"

Answers Question As To Whether He Believes Hauptmann is Guilty of Kidnaping

Trenton, N. J., Dec. 18.—(AP)—Gov. Harold G. Hoffman said today he was satisfied the Lindbergh baby kidnaping murder case had not been fully solved, but that he had never expressed "any element of doubt" as to Hauptmann's guilt.

"Hauptmann stands guilty," he said "as convicted by the courts."

Asked if he believed the ultimate solution of the case had been reached, the Governor said:

"In my opinion it has not. No state official is warranted in thinking that it has and saying that the books are closed. You can't quote me, however, as saying there is any element of doubt" as to Hauptmann's guilt. The courts have passed on that."

Questioned as to whether that statement meant he believed Hauptmann guilty, the Governor replied: "He stands guilty as convicted by the courts."

Washington, Dec. 18.—(AP)—The National debt reached \$30,555,791,997 today passing the \$30,000,000,000 for the first time in history.

The new high was caused by middle December financing operations which added \$962,639,937 to the debt.

The debt was near the figure estimated by President Roosevelt for the end of the fiscal year, next June 30—\$30,273,000,000.

The deficit today stood at \$1,606,711,375 compared with the year-end estimate of \$3,281,600,000. Expenditures were \$3,307,348,286 compared with full year estimates of \$7,752,332,000.

These figures indicated to some the possibility that the public debt when the 1936 fiscal year closes in June may exceed the President's September estimate.

But if budget plans are carried out a half billion dollars remains to be cut out of the debt between now and June 30.

Receipts for the present fiscal year to December 16 were \$1,700,636,910 compared with \$1,663,891,727 in the same period last year despite a big lag in processing tax payments pending court challenges of the AAA. Collections of this tax have amounted to \$65,000,000 this year as against \$263,000,000 last year.

The \$3,307,000,000 expenditures compared with \$3,243,000,000 last year. "Emergency" spending stood at \$1,411,000,000 compared with \$1,723,000,000 in 1934.

Thelma Todd's Maid Testifies About Death

Los Angeles, Dec. 18.—(AP)—May Whitehead, negro maid of Thelma Todd, at the inquest today, discredited the story told by police by Roland West, cafe partner of the film actress that he "locked her out" of her seaside apartment.

The maid, testifying about the death of the blonde actress, told Coroner Frank Nance that before Miss Todd left Saturday afternoon for a Hollywood restaurant party, he gave her a key to the side door of the apartment.

West had previously told detectives that he waited up for Miss Todd until about two a. m. Sunday and then retired, having "locked her out."

"Can you account for the fact that she was in the garage," asked Coroner Nance.

"No," said the maid.

"Do you know of any reason why she could not have gotten in?" "I gave her a key to the side door which she kept in a coin purse," was the maid's reply.

Earlier George Rochester, foreman of the grand jury demanded that an analysis be made of Miss Todd's stomach to determine if poison was present.

Franco-British Formula For Settling African War Described As Being Dead

Assertion Made By One Power At Geneva

IL DUCE AGAIN BELLIGERENT

Premier's Language Filled With Assertions Italy Would "Fight to The End"

Geneva, Dec. 18.—(AP)—Great Britain practically abandoned the Franco-British peace plan in the league of nations of council today and Ethiopia indicated it would not accept it anyway.

Anthony Eden of Great Britain said his government would not stay with the plan unless Ethiopia, Italy and the league all accepted.

Wolde Mariam, the Ethiopian delegate immediately rose in the council chamber to attack the plan. While he carefully refrained from making an official reply, he made it clear the plan was not acceptable to his nation.

The council then adjourned indefinitely to await definite replies from Ethiopia and Italy.

The latter had no representatives present at the session. Mariani referred scornfully to the Italian army speaking of the fascist campaign in Ethiopia as a "slight advance" which had taken Premier Mussolini's soldiers two and one-half months despite the fact Italy had the most highly perfected arms ever taken to the soil of Africa.

(By The Associated Press) The Franco-British formula for settling Italy-Ethiopian war was described as "dead" today by a representative of one Europe's great powers at Geneva.

The declaration followed conferences by Anthony Eden, British minister of league of nations affairs with Russian-Spanish and Turkish member of the league council gathered to consider the Franco-British plan among its problems.

The Italian delegation has announced it would not be represented at the session. At Rome Premier Mussolini, again aggressively belligerent, defied Europe to stop his campaign in Ethiopia.

Sharply focused on the diplomatic front was the replacement of Pi Duce's more amicable utterances lately to peace negotiations by an attitude expressed in his description of Europe as "crooked."

High Fascists said the speech, delivered at Pontinia, constituted Mussolini's reply to the peace plan drawn up in Paris by Premier Pierre Laval and the British foreign minister Sir Samuel Hoare.

It bristled with assertions Italy would "fight to the end" and that Europe was guilty of "egotism and hypocrisy." The council of the league met in a funeral atmosphere to go over the Franco-British peace plan almost unopposed by the smaller nations of the league, while speculation arose in league circles over the possibility of a new covenant based on international conciliation without provisions for punitive sanctions. This would pull the teeth of the league's authority to enforce its decisions.

League officials hoped faintly Great Britain might pronounce the Paris peace proposal dead, but advances from London and Paris to Geneva, failed to indicate those governments plan to repudiate the scheme, regardless of the opposition to it.

Another element cropped up in the council discussions of peace at Geneva. It was a possibility of abandonment of a United front for peace. In favor of a conception of relatively peace. In other words some delegates are inclined toward accepting an unsatisfactory peace in east Africa to keep the lid on the pot of European animosities.

FUNERAL HELD FOR PITTMAN

Robert Ernest Pittman Buried in Falkland

Funeral services for Robert Ernest Pittman, 20, popular young Greenville man, was held from the Memorial Baptist church this afternoon at two o'clock. Rev. A. W. Fleischman, pastor of the church, was in charge of the services which were attended by a large crowd of friends and relatives.

Mr. Fleischman was assisted in conducting the final rites by Rev. R. C. Grady, local Presbyterian minister, and Rev. H. M. Wilson, pastor of Farmville and Falkland Presbyterian churches.

Immediately following the services here the funeral cortege left here for Falkland, where the body was interred in the family plot by the side of the young man's father, who died several years ago.

Pittman was killed early Tuesday morning in an automobile wreck while on his way home from Rocky Mount.

Pittman was graduated from the Greenville high school in 1933. In the fall of 1934, he entered Mars Hill college, but matriculated at Smithfield Business school in Richmond, Va. He was a member of the Alpha-Pi-Delta fraternity.

After attending the business college, he was employed by the Imperial Tobacco company and worked out from the Rocky Mount branch. His duties took him to South Branch, Va., and to Roxboro, having worked at the latter place more recently.

He was born and reared in Greenville and was a member of the Memorial Baptist church.

He was the only child of Mrs. R. E. Pittman of this city. Other survivors include three aunts, Mrs. A. P. Godwin of Gatesville, and Mrs. L. T. Pierce and Mrs. R. C. Thornton of Farmville; and two uncles Dr. E. E. Pittman of Oak City and H. G. Pittman of Falkland.

Pittman was killed, according to investigating officers, when the car he was driving failed to make a curve and turned over several times near Pinetops early yesterday morning.

# Some Form Liquor Control Is Predicted By Observers

## Method of Sales To Be Issue At Stake

### MANY CONVINCED DRYS HELPLESS

### Leading Gubernatorial Candidates Are Expected to Say Little About Question

Raleigh, Dec. 18.—The liquor question is no longer going to be a major issue in the campaign for Governor, due to the fact that to all intents and purposes the state has already voted on liquor, according to most of the political observers here.

They are convinced that regardless of the position taken by the various candidates for Governor and of who is nominated and then elected Governor, the 1937 general assembly will pass some sort of liquor control and liquor sales laws. For even if Cale K. Burgess and the United Dry Forces try to elect dry Democrats and even dry Republicans to the 1937 general assembly, as they have indicated they will try to do, most observers here are already convinced that the 1937 general assembly will be pre-eminently in favor of liquor control and liquor stores, with the only issues whether they shall be under state control or county control, and which shall get the revenue, the state or the counties.

None of the three leading candidates for Governor are expected to say much about the liquor question in the campaign other than to state their position. Both Lieut-Governor A. H. Graham and Dr. Ralph W. McDonald have already made declarations as to their positions on the liquor question and Clyde R. Hoey and John A. McRae are expected to make statements outlining their positions before long. Hoey, though a personal dry and the adopted candidate of the dry forces, is reported to have told individual inquirers that while he is still personally opposed to the sale of liquor in North Carolina, he will not oppose a state-wide referendum on liquor control if elected Governor. Other observers think he would be willing to accept any plan the 1937 general assembly might agree upon, whether a state-wide referendum or county option plan.

Lieut-Gov. Graham has already come out in favor of a state liquor control law and state liquor stores, so that any counties which want liquor stores may have them by voting for their establishment. The most recent reports are, however, that he will be favorable to either a state liquor stores plan under which the state and the counties will share fifty-fifty in the revenue, or one which will permit the counties to set up stores and retain all the revenue, as well as the control, such as now in effect in 16 counties.

Dr. McDonald so far has limited his discussion of the liquor question to a statement in which he said he would agree to a state-wide referendum on liquor control and liquor stores. Despite the fact that he is personally dry and voted against all of the various liquor control bills offered in the 1935 general assembly. But it is not believed he would seriously oppose any plan which the 1937 general assembly might desire to set up if he should be elected Governor. And after all it is agreed that the disposition of the liquor question will be up in the general assembly rather than the Governor and that the personal views of the Governor in 1937 may or may not count for much with the general assembly.

A majority of the counties in the state now would like to have liquor stores and a special session of the present general assembly or the 1937 session will vote to give the counties that want to sell legal liquor and get some revenue from its sale, instead of leaving the sale in the hands of the bootleggers, most political observers here are convinced. Most of them think there would be more real "control" and better conditions under state control than under a county set-up similar to that now existing in 17 counties and the revenue they are earning from their stores, has already converted many of those who were formerly bone dry, it is now agreed.

That the counties which now have liquor stores will fight to keep them and the revenue from them, is generally conceded. But there is going to be such dire need for additional state revenue by the 1937 general assembly that it may be persuaded to set up a state control plan and state stores, under which the state will get fifty percent of the profits and the counties 50 percent. But many counties are going to fight to keep all the revenue for themselves, it is freely admitted.

The anti-Hoover declaration of the Ohio Republican leaders is one of those comparatively small events which sometimes mark the turning point of great political movements. Considered by itself apart from its background of local and national rivalries, the action is not so important. The state central committee, which framed the declaration, does not decide what candidate the state will support, and after all, Ohio is only one state among many.

Yet, when all of the circumstances are taken into account, the development carries certain implications of the most interesting sort. One inevitable suggestion is that the committee may not have acted entirely as an isolated unit of the party's national organization—that a step of so extraordinary a character must have had some extraordinary cause and purpose.

In other words, the declaration raises the question whether this really is the first concrete gesture of a widespread and well organized effort to read Mr. Hoover out of party leadership.

The facts of the case are interesting enough to warrant detailed examination. Ohio has a primary law and the primary returns usually decide what candidate will be supported. The state central committee presumably represents all elements of party opinion and occupies itself with party organization, not with candidates.

A half dozen or more Republicans now are prominently mentioned for the Presidency. One of them is Mr. Hoover, who by virtue of his nomination in 1932 remains the titular leader of the party. Furthermore, it has been reported that Mr. Hoover might try to capture the Ohio delegation as an entering wedge of convention strength. It is not unusual for a state committee, when several candidates are in the field, to step out of its designated role to express its approval of one of them; but to single out one among several for condemnation, and to select the party leader for that role, is something out of the ordinary. It is difficult to recall any exactly similar case.

But that is what the committee did. In the words of State Chairman Schorr: "While no formal action was taken, the committee unanimously and informally expressed the opinion that Herbert Hoover should not be a candidate and should not be nominated."

This, to many politicians, appeared something more than an invitation to Mr. Hoover to stay out of Ohio politics. It unquestionably will be interpreted by the former President's political enemies in many other states as an invitation to follow the lead of Ohio, and disavow well in advance of the national convention any willingness to go through another campaign under a Hoover banner.

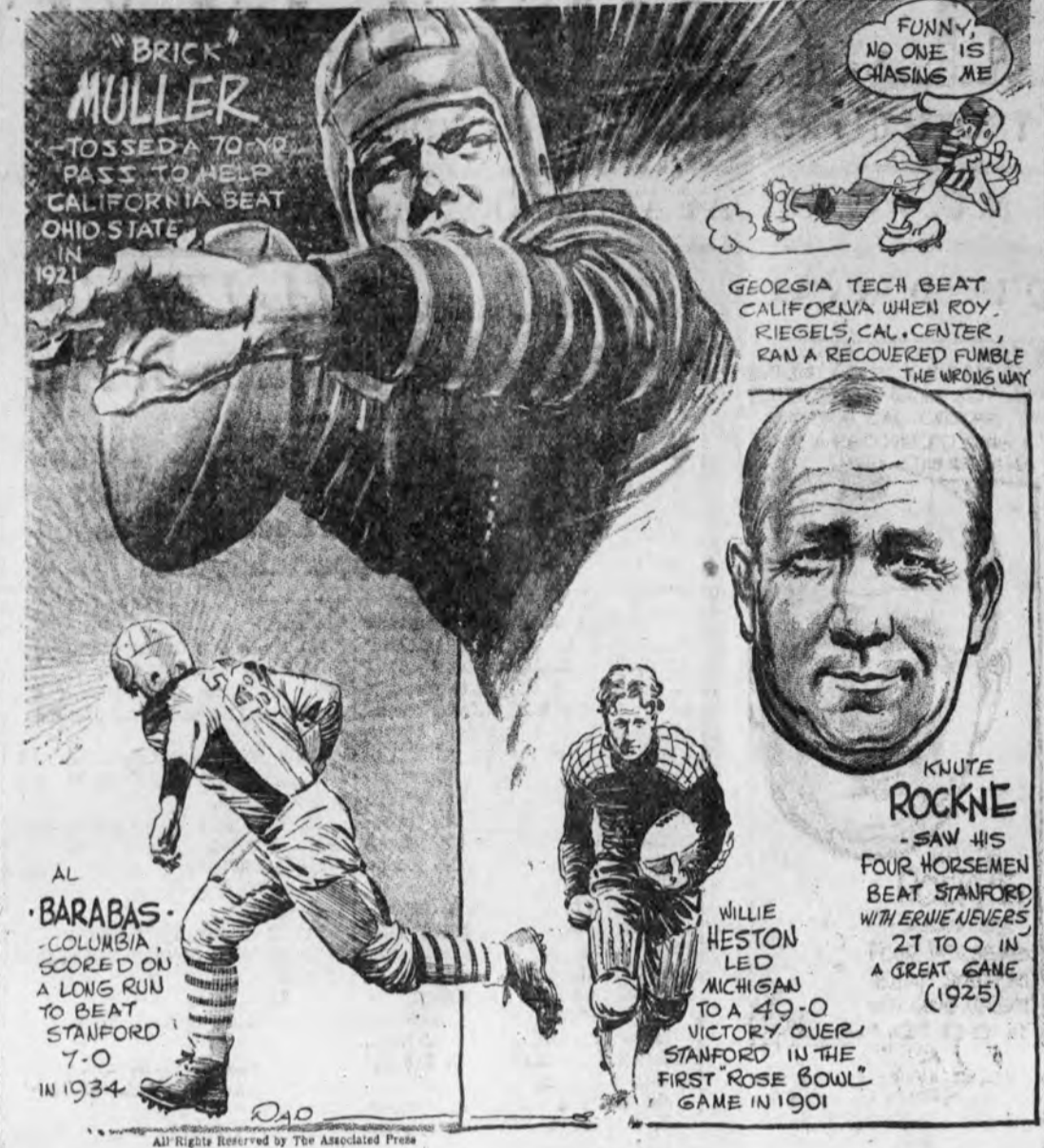

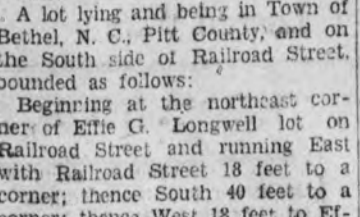

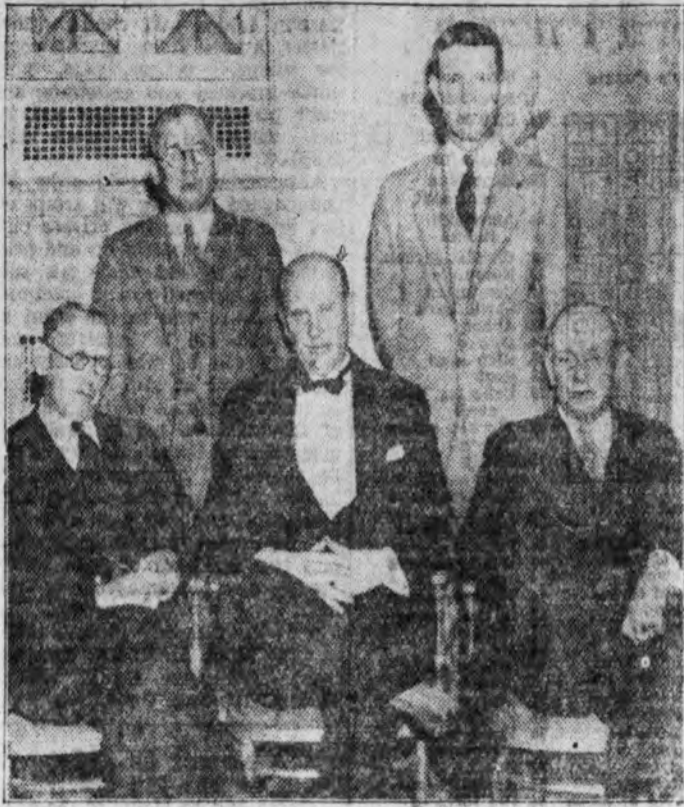

It would be hard to imagine a more colorful political combination than that of Charlie Curtis, of Kansas, and Joe Guiley of Pennsylvania arrayed against each other. Guiley, a first term senator but a veteran at politics, has been made chairman of the Democratic senatorial campaign committee.

It has been known for some time the Republicans have been up against it in the selection of a chairman to direct their senatorial campaigns. Traditionally, a senator not up for reelection is chosen. The present chairman, Senator Hastings of Delaware, must run in 1936 and of necessity had to retire to look after his own fortunes.

Thirteen of the 24 sitting Republicans in the senate are up for reelection next year. For the most part they comprise the senators on the left side of the dividing political aisle who have borne the brunt of leadership in the party.

The list includes, for example, such senators as McNary, of Oregon, the republican floor leader; Dickinson, of Iowa, one of the most outspoken critics of the Roosevelt administration, and others.

The list of eligibles doesn't contain many names to choose from for such an important job.

Davis of Pennsylvania is in poor health. A great part of the last congress found him confined to a hospital.

Gibson of Vermont has been in the senate only a little over two years, thus is lacking in experience.

Norbeck of South Dakota entertains liberal views on politics hardly acceptable to the more conservative Republicans. He proudly describes himself in the Congressional Directory as a "Theodore Roosevelt Republican."

the sales tax, most of those here who know Dowell have observed him in action agree. In fact, Dowell is generally conceded to be the most potent one man lobby who has ever worked in a legislative session in Raleigh by most legislative observers—and that is saying a mouthful.

He is conceded to have offered more opposition to the sales tax than all of the other anti-sales tax agitators put together during the eight years or more he has been executive secretary of the North Carolina Merchants Association.

Opinion here is about evenly divided as to whether Dowell will become a candidate for State Auditor in opposition to Baxter Durham, the incumbent. There is no doubt that Dowell is receiving some strong urging to make the run and he would get some excellent support. But there are indications that the merchants know this and are urging him to stay where he is. It is known that the merchants association recently employed an assistant field man to assist Dowell and even tried to increase his salary, but that he declined to accept the increase.

The prevailing belief is that Mr. Dowell would not gain anything financially if he should run for State Auditor and be elected.

There are some here who see in the effort to get Dowell to run for State Auditor little more than an effort on the part of those who want to see the sales tax continu-

to let on. It's a blow at the very roots of the managed currency system that England has exploited so neatly.

A free currency — like sterling — can only be managed successfully against a fixed fulcrum. We have been providing the fulcrum of a stable gold dollar for the British pound and the fulcrum of steady silver purchases at a set price against which London has been man-  
aging Nanking and Hong Kong exchange. Now the silver prop has been withdrawn and British monetary maneuvers in the Far East collapse in confusion.

That's bad enough — but there's a still more ominous implication for the British behind it. There's nothing to stop us from kicking the far more important gold scaffold out from under them also if we choose. If we were merely to announce that henceforth we shall no longer pay a set price of \$35 an ounce for gold it would blast the daylight out of the delicately ad-  
justed British monetary structure. Not that it's the bare possibility that gives London the shudders.

**FORCE:** Behind the surface confusion about silver, financial experts credit Secretary Morgenthau with one of the smartest, subtler, and most courageous moves in new deal monetary history. Our government wants international currency stabilization on a metallic base. London prefers the status quo, in which the managed pound has a big advantage over the fixed dollar, and has stalled off every suggestion of stabilization.

Now our Treasury, although it obviously can't admit it for publication, is telling the British in effect that we are onto their little game and don't intend to be played for suckers any longer. The inference is that they had better play ball on stabilization or be prepared for a dog-eat-dog battle of managed currencies (with the dollar off gold again) in which our superior resources would give us a vital edge.

New York sharps are confident that England will come to terms. She can't afford the risk of assuming that we are bluffing. This should greatly expedite a stabilization agreement—which FDR wants to get before election. France is understood to be ready to revalue on a new international gold basis just as soon as she is sure the pound will stay put. That's why the silver maneuver is rated a beautiful force play.

**ATONED:** Winthrop Aldrich of the Chase National Bank has been viewed with suspicion by conservative colleagues ever since he created a sensation back in 1933. His suggestions at that time were pointedly aimed at Morgan interests. For some time he was a fairly regular White House conferee and had kind words to say of the President's program. He was instrumental in promoting the famous "truce" between the bankers and the administration a year ago. He served on Secretary Roper's Planning and Advisory Council.

His order for the New Deal be-

gan to cool during the argument which preceded passage of the banking act of 1935. He retired from the Council and went into the silences. While it was understood that he was disillusioned, his New York critics recalled his pro-Roosevelt record and kept their mental reservations about him.

But now all is forgiven to the head of the nation's largest bank. The vitriol he poured on the New Deal in his speech to the Houston Chamber of Commerce is regarded as ample atonement for his earlier espousal of Roosevelt heresies. He is expected to take a leading and most capable part in the beat-Roosevelt drive hereafter.

**COSTS:** New York observers are keenly interested in the report of the Massachusetts Commission on instalment selling and financing as to the cost of instalment purchasing to consumers. The report stressed the difficulty of getting a correct answer to the question: "What rate of interest on a true annual basis must I pay on the unpaid balance?"

The Commission analyzed instalment interests costs of 491 items, including new and used automobiles, refrigerators, radios, pianos, furniture, clothing etc. In only one case of the 491 did the salesman give a correct answer to the question above. Where the rate quoted by the salesman was 6 per cent analysis showed the actual range of interest cost for new cars from 23 to 28 per cent, for used cars from 24 to 40 per cent, for refrigerators from 12 to 16 per cent, for radios from 15 to 125 per cent, and so on. The Commission recommends licensing and regulation of retail sales finance companies and compulsory use of clear and standardized instalment sales contracts to prevent this wholesale gypping of unsuspecting consumers.

Meanwhile the pressure of competition is tending to force such costs down in the New York area and elsewhere. General Motors' reduction of financing charges was symptomatic. Hunger for earnings has brought the Morris Plan and many commercial banks into the field in addition to regular finance companies—which helps to give the buyers a break.

Wild geese take their "home life" seriously, even in the barnyard. The four mentioned previously did not mate until they were four years old and they seem to have "hooked up" for life.

## Expect Hancock Seek Old Post Of Congressman

Political Circles Say Sen Will Not Seek to Unseat Senator Josiah W. Bailey

Raleigh, Dec. 13.—Congressman Frank Hancock of Oxford, Granville county, is not going to oppose Senator Josiah W. Bailey, for the 1936 June primary, but instead will be a candidate for re-nomination to succeed himself in Congress according to the prevailing belief both in political circles here and in his own district.

Visitors here today both from Surry and Granville counties expressed the emphatic belief that Hancock would not run against Bailey, but that he would seek the nomination to the lower house of Congress from the Fifth District.

Nor will former State Senator John A. Felger of Mt. Airy, Surry county, be a candidate against Hancock for the congressional nomination in the district, according to reports from Surry county heard here. There have been rumors here for several weeks that Felger might become a candidate for the nomination against Hancock, and that if he did he would give the Oxford man a real contest.

Checks and Balances

He understood what the history books meant when they discussed the American governmental system of "checks and balances."

He saw it most clearly when the supreme court voided NRA, throwing out government regulation of hundreds of industries which employ millions of workers and produce goods or services for practically the entire nation.

Many called the decision a "death blow" to decent competition and workers' standards; others saw it a "life saver" for business. One of its results was to push organized labor's drive for collective bargaining guarantees—later provided in the Wagner measure, prohibiting employers interference with labor organization and bargaining.

But the fate of this law also might hang upon a high court ruling. Other measures, close to the average person, and upon which the supreme court was expected to pass, included the Guffey coal bill, setting up a reorganization in the soft coal industry to draft codes containing wage, hour and fair practice standards; and the agricultural adjustment administration's processing taxes—based on certain farm products before they reach the consumer and used to compensate the farmer for controlling production.

Uncle Sam seemed to take particular interest in John Smith's electric equipment. In newspaper advertisements, bill boards, show windows, Mr. Smith was informed the government gladly would help him buy his electric washer, his refrigerator, his radio. The help came in the payment terms—Mr. Smith was encouraged to buy at nothing down an dittle a month over a long time.

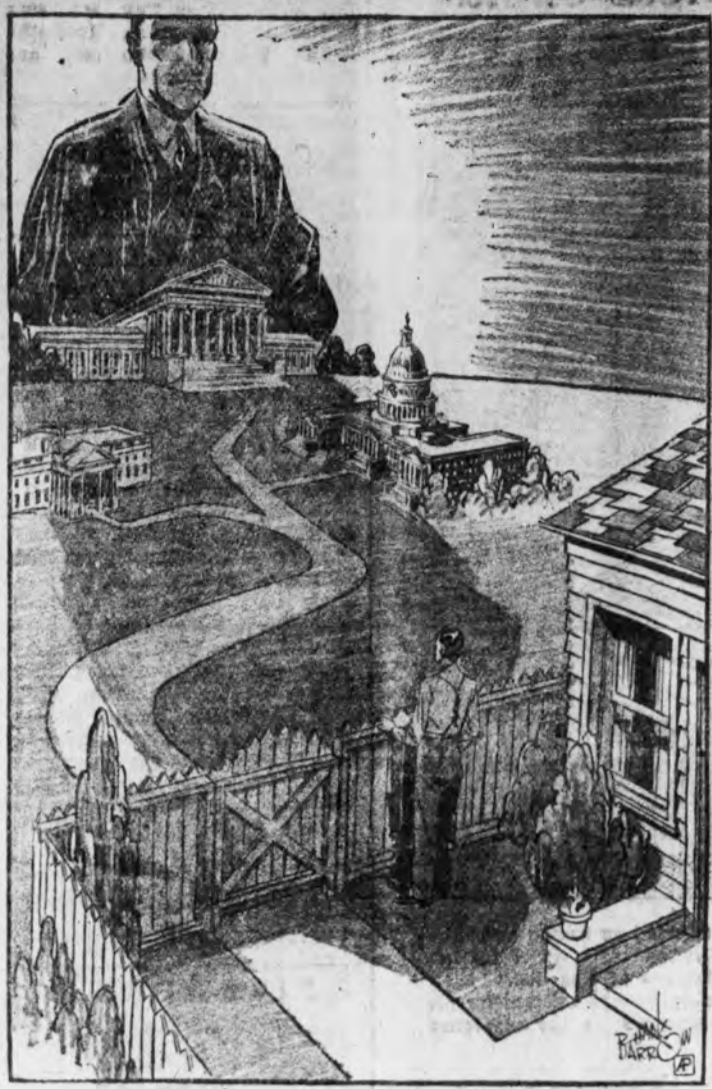

# M'DOWELL MAN TO SEEK POST

## W. W. Neal Says If Elected He'll Seek Speakership

Raleigh, Dec. 18.—W. W. Neal of Marion, McDowell county, will not only be a candidate for the house of the 1937 general assembly, but will also be a candidate for the speakership of that house, he again told friends here while in the city Tuesday. While Neal did not serve as a member of the 1936 house, he was a member in 1933 and in five previous sessions, including the 1931 and 1935 sessions.

Known to his intimates as "Ambassador Neal" he has become famous for the socks he distributes to his friends and fellow legislators, from his hosiery mill in Marion. He has always been one of the most popular members of the general assembly and it is expected he will become a formidable candidate for the speakership. There is little doubt that he will be elected.

The other leading candidate for the speakership is regarded as being R. Gregg Cherry of Gastonia, who was chairman of the house finance committee in the 1935 session and the leader of the now historic "Cherry bloc" in the 1933 session which succeeded in splitting the "Bowie bloc" wide open and in increasing the appropriation for schools and other purposes above the figure which Bowie and his "boc" had set at \$10,000,000 a year. Others whose names have been mentioned in connection with the 1937 speakership race are Victor S. Bryant of Durham chairman of the appropriations committee in the 1935 session; Jack Morphew of Graham county, but now with the WPA, and Thomas K. Hoyle of Greensboro, Guilford county.

If Bryant gets into the race, most observers here agree that the contest will be largely between Cherry, Bryant and Neal. But there is some doubt here as to whether Bryant will run, although it is agreed he would make a strong candidate. If he does not run, present indications are that the principal contest would be between Cherry and Neal, most observers here believe.

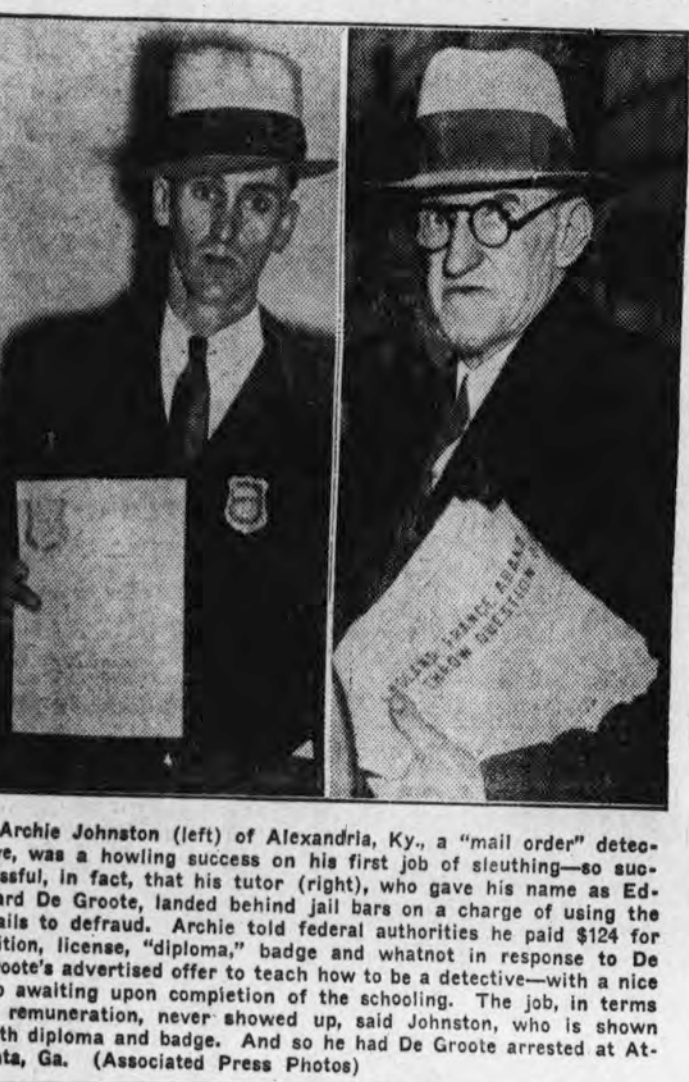
