YOUNG MILNE ADMITS HOAX IN KIDNAPING

Said He Thought It Would Help Him Get Stage Job

BREAKS SHORTLY AFTER MIDNIGHT

Scion Arrested By Federal Agents And Is Being Held Somewhere in New York

New York, Dec. 28.—(AP)—Confessing that his "kidnaping" was a hoax, engineered in an attempt to get some money, Caleb J. Milne, 17, was arraigned today before U. S. Commissioner Garrett W. Cotter on a charge of attempted extortion, a violation of the United States postal laws.

Ball was fixed at \$7,500. A hearing on the charge was set for January 9.

New York, Dec. 28.—(AP)—J. Edgar Hoover, chief of the federal bureau of investigation announced today Caleb J. Milne, IV, kidnaped himself as a medium of publicity to help him get a job on the stage.

"He broke shortly after midnight," Hoover said, "and told us the whole story of how he had conceived the idea when he was in financial strain and could not get a job."

The young grandson of a wealthy returned Pennsylvania textile manufacturer was arrested by the federal agents at Hoover's direction and held "somewhere in New York city."

Young Milne, however, said, faked a story to his landlady that a "Doctor Green of Grace Square" wanted him to go to Philadelphia because his grandfather was ill.

He cut words from newspapers of a \$20,000 "ransom" note which he mailed to his family in a box containing his wrist watch, newspapers he had touched with blood.

Then Milne went by bus to Trenton, N. J., and remained four days. Finally he moved on to Doylestown, Penn., on December 18.

"He went up by a school house three away his coat, brown hat and gloves," Hoover said he taped his eyes and mouth, tied his ankles, knees and hands and rolled down a hill to a highway.

"A few minutes later a car came along and the amateur actor and mystery story writer was found. The supposed object of a kidnaping."

Marks on his arm, which Milne said were made by a hypodermic needle used by his "kidnappers," Hoover reported actually were pin pricks. Hoover said he probably would be arraigned before a United States commissioner here during the day after the United States District Attorney had reviewed the facts of the case and decided what charges may be brought.

The 23-year-old Milne who disappeared from his New York apartment on December 14 and was found trussed five days later near Doylestown, Penn., was brought from his mother's home at Woodstock, New York, yesterday for questioning.

A year ago Miss Bourne quit a job on a British newspaper to make a trip 'round Cape Horn on the Herzogin Cecilie, one of the most beautiful sailing ships in the world. She signed on as a passenger but during the long hard trip helped with the washing and cooking. She also wrote a book.

And just before the vessel started again southward she married Sven Erikson, the captain. Now she is signing on permanently as kaptenskan.

AGED PENSION SURVEY MADE

Pitt County One Of Nine In Which Experiment Made

It was announced in the office of K. T. Futrell, Superintendent of Public Welfare, today that the sample study of persons probably eligible for the old age pension, which has been in progress for the past several weeks, has been finished.

A total of 950 schedules have been made and sent to Raleigh. They represent the probable number of persons past 65 years of age who would be eligible for old age pensions under the National Security Act. Pitt County was selected as one of the nine counties in North Carolina in which this survey has been made. Nine counties in the state were selected so as to ascertain the approximate number in the state that would be eligible to share in the old age pension under the National Security Act. It is pointed out that North Carolina will not share in any old age pensions until the state legislature takes action in the matter.

Mr. Futrell states that a survey of widows having children under sixteen years of age also is being made at this time. He stated he would appreciate the name and address and the number of children of any widows living within the county. Approximately two hundred have registered to date. Any names sent in to the office will be checked against present registrations. This applies to both races.

The Superintendent of Public Welfare has requested the cooperation of the general public in tabulating to be submitted to the State and National Government from Pitt County.

Manchoukuo Army Advancing Across Chinese Province

Aided By Japanese Forces Threatening To Sever Part of China From Central Control.

Shanghai, Dec. 29.—(AP)—(Sunday)—A Manchoukuoan army assisted by Japanese airplanes, said a Chinese report today, was advancing across Chahar province of China and threatening to sever part of it from Chinese control.

The invaders were reported to be driving a military wedge toward Shantung on Chahar's western frontier and possibly isolating the northern half of the province.

Some 2,000 irregulars under the pro-Japanese leader, Liu Wei-tang were reported to be invading northern Hopeh province.

They were said to be menacing the rail center of Chanting, 25 miles northwest of Peiping.

Chinese observer expressed the opinion the man thrust into Chahar was inspired by the Japanese in an effort to cut trade routes between China and outer Mongolia the independent Republic in which Soviet influence is dominant.

TWO OFFICERS FACE CHARGES

Angier Policemen Held for Killing Prisoner

Angier, Dec. 28.—(AP)—Angier's only policeman, O. M. Pollard and C. F. Deans, were held without bond today in connection with the death of a prisoner said by witnesses at a coroner's inquest to have been brutally beaten with a blackjack.

Solicitor Claude Cannaday said the victim of the alleged attack, Green Collins, a 47-year-old farmer, had been arrested for being "slightly intoxicated" and went to the town jail unprotestingly.

The solicitor said testimony showed that Pollard beat the prisoner across the head on three occasions while Dean held a flashlight on each occasion. Between 6 and 15 blows were struck with the blackjack, Cannaday said.

At Lillington this morning sheriff W. E. Salmon quoted the two officers as saying Collins "never was hit with any blackjack" by them. "That is about all they are saying and that is about all they can say now," Sheriff Salmon said. Pollard and Deans are in the county jail there.

LAVAL VOTED CONFIDENCE

Majorities So Small Cabinet Crisis Is Feared

Paris, Dec. 28.—(AP)—Premier Laval, fighting for his political life wrested a double vote of confidence from the Chamber of Deputies today but his majorities were so small that the danger of a cabinet crisis remained.

The vote came after two days of debate on foreign policy and while armed mobile guards were held in readiness outside the chamber to crush possible disorders.

By the slim margin of 296 to 279 and 304 to 262 Laval escaped the fate of his fellow author of the denominated Anglo-French plan, Sir Samuel Hoare. Hoare was forced to resign as Great Britain's foreign secretary because of resentment to the proposal.

Laval defending himself against bitter Leftist attacks pledged today that he would follow the League of Nations to the limit in its efforts to end the war in Africa.

Although the second vote gave him an increasing majority, it was still small enough to foreshadow difficult shoals ahead.

Political Pot Luke Warm In Tar Heel In 1935

Peaceful Year, However, Saw State Desert Prohibition and Form Lines For Active Political Campaigns in 1936

JOYNES MACFARLAN (Associated Press Staff Writer) Raleigh, Dec. 28.—(AP)—Despite the brew of a legislature, the North Carolina political pot mustered nothing warmer than a simmer in 1935, but there were bubbles on the bottom big and rambunctious enough to blow the lid off in 1936 if they decided to go places.

This politically peaceful year, however, saw the state desert a time-honored prohibition stand adopted in 1908. In its valetictory hours the legislature granted 18 counties the right to ballot on liquor stores but turned thumbs down on a state-wide voting for legalization. Each of the heavily Democratic counties in the east given the privilege went "wet" and opened stores. The county of Rockingham, where political margins are closer, refused to legalize the sale.

There was no active political campaign in the state during the year but lines were laid for a heavy barrage for 1936 with five men formally announcing for the Democratic gubernatorial nomination. All

was quiet on the Republican sector.

Democrats hurling their hats into the ring were: Clyde R. Hoey of Shelby, former congressman and a member of the "Shelby Dynasty," a brother-in-law of former Governor O. Max Gardner; Lieut. Gov. A. H. (Sandy) Graham of that well known family of Hillsboro; Dr. Ralph W. MacDonald of Winston-Salem, who made his political debut a year ago with election to the legislature from Forsyth; John A. McRae of Charlotte, former legislator; and Colonel T. L. Kirkpatrick also of Charlotte.

Doctor McDonald is running as an anti-sales taxer. He fought the sales tax in the legislature and lost. The three per cent levy was extended to cover every retail sale except milk. Lieut. Gov. Graham wants exemptions on basic food items put back in the levy and Mr. Hoey hasn't declared himself definitely on the taxation question so far. McRae and Kirkpatrick go along with McDonald in opposing the sales tax.

TO START WORK ON BUILDINGS

Plan to Begin Grimesland and Winterville Schools

Work scheduled to have begun on the new Winterville and Grimesland school buildings yesterday will not begin until Monday, if then, it was announced today by H. P. S. Keller, resident engineer for the PWA project under which the new buildings are being constructed.

The extreme cold weather has hindered the contractor in getting started on the work. It is hoped, however, an engineer will be placed on the grounds Monday to lay out the buildings preparatory to digging trenches.

It has been announced that work would begin on the Grimesland, Winterville and Arthur schools Friday. This was found practically impossible, however, on account of the snow and cold.

Plans at present call for initial work to begin on the grounds Monday for the Winterville and Grimesland projects. Each building will be a brick structure of several classrooms and an auditorium.

No announcement was made as to when work would begin.

Special Session Regarded As Unlikely By Observers

Raleigh, Dec. 28.—No special session of the general assembly is expected in most political circles here—certainly not until after Congress has met again and taken further action with regard to social security legislation, despite the fact that three is still much agitation in some quarters for a special session.

The principal reason for this belief is the fact that those who are in close touch with Gov. E. B. W. know that he is very much opposed to calling a special session, principally because he does not think a special session is necessary at this time, either for the enactment of cooperating state social security legislation or for any other purpose. He is firmly convinced that a special session of the general assembly at this time, especially with many of its members seeking political office, would be likely to do a great deal more harm than good and that the state will be much better off to rock along with its present laws until 1937, even if it does not get all the federal money it might otherwise get.

The only ones who are clamoring for a special session are those who think they would profit from it personally, a good many observers here point out. Those opposed to the sales tax want special session because they believe they could at least restore the exemptions if not actually repeal or reduce the sales tax, it is pointed out. The "wets" and liquor control advocates believe the legislature would now enact a state-wide liquor control law which would permit any county that wants liquor stores to hold elections and have liquor stores if the people so voted. Those favoring old age benefits and unemployment insurance want the general assembly to pass legislation which will permit the

POLICE CHIEF KILLS SLAYER

Slayer of Four Men Is Shot to Death In Montana

Butte, Mont., Dec. 28.—(AP)—William Henry Knight, slayer of four men, was shot to death in a fog of tear gas by possemen last night ending a one man reign of terror of town in Southwest Montana.

The 39 year old ex-convict, object of a sensation three-day man hunt, died a few hours after he was cornered and shot at the home of a former employee, James Gilligan. Gilligan, his wife and two small children were held captives by the desperado until they persuaded him to permit them to remove their children to their grandmother's home.

Knight consented and the terrified parents notified police who made short work of the man who boasted of killing two officers.

A posse surrounded the house and Jack Duggan, assistant police chief, fired a bullet into Knight's head as the fugitive ran from the house.

Mrs. Gilligan, held captive all day by the fugitive, said he freely ad-

Mercury Standing at 20 Degrees This Morning

Cold weather continued in Greenville today despite the fact the mercury reading at eight o'clock this morning was several degrees above the standing at the same time yesterday morning.

B. T. Clark, in charge of the local weather bureau, reported the official temperature here at eight o'clock this morning was 20 degrees, as compared with 16 yesterday morning.

The mercury did not drop below 16 degrees last night, while during the previous night it fell to 13 degrees, the lowest here in several years.

Icebergs continued to float down the Tar river and they froze together as they collided, but there was little possibility the river would freeze over here. Mr. Clark reported that the stream froze over at Washington.

With much of the snow which fell Sunday still on the ground, there was a possibility more would fall over the week-end. Snow or rain having been predicted.

ROAD PATROL STARTS DRIVE

To Bear Down Harder on Highway Law Violators

Raleigh, Dec. 28.—Although activities of the state highway patrol resulted in the revocation of more than 450 drivers' licenses so far this month, the patrol is going to launch a still more determined drive against reckless and drunken driving beginning January 1, Capt. Charles D. Farmer said today.

An order is now being prepared, to go to every patrol officer and private, instructed men to bear down harder than ever on highway law violators, especially reckless and drunken driving, beginning the first day of 1936. Since a far larger number of fatal accidents, as well as of other accidents, are caused by reckless driving than by drunken driving, patrolmen are going to be urged to bear down especially hard on reckless drivers, Captain Farmer said.

"We are going to do our part in arresting these dangerous drivers and bringing them to court," Captain Farmer said. "It will then be up to the various judges as to whether they give them fines and sentences that will retard this reckless driving or merely let them off with light fines or costs."

More and more revocations of drivers' licenses for reckless driving are expected during January, due to the fact that a driver has to be twice convicted of reckless driving before his license can be revoked. The files in the highway safety division already contain hundreds of

Armies on Northern Front Relinquish Abbi Addi

ROME REPORTS OPPONENTS FLEE

European Situation Reflected in Germany As Hitler Increases Armaments

Addis Ababa, Dec. 28.—(AP)—A telegram from Emperor Haile Selassie disclosed today that a huge Ethiopian army attempting to advance against Italy's northern army is now engaged in its first important battle with the Fascist invaders.

The warriors are encountering opposition and many were slain on both sides, the message said. Ras Mulgueta, Ethiopian minister of war, is commanding the army. Emperor Haile Selassie is now at Dessye, field headquarters for the army.

The latest of a succession of bold forays by Ethiopian troops against Italy's invading blackshirts, described in communique from Addis Ababa, gave a fresh complexion today to Premier Mussolini's "campaign of occupation" in Ethiopia.

Practically stationary for weeks Italy forces on the northern front were forced to relinquish Abbi Addi, 25 miles southwest of the main northern lines in an Ethiopian surprise attack said an announcement from the capital city of Emperor Haile Selassie.

If it has succeeded in doing nothing more the guerrilla warfare of encouraged Ethiopian armies has worried the Italians and inflicted small but consistent losses.

The bodies of 20 Italian officers and many natives, said the Ethiopian government, were found on the battlefields at Abbi Addi and a hundred of Italian native soldiers were taken prisoners.

From Rome, however, issued Italian press dispatches saying Ethiopian (Continued on Page Four)

No Announcement As To Intentions Dowell and Scott

Both Are Still Flirting With Idea of Becoming Candidates For High State Offices

Reflector Bureau, Sir Walter Hotel. Raleigh, Dec. 28.—Willard H. Dowell, executive secretary of the North Carolina Merchants Association and W. Kerr Scott, past master of the Grange in the state, are still considering becoming candidates for nomination to state offices in the Democratic primary in June, 1936, according to reports heard here today.

Dowell for some time has been mentioned as a possible candidate for the nomination for State Auditor, opposing Baxter Durham, the present incumbent, while Kerr has been mentioned as a possible opponent of William A. Graham for the nomination as Commissioner of Agriculture.

When Dowell was first mentioned as a possible candidate for state auditor, he did not respond very warmly to the suggestion, his friends say. But within the past few weeks those who have talked with him believe he is giving the matter more and more serious consideration. As a result, a good many of his friends are already convinced that it is now only a matter of a few weeks before Dowell will formally announce as a candidate for state auditor. If he does become a candidate, as many now expect, many here freely admit he will become a formidable candidate and give Baxter Durham some really stiff opposition.

Some four or five weeks ago it was known here that Scott was in the verge of announcing as a candidate for the nomination as Commissioner of Agriculture and his announcement was expected at any time. It was then reported that he had decided not to seek the nomination after all. But within the past few days several known to be very close to Scott are maintaining that he has by no means decided not to run and if anything, is more likely to announce now than at any other time. It is known, however, that some of Scott's friends are advising him not to run, since they are convinced that he cannot defeat Graham, considered me to be one of, if not the ablest practical politician among the various state election officials. The prevailing opinion in most circles here is that Scott cannot defeat Graham.

CHINESE STUDENTS RENEW FLARE-UPS IN MANY SECTORS

Discontented Students Demonstrate Against Government in Widely Separated Cities

Shanghai, China, Dec. 29.—(Sunday)—(AP)—Students discontent with the government policies in north China flared in widely separated cities of China early today. Despite vigorous measures to suppress demonstrations, 10,000 students paraded at Nanchang in Kiangsi province. Students launched a three day strike in Taiquanfu, Shansi province.

Students whose numbers had increased to 13,000 continued to hold the Kaifeng railway station derailing troops who were attempting to oust them.

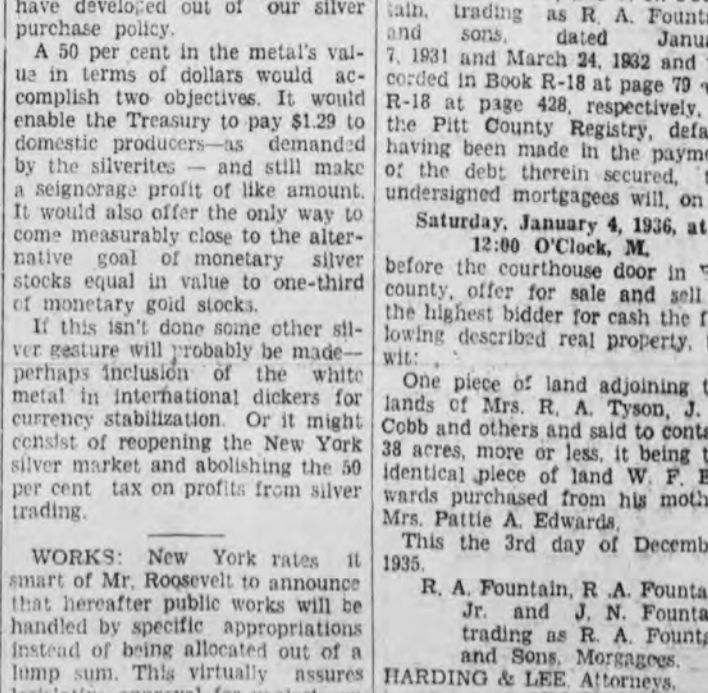

Seek Senator Bailey's Aid In Rural Electrification

Raleigh, Dec. 28.—The assistance of Senator Josiah W. Bailey is being sought here today by Chairman Dudley W. Bagley of the state Rural Electrification Authority and J. L. Horne, Jr., of Rocky Mount, a member of the authority in an effort to get some action and if possible some money out of the Rural Electrification Administration in Washington for several projects in North Carolina. For while the federal Rural Electrification Administration has had a fund of \$100,000,000 with which it has been supposed to assist states in getting rural electric lines constructed, about all the assistance most of the states have obtained from the REA in Washington has been a pat on the back and promise of help in the future.

So far, not a single dollar of this money has been obtained for any project in North Carolina, although several applications for loans from the REA have been before it in Washington for many months. The facts are that so far the various power companies in North Carolina have been much more helpful to the North Carolina Rural Electrification Authority and have done more to bring about the building of rural lines than has the REA in Washington. At the present time more than 600 miles of rural electric lines are already under construction, with a prospect of at least 1,000 miles of new lines in the near future, all being built by the various power companies. Months ago these power companies agreed to build as many miles as possible of these rural lines if they could make the lines pay out within five years, previously the power companies had maintained they could not afford to build lines unless they would pay out within from two to three years.

It is no secret that Bagley and other members of the state authority are getting tired of the procrastination and delay on the part of the REA in Washington with regard to applications for loans for North Carolina projects. Accordingly Bagley and Horne are going to confer with Senator Bailey here today in an effort to get his assistance in unfreezing the REA in Washington.

High Is Reached In Residential Building

New York, Dec. 27.—(AP)—America dug away the depression debris and began again, in respectable quantities, to build homes in 1935. As a consequence, residential building in 1935 exceeded 1934 by 85 per cent in the first eleven months, with December expected to make little difference in the full year's gain.

Home construction far outstripped other forms of building in the rate of its climb. The Associated Press seasonally adjusted index for this classification had improved by late 1935 to the best levels since early 1933.

The expenditure of public funds, mostly WPA projects of the federal government with some minor aid on the part of states and municipalities, helped swell totals, but its major effect was not expected to be felt until well into 1936.

All classes of construction, total contracts awarded in the 37 states east of the Rocky Mountains, as compiled by the F. W. Dodge Corporation 9 per cent higher in the first 11 months of 1935 than in the same period of 1934.

Such factors as higher rents, a pent-up demand for homes partially undammed by better employment and business conditions, and some relaxation of the mortgage money market operated to boost home construction to an estimated 70,000 units in 1935.

Yet housing experts estimate that based on the normal year-to-year new and replacement need for homes the nation is some seven to ten million dwellings behind in its house building.

Unit Homes In this situation they see the hope of better things ahead for the industry in 1936. Such predictable factors as costs, which showed little change in 1935 from the previous year, and a further thawing of mortgage funds, were admittedly uncertain factors, but did not appear to dampen the optimism of most building trade men.

Efforts went forward in 1935, though still on a relatively small scale, to tap the "mass-consumption" housing field, through prefabricated units of very low cost. To some housing authorities the most promising long-range goal of the industry appears to be the development of homes costing \$2,000 to \$5,000.

"Lindbergh Law" Causes Hundreds Of Investigations

Washington (AP)—If you receive a threatening letter, take it at once to your local postmaster; he'll know what to do.

Silent as to the threats that reputedly helped drive the Lindberghs out of America, the post office inspection service, whose 550 operatives constantly trail extortionists, gives that advice to citizens.

The public isn't told to go directly to an inspector because, officials explain, the public doesn't know where they are. The postmaster does, and it is part of his duty to see that extortion notes reach the proper office.

Slight Decline. A high service officer, acting as spokesman, says "innumerable" letters are turned over annually to the inspectors, although the number has decreased slightly in the last year.

Most supposed terrorists turn out, upon arrest, he said, to be shivering weaklings.

The so-called "Lindbergh law" is the statute under which the post office department now works against "blackhanders." Briefly, it provides that it is a felony punishable by fine of \$5,000 and jail sentence of 20 years to send a letter containing a threat to injure reputation, inflict bodily harm or kidnap, accompanied by any other demand for "money or any other thing of value."

Work of the post office inspectors embraces many activities other than tracking down extortionists. Nevertheless, they made 523 detailed investigations in the fiscal year of 1935, 121 arrests and got 103 convictions.

Work for Experts. The paper on which a blackmail or extortion note is written is examined by experts to denote its general quality—as a key to the personality and general standing of the sender—and if possible where it was bought. Handwriting or type-writing examination comes next, and then an infinite variety of inquiries depending on the case.

Post office inspectors are "career men." Politics does not enter their appointment; they must work up through the system and be familiar with every line in the postal laws. The majority of them have been in the service from 10 to 40 years. Every man, after passing stiff examinations which include the subjects of poise and background, must serve a year on probation.

# LIFE IN 1935



The guns that gained turned against its own and the guns of peace officers cut deeply into the crime ranks during the year, left only a few of the older public enemies alive and still at large.

"G-men" and gunmen wiped out most of the old crop of public enemies during 1935.

John Smith read the crime headlines of the year with a growing feeling of security as peace officers "mopped up," leaving only three major criminals of the old order on the "wanted list."

"Fred Barker, wanted for the Bremer kidnaping, was killed in a blaze of machine gun bullets from department of justice agents, in Florida. Trapped with him and killed during the six-hour battle was "Ma" Parker, no model for Mother's day.

Raymond Hamilton, ace bad man of the southwest, died in the electric chair in Texas.

**Dutch Shultz Killed.**

Walter Legenza and Robert Mals, murderers, escaped convicts, members of the tri-state gang, died in the electric chair, Virginia.

Dutch Shultz (Arthur Plegenheimer), ex-New York Beer baron and racketeer, died in a Newark hospital after a spat of gunmen's bullets. Three of his henchmen also died in the brief gang battle.

John Paul Chase, buddy of the late "Baby Face" Nelson, got life for the killing of a "G-Man," several members of the Barker-Karpis gang went to prison, variously under small fry, especially in New York, were shot, stabbed, strangled or burned to death.

The year-end found Alvin Karpis, "Public Enemy No. 1," virtually the only former big shot gangster still at large. He's wanted for the kidnaping of Edward G. Bremer, the murder of a Missouri sheriff, many robberies.

Also widely sought were Thomas Robinson, Jr., and William Mahan, implicated in kidnapings, Robinson, who has eluded capture for more than a year, is wanted for the abduction of Mrs. Berry V. Stoll in Louisville.

**Reminders of Dillinger**

In August the body of John Dillinger's lieutenant, John Hamilton, was found in a shallow grave near Oswego Ill. Government agents theorized he had been fatally wounded when he and his chief shot it out with officers in Minnesota a year ago. A month later, the "women in red," Mrs. Anna Sage, fought a deportation order by alleging she had been promised a stay in return for her betrayal of Dillinger.

The year saw the end of one "American tragedy" case, the beginning of another. Robert Edwards was electrocuted in May, in Pennsylvania, for the murder of Freda McKechnie. In July, Mrs. Newell P. Sherman was drowned in a Massachusetts lake. Her husband, convicted of murder, appealed.

**Other Cases**

Other cases that engaged John Smith's attention included the gruesome mutilation murder of Walter J. Bauer, kidnaped in Ann Arbor, Mich., shortly after his marriage; the killing of Mrs. John Crempa as a climax to the long discord between her family and the Public Service Corporation of New Jersey; the arsenic poison death of Mrs. Everett C. Appleate. New York; the conviction of Edith Maxwell, Virginia hill girl, for slaying her father, Trigg, with a shoe when he attempted to punish her.

state to share in funds for these purposes already set aside by the federal government. This group is composed almost entirely of those who think they would get some of this money.

Within the last few days there have also been indications that the gasoline and oil industry is tremendously interested in having a special session called by the governor and that the various gasoline companies doing business in the state are giving all the encouragement possible to the movement for a special session. Those connected with this industry outwardly maintain that the session should be called to pass needed social security legislation. But the real reason for their desire for such a session is believed to be their hope that they could get the new tax on chain filling stations, imposed by the 1935 session, repealed. This tax was fought tooth and nail by the powerful and affluent gasoline and oil lobby throughout the 1935 session, but was finally enacted in spite of it. There are indications now, however, that the gasoline and oil interests think they would have no difficulty in getting this tax removed in a special session, indicating to some that the members of both houses have already been well canvassed on this question.

## LESSONS IN LAW-MAKING

2. How Laws Are 'Born'

Legislation in congress originates in various ways.

The President may send brief messages from time to time, each making a specific recommendation. Usually a senator or representative will prepare a bill carrying out the President's recommendations and introduce it immediately upon receipt of the message. If this is not done, the committee considering the message may draft such a bill and report it to the senate or house.

Bills for raising revenue, under the constitution, must originate in the house of representatives. A bill may originate through any member of the senate or house. The member prepares his bill and introduces it. In the house he drops it in a basket on the clerk's desk. It immediately is referred to the proper committee, which will consider it and report it favorably if the committee considers the proposed legislation desirable.

Many bills remain in committee undisturbed and never are heard from again. In some cases they have served their purpose without further action. They have advertised the member and the project. Many bills introduced have no chance of serious consideration or passage.

Several members may introduce similar bills. The committee considering them may combine the best features of several of them in a new bill, or it may write an entirely new measure and report it.

Some legislation originates by petitions from citizens.
