## REFERS NAMES ARMS MAKERS TO CUMMINGS

Secretary Hull Submits Those Not Registering

NAMES WITHHELD FROM PUBLIC

More than Two Score Handed to Attorney General for "Appropriate Action"

Washington, Jan. 18.—(AP)—Secretary Hull announced today he had submitted to Attorney General Cummings for "appropriate action" names of more than two score of munitions manufacturing companies which have failed to register with the state department in compliance with the neutrality act.

Names and the exact number of firms involved were not made known although Secretary Hull said at his press conference there were 20 or 30 of them.

Mostly, he said, they are small companies although among them are one or two of some importance. Under the neutrality statute all firms and individuals dealing in arms, ammunitions and implements of war were required to register with the state department not later than November 29, 1935.

## MORE DEBATE ABOUT WILSON

Argument Over War-Time President Continues

Washington, Jan. 18.—(AP)—Plunging into debate over a charge that Woodrow Wilson "falsified" the records of the World War, Senator Clark (D-Mo.) lashed out today at William Jennings Bryan, Wilson's secretary of state, for having "betrayed my father."

The son of the late Champ Clark, speaker of the House in days gone by, the Missourian told a thronged gallery that he held no animosity toward the war-time President.

Any animosity he had was toward Bryan for "betraying my father at the Baltimore convention."

Clark, who has joined Chairman Nye of the munitions committee, in attacking "inconsistencies" in public records of the Wilson administration, declared: "Some effort has been made to show he was 'animus' toward President Wilson who defeated my father at the Baltimore convention."

He referred to the Democratic national convention in 1912 at which Champ Clark was defeated by Wilson to rite nomination.

At that convention Clark charged Bryan "violated" instructions in handling an instructed delegation. Attempts to rescue the committee's neutrality investigation from a sea of Democratic indignation, Clark took the floor before galleries packed with spectators eager for debate.

Senator Glass (D-Va.) yesterday had shouted "coward" and "demagogue" at Chairman Nye of the committee who accused Wilson of having "falsified" the records of the World War.

Clark said "More than 20 years ago I heard a prominent member of the House say on the floor while Glass was a member of that body, that Glass was one man who never speaks except in terms of indignation."

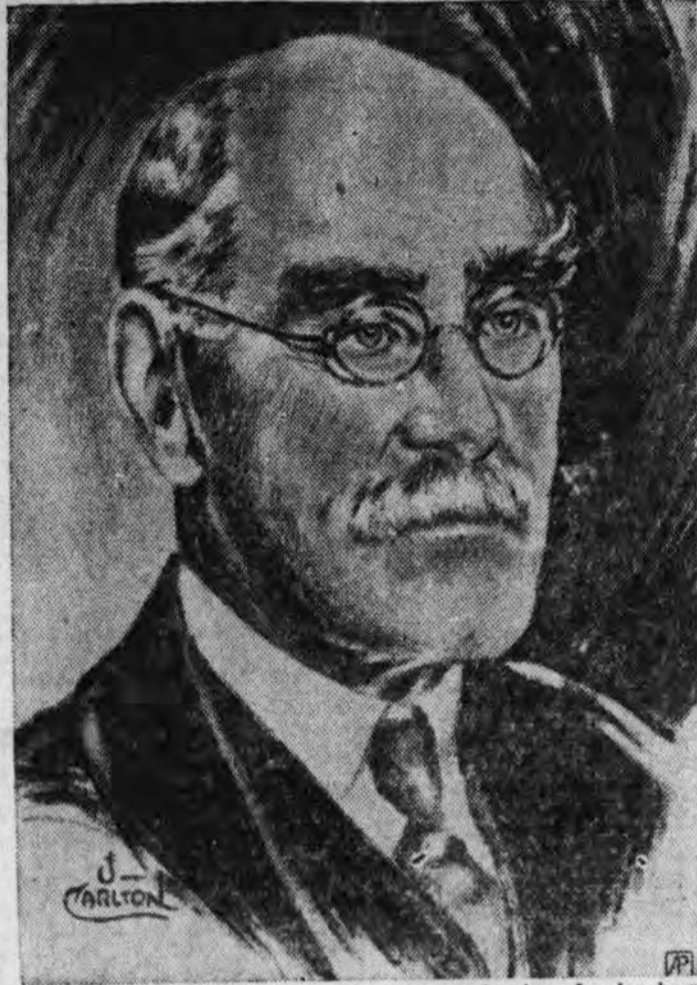
Glass sat in his chair, one of his hands injured yesterday when he pounded his desk to emphasize his attack against Nye, was bound. "I regret that the Senator from Virginia was fit to use his unrivaled power of vituperation in invective and abuse on a member of the committee," Clark said.

## Body Of Rudyard Kipling Moved To Hospital Chapel

Death Claims Famous Poet Early Today

FUNERAL RITES NOT ANNOUNCED

Dies at Age of 70 in Middlesex Hospital Following Operation There

London, Jan. 18.—(AP)—Rudyard Kipling, Great Britain's famous poet-imperialist, died early today in the Middlesex hospital at the age of 70 and his body was taken to the hospital chapel to await cremation.

Whether the noted author even would be buried in Westminster Abbey, last resting place of so many of Britain's famed sons, did not immediately become known.

His body was taken to the hospital chapel from the simple bed in a private room at the hospital which he had occupied since he underwent an emergency operation last Monday for a perforated stomach ulcer.

NEW YORK, Jan. 18.—(AP)—Story-teller to the world, Rudyard Kipling brought the glamor of empire-making out of India and sent over the threshold of East and West in prose and verse, a procession of lovable character and unforgettable phrases.

The author of "Kim," "Captains Courageous," "Gunga Din" and "Recessional," who was 70 years old December 30, 1935, found as much popularity in America as elsewhere in the English-speaking world.

In 1890, after writing "Departmental Ditties," "Plain Tales from the Hills," "Soldiers Three," "The Phantom Rickshaw" and other now-famous volumes, he left India for England, via the United States.

Famous as he had become in India, the New World had not heard of him. In "The Light That Failed" he told of his months of discouragement going across the American continent from San Francisco to New York, an author whose works were unwanted, and unable to find a job.

The following year an English publisher brought out "Plain Tales from the Hills," and his reputation as made. Manuscripts that jammed his trunks made a rapid succession of successful books.

His second visit to New York brought romance. He married Caroline Balestier, the sister of an American writer he had known in London. They settled in Brattleboro, Vt. There he wrote more than 20 books, and there his two children were born. One, Lieutenant John Kipling, died in the World War. His daughter was married in London in 1925.

Dr. James Conland, of Brattleboro, was the physician of the Kipling household, and it was he who introduced the author to the ways of the Gloucester fishermen, which resulted in "Captains Courageous."

The Kiplings fled the American scene because of the importunities of hundreds of autograph seekers and "lion" hunters who would not let him alone. In his home at Burwash, Sussex, moats and walls have kept strangers away.

## PREDICT VOTE ON BONUS PLAN OF BABY BONDS

Vote Looked for Before Week-End Adjournment

LEADERS CLAIM BILL TO PASS

Group Says Payment in Cashable Bonds Will Be Enacted Regardless of Veto

Washington, Jan. 18.—(AP)—As khaki-clad veterans watched from the galleries the senate moved today toward final passage of the coalition bill for full payment of the world war service bonus in cashable bonds.

With restricting on debate becoming operative two hours after convening administration leaders purported "baby bonds" measure looked for a favorable top heavy majority on the last roll call before the week-end adjournment.

House acceptance of the bill was forecast. Senator Harrison (D-Miss) author of the bond proposed and Senators Byrnes (D-S. C.) Steiwer (R-Ore.) and Clark (D-Mo.) has confidently predicted enactment "whether the President signs it or not."

Senator Thomas (D-Okla.) opened today's debate with an argument that the coalition bill may require at least three bond issues.

Counting estimated federal deficit for this and next fiscal years re-funding operations, the bonus relief and money to pay farmers and possible processing tax payers, Thomas said the government "may have to issue \$15,000,000,000 bonds" in the next 17 months.

## 13 Killed As Plane Crashes in Andes Mountains Friday

La Paz, Bolivia, Jan. 18.—(AP)—An eye witness reported to authorities today that 13 persons were burned to death in the crash of an airplane at the small town of Chalabait near Chaca Bamba yesterday.

The plane bound from Chaca Bamba on the plains, at the foot of the Andes mountains to La Paz, fell in a region surrounded by flood water and a relief party was reported as experiencing difficulty in getting to the plane.

The dead included ten passengers, pilot and two mechanics and all those aboard.

## Charge White Boy With Stabbing Negro

Earl Dunn, 15-year-old Greenville white boy, will face charges in juvenile court of cutting and seriously wounding Anthony Coward, negro boy of about the same age, last night.

Chief George Clark said today he had taken the white boy in custody and that he would be tried in juvenile court.

He said young Dunn told him that the negro boy hit him with a brick Thursday night and that last night when the two met he thought the boy was going to hit him again and that he cut him.

The negro is in the hospital with a serious wound near the heart. His condition is not considered critical, however.

STONE: The latest name which some high-up Republicans are rolling on their tongues as a presidential nominee is Justice Harlan Stone. They have dropped Justice Owen J. Mr. Stone impresses them as possessing many qualities which would carry him far in the political world. He was a friend of Calvin Coolidge, who first named him as Attorney General. The Justice has a conservative background, although his record on the court stamps him as a so-called "liberal." In personal appearance he is regarded as the type which would appeal to the farm country. GOP-ers class him as a "liberal-conservative."

## SCHOOL UNITS BACK AT WORK

First Full Week's Work Carried On Since Dec. 6

Pitt county schools this week observed the first five day school period without interruption since two weeks before the regular Christmas holidays began.

The Winterville school was closed December 6 while a deep well was being dug and did not reopen again until after the Christmas vacation.

After the holidays, the roads were in such a condition it was almost impossible for school trucks to travel on them and a number of the schools were closed for them to improve.

All schools in the county, however, operated during the present week without interruption.

D. H. Conley, county school superintendent, said the operation of school trucks at present was costing about double the usual operating expenses. He explained that the bad roads cause the trucks to burn much more gasoline and oil. The trucks had to operate in low gear much of the time during this week.

## One Week Session Of Criminal Court Begins on Monday

Heavy Docket Faces Judge Marshall Spears in Superior Court; Civil Term Completed

A term of Superior civil court was completed here this week by Judge Marshall Spears, with a criminal term set for next week.

A number of the cases docketed to come up at the civil term was disposed of outside court, but the regular run of divorces and other minor cases were afraid.

Much interest is expected to be shown in the criminal term beginning Monday. A heavy calendar faces the court with possibility that at least one murder trial will be heard.

Donald Deaver, charged with attempt to kidnap two children of S. V. Morton, will probably be tried at the term.

## TO ESTABLISH CORPORATION

Pasteurization Plant To Start Work About Feb. 15

The Carolina Dairy products, Inc. has been organized and will start operating a pasteurization plant on Washington street about February 15, C. W. Harvey, president of the new company, announced today.

The corporation will engage in the pasteurization of milk and the manufacture of all dairy products, including ice cream. The plant was designed by the State Board of Health and has been supervised by J. B. Stone, sanitary inspector for the Pitt County Board of Health.

J. B. Webb, Jr., of Edenton, formerly with DeLaval Separator company, will be general manager of the plant. The manager is a graduate of N. C. State college's dairying school and has been associated with the dairying industry for the past seven years. He already has arrived in the city to supervise the installation of the equipment, the most modern and up-to-date obtainable.

It is the announced purpose of the corporation to serve, not only the city of Greenville, but Pitt county and other sections of Eastern North Carolina. Officials have announced their policy will be to handle only grade-A milk for its products.

## TORNADO HITS FARM SECTION

Four Known Dead in Alabama Mountain Slopes

Fyffe, Ala., Jan. 18.—(AP)—Four persons were killed and a number injured today as a tornado swept up the populous farm section on the eastern slope of Sande mountain.

The known dead were: Rob Rowell, a farmer. A small daughter of Rowell. Mr. and Mrs. Claude Courtwood. The storm struck about 4:30 p. m. (CST) swooping down the slopes of the mountains from the Southwest after wrecking a number of homes in the Rainville section.

Searching parties began to move up the valley behind the path of the storm. Many persons expressed the fear the dead might be increased.

## THREATS MADE AGAINST LIFE OF HOFFMANS

Governor's Children and Home Closely Guarded

MRS. HOFFMAN GETS LETTERS

Governor Meanwhile Intensifies Search For Other Persons in Lindy Crime

(Copyright By Associated Press)  
Trenton, N. J., Jan. 18.—(AP)—Governor Hoffman intensified today his search for other persons besides Bruno Richard Hauptmann who might have been involved in the kidnap-slaying of Charles A. Lindbergh, Jr.

Details of the search were kept secret, the Governor having announced that in due course he would give his reasons for doubting that any one man could have committed the crime.

Possibility the threat of death from which Hauptmann was snatched from by a reprieve last night sounded in the ears of the man who saved him.

The Newark Ledger in a copyrighted story said the Governor's home at Douth Embury is under heavy guard because of letters threatening the lives of Mrs. Hauptmann and the three Hoffman children.

State police and city authorities, the paper said, took the action yesterday. The threats, it explained, followed the Governor's reprieve of Bruno Hauptmann.

It was revealed that the two Hoffman children of school age were being escorted to and from classes by plain coastmen," the paper said.

One of the letters sent to Mrs. Hauptmann and told her, "the paper said," that if her husband did not drop his interest in Hauptmann "one of your children will suffer the consequence."

## RAILWAY PLANS NEW SERVICE

To Inaugurate Pickup and Delivery Accommodations

Atlanta, Jan. 18.—(AP)—Officials of the Southern Railway announced today authorization of a plan for universal free pickup and delivery service on less than carload merchandise traffic.

April is being made to the Interstate commerce committee for authorization to install all the system February 1 on not more than 10 days' notice to the public.

In addition to authorized free pickups and delivery tariff will authorize payments of five cents a hundred pounds to shippers of consignees make their own arrangement for performing such service.

In inaugurating the service, the Southern joined other Railways in the south and other section offering such accommodating officials said.

STIRRING WAR FILM IS PLEA FOR PEACE

By Dr. Frank S. Hickman (Preacher To Duke University) Last Monday, Armistice day, a little company of us were the guests of the Carolina Theatre at a preliminary showing of Cecil B. DeMille's pictures, "The Crusades." DeMille, with a long list of triumphs in the field of spectacular drama to his credit, seems to have reached his peak in this picture. I do not see how anything more overwhelming impressive could have been committed to the screen. The picture of war in "The Crusades" is so real that it is difficult to think the participants only trained actors. The earlier part of the drama seems to glorify war, centering as it does in the ruthless courage of Richard the Lion-hearted king of England. But as the plot unfolds, the bloody glory of battle gradually recedes into the background of another and more impressive kind of glory. This film might well have borne the caption, "The Sword of the Lion-Hearted," for Richard's mag-

nificent sword is the symbol around which the whole dramatic movement revolves. In the beginning it stands for all that a bloody battle sword can stand. It even cuts asunder, under a military vow, the king and his beloved queen, the daughter of Navarre. But in the end it lies shattered at the foot of the cross of Christ, placed there by the queen's own beautiful hands. In its broken wholeness it becomes the pledge of deathless love.

The ruined sword points to the wrecked crusade in whose service it had been wielded. Out of the wreckage two great truths emerge; one, that the vindication of the cross does not lie in the sword; and the other, that true men, fanatically misguided, may leap at each other's throats, each fancying himself God's appointed and his foe an infidel. An intensely dramatic moment shows the knightly Saladin looking the haughty Richard straight in the eyes, and exclaiming in a burst of generous appreciation, "I wish I might call you brother, and not foe."

Every high-minded man or woman, young or old, ought to see this picture. It plucks out all the glamorous, bloody story of the Crusades the fallacy that lies in all war; and it brings up out of the ruck and mool of battle fields that deeper understanding of men for men of other faiths which is the only ground we shall ever find for the sheathing of our swords against the stranger who knows not our own creed.

What I have written here is my own; no one else has even remotely suggested that I write it. I have seen a great masterpiece, and I wish to share it with my neighbors.—(Re-

# Old Bills To Be Paid With Bonus Payments To Veterans

WASHINGTON (AP)—Immediate payment of the soldiers' bonus, say its backers, would start cash registers ringing in virtually every city, town and rural community of the nation where holders of adjusted service certificates reside.

National Commander Ray Murphy of the American Legion asserts "the payment of the certificates at this time will prime all business and industry" and that "the spread of the money will be in direct proportion to the recruiting of the army and navy in wartime which as is well known was upon an even basis of distribution of population."

Bonus seekers are interested chiefly in paying old debts and improving living conditions for their families, if a statistical study by a magazine circulating to American Legion members (the American Legion Monthly) is a true guide to "Where the Bonus Dollar will Go."

On the basis of 42,500 replies to questionnaires sent at "random" to certificate holders, it is estimated that more than half of the eligible veterans are troubled by old debts; that virtually all of them plan to do something about acquiring or improving homes if they get the money. Their third ranking ambition is indicated to be the purchase or re-equipment of motor cars.

In an effort to determine how the veterans would spend their bonus money the magazine sent 25 questionnaires to each of the more than 11,000 posts of the Legion where they were distributed at random to members who filled them out.

The envelopes containing the questionnaires were turned over unopened to certified accountants by whom they were counted, audited and projected to a basis of 3,518,191 outstanding adjusted service certificates with an average net value of \$665.17 each.

On this basis it is estimated merchants and retailers of the country will receive a total payment of \$623,615,793.86 from 1,897,836 veterans on debts incurred.

While the amount of estimated payment on old debts figures at approximately one-third of the total bonus replies to questionnaires indicate that to 54 per cent of the bonus recipients, squaring up old debts is an important item.

Spending for Homes  
The greatest bulk of the bonus money, according to this survey, would go into items related to the home life of the veterans after payment of past due obligations. It is estimated that more than 34 per cent of the approximately \$2,000,000,000 required to pay off the bonus will go for this purpose.

Other estimates on how the World War veterans will spend their bonus include:  
For motor vehicles and accessories, 6 per cent of the total.  
Clothing for personal use, 21-2 per cent.  
Clothing for their families 4 per cent.

Expenditure for investment and their own business, 7 per cent.  
All other expenditures, including insurance, education, savings accounts and miscellaneous items, 12 per cent.

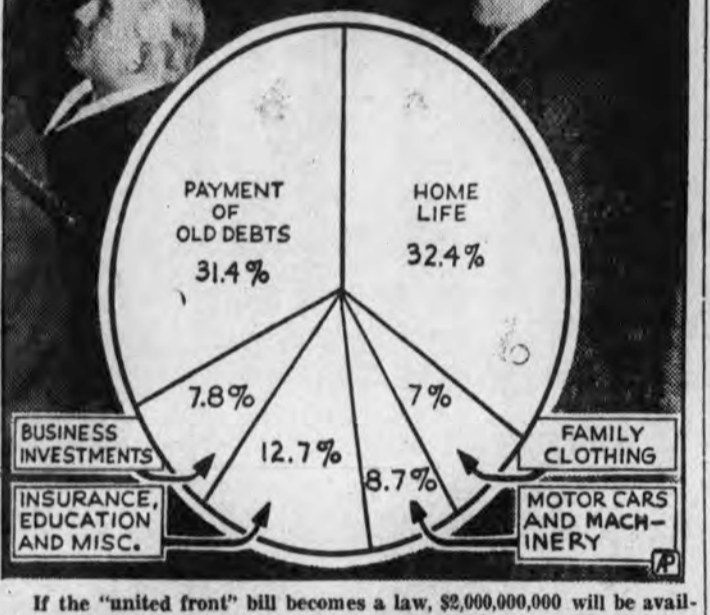

# ASKS BIDS FOR PATROL RADIO

## To Buy Equipment For Five Stations and Patrol Cars

Reflector Bureau, Sir Walter Hotel, Raleigh, Jan. 18.—Bids for the radio equipment for the five highway patrol radio stations and for the patrol cars and motorcycles will be received and opened January 30 by the Division of Purchase and Contract, it was announced today.

It is not known yet how much time will be required from the time the contracts are let until the state-wide short wave radio stations can be built and be ready for operation, but it is expected that from 60 to 90 days will be required to get the entire system ready to function.

The recent survey of the state by radio technicians to locate the best points for the location of the radio stations, resulted in recommendations in Raleigh, Williamston, Elizabethtown, Salisbury and Asheville, or in places in the vicinity of these towns. It is expected that all of these stations will be in telephone communication with each other as well as in constant communication by radio. These five stations in turn will be able to stay in continuous communication with all of the highway patrol cars and motorcycles, all of which will be equipped with receiving sets. All of these receiving sets will be tuned in on the state transmitting stations only, and so adjusted that they cannot be changed to get any other station.

The radio control system will make the highway patrol more effective than ever in reducing accidents, especially in arresting reckless, hit-and-run and drunken drivers. Captain Charles D. Farmer of the patrol pointed out. For if a drunken driver is reported in a particular vicinity, or a hit-and-run driver is heading in a certain direction, a full description can at once be broadcast to all patrolmen in that territory and orders, issued to the nearest ones to make a search for the driver and arrest him. Farmer said. The radio system will also make it possible to dispatch patrolmen to scenes of accidents in a minimum length of time.

"We believe the radio network will greatly aid us in the enforcement of all the highway laws and thus reduce the number of accidents," Farmer said.
