More Than 110 Dead From Intense Cold Wave Gripping Much Of Nation

More Sub-Zero Weather Forecast For Nation

MUCH PROPERTY IS LOST IN FIRES

Minnesota Town Continues to Hold Record Low with Reading of 56 Below

Chicago, Jan. 24.—(AP)—A new blast of Arctic weather slashed down the Eastern slope of the Rocky Mountains today with more sub-zero weather forecast for the nations.

Snow barriers deepened over the northwest just as the eastern half was beginning to recover from a two-day frigid wave that left at least 110 dead in 17 states.

Temperatures rose slightly from South Dakota and Nebraska to New York and wild gales spent their force over the Atlantic but more icy winds whistled down from the Canadian-MacKenzie river basin.

Chicago, Jan. 24.—(AP)—Intense cold which gripped the upper half of the nation leaving almost 100 dead and widespread property damage today apparently headed for the Atlantic ocean as moderating temperatures with more snow were forecast generally.

The fury of the storm apparently spent itself on New England, New York and New Jersey, but sub-zero frigidly still held many north central and midwestern states in its icy grip.

Hundreds of thousands of dollars property damage was caused by fires. Three villages in upper New York virtually were burned out by flames carried by high winds. Small fires in Ohio caused an estimated \$250,000 loss. Two buildings in downtown Pittsburgh were reported with a loss of \$100,000.

International Falls on the Minnesota-Canadian border again turned in the record low temperature for the nation yesterday with minus 56 degrees.

Near Anderson, Ind., 100 persons, including motorists and school children, spent their second night in the Walnut Grove school marooned by eight feet drifts. The group had plenty of food and fuel.

Meets Success In Attempts To Form French Cabinet

Albert Sarraut, Veteran Radical Socialist, Forms 101st Government of Third Republic

Paris, Jan. 24.—(AP)—Senator Albert Sarraut was successful today in his attempt to form a new cabinet for France—the 101st government of the third Republic.

Sarraut, who already has served his country before, is a veteran of the radical, socialist party.

The cabinet he has formed is a transitory body to keep the government running until the parliamentary election which will be held in April or May.

Frontier Incidents Between Countries Brings New Climax

Recurring Clashes Bring Protest From Manchoukuo, Considered as Virtual Final Warning

Tokyo, Jan. 24.—(AP)—Numerous new frontier incidents between the Japanese-occupied state of Manchoukuo and Soviet-occupied Outer Mongolia drove the Eastern Asian border controversy to say toward an apparent climax.

A Domela (Jap) news agency dispatch from Siping, capital of Manchoukuo, said the recurring clashes brought a virtual protest from the Manchoukuo foreign office to Outer Mongolia—conferred by officers as a virtual "final warning."

MERCURY HERE RECORDS RISE

Official Reading at 8 O'Clock This Morning 19 Degrees

Relief from the cold weather experienced by Greenville people the past two days seen here today as the mercury began a rise in the afternoon which carried it above the maximum reached yesterday.

The lowest mark reached last night was 15 degrees, one above that reached on the previous night when it dropped to 14 degrees. The lowest recorded for this winter is 13 degrees registered December 27.

The highest mark reached yesterday was 28 degrees, but the thermometer reading was at about that mark at noon with indications the official high standing for the day would be higher.

The reading at 8 o'clock this morning was 19 degrees, while yesterday morning at the same time it was 15.

With a normal death of about four feet, the Tar river here today stood at 15.4 feet, and was still rising. The stream already has begun to fall at Rocky Mount, but weather bureau officials said the crest would be reached here and at Tarboro tomorrow.

It was predicted yesterday the river would reach 17 feet, but it was believed today it would not go quite that high.

Executive Council of A.F. of L. Defers Act On Resolution

Postpones Until Next Meeting Action on Resolution Seeking Constitutional Amendment

Miami, Fla., Jan. 23.—(AP)—The American Federation of Labor executive council deferred until its next meeting action on the last convention's resolution for an amendment to the constitution limiting the court's power to nullify social legislation.

It was indicated the council was investigating whether congress does not at present possess the power to prevent the supreme court from voiding legislation.

"We are going into this matter carefully," said President William Green of the federation, in announcing the council's action. "We don't want to defeat our own aim."

He pointed out a constitutional amendment denying the court the power to declare "social justice" acts unconstitutional might be possible by using fixing wages and hour or denying workers the right to strike.

DEATH BY GAS IS DISPLEASING TO WITNESSES

Allen Foster, Birmingham Negro, Is First Victim

CORONER SAYS IT IS HIS LAST

Eleven Minutes After Switch Tripped Before Negro is Pronounced Dead

Raleigh, Jan. 24.—(AP)—Allen Foster, 20-year-old Birmingham, Ala. negro, was asphyxiated here today for criminal assault on a Polk county white woman in the first lethal gas execution east of the Mississippi river.

It was 11 minutes after the electrical apparatus operating the gas generating the equipment was tripped before physicians pronounced the man dead and witnesses who had seen many electrocutions expressed displeasure with the way the gas acted.

The switch on the gas machinery was tripped at 10:37 a. m. a minute after the death chamber was locked tight but it was 10:48 before Dr. George S. Coleman, prison physician and Dr. Kemp Neal of Raleigh said the negro was dead. The man breathed spasmodically and convulsively while the gas filled the chamber.

Coroner L. M. Waring of Wake county who had witnessed 72 electrocutions at the prison, said "my first gas execution will be my last," as he criticized the method.

Although Foster had declined to make any last statement as he was strapped into the middle chair of the three in the new chamber, he tried to talk after he was locked alone in the nearly sound proof room. The man was not blindfolded and faced some 25 witnesses who peered through a thick wall of glass.

Witnesses thought he said "tell my mother good by" and mumbled a "goodbye to you all."

AGREE ON NEW SUB FOR AAA

Keep Details Secret For Time Being, However

Washington, Jan. 24.—(AP)—A Senate Agriculture sub-committee of five Democrats today unanimously agreed on a revised farm bill to replace the AAA but members were bound to secret on its details for the time being.

This action was announced shortly after President Roosevelt set making agriculture "as productive as it was 100 years ago" as the New Deal's goal and expressed a hope it could be done within the constitution.

Secretary Wallace who grooped in on the group as it went over the amendment, drafted overnight came out smiling and told reporters "everybody is happy."

Wallace earlier told news men: "The soil conservation thing is very fundamental and important."

"In drafting it you can say it is the principal thing presented before the committee."

Both Chester C. Davis, farm aid and Wallace earlier had appeared before the house agriculture committee.

Chairman Jones (D. Texas) told newspapermen afterwards that in addition to canvas in the two-year stop gap plan for direct subsidy payments for soil conservation.

"We include the question of endeavoring to add as a part of the program a plan for cooperation of the state in the utilities program."

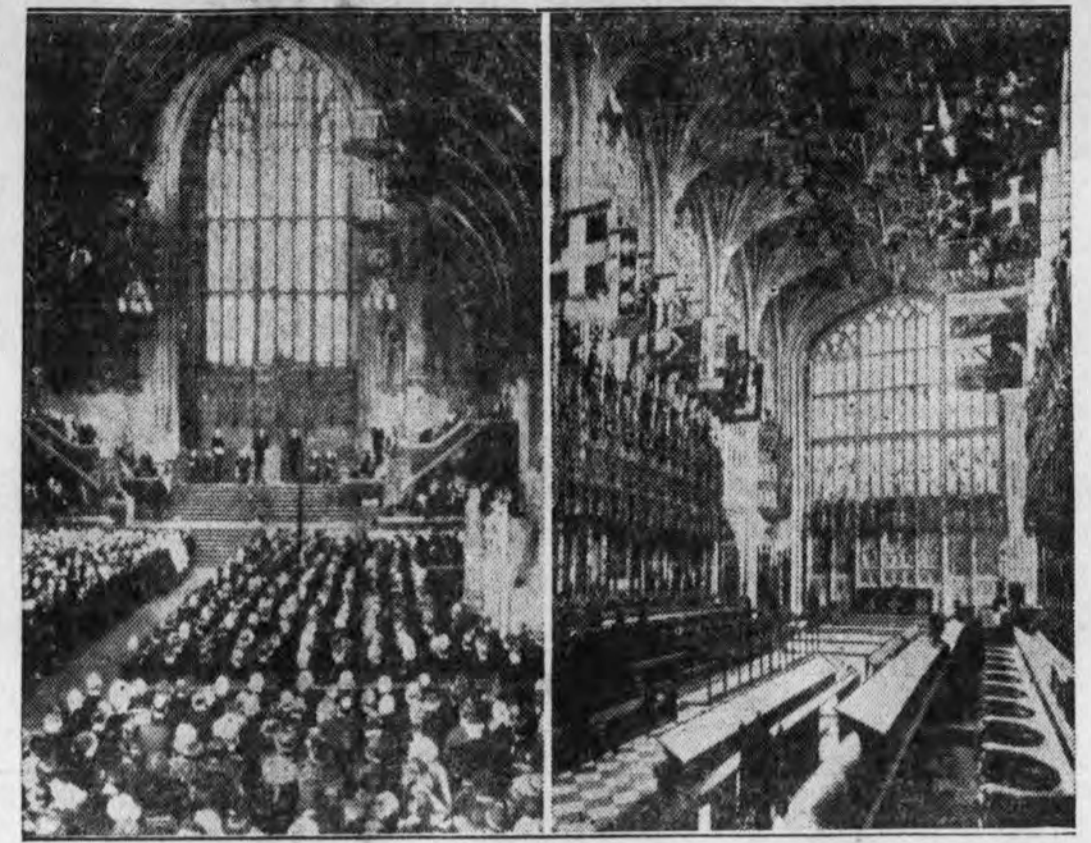
This method has been referred to as "48 little AAAs." It contemplates making subsidy payments after the first two year's contingent upon state cooperation in the program.

PACTOLUS MAN CROWDS MOURN ALDERMEN ASK IS SENTENCED FOR LATE KING BETTER PLANS

John Cannon Sentenced to From Five to Seven Years

Two Pitt county men, one a white man, were given sentences, the negro upon conviction and the white man after entering a plea of guilty, on charges of having carnal knowledge of a girl under 16 years in Superior court here.

Dave Harris, Fountain negro was sentenced to 18 months after he was adjudged guilty of the crime on his wife's sister's daughter.

Testimony brought out at the trial disclosed that the girl was a sister of the man's wife and that while the woman was sick the girl came to the home and aided in taking care of her. The woman died from the sickness. It was brought out that the girl spent some time there and that the defendant had carnal knowledge on more than one occasion. He expressed his willingness to marry the girl, but her father objected to it.

Much of the Thursday afternoon session was taken up in trying Arthur Lee Tysen, negro charged with burglary. The jury returned a verdict of not guilty against the man. He was charged with stealing \$54 from a negro girl, who claimed the money was tied around her waist.

Tom Adams entered a plea of guilty to forgery this morning and was sentenced to 18 months on the roads in one county and 12 months on another.

Thousands File Past Bier in Westminster Hall

(Copyright By Associated Press) London, Jan. 24.—(AP)—The first of 1,000,000 sorrowing pilgrims filed today past the bier of the late King George V. In the ancient palace of Westminster.

There, the new King, Edward, VIII, and the bereaved royal family left their liege for four days of public homage before the final service and burial next Tuesday at Windsor.

Long before last midnight crowds gathered in the streets about Westminster Hall, sacrificed their sleep and braving a misty rain to be among the first to pay tribute to the late king.

When dawn broke over the rooftops of London the queue stretched nearly a mile.

When the great crowd of pilgrims at last surged in the building it was in lines four abreast along both sides of the coffin.

Rich and poor, young and old, they flowed by throughout the day at an estimated rate of 16,000 persons an hour.

Amid this scene the body will remain until Tuesday when it will be taken again through the streets of London as it was in yesterday's solemn procession from the King's cross railroad station.

Greenville Officials Take Initiative in Many Moves

Greenville city officials are taking the initiative in many movements leading toward better city government, working through the North Carolina League of Municipalities.

At a recent regional meeting of that organization in Winston-Salem H. H. Duncan raised two questions: First, what is the best procedure for the collection of taxes delinquent for 1931 and prior years and second, why could not cities and towns make purchases on a co-operative plan so as to effect a saving?

The Greenville man declared that if the public at large is made aware of the fact that the Homestead amendment, if it becomes operative, will result in increased taxes on other property, the measure might be defeated.

J. O. Duval, in connection with the discussion in collecting taxes, suggested that a uniform tax collection law was greatly needed in this state and that such legislation should be sponsored by the League.

In discussions on the relief situation in the various cities, Mayor M. K. Blount stated that the situation is serious in this city.

Mr. Duncan offered a motion, which was carried, that the meeting instruct the committee on welfare and unemployment relief ascertain the facts and attempt to take definite action on the relief problem and that the proper authorities be requested to distribute surplus commodities.

An accepted amendment urged that the certification date for relief cases to WPA be moved up to January 15.

Mr. Blount stated that the situation is serious in this city.

DUCE STRIKES AT OPPONENTS

Rome Speaks Out Against Mutual Arrangements

(By The Associated Press) Rome spoke out today in bitter warring against Mediterranean security arrangements among "sanctitists" powers while her armies claimed aggressive success on both north and south African fronts.

Il Duce prepared for Geneva distribution to the sanctionists nations warning that Great Britain's action in arranging Mediterranean mutual Assistance agreements before other powers constituted a "danger for European peace" and that it was outside the League of Nations covenant.

Marshall Pietro Badoglio, Mussolini's high commander in Africa, reported "complete victory" for the Italians at the end of a three-day battle in the southern Tembien mountains.

Down in the arid Ogaden, General Graziani, mounted in modern fashion on a truck rode at the head of his column into Negagelli, capital of Galla Borana, to climax a six-day drive in which the southern army plowed straight through the heart of Ras Desta Dempo's, Ethiopians and seized all the water holes within 250 miles of Dolo.

These reports of Italian success followed upon Ethiopian claims that "thousands of Italians" had been killed in the Tembien battle and that Ras Desta, son-in-law of Emperor Haile Selassie was yet undefeated in the south.

The Italian's league protest reaffirmed "explicitly" that Italy does not intend her colonial action in Ethiopia to "constitute a menace to European peace."

Hence, Italy protested, mutual security actions were unnecessary and dangerous because they disclosed that military conversations had taken place between league members against another league member.

FOUR PERSONS DIE IN BLAZE

Only One Member of Family Escapes in Maryland Fire

Knockville, Md., Jan. 24.—(AP)—With ice coated snow blocked roads cutting off rescuers, four members of a family of five were burned to death early today when fire destroyed their isolated farm house on South Mountain near here.

A 10-year-old boy, the only survivor, escaped with severe burns and bruises by leaping from a second-story window after his heroic attempt to arouse the family had failed.

The child, Charles Swope, told firemen he was awakened sometime after midnight by the crackle of flames and found his bed room in flames.

He said he shouted to his father, but received no answer and was forced to jump from the window to save himself.

Republicans Refuse to Delay Vote Single Day

BILL NOW GOES TO THE SENATE

Author of the Measure Predicts Not More Than 20 to Vote to Sustain

Washington, Jan. 24.—(AP)—A heavily Democratic House voted 324 to 61 to override President Roosevelt's veto of the \$2,491,000,000 bonus bill today.

Only a two-thirds majority was needed. Republicans who refused to delay the vote even a day. The bill now goes to the Senate where a vote is not possible until Monday.

There, 100 leaders forecast the bill will be made law over President Roosevelt's opposition. Senator Clark (D-Mo.) and author of the measure predicted not more than 20 votes would be cast to sustain the veto as against 33 needed.

Members barely awaited to hear the reading of the brief hand written message before demands of "Vote! Vote!" were shouted.

Democratic leaders sought to delay balloting until Monday but were voted down 189 to 131.

Mr. Roosevelt vetoed his written message returning the bonus bill "without my approval."

When Senator Harrison (D-Miss.) chairman of the finance committee and administration stalwart, said: "It is my opinion that the veto will not be sustained. I shall vote to override the veto."

In his short text President Roosevelt referred senators and representatives "respectfully... to every word in what I said in last year's veto of a current answer to the bonus payment bill."

"My convictions are as impelling today as they were then," the President said. "Therefore, I cannot change them."

Many Auto Wrecks At Intersections Can Be Prevented

Highway Safety Director, Fulk Says Many Accidents Could Be Avoided If Drivers Careful

Raleigh, Jan. 24.—Too many automobile accidents are happening at street and highway intersections—and all of these could be prevented if just one of the two drivers involved in every intersection accident would be careful, according to Arthur Fulk, director of the division of highway safety of the Department of Revenue.

"There were 1,935 accidents at intersections in 1935, of which 1,194 were at street intersections in cities and towns and 741 at rural intersections," Fulk said. "While the traffic is more dense in the cities and towns, still these figures would indicate that drivers are more careful at rural intersections than at city intersections. The sad part of these figures is that every one of these accidents could have been prevented if just one driver of each car involved had been careful and observed the law."

"Stop signs and traffic lights were put up not only to control traffic at important and dangerous intersections, but also to protect both the motorists and pedestrians. Observation of them by both automobile drivers and pedestrians is a necessity if we are to eliminate accidents. Some motorists become annoyed at having to wait for traffic lights to change and insist in 'crashing' these lights. But the drivers who do this are running the risk of crashing into or being crashed into by another driver doing the same thing. The wise thing to do is to wait until the light changes, or at rural intersections, to slow down sufficiently to see that the way is clear."

In December, there were seven fatal and 93 non-fatal accidents at rural intersections and three fatal and 30 non-fatal accidents at rural intersections. These were 11 fatal and 63 non-fatal accidents between intersections in cities and towns, many of the injured being pedestrians.

News Behind The News

Washington By RAY TUCKER EFFECTIVES: The liberal doses of soothing syrup which Ray Roper has fed to his Business Advisory Committee seem to guarantee less bickering between this group and the White House. The Commerce Secretary has again justified FDR's reliance on him as No. 1 Fixer at Washington.

New blood has been infused and special care was taken to insure that the substitutes were less excitable, less publicity-minded than some of their predecessors. Several members suspected of tipping off the press to anti-administration resolutions were quietly dropped. The executive committee is dominated by men who prefer cooperation to carping. But Mr. Roper's fine hand shows most astutely in the "agenda" he persuaded them to adopt for 1936.

Although he proposed it some weeks ago, nobody has leaked. It stipulates that the committee will avoid controversial matters such as New Deal legislation and policies. It won't march to the White House in mass protest, as it did last year. It will limit its curiosity to a field where there is little room for sharp differences of political opinion—trade development, merchant marine, aviation, automobile safety campaigns, railroads etc.

FEUD: The New York reunion of the Hyde Park and Oyster Bay Roosevelts didn't promote peace in the family. Alice and Teddy resented the suggestions of the President and Mayor LaGuardia that their father would bless the new philosophy if he were still alive. Teddy grumbled that "most of them now praising him (T. R.) were on the other side during his fights." Teddy showed how he felt when he arose to speak. He failed to include "Mister President" in his opening salutation. Then he spoke with his back to the nation's head man. A deep flush suffused the presidential countenance.

A secret feud has existed between the family's claim to fame. As landed proprietors, the President's family looked down on the Oyster Bay branch, who made their money in trade. Political warfare has sharpened the feelings all around. Friends say FDR's deepest ambition is to leave a more permanent imprint on history than T. R. did.

IRKSOME: The two political generalissimos—Jim Fawley and Henry Fletcher—have resumed up in a quiet move to keep the 1936 campaign free of the back-stage whispers which have marked so many presidential contests in recent years.

Chairman Fletcher acted immediately when he learned that the "Republican National Council" of New York was distributing envelope stickers defaming President and Mrs. Roosevelt. He asked New York National Committeeman Charles D. Hill to investigate the sponsors. Mr. Hill reported that none of the named listed on the council's literature was known to responsible Republicans. They didn't have bona fide addresses or telephone listings.

Then Reps. Bolton and Bacon of the G. O. P. Congressional Committee disavowed the "council." (Continued on Page Four)

British 'Bobbies' Turn Tough Abroad— And That's Why Empire Holds Together

CAIRO, Egypt (AP)—The tourist who, after a month in England, notices the impression that every British policeman is a model of sweetness and light, owes it to himself to gain a working knowledge of the British "Bobby," Egyptian model.

The latter is, with the possible exception of the original Texas Ranger, the coolest, most deadly executioner in time of stress to be found in the course of a world tour.

A close association with him for a few weeks will go a long way toward explaining the British empire. It will make clear how a handful of British "sahibs" can control several million natives.

"They're 'Ard 'Uns Matey'"

There's no particular trick to it. The British policeman who, in London, doesn't pack a gun and spends most of his time assisting old ladies across Piccadilly Circus, simply reacts in normal fashion once he sets foot on colonial or protectorate soil.

No longer under the compulsion



to smile, and with a ".38" strapped to his hip, he becomes a bad person to fool with.

He shoots to kill, as was evidenced by some eight of ten deaths among Egyptian students in recent riots here. The exact number may never be known, as British authorities, anxious to avoid public funerals, took several bodies from the hospital and buried them at night.

Shot Guns Declared 'Out'

The most gun notches were accredited to Bimbashi (or ajor) E. L. Lees, a bulky, 45-year-old British police officer, who killed one student and fatally wounded three others in an encounter at Giza bridge, over the Nile. He had, however, been knocked down and severely injured when he fired.

A week later, after passing three shotguns sentries, I was Major Lees' guest at his home some 20 miles from Cairo.

"I wouldn't have had to kill them," he explained, exhibiting a heavily bandaged arm, "if I hadn't first tried to stop them with a shotgun. Bird shot only made them mad. I'll never fool with a shot gun again."

One night the anti-British element was holding a mass meeting and Nahas Pasha, fiery leader of the Wafd party, was working them up to fighting pitch. Several hundred police, with steel helmets and riot shields, were waiting for them.

Washington Daybook

HERBERT PLUMER

Washington, Jan. 24—Representation by states on the supreme court, now that the judicial branch of the government has come in for such close scrutiny, may figure prominently in discussions regarding the future of that tribunal.

There have been repeated requests for more sectional representation on the supreme court for years. Even a certain amount of jealousy has been displayed by those states who have never had a native son to sit there.

Only 28 states have had natives to sit on the nation's highest court. New York has had the largest number with 10, Massachusetts and Ohio, with seven each, come next. Several of the states have contributed as many as five members to the court—Pennsylvania, Virginia, Maryland and Tennessee.

New Jersey, Kentucky, Georgia and South Carolina have had three each.

Connecticut has had two, as have Alabama, Illinois, California and Louisiana. Minnesota, Wyoming, Michigan, Kansas, Mississippi, Iowa, Maine, New Hampshire and Utah have had one member each.

Those states which have never been represented on the court are: Arizona, Arkansas, Colorado, Delaware, Florida, Idaho, Indiana, Missouri, Montana, Nebraska, Nevada, New Mexico, North Dakota, Oklahoma, Oregon, Rhode Island, South Dakota, Texas, Vermont, Washington, West Virginia and Wisconsin.

It is true, of course, that some of the states that have had no representation on the court as yet, were admitted to the Union a relatively short while ago.

Whether President Roosevelt will have opportunity during his administration to change the line-up of the court is a matter of speculation. The advanced age of one of the justices, illness of another and the reported inclination of a third to retire may give him the chance.

President Hoover sent the names of four men to the senate for places on the supreme bench. One was rejected flatly—Judge Parker of North Carolina. Another, Chief Justice Hughes, was confirmed by that body after a tremendous upsurge. The third and fourth—Justices Roberts and Cardozo—were confirmed by the senate with little difficulty.

If President Roosevelt is called on to fill a supreme court vacancy during his administration, the best bet, probably is that he will name

KIRKPATRICK ALTERS PLANS

News Received At Raleigh He Will Seek Senate Job

Reflector Bureau.
Sir Walter Hotel.
Raleigh, Jan. 24.—The news just received here to the effect that Colonel T. L. Kirkpatrick of Charlotte has withdrawn from the race for the Democratic nomination for Governor and instead will become a candidate for the Democratic nomination for the United States Senate against Senator Robert F. Reynolds in 1936, is causing some mild interest in political circles here.

The prevailing opinion is that the Colonel is merely postponing his own political execution another two years. It has never been definitely known here whether he was actually ever a candidate for the nomination for Governor in 1936, although he has talked of becoming a candidate for the past four years. When he was a member of the senate here in 1933, he announced that he was a candidate for Governor in 1936, but not many took the announcement seriously.

The prevailing opinion in most circles here has been and still is that Kirkpatrick will not be able to make any more progress as a candidate for Senator than he has made so far as a candidate for Governor, owing to the fact that few people take him as seriously as he takes himself.

While the 1936 contest for the senatorial nomination is still a long way off, opinion in most circles here is already leaning the belief that Judge Wilson Warlick of Newton, Catawba county, is likely to be the principal opponent of Senator Reynolds and the one most likely to defeat him, if he is defeated. For almost a year now Warlick has been considered the most likely and most dangerous opponent Reynolds will have in 1936.

Naval Expansion Enriches Builders of Ships, Pay Rolls

Berlin, Jan. 24.—(AP)—Increased earnings, increased dividends and increased wages of ship building companies for 1935 tell the story of Germany's biggest naval building year since the war.
And if Dr. Hjalmar Schacht, Hitler's economic dictator, can find the means, 1936 promises to be a bigger year for only one-fourth of the sparkling new navy the Nazis expect to construct has been talked so far.

The 1935 program called for a little more than 107,000 tons while the completed navy is to be 420,585 tons.
The 1936 program is under preparation. Among the big units it will contain is an airplane carrier which the Nazis are eager to add to the rapidly growing "swastika" fleet. They want as soon as possible to add an air arm to the marine forces.

No hints, however, have been given as to what sea plane equipment is intended.
Foreign naval experts say that the German naval construction program has been planned for a long time ahead—even beyond the 420,585 tons permitted by the Anglo-German treaty which allows the rich a navy equal to 35 per cent of Great Britain's globe-encircling fleet.

One of the most important marine construction concerns, Blohm and Voss of Hamburg, declared a five per cent dividend on last year's business, against four per cent in 1934. The same company tripled its expansion account for new docks and equipment and bolstered other special accounts by similar amounts.
It paid out twice as much in wages in 1935 as in 1934 and still wound up with \$40,000 additional net profit. Total income was \$9,616,400 and net income was \$231,600.

The company was able to make this jump in business although the naval building program officially did not go into effect until July—after half of the year had passed.
The annual report says only three commercial ships were constructed by the yards. It simply ignores mention of how many fighting ships it built.

Nor does it give any indication as to how much Germany's new navy is costing. This latter information is withheld, as a state secret.

Continued from Page One. Two days later Mr. Farley's Solicitor General ruled that three of the stickers were clearly objectionable and unamenable under the law.

PENSIONS: If World War veterans launch a drive for pensions for all when and if the bonus is paid they will be getting in astronomical figures—from \$3,000,000,000 to \$10,000,000,000.

Veterans' Administration mathematicians' studies reveal that peak demands are always voiced in times of depression, that peak costs come under Democratic Presidents—Monroe, Jackson, Cleveland, Wilson and perhaps FDR. They attribute the phenomenon to the fact that depression always follows a war, and Democratic presidents are usually elected in days of depression.

They also learn that the veteran have cut down the waiting time for pensions war by war. The years which elapsed between the war's ending and the grant of general pensions for the various conflicts follow: Revolutionary, 35; War of 1812, 59; Civil War, 25; Spanish-American, 21; World War—bonus payments in 1936, or 18 years. If the bonus could be started off till 1945, it is figured the move for further liberalization would not begin until 1950. Payment now may mean the movement for permanent monthly allowances will start ten years earlier.

New York By JAMES McMULLIN

MUST: New York Republican backstagers have been making a careful survey of Borah's chances. Their best estimates indicate that the Idahoan will come to Cleveland with between 150 and 200 delegates apiece. That isn't a very high percentage of the total convention vote—but it might easily represent a troublesome balance of power.

Meanwhile the GOP ears-to-the-ground department learns that Tammany sentiment for a revolt against FDR is subsiding. Boss Dooley has just about persuaded the die-hards there's no percentage in it. Unless the Tiger undertakes at least passive resistance at the polls next November, Republican prospects for carrying New York State are not so hot.

Party strategists are currently planning to lay down their heaviest barrage—outside of New York—in Illinois, Indiana and Ohio. The feeling is that these three must be captured if the elephant is to come home in front.

SQUELCHED: Financial leaders say the biggest issue involved in the Supreme Court decision on the Rice Millers case has escaped general attention. The government's argument that the case should be dismissed was based chiefly on an existing statute which reads: "No suit for the purpose of restraining the assessment or collection of any tax shall be maintained in any court." The Supreme Court held that this plea was invalid because the tax question was itself illegal.

This ruling was in effect a lethal wallop at the President's intimates who for legislation to curtail the jurisdiction of the lower federal courts in constitutional questions—especially in the matter of injunctions against tax collection. The "Big Nine" decreed—unanimously—that the protection of a litigant's constitutional rights cannot be curbed by limitations on jurisdiction. Thus another attempt to buttress the New Deal's legal foundations is squelched even before it is seriously begun. Several bills are in the Congressional hopper to put

George Helped Great Britain Out Of Post-War Poverty

Great Britain came out of the World war hard hit by losses in men and treasure, but even more vitally wounded in her life stream of world trade. Poverty and distress such as beset her in the decade following the fighting have seldom fallen to the lot of any state in modern civilization.

Soldiers pouring back from the battlefields found mills, foundries and mines idle. Countries which had depended upon England for fabrics, steel, and fuel before the war, had turned to other sources or developed their own. Attempts to reopen these markets met with indifferent success. Some still are closed.

The "right little, tight little island" which had been the "workshop of the world" found itself periously close to being the world's poor-house.

Ireland Partitioned

Economy was the watchword and Buckingham Palace showed the way. The civil list, settled by parliament in 1910, provided \$2,350,000 annually to maintain "the honor and dignity of the crown." In the post-war depression this proved inadequate to maintain the royal household on its usual scale. Yet the king made it do.

Coincidental with economic stress was the partition of Ireland. The Irish Free State came into being by the king's proclamation of December 6, 1922, while Ulster remained loyal to the crown.

Slowly the United Kingdom found its way back. A laborite government, formed by Ramsay MacDonald in 1924, initiated measures looking toward greater social security, but fell after eleven months before popular indignation over its friendliness with communist Russia. A general strike almost paralyzed England in 1926.

MacDonald gained his second prime ministership in 1929. The resurfacing of the labor party saw several of its members raised to the peerage, so that the organization might have spokesmen in the house of lords. There was much public chaffing of some of these ex-warriors as they donned robes and coronets.

The King Confers

The big crisis came in August, 1931, when Britain reeled under the shock of a world economic tremor which had started nearly two years before.

Withdrawals of foreign balances from London, drain of the gold reserves from the Bank of England, disputes in the labor cabinet and a budget that would not balance, troubled matters to a head. The king was in the Scottish highlands, but after a telephone message from MacDonald, he hurried back to the capital.

He arrived at Buckingham Palace on a Sunday morning, ate breakfast and sent for the prime minister. Later he talked with Stanley Baldwin, conservative leader, and then with Sir Hubert Samuel, liberal party adviser. One of this initiative there emerged on August 26 a "national" government, MacDonald remained prime minister with Baldwin second in command.

The new government suspended the gold standard. This step gave British industries, paying production costs in depreciated pounds but collecting full value money in importing countries, a change to cut prices. Trade began to mount and factory chimneys to smoke. Workers' who for years had subsisted meagerly on government doles took more adequate amounts from pay envelopes.

Commonwealth of Nations.

Once again the royal household helped. The king cut \$250,000 off the civil list, the Prince of Wales offered the exchequer \$50,000 from the revenues of his Duchy of Cornwall.

The India question would not down. Mahatma Gandhi's "salt rebellion," progressed from "passive resistance" to riots. Out of the unrest came the round table conference of 1930, followed finally by a "self-government for India" bill that will put the peninsula upon a dominion basis when its provisions go into effect.

Empire conferences in 1926 and 1930 erected a new imperial structure. Its capstone was the 1931 statute of Westminster which gave the dominions a vote in the law of succession to the throne.

Thus the close-knit empire which George V inherited, was left for his successor a "commonwealth of nations."

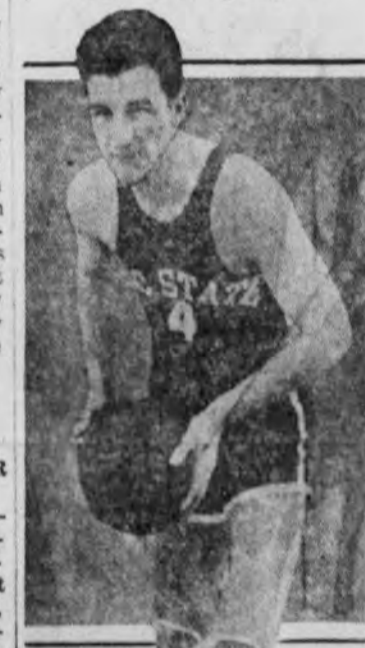

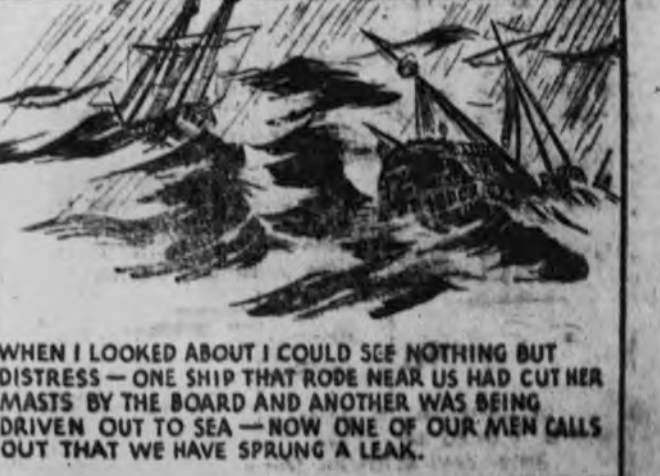

STATE LOOKS TO KENTUCKY

Bluegrass State Drops Sales Tax With No Substitute

Raleigh, Jan. 24.—Could North Carolina do what Kentucky has done if the North Carolina sales tax should be repealed? Would the measure which Governor "Happy" Chandler has put into effect or is advocating as a substitute for the sales tax prove effective in North Carolina?

These questions are being asked in state governmental circles following the receipt of word as to how Governor Chandler is meeting the situation in Kentucky as a result of the repeal of the sales tax which last year brought \$10,000,140 into the Kentucky treasury, one-third of which was allocated back to the counties and towns for local use. It is estimated that the abolition of the sales tax in Kentucky within the last ten days will reduce the revenue of that state between now and June 30, 1936, by \$3,500,000 and that the counties will also lose \$1,750,000 in revenue that would have been allocated back to them.

The first step being advocated is the issuance of from \$2,000,000 to \$3,000,000 in interest-bearing state warrants at a high rate of interest to bridge the gap until the legislature, now in session can devise ways and means of finding new revenue with which to replace the revenue lost as a result of the repeal of the sales tax. The state already has something like \$25,000,000 in interest-bearing state warrants already outstanding, so that if this new batch of warrants is issued, the state's floating debt will be boosted up to \$27,000,000 or \$28,000,000. This debt is in state warrants, not state notes, issued in payment of current bills and salaries. The largest floating debt North Carolina has had in the past ten years was at the close of the Gardner administration, when some \$12,000,000 in notes were outstanding. This amount was borrowed so the state could pay the school teachers for the state-supported six months school term since the 1931 general assembly passed a law stipulating that the budget act should not apply to teachers' salaries, with the result that they could not be reduced in accordance with other expenditures. This amount of indebtedness, together with some \$2,000,000 more, was ordered funded by a bond issue by the 1935 general assembly and the bonds sold at a rate of 2 1/2 per cent interest, the lowest in the history of the state. North Carolina now has no floating indebtedness and has not had to borrow one penny of money since 1933.

But Kentucky cannot issue any bonds without a vote of the people and the people have consistently refused to authorize the issuance of any bonds to fund this floating indebtedness. Apparently it cannot even borrow on state notes, with the result that for several years it has been forced to issue interest-bearing warrants whenever it lacked enough cash to pay its obligations in cash. One of the present problems of the Kentucky legislature is not only to find revenue with which to retire the \$2,000,000 to \$3,000,000 in warrants which Governor Chandler is expected to authorize immediately, but to find some way to retire the other \$25,000,000 in state warrants.

The only direct move made by Governor Chandler so far to find a substitute for the sales tax has been to discharge some 8,500 state employees, which he estimates will save the state about \$1,000,000 within the next six months. But he still must find funds with which to pay the university and normal school faculties and operating expenses, also the school teachers—or the part of their salaries paid from state funds. So far the money with which to do all this is not in sight, according to press reports from Kentucky. For the revenue from the sales tax in Kentucky, as in North Carolina, was used to pay the expense of the schools and other state educational institutions.

Kentucky already imposes a state tax of 5 cents a gallon on the manufacture of whiskey, but the distillers are already objecting to this on the grounds that it puts them at a disadvantage in competing with distillers in other states. So on the whole, it would seem that Kentucky is in something of a mess.

Lawyers In State Ready To Cash In On Driver's Law

Highway Safety Division Receiving Many Letters From Attorneys Concerning New Statute
Reflector Bureau, Sir Walter Hotel.
Raleigh, Jan. 24.—A good many lawyers in the state are now making a careful study of the new driver's license law which went into effect November 1 and which has already resulted in more than 1,000 drunken drivers losing their licenses, with a view to seeing if they can't "cash in" by taking cases fighting the law. It was intimated here today.
It was definitely learned that for a good many weeks now, the Division of Highway Safety has been receiving many letters from lawyers asking many questions about the law, evidently with a view to finding some loopholes in it.

In addition, a good many of the more than 1,000 drivers who have had their driver's license revoked have retained lawyers in an effort to get their licenses back. It was admitted. Indications are that before long a test case or several cases may be brought, challenging the authority of the Department of Revenue to revoke licenses, despite the fact that the best legal talent here holds the law entirely constitutional. The Attorney General has already held that it is mandatory for the department to revoke licenses for one year when drivers are convicted of any of the offenses contained in Section 12, also that a driver cannot appeal when his permit has been revoked, though a driver may appeal from a suspension.
