Premier Okada Of Japan Reappears Unhurt After Having Been Listed Dead

Rebellion Fails Under Threats of Machine-Gun Fire

TROOPS GIVE UP MAIN BUILDINGS

Secretary Mistaken for Premier and Killed by Insurgent Japanese Soldiers

The Japanese army's rebellion collapsed today under threats of machine-gun fire as Premier Keisuke Okada, previously reported assassinated, reappeared on the scene unhurt.

Surrender of the troops, which on Wednesday attempted a massacre of cabinet leaders and succeeded in three instances was swift and bloodless after the martial law administration issued them an ultimatum.

Okada, hard-drinking liberal, whose regime has been sharply at odds with the militarists, refusing to bow to civil authority, survived assassin's bullets only because his intended assassins mistook his secretary for him.

The government itself had announced Okada's death.

The secretary fell in the snow outside the Premier's home early Wednesday morning was Colonel Denzo Hatazo, the Premier's brother-in-law.

Okada had an audience with Emperor Hirohito last night. Yesterday morning he submitted his resignation, but he was ordered to remain in office until a successor was chosen. Acting Premier Gumbo Goto was relieved of his post.

The crisis engendered by the mutinous troops numbering 1,000 and commanded by a captain, ended with the surrender of the buildings they had occupied for more than three days.

Loyal soldiers under Lieutenant General Kohji Kasai, who established martial law in Tokyo, advanced on the rebels position in the center of the capital in tanks while airplanes whirled overhead. Machine-gun fire was heard but an official communique said no blood had been spilled.

Woolworth Heiress Is Seriously Sick After Son's Birth

Countess Haugwitz-Reventlow, Former Barbara Hutton, Hovering Between Life and Death

London, Feb. 29.—(AP)—Countess Barbara Hutton Haugwitz-Reventlow, gravely ill after an operation, following the birth of her first child, took a sudden turn for the worse tonight.

An authoritative source said the crisis in her illness was expected later in the evening.

London, Feb. 29.—(Copyright by Associated Press)—Lord Horne, a physician in ordinary to King Edward, paid an unexpected early visit today to Countess Haugwitz-Reventlow, the former Barbara Hutton, hovering between life and death after the birth of her first child and an operation.

A bulletin was issued, announcing: "The Countess had a fairly restful night."

The condition of the Countess, heir to the Woolworth millions, however, was understood to be grave and causing considerable anxiety, having grown worse after earlier assurances that she was "going on as well as can be expected."

SAY POLITICS ARE INVOLVED

Hauptmann's Case Nears Field of Political Activity

Trenton, N. J., Feb. 29.—(AP)—Governor Harold Hoffman in a sharply phrased letter to Col. H. Norman Schwarzkopf, head of the state police, decried today he had no knowledge of any "threats or promises" made by his representative to state troopers who worked on the original Lindbergh kidnaping investigation.

The governor wrote Schwarzkopf after reading the superintendent's fourth weekly report on the reopened investigation of the crime for which Bruno Richard Hauptmann is under sentence to die the week of March 30.

Trenton, N. J., Feb. 29.—(AP)—The fourth weekly state police report on the reopened investigation of the Lindbergh crime submitted to Governor Harold G. Hoffman thru the case of Bruno Richard Hauptmann close today to the field of political controversy.

A report, an authoritative source disclosed, contained allegations of outside meddling with state troopers who were active in the original investigation of the kidnap-slaying of Charles A. Lindbergh, Jr., and the arrest and conviction of Bruno Hauptmann. It was signed by Col. H. Norman Schwarzkopf, superintendent of the State police.

The outsiders, the court said, represented themselves as agents of the government and secretly questioned troopers on their actions.

The source said the troopers who were interviewed were promised security of jobs and in one case an advancement if Schwarzkopf is not reappointed.

Schwarzkopf's term expires in June. The governor thus far has not indicated whether he will reappoint him.

Foes of the Governor have charged at various times that his personal activities in the Hauptmann case and his criticism of the state police investigation have been directed at finding a reason for not retaining Schwarzkopf for another five-year term.

PAPER STATES JUSTICE DEPT. UPHOLDS ACTS

New York Sun Says Air Mail Contracts Were Legal

WERE CANCELLED BY JIM FARLEY

Not Determined As to Whether Companies Have Ground to Sue Govt. for Losses

New York, Feb. 29.—(AP)—The New York Sun in a special dispatch from its Washington bureau, said today the Department of Justice has prepared a report for President Roosevelt officially clearing air mail companies of all civil and criminal liabilities in connection with contract negotiations during the Hoover administration, and cancelled by Postmaster General Farley in 1934.

The Sun said it understood the report confined itself to legal questions and while it takes note of certain "irregularities" in the negotiations of the air mail contracts, it reached the conclusion that there was no transgression of the law by any of the parties concerned.

Whether this would constitute grounds upon which the companies might sue the government for damages resulting from the cancellation of the contracts, could not be learned, the paper said.

The contracts were cancelled by Farley after a Senate committee, headed by Senator Black (D.-Ala.) heard charges of fraud and collusion in the letting of the contracts by Walter Brown, postmaster general in the Hoover cabinet.

WEEKLY INDEX RECORDS GAIN

Associated Press Reports Gain in Industrial Activity

New York, Feb. 29.—(AP)—The Associated Press seasonally adjusted weekly index of industrial activity was unchanged today at 78.7 after declining steadily since the turn of the year. The comparable figure last year was 75.3.

The trend of industry during the week was mixed. Half of the index's components gaining and the rest declining after allowances for the seasonal factors.

The brightest spot aside from the halting of the long decline was the fact that automobile output improved seasonally for the first time in almost two months.

Electric power production made a new record peak for the third time this year. Steel mill activity moved ahead. The drop in car loadings was due principally to the smaller coal movements necessitated by milder weather. Cotton manufacturing and residential building were also lower.

Ten States Join In Petitions To Supreme Justices

Contend Recent Decision Will Force Building and Loan Associations Out of Business

Washington, Feb. 29.—(AP)—Ten states in joint petitions to the Supreme court today contended a recent unanimous decision by the nine justices was "erroneous" and will force many solvent building and loan associations out of business.

They protested a decision February 3 which held that a 1932 Louisiana statute limiting withdrawals from building and loan associations was unconstitutional.

The unanimous opinion, delivered by Justice Roberts, asserted the law—passed when the late Huey P. Long dominated affairs—was invalid.

Texas, Indiana, Illinois, Iowa, Kansas, Missouri, North Carolina, Oklahoma, Wisconsin and Louisiana, asked the rehearing.

Outlook Now Is For Cheap Tobacco Prices This Fall

Raleigh, Feb. 29.—The outlook is now for a tobacco crop of at least 900,000,000 pounds this year and with prices averaging 10 cents a pound or even less as a result of the inability of the Federal government to enact any effective tobacco crop control legislation and the refusal of the state of Georgia to cooperate with the other tobacco producing states by the enactment of state laws limiting tobacco production, Governor J. C. Ehringhaus admitted today.

He sees no possibility of a state pact plan that will be effective in regulating the 1936 crop unless Georgia agrees to cooperate, nor does he believe the present farm bill passed by Congress as a substitute for the AAA will prove effective in limiting tobacco production.

"About the only thing left, as I see it, is a voluntary crop reduction plan under which the farmers would attempt to limit tobacco plantings by voluntary agreement," Governor Ehringhaus said. "And even this plan would not prove very effective unless the tobacco farmers in Georgia, South Carolina and Virginia operated, which is unlikely. For the representatives from Georgia, who met with us in Washington this week told us that there is not the slightest indication that Governor Eugene Talmadge would call a special session for any reason whatever. They also told us that most of the Georgia tobacco growers were planning to increase their tobacco acreage this year enough to produce a crop of about 100,000,000 pounds, as compared with the 60,000,000 pounds they produced in 1935 and which was one of the principal reasons for the depression of the 1935 tobacco prices. So the chances for securing pact plan for restricting tobacco acreage this year seem to be out of the picture entirely."

While Virginia and South Carolina are both willing to enter a state pact plan, they are not willing to go into such a plan unless all the other free cured tobacco producing states likewise agreed to such a plan, Governor Ehringhaus pointed out. The result is that while the legislatures of both these states are now in session and that state pact tobacco control laws will probably be introduced and enacted, they will not become operative unless and until Georgia and North Carolina enact similar laws, Governor Ehringhaus said. He intimated that

if Georgia would have a special session and come into the state pact plan that he would hesitate to call the North Carolina general assembly into special session to enact similar legislation. He likewise pointed out that it would be useless for him to convene the North Carolina assembly without any assurance as to what Georgia would do. "I am naturally awaiting with a great deal of interest just what South Carolina and Virginia will do and am interested in seeing just what kind of a state pact law each will adopt—if any are enacted during the present legislative sessions," Governor Ehringhaus said. "But from my conversations with the delegates from these states in Washington this week, I do not think they have any hope of devising a plan that will become operative in time to have any effect on the 1936 crop."

Sheriff's Deputies Locate Two Stills With One Running

Attendant, However, Flees as Officers Near Distillery: Large Amount of Liquor Destroyed

With a let-up in the recent bad weather, officers of the sheriff's office have resumed their activities of breaking up stills, and yesterday two more illicit distilleries were destroyed by the deputies.

The two stills were located in Greenville township. One was in operation, but the operator made his get-away. The other still was not in operation.

In all, the officers found about 1,000 gallons of beer and 15 or 20 gallons of whiskey.

Since the first of the year the sheriff's officers have broken up a large number of stills, but the recent period of extremely bad weather made it impossible for them to get into the woods in search of the illegal distilleries.

To Revive 'Deserted' Town.

SEN. REYNOLDS CAUSES CLASH IN COMMITTEE

Complains Witnesses Were Being 'Cut Short' in Hearing

IMMIGRATION BILL STUDIED

Senator King of Utah Answers Reynolds by Saying Complaint Was Unwarranted

Washington, Feb. 29.—(AP)—A complaint by Senator Reynolds (D. N. C.), that witnesses were being "cut short" in testimony on the Coolidge-Kerr alien deportation bill caused a sharp clash today at a Senate immigration subcommittee hearing. Several witnesses had appeared before the committee each adjured by chairman Coolidge (R. Mass.) to "be as brief as possible."

"If the witnesses are to be rushed," interposed Senator Reynolds, who is not a committee member, "if they are not to be availed of an opportunity to talk and others are not to be allowed to question these witnesses, perhaps the best thing to do is to withdraw."

Quickly, Senator King (D. Utah), shot back: "The complaint is wholly unwarranted."

Nevertheless, Reynolds protested witnesses were being asked to cut short their testimony. Those being heard at the time were opposed to lenient features of the bill.

The bill was a rival to a more drastic measure by Senator Reynolds. The Reynolds bill was described as likely to limit immigration by 90 per cent as well as bring deportation to alien criminals.

Officers Seeking Negro For Murder And Assault Of Young White Couple

ROME REPORTS GREAT BATTLE

Advancing Fascists Encounter Resistance on Front

Rome, Feb. 29.—(AP)—Marshall Pietro Badoglio, Italian communist on the northern front, telegraphed his government today that the "second battle of the Tembien has arrived at its decisive phase."

"The situation of the armed forces of Fas Kassa and Ras Seyoum, caught in a fight by our troops, is becoming hour by hour more critical."

Rome, Feb. 29.—(AP)—A great battle raging in the Tembien sector of the northern front today between the third army corps of the Italian forces and the Ethiopian warriors of Ras Kassa, Marshall Pietro Badoglio reported.

The advancing Fascists encountered this resistance just as their sentries mounted guard over Amba Alaji, the point occupied yesterday and which for several months to come may be the high water mark of the Italian invasion.

Marshal Badoglio's communique said: "While troops of the first army corps reached Amba Alaji, troops of the third army corps and those of the Eritrean army corps attacked from the north and south the forces of Ras Kassa."

"From dawn yesterday, February 28, a bitter battle is raging."

Reports circulated Emperor Haile Selassie, himself, was hurrying from Dessye, his field headquarters, northward in an effort to check the Fascist advance which has penetrated some 37 miles since the start of the February 10th advance.

The capture of Amba Alaji by the first army corps in a swift maneuver, dislodging the Ethiopians, who had retreated to that point from Amba Aradam, coincided with unofficial reports of a major Italian victory in the Tembien mountain section. Three thousand Ethiopians were reported killed and Ras Seyoum's army routed.

Expect To Resume Work at All Pitt Schools Monday

Stokes and Pactolus Units Not in Operation This Week, But They are Expected Re-Open Monday

All schools in the county system are expected to resume normal activities Monday, when the Stokes and Pactolus units are scheduled to re-open, and D. F. Conley, superintendent, said every effort would be made to keep the schools going without interruption until the session is completed.

All schools in the county with the exception of the Stokes and Pactolus units, resumed work this week, but roads were so bad the two districts the schools were kept closed until Monday.

The schools are running from two or three weeks to more than a month behind regular schedule. When the Stokes unit re-opens on Monday, it will be exactly one month and a day behind its regular schedule.

While no definite plans have been mapped out, it is understood that a "movement" is underway to operate schools on Saturday to make up at least a part of the time missed due to bad weather and roads. Whether to operate on Saturdays will be left, to a great extent, to the local boards, it was explained at the offices of the county superintendent.

A plan also is being discussed to operate the strictly rural schools on an earlier schedule, allowing the children to get out earlier in the afternoon and help on the farm.

Mrs. Jones is survived by her husband; three daughters, Mrs. Roy Scott of Bethel and Misses Minnie and Jessie May Jones; one son, William Edward Jones, all of the home place, and one sister, Mrs. "Perrell Ham of Belvoir.

Alexander Warren Dies Instantly Of Pistol Wounds

NO CLUES FOUND AS TO ASSAILANT

Entire County and City Police Force Engaged in Search for Assailant-Slayer

Alexander Warren, 22, was shot and instantly killed last night, allegedly by a negro who, Miss Helen Phelps, popular Greenville girl, said, criminally assaulted her after slaying her companion on an automobile ride.

Sheriff S. A. Whitehurst said this morning, after having searched all night for the negro, that the girl told him the man was successful in his attack.

The murder and alleged attack took place about 11:45 o'clock last night on a side road the old Greenville-Farmville road, the sheriff said. He added his investigation disclosed that the young, popular couple was driving slowly, or possibly had stopped, when the negro flung the door open, fired one shot into the chest of Warren, dragged the girl about 100 yards from the automobile and accomplished the assault.

Dr. J. L. Winstead, in charge of Pitt General hospital, said this morning he "found no conclusive evidence" Miss Phelps had been criminally assaulted, but that she had told him the assault had taken place.

Warren died instantly, the bullet having severed a main artery in its course through his body. The bullet entered the right chest and came out on the left side.

Sheriff Whitehurst said he understood the negro, after having assaulted the girl one time, attempted to do so again, but a car drove nearby and the negro ran. The negro threatened to kill Miss Phelps, Sheriff Whitehurst said she told him, if she made any outcry.

After the negro fled, the young woman, popular amateur entertainer, ran back to the car, pushed young Warren over and, with him still under the steering wheel, drove to Smith's filling station on the Farmville highway. Finding the place closed, she drove to Dr. Cox's filling station on the opposite side of town, from which place Sheriff Whitehurst was called.

In a hysterical condition, the girl was unable to give any details and she was taken to the hospital. Sheriff Whitehurst attempted to further question her again this morning, but she was in such a nervous condition, he said, that she was unable to recount fully the events which took place. She did, however, Sheriff Whitehurst said, disclose the negro succeeded in his attempts.

After taking the girl to the hospital, Sheriff Whitehurst and Deputy Herbert Harris returned to the filling station where Warren's body remained in the automobile.

Then returning to the scene of the crime, the officers traced the negro to town, but lost track of him in the city. The entire county and city police force was engaged this morning in attempting to track down the negro.

Sheriff Whitehurst said he was unable to determine whether the negro came from inside a tobacco barn at the scene of the murder and alleged attack or not. He said the girl told him she saw the negro for the first time about when he opened fire.

The officer said that an inspection of the surrounding grounds indicated the attack had taken place. He said prints indicated there had been a struggle and the ground tended to show the act was accomplished.

Miss Phelps is the daughter of Mrs. Martha E. Phelps of 304 East Fourth street, widow of W. T. Phelps. She has participated in a number of amateur contests in the city and has won a number of prizes for her singing.

Warren, son of C. A. Warren of Carolina township, had been employed at Wynne's filling station at Bethel for some time.

Miss Phelps was reported to be getting along as well as could be expected. She remained in a highly nervous condition, however, and was in the hospital.

Young Warren is survived by his parents; three brothers, Hassell, Edgar and Troy Warren, and three sisters, Clarine, Edna and Joan Warren, all of Carolina township.

He had been employed at Wynne's filling station for two years. Previously he had lived in Greenville for five years, 1923 to 1928.

After a brief business session, Miss Frances Wahl read a most interesting paper on "What Is New in Education," carrying out the club's general topic "Recent Trends in Human Progress." The paper was prepared by Miss Elizabeth Hyman, who could not be present. Miss Hyman told of the charges that have taken place in education during the past decade.

This is a changing civilization and with it, in our educational system has come, and is coming a changing curricula. Because learning comes easier in response to a felt need the modern general tendency is away from the material for which the child feels no need and toward those things whose present use can be demonstrated.

Always there has been change. The best training that can be given a child, therefore is the one that will enable him to meet and adjust himself to changes.

The most fundamental change has been in the underlying philosophy of education. The whole child now is considered. Education is life. It means change, growth, development. Its aim is to provide for richer living. Real education is, and should be, preparation for life. The business of education is, and should be, to teach pupils things useful to them later, when they enter the world of business, or society. Co-operation, initiative, self-control, consideration for others is taught.

The trend is away from so much cut and dried subject matter in text books and toward the development of those characteristics which make for fuller, more satisfactory living. It is more important to teach co-operation and tolerance than historical facts; accuracy, neatness and order, than percentage; honesty, self-reliance, more than political organization of the government. Of course, the formal subject matter is used toward this end and the skillful educator while making character his goal turns out pupils more thoroughly informed than the ones taught under the old regime.

Not so much, as a generation ago, is the human mind regarded as a storehouse in which to store up merely the largest possible number of facts.

In the final analysis, education is worth just the difference it makes in the activities of the individual who has been educated. The question is not how many books did the child read, not how much does he know of social science but rather what use does he make of this knowledge; how is he different from the person who does not possess this information; and still more important, are these differences in his activity desirable from the point of view of the group in which he lives?

Both the teacher's attitude toward the child and the atmosphere of the classroom have changed also. Discipline is evolving from enforcing order to definite training in the making of wise choices of conduct. In regard to grades, children are being encouraged to get satisfaction from the consciousness of a task well done, than from surpassing a rival in the group, to set his value upon what he has learned instead of upon the mark he has made.

BAGLEY TALKS ABOUT POWER

Thinks Municipal Plants Allowed to Sell Current

Reflector Bureau, Sir Walter Hotel.

Raleigh, Feb. 29.—While most of the larger cities and towns in the state operating municipal electric plants have authority to sell current outside their city limits and even to build rural distribution lines, there is still some doubt as to whether these cities and towns can sell bonds or incur debts for the purpose of building rural electrification lines. Chairman Dudley Bagley of the North Carolina Rural Electrification Authority said today.

Yet there is absolutely nothing to prevent these towns from selling electric current to rural lines if such lines are built by independent cooperative corporations, Bagley believes.

Accordingly, Bagley is going ahead with plans for the formation of local membership corporations in communities which want rural electric lines and which are in areas where connections can be made with existing municipal lines, he indicated. The procedure will be to form these local corporations, which in turn will make application to the Federal Rural Electrification Administration for loans for the amount needed to build these lines. If the loans are granted, these membership corporations will either call for bids for the construction of the lines or make contracts with the municipalities to build and service the lines. The city supplying the current and service will then earmark all receipts from these lines in excess of actual cost and turn this revenue over to the corporation for the retirement of the REA loan. There must be enough customers on these rural lines to insure the use of enough current to pay for the construction

of the lines within five years, before the REA will make any loans. Since the REA will not lend any money to municipalities with which to build rural electric lines unless they have authority to incur debts for such purposes, the membership corporation plan offers an excellent way to get around these restrictions, Bagley pointed out.

MORE DRIVERS LOSE PERMITS

Total Revocations Under Safety Law Stands at 1,650

Reflector Bureau, Sir Walter Hotel.

Raleigh, Feb. 29.—A total of 135 automobile drivers had their driving licenses revoked during the past week, bringing the total number of drivers' licenses revoked to date to 1,650, Director Arthur Fulk of the division of highway safety of the department of revenue announced today. Most of the 135 licenses revoked this week were for drunken driving, combinations of drunken driving with reckless driving or for driving after the previous revocation of a license. The license of Paul H. McCaskill of Greensboro was revoked for an additional year following his conviction of driving after his license had been revoked.

Of the 135 drivers who lost their licenses this past week for drunken driving and variations of this offense, Charlotte led the list with 25, while Asheville had the next largest number with nine. Three were from Concord, three from Salisbury, two from Durham and one each from Gastonia, Goldsboro and Kinston. The others were scattered generally over the state.

A slight decrease in the number of convictions for drunken driving is being noticed, since not as many notices of convictions are being received as formerly, Director Fulk said. Whether this means there is less drunken driving and fewer arrests or only that fewer are being convicted, Fulk could not say. He expressed hope, however, that it indicated that there are actually less drunken drivers and that drivers are beginning to pay more attention to the highway safety laws.

"We cannot help but feel that part of the decrease in the convictions for drunken and reckless driving is due to the better enforcement of the highway safety laws by police departments and the highway patrol and especially due to excellent cooperation we have been getting from the courts and the heavier penalties being imposed," Fulk said. Raleigh, Feb. 29.—Lieutenant Governor A. H. (Sandy) Graham is expected to open up his campaign headquarters here within the next week or so, according to reliable reports heard here today. Arrangements have already been made for a suite of rooms on the tenth floor of the Sir Walter Hotel and it is expected that Graham's campaign manager, A. D. (Lon) Folger of Surry county will arrive here during the coming week to take active charge of the direction of the Graham campaign. Folger will be assisted by Ronald B. Wilson, who was assistant manager and publicity man for A. J. Maxwell in his campaign for the Democratic nomination for Governor four years ago and who was a member of the Ehringhaus headquarters staff during the second primary campaign between Ehringhaus and Fountain. Wilson will handle the campaign publicity and likewise assist Folger in getting his organization perfected.

While it is generally agreed that the selection of Folger as Graham's campaign manager has been an excellent political move in the Piedmont and western counties and will greatly strengthen Graham's support in that portion of the state, some observers here doubt if Folger

will be able to help him as much in the eastern counties as John Hinsdale could. Hinsdale was at first slated for the appointment as Graham's manager and it is generally believed that he was offered the post but finally declined it. But Wilson is generally regarded as being as familiar with conditions in the eastern counties as was Hinsdale and to have an excellent working knowledge of the entire state as a result of this experience in the primary campaign four years ago. Accordingly, the Graham supporters maintain that "Sandy" already has a managerial staff that has intimate knowledge of conditions in every section of the state.
