GERMANY GETS FINAL CHANCE ACCEPT PEACE

League Council Invites Reich to Accept Offer

LEAGUE IS ASKED CONDEMN REICH

France and Belgium Demand League To Condemn Germany as Treaty Violator

London, March 14.—(AP)—The League of Nations council formally requested by France and Belgium to condemn Germany as a treaty violator invited the Reich today to send a representative to London as a last chance to make peace with the Locarno powers.

The council, meeting in secret, invited Adolf Hitler to lay his cards on the council table after being assured by Britain in a public meeting of full cooperation for the building of a new peace structure.

France and Belgium joined in a demand at the public meeting of the council that the league condemn the Reich as a breaker of treaties for its occupation of the Rhineland, just a week ago in violation of the Locarno pact and Versailles treaty.

Anthony Eden, Britain's foreign secretary, supporting the charge that an "incontestable breach of treaties has been committed," declared it was for the council to deal with the crisis.

Asserting the peace of Europe depended on the wisdom of the court's action, Eden declared the community of nations could count on Britain's help in reestablishing peace on a firm foundation.

French sources entering into the final efforts to break the Rhineland deadlock said France was likely to abandon her idea of sanctions against Germany if she could obtain a definite military agreement with Great Britain.

FRANCE IS WILLING TO CONSIDER ALTERNATIVE PLAN

London, March 14.—(AP)—France announced tonight its willingness to consider an alternative plan whereby Germany might retain her troops in the Rhineland.

This break in the critical European situation which until now has seen France and Germany bitterly at odds over the question of German troops on the French border came after the League of Nations council had made a friendly gesture to Germany.

The council asked that Hitler send a representative to London to talk with the League representatives which decided that Germany had violated the treaty object by moving soldiers into the Rhineland.

"We do not want to stick blindly to our insistence on evacuation if we can get something better."

The spokesman's emphasis, however, that his nation was willing to parley with Germany only on the question of the Locarno treaty denunciation and that France will not discuss Hitler's peace over until the Rhineland dispute is settled.

The aspirant to the office of sheriff has been living in Greenville since 1920.

FLOOD WATERS ARE SUBSIDING

Known Toll of 24 Dead Reported in 48 Hours

(By The Associated Press)

Floodwaters of the east, menacing many communities subsided slowly today after taking a known toll of 24 lives in 48 hours.

Remaining in the path of danger were the Wyoming valley of Pennsylvania where the Susquehanna river raised, a portion of the Hudson valley in New York state, scattered parts of New England and eastern Canada.

Thirteen of the dead were lost in Canada, five of them, members of one family were swept away with their homes in Quebec last night.

Four members of a family died at Kingston, Penn., of asphyxiation, blame on the destructive action of the Susquehanna at their home where flood waters broke gas connections.

Forecast of additional rains in Pennsylvania added to the fears of the residents of the region threatened by the Susquehanna where eight power boats and 30 men of the Lake Erie coast guard district were en route to aid in rescuing the marooned.

In upper New York state a blizzard replaced floods as the chief cause of concern. Two men were killed when their car was struck by a train near Buffalo in a blinding snow storm.

Raleigh, March 14.—The North Carolina Branch of the National Vocational Guidance Association will hold its annual meeting in Raleigh in connection with the North Carolina Education Association. Dr. O. Latham Hatcher, president of Southern Woman's Educational Alliance, Richmond, Va., will present a plan of revision of the secondary school curriculum in order to provide for vocational and other types of guidance.

Professor Edward W. Bashari of State College, will lead a round table discussion following the presentation of the above topics.

No Date Set For Hearing Of Assault, Murder Case

Solicitor Clark Undecided Whether to Call Next Week

Solicitor D. M. Clark said today he had not decided whether he would call the case against Willie Tate and two other negroes on charges of murdering Alexander Miss Helen Phelps, at the spring term of Superior court convening here Monday morning.

Tate and the two other negroes, Otis Watson and George Lee, are being held in an unrevealed jail following their arrest and a confession by Tate that he participated in the crimes. He incriminated Watson and Lee, saying the former shot Warren and that he and Watson dragged the girl from the car and attempted the assault. Both Watson and Lee deny any participation in the crimes.

It was at first officially reported that Tate was taken to state's prison at Raleigh, but a check-up there revealed that the negro had not been admitted.

While Solicitor Clark said his office had not decided yet whether the trio would be tried next week, officers have indicated they would like to have it called up as soon as possible.

The confession made by Tate substantiates the account of the murder and assault told by Miss Phelps with the one exception of the number of persons involved.

Both Sheriff S. A. Whitehurst and Chief of Police George Clark have declared they place little credence in the declaration by Tate that he was aided in the crimes by Wilson and Lee. They added, however, that it was possible that the two accompanied Tate to the scene of the crimes, on a side road between the old Greenville-Farmville highway and the fair grounds, but remained in the background.

The two officers said they were fully convinced Tate was the one who fired the fatal shot.

Man Admits Killing Brother E. H. Wilson

E. H. Wilson reported today that Silas Solomon, white man of near Roxboro, had surrendered to authorities at that place and admitted that he was the hit-and-run driver who fatally injured Otho L. Wilson, brother of the local man, on the night of Monday, March 2.

Mr. Wilson said that the hit-and-run driver said that he did everything in his power to avoid striking the victim, but that he was unable to do so. He quoted Mr. Solomon as saying that he had his wife and a child with him and that they became so excited he did not know what to do, so drove on from the scene.

GOV. TALMADGE IS DEALT BLOW

Is Restrained from Withdrawing Funds from Treasury

Atlanta, March 14.—(AP)—A three judge Superior court today dealt a blow to Governor Talmadge's financial "dictatorship" by holding state funds can not be withdrawn from depositories without an appropriations bill.

The decision in which two judges concurred and one judge dissented, restrained J. B. Daniel, Talmadge-appointed de facto state treasurer, and George B. Hamilton, ousted treasurer, and the four depository banks from paying out any money except as directed by statutory appropriations. More than \$2,500,000 in state funds is involved.

Governor Talmadge has insisted that even though the general assembly of 1935 failed to pass an appropriation bill for 1936-37 he had the right to administer funds of the state.

RELIEF WORK IS DEFENDED BY NEW DEAL HEAD

Says Program Is Being Assailed For Political Reasons

FLARES AGAINST HOOVER REGIME

Declares Record of Previous Administration is Characterized by Failures

New York, March 14.—(AP)—Declaring the new deal's works relief program is being assailed "maliciously for political and selfish personal reasons," Harry L. Hopkins, entered a two-fold defense today.

The works progress chief said the program was "relieving distress and adding brick and good sound dollars to our national wealth at the same time."

In a speech delivered at a meeting of the United Neighborhood House and broadcast nationally, Hopkins flashed at the Hoover administration.

"The record of the previous administration," he said, "is characterized by failure to provide food and shelter for destitute, for decent and failure to provide work for the millions of unemployed, the failure to take any substantial steps to allay the fear and misgivings of a nation."

J. S. Moore of Bethel today announced his candidacy for the State House of Representatives.

COUNTY AGENT ADOLF HITLER CLUB SPEAKER FAILS APPEAR

E. F. Arnold Feature Speaker at Kiwanis Club Meeting

Following a brief talk on the agricultural situation and legislation to control tobacco crops, by E. F. WILL REQUEST LEAF FARMERS TO COOPERATE

Governor Will Make Radio Appeal To Growers for Help

ASKS PRESIDENT ALLOCATE FUNDS

Additional Funds are Asked as Inducement to Shift to Soil Conserving Crops

Raleigh, March 14.—(AP)—Governor Ehringhaus, who last night appealed to President Roosevelt to allocate \$50,000,000 under the new soil conservation program to tobacco areas, said today he would appeal directly to farmers for cooperation in a radio address next Monday night.

The governor in his telegram to the President asked the allotment as an inducement to tobacco grower to shift to soil conservation crops and reduce acreage in weed planting.

Growers in the flue-cured belt, the governor's telegram said "face at this moment the greatest peril in years, because of the present all time record of tobacco stock on hand which hangs over this year's prospect like a cloud."

"Not less than \$40,000,000 should be allocated to tobacco, for this is but the practical equivalent of four cents a pound on the basis of a billion pounds for all types," the governor said, "and anything less than this figure would furnish insufficient inducement for a change to soil conserving crops."

Authoritative sources indicated the government would urge an immediate voluntary sign up reduction by which farmers possibly would benefit several cents a pound for tobacco they do not plant, provided the \$50,000,000 allotted.

GOVERNOR EHRINGHAUS ASKS OTHER STATES TO JOIN

Raleigh, March 14.—(AP)—Governor J. C. B. Ehringhaus today requested governors and commissioners of agriculture of tobacco producing states to give "vigorous support" to his plea to President Roosevelt to allocate \$50,000,000 to tobacco areas under the new soil conservation program.

The governor dispatched telegrams to the officials and announced he would appeal directly to the farmers for cooperation in a radio address Monday night, which may be carried on stations in three states.

Raleigh, Asheville, and Charlotte stations will carry the address at 8 o'clock tonight for the ears of up to a million of his staunch supporters and for the signatories of the Locarno treaty.

The foreign office organ, der Deutsche Diplomatische Correspondenz, confirmed officially that the Reich already had foreseen "small and disconnected" fortifications, the newspaper announced, will be erected in the Rhineland, rearmend a week ago over the paper barrier of post-war treaties.

Hitler after a sudden and perhaps significant dash back to Germany turned toward Munich for his third, world-watched speaking appearance within a week. In that city der Fuehrer will speak at 8 o'clock tonight for the ears of up to a million of his staunch supporters and for the signatories of the Locarno treaty.

The foreign office organ, der Deutsche Diplomatische Correspondenz, confirmed officially that the Reich already had foreseen "small and disconnected" fortifications, the newspaper announced, will be erected in the Rhineland, rearmend a week ago over the paper barrier of post-war treaties.

Many believed Hitler, who first announced the new watch on the Rhine before his Reichstag last Saturday and flatly refused to withdraw troops at Garmisch Thursday night, would continue to exploit the London Locarno and League of Nations session for phibetic purposes at Munich.

CONGRESSMEN ANSWER TELEGRAMS OF GOVERNOR

Washington, March 14.—(AP)—The telegram Governor J. C. B. Ehringhaus of North Carolina sent to President Roosevelt requiring that \$50,000,000 be allocated for tobacco under the new soil conservative program drew quick response today from members of the state's congressional delegation.

While emphasizing he was not speaking for the delegation, Rep. J. Walter Lambeth of Thomasville, N. C., said in a telegram to the chief executive:

"Your suggestion has already been discussed and agreed upon in a meeting attended by our entire delegates together with speaker Byrnes and others on March 2."

Lambeth and Representative Lindsay C. Warren of Washington, N. C., said the state congressmen already had made arrangements to confer with Secretary Wallace, regarding the tobacco allocation.

It was understood Rep. Robert L. Doughton would call a meeting of the delegates next week to consider the tobacco program.

Graham Demands Session For Tobacco Legislation

Reflector Bureau, Sir Walter Hotel.

Raleigh, March 13.—The demand for a special session of the general assembly to remove the sales tax from meals and essential foods, in addition to considering tobacco crop control and social security legislation, made by Lieutenant Governor A. H. (Sandy) Graham in his first state-wide political radio speech last night has political circles buzzing here today.

For while Graham pulled a number of surprises out of his campaign hat in the course of his speech that made some of the old-time politicians sit up and gape, none proved more of a shock either to the present administration, known to be strongly in favor of the sales tax as it now stands, or to the extreme anti-sales tax forces, regarded as strong backers of Dr. Ralph W. McDonald for Governor, than Graham's inclusion of the sales tax in his special session agenda.

Several other things advocated by Graham, however, have left those who heard or who have read the speech equally surprised, according to comment heard here today.

Among these are:

1. His advocacy of a 50 per cent reduction in the cost of automobile licenses, on the grounds that whatever revenue would be lost from this cut would be more than made up by an increased consumption of gasoline.
2. The recommendation that the State Superintendent of Public Instruction be made the chairman of the State School Commission, a post which Graham now holds as Lieutenant Governor.
3. The recommendation that the State Highway Patrol be transferred back to the State Highway and Public Works Commission and thus be completely divorced from the Department of Revenue.
4. The recommendation that an increased proportion of all highway revenue be used for maintenance from now on, especially of the county roads, and that all of the present highway surplus be expended immediately on repairing and maintaining the roads.

It had been expected that Graham would strongly advocate the immediate calling of a special session of the general assembly for the purpose of enacting tobacco crop control and social security legislation, since he has been consistently pointing to the need of a special session for these two purposes for several weeks.

But when Graham included in his special session program the restoration of the sales tax exemptions on essential foods and on meals, he caused confusion in the ranks of both the McDonald followers as well as of the supporters of Clyde R. Hoey and the present administration, it is agreed here today.

The first general subject discussed by Graham was public education and the schools. He pointed out that he was in complete accord with the sentiment favoring more adequate pay for teachers and superintendents, also for the need of supplements in the larger towns and cities or wherever the people would vote them, to provide a longer term, more teachers and a greater diversion of subjects.

In his discussion of the state highway system and its roads, Graham maintained that the greatest need was more adequate maintenance, especially of the secondary and county roads and urged that a greater portion of highway revenue be devoted to maintenance from now on.

He also cited figures to show that the revenue from the gasoline tax has been steadily increasing, despite the cut made in the cost of automobile license tags by the 1935 general assembly, thus indicating that the cost of license plates can be cut at least 50 per cent without reducing the highway revenue.

With regard to the liquor situation, Graham pointed out that since prohibition is now generally conceded to have been a failure, that the next step is to try to control the bootleggers. He would do this by enacting a law establishing a State Liquor Control Commission, which would permit any counties wanting liquor stores to hold elections and determine if the people wanted them. He would have the profits from these liquor stores divided between the state, counties and towns in which the stores are located, but would leave it to the general assembly to determine the proportion going to each.

The balance of Graham's speech was devoted to the presentation of his views on social security legislation, the sales tax, tobacco control and general observations.

High Point has announced that he will not act as McDonald's manager in the kind of work, so that Dr. Burrus will be a member of the campaign advisory committee.

Since Dr. McDonald has not yet announced the members of this committee, or even admitted that such a committee is in process of being formed, it is not known yet exactly who will serve on it. The prevailing belief now, however, is that Representative Willie Lee Lumpkin of Franklin county will probably be its chairman, and that Temous T. Valentine of Nashville will be one of its members.

It is also agreed that Lumpkin and Valentine are able politicians each with a large following and with extensive knowledge of conditions in their immediate sections and that they will be able to be of a lot of help to McDonald throughout eastern Carolina. It is now conceded that Valentine, who was district manager for former Lieutenant Governor R. T. Fountain in his campaign for the nomination for Governor in 1932, had as much to do with organizing the eastern counties and carrying them for Fountain as any one else. And as campaign manager for Harold D. Cooley in his campaign for Congress against George Ross POU two years ago, Valentine is regarded as having done as fine a piece of political work as has been done in the state in many years.

Lumpkin is likewise no newcomer to North Carolina politics and at one time was regarded as a certain candidate for Lieutenant Governor. It is now reported, however, that Lumpkin has become so convinced that McDonald will be nominated and elected Governor that he decided not to run for Lieutenant Governor in order to return to the 1937 legislature and act as the McDonald floor leader in the house, or possibly be a candidate for speaker. In return for this service, it is rumored that McDonald will back Lumpkin as his successor for Governor in 1940.

PLANS SUPPLY CROP WORKERS

Service to Provide Help for Seasonable Crops

Reflector Bureau, Sir Walter Hotel.

Raleigh, March 13.—The North Carolina Employment Service of the State Department of Labor is now making its plans to supply as many workers as may be needed by the truck farmers, strawberry growers and growers of seasonal crops generally. Mrs. Thompson Evans, director of the employment service, said today.

The full cooperation of the truck farmers and berry growers will be necessary to make these plans work out, however, since they must supply the employment service with estimates of their needs and the approximate dates on which they will need this additional labor well in advance of these dates, in order to make it possible for the employment service to have the workers ready, Mrs. Evans said.

The first conference concerning

the plans and procedure to be followed was held in Wilmington on March 11 and was attended by representatives of the State Employment Service, the Works Progress Administration and the State Welfare Department. Since the WPA activities are to be curtailed materially from now on, a considerable number of WPA workers will be available for employment in handling these seasonal crops. A much larger group of unemployed in the active files of the unemployment service are available, however, so that there will not be any difficulty in finding an adequate supply of workers for the truck farms and strawberry fields, Mrs. Evans said. The employment service will make an effort to send the farmers and berry growers only those who had previous experience or stand under 5 feet, 11 they can be assured of getting only experienced labor.

Growers in the Wilmington area are urged to make an estimate of the number of workers they will need and to send these estimates to R. C. Dellinger, manager of the Wilmington office of the State Employment Service, so that their requirements may be met promptly when the time comes, Mrs. Evans said. Farm workers who are interested in this type of work but who are not yet registered with the employment service, are urged to register as soon as possible.
