## FLOOD WATERS TEAR THROUGH NEW VILLAGES

### Communities in Kentucky and Ohio are Last Menaced

### FLOOD SUBSIDING IN MOST STATES

### Central New York Only Place in East Where Waters Still Continue to Rise

(Copyright by Associated Press) Unchecked flood waters of the Ohio river tore through a score of small communities in Kentucky and Ohio today, the last menace of the 13 states disaster that took 181 lives and made thousands homeless.

In New England and Pennsylvania swollen waters gradually subsided, leaving behind a tremendous job of relief and rehabilitation.

The death list was revised downward with a recheck in Pennsylvania, the worst sufferer among the states. The death toll stood at 172. Unofficial and official estimates of the property damage mounted to more than \$500,000,000. Through-out the devastated area more than 425,000 persons were homeless.

Almost as many, including thousands of CCC and PWA workers, were engaged in rebuilding and repairing.

While Connecticut and Portsmouth, Ohio, were batten down against the eminent approach of the Ohio flood crest, Hartford, Connecticut, went under strict military discipline to prevent looting of its water-torn homes and stores.

In the east the only bodies of water still rising were the Susquehanna river in Maine and the Finger Lakes in central New York. Extensive damage was not anticipated. From Wilkes Barre, Pa., came word that the Schuylkill river was dropping rapidly. Milton and New York on the same river received needed food supplies from Philadelphia. The provisions were rationed under watchful eyes of national guardsmen.

Families in Western Ohio, as their eastern cousins had done, ran to the hills, as the flood approached. Village after village was submerged although the crest of about 57 feet was below that of the 1933 Ohio flood.

The grip of the flood eased to a greater degree in Pennsylvania where Pittsburgh, Johnstown and the other stricken communities sorrowfully buried 123 dead.

### Bishop M'Dowell To Conduct Services at Local Church

Bishop William Frazier McDowell of Washington, described as one of the most distinguished ministers of America, will conduct a preaching mission at Jarvis Memorial Methodist church beginning on Palm Sunday, April 5, and continuing through the week to Friday night, the noted minister will preach twice on Palm Sunday and at 7:30 p. m. on each of the other five nights.

In announcing the services, Dr. Gilbert R. Combs, pastor of the church, declared that "few ministers in our country have been so richly blessed in great service to the church and the cause of religion" as Bishop McDowell.

For more than 50 years Bishop McDowell has given a distinguished ministry to the continent. He has been a church executive, but his chief accomplishments came as a minister of the gospel. The Bishop is author of numerous volumes. He has perhaps delivered more university lectureships than any other man in America. Since 1910 he has delivered the Lyman Beecher lectures at Yale, the Mendhall lectures at Vanderbilt, the Merrick lectures at Ohio Wesleyan, the Earl lectures at the Pacific school of religion, the alumni lectures at the Gammon school of theology, the Wilkin lectures at the University of Illinois, and the Drew lectures at Drew university.

In spite of his extended activities as speaker at university centers, the minister has continued his regular preaching. The pastor and congregation of the Methodist church have extended an invitation for all the people of the city to hear the guest preacher.

## Group Decides On Recommendation Of Windfall Levy

### Tax Would Recapture Perhaps \$100,000,000 of Refunded or Unpaid AAA Processing Levies

Washington, March 23.—(AP)—A house ways and means subcommittee agreed today to recommend to the full committee a high "windfall" tax to recapture perhaps \$100,000,000 of refunded or unpaid AAA processing levies.

"It is safe to say we are going to recommend the windfall tax," Chairman Samuel B. Hill (D. Wash.) told reporters.

He added that the committee was working on a report now and expects to complete it Thursday or Friday to allow the full committee to start open hearings next Monday on the President's \$792,000,000 tax program.

No decision was reached as to the rate for the windfall levy, Hill said, but subcommittee members have been talking of 90 per cent with a yield of around \$100,000,000.

The subcommittee has worked out major difficulties arising over the corporate tax and is in tentative agreement on a set of rates. Members are hoping, however, to avoid processing taxes this year.

After consulting with Solicitor General Stanley Reed in a subcommittee morning session, Hill said he felt the windfall tax would be legal.

## PRESIDENT ON FISHING TRIP AFTER DELAYS

### Chief Executive Given Honorary Degree Rollins College

### BRIEF STOP-OVER MADE BY PARTY

### Major General Johnson Hagood Remains On Board Presidential Train For Talk

Rollins College, Winter Park, Fla., March 23.—(AP)—The "good neighbor" policy was credited today by President Roosevelt as developing "national understanding" among the people in contrast to individual and group domination, in an address accepting an honorary degree from Rollins College.

Arriving here early today en route to his annual fishing cruise in southern waters, the President and Mrs. Roosevelt were both awarded honors at special exercises at this college.

In accepting the honorary degree of Doctor of Literature from the college, the President also declared that growth and progress in educational policies and other spheres "invariably and inevitably are bitterly, falsely and blindly opposed."

Business and commerce forces, in which many of the new deal opponents are to be found, were declared by Mr. Roosevelt as "almost wholly made up of groups."

No where in the brief address did he mention the new deal specifically, but the tenor of his remarks was not lost on observers.

Greeted by Governor Scott of Florida, Mr. and Mrs. Roosevelt, donned the scholastic robes to participate in the chapel exercises.

Major General Johnson Hagood, disciplined eighth corps area commander, remained aboard the President's special train to talk with Mr. Roosevelt when he boards later today at Titusville.

## Political Leaders Study Effect Of Townsend Actions

Washington, March 23.—(AP)—A capital sought today to figure what effect the endorsement of Dr. F. E. Townsend, old age pension leader, would have on the Borah presidential drive.

Dr. Townsend announced his support of Senator Borah (R. Idaho) on the ground that he "has moved a great deal further toward our ideals than any other candidate in sight in either party."

This development shared interest with several others including a new onslaught on the new deal by Republican National Chairman Henry P. Fletcher. He asserted in a statement that "the Roosevelt regime had merely deepened the depression."

Meanwhile Democratic leaders, mapping the campaign to come, withheld their fire, but were expected to open up on the foe in increasing measure as the fight progressed.

Raleigh, March 23.—(AP)—The platform committee, headed by Irvin B. Tucker of Fayetteville, former United States district attorney, tonight will draft recommendations to be laid before the state republican convention here tomorrow.

Party leaders expressed belief the platform would contain a "both dry" plank again and possibly demand outright repeal or modification of the state's three per cent sales tax.

Senator Frederick Stelwer, (R. Ore.) will make the keynote speech of the state meeting. A. A. Whitener of Hickory, one time republican senatorial candidate, has been designated temporary chairman.

### News Behind The News

Washington By RAY TUCKER POLISH: "Still hard at it" is President Roosevelt's disarming reply when visitors question him about his treasury experts' burscraping economies.

What Mr. Roosevelt doesn't let out is that Henry Morgenthau's economy squad is aiming at results calculated to confound financial finger-pointers. They have sprung a novel idea which may boost actual savings to almost a billion and paper parings to twice that amount. It consists of withdrawing hundreds of millions of unimpaired capital which the treasury has turned over to permanent and emergency lending agencies.

Reason for the delay in advertising pen-and-ink and real economies lies in the fact that heads of these agencies have combined against the head saver. To hear them talk, Henry is more wicked than the thief who robs the poor box. But Mr. Morgenthau usually comes out on top in these intra-family affairs. Chances are particularly bright now because Mr. Roosevelt seeks to polish the books before November.

ACE: Mr. Roosevelt's relief message reflects the new technique liberally developed in sparring with business and industrial leaders. It carried no solar plexus blows, as did his sensational speech on the "state of the union," but it was packed with solid, inflating jobs. He disregarded the advice of conservative seconds in drafting this last call to industry for cooperation. They had urged him to ask for a moderate amount—a maximum of a billion—and to prophesy an in-

## COMPACT BILL IS CHALLENGED IN COMMITTEE

### Constitutionality of Measure Questioned by Cox

### SEES DOUBT OF BILL'S VALIDITY

### Also Declares He Does Not Believe Consent of Congress Necessary

Washington, March 23.—(AP)—Constitutionality of legislation to give congressional consent to interstate compact for tobacco growing states was questioned today at a hearing before the house agriculture committee.

Representative Cox (D. Ga.) said he was doubtful of the constitutionality of a section in the Kerr bill making it a federal offense to violate state compact provisions. The measure would provide forfeiture of tobacco shipped from non-compact states to states joining in the compact.

"I do not believe congress has the power to make penal the violation of a state law," Cox said. Representative Vinson (D. Ky.) also questioned the provision in the bill affecting interstate shipments of tobacco.

Cox said he did not believe consent of congress was necessary before state action. "State action should be independent of congress," he said.

The measure would authorize tobacco growing states to enter into compacts to regulate tobacco production.

A half million dollars in federal funds would be advanced to states for enforcement of state laws which each state would enact.

Representative Kerr (D. N. C.), author of the bill, argued, that prior consent of congress was necessary.

## MOVE SWIFTLY RESCUE PLANE

### Two Governments Make Efforts Save Coast Guard Ship

Miami, Fla., March 23.—(AP)—By air and sea two governments moved swiftly today to the rescue of five men adrift off Point Matanzas, Cuba, in the United States coast guard ambulance plane Arcurus.

As the amphibian, unable to rise from the surface because of battering waves, fought to keep clear of land, United States planes and a cutter sped to her assistance and the Cuban government mobilized shore forces.

Coast guard officers here believed the plane and those aboard were in no immediate danger as long as her motors kept the big ship in clear waters.

The coast guard vessel Nemesis put off from Key West but the 325 miles of adverse seas to be covered meant the cutter would not reach the scene before late tonight.

## Senators Decline Reconsider Action On Florida Canal

### Refuse by One Vote Marzin to Take Up Its Action in Rejecting Fletcher Request for Funds

Washington, March 23.—(AP)—By one vote the Senate refused today to reconsider its action of last Tuesday in rejecting the Fletcher proposal to provide \$2,000,000 to continue work on the Florida shipping canal.

It defeated, 36 to 35, a motion by Sen. Truman (D. Mo.) to provide another test on the army bill amendment of Senator Fletcher, (D. Fla.) providing the fund.

The amendment lost, 39 to 35, on the first vote last week after Senator Vandenberg (R-Mich.) had conducted a vigorous drive against the project as "economically unsound."

Senator Fletcher replied that failure to supply additional funds meant a slap at President Roosevelt for "making a great mistake" in tarring the project.

## LEAGUE SENDS DIRECT PLEAS

### Orders Requests Sent To Both Italy and Africa

(Copyright by Associated Press) London, March 23.—(AP)—The "committee of 13" of the league of nations council ordered a new direct plea for peace transmitted to Italy and Ethiopia today.

The committee, which comprised every member of the council except Italy, made this report toward a quick armistice in Africa while it awaited a reply from Reichsfuehrer Hitler of Germany to proposals for ending the crisis precipitated by Germany's remilitarization of the Rhineland.

Informed sources said the League expected Hitler to accept the proposals—but with strong reservations.

At the same time the council made its bid for peace in Africa, it decided to send to the Italian government a new Ethiopian protest concerning the use by Italian troops of asphyxiating gas.

At the night service it was necessary to open the adjoining school auditorium to accommodate the crowds attending, and every available seat was occupied.

I have watched the long, long trains loaded with their mutilated bodies. I have heard the raving of those that were crazed and the cries of those who wanted to die and could not. I hate war for what it forces us to do to our enemies, slaying their children with our blockades, bombing their mothers in their villages. . . . I hate war for its consequences, for the lies it lives on and propagates, for the undying hatreds it arouses, for the dictatorships it puts in the place of democracies, and for the starvation that stalks after it."

That would seem sufficient answer to such a question.

## WASHINGTON DAYBOOK

Washington, March 21.—The bill collector with the toughest job in Washington at the present, oddly enough, is no one connected with the New Deal, but is the first congressional representative of the new Philippine commonwealth.

His name is Quintin Paredes, insular secretary of justice before the Islands were voted their independence.

There's approximately \$50,000,000 involved—probably more important to Paredes and the Philippines than the \$12,000,000,000 owed this country as world war debts. Fifty million dollars would finance the Filipino government for a year and a half.

Here's what has happened: Congress in 1934, with the approval of President Roosevelt, voted \$23,862,750 credit to the Philippines as compensation for the decrease in the gold value of Filipino currency reserves in this country.

In 1935, however, both the house and senate rejected an appropriation to implement this credit.

Moreover, Senator Adams of Colorado, a Democrat and a member of the senate banking and currency committee, has moved to expunge the Filipinos' equity from the books. Adams' contention is that the claim was given insufficient consideration.

Gossip has it that the banking and currency committee will side with Adams, despite the contention of the Islands' counsel that the question rightly is under the jurisdiction of the insular government.

More than \$25,000,000 is at stake in Paredes' effort to collect proceeds of the excise tax imposed by congress in 1934 on Philippine coconut oil used in this country. The 1934 revenue act provided that proceeds should be returned to the insular government. Litigation attacking the constitutionality of the tax has tied up even payment of this.

In addition, Philippine sugar exports, which account for about 60 per cent of the insular government's revenue, were restricted by the Jones-Costigan act. Benefit payments were made to growers until the supreme court invalidated AAA. Since Philippine sugar exports have entered the United States under restrictions but with no compensation.

Paredes also has had to contend with a series of suits involving some \$4,500,000 of Philippine bank deposits in this country growing out of the preferred status given them when President Roosevelt declared his bank holiday in 1933.

Both a friend and adviser of Manuel Quezon, president of the Philippine Commonwealth, Paredes resigned as speaker of the insular house of representatives to become the Islands' first resident commissioner after independence.

How he handles the job during the 10 year transition period the Philippines must undergo before independence becomes a reality is vital to future growth of the Islands.

ILL WIND FROM VERSAILLES AT LAST BLOWS MOST GOOD

Ahrweiler, Germany (AP) — At last some good has blown from what every man calls the ill winds of the Versailles treaty.

It's the 75,000,000-mark network of railroad tunnels between Llibar and Ahr, which was started before the World war to connect the Ruhr and Alsace-Lorraine. The treaty forbade completion of the enterprise on the ground that it would be a "strategic line."

For two decades the tunnels furnished only a shortcut for pedestrians, but now they have been turned into mushroom beds, the soil in them being especially fertile. A crop of 200,000 pounds is expected this year.

LUMPKIN HEAD OF CAMPAIGN

Forsyth Legislator Named McDonald Manager

Raleigh, March 23.—Representative Willie Lee Lumpkin of Lenoir County, will be campaign manager for Dr. Ralph W. McDonald of Winston-Salem, in his race for the Democratic nomination for Governor, Dr. McDonald announced today.

Lumpkin has served four terms in the general assembly from Franklin county and in the 1935 was co-leader with McDonald of the anti-sales tax group and of the school forces in the house. He was one of the three candidates for speaker of the 1935 house and since the 1935 session has been considered a strong political candidate for the Democratic nomination for Lieutenant Governor until only recently.

Although Lumpkin has been mentioned by a few as a possible choice as McDonald's campaign manager, the prevailing opinion in most circles here recently has been that Phillip Whitley of Raleigh and Wendell, would be named as manager by McDonald. Consequently, the selection of Lumpkin came as a considerable surprise to a good many here today as a distinct disappointment to the campaign headquarters of both Clyde R. Hoey and Lieutenant Governor A. H. (Sandy) Graham, where it was being strongly hoped that Whitley would be named as McDonald's manager.

NOT TOLERATE MUD SLINGING

Hoey Headquarters Says Campaign to Be Clean One

Raleigh, March 23.—If there is going to be any mud slinging in the campaign for the Democratic nomination for Governor, it will not come from the headquarters of Clyde R. Hoey, his campaign manager, Hubert Olive of Lexington, said today.

"We are for Clyde Hoey and not against anybody," Campaign Manager Olive said. "This is a democratic primary campaign, a sort of family affair. The idea is to choose a nominee who in the November election will have the support of all the Democrats, regardless of who they supported in the campaign."

"We believe, of course, that Mr. Hoey will be that nominee. But if some other candidate should get the nomination, he, of course, will get our full support in the campaign between the primary and November election."

"Mud slingers may call themselves Democrats, but the fact remains that they are in reality the best friends the Republican party has and that every time they hurl a word of mud the Republicans applaud vigorously. They know that the more dissatisfied action a candidate can stir up among the border-line Democrats, the better the chances of the Republicans become."

New to a state-wide political campaign, Manager Olive did not have as wide an acquaintance in eastern North Carolina as did some of Mr. Hoey's other advisers. Yet in the week or so Olive has been here in charge of the Hoey headquarters, he has made a distinctly favorable impression upon those who have called at the headquarters. He has a frankness that is distinctly refreshing in a field not too crowded with those who say what they mean in words that can easily be understood.

RESTRICTIONS GO ON FISHING

Season for Warm Water Fish to Close on April 1

Raleigh, March 21.—Balmly spring days drawing sportsmen to the stream bank and lakeside will shortly bring a suspension of fishing activities for a period of approximately 40 days for most types of fish in North Carolina. J. C. Chalk, State Game and Inland Fisheries Commissioner, announced today that the closed season for warm water fish in Piedmont and Eastern North Carolina will begin April 1. In these same sections the closed season during the spawning period will continue thru May 10.

Shortly after the beginning of the spawning season for warm water fish, angling for cold water trout in the mountain section will begin. The opening date for this type of fish, the season for which has been closed for the last seven months, is set for April 15. Small-mouth bass fishing, which has been closed since last fall, starts June 10 as does the season on muskallunge. The season on large-mouth bass in Western Carolina will close with the opening of trout fishing in the same section and will extend to the opening date for small-mouth bass.

There is no closed season on angling for salt water species of fish and no regulations on the taking of these types of fish with hook and line or rod and reel in the salt waters and in adjoining the state.
