Mussolini Summons Italians to Another Adunata

DEFEATED PLAN ENTER PROTEST

Ethiopian Representative to Go Before League for "Justice Against Italy"

(By The Associate Press) Premier Mussolini summoned the people of Italy to another great "adunata" tonight — the second within the week and the second since conclusion of the Italian conquest of Ethiopia.

Well informed sources expected the Fascist Dictator to proclaim formal annexation of Emperor Haile Selassie's kingdom before the grand council and the cabinet, handing to King Victor Emmanuel the title of "Emperor."

As Italy prepared to strengthen its hold on the East African kingdom, an Ethiopian diplomatic representative prepared to go to a League of Nations council meeting for "justice against Italy."

Wolde Mariam, minister to Paris, disclosed a "new secret" capital had been set up to replace his government's former headquarters.

The minister declared the "Paris legation is receiving orders from a new capital, but declined to disclose the location of the new seat of government.

The Ethiopian emperor was reported preparing to leave his voluntary exile at Jerusalem for London.

British differences over sanctions widened as Winston Churchill, joined his support to the anti-sanctions group with the declaration of the imposition of penalties against Italy for its aggression was "judicious, if not tragic."

A mass meeting under the auspices of the League of Nations, on the other hand, approved a resolution to continue the war penalties until Italy accepts peace terms satisfactory to the league council.

Mecklenburg Man Hurt In Accident Near Here Friday

C. L. Widmer of Charlotte and Lee Lawrence, Greenville Negro, Face Charge in County

C. L. Widmer of Charlotte, said to be connected with the United States Casualty insurance company, is under bond of \$100, facing charges of being drunk on the highway and allowing his car to be operated by a person in an intoxicated condition and not having a driver's license.

Lee Lawrence, Greenville negro, is being held on a charge of driving drunk. The arrests, by the State Highway patrol force, followed a wreck between Grifton and Ayden yesterday afternoon. Both occupants of the car were injured, but not seriously. Mr. Widmer was taken to a doctor's office in Grifton, later being brought to the local hospital. He was dismissed this morning and immediately taken in custody by patrolmen.

The negro was arrested last night while he was having his wounds dressed by a local doctor.

Patrolmen said both Widmer and the negro, the latter driving, were in an intoxicated condition. They said no other car featured in the wreck, but that the automobile occupied by the two turned over three times, finally righting itself in the direction it was going before the wreck.

Lieut. Lester Jones of the highway patrol said Widmer stood to lose his license, even though he was not driving. The cases are expected to be tried in County court Tuesday morning.

Mercury Begins To Set New High Mark Records

Tornadoes, Blizzards and Heavy Rains Also Recorded

Horatio, Ark., May 9.—(AP)—A tornado struck the Dilworth and Lone Oak communities five miles east of Horatio today, killing two persons, seriously injuring another and destroying 15 farm homes. Reports also reached here that the tornado had swept through nearby Omaha, Texas, at approximately the same time, seriously injuring two persons there and causing property damage estimated at \$5,000.

Chicago, May 9.—(AP)—Tornadoes, blizzards, heavy rains and abnormal heat bottled the nation today.

Tornadoes injured five persons and wrecked a score of buildings at Hanna, Okla., late yesterday and injured four residents of Gore, Oklahoma, last night. A small twister claimed one life at Bonham, Texas. Torrential rains washed out roads in the Hanna area.

One hundred fifty travellers, marooned for nearly 24 hours by a blizzard atop Raton pass in New Mexico, were rescued or made their way to safety last night. Forty-five of them, passengers on two buses, were brought to Trinidad, Colo., and Raton, New Mexico.

Snow and rain ended a spring drought over great stretches of the western plains. The precipitation brightened crop prospects in the southwestern "dust bowl." As a consequence the wheat market dropped three cents at Chicago yesterday and five cents at Minneapolis.

From the Mississippi valley to the Atlantic seaboard a heat wave brought out straw hats. A peak of 93 was reached yesterday at Easton, Penn. Philadelphia reported 92. Chicago 86 and New York 87.1—a record for the date.

THE NATIONAL WHIRLIGIG News Behind The News

Washington By RAY TUCKER FAVORED: Democratic leaders have fixed June 6 as the day for closing the big doors on Capitol Hill. Which means that no major legislation except the tax and relief measures will be enacted before adjournment. The principal consideration behind settling on June 6 are the two national conventions. Unless Speaker Byrns and Vice President Garner bang their gavel before the political meetings open, it is figured that Congress will dwindle along until almost August 1. Most Republican members will attend the G. O. P. meet at Cleveland which opens on June 9 and most Democrats will want to show up at Philadelphia on June 23. It would be July 1 before they settled down to business again. If they don't quit early in June. From a legislative standpoint this schedule means that House and Senate bosses will sit on the lid from now on. Several unwanted measures may slip through, but enactment of the tax and relief bills almost as Mr. Roosevelt desires them is virtually assured. Time fatal (Continued on page two)

Highway Accidents Fatal To 12 In Eastern Section

Monthly Report of Division of Highway Patrol Shows Increase of One in Fatal Accidents Over Previous Month

Twelve persons were killed in highway traffic accidents in the Eastern division during April, the report of the Highway patrol for the section, issued today by Lieut. Lester Jones, revealed. The 12 deaths compare with 11 during the previous month.

Sixty persons were injured in wrecks during the month, as compared with 66 in March. There was a total of 94 accidents in the section the past month, as compared with 102 during March.

The number of arrests during April and also the number charged with driving drunk showed decreases for the past month as compared with the previous period. A total of 579 arrests were made in April, as against 664 in March. Only 99 persons were charged with driving drunk during the past month, compared with 118 in the previous period.

Sentences totaling 21 months were meted out as a result of activities of the patrol force.

Fines totaled \$5,749 and costs, \$3,386.44. The force recovered property valued at \$1,850 and collected \$15,309.87, to make a total collection during the month of \$26,295.31.

Other activities of the patrol included: vehicle inspected, 4,017; equipment tickets issued, 71; light tickets, 21; lights corrected, 2,885; warnings issued, 1,237; court-tesies extended, 616; cars recovered, five; receipts issued, 2,747; vehicles stored, 64; applicants examined for drivers' licenses, 1,638; vehicles weighed, 49; vehicles found overloaded, 26; complaints investigated, 192; fires extinguished, one; number of citations, 295 and warrants procured 386.

The entire personnel of the Eastern division traveled a total of 1,000 miles during the month, using 1,179 pints of oil and 4,536 gallons of gasoline. The force devoted a total of 14,111 hours to highway patrol work. Twenty-six days were missed by members, all due to sickness.

MAHAN ENTERS PLEA OF GUILT CUT MAJORITY OF MCDONALD

Sentenced to Terms of 60 Years Each on Two Counts Forsyth Man Continues to Hold Big Margin, However

Tacoma, Wash., May 9.—(AP)—William Mahan plead guilty today to two charges of kidnapping and conspiracy to kidnap in connection with the abduction of nine-year-old George Weverhauser, and was sentenced to 60 years on each count, the sentences to run concurrently.

Mahan's first reply "guilty" was in a low tone of voice and Federal Judge E. E. Cushman lifted his head and looked quickly at him. Mahan then repeated again in a loud tone "guilty."

The sentence was to McNeil Island penitentiary in Puget Sound near here.

Another indictment charging mail fraud was not read. Mahan declined to make any statement. He had also refused the offer by the court to appoint an attorney to represent him.

The United States Attorney General at Washington will determine later whether Mahan will remain at McNeil island or be transferred to Alcatraz or Leavenworth penitentiary.

Claims Of Publisher Challenged in Reply

Washington, May 9.—(AP)—The Black lobby committee challenged claims of William Randolph Hearst today that its scrutiny of his telegrams constituted an invasion of the freedom of the press.

Replying to the publisher's appeal to the United States Court of Appeals from the District of Columbia Supreme Court's refusal to enjoin the committee, Crampton Harris, committee counsel, said Hearst's reliance on the freedom of the press provision in the constitution was "new to our experience."

Steps Taken Toward Cut In PWA Administration

Action Taken As Result of House to Ear-mark Funds

Washington, May 9.—(AP)—First steps toward a 25 per cent cut in the PWA administrative staffs were taken by Secretary Ickes today after the house failed to earmark any of the proposed \$1,425,000,000 works relief appropriation for a new public works program.

An order directed PWA division heads, both in Washington and in the field to prepare lists of employees to be dropped and at the same time forbade any further pay increases.

Officials explained that the order, which followed victory of administration forces over a house PWA bloc and paved the way for house passage Monday.

Of the deficiency bill containing the new PWA appropriation would not be carried out immediately. The lists which are to cover employees of both PWA and the PWA housing division, also left without further funds—are to be submitted immediately, however.

Driving toward early passage of the deficiency relief measure, the administration high command yesterday accepted amendment requiring payments of prevailing wages on the new PWA program and barring aliens who entered illegally from WPA jobs.

After Monday's house vote the deficiency bill, with its relief issue, will go to the senate.

Pitt Boys Accepted As Enrolles in CCC

Announcement was made here today that 17 boys from this county have been accepted as Civilian Conservation Corps enrollees making up the full quota for Pitt at the present.

The enrollees, 12 white boys and five negroes, were accepted after an examination in Washington. No details were announced as to when they will go to camp or where they will be located.

Organized home demonstration club work in North Carolina, during the 25 years of its history, has grown into an institution with 54,310 white and negro club members in 77 counties.

Hoffman Defends Action In Hauptmann Case Probe

Newark, N. J., May 9.—(AP)—Gov. Harold G. Hoffman who is still convinced the Lindbergh baby kidnapping is unsolved, believes New Jersey prosecutors and police officials should "devote their energies" to its investigation instead of "so deeply concerning themselves with the abuse of (Paul H.) Wendell."

In two broadcast addresses the governor defended his own activities in reopening the investigation of the Lindbergh case and assumed responsibility for any acts of Ellis H. Parker, Sr., Burlington county detective, and his son, Ellis, Jr., of which he had knowledge.

Young Parker has been indicted in Brooklyn in connection with Wendell's charges he was abducted there and (returned into) falsely admitting he kidnapped the Lindbergh child. He has not been apprehended. Hoffman said that on the basis of present information he would not permit extradition of young Parker or his father should the question arise. William F. Georgian, Kings county district attorney, Brooklyn, has said Parker, senior, was "certainly one of the kidnapers" of Wendell, but no charges have been made against the detective. "I will not sacrifice the Parkers," the governor said, "to save the face of a discredited Brooklyn district attorney."

BIG ZEPPELIN ENDS JOURNEY ACROSS OCEAN

Hindenburg Finishes First Trip Over North Atlantic

SHIP MOORED AT LAKEHURST, N. J.

Record for Lighter Than Air Craft Set by Giant German Ship in Crossing Sea

(Copyright by Associated Press) Lakehurst, N. J., May 9.—(AP)—The Hindenburg, newest and largest of the Zeppelins, completed its first trip across the north Atlantic today in record time for lighter than air craft.

The giant ship was moored at the naval air base at 5:23 a. m. (EST)—8 hours and 53 minutes after it left its home port of Friedrichshafen, Germany.

Following the shipping lane across the north Atlantic, the Hindenburg did not pass over American land until it skirted Long Island, followed Ambrose Channel in New York harbor and cruised over New York city.

It was sighted over New York at 4 a. m., just as dawn was breaking. Thousands of early risers cheered.

After cruising over Manhattan for 18 minutes, the 803-foot ship circled south, directly for Lakehurst.

At 5:10 a. m. the Hindenburg for the first time touched soil in the United States—on the first of its 10 scheduled round trip commercial voyages from Germany during the summer.

The boys were quoted as saying they went to Durham after robbing a pin machine at Cox's filling station and spent the money. Chief Clark said the boys were planning to go to Norfolk, Va., on the money they stole from Bissette's. He said they already had their suitcase packed when they were arrested.

Roosevelt talks on the phone with Professor Frankfurter several times a week, and they still use and think eye to eye. Mr. Richberg is handling the problem of reemployment for the President, and the former Blue Eagle chieftain trained Secretary Roper's speech before the U. S. Chamber of Commerce. Prof. Moley is doing a tactful job as interpreter and critic of FDR's policies to business and industry.

Mr. Roosevelt feels freer to talk with professors since the G. O. P. established a "brain trust" of its own. Felix Frankfurter is being shipped into the White House unannounced for a year—and so has Prof. Moley—but their presence was boldly proclaimed on the presidential appointment list a few days ago.

It is understood that Mr. LaGuardia will support FDR in next fall's campaign. The two have cooperated closely, and they see alike in many social and economic vistas. For the President to back the Mayor in the 1937 New York campaign would be embarrassing from many angles. He could hardly afford to antagonize the regular Democratic machine, which is aching for control of City Hall.

So the way out is for Mr. LaGuardia to join the New Deal openly. The post said to be ready for him is Secretary of Labor.

BOLSTERED: The Supreme Court's record delay in rendering a decision on the Guffey Act has New York by the ears. It has completely dispelled conservative confidence that the New Deal was in for another crushing judicial wallop.

New York sharp figures that the decision may run along any one of four major lines. The act might be declared wholly constitutional or wholly unconstitutional. Or the labor provisions might be declared lawful and the price fixing provisions unlawful. Or vice versa. And there are infinite shades of variation possible within these four general outlines. One interested observer ruefully comments that with all this room for difference the nine justices are probably split seven ways.

If the government wins, some of the coal companies which favor the act will feel entitled to a share of the credit. Although not active participants in the suit, they privately claim to have bolstered the morale of the government's legal battalions with encouragement and suggestions when said legalities were about ready to concede defeat in advance. So business doesn't always work against the New Deal.

CREDIT: The Frazier-Lemke farm mortgage bill—suddenly resurrected from an apparently safe grave—is a hot potato politically and economically. New York financial and business leaders have kept the phone wires to Washington humming trying to find out what will happen to it. Even their best contacts in the capital don't pretend to know—but some of them figure it will probably work out about as follows:

Just a few months ago some time about Christmas our neighbor, Mrs. I. U. Joyner, suffered a similar loss, taking the same steps in order to arrest the thief and recover her hams. She met no better attention—she still wonders who got her meat and which way it went.

Such inefficiency and helplessness in this age of progress seems entirely out of place. Why do we not have bloodhounds? Why do we not have a system of finger-printing? Sheriff Whitehurst remarked that if the meat had been stolen by the colored folks on this farm they would not have it within their house, but would have it buried out somewhere. Such being the case, bloodhounds would unerringly find it—they have actually located beef right to the plates on a table.

Mrs. Fred Hoeger, mother and coach of the "flying fingerling," took her daughter from school to enable Mary to take two daily workouts on the springboard—one in the morning, then a rest, followed by another hour's grind in the afternoon.

Mrs. Hoeger, swimming instructor at the Miami Biltmore pools, where Mary trains, rides herd on her champion daughter's daily activities from the time Mary's small toes touch the floor until she's tucked in at an early hour in the evening.

A year older than when she won the National A. A. U. senior women's diving crown last summer, Mary is taking no chances on losing her laurels in New York in June because of under-training. Too, she trains her grey eyes on a goal only a little more distant—the select circles of American Olympic mermaids.

Likes Geography
Mary, in discussing the Olympics relegates diving to the background and frankly admits that she's mainly interested in seeing Europe, this because, her classmate explain, the champ's favorite study is geography, and she wants a first-hand view of the places she's been studying in her schoolbooks.

Mary goes to the National A. A. U. tank carnival in a slightly larger edition this year. She is nine pounds heavier and two inches taller than a year ago. Her present weight is 82, her height 59 inches.

The child diver's day leaves little opportunity for play. Her day's training begins with a brisk round of calisthenics. Her diet is strictly regulated, and is the product of Mrs. Hoeger's own culinary accomplishments. Moreover, Mary is on a tonic—or, rather, two tonics, cod liver oil and a mixture containing largely, calcium.

Mary's morning hours, until about 11 o'clock, are devoted to studies. From 11 until noon, sometimes longer, she may be observed bouncing off a springboard to convert her small body into all sorts of graceful figures as gravity yanks her into the water.

Mother Can Be Severe
Mrs. Hoeger, at times a severe critic, stands by with a steady barrage of orders, formulae designed to improve one who seems to the lay eye already to have attained perfection. Occasionally, Mrs. Hoeger always a dry-land teacher, will call Cary down from the board and over the beam to demonstrate what her words are trying to convey.

This is always an amusing sight. Mary's trim stature, her slender hips, flat chest, thick, boyish shoulders, are not inherited from the maternal side of the family. Yet Mary seems to grasp the idea. She returns to the board and makes
