FOLLOWERS OF DR. TOWNSEND EMULATE BOSS

Old Age Pension Leaders Fail to Appear at Hearing

BOTH OFFICIALS UNDER SUBPOENA

Chairman Bell Calls Representative McGroarty to Stand in Surprise Move

Washington, May 26.—(AP)—Dr. F. E. Townsend's defiant attitude toward a House investigating committee was emulated today by two of his old age pension leaders who failed to appear when they were called for questioning.

Chairman Bell (D. Mo.) called for John Kiefer of Chicago and the Rev. Clinton Wunder of New York when he opened today's hearing. Neither answered.

Bell noted for the record that both were under subpoena to appear today before the committee. The chairman then told newsmen a closed session of the committee this morning failed to change the situation in regard to action against Dr. Townsend for his walkout last Thursday and refusal to testify further.

Both Kiefer and Wunder were among those officials of the organization whom Townsend had instructed not to testify.

In a surprise move Bell then called Representative McGroarty (D. Calif.) one time leader of the House Townsend block.

Questioning of McGroarty developed that he introduced bills embodying the principles of the Townsend plan for a transaction tax to raise funds for a \$200 monthly pension to the aged.

Last Services For Drowning Victim Held From Church

Charles Martel Pierce, 16, of Falkland Drowns Near Home While Playing With Companions

Last rites for Charles Martel Pierce, 16-year-old son of Mr. and Mrs. A. S. Pierce of Falkland, who drowned in Tar river yesterday were conducted this afternoon at the Falkland Presbyterian Church. Rev. H. M. Wilson of Farmville Presbyterian Church, and Rev. C. A. Lawrence, Falkland Presbyterian minister, were in charge. Burial was in the Falkland cemetery.

Young Pierce drowned as he and several companions were playing in the river at a bridge near Falkland. He went under about two o'clock and his body was not discovered until two hours later. Artificial respiration was resorted to, but with no success.

Young Pierce graduated last week from the tenth grade of the Belvoir high school. He was a member of the Falkland Presbyterian Church. Surviving are his father and mother; a brother, Clarence Pierce; and a sister, Lillie Virginia Pierce, all of the Falkland community.

Members of the boy's high school class served as honorary pallbearers. Active pallbearers were Ralph Stokes, J. F. Parker, Jr., Carson Jones, Woodrow Wooten, Brown Mayo and Charlie Proctor.

Senate Committee Is Against Tax on Sugar

Washington, May 26.—(AP)—A Senate finance subcommittee agreed unanimously today to recommend against including a proposed tax of one half a cent a pound on sugar in the new tax bill.

Subcommittee members said too many complicating factors were involved to permit carrying the excise levy in the revenue bill even though it would raise around \$66,000,000 and raise the total estimated yield of the measure to about the \$620,000,000 of permanent funds requested by President Roosevelt.

Relief Deficiency Bill Moves Toward Enactment

Full Committee To Meet Tomorrow to Act on Measure

Washington, May 26.—(AP)—One of the vital pre-adjournment bills moved forward today when a Senate appropriation subcommittee approved the \$2,364,000,000 relief deficiency bill carrying funds for next year's work relief program.

Chairman Adams (D. Colo.) of the subcommittee, which has been studying the bill for two weeks, announced the full committee would meet to act on the measure tomorrow. Upon the expected approval it would then be ready for Senate debate Thursday.

Adams and other committee members refused, however, to discuss the contents of the bill as approved by the subcommittee except to say it contained the \$1,425,000,000 item approved by the House for the Works Progress Administration.

THE NATIONAL WHIRLIGIG News Behind The News

Washington By RAY TUCKER LUCK: Blue-eyed, blue-shirted Gerald L. K. Smith, Huey Long's picturesque successor as head of the Share-the-Wealth League, recently paid a mysterious visit to the Capitol. Mr. Smith told friends that he had two objectives. The first was to unite Townsends, Coughlins and share-the-wealthers into an independent anti-Roosevelt party. The second was to persuade Senator William Edgar Borah to run for the White House as the candidate of all these economic leftists. Reverend Smith conferred with Messrs. Borah and Townsend, but they reached no definite decisions. They agreed in principle, however. Mr. Smith dropped one secret. It was that if Senator Long had lived, he planned to merge these three groups into a third party, and his political cunning might have effected such an amalgamation. Though Mr. Smith is a vibrant, dynamic political evangelist, he lacks Huey's intuitive grasp of practical politics. More and more it appears that the death of the "King-fish" was the best break PDR has had since he entered the White House.

BLACK LEGION PROBE PUSHED

Uncover Information Band Dreamed Of Dictatorship

Detroit, May 26.—(AP)—The "war of extermination" on the Black Legion brought 25 warrants charging kidnaping and felonious assault in Jackson today against members of the secret hooded order accused of stripping and flogging a relief worker who refused to join.

Acting with speed, that of authorities of Detroit in charging 13 members with the slaying of Charles A. Poole, Prosecutor Owen Dudley of Jackson swore out warrants today against three guards to the southern Michigan prison, a resident of Norville and 21 "John Does" accused of participation in the beating last November 5 of Harley Smith, father of five children.

The men accused are Ray Ernest, said by Dudley to be a "brigadier general" in the terrorists band, his brothers Glenn and Clarence, and Allen Bascom. The Ernest brothers are guards at the prison. The men held at the state police post in Jackson for investigation in the death of Paul Avery, another prison guard, will be arraigned today, Dudley said.

Detroit, May 26.—(AP)—Definite developments were predicted today in the far-flung investigation of the Black Legion, whose skull and cross bones decorated hoods, according to one investigator, masked visions of a dictatorship.

Harry Clubb, chief investigator for Wayne County Prosecutor Duncan C. McCrea, claimed "positive information" about the dictatorship aspirations of Black Legion leaders and said important revelations might be made today.

Clubb also disclosed that seven deaths in the Detroit area in recent years, one of a radical, were being scrutinized for possible connection with alleged terrorist acts of the night riding order.

Arthur F. Lupp, described by his attorney as "Chief recruiting officer" for the Black Legion, denied however, that the society believed in taking its law into its own hands. Investigation led to other cities and to other states as did the tangles of the robbed and hooded order for which one spokesman claimed 6,000,000 men.

Reports that the federal government might enter the investigation were denied at Washington by J. Edgar Hoover head of the Federal Bureau of Investigation. He said no "federal angle" had been brought to the bureau's attention.

Arab Snipers Open Fire Into Jewish Settlement

British High Command for Palestine Warns Terrorists Nothing Will Deter Government From Fulfilling Its Obligations

Jerusalem, May 26.—(AP)—Trans-Jordan troops under British officers fought a long range rifle battle with Arab snipers today in the Esdraelon valley.

The snipers, hidden on a hill side, opened the battle by firing into a Jewish settlement.

The troops advanced against the concealed rifle men and the firing from the hillside stopped.

Previous to the fight British sources campaigning to restore order after 40 days of violence in which at least 50 persons have been killed, fought two engagements dispersing a mob of 200 Arabs in one clash, but withdrawing before an Arab advance in another.

The British high command for Palestine, Sir Arthur Grenfell Wau-

chop, in an address warned terrorists: "no strike, no violence can deter the government from fulfilling its obligations under the League of Nations' mandate."

The conflict appeared to be spreading up and down the land as fresh reports of disorders came to the British administration.

Police were forced to return from their position at the foot of Mount Tabor, east of Nazareth, when their ammunition ran out early today after a long gun battle.

Another force of British soldiers and police fought an encounter with 200 Arabs at Meskha near Nazareth.

The Arabs were repelled late last night, carrying off their wounded. The number of casualties was not determined.

Four Men Being Held On Counterfeiting Charges

Clyde R. Hoey Leader Today

Shelby Man Receives Greatest Number of Ballots Today

With but seven votes cast in The Reflector gubernatorial poll since the last published tabulation, the tables took a complete turn with Clyde R. Hoey getting three votes, Sandy Graham two and Dr. Ralph McDonald one. The seventh vote, received from Hyde county, shows all four Democratic candidates marked from the card and the name of Gilliam Grissom inserted.

Since the newspaper poll on the gubernatorial race was begun several weeks ago today marked the second time that Hoey has led in the votes received from The Reflector's five counties and the first time in which both the other major contenders scored ahead of McDonald placing him in third place in the day's voting.

Today's voting brought McDonald's total vote in the five counties to 328, Hoey's to 133, Graham to 103 while McRae remained 4. The day's voting likewise cut McDonald's previous clear majority of 92 in the five counties down to 88 a loss of four votes.

GIVES REPORT STUDENT HELP

Youth Administration Functioning Well at College

Dr. Howard J. McGinnis, in his report on the NYA work for the past year, gives abundant proof that this project is functioning well at East Carolina Teachers College. A large number of students are being given the chance to stay in college and carry on their education and do various kinds of work that will be valuable to them throughout life.

The total number of students assigned NYA work during the year is 211, with the number working at one time 187, with an average earning of \$76.25, which means that these students have been able to earn only a little less than the expenses of one term.

Many of the jobs done by the NYA are the same in their nature as those done by the 108 self-help students on the college payrolls.

As the enrollment has grown the staff of workers has not been increased, so the NYA workers have furnished the needed relief, such positions as serving in the dining hall, in the college post-office, book room and library, and infirmary.

In athletics, which has played an important part in campus life ever since the number of boys has increased, there was great need for help. NYA students help care for equipment and the athletic field, the tennis courts and assist in many details connected with committee work.

Six Men Reported Drowned in Sea As Trawler Sinks

Fourteen Members of Crew of Picador Rescued by San Salvador Following North Sea Collision

London, May 26.—(AP)—Six men were reported missing and probably drowned today after the steam trawler, Picador, sank three minutes after colliding with the tanker, San Salvador, in the North Sea.

This report, received by the owners of the San Salvador, added that the 14 other members of the Picador's crew had been rescued by the San Salvador.

Earlier it had been reported that 20 members of the Picador's crew were missing.

Greenville Bonds Sold Winston-Salem Firm

Raleigh, May 26.—(AP)—Eight securities, issues of state subdivisions, brought "very good prices" today when sold by the local government commission executive committee.

William B. Greene and Company of Winston-Salem bought \$75,000 worth of Greenville improvement bonds at par with the first \$55,000 worth of maturities to bear interest at 3-3/4 per cent and the remainder 3-1/2 per cent.

The Takoma Park bank of Takoma Park, Md., bought two Farmville issues, \$19,000 worth of water and sewer and \$100,000 of electric light system bonds with interest at 4 per cent by paying a \$27,500 premium on the small issues and 2,750 premium on the other.

LEADERS PLAN CONSULT F.D.R. ON TAX PLANS

Committee Moves To Tighten Law For Penalty on Taxes

FINAL APPROVAL EXPECTED SOON

Moves Made to Induce Large Corporations to Distribute More Earnings

Washington, May 26.—(AP)—A Democratic members arranged to consult with President Roosevelt tonight on the tax bill, the Senate finance committee today agreed definitely to tighten up provision of existing law for penalty taxes on corporations "improperly accumulating" surpluses.

The committee decided that every corporation which retains more than \$15,000 in income, or more than 40 per cent on income, whichever is greatest, shall be required to file a statement with its tax returns setting forth the reason for accumulating the funds.

It agreed to extend from three to four years the statute of limitations applicable to collection of high taxes on corporations which build up surpluses, improperly for purposes of allowing stockholders to avoid surtaxes in the upper income bracket.

Acting Chairman King (D-Tiah) said they were "more psychology than realism" and that their effect would be to make large corporations a "little more careful in withholding" and to induce them to make bigger distributions of their earnings.

Earlier the White House had indicated that the Democratic committee would confer with the President on the request of Chairman Harrison (D-Miss.)

Final approval of the tax bill was regarded as certain to be held over at least until tomorrow.

The committee expected to vote during the afternoon on whether to impose an excise tax of one-half a cent a pound on sugar and on a proposal for additional excise, some as high as 4-1/2 per cent on imported vegetable oil.

A sub-committee headed by King decided after hearing a barrage of opposition from beet sugar interests to recommend that the sugar tax be rejected.

King said he had not been advised of the White House conference tonight and did not know its purpose.

Favorable Action Is Predicted For New Coal Measure

Hill Sees Possibility of Affirmative Vote by House Ways and Means Committee

Washington, May 26.—(AP)—The possibility of favorable action by the House Ways and Means committee on the new Guffey-Vinson bill was predicted by Representative Sam Hill, (D. Wash.), after a two hour closed session on the sub-measure.

The committee member expressed this view to newsmen after representatives of the Justice Department and the bituminous coal commission had testified and were requested to appear again when the committee reconvenes later in the day.

Representative Woodruff, (R. Mich.), who opposed the original bill last year, told reporters he thought the new legislation "all-right" and said he was willing to "take a chance on it."

 "WOULD you know Fazzini from one of his brothers?" inquired Dirk. "From the chef, for instance?" "This was no chef," smiled the astute Dinwiddie.
 Dirk was silent and Logan said, "I have also the information regarding Merritt's wonder show. You asked me for it some time ago, but it took time. The show went broke, it seems, and disbanded, down in Rome, Georgia. Akin, an associate of mine in Atlanta, got the facts from the circus book-keeper before the troupe melted away. While he was not in time to find Merritt, the book-keeper told him all there was to know about Torrobin and the clown."

 "There was certainly bad luck aplenty, rainy weather not being the least of it. Then, just before the show left, both Carlo and Leonor disappeared. Nobody knew why at the time, but they realized what foresight the two had shown when Madame Chowdhury, the fortune-teller, was arrested further down the road on charges of blackmail. Carlo and Leonor were involved, and the authorities were also out for Torrobin. The four had been conducting in form of the old badger game, if understood. They are forwarding these charts to directors and engineers in the field, who are supposed to display them in public buildings and get them published in the newspapers. TRICK: Rooseveltians are growing uneasy over the antics of certain foreign governments about those two touchy problems—American participation in the League of Nations and payment of World War debts. Certain powerful factors in Great Britain and France unquestionably would welcome the defeat of President Roosevelt.
 FDR doesn't want a revival of the League issue in any form during the campaign. He was an ardent advocate of American membership when he ran for the vice presidency in 1920. He urged adherence to the World Court and for a time he was accused of playing the League's game with respect to sanctions against Italy. The G. O. P. is praying for a chance to hang

this international milestone around his neck next fall. A few more suggestions by Stanley Baldwin that the Covenant be revised to permit American adherence might do the trick.
 Privately the G. O. P. plans to attack FDR for not trying to collect war debts from a Europe anxious to win American goodwill. Anglo-French hints that they would and could pay up depict the President as missing a chance to drive a good bargain. The Republicans figure that they can pick up a few votes on these impractical but emotional issues.

Washington Daybook

 Washington—Two advance samples of what may go into the majority party keynote addresses emphasize anew the broad front of the attack and defense of the Roosevelt administration.
 Former President Hoover, in his Philadelphia speech, called the roll of New Deal developments to which he is antagonistic. It is a long roll.
 Inadvertently he left a clue to the time he had spent from his speech. He mentioned that five weeks remained before the date of the Democratic convention. Let in the text he said "in another 60 days the New Deal party will convene in this (Philadelphia) city." A slip, no doubt, but perhaps an indication he had been polishing off his phrases since April 23.

Similarly calling the roll of New Deal acts was Attorney General Homer Cummings in the keynote address before the Connecticut state convention. Down the line he went, beginning with the banking crisis encountered by President Roosevelt within 24 hours after he took office. He defended and applauded monetary revision, the CCC, the Home Owners' Loan Corporation, deposit insurance, TVA, and reciprocal trade.
 There were indications it was not merely a state convention keynote, for on the advance drafts handed out in Washington it was written that the speech was to be broadcast over a radio network. It would not take much of a network to get beyond the confines of compact Connecticut.
 Noticeable to those reading Mr.

HOOPER'S SPEECH: The instances in which he had sought to translate New Deal theories into the language of cottage economics.
 "These artificial increases in the cost of living," he said at one point, "all decrease the amount she (the housewife) can purchase and save."
 He talked of inflation paid women. He didn't overlook seasonal sports, comparing the New Deal to an effort of an umpire also trying to pitch.
 Those who know the style of oratory of Senator Barkley of Kentucky, the Democratic keynoter, would have little difficulty shaping Mr. Cummings' speech to fit the Kentuckian's mouth. Barkley has made similar speeches in the senate without the formality of a keynote invitation.
 But whether the ideas of Mr. Hoover will form much of the framework of the Republican keynote address by Senator Steiwer (it's pronounced sty-were) of Oregon is another question.

FOOLED: The Communist Party in this country has its agents busy trying to drum up sentiment for a new Farm-Labor party, although Earl Browder — its secretary — recently admitted that nothing would come of the movement this year.
 Realistic Red leaders are aware that they can't make any important headway in the United States on their own label. Moreover their traditional "boring from within" methods in organized labor unions haven't produced the results they hope for. So now their game is to collaborate with all other left wing elements — Lewisites, Progressives, Socialists, EPICs and what have you — to form a comprehensive political front.

Mr. Lewis probably thinks as little of the bill as Mr. Green does, but he sees no reason for saying so. It's just another example of the wire-crossing that results from their feud.

TICKET: The Landonites' private poll gives the Kansas Government almost 400 delegates on the first ballot, with 502 necessary to nominate.
 If these calculations are correct, it's all over but the shouting. Mr. Landon will go over on the second ballot. His friends expect him to pick up the additional 100-odd from uninstructed delegations or those now pledged to rival candidates like Senator Dickinson, Robert A. Taft or Col. Frank Knox. Lowden, whose age alone bars him from presidential consideration. Washington wiseseps predict that the ticket will be Landon and Steiwer or Landon and Wadsworth.

VOID: Harry Hopkins and Harold Ickes have now clinched in a propaganda fight over the comparative virtues of WPA and PWA expenditures. Behind the President's back both are scheming to whip Congress into allocating relief money their way.
 Mr. Ickes' publicists are distributing colored graphs designed to prove that for every man employed on the WPA, four and-a-half men are working in providing raw materials or in fabricating manufactured articles. Their slogan is that \$300,000 of PWA money furnishes \$1,000,000 worth of work.

TRICK: Rooseveltians are growing uneasy over the antics of certain foreign governments about those two touchy problems—American participation in the League of Nations and payment of World War debts. Certain powerful factors in Great Britain and France unquestionably would welcome the defeat of President Roosevelt.
 FDR doesn't want a revival of the League issue in any form during the campaign. He was an ardent advocate of American membership when he ran for the vice presidency in 1920. DR. McDONALD IS AMBITIOUS

Candidate Speaks At Raleigh Auditorium Tonight

Reflector Bureau, Sir Walter Hotel. Raleigh, May 26.—The speech which Dr. Ralph W. McDonald will make here tonight in the interest of his campaign for the Democratic nomination for Governor, is regarded as the most ambitious of his campaign, since he is going to attempt to fill the Memorial Auditorium here, which seats almost 5,000 people. 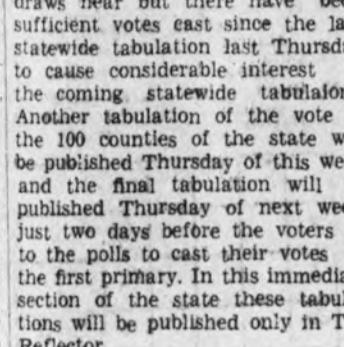

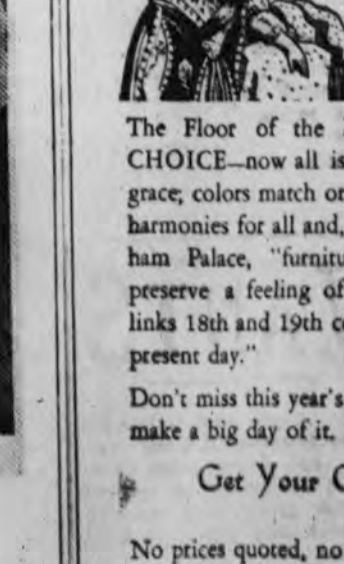
