TWO FACTIONS TIGHTEN LINES IN DEADLOCKS

Fifteen States Seek to Quell Discord Over Strikes

UNION LEADERS CLAIMING GAINS

Hundreds of Farms and Factories Affected in Strikes From Coast to Coast

(By the Associated Press) Fifteen states sought today to quell labor discord that spanned a vast swiftly-growing army of strikers.

Peace negotiations were generally deadlocked after 24 hours marked by a tightening of lines by both employers and strikers and claims of union leaders that the roll of strikers already out or called out had mounted from 30,000 to 45,000.

Hundreds of farmers and factories were affected from coast to coast.

Employers generally challenged the union claims of the effectiveness of the strikes. Settlements were reached in only isolated cases affecting a negligible number of workers.

In New York police intervened early today to prevent six striking seamen from picketing the home of Mayor F. H. LaGuardia.

This followed an unsuccessful attempt by officials of the international seaman's union and striking members of the Atlantic and Gulf district to reach an agreement in Chicago.

Insurgent leaders of the union said 7,000 seamen were participating in the strike.

Workers in six plants of Remington Rand, Inc., were ordered to strike by union leaders at Syracuse, N. Y., where 1,700 are employed normally. They said 6,000 workers in the Company's New York, Ohio and Connecticut plants were involved.

Machine Hearing To Be Held in City

Hearing of the temporary order restraining local officials from confiscating or molesting the operation of pin machines will be held in the Pitt court house here Saturday morning at 10:30 o'clock, the place having been transferred from Snow Hill upon petition of local citizens.

Judge J. Paul Frizzelle will hear the order and either make it permanent or set it aside.

The restraining order was signed in Washington by Judge Walter L. Small upon motion of owners of the machines. The move came immediately after Chief George Clark of the local police force announced that he would confiscate all of the devices found in operation in the city at the expiration of 24 hours following the announcement.

Most of the machines have been removed from the city, however, despite the order prohibiting officers from interfering with their operation.

EXPLAINS WAY RATING VOTES

Another State - Wide Straw Ballot Tabulation Tomorrow

The relative voting strength of each of the state's 100 counties is a factor which will play a prominent part in tomorrow's statewide tabulation, the fourth, in the newspaper poll on the democratic governorship race being conducted by The Daily Reflector and 24 cooperating newspapers.

In the table accompanying this article, the 100 counties and their voting strength as related to the whole state and based on the vote for governor in the first primary, 1932, are listed. The percentages are based on the primary and appear in the first column opposite the counties. The figures appearing in the second column and under the heading, "Number of Votes," are estimates of the number of votes to be cast in the first primary this year, to be held Saturday, June 6, and are based upon the percentages in the first column, after election officials and others had estimated the total vote to be cast in the first primary to be 400,000 for the state as a whole.

The figure opposite your county, then, give the relative importance of it in the voting. In tomorrow's statewide tabulation these figures will be used to "weight" the vote, so that counties returning heavy percentages of straw votes will not make the poll topheavy. By the same means, that is, relative voting strength, counties which are casting light votes in the straw voting but which in actual elections record heavy votes will not suffer by comparison with the heavy-voting counties.

PLAN TO OFFER BONDS TO CITY

Guaranty Bank Joint Purchasers With Winston Firm

William H. Woolard, vice president of the Guaranty Bank and Trust company, announced today that \$75,000 Greenville street improvement bonds would be advertised and offered to the local public within a few days.

The bonds were purchased yesterday jointly by the local bank and William B. Green and company of Winston-Salem. The securities, sold by the executive committee of the Local Government commission for the city, were sold by Mr. Woolard to "be the best sale the town ever made." W. E. Easterling, commission secretary, said he considered the prices "very good."

The bonds were sold at par with the first \$55,000 worth of maturities to bear interest at 3 3/4 per cent and the remaining \$20,000 at 3 1/2 per cent.

The money will be used in the general street paving program underway in the city.

Mr. Woolard said the bank would be prepared to quote prices on the bonds within a few days and would deliver the bonds when they were received from the city.

Mayor M. K. Blount, who was present at the sale, said he was "very pleased" with the prices the bonds brought, pointing out that it was the best price the city ever has received for securities.

Committee Discusses Suggestions of The President

MEMBERS MEET MIDDAY SESSION

Latest Suggestions Offered by Roosevelt Outlined by One Senator

Washington, May 27.—(AP)—An hour's discussion of the new tax suggestions received last night at the White House failed to produce an agreement today among Senate finance committee Democrats on any plan for revising the revenue bill.

The committee had been called to a secret mid-day caucus to consider the latest presidential tax suggestions, received in a two-hour White House conference last night.

One senatorial source outlined on the latest suggestions of the President to bring the yield of the drastically altered tax plan up to the amount the chief executive desires as follows:

A 15 per cent flat tax on all corporate income, a superstructure of graduated levies on undistributed corporate earnings and a \$15,000 exemption of all corporations from the latter.

The super taxes on undistributed profits would be 25 per cent on industrial adjusted net income not in excess of 25 per cent; 35 per cent on that in excess of 20, but not greater than 40 per cent and a 45 per cent on that in excess of 40 per cent.

Solicitor D. M. Clark, However, Claims Convicted Man "Guiltiest of Them All"

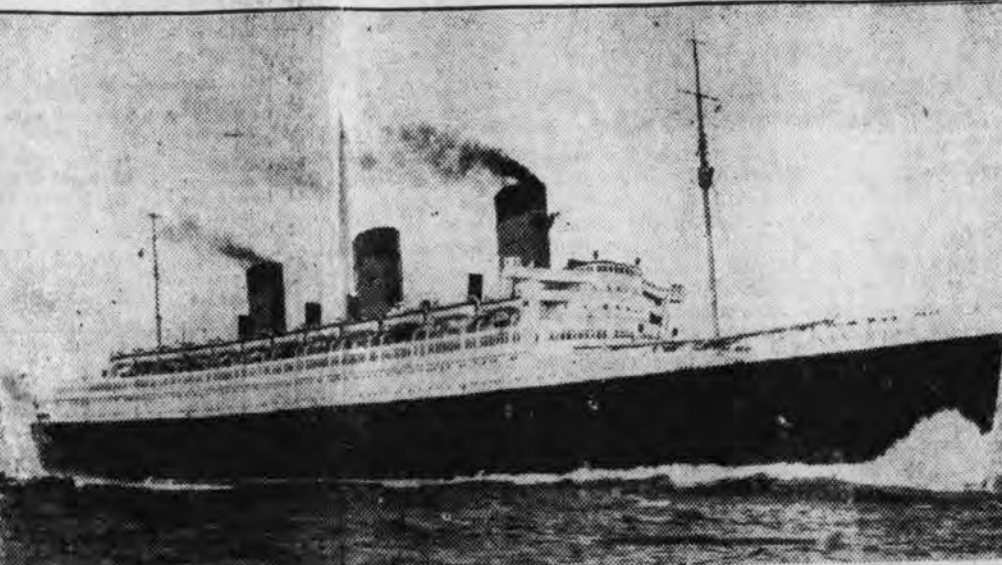

News Behind The News

Washington By RAY TUCKER WOOING: President Roosevelt intends to rely on the subtle strategy of the "White House conference" to win his way back into the hearts of liberal and conservative voters.

Few weeks ago a procession of industrialists—Messrs. Baruch, Young and Taylor—made mysterious visits to the White House. They came and went with an inscrutable smile on their lips, referring all questions of etiquette for guests to disclose such secrets. Mr. Roosevelt was even more close-mouthed, but he gave the impression that he and the "big boys" were making up again. Hence the barrage of reports that hostile interests are reconciled to Mr. Roosevelt's reelection.

Almost on the heels of these visitors there trooped into the upstairs study eight wild and woolly Progressives representing four different political parties. They spent four hours with FDR then stole away with fingers parked on their lips. They confide that they were "pledged" to say the affair had no significance, and that only "general matters" were discussed. And, strangely, that's the truth. It was a window-dressing party designed to convince radicals and liberals that FDR's heart beats for them as well as for the Wall Streeters.

ASK PLATFORM FAVOR FARMER

Farm Organization Leaders to Approach Committees

Washington, May 27.—(AP)—Farm organization leaders today predicted special attention would be given to the agricultural tariff question by platform committees of both National conventions next month.

Fred Breckenman, Washington representative of the National Grange, said his group would appear before both democratic and republican committees to protest against present handling of reciprocal trade agreements.

The Grange will urge a farm plank calling for preservation of "the American market for the American farmer," Breckenman said, and for the repeal of the "most favored nation" clause of the reciprocal trade agreement act.

However, it was indicated in some quarters that leader of the American farm Bureau Federation might support the administration policies and urge both republican and democrats to retain existing plans.

Some farm leaders said they believed the democrats would endorse the present soil conservation movement while the republicans might urge high agricultural tariffs and a purchase program to remove submarginal lands as a substitute for the AAA conservation plan.

Killers Of Women Scheduled To Die Raleigh Tomorrow

Marvin Batten of Johnston County and Henry Grier, Forsyth County Negro Face Asphyxiation

Raleigh, May 27.—(AP)—Two men, Marvin Batten of Johnston county and Henry Grier, Forsyth county negroes, are due to be executed at state's prison Friday for killing women unless Governor Ehringhaus intervenes.

Batten was sentenced to be put to death by gas for killing Lydia Daughtry. He was granted a reprieve some time ago so that alienists might examine him and though his report as to his sanity has not been revealed, it was indicated this morning chances for further clemency for him were slight.

NIGHT RIDERS FACE CHARGES

Twelve Members Of Black Legion Hailed Into Court

Detroit, May 27.—(AP)—Declaring that he had received information from 15 to 18 states regarding crimes allegedly committed by the Black Legion, Prosecutor Duncan C. McCrea appealed to Attorney General Cummings today for federal assistance in investigating the vigilantes' order.

Detroit, May 27.—(AP)—Twelve men accused of the black legion "execution" of Charles A. Poole, were brought into common pleas court today for examination on kidnaping and murder charges shortly after Representative Dickstein (D. N. Y.) demanded that congress investigate terroristic activities of the masked band.

Meanwhile Michigan declared a "war of extinction" on the hooded band and reports from other states disclosed that activities attributed to the night riders were not bounded by state lines.

Prosecutor Duncan C. McCrea, preparing to submit evidence linking the 12 legion members with the slaying of Poole, declared his intention to "stamp it out as I would a pestilence."

Already authorities were investigating the burning of Father Charles E. Coughlin's original Shrine of the Little Flower, numerous reports of floggings and at least a dozen deaths over the state for possible connection with the legion.

Sheridan Downey Refuses to Appear at Probe

ASKS COMMITTEE HASTEN ACTION

Group Accepts Statement for Consideration in Executive Session Only

Washington, May 27.—(AP)—A House investigating committee today voted 6 to 2 to recommend to the House that Dr. F. E. Townsend and two of his old age pension organization aides be cited for contempt and the case turned over to the U. S. district attorney.

The committee recommended that the Rev. Clinton Wunder of New York and J. K. Kiefer of Chicago, be cited with Dr. Townsend for their failure to appear for examination as ordered in subpoenas.

No action was taken against Sheridan Downey, attorney for Townsend, who was summoned as a witness last night and answered with a defiant letter to the committee challenging it to "punitive action."

A spokesman said it had not been decided when the contempt resolutions would be submitted to the House, but indicated it would be Friday, at the latest.

Washington, May 27.—(AP)—Challenging "punitive action," Sheridan Downey, counsel for Dr. F. E. Townsend, today advised a House investigating committee, "I shall not honor your subpoena to appear for examination."

"Like Dr. Townsend's challenge you to punitive action for the unholo records of this investigation (into the Townsend old age pension movement) is a shield that will protect us," said Downey's statement, submitted by Thomas W. Hardwick, counsel for the old age revolving pension, limited.

The committee refused Hardwick permission to read the statement, but accepted it for consideration in executive session. Downey was subpoenaed late yesterday.

"All over America hundreds of newspapers and citizens by the millions approve our conduct," Downey's statement read.

"Though they energetically oppose our economics, they enthusiastically defend our defiance of your oppressive conduct."

"So, gentlemen, proceed. Congressional inquiries are on trial. Your delay to force the issue against us weakens your prestige and increases ours. We seek the opportunity to present before the bar of congress or before an American jury our charges against you. Will you not therefore hasten your action, make good your threat and proceed against us."

Deed For Local Lot Signed In England

A deed for a house and lot on Raleigh avenue was displayed here today by L. J. Smith, real estate dealer, which was signed by officials in London and which bore documentary stamps of both England and the United States.

The deed was for a house and lot sold by the Imperial Tobacco company of Great Britain and Ireland, Limited, to C. T. Day.

The legal form was sent to England for the signatures of officials of the company. The deed bore the signature of The Right Honorable Lord Dufferin. It displayed the notary seal of Frederick John Press of Bristol, Eng., and that of John F. Claffey, vice consul of the United States at Bristol.

Another interesting feature revealed by the deed was that notaries are appointed in England for life.

The deal was consummated by C. W. Shuff, manager of the local branch of the Imperial company.

Tree Expert Advises Artificial Watering

Joseph A. Frain of Norfolk, Va., who is in Greenville in the interest of saving trees from dying because of the dry weather being experienced in this section of the country, warned today that unless proper care was taken the plants would surely die.

The expert advised citizens to water the trees daily until a hard rain falls. He added the trees between the sidewalks and streets need attention more than those on lawns, but insisted that unless all trees were watered they were sure to suffer, and probably die, from the dry weather.

Investigations Of Poisonous Deaths Started In Selma

Fourth Man Succumbs From Fumes at Virginia-Carolina Chemical Company in Johnston

Selma, May 27.—(AP)—A fourth man died today from breathing poisonous gas fumes at the Virginia-Carolina Chemical company plant here Monday as three investigations of the cause of the accident got under way.

Officials of the company came here last night and started their own inquiry. Forest H. Shuford, head of the division of inspections and standards of the state department of labor started an investigation and Coroner E. N. Booker of Johnston county said he would investigate the deaths this afternoon though he believed they resulted "purely from an industrial accident."

Lem Perry, 52-year-old Selma man formerly of Charleston, S. C., died shortly after noon at the Johnston county hospital at Smithfield. Others dead were Charles Dunham, Alfred Cooper and Julius Austin, all of Selma.

Hospital nurses said four others who breathed in the poison fumes while cleaning a vat were "doing all right."

Big Attorney Fee Is Awarded Three Tar Heel Lawyers

Counsel for Z. Smith Reynolds, Infant Son of Late Tobacco Heir, Granted More Than \$1,000,000

Winston-Salem, May 27.—(AP)—Benet Polikoff, William Graves and Dallas McClellan, attorneys for Z. Smith Reynolds, infant son of the late tobacco heir, are entitled to collect more than \$1,000,000 in fees it was decided in Superior court here today.

The fee believed here to be the largest ever collected for a single case in North Carolina, was set by Judge Wilson Warlick upon petition of the three attorneys who yesterday prayed the court to set "a reasonable sum for their services."

Judge Warlick ruled the child's lawyers were entitled to 15 per cent of the net inheritance of the infant.

Under the terms of the so-called family agreement which was reached after court fights in two states, Libby Holman's baby will receive approximately \$7,000,000 of the tobacco fortune.

Believing that the voters of this county desired and were entitled to know how the various legislative candidates stood on important questions that would likely come before the next session of the General Assembly, we took the liberty last Friday of addressing through this column an open letter to each of our candidates in which we asked that they answer questions as to their stands on certain important legislative matters.

Here are the questions we asked the candidates:

1. TAXATION AND REVENUES

(a) Do you favor repeal of the sales tax in this state if other sources of revenue can be found without returning the tax burdens to land?

(b) If elected to the legislature, do you promise to diligently seek those other sources of revenue most able to pay the tax and refuse to vote for the sales tax until and unless these sources are properly and adequately taxed according to their ability to pay?

(c) If you have previously served in either branch of the General Assembly please give brief record of your votes for or against the sales tax measures on each of the three readings.

(d) Do you favor the repeal of the present statute that gives preference to owners of stocks and bonds of foreign corporations by exempting such stocks and bonds from ad valorem taxes and limits taxation to a maximum of six per cent of the dividends, and would you vote to have these stocks and bonds taxed upon a basis of their actual worth the same as real estate and other property?

(e) If after exhausting all other sources of revenue you found it necessary to raise additional revenues by a sales tax, would you vote to remove the present \$10 limit in order that every purchase might bear its true proportionate part of such a tax? Would you also vote for the sales tax to be collected through a stamp tax or a system of fractional money in order that the present inequalities in the payment of the tax might be removed and the present high cost of collection might be eliminated?

2. SCHOOLS:

(a) Are you in favor of the highest possible standards for the public school system of this state with teachers' salaries in keeping with salaries and wages of other state and private employees who must spend an equal amount of time and money and effort to equip themselves to efficiently fill their positions?

(b) Will you vote for and work for larger appropriations for schools?

(c) Do you favor some form of civil service system for the school teachers of this state whereby their salaries might be increased from time to time, based on years of service and the attainment of certain proficiencies in their work?

(d) Do you favor making reasonable provision for sick leave for teachers?

3. SLOT MACHINES AND LEGALIZED GAMBLING:

(a) Will you sponsor, vote for and work for legislation that would bar from operation in this state any slot machine or other form of coin operated machine that does not give a fixed and the same value each and every time it is operated?

of legalized gambling in this state?

4. LIQUOR CONTROL

(a) Do you favor a return to our former status of state-wide prohibition under the Turlington Act?

(b) If you believe that legalized sale of liquor, properly controlled, is preferable to re-enactment of the prohibition law, will you vote for a state-wide control measure that would set forth a uniform system for county control in each and every county that has or later votes for legalized liquor with the revenues derived therefrom to remain the property of the counties or the counties and cities in which the stores operate?

5. ABSENTEE BALLOT AND ELECTION REFORMS:

(a) The 1935 General Assembly enacted a law prohibiting the voting of the absentee ballot in the primaries in Pitt and several other counties. Will you vote against any effort to repeal this prohibition as it pertains to our county and will you vote for a law that would prohibit absentee balloting throughout our state? If you have previously served in the General Assembly, what has been your previous stand on this question?

(b) Will you seek and support other reforms in our election laws that would tend to make our elections more honest?

6. HIGHWAY SAFETY:

(a) Do you favor strengthening the present driver's license law to the extent that persons caught driving during a period of revocation of their license would serve a mandatory jail sentence?

(b) Do you favor enlargement of the highway patrol and would you confine their duties to that of protecting life and property on our highways and carrying out the traffic laws?

The candidates have cooperated with us by answering these questions and we print them herewith in order that you might study the questions together with the answers.

In your issue of May 22 you asked certain questions of legislative candidates. As a candidate for one of the seats from Pitt County in the House of Representatives, I am glad to answer your questionnaire and make known my stand to the people, and I herewith submit my answers below:

1. TAXATION AND REVENUE

(a) Yes. (b) Yes. (c) I have never served in the General Assembly. In 1930 I was one of seven candidates for the House, and received the third highest vote which entitled me to call a second primary, which I declined to do and withdrew in order to save the County the expense of a second primary. (d) They should not be discriminated for or against. (e) In answer to the first question under (e) I would vote to remove the present \$10.00 limit. However, if North Carolina has a sales tax, and any state adjacent to North Carolina does not have a sales tax, I think that it would be necessary to have a limit, in order that the merchants near the state line might not suffer because of people going over into the adjoining state to do their buying in order to save the sales tax. If a limit is necessary, it ought to be more than \$10.00.

In answer to the second question under (e) I think that the sales tax could be better collected through a stamp tax or a system of fractional money. I believe that the tax could be collected with less expense than by the present system, and that a greater percentage of what is due the state would be collected.

I want it clearly understood that if the sales tax is retained, if I am elected, I shall strenuously insist that it be removed from the necessities of life, such as meat, bread, lard, etc.

2. SCHOOLS

(a) Yes. (b) Yes, commensurate with our ability to pay. (c) Yes. (d) Yes.

3. SLOT MACHINES AND LEGALIZED GAMBLING

(a) Yes. (b) Yes.

4. LIQUOR CONTROL

(a) Liquor is an evil that must be controlled, and experience has shown that it can be better controlled through legalized sale than under prohibition. The schools should be required to teach the evil effects of alcohol. The AEC stores are making too much profit. Control and not profit is the primary aim of legalized sale of liquor. (b) Yes.

5. ABSENTEE BALLOT AND ELECTION REFORMS

(a) Yes, the absentee ballot affords too much opportunity for corruption of the ballot. (b) Yes.

6. HIGHWAY SAFETY

(a) I favor a strict driver's license law to the end that drunken and dangerous drivers should be kept off the road. Persons caught driving during a period of revocation of their licenses should receive severe and certain punishment. It is of no use to revoke drivers' licenses unless the revocation is enforced. (b) Yes.

I have answered these questions as briefly as possible, as requested in your open letter. My answers are not merely to get votes, but in sincerity and truth.

JOHN S. MOORE Candidate, House of Representatives

In making answer to The Reflector's open letter of May 22, I wish to say that I do not consider the questions asked as being sufficiently comprehensive to give the voters of Pitt County a complete knowledge of what a candidate might or might not stand for. They are of course pertinent and vital questions, but when one goes on record as opposing such large measures as the sales tax, he ought at the same time state what he proposes to substitute for that tax. Grave dangers can lie in such substitutions. Incomes have, for instance, been mentioned. I must be frank and say that I will never vote for a heavy or unreasonable tax on the small incomes of salaried persons. I must in good conscience also go on record as saying that whatever substitutes that are offered to replace the sales tax must be fair

and square. It is an obnoxious tax and should be eliminated if it can be done wisely and fairly, but one should not leap blindly from one evil to another. If North Carolina should preserve its balance, its progress, and its integrity, its people must deal fairly with each other. I am in favor of repealing the sales tax if it can be done on these grounds. I must go one step further; I will not agree to returning the tax burden to land.

1. TAXATION AND REVENUES

(a) Yes, if it can be done as outlined above. (b) Yes. That would be the duty of every legislator. (c) I have no previous legislative record. (d) The owners of stocks and bonds of foreign corporations should be treated fairly. They should not ask or expect something that militates in their favor by discriminating against others. I am therefore in favor of according them neither more nor less than the same square treatment given the holders of other property. (e) The present \$10.00 limit ought not to be law. I would vote against it. (f) I am against a system of fractional money as I understand it. I am in favor of any law that would do away with the present gross inequalities in the sales tax.

2. SCHOOLS

(a) Yes, the best that North Carolina is able to pay for. I also look forward with interest and zeal to a new interpretation of public school functions and sensible reorganization to meet such new interpretation. The public schools like every other function of good government, must be governed by the state's ability to pay, and nothing radical should be tolerated. (b) This question merely duplicates (a). Higher standards call for larger appropriations. The public school appropriation should be larger than it is. I do not mean abnormally large. (c) Question seems vague and full of loopholes. I do not clearly understand what is meant by "the attainment of certain proficiencies" in their work. I would vote for a system whereby reasonable increments in salary would be given for experience and higher preparation. (d) Yes; reasonable sick leave should be paid for.

3. SLOT MACHINES AND LEGALIZED GAMBLING

(a) Yes. (b) I am opposed to legalized gambling in any form.

4. LIQUOR CONTROL

(a) I favor it if it could be obtained, but I see small gains for us in deceiving ourselves. I don't remember a time when whiskey was not as plentiful as spinach. Prohibition in its true and lofty conception will come when we shall have inculcated it in the minds and hearts of a new generation. I don't drink myself, and never have. I am therefore in deep sympathy with prohibition, but I do not consider that we have ever had prohibition. I must therefore say that I feel liquor control to be the wisest course of action. The whole question, however, is one that the people should decide at the polls and not in the halls of the legislature. (b) A uniform system should be set up for liquor control in every county which has it, and the money derived from liquor sales should be used by the counties.

5. ABSENTEE BALLOT AND ELECTION REFORMS

(a) I am against the corruption afforded by absentee balloting and will vote against any effort made to re-introduce it in Pitt County. (b) Yes.

6. HIGHWAY SAFETY

(a) I favor strengthening the present driver's license law, and I want the same law to be applied equally without prejudice to race or color. I would like to think further about the wisdom of the jail sentence. (b) I favor using the highway patrol for specified purposes. I favor a system that will do away with the patrol and the police and the county officers "passing the buck." I am against the use of the patrol of highway escorts for state officers and state parades.

I have endeavored to answer the above questions clearly and fairly and if any answer does not appear so, I am willing to be called on again. I do not wish to straddle any issue. I am not "burning up" to go to the legislature. I have nothing in the world to gain by it beyond the honor that it would mean to me and my family. I am simply offering my services to my people. If it appears that these services might be worthwhile to the people among whom I was born, among whom I have worked at the plow, in the schoolroom, and at the bookkeeper's desk, then I shall be happy to have an opportunity for legislative service, and I will do everything within my power to serve my county and my State faithfully and well.

Lefty Grove at 36 may not be the pitcher he was in 1931 when he turned in 31 victories while dropping only four decisions. And then again, if his present pace is a fair yardstick, he may be better. Surely his present record of seven triumphs, four shutouts included, against a lone defeat, would tend to indicate that he has found something to take the place of the blinding speed with which he used to handcut American league slug-gers.

I doubt if you could convince the present crop of sluggers who have faced Lefty that he is not the pitcher he was.

As the years pile on, especially after an athlete passes the 30-year mark, there is bound to be some loss of speed. Whether the additional experience gained is enough to compensate for the loss of strength and speed is an open question. In Lefty's case apparently it is.

When the old fireball was burning a path down the middle, Grove didn't give much thought to trying to outsmart his opponents. He didn't have to. And, too, for a strong-armed young fellow there is an extra thrill to throwing them past a batter. 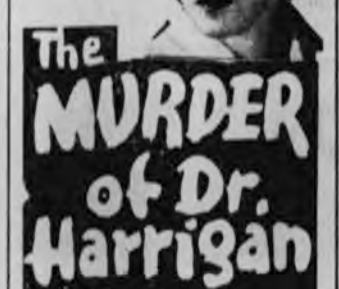

McDonald Still Conceded Leading in Many Counties

Reflector Bureau, Sir Walter Hotel. Raleigh, May 27.—While Dr. McDonald is still leading in a good many of the northeastern counties of the state, his lead is much smaller now than it was two weeks ago, while in a number of these counties either Clyde R. Hoey or Sandy Graham is now generally regarded as being in the lead, according to residents of these counties with whom this correspondent talked in a swing through about 14 counties over the week-end. There was not a county in which the writer stopped in which it was not agreed that Dr. McDonald was definitely losing votes.

Hoey and Graham were reported as making substantial gains. The biggest factor in bringing about the change of sentiment in these counties and the drift away from McDonald was said to be the growing belief that the Winston-Salem college professor could not "deceive the goods" and carry out all the promises he has made, even if he should be nominated and elected. The second biggest factor was reported as being the increased activity of the Hoey and Graham forces, who became so aroused at the McDonald lead that they have taken off their coats and gone to work, even to the extent of making a house-to-house and farm-to-farm canvass of the voters in these counties. This type of campaigning is expected to continue right up to the primary. It is generally conceded that it is getting results.

Senator Bailey Uses Mails Aid Campaign
