## Republicans Name Knox Vice President Nominee To Run With Landon

### Chicago Publisher Is Named to Post on First Ballot

### KNOX GRATEFUL FOR NOMINATION

### Plain Signs Some Chief Landon Leaders Had Been Working For Vandenberg

Convention Hall, Cleveland, June 12.—(AP)—The Republican convention nominated Colonel Frank Knox of Illinois for the vice-presidency today with the same unanimity that marked the nomination of Governor Alf M. Landon of Kansas for the presidential nominee last night.

From the start of the call of the states the delegates went for him without a solitary dissent, cheered a telegram from Landon saying the "road led to victory in November" and disbanded for the campaign already underway.

For a time a "draft Vandenberg" movement seemed in the making but the Michigan Senator in a letter read to the convention asked that his name not be considered. He said he could "serve more effectively on the floor of the Senate during the next Landon administration."

Col. Knox had left the city evidently with a landslide for him farthest from his mind. He indicated and expectation that Vandenberg would be nominated and accepted.

There were plain signs that some of the main Landon leaders were looking for Vandenberg on the ticket even after the convention met, but they finally joined the rush.

No other name was voted on.

Learning of his nomination in a Michigan city, Knox said he was "profoundly grateful."

Convention Hall, Cleveland, June 12.—(AP)—The Landon legions, who last night unanimously voted the republican presidential nomination to the governor of Kansas, seemed bent today on insisting that Senator Arthur Vandenberg of Michigan be his running mate.

Although Colonel Frank Knox had definitely been discussed because Vandenberg said he would not accept the turn to the Michigan senator was on all tongues as the convention delegates gathered for his final session. Knox left the city, apparently convinced Vandenberg would accept if drafted. Vandenberg himself would not say a word.

There was slight hope of repeating at today's session last night's contribution to political history when the Landon name was the only one even presented and on the roll call he received 984 of the 1,063 votes. The teller's announcement was drowned by the din of Landon's shouting and parading followers.

Of the 19 non-Landon votes Wisconsin cast 18 for William E. Borah of Idaho, while a single one from West Virginia's bloc also went to Borah.

Besides the vice president puzzle, another question hung fire. "What will Senator Borah do?"

Speeding to Washington after losing the presidential race, but winning recognition for his views in a compromise platform which the convention adopted with a chorus of "ayes," Borah was reported stunned on hearing that Governor Landon had wired he convention reserving the right to place his personal interpretation on two major planks.

However, other men, including Herbert Hoover and Colonel Knox, expressed much satisfaction over the Landon message.

## BUY NECKTIE FRANCE FEARS TO CELEBRATE STRIKE MOVES

### Governor Landon Assumes Fighting Position for Race

Topeka, Kas., June 12.—(AP)—Alf M. Landon picked out a new necktie, took a fighting stance and gathered up the reins of the republican party today with the avowed determination of leading his party to victory in November.

"I propose to wage the most aggressive campaign the republican party has seen in years," the Kansas governor told newsmen shortly before the Cleveland convention unanimously named him its presidential nominee.

The tumult among Topeka's 65,000 — when the phrase "Landon nominated" rippled across the wires and through the ether — was unparalleled here since the world war armistice.

In the demonstration thousands thronged their way through the downtown district and surged across the lawn of the executive mansion.

## SHARP ATTACK MADE AGAINST TAX MEASURES

### Chamber of Commerce Assails Bills Both Houses

### HOUSE PROPOSAL SPECIFICALLY HIT

### Legislative Conferees Struggle Anew To Whip Revenue in Shape

Washington, June 12.—(AP)—A sharp attack directed by the chamber of commerce of the United States today against the United States tax bills came today as conferees met again to compose differences in the two measures.

Harper Sibley, chamber president, aimed his criticism particularly against the house measure, which would provide a graduated levy up to 42 1-2 per cent against the undistributed profits of a corporation.

The chamber executive declared the senate bill which provided for a flat 7 per cent tax on such profits, was to be "preferred, although it also imposes penalties upon reasonable retention of earnings needed for business purposes."

In a letter to all members of the organizations, Sibley declared the house proposal "would obstruct industrial growth and the progress of recovery."

"Under the house bill," said an accompanying statement, "the highest rate of tax, 42 1-2 per cent, falls upon a corporation which has income of \$18,000 or more and which is so situated that it must retain 54 1-2 per cent of its earnings."

As the chamber attack came, the legislative conferees struggled anew to bridge the differences in the bills with only three days remaining before congress goes back into session.

## Great Britain And France In Accord Remove Sanctions

### Two Countries Move Toward Committee 'Sanctions Front' Expected Reach Culmination at Geneva

Paris, June 12.—(AP)—Great Britain and France moved toward a common "sanctions front" today, which, informed sources predicted, would reach its culmination at Geneva late this month.

The new socialistic administration, harassed by strikes at home, began a study of a British proposal to lift war sanctions from Italy and revamp the covenant of the League of Nations.

Some quarters declared the government was inclined to view suspension of war penalties as "the only practical course," but was anxious for British collaboration.

## Black Legion Chief Is Named In Indictment

Detroit, June 12.—(AP)—Prosecutor Duncan C. McCrea named 15 men including Arthur F. Lynn, Michigan commander of the Black Legion in asking a warrant today on charges of conspiracy to murder a suburban newspaper editor and village mayor.

### Bolivian-Argentine Line Marked

La Paz.—(AP)—A stretch of Bolivia's boundary with Argentina is being marked temporarily by a mixed commission pending ratification by the Argentine Chamber of Deputies of a border treaty negotiated in 1925. A reputedly rich deposit of tin has been shut off from development because of the uncertainty about the frontier.

TOUCHY: Before leaving for his swing around the southern circle, FDR posted himself on internal political quarrels in states he was to visit. Perhaps he had in mind the manner in which Candidate Hughes was whipsawed in California in 1916, a calamity that cost him the state and the Presidency.

## State Convention Votes To Pledge 26 Delegates To Roosevelt And Garner

### Present Administrations Upheld By J. M. Broughton

### Keynote Speaker for State Democratic Convention Submits for Approval Records of Both Roosevelt and Gov. Ehringhaus

Raleigh, June 12.—(AP)—J. M. Broughton, keynote speaker for the Democrats of North Carolina, this afternoon offered the people of the state their choice between what he called the "tragic circumstances" of the last Republican administration and the "inspired leadership" of President Roosevelt.

Addressing the state Democratic convention, in session at Memorial auditorium here, the Raleigh attorney asserted virtually the only murmurs of protest against policies of the New Deal were the "carping criticisms of the high priests of big business."

More than 3,000 delegates and spectators were here.

Confidently, Broughton submitted for approval the records of President Roosevelt and Governor Ehringhaus.

Roosevelt, he termed "the greatest friend of mankind in the world today."

Because of Ehringhaus and previous Democratic governors in North Carolina, he said, "The groundwork has been laid for the building of a civilization unsurpassed anywhere among the states of the union, and undreamed of by the founders of government in this state."

In a torrid bombardment aimed at the twelve years of "Republicanism" between Wilson and Roosevelt, the key-note pointed to the "corruption that flagrantly vaulted itself under the Harding regime."

## RECENT RAINS HELP FARMERS AT 'CHISELERS'

### Showers Have Been Worth Thousands of Dollars

Raleigh, June 12.—The recent rains which have fallen over the state have already been worth hundreds of thousands of dollars to the farmers so that they rained dollars into the farmers' pockets, according to Frank Parker, chief statistician of the State-Federal Crop Reporting Service of the State Department of Agriculture.

The fact that the rains have been more or less general has made them all the more valuable, Parker said. They have been of particular benefit to the tobacco, cotton, corn, truck, potato, fruit and hay crops.

"The fruit crops, especially the peach crop in the Sandhills section, have been especially benefited by these recent rains," Parker said.

"The apple crop in the western mountain sections of the state has also been greatly helped. The Elberta peach crop was especially in need of moisture and if the rain had not come just when it did, the early peach crop would have suffered very seriously."

The rain was also a life-saver for the tobacco and cotton farmers, many of whom had not yet been able to finish planting their crops. It also helped to save much tobacco which had been set out but which was rapidly dying for lack of moisture. The result is that the prospects for a fair tobacco crop are now much better than they were a week ago, although indications are that the crop will be much smaller than usual, probably not much more than half as large as last year's crop.

The fact that the rains were not as general through the Piedmont section as in the eastern and western portions of the state, leaves the crop outlook there still far from satisfactory, especially with regard to cotton, corn and hay crops. But in the whole, the crop outlook in the state is much better now than it was a week or ten days ago, Parker said.

## RUSSIA HAILS NEW FREEDOM

### Populace to Take Part in New Government Set-up

Moscow, June 12.—(AP)—Soviet Russia hailed today an approaching type of "advance democracy," under which her 165,000,000 people enjoying new freedom will elect part of the governing representatives by direct and secret vote.

A new constitution, drawn up for final enactment in the autumn, now only extends the rights of all citizens to freedom of speech, press, employment and religion, but guarantees protection for private property and sets up two parliament-like bodies.

One, the council of the union, will be chosen by the people themselves. The right to vote and to stand for reelection will be granted to all person over 18 years old who are not disenfranchised by the courts regardless of their sex, race, social origin, religious beliefs, previous activities or the amount of property they own.

The other supreme legislative body, the council of nationalities, will be chosen through the old indirect system of Soviets.

A board of 31 officials chosen from the two legislative bodies will wield the highest powers of government.

## McDonald Promises Fight 'Machine Rule'

Raleigh, June 12.—(AP)—Dr. Ralph W. McDonald, militant sales tax repealer, indicated in a statement here today he would make "machine rule" the foremost issue in his second primary race for governor against Clyde R. Hoy, veteran party stalwart.

McDonald said developments during the first primary placed "many of the issues" in a secondary place.

## EGYPTIAN TOMB FOUND BUILT ABOUT 3200 B. C.

Cairo, Egypt, (AP)—A new tomb with two burial chambers believed to have been constructed during the fifth Egyptian dynasty has been discovered by Selim Hassan Bey, professor of Egyptology at the University of Cairo.

Announcing his discovery the professor said one of the burial chambers contains the body of Ka Nihit, director of granaries, chief priest to the Pharaoh Sahure. The other chamber holds the body of Nihit's wife.

Sahure lived about 3200 B. C.

# YOUNG BLOOD CONTROL GOP

## Roosevelt To Have Hard Time Recognizing Foes

Cleveland—The Republican Party leaves Cleveland with its face lifted, beautified and liberalized. The 80-year-old Party will never again present quite the same political profile as a result of the youthful doctors' facial operation here. Not even President Roosevelt will recognize his 1932 victim when he goes to work on the G. O. P. two months hence.

Both platform and candidate face towards the dwellers in "Little Grey Homes in the West" rather than towards eastern temples of politics, economics and finance which Mr. Roosevelt promised to destroy four years ago. The Roosevelt influence—both T. R.'s and F. R. D.'s—stamps the reorganized and revitalized G. O. P. for good or ill, for defeat or victory, permanently or temporarily.

It is ironic that this face-changing or face-saving should occur in this Ohio metropolis, William McKinley, who was born only sixty miles from here, and Mark Hanna, who gained fame and fortune while a resident of Cleveland, would whirl in their graves if they could read the minds, much less the platform, of their political descendants. Some of the examples of whirling derbies on Cleveland sidewalks. In their opinion, the Party has grown soft and assiduous. Because of a desire to return to office, the younger faction has met the New Deal more than half way. So reasons the remnant of what was once so proudly titled the Republican Old Guard.

The nominee and platform do not reflect the shift so much as the sorry role and lonesome lives which ancient and honorable Republicans have spent here for the last week. Here was assembled the largest and most distinguished group of "politically forgotten men" any national convention has ever seen. Men who have run the Party since the turn of this turbulent century were pathetic figures. They were not even steam-rollered; they were simply ignored.

Though ex-President Hoover received a friendly welcome, neither his speech nor presence ripped the surface of convention thought or influenced the outcome. His Secretary of the Treasury, Ogden L. Mills—who dominated the 1932 assemblage—was a forlorn figure as he trooped through lobby throngs who did not step aside to cleave a path for him. Mr. Hoover's National Chairman—Walter Brown of Ohio—was toppled from his seat as National Committeeman, and southern delegations he had garnered were denied admission to the convention. George Akerson, Mr. Hoover's secretary, buttonholed old newspaper buddies to wangle a ticket to the hall.

But the up-and-coming Republicans did not limit their aloofness to relics of Hoover days. Ex-Rep. Everett Sanders, Calvin Coolidge's secretary, chummed with non-delegates for lack of other companionship. Ex-Senator "Dave" Reed of Pennsylvania, Mellon—Coolidge spokesman in the Senate, struck up friendship with hotel employees to relieve his solitude.

Charles D. Hilles, New York National Committeeman, Taft's secretary and Mr. Coolidge's favorite overnight guest, couldn't control his tongue on a suburban golf course. And erstwhile Senate leader "Jim" Watson of Indiana, whose droll tales used to delight the dour Mr. Coolidge, boldly admitted that he was "an uneducated and uninformed delegate." "Jim" never took himself or politics seriously.

Not even William Edgar Borah's close association with this convention's political godfather and with the first presidential candidate Alf Landon ever voted for—Theodore Roosevelt—saved the Senator from a gentle snubbing. Though the Party years for his endorsement—the past patting the present on the back, as it were—the youthful Lochinvars from Kansas simply flirted with him. They don't really love him. He was a "lone wolf" at Cleveland, not by his own desire, but by acclamation.

There may be a moral and prophecy in this dethronement of yesterday's bosses. The Grand Old Party may be marching forward and leftward. But the principal lesson seems to be that politics is a game of brutality and ballyhoo. The man with the toughest skin and loudest voice comes out on top. Copyright McClure Newspaper Syndicate

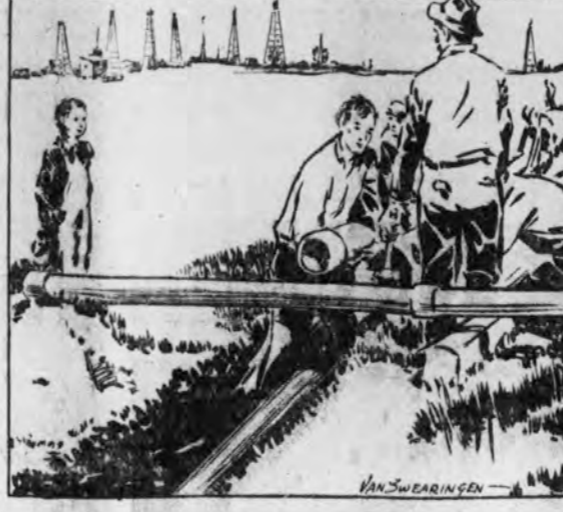

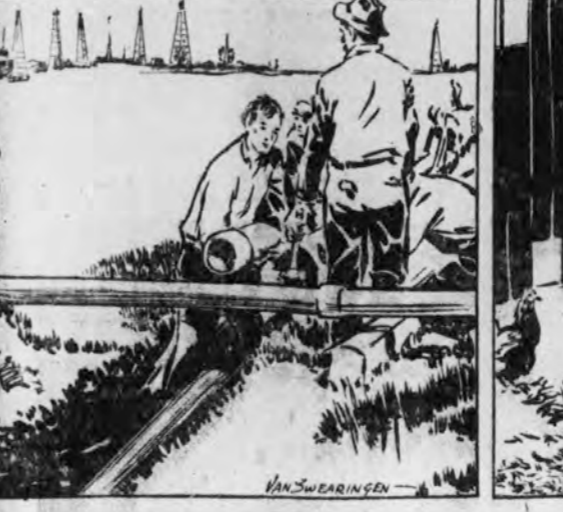

Reflector Bureau, Sir Walter Hotel, Raleigh, June 12.—The formal call issued today by Dr. Ralph W. McDonald for a second primary has not in the least disturbed the optimism and equanimity of a majority of the delegates to the State Democratic Convention in session here today. In fact, most of those who have expressed themselves here today are happy that McDonald has called for a second primary, since they feel the best thing for the Democratic party is to go ahead with the second primary so that either McDonald or Clyde Hoey may be declared the party nominee by a clear majority. The Hoey backers are convinced that he will defeat McDonald by at least 50,000 votes in the second primary, which will fall on July 4.

If McDonald had not called for a second primary and Hoey had been declared the Democratic nominee by his lead of only about 4,400 votes, McDonald would continue

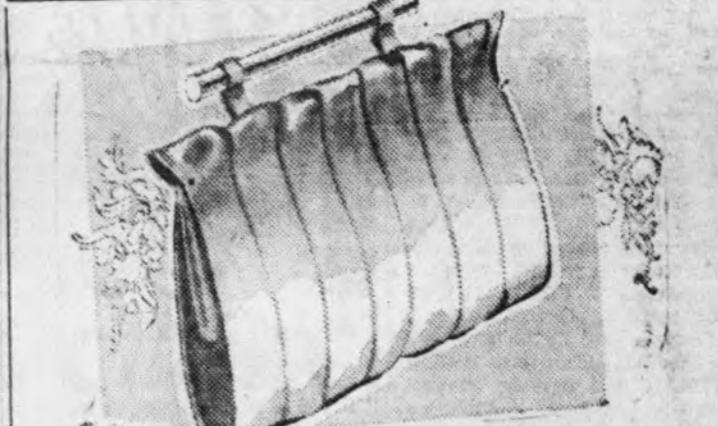

(Continued from Page One) equally touchy rivals.

**HOT:** The House, still numb because of Speaker Byrns' sudden death, did nothing upon recess adjournment except to send the tax bill to conference. Rep. Lammec (D. O.) who voted against the House bill, made a rousing talk, saying he preferred the Senate bill—and growls from several corners gave clear warning of the scrap that is to come.

Backed by the President, the House is in fighting mood on this tax question. It represents the common notion that the Senate always "perfects" House legislation. Anti-Senate feeling binds many members together. Beyond this, FDR wants a tax law that will distribute corporation surpluses with a vengeance. Having laid down this program in the form of a suggestion, he doesn't relish being beaten by a Senatorial clique. Why not utilize his big majority in the House to trounce the Senate?

A few hot days will be "enjoyed" by shirt-sleeved conferees. They've simply got to get together if there is to be a law.

**YIELD:** Some evidence of the heat engendered by the tax program was given when Senators Coughens and Keyes refused to serve as conferees. They were replaced by Hastings and Metcalf. The Senate conferees are headed by King, of Utah, a leader in putting through a bill obnoxious to FDR. With him on this stand are George, of Georgia, Connally and La Follette—a team that will prove mighty stubborn. Walsh and Barkley, remaining Senate conferees, can't move this majority.

Everybody wants to get away before the Philadelphia convention. While FDR may hold the House behind its conferees for a time, indications are that most of the yielding must be done by the House.

"Put it down that the Senate tax bill in its essentials will become law, or there will be no tax law at this time," says a Senate leader.

**PRESTIGE:** Naturally House members are speculating upon the next Speakership. A Democratic majority is fully expected, although it may be reduced. Bankhead, present Speaker, is not in good health. O'Connor of New York and Rayburn of Texas are likely to be the chief contenders, with Rankin of Mississippi a candidate.

The immense Southern strength in the House might defeat O'Connor, who "logically" would move up if Bankhead should be out of the running. O'Connor is serving for the time being as majority leader. He gained prestige during this session as chairman of the Rules Committee.

**RAILS:** Senator Wheeler gets through his resolution to continue investigation of railroad financing. The summer may develop mighty interesting items for Wall Street through this inquiry—at least Wheeler thinks so. Several other Senators disagreed with him. They insisted that everything on the subject had been thrashed out in previous investigations by the Interstate Commerce Commission, to say nothing of Jesse Jones' stock of information gathered as chairman of the RFC.

One of the benches of the smelling committee is hard at work on a program for government ownership of railroads. He believes it's coming right away—just around the corner, in fact. No sign that he's representing anybody but himself in this undertaking. Certainly the New Deal can't be charged with that particular piece of "planning."

Railroad labor maintains a regular organization to promote government ownership propaganda.

## PLAN TO BUILD COTTON ROADS

### Highway Department to Get Material by End This Week

Reflector Bureau.

Raleigh, June 11.—The first shipment of cotton fabric to be used in the construction of something like 100 miles of "cotton roads" in North Carolina should be received by the latter part of next week or the first of the next. Chief Engineer W. Vance Baise of the State Highway and Public Works Commission said today. The U. S. Department of Agriculture has already assured Baise that three-fourths of the first batch of this fabric would be allotted to North Carolina and that it was scheduled to be shipped from the mills in Georgia, where it is being woven, by not later than June 16. Accordingly, Baise thinks the first shipments should arrive here by not later than June 20.

Some of the first projects on which the cotton fabric will be used will be on Route 403 between Clinton and Faison in Sampson county, on Route 43 in Warren county, on a short strip of road here in Wake county and on projects in Gaston, Anson and Wilkes counties.

"We already have definite projects planned in several of the large cotton manufacturing counties, since we want the people in those counties to see definite examples of road construction with cotton fabric as a binder between the base and the surface treatment," Baise said. "For if the use of the cotton should be used in the future not only in this but in other states as well which will mean that its manufacture should greatly help both the cotton growers and manufacturer."

This first shipment of cotton fabric will consist of about 145,000 turers in North Carolina.

Democratic of equal rights for all and special privileges for one, we will continue to win and to lead.

"If we fall in this high endeavor, defeat will be our deserved portion."

When Roosevelt, after an overwhelming victory, took over the leadership of the United States, he continued, America needed an "inspired and courageous leadership."

"Under the blight of Hooverism and defeatism, a dark shadow hovered over the portals of virtually every American home and business and the very life of the nation itself was in jeopardy," he declared.

Not even the Republican party he said "will have the audacity to challenge the wisdom" of laws enacted by the Roosevelt administration "to drive from the temple of democracy the money changers and the exploiters of the American people."

Because of farm legislation passed under Roosevelt's administration, he said, even such rock-ribbed Republican states as Iowa—have gone overwhelmingly Democratic and will continue to do so.

Senators Josiah W. Bailey and Robert R. Reynolds and North Carolina's eleven representatives have cooperated with the New Deal and "distinguished themselves in their leadership and achievement," the keynoter said.

Endorsing Governor Ehringhaus as strongly as he had President Roosevelt, Broughton said that four years ago people of the state came in the lowest depths of a worldwide depression, to select a leader to direct the affairs of North Carolina.

"Not even the Republicans seriously suggested entrusting the administration of the state in this trying hour to any other Democratic hands."

"The task was to find a man with the strength, wisdom and courage to lead us in this great crisis. The task was solved in the

But actually, Broughton said the new deal in North Carolina has its beginning 36 years ago.

"It was then that an outraged citizenship, under the inspired leadership of the immortal Aycocch threw off the galling yoke of Republicanism and established a regime of honesty and progress under the Democratic party."
