SURVEY SHOWS SOUTH DIVIDED ON PARTY RULE

Leaders Polled On Abrogation of Two-Thirds Clause

S. C. CHAIRMAN IS FOR REGULATION

Claud Sapp Declares Measure Adopted to Protect States in Solid South

Atlanta, June 17.—(AP)—Sharp cleavages developed in the solid south today over the new proposal that the democratic party abrogate its century old two-thirds nomination rule.

A survey among party leaders showed such division of opinion that it was impossible to determine how the bulk of the sector's 270 odd delegates will vote if and when the matter comes before the Philadelphia convention next week.

None of those commenting made any direct reference to the recent claim of Senator Bennett Champ Clark of Missouri that "the administration wants the change."

Claud Sapp of Columbia, chairman of the South Carolina delegation, summed up the opposition in a sentence.

"The two-thirds rule," he said, "was adopted to protect the southern states so that as long as the solid south stood together a nominee could not be run over them by a simple majority."

He added that he did not believe South Carolina would approve a change.

Carmax Cochran, secretary of the Tennessee democratic executive committee, favored the majority rule as an aid to party harmony.

Texas, Virginia and Florida delegates were recorded against abrogation of the rule.

Arkansas and Oklahoma delegates seemed to favor the change.

Louisiana, North Carolina and Mississippi party leaders withheld specific comment.

Sheriff Finds Negro Said Fatally Beaten

Little Rock, Ark., June 17.—(AP)—Governor Futrell said today Sheriff Howard Curdin of Crittendon county had advised him he had found Frank Weems, negro share cropper reported by southern tenant farm union officials to have died last week from a beating by men who broke up a union meeting.

The governor said Curdin advised him Weems is alive and that neither he nor his wife knew anything about reports that the 40-year-old negro had been beaten fatally.

"That was a mock funeral deliberately planned by H. L. Mitchell (southern tenant farmers union secretary) and his confederates as propaganda," the governor said after a conference with Sheriff Curdin.

REVEALS COST JUNE PRIMARY

Auditor Provides Figures Showing Vote Cost \$652.61

The June Democratic primary cost Pitt county taxpayers a total of \$652.61, less the sums paid in by candidates as filing fees, County Auditor J. H. Coward announced today.

Greenville township spent the largest sum, \$203.58 having been expended in the section. Chicod township spent the next largest sum, \$102.70, the figures revealed.

The figures were tabulated from vouchers drawn on the county treasury and approved by the election board.

The cost of the election chiefly was for salaries and per diems for the various primary officials, including registrars, poll holders, members of the elections board and for necessary expenses and equipment.

The total revenue from filing fees has not been tabulated as yet, but it will fall far short of the cost of the primary, although the filing fees are provided to pay the cost of the primary.

Filing fees of the sheriff and treasurer are higher than those of any other officers. Candidates for these positions are required to put up one-half of one per cent of the office's annual salary. Other candidates were required to pay either one or three dollars.

While a second primary will be held on July 4, the cost will be nothing like as much as the first. Officials today were preparing the county ticket for the run-off primary. The ticket will bear only four names, races for county commissioner from the First and Fifth districts having been provided.

S. I. Dudley will engage Walter Cherry in a contest for commissioner from the First district and Dr. G. H. Sumrell has requested a run-off with Frank M. Kilpatrick for the post from the Fifth district.

WASHINGTON

TAXES: It is now the demitron grind between convention "debauchers." Republicans in Congress are tired but happy, Democrats are impatient—they want those chyers at Philadelphia, and they don't want to return to Washington afterward. Whether it's in the mind of the high command to shut up shop or hold Congress after the Philadelphia convention is not known. But even the high command doesn't always have its way—if it had had, Congress would have quit June 6.

Talk in Senate corridors is that members of the Democratic bloc opposing FDR on the tax bill are stiffer than ever, after the Cleveland convention. They are trying to put through a bill that will at least partly mollify the business interests of the country. Deep and drastic business taxes, they think would bring retaliation in November.

VOTES: In spite of this, word goes out that House conferees, backed by FDR, will drive through the enormous graduated tax on corporation surpluses. It's true that his reform of the tax system would go

but if the Senate draft should prevail. So it's reasoned by New Dealers that he will force the issue for the purpose of convincing the customers that he is carrying the war into Ethiopia.

Rugged old Rep. Doughton, head of the House Ways and Means, can sit like a rock in conference. He's loyal to FDR. If the White House asks him to sit pat he'll sit pat till the cows come home.

A locked conference might suit the purpose of the New Deal general staff. It will give time to round out raged legislation and put thru a few more laws calculated to win votes.

RETIRED: Borah and Hoover—twins of frustration and disappointment! Both admired for sterling qualities, and yet both rebuffed when they tested their dreams by reality. The G.O.P. suffers a handicap when it passes Hoover by and thus virtually admits that the last Republican administration was not a success. Yet the Republicans honored him and expect him to pull a heavy car in the campaign to elect the man who has superseded him. Borah was under a greater illu-

PRISON GUARD FATALLY SHOT

Virginia State Penitentiary Officials Begin Probe

Richmond, Va., June 17.—(AP)—Virginia state penitentiary officials launched a probe today into the attempt of eight long-term convicts to break out, resulting in the death of a guard and wounding of another guard and five convicts.

Powhatan D. Bass, 46, guard was seized by the convicts as a hostage in the attempted break, was killed by machine bullets fired by C. H. Smith, another guard, in halting the break.

The eight convicts seized a prison truck in the penitentiary yard, forced Bass and other guards and a trusty convict into the rear of the truck as hostages and attempted to drive their truck through the penitentiary yard gate.

Smith on duty at the gate, fired a shotgun in an attempt to halt the truck and then brought a machine gun into play. The machine gun fire killed Bass, wounded another guard and trusty and four of the convicts attempting the escape.

Arkansas Minister Urges Prosecution Alleged Attackers

Decides Against Returning to Earle, Ark., However, to Lodge Formal Complaints at This Time

Memphis, Tenn., June 17.—(AP)—The Rev. Claude Williams, Presbyterian minister from Little Rock, Ark., urged today the prosecution of six men he said flogged him and a young Memphis woman near Earle, Ark., Monday night.

The clergyman and the other asserted victim of the attack Miss Willie B'agden, decided against returning to Earle to lodge formal complaints at this time.

Mr. Williams and Miss B'agden reported they were abducted and beaten when they went to Earle to investigate the rumored slaying of a negro share-cropper in a fight growing out of a prolonged cotton workers' strike.

Counsel for the southern tenant farmers' union who is sponsoring the strike in three eastern Arkansas counties, advised the pair against returning to Earle pending a conference of attorneys Friday to decide on action.

CHANGES MADE PITT SCHOOLS

H. H. Deaton of Troy Named Principal at Belvoir

H. H. Deaton of Troy has been named principal of the Belvoir school, succeeding Newman Lewis, who has been transferred to the Bethel school. D. H. Conley, superintendent of the Pitt county school system, announced today.

Mr. Deaton, a graduate of Wake Forest college, has been engaged in the teaching profession for the past four years. Last year he was principal of the Deep Creek school near Wacesboro.

Mr. Lewis, who was principal of the Belvoir school last term, will go to Bethel to succeed D. T. House, who resigned from the position, declaring he was retiring from the teaching profession in Pitt county when he filed his candidacy for membership on the Board of Commissioners.

One other change was announced for the county school system. I. T. Lewis, who was assistant principal and athletic coach at the Farmville school last year, will assume the duties of principal at the Falkland school, succeeding H. C. Vaughan, who resigned with the expressed aim of entering high school work.

Mr. Conley said the turnover in teachers in the county would be very small, adding most of the vacancies already had been filled. He said he had interviewed numerous applicants, but had found places for only a few.

MORE PERSONS DIE IN WRECKS DURING MONTH

Record Number Auto Fatalities for Month of May

530 ACCIDENTS DURING PERIOD

Heavy Toll Announced for Past Month Brings Road Deaths to 367 For Year

Raleigh, June 17.—(AP)—Auto accidents in North Carolina killed more people last month than ever before in May with a death list of 52.

The heavy May toll announced today by the motor vehicle bureau, followed an April high record this year of 83 and brought to 367 the number of automobile fatalities in 1936 compared with 397 in the similar period of 1935.

Last month there were 530 accidents in which 807 drivers were involved and 639 persons were injured. In May 1935 there were 75 killed and 495 injured in 377 accidents.

DAVIS KNOCKS PROPOSALS OF REPUBLICANS

Retiring Farm Administrator Attacks GOP Farm Planks

TWO POLICIES SINGLED OUT

Speaker Says Plans Would Throttle International Trade of U. S. and World

Memphis, Tenn., June 17.—(AP)—Chester Davis, retiring farm administrator, attacked today two proposals in the farm planks of the Republican platform. If enacted, he said, these two policies relating to farm imports and surpluses would "throttle international trade between the United States and the rest of the world."

Addressing himself to cotton interests of the south in a speech before the Chamber of Commerce, Davis called attention to a platform pledge "to protect the American farmer against the importation of all livestock and agricultural products... which will depress American farm prices."

"Now you know and I know," he said, "that competitive agricultural products can come into this country only if domestic prices are higher than world prices by more than the amount of existing tariff."

"That isn't the trouble," Davis continued, "the real menace to our international trade, our cotton and other exports is concealed behind policies advocated ostensibly for agriculture..."

The second policy, Davis said again, quoting from the farm plank would put the government in the business of "disposing of surpluses by bargaining for foreign markets selectively by countries, both as to exports and imports."

"That is copying the disastrous European nationalism at its worst," Davis continued, "it will work out in America as it has done in Europe in two channels, both of them bad. These plans for selected and restricted trading are a dangerous importation of European plans of which the nations of Europe are already becoming thoroughly sick."

# GOP REINS IN FOR BIG RACE

## Anxiety To Defeat Roosevelt Unquenchably Bitter

Cleveland, June 16.—The anxiety to defeat Roosevelt and dust the New Deal from Washington has become so unquenchably bitter among Republicans that it worries Alf Landon's advisers as they prepare to head into what they call the "crisis of America."

Preventing it from assuming extreme and self-destructive shape in the form of speeches and campaign literature will be one of Nominee Landon's first responsibilities. Personal hatred of the President, though based largely on his White House policies and behavior, stamps the seemingly revitalized G. O. P. Humble individuals and high-hatted politicians who swung behind him for the first year now refer to him in scathing tones. The convention speeches and platform are only mild examples of what privates in the ranks say and think. The motto is "Anything to lick FDR!"

This backstage bitterness explains why Easterners bowed so cavalierly to planks which must shock the shades of Hanna and McKinley, as they do, deep down, certain convictions of Messrs. Hillis, Mills and Bingham. It bears the handiwork of the arch-destroyer — Borah — more definitely than the traditional touch of veteran architects.

On money, monopoly, relief and farm benefits it upholds beliefs once branded as heretical by the conservative crowd. Nevertheless, the budget-balancers, apostles of gold and high-tariffites will cherish it as a politically priceless document, provided it attracts sufficient customers to blast FDR out of the White House. A common prejudice toward "experimentation" and "regimentation" unites eastern and western G. O. P.-ers.

The supposed threat a re-elected Roosevelt holds for the Supreme Court ranks second in the G. O. P.-ers' list of his major offenses. Great eastern interests shudder lest he remake the high tribunal so that it would look more lovingly on his philosophy of federal regulation of pigs, profits and prices. From now until November four Republican spellbinders will repeat Herbert Hoover's question as to the kind of men Mr. Roosevelt will name if reelection furnishes him that opportunity.

The third ingredient in this pent-up prejudice against the President is the party workers' hunger for jobs. The 1001 delegates at Cleveland included many men who were tossed out of postmasterhips, deputy marshalships and collectorships when Jim Farley swung the axe. They don't like Mr. Farley very much, either. Victory for their side will insure a return to office. The same yearning light shone in the eyes of party bigwigs; they hope for cabinet and diplomatic appointments.

Their ache could almost be felt whenever the crowd at Cleveland chanted Senator Steiwer's lugubrious line—"After three long years!" It's a longing which, like love, no politician can conceal. Now, every party suffers from these pangs when on the outside looking in. They conceive the leader of the opposition to be a wretcher for keeping them from the promised political land. The Democrats felt the same twinges during the "twelve long years" from 1921 to 1932. But the Republicans' reaction to FDR seems more hostile, more solid, more personal.

These G. O. P.-ers don't appreciate his smile and "radio crooning" (their description) any more than they do his ideas of government. They subscribe wholeheartedly to the Hoover-Steiwer-Snell-Hamilton indictment of him as a "dictator" who would plow under "American institutions" and sow a hybrid crop of "European collectivism." They discern no charm in his personality and predict that next January will see the White House occupied by a "cornhusker instead of a charmer and a crooner." They'll ring the charges on that expression unless the Landonites decide that it is a bit too disrespectful to the Chief Executive.

These prejudices, as smart political managers realize, can be capitalized on behalf of the Republican cause. But smart Landonites also recognize that they can be advertised and displayed to best advantage too flamboyantly. There might be a wicked rebound that would hit somebody in the face.

Mr. Landon's task—or somebody's—will be to temper and train those forces so that they won't place the ticket in a selfish, reactionary light. His advisers don't want him left open to the Michelsonia charge that he is willing to win at any cost and on any issue.

Though certain minor speakers will be told off to roughhouse the administration, higher spokesmen cannot call hard names or engage in rowdy presidential fistfights. And Mr. Landon knows that his campaign will be weakened if his party seems motivated by an appetite rather than inspired by ideals.

The boys from Kansas—no foolin'—really believe that the right kind of battle will tumble the New Dealers down the hill and out of office. So they don't want their opportunity spotted by blabbing belligerent "boneheads"—of which every party has more than its share.

The Republican boys and girls are fighting mad—but the new, shrewd strategists don't want them to get so mad that they'll lose their heads or lead too much with their chins.

### HOOVER NEARS END OF TRAIL

#### Last-Minute Efforts Failed Materialize at Cleveland

Cleveland — The last-minute hotel room movement to slip Herbert Hoover another chance at the White House threw a scare into Alf Landon's backers for a few hours. Behind the delegates' high-pitched cries of "Who but Hoover?" there was some wishful thinking and plotting by his erstwhile associates at Washington.

The Kansas crowd patting themselves on the back for the solid groundwork they had laid in conferences during the past week had they not puffed all holes. As Hoover might have commanded the convention's vote instead of its momentary enthusiasm.

The former President did not lift a noticable finger to forward any secret ambitions he may nurse. He came and spoke and left, he was politically polite to his rivals.

But former cabinet members and friends who huddled with him came away with the conviction that he would have liked to shift his household goods from Palo Alto to Washington next January. He was anxiously delighted with another puff of popular acclaim. His face beamed and he shot his arm heavenward to vigorously that his cuffs showed.

But the answer to whatever hope he entertains is that the delegates like him — especially the women — and the politicians don't. Even as feminine faces shone and tiny men's handkerchiefs waved before his eyes, national committee members on the platform grumbled: "I could not carry a county in my state for him."

The ladies gave way to their maternal instincts; they don't think contemporary historians and hard-boiled politicians have done right by him. But G. O. P. machinists calmly weighed their chance of winning the White House with him as the nominee.

Ironically, they concede privately that he has delivered the most intelligent attack on the New Deal, and they consider his address here the best of the lot. But they want to win — after three long years.

it spurns the one man whose name and fame and previous condition of presidential servitude qualify him prominently. But with the smell of victory in their nostrils, party leaders realize that other people have bitter memories, too.

There was a pathetic touch in the rush of his old comrades to rally around "the Chief." Half his cabinet named themselves as his unofficial escort. They hustled him from the headquarters of one delegation to another. They brought up humble political privates to shake Mr. Hoover's hand. They beamed and nodded at every hand-clap and squeezed the last drop of comfort out of every cheer. Ignored by convention bosses, they dwelt for a day in the shadow of the headlines.

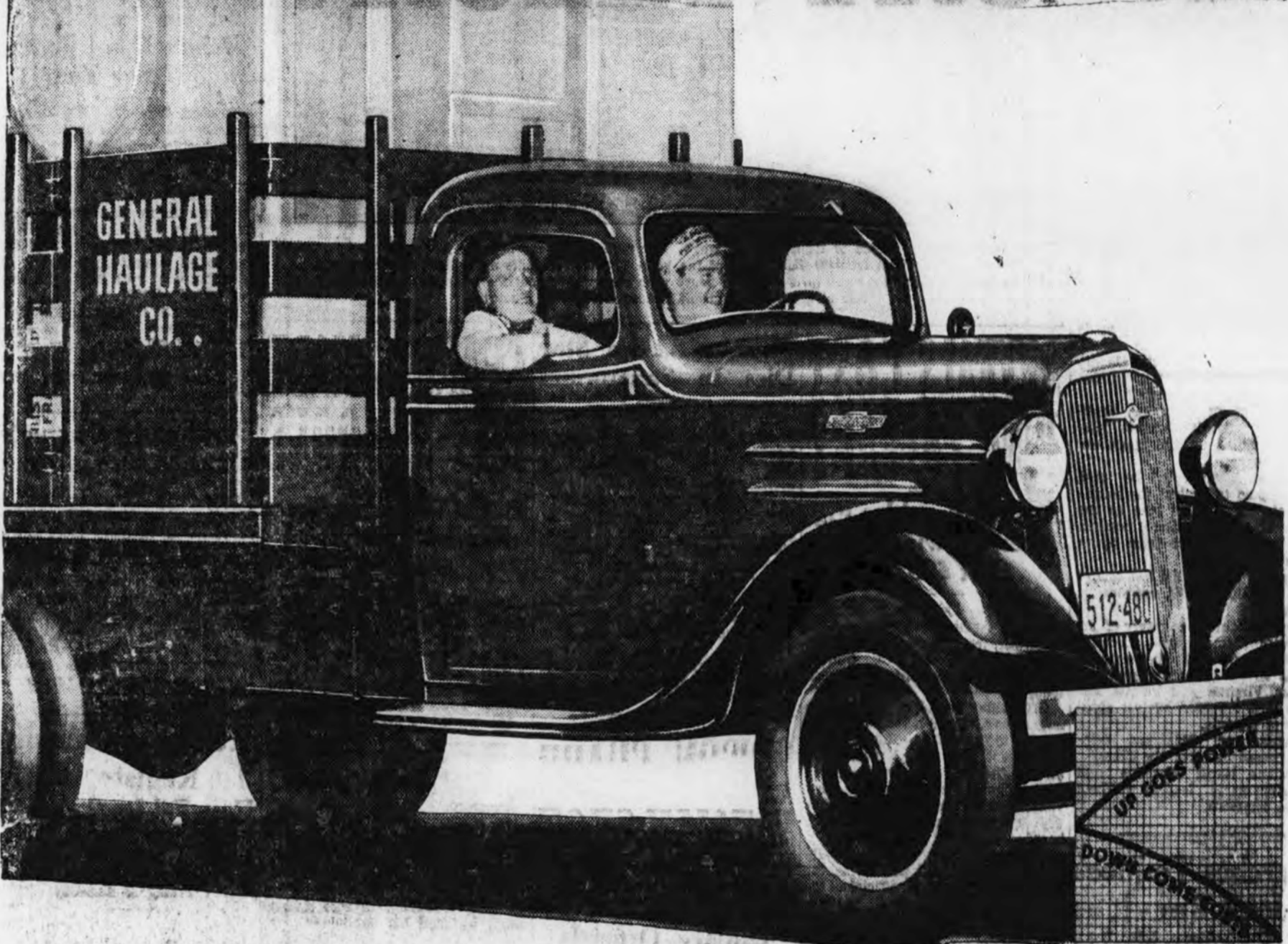
For all his appreciation of his reception, Mr. Hoover may now supplant William Edgar Borah as the G. O. P.'s problem child. The Landonites first antagonized the ex-President though he did not show it here when they allowed publicity to Hears to enter a ticket in the California primary against Mr. Hoover's delegates. Now they are making platform gestures to Mr. Borah. They are exhibiting keener concern over the Senator's campaign conduct than they are over the attitude of the titular leader. And some of the Borah-bait planks do not square at all with the broad principles which Mr. Hoover maintained here. These incidents are important, because Messrs. Borah and Hears rank as number 1 and number 2 on the former President's list of political enemies.

Oddly, the inside story of the nomination campaign is that Mr. Borah asked whatever chance Mr. Hoover had to square his as a surprise nominee. The Senator did it unknowingly, but he could not have anticipated his old foe more effectively if he had done it with more forethought. Political manipulators who put these things in ex-laris states told the story, now that it is too late to spoil their strategy.

The Landon planks for Landon early in the game for only one reason — Borah. They feared he might enter their primaries, carry them and take it on with their party machine. They also detest his views on money — as does Mr. Hoover. By declaring for the Kansan so far in advance, they promoted his stock above par, doomed the "Stop Landon" movement and spelled any chance of a deadlock that might have been broken by the Californian's nomination.

Now the G. O. P.'s major problem is to conciliate both men. This is also the most human and picturesque story of the convention. The saviour of Belgium and the destroyer of the League of Nations seem to have come to the end of the trail. But each may have the power to ruin the trail for anybody else.

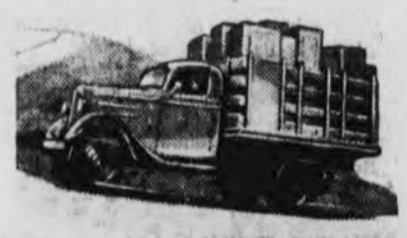

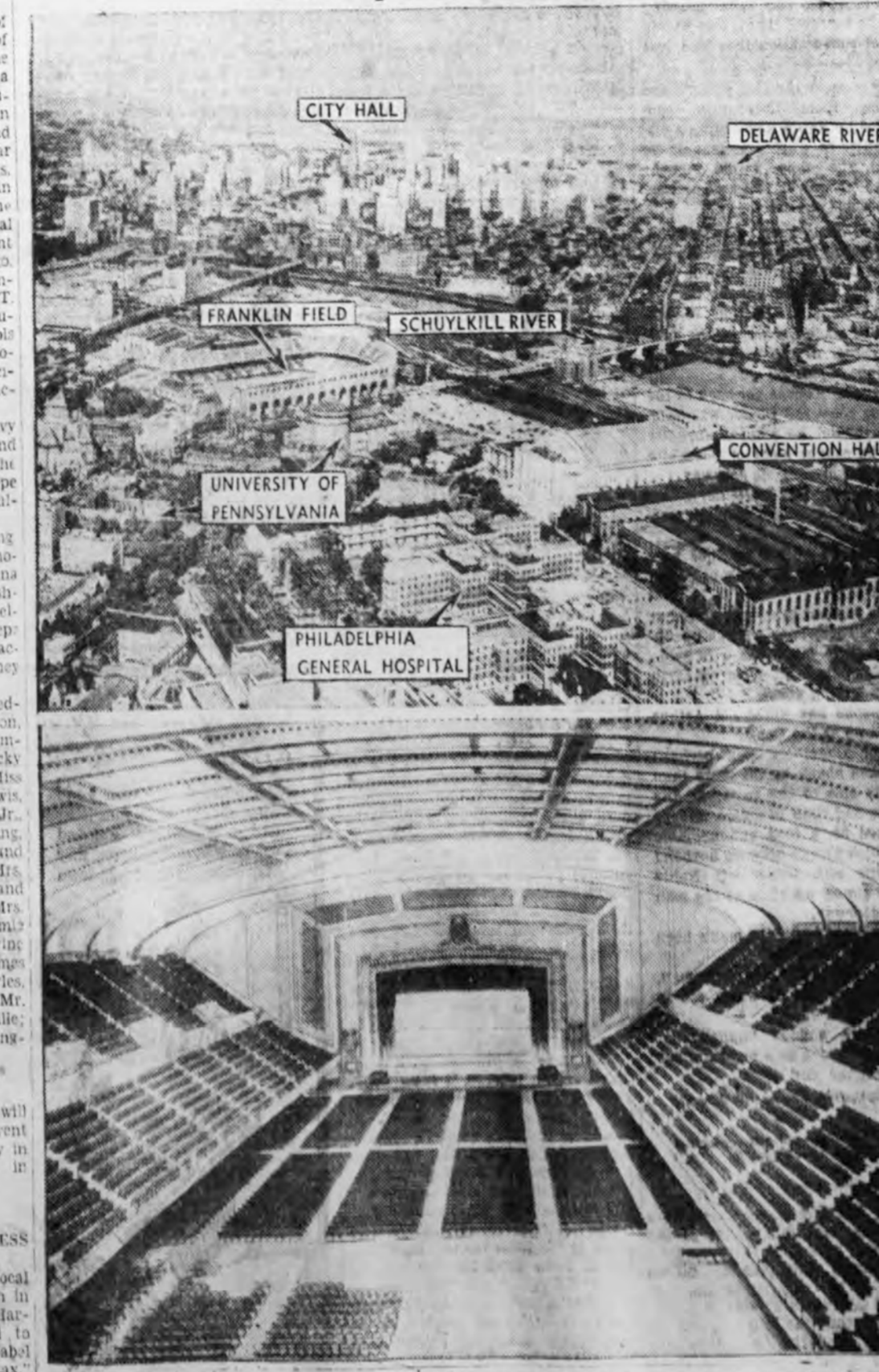

Mr. Hoey might not have been a lobbyist but the records of the Federal Trade Commission show that the Duke Power Company reported paying Mr. Hoey the sum of \$3,412.50 for appearing before legislative committees in regard to franchise tax, production tax and power bills. The News and Observer, published in Raleigh, the capital city, in its issue of March 28, 1931, stated in an editorial that Hoey "has faithfully been in attendance upon the Legislature." Mr. Hoey was not a member of that session of the General Assembly yet he found it necessary to be in attendance and to receive pay from a power company for his services there, yet according to those who now are supporting him, he was not a lobbyist.

It is almost next to impossible to teach an old dog new tricks and likewise we believe it will be almost impossible to change Clyde R. Hoey from a representative of the big interests to a representative of the masses of the people of this state even though he be clothed with the robe of governor of North Carolina. If the people of North Carolina ever want to wrest their government from the hands and control of wealthy corporations of the state they must elect for governor of the state someone other than a representative of these interests, who has made it his business to be in attendance upon the legislature seeking legislation favorable to his clients.

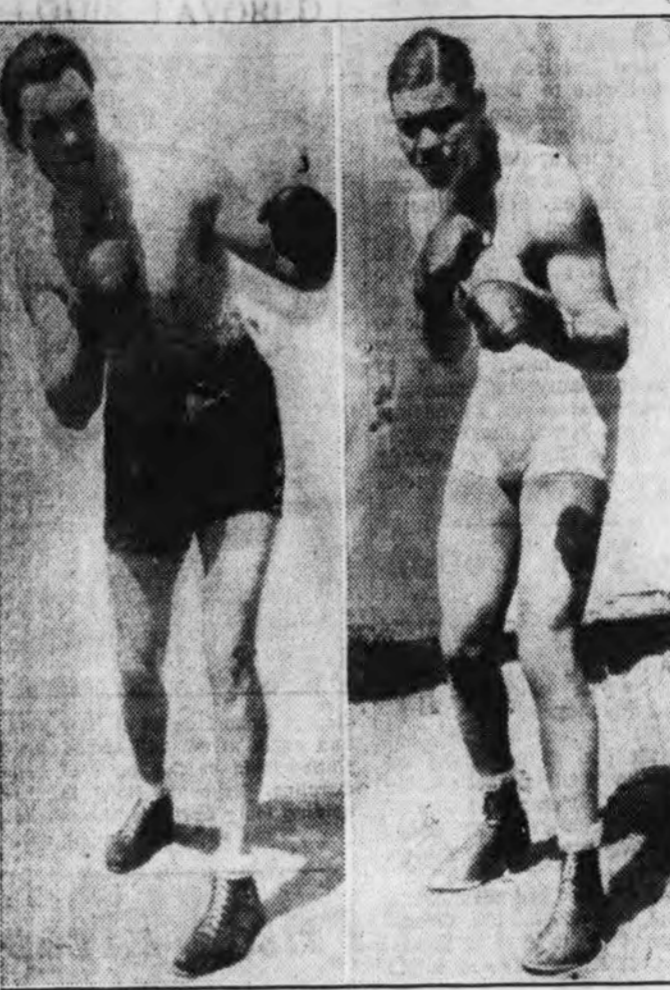
Several weeks ago the prisoners started asking me what they had better do with their bonus bonds when they got them." Director Pitts said, "I told them that they could either cash in the bonds right away for their cash value or could keep them and explained that the longer they were held the more money they would be worth, since the bonds bear interest. "So we told the boys who wanted to keep their bonds to take them to the office of Warden H. H. Honeycutt, get a receipt for them, giving the amount and that they would be locked up in the fire-proof, theft-proof vault within the prison itself. Accordingly, there has been a steady stream of veterans going to the warden's office the past two days to have their bonus bonds put away in the vault for safe-keeping until they are released or until they may want to cash in all or part of their bonds. They seem to feel the bonds will be safe in the prison vault, since they know it is even harder for a burglar to break into the prison as it is for one to break out of it."

## BEAUFORT POTATO CROP SHOWS SHARP DECREASE

Washington, N. C., June 17.—According to present figures Beaufort county's potato crop has been cut more than half compared to last year, it was learned today. With about 50 per cent of this year's crop dug and shipped, indications are that the yield will be far below normal. The reduction, however, which has been due largely to dry weather, has been offset to a great extent by an increase in price.

County Agent W. L. McGahey said today that up through Friday 542 carloads had been shipped, leaving around 458 carloads to go later. The estimate yield for the season's crop was set at about 1,000 carloads. Last year 2,410 carloads were shipped.

The crop last year brought about \$1.70 per barrel for U. S. No. 1, while the price last week for that grade was between \$4 and \$4.50 cash and \$5 1/2 per barrel.

# HORTON PLANS BIG CAMPAIGN

## Candidate to Open Headquarters in Raleigh

Reflector Bureau, Sir Walter Hotel, Raleigh, June 15.—W. P. Horton of Pittsboro, who ran in second place in the three cornered race for Lieutenant Governor in the June 6 primary and who has already announced he will enter a second primary with Paul D. Grady of Keno, Johnston county, who was high man, will open state headquarters here in the Sir Walter Hotel tomorrow, June 16. It was learned here today. He has named Daniel L. Bell, judge of the Chatham county court in Pittsboro, as his state campaign manager.

Horton could not be reached for a statement today, but it was learned from authoritative sources that he intends to make an intensive, state-wide campaign against Grady for the nomination, and that he is confident he will be able to overcome Grady's lead and defeat him in the second primary. Those who are supporting Horton are confident that the greater portion of those who voted for George McNeill of Fayetteville, who ran in third place, will now vote for Horton.

In the first primary, Grady was regarded as being the pro-McDonald, anti-sales tax candidate. McNeill the pro-administration and pro-Hoy candidate and Horton the middle-of-the-road candidate. The prevailing belief during the last few weeks of the campaign was that Horton was in the lead and would probably win the nomination due to the fact that he was regarded as an independent and not linked up with any of the candidates for Governor.

It is now generally agreed that the instructions from the McDonald managers here to their county managers and workers was to "down the line" for Grady, pointing out that unless the McDonald forces could get control of the state senate by having a Lieutenant Governor who was sympathetic towards their program. It is expected that the McDonald forces will continue to support Grady in the second primary.

There are also indications that the pro-administration forces attempted to get the forces over to back McNeill and get him aboard the Hoy bandwagon. But this move failed and McNeill ran third in the first primary. It is now believed that a larger part of the McNeill vote will go to Horton rather than to Grady.

# Road Improv'm't Work Progressing Throughout State

## Resurfacing and Reconditioning Program Now Being Completed Only Part of Spring Project

Reflector Bureau, Sir Walter Hotel, Raleigh, June 17.—Approximately 700 miles of highways will have been given new surface treatment while between 300 and 400 miles will have been reconditioned and prepared for surface treating with bituminous surfacing by July 1, W. Vance Baise, chief highway engineer of the State Highway and Public Works Commission said today. The division engineers in Divisions E and B have almost completed their resurfacing and reconditioning programs already, while the others will complete them by July 1. But this does not mean that no more resurfacing or reconditioning work will be done after July 1, Baise said.

"The resurfacing and reconditioning work now being completed is only that part which was included in the spring schedule to be paid for out of the present year's maintenance and the betterment budget," Baise said. "Starting July 1, the new appropriation will be available and we can probably do just as much if not more work than we have been able to so far. This spring we had an allotment of \$650,000 for resurfacing work in addition to our regular budget and had about \$300,000 addition for reconditioning."

Many people are inclined to wonder why the highway department is being so slow in resurfacing certain sections of surface treated roads that went to pieces, while other portions are being retreated, Baise said. But the reason for this many cases is that these sections have to be reconditioned, which means they must be dug up and the clay in order to obtain a sub grade that will stand up, before they can be surface treated.

"Accordingly, where the sub-grade is in good shape, we are going ahead with the surface treatment work as rapidly as possible," Baise said. "But where the sub-grade is in bad condition, we are having to wait until the base is conditioned before we can put down the surfacing."

## French Workers Strike Ahead of Leaders' Pace

By JOHN EVANS  
New York, (AP)—France's militant workers, marching faster than their leader, Leon Blum, rich socialist premier, are sweeping on to their goal of a 40-hour week and "greater social justice."

The strikes which gripped industry in all sections of the republic when Blum took office may have seemed to break like a sudden summer storm, but in France the clouds have been gathering ever since February 6, 1934.

On that "bloody Tuesday" massed and barricaded police fired on demonstrators in the Place de la Concorde. The people had gathered in demonstration against what all parties agreed was a faulty and morally defaulting parliament, their resentment fanned to the explosive point by the revelations of the Stavisky scandal.

Repeatedly French premiers have warned parliament since then that the system of responsible government was having its "last chance."

## Prison Escapes Continue Show Decrease For State

Reflector Bureau, Sir Walter Hotel, Raleigh, June 17.—The number of escapes from the state prison system continues to remain small in spite of the increase in the prison population and the fact that more prisoners are being worked outside where there is greater opportunity to escape. Oscar T. Pitt, acting director of the prison division, pointed out here today in making public the prison department statistics for May.

During the month of May only 38 prisoners escaped, while 27 escaped prisoners were recaptured, while in May, 1935, 94 prisoners escaped, with 78 captures. The prison population during May of this year averaged 8,213 while in May a year ago it averaged about 7,800 or about 1,000 less.

Pitt is more pleased with the record so far in June than with the May record, however, since there have been only 13 escapes so far this month, through today, as compared with 35 escapes through June 17 a year ago. If the last two weeks

Gold flowed from the Bank of France at such an alarming rate the past year or more that many financiers predicted devaluation of the franc would be inevitable after a few more shocks. The gold coverage of the franc is technically adequate, bankers said, but the government could not borrow from its own people. The French treasury, almost empty, had to negotiate loans in London.

**Agitators Stir Workers**  
Gold prices prevented factories from selling much abroad. Reduced production kept up prices. The vicious circle worked into a downward whirlpool and labor seethed under the double stirring of economic distress and political agitation.

At the elections, the communist-socialist-radical socialist "popular front" was swept into power. Its followers then looked to it for quick action to relieve their distress—where there was distress—and to improve conditions generally. The strikers, without official union approval at the start, developed a movement which many of the workers' leaders call support for Blum. They said Blum could get action from parliament more easily if he could show a serious situation existed.

Blum himself blamed the strikes partly on employers' "stubbornness."
