JUSTICE DEPT. CHARGED WITH TAKING ACTION

Hold Steel Corporations in Collusive Bidding

FOUR COMPANIES FACING CHARGES

Report of Commission Turned Over to Attorney General For "Action"

Washington, June 22.—(AP)—The justice department was charged today with the task of taking "appropriate action" in the case of four steel corporations accused of collusive bidding by the federal trade commission.

The companies are the United States steel corporation, the Bethlehem steel corporation, the Jones and Laughlin steel corporation and the Inland steel corporation.

President Roosevelt turned the commission's report over to Attorney General Cummings, saying in a letter:

"You will note that the federal trade commission definitely finds the existence of collusion. In accordance with their recommendation I am referring the whole matter to you for appropriate action."

The report said the four companies "admitted" they quoted identical bids for the delivery prices of sheet piling on three projects because they acted pursuant to a resolution of the industry for the continuance of a system of prices fixed under the provisions of the former NRA steel code.

The commission report prepared at the request of the President said the bids were submitted in August and September, 1935, on the piling of the Triborough Bridge at New York, a harbor project at Miami and an ocean terminal at Morehead City, N. C.

In recommending to Mr. Roosevelt that the whole question be turned over to the justice department, the commission said there was "reasonable ground to believe that the anti-trust laws had been violated."

Order To Remove WPA Requirement Relating To Dole

New Regulation Will Lift Requirement That Person Must Have Been on Relief in Order to Obtain Job

Washington, June 22.—(AP)—An order to be issued this week by the Works Progress Administration will lift the requirements that a person must have been on the dole prior to November 1 in order to obtain a WPA job.

Officials said today that state WPA administrators hereafter could decide which of those eligible for local relief and able to work would get jobs regardless of when they went on the dole.

Lifting of the previous requirements originally adopted to prevent communities from certifying an excessive number of unemployed for WPA work was forecast several months ago by administrator Harry L. Hopkins.

Officials said the present rule requiring that a person must be on relief or certified for relief to be eligible for WPA employment will be continued.

Explaining that under the new \$1,425,000,000 work relief appropriation not more than 2,300,000 persons could be given jobs, they said the rule is to be continued although a large number of the unemployed will not be eligible for federal help under it.

Hopkins reported today that the WPA is ready to begin the new fiscal year on July 1 with nearly 4,000,000,000 in approved projects available for the job problem.

On April 15, North Carolina had \$12,237,727 in WPA projects being carried out, of which 20.1 per cent was furnished by the state and local governments.

Two Candidates On Speaking Campaign

Raleigh, June 22.—(AP)—Dr. Ralph McDonald heads east today to speak in Greenville tonight continuing his campaign for the Democratic gubernatorial nomination.

Clyde R. Hoey, who led McDonald in the first primary on June 6, also will invade the east with night speeches at Thomasville tomorrow, Henderson Wednesday, Wilson Thursday and Greenville Friday.

McDonald planned to make a number of speeches during the week he said, although dates had not been set for any others except one at Elizabeth City Wednesday night.

FARM WOMEN PLAN MEETING

Farm - Home Week To Be Observed at State College

Raleigh, June 22.—North Carolina farm women who attend Farm and Home Week at State College, July 27-31, will have a pleasant vacation while attending the annual short course for home demonstration club women.

In addition to the recreation, tours, and entertainment to be provided, said Miss Ruth Current, district home agent who has charge of the women's program for the week, specialists will conduct classes in those things particularly interesting to rural women.

Some of the subjects are: parent education, food preparation, nutrition, dyeing with native roots and herbs, home improvement and beautification, clothing, refinishing furniture, purchasing practices, parliamentary procedure, and wiring homes.

Besides the specialists of the State College extension service, Miss Current said, addresses and demonstrations by nationally known men and women will feature the program of women's activities. Among them are: Dr. C. P. Segard, nutritionist; of New York City; Miss Margaret Furry, of the Washington office of the federal extension service; Miss Vie Dowdy, of Georgia extension service; Mrs. Evelyn Tobey, stylist in charge of clothing work at Columbia University; and Dr. C. W. Warburton, director of extension work, U. S. Department of Agriculture.

Rooms for women attending Farm and Home Week will be provided in the State College dormitories, Miss Current said, and meals will be served in the college cafeteria.

Special rooms will be reserved for married couples who wish to attend the short course together. Although special features have been arranged for men and for women, a large part of the program will be for both, she continued.

Pitt Lawyer's Case Again Is Postponed

Funeral services were conducted this afternoon from the late home at 4:30 by Elders L. B. Manning and J. H. Joyner, Free Will Baptist ministers. Burial followed in the Harris cemetery near King's Cross Roads.

Besides the parents, a brother and sister survive, R. T. and Lillian Jolly.

Giant Hindenburg Beats Old Record Crossing Atlantic

German Dirigible Grounded at Lakehurst Naval Air Station at 5:15 o'Clock This Morning

Lakehurst, N. J., June 22.—(AP)—The dirigible Hindenburg grounded at the naval air station at 5:15 a. m. (EST) today, bettering its previous record for a westward crossing of the North Atlantic by 32 minutes.

It was 61 hours and 25 minutes out of its home port, Frankfurt-on-Main, Germany, when the grounding ropes were heaved out.

NEW DEAL FOR SEEKING AID

Governor Talmadge Urges Discontents Line Up with Him

Atlanta, June 22.—(AP)—Governor Eugene Talmadge, new deal critic, today urged Al Smith and other discontents to "line up with me" on my plan to fight the new deal and Roosevelt within the democratic party.

The fiery Georgia executive made it plain he did not intend to bolt the party ticket.

"I am a party man," Talmadge said banging his fist on his desk. "I am opposed to Roosevelt being the nominee of the party."

"The governor said he was not informed about what former Governor Smith, former Governor Ely of Massachusetts, former Secretary of State Bainbridge Colby and others intended to do if the democratic national convention nominate Mr. Roosevelt.

"The best thing Al Smith and Governor Ely and the others can do is to line up with me on my plan to fight Roosevelt and the new deal within the party."

Kiwanians Arrive At Capital City for Annual Convent'n

Washington, June 22.—(AP)—Kiwanians from the Carolinas arriving here for the 20th annual convention of Kiwanis international prepared today for four days of conferences on child welfare, urban-rural problems, adult education and public affairs.

The delegation is headed by J. Henry LeRoy, Jr. of Elizabeth City, governor of the Carolina's district. Lieutenant Governors include the Rev. T. C. Johnson of Kinston.

HIGHER COURT REFUSES STAY

Government Loses In Efforts on Holding Company Act

Washington, June 2.—(AP)—The government lost in the District of Columbia court of appeals today in its efforts to delay trial of injunction suits brought by seven utility companies against the Wheeler-Rayburn holding company law.

The court reversed a stay order entered in the case several months ago by Justice Jennings Bailey of the District supreme court.

Justice Bailey granted the stay after Attorney General Cummings had argued that litigation brought by the government in New York against the electric bond and share company would thoroughly test constitutionality of the holding company law.

Cummings' plea that a "multiplicity" of suits brought by utility interests threatened to break down the machinery of the Department of Justice failed to win over to the appellate court.

Speaking for it, Associate Justice Josiah A. Van Orsdel said issues raised in the case here were not identical with those in the bond and share case.

"The government of the United States, as a litigant, has no greater rights than the humblest citizen," he said, in his opinion.

Local Patrol Office Entered During Night

The local offices of the State Highway patrol were broken into early Sunday morning and Lieut. Lester Jones, head of the Eastern division, expressed the opinion today that persons seeking firearms were the guilty parties.

No information as to who entered the offices was available today. Highway patrol officials said nothing was missing from either of the two offices. No firearms are kept in the headquarters.

Lieut. Jones said he was of the opinion those who entered the place were responsible for a call about 4 o'clock Sunday morning saying that three highwaymen were on the Farmville road and asking that patrolmen be sent out to investigate. Officers who answered the call found nothing to indicate any highwaymen had been on the road.

DISCUSS PLAN OF INSURANCE HELP FARMERS

Democratic Platform Builders Consider Farm Plank

QUOTE WALLACE FOR INSURANCE

Some Other New Dealers Said to Believe No Mention Should Be Made

Philadelphia, June 22.—(AP)—Democratic platform builders faced this question today: Should the party promise the farmer a system of insurance against disasters like floods and droughts.

Authoritative sources said Secretary Wallace wanted crop insurance as a new form of federal aid to agriculture and that he also desired endorsement of the principle of crop control.

Some other highly placed New Dealers were said to believe no mention should be made of these ideas specifically and that language of the farm plank should be broad and general.

A tentative draft of a farm plank said to be in the hands of Senator Wagner of New York, prospective chairman of the resolutions committee, has omitted both crop insurance and production control.

Administrative sources reported that there was general agreement upon these suggestions: Preservation of soil fertility. Continuation of the reciprocal trade agreement policy. Encouragement of farm cooperative organizations.

Enlargement of the domestic market through increase of industrial wages. Endorsement of commodity loans. Provision of credit to combat farm tenancy by enabling qualified tenants to buy their own farms.

Three Candidates For County Posts File Expenditures

Charles Whedbee, J. Vance Perkins and Dink James Only Ones Who Have Filed Report Up to Date

Only three candidates, all of whom were victorious in the first Democratic primary, have filed accounts of receipts and expenditures with the county clerk of court, as required by law.

Charles Whedbee, who was nominated solicitor of county court, reported that he spent \$103.60 and received no contributions. He reported the money was spent in paying the \$3.60 filing fee, for cards, newspaper advertisements, purchasing gasoline and oil and buying soft drinks, as well as for other purposes.

J. Vance Perkins declared he spent \$509.66. He did not report any contributions. Mr. Perkins was nominated county treasurer.

Judge Dink James who has filed his expenses in successfully seeking re-nomination for judge of county court, reported that he did not receive any contributions. The report had been misplaced in the clerk of court's office, and the exact amount of money spent was not available.

Other candidates who were entered in the primary and who have not already done so, said they would file their reports within a few days. The law provides that each candidate shall make a sworn statement as to the amount spent in seeking nomination, and also report contributions, in case of any.

YOUNG VOTERS PLAN MEETING

Interest High in Coming Convention of Young Democrats

Raleigh, June 22.—The younger Democrats in the state, as well as many of the older ones, are already beginning to show a brisk interest in the forthcoming annual state convention of Young Democratic Clubs in North Carolina which will be held in Greensboro July 17 to 19. A spirited, though good-natured contest for the various offices is also in prospect.

Three hats are already in the ring for the presidency of the North Carolina Young Democratic Clubs to succeed Mrs. Bessie Phoenix of Raleigh, the retiring president. These are Haywood Robbins of Charlotte, Ed Butler of Morganton and Dave Harris of Canton.

James A. Abernethy of Lincolnton, the present vice president of the state organization and who was in line for the presidency, has recently announced that he would not be a candidate for president due to the fact that he has been nominated to represent Lincoln county in the house of the 1937 general assembly. Of the candidates for the presidency, Robbins is regarded as having some very strong support.

All of the candidates for the presidency are from the west this year, since under the plan of organization followed, the presidency alternates from east to west.

The position of national committeewoman on the National Executive Committee of Young Democrats will also go to the west this year, while the post of national committeewoman will come to the east this time. Miss Winifred Baggett of Lillington is the present national committeewoman and Judge Sam Cathy of Asheville is the present national committeeman.

The only candidate in the field at present for the post of national committeeman is Wade H. Lucas, managing editor of the Raleigh Times, who has been active in county and state Young Democratic circles since the Young Democrats were first organized by Tyre C. Taylor some five years ago. Lucas was floor leader of the Young Democrats in their annual convention in Asheville in 1934 and was largely responsible for the adoption of the resolution calling for the adoption of an "adequate liquor control system" in North Carolina.

In the convention here last summer Lucas was chairman of the resolutions committee which brought out a similar resolution with regard to liquor control, which was also adopted. Lucas was vice president of the Wake county Young Democratic Club from 1932 to 1934. He has never before sought a state office.

Checks are received here today by a number of ex-service men who had their bonus bonds certified and sent to Raleigh immediately after they were received last week.

All veterans who have returned their bonds did not get their checks today, however, but unless some error is found, they are expected to be received within a few days.

The first batch of bonds were sent to Raleigh last Tuesday night by local postoffice officials. It is understood checks received today were for bonds included in the first mailing.

High Ranking Democrats Return Thundering 'No's' To Suggestions Of Smith

SOLONS LEAVE; FDR AT WORK

President Tackles Anew Stack of Passed Legislation

Washington, June 22.—(AP)—Amid the hurried departure of congressmen for home or the Democratic National Convention at Philadelphia, President Roosevelt went back to his desk today to tackle anew a stack of bills passed in the last hours before adjournment.

Senator Robinson of Arkansas who will be permanent chairman at Philadelphia, and Senator Barkley of Kentucky, who will make the keynote address at tomorrow night's convention session, led a small group who talked with President Roosevelt yesterday afternoon.

Barkley said the President "talked in general terms about the convention and some of the problems connected with it."

Measures upon which legislative action was completed before the 74th Congress adjourned early yesterday morning included the new revenue measure and the \$2,370,000,000 deficiency relief bill which carries \$1,425,000,000 for relief.

While the 74th Congress was a matter of history many of its investigating committees were ready to plunge again into hearings.

Big Tobacco Crop Seems Be Outlook In Some Sections

Fickle Weather and Variable Growing Conditions Promise Good Crops in Some Areas; Others Poor

Raleigh, June 22.—A good crop of blue-cured tobacco is expected in some sections of the State, while in others the yield will be very low.

Fickle weather and variable growing conditions are largely responsible for this situation, said E. Y. Floyd, extension tobacco specialist at State College.

They also make it practically impossible to forecast at this time the size and quality of the crop for the State as a whole he added.

As one example of variable conditions, he said that in Johnston county a farmer watered part of his crop with water from a branch and got a good stand, but where he got water from a well, the stand is so poor that only a small yield is expected.

However, Floyd continued, some farmers have a better stand than they realize. In certain cases, dry weather has burned off the plant tops, but the bud is still there even though hard to detect.

He urges that tobacco farmers break the soil thoroughly around the plants, cultivating it in such a way as to pull as much soil as possible around the stalks.

Keep the row middles well watered to take care of excess water, he continued. Tobacco can be damaged very easily by too much moisture.

He also urged growers to keep a close watch for bud worms, and apply a mixture of one pound of arsenate of lead to 50 pounds of corn meal, mixed thoroughly. Drop a pinch of the bait in each bud.

Three Persons Given Terms by City Court

One white man and two negroes were given terms of 30 days each on the roads today following trials in Mayor's court.

Eliot Creech, white, was sent to the roads for being drunk. Jesse Johnson, negro, was sent up for being drunk and fighting, and Jim Duncan, negro, was given a road sentence for being drunk and disorderly.

LEADERS BEGIN MAP PLATFORM

Rule Requiring Two-Thirds Majority For Nomination Set For Disposition Thursd'y

Philadelphia, June 22.—(AP)—The convening Democrats took over this long-time Republican citadel today amid predictions by leaders that the national conclave would return a thundering "No" to Alfred E. Smith's demand for the repudiation of President Roosevelt.

One after another, New Dealers in command of the situation here stepped forward to denounce Smith or to shake their heads sadly over what they called his mistaken course.

Among the delegates arriving for the convention, opening tomorrow, none thus far have risen to support the statement in which Smith and four other anti-New Deal Democrats called on the convention to put aside Mr. Roosevelt and nominate "some genuine Democrat" for President.

Chairman James A. Farley's usual broad smile faded when he was asked about the Smith statement. He answered in clipped words: "This convention will nominate a genuine Democrat, Franklin D. Roosevelt."

Recalling Smith's affiliation with the American Liberty League, Farley said "The objectives and connections of people of this kind are by this time thoroughly well known to every American."

The tenor of remarks by several others prominent in the party was the same.

Jammed hotel lobbies and downtown streets, decorations abounding and bands blaring "Happy Days Are Here Again"—all told the quadrennial tale of convention fanfare for rank and file. But the leaders, secluded in rooms high above the bustle, had their platform problems to wrestle with.

One question apparently destined to arouse floor debate, the repeal of the 10-year-old rule requiring a two-thirds majority to nominate, has now been set for disposition Thursday morning. Some southerners have their dandruff up on that. The powers that be expected to settle in in stride.

TAR HEEL DELEGATION AT DEMOCRATIC CONVENTION

Philadelphia, June 22.—(AP)—North Carolina's delegation to the Democratic National Convention converged on Philadelphia today prepared to opening of the party conclave tomorrow.

A caucus was in prospect at the earliest possible time to sound out the delegation's attitude toward the proposal to abrogate the century old rule requiring a two-thirds vote for nomination of candidates.

Temporarily overshadowing the prospective caucuses, however, was the announcement by Julian Price of Greensboro, that he had been named proxy for National Committeeman C. L. Shuping also of Greensboro.

Anti-Roosevelt sentiments have been attributed to Shuping, who did not offer himself for renomination at the recent state convention held in Raleigh.

A. D. Folger of Mount Airy, recommended to succeed Shuping, is not expected to attend the national meeting because of illness.

Price and Miss Beatrice Cobb of Morganton, national committeewoman, represented the state at this morning's meeting of the national committee.

Miss Cobb said the proposal to abrogate the two-thirds rule made by National Chairman James A. Farley would be left to a vote of the delegation.

he announced that his delegation would vote for Landon on the first ballot. In past years he has passed cigars and swapped votes. Recently he suffered a severe illness. Friends and foes tipped sympathetically to his bedroom door. He who had lived to fight — and browbeat — seemed not to have an enemy in the world. The demonstration meliowed the old political pirate. He regretted his record as a selfish, cynical, convention conniver. So he pinned a sunflower on his lapel, danced a jig to the tune of "Susanna" and hooked arms with the kindergarteners from Kansas.
 Mr. Glass shares whenever he thinks of New Deal reforms; FDR's monetary policies rack him. Nobody on the Senate floor has flayed the administration more bitingly. But his Cromwellian righteousness has brought new acclaim everywhere. Universities have scrambled to honor him with degrees which he acknowledges in a hoarse voice. Old Dominion Democrats cheered him till tears dimmed his blue eyes. Like the Nutmeg patriot, he has been touched to tenderness, even toward New Dealers. He'll get join the Copeland-Smith-Raskoo marchin' and chawin' club.

LOSSES: You don't have to doubt Senator Copeland's sincerity to suspect that there is a lot more behind his desertion of the New Deal than his dislike of Roosevelt reforms. Those in the know proclaim that the propelling forces were Tammany, Al Smith, and William Randolph Hearst—a combination few office-holders dare to defy.
 Dr. Copeland entered politics under Hearst-Hylan sponsorship, and he still prescribes for fat ladies and thin men through the Hearst columns. It accounts for his political strength in upstate New York. Although only a Tammany stepchild, he has been adopted and christened by the braves until no man in Washington is closer to the "hall." Al Smith still wings a tomahawk in the wigwag. By 1940 when Dr. Copeland must run again, the New Yorkers may have ousted Roosevelt — Farley horsemen from the driver's seat.
 New Dealers profess no concern over the doctor's defection. They

fall back on the hoary line that many a man who commands votes for himself can't carry them with him against somebody else. Maybe so. But the Smith-Copeland-Lehman walkouts encourage G. O. P. ers to the point where they place New York's 47 electoral votes in the Landon column.

STRINGS: There are two significant reservations attached to the kindly British suggestion as reported in high financial circles. One is that the Republican administration shall carry out its balanced budget pledge as rapidly as possible. Why should the British care about that? Because the only way to fulfill it quickly would be by drastic and deflationary economies American deflation would not be exactly detrimental to British competition with our foreign trade.
 The second string is that the Republicans — if and when they regain power — shall move promptly to restore the dollar to a firm gold basis and thus redeem their sound money commitment. It would be perfectly lovely for John Bull if they did. The managed pound could then run circles around the hobbled dollar to give English exporters a huge edge over ours.
 Our cousins across the pond may be generous — but never altruistic. The inferences behind their sub rosa gesture are so plainly to our disadvantage that even confirmed New York anglophiles cannot swallow them. It is unlikely that the Republican high command will be naive enough to fall for such a thinly veiled come-on gag. But you can't hang the British for trying.

REALIST: The tendency to portray John D. M. Hamilton — new chairman of the Republican national committee — as a sort of western Galahad who will slay the Old Guard dragon and convert the Republican party into a symbol of progressiveness and political purity amuses New Yorkers who know him well. They point out that Mr. Hamilton — while young as national chairman go — has had a long and arduous training in poli-

tics and is familiar with all the tricks of the trade. He is a thorough realist, and it can safely be predicted that he will not sacrifice practical consideration for any "progressive" jargon.
 Such familiar Old Guard figures as Charles D. Hilles of New York, J. Henry Roraback of Connecticut and Ralph Williams of Oregon are on the new Republican executive committee because Hamilton wants

them there. He isn't shooting anybody who figures — to help corral votes or money.
 The West is in the saddle all right. It will be made clear to the eastern "bosses" that they are not running the show. But they will be treated as valued allies and any overzealous westerner who may try to start an anti-Old Guard crusade will find Hamilton on his neck like a ton of brick.

PEACE ACTION

The Greenville Council for Peace Action, through its committee on legislation, Mrs. C. C. Hilton, chairman, and in cooperation with other peace units throughout the country, sent letters to the chairmen of the platform committees of both the Republican and Democratic National Conventions regarding policies which the National Peace Conference—the agency for the united peace organizations of the country—desired to see incorporated in the platforms of both parties. Although the Democratic platform in its foreign affairs plank has not been released to the public as yet, the Republican platform was a distinct disappointment from the standpoint of peace-minded Americans. Mrs. Hilton announces that the following statement to Governor Alfred M. Landon was released last week following the announcement of the Republican platform:

"The National Peace Conference composed of representatives of thirty-four non-partisan national organizations, registers its intense disappointment with the foreign affairs plank of the Republican platform. This plank is among the most isolationist in party history and is utterly unrealistic. The platform shows no appreciation of the fact that a World War produced a world depression, that fear of another war, combined with extreme economic nationalism, is continuing this depression, and that only world cooperation can save the situation."

"In repudiating the World Court the platform reverses the stand of the Party and of all its Presidents and Secretaries of State since 1899. It shows itself completely indifferent to the fact that necessity has forced American cooperation with the League of Nations in many of its activities."

"The platform is practically silent on disarmament; it says nothing about taking the profits out of war; it completely ignores the tremendous public opinion in this country for strict neutrality legislation. The platform is a repudiation of the desires of millions of people in this country for a constructive policy on world peace."

Mrs. Hilton announces that from time to time the Greenville public will be kept informed of the work done, bearing national and international interests of the Greenville Council for Peace Action through its committee on legislation.

STATE FORCES SEEM PLEASED

Politicians Appear Satisfied with Gaddy's Resignation

Reflector Bureau, Sir Walter Hotel.

Raleigh, June 22.—The school politicians, especially the representatives of the textbook manufacturing companies and the North Carolina Education Association, are delighted with the selection of Claude F. Gaddy, formerly assistant secretary of the State School Commission, as the new Superintendent of the Raleigh City schools, because they are convinced that his resignation from the School Commission has materially weakened it and will make its abolition more easy by the 1937 general assembly. Another reason for this view is that all of the school politicians and lobbyists like Gaddy personally and admit that he has outstanding ability.

"We are glad to see Gaddy get this job as Superintendent of the Raleigh schools and also glad to see him leave the State School Commission, for the chances are that he would not have been able to have a job there much longer," one of the high-ups in school circles is known to have remarked since Gaddy was elected head of the Raleigh school system.

This statement is being interpreted as indicating that the school forces, consisting of the State Department of Public Instruction, the North Carolina Education Association, and the textbook publishers are going to renew their efforts in the 1937 general assembly to either abolish the State School Commission outright, as they have sought to do for the past six years, or else secure the control of it by consolidating it with the State Department of Public Instruction with the State Superintendent as its chairman and directing head. The school forces tried unsuccessfully to abolish the commission in both 1931 and 1933 and in the 1935 session of the legislature tried to secure the control of the commission by making the State Superintendent its chairman and active head.

The legislature has constantly and consistently repudiated these attempts to either abolish or cripple the school commission and refused to turn over the spending of almost \$22,000,000 a year of state school funds to the school forces, however.

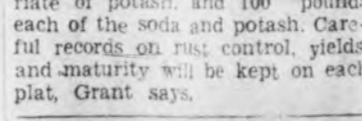
Rust Demonstrations To Be Held In Bertie
