Depart From Philadelphia to All Corners of Nation

ROOSEVELT GETS GRAND OVATION

Celebration Drowns Out Last Three Sentences of President's Acceptance Speech

Philadelphia, June 29. (AP)—Democratic leaders scattered to the four corners of the country today to preach economic freedom as the keynote of their campaign to reelect President Roosevelt.

They carried a pledge to battle "economic tyranny" directly from the President who wound up the party's convention Saturday night by accepting his renomination before an enthusiastic crowd of 100,000 in rain-soaked Franklin field.

Only those near loud speakers heard the last three sentences of the President's address. "I accept," started a tumultuous ovation that all but drowned out "the commission you have tendered me. I join with you. I am enlisted for the duration of the war." It lasted until Mr. Roosevelt drove from the vast stadium.

Half way through his speech the President sounded his war cry. "For too many of us the political equality we once had won was meaningless in the face of economic inequality. A small group had concentrated into their own hands an almost complete control over other people's property, other people's money, other people's labor, other people's lives x x x"

For too many of us life was no longer free, liberty no longer real, men could no longer follow the pursuit of happiness.

Officials of City Facing Busy Week With Three Meets

In Addition to Regular Monthly Session, Board of Aldermen to Convene in Two Charter Meetings.

City officials are in for a busy week, two charter meetings being on schedule in addition to the regular monthly meeting on Thursday night.

J. O. Duval, city clerk said today the city's 1936-37 budget was practically completed, but could not be offered for approval until the Thursday night meeting. He added that the \$1.00 tax rate probably would remain the same. "I can't see how it can be lowered... but neither do I see where it will have to be increased," the veteran clerk said.

He added that by working close, he felt the city could live within the \$1.00 rate during the next fiscal year.

Tomorrow night the board will meet, as provided by charter, for the purpose of winding up the past year's fiscal business. Mr. Duval said it was impossible to offer a budget for the coming year until after this session.

On Wednesday, July 1, at noon, the Board will go into session for the purpose of swearing in its new members, and possibly name appointive officers. J. A. Watson will be the only new member of the board, the other two who were up for re-election, Dr. M. B. Massey and Joseph M. Taft, having been named without any opposition. Mr. Watson succeeds Mrs. J. L. Hasel, who did not offer for reelection.

Following on the heels of these two charter meetings, the regular monthly meeting is set for Thursday night.

Zioncheck Glimpsed Following Escape From Sanitarium

Washington, June 29. (AP)—Representative Marion A. Zioncheck (D. Wash.) who escaped from a Towson, Md., sanitarium last night, appeared at the door of his office on Capitol Hill today after police had entered the office.

The fleeting glimpse of the congressman, sought since his escape from a Maryland sanitarium about 24 hours earlier, came after announcement of unverified reports that he had come to Washington early today and locked himself in his office.

Zioncheck appeared after Capitol police had entered the office accompanied by an assistant sergeant at arms.

During the forenoon a warrant for the arrest of the Representative was issued by District Attorney Leslie Garnett. The warrant was based on the complaint of Mrs. Benjamin Scott Young, who sues an apartment to Zioncheck.

She alleged she had been injured in struggles with the Zionchecks at the apartment. A similar warrant has been issued for Mrs. Zioncheck.

Towson, Md., June 29. (AP)—Marion A. Zioncheck, madcap congressman from Seattle, Wash., baffled his pursuers today in a weird game of hide-and-seek that began with his escape from a private sanitarium here.

His whereabouts remained a mystery 24 hours after he leaped a wire fence and ducked into the woods surrounding the Sheppard and Enoch Pratt hospital.

State police said they had broadcast no general alarm, but Baltimore city police headquarters sent out to all its officers a detailed description of the 35-year-old congressman.

Far into the night hospital attendants, reinforced by police officers, combed the state and searched elsewhere for their missing patient. The police said one attendant told of Zioncheck being seen on the grounds during the night, but no report of his capture was forthcoming.

Funeral services were conducted yesterday afternoon by Rev. Richard Bagley, pastor of the Christian church of Washington, for John Benjamin Brinson, Sr., 65, who died at his home Saturday afternoon on the Ramshorn road at 1:15 o'clock after several weeks of illness caused by cerebraloplexy. Interment was made in the Westley cemetery in Beaufort county.

Mr. Brinson was a farmer and had lived in Pitt county for many years, and was well known among a large circle of friends.

Surviving are his wife, Mrs. Carrie P. Brinson; two sons, J. B. Jr. and V. P. Brinson of Washington; two daughters, Mrs. J. A. Campbell of Greenville, Route 5, and Miss Elizabeth Brinson of the home place; two brothers, J. W. Brinson of Pamlico county, and Thomas Brinson of Scotland Neck; one sister, Mrs. Annie Catherell of Pamlico county.

Active pallbearers were Vance Gray, W. H. Skinner, L. R. Sutton, J. D. Mayo, R. B. Harris and J. E. Jones.

YOUNG WOMAN BEATEN DEATH

Chicago Divorcee Is Found Dead in Hotel Room

Chicago, June 29. (AP)—Beaten to death by blows on the head, Mrs. Florence Castle, 25-year-old divorcee, was found today in her room at a hotel near the Gold coast on Chicago's near north side.

Scrawled across the mirror of her dresser in what detectives said appeared to be either red crayon or lipstick were the words: "This is the black legion."

On a bed near the body the police found the two pieces of a paving brick broken in half and blood-stained which was used to bludgeon the victim while James, her six-year-old son, looked on in horror.

James ran into the lobby of the hotel in his nightclothes and told the desk clerk: "A man with a black mask hit mamma."

Hotel employees said they believed Mrs. Castle had been employed as a night club hostess.

Detectives said they believe that because of her son's terror, he might have mistaken a negro for a masked man. They theorized the murderer climbed the fire escape to Mrs. Castle's fifth floor room, armed with the brick and slugged her to death when she resisted his attack.

The slaying scene was about two miles north of the hotel where Mrs. Lillian Guild, 55-year-old widow, was killed under similar circumstances a few weeks ago by a negro. The negro pleaded guilty and was imprisoned.

MAYOR WARNS FAST DRIVERS

Declares Speeding on Dickinson Avenue Must Be Ended

Mayor M. K. Blount gave notice in Police court today that motorists who insist on speeding in the city, and especially on Dickinson avenue, would be dealt with severely.

The mayor's warning came after he had fined Richard Leary, negro, five dollars and costs for speeding on the Avenue. The mayor-judge said that unless the practice of using the street for a racetrack was halted, he was going to take more serious action. He also instructed city policemen to pay special attention to the Avenue in regard to speeders. He also asked them to keep an eye on the entrance of Falkland highway, saying motorists fail to slacken up their speed on the street.

SHAVE HEADS OF WOMEN VICTIMS

Solicitor Announces "War to the Death" Will Be Waged On Those Responsible

Wilmington, June 29. (AP)—Solicitor John J. Burney announced a "war to the death" today against Columbus county night riding women floggers, and in Whiteville a grand jury continued a probe of the band directed last week by Judge R. Hunt Parker.

Burney said the secret band had been operating for 7 months and that their activities came to life only Saturday.

"Every man responsible for this outrage is going to be ferreted out and brought to trial," he said. "I am convinced that not half of the depredations committed have been brought to life and I am morally certain that the gangsters have so intimidated the country side people have been afraid to speak."

Hackett Applewhite, directing the grand jury investigation, said the judge was in possession of the names of some of the night riders and that other names were expected to be revealed in a short time.

Burney said the names of six victims so far had been revealed—four women and two men. He said the women were subjected to head shaving, then beaten with straps upon their bare flesh. One of the male victims was paralyzed.

The situation came to life during the trial of Pink King, who was charged with criminally assaulting a 15-year-old girl. Court attaches were attracted by refusal of the girl's mother to remove her hat and when it was forcibly taken off her head was revealed to have been shaved and an investigation was begun.

All the attacks were said to have taken place in or near the town of Clarendon, in the southern edge of the county near the South Carolina line.

Associations Aid Builders of Homes

Just three years to the day after they were first authorized by Congress as a model type of the familiar building and loan association, 1118 Federal Savings and Loan associations were in operation in 44 states on June 13.

They were designed to afford increased protection to the public's savings and to lower the cost of home loans by augmenting the volume of funds available for home financing in districts where local funds were inadequate. Existing building and loan units were authorized to apply for conversion into Federal Savings and Loan associations if they chose to do so.

Through no figures on revenue receipts for June will be announced until tomorrow, investigation by the Associated Press today showed that tax revenue for the year was \$51,980,989.87 on June 1, almost a million dollars more than the receipts from all sources in 1934-35 of \$50,976,41, which set a record then.

June receipts usually exceed those of May, due to the pay of schedule B license fees and last month the receipts for the highway and general fund were \$3,667,574.82 indicating the fiscal year's tax revenue will exceed by upward of \$4,000,000 the total revenues of the previous high year.

Frank Dunlap, assistant director of the budget, said there was no doubt the general fund would show a credit balance at midnight tomorrow night, though it may be several weeks before the definite figure is available.

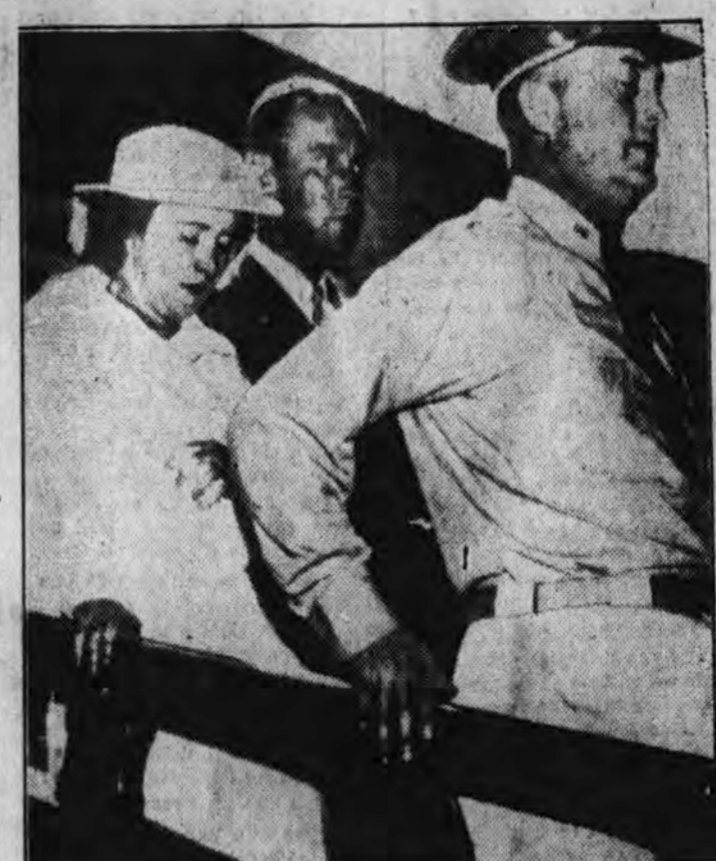

CROPS SUFFER HEAVY DAMAGE FROM STORMS

One Killed in Belhaven as Twister Hits Negro Section

WILSON SUFFERS FROM WIND, HAIL

Tobacco and Other Crops in Fountain Section of Pitt County Damaged

Belhaven, June 29. (AP)—Upsetting oak trees and ripping houses to matchwood, a tornado struck Belhaven last night about 11:30, killing one person and injuring others and cutting a swath of destruction which will run into thousands of dollars damage.

The twister came from the north, but later shifted to the west, striking the west section of the town where the negro section is located. The main section of the town was not hit.

Tobacco and other crops in the Fountain section suffered from a hail storm yesterday afternoon, but no other sections of the county reported any material damage from hail and wind storms which struck in Eastern North Carolina.

Tobacco crops of a few farmers near Fountain were said to have been destroyed almost completely, but the storm did only a small patch, Pitt officials said. Some damage was also reported in the vicinity of Leak's Crossroads.

Mabel Lee Burriss, six-year-old negro girl, was killed when the wind, estimated by residents to have had the velocity of about 100 miles an hour, struck her home and tore it from the foundations and scattered her. Her sister suffered a broken arm and her mother received cuts and bruises in a shattered escape from the ruins.

Wilson, June 29. (AP)—Farmers of the northern part of Wilson county today surveyed the results of destructive winds and hail storms which did heavy damage to crops late yesterday.

A path about half a mile wide and 12 to 15 miles long was swept by the storm. Tobacco, cotton, corn and other crops were reported ruined.

High winds uprooted many trees and unroofed farm buildings in the area.

County officials said the damage would amount to thousands of dollars.

Heavy damage also was reported in the Macclesfield and other sections.

Rocky Mount, June 29. (AP)—Wind, hail and rainstorms yesterday severely damaged many acres of cotton, tobacco and corn in two sections of Nash county.

Warrenton, June 29. (AP)—A cyclone accompanied by hail tore into Warrenton yesterday afternoon leaving in its wake damages estimated at between \$50,000 and \$75,000. No one was injured but practically every home in the old town suffered some damage from the terrific wind which leveled trees, tore down electric light and telephone wires, tore the steeple off the Negro Baptist church, lifted the roof off one building and smashed two others to the ground.

The two-story part of the Cigette Warehouse, a frame structure, was blown to the ground and the Bledsoe Warehouse, a brick building containing several hundred bales of cotton, was crumpled like so much paper.

"And what's more, somebody that he wasn't afraid of. We know that the old boy had his safe open in that front room and the visitor at the door had been anyone that he didn't like the look of, even if he knew whoever it was, you bet your boots he'd have gone back and shut that safe before ever he took the door off the chain. Don't you agree?"

"Well, yes, I suppose I do, sir."

"The only thing we know for certain in this case so far is the character of old Burdett. We can build on that."

IT'S SOMEBODY'S FAULT

"Nobody is killed on a highway except by somebody's carelessness," said Judge Sinclair in a recent charge to a Johnston county grand jury. The few words uttered by the judge in this instance carry a world of truth. If you will look carefully at the underlying causes of almost every accident you will find that but for the carelessness of someone the accident would not have happened.

Too often when somebody is killed in a highway accident the coroner's jury will return a verdict of "unavoidable accident" which is truly not the case at all. In making its findings in highway accidents the investigators should seek to learn whose carelessness was the cause and if it happens to be the party who was killed there should be no hesitancy in making the fact known in order that the other party or parties concerned might be absolutely exonerated, or if the accident was the carelessness of some person who was fortunate enough to escape death then action should be taken against that person.

Unavoidable accidents are as rare as the proverbial hen's teeth and when our people, motorists and pedestrians cease to be careless we will cease to have highway accidents.

 Barkley implied that the Supreme Court had blocked justice to farmers and labor he was speaking for the President.

In every way, by every device, it is the aim of the G.O.P. to show that the executive department is assailing the third arm of the government, seeking to disable or intimidate it so that laws demanded by farm and labor leaders can be enacted and executed in spite of the Supreme Court or outcries from the states.

Organized labor presses the New Deal. Farm organizations press it and threaten it. And if Senator Barkley is a true prophet the New Deal will respond by attempting to take over the powers of the states.

FATE: As experienced Washington observers see it, the main question of the campaign will be this: "Do the people wish to enlarge the power of the federal government at the expense of the states?"

Senator Barkley confessed, according to some interpretations, that the government is powerless to carry the New Deal to its objectives while the Constitution bars its path. Hence, unless the Supreme Court should change the Constitution must, if the new order is to prevail.

Fate sometimes settles tough problems. What if the personnel of the Supreme Court should be changed by fate so that rulings will be changed which will transfer vast powers from the states to the federal government? Current reports are that at least one of the eldest justices, a conservative, is on the verge of retirement. If his successor should hold with the recent minorities the course of the United States might be altered.

not be competitors. Sound radio is used not only as primary source of entertainment and education but also as background while reading working or playing bridge. Looking at television requires concentration. However, said Mr. Skinner, addition of daily television programs at certain hours should be important addition to home life of the American people.

The United States is not lagging behind in perfection of television. Skinner explained, but owing to larger area of country and lower density of population, problems of providing service are greater here than in Europe. He urged the commission to adopt the following television policies:

1. Establishment of single set television standard for the United States so that all receivers shall be capable of receiving signals of all transmitters.
2. Development of pictures free from distortion and blur, approaching ultimately distinctness and clarity obtainable in home movies.
3. Provision for services giving as near nation-wide coverage as possible so that benefits of television may be available in all sections of the country.
4. Provision for choice of programs, simultaneous broadcasting more than one television program in as many localities as possible to avoid monopoly, to provide variety

Television, we believe, is one of new businesses the country needs to create new jobs."

Much money will be spent for research and development despite millions of dollars already devoted this purpose by radio manufacturers, Skinner continued. Just as ten years were required before general public acceptance of car had developed, expected it will take sim-

ilar period television to come into general use in average American home within range of broadcasting stations.
