

## NEWTON BAKER HAILS LEGION AS 'GUARDIAN'

### Urges Ex-Soldiers To Watch Over American Principles

### COMMAND'R ASKS UNIVERS'L PEACE

### Thousands of American Legionnaires Gather at Cleveland for Annual Conclave

Cleveland, Sept. 21.—(AP)—Newton D. Baker, World War-time secretary of war, hailed the American legion today as "the guardian of American principle of liberty" in an international situation "that may fill the stoutest heart with concern."

Baker's address to the opening session of the legion's 18th national convention followed National Commander Ray Murphy's plea for universal peace, coupled with a warning that "America can not disarm in the light of existing conditions."

To thousands of legionnaires in colorful uniform, Baker described the rise of "strange philosophies" in other countries of the world and said "you will find your fellow-citizens looking more and more to you for guidance."

"The situation in the world at large," Baker said, "is one that may fill the stoutest heart with concern. There have grown up in the world strange philosophies different from any we have seen and they are mastering the minds and hearts of many men."

"There is scarcely a nation on the face of the earth at this hour that is not fearful of a renewal of conflict."

If the American legion has one mission above another it is to see that the principal of liberty of individual liberty is not surrendered in deference to any political expediency."

### Lets Brother Use Driver's License; Both Facing Trial

Columbus Baker, Pitt county negro, is charged with operating a motor vehicle without a proper driving license and with using that of another person and his brother, Lester Baker, is charged with allowing another person to drive his car knowing that the person did not have a permit and with allowing the person to use his license.

The warrants were sworn out by Patrolman C. R. Williams after he had stopped the pair and asked Columbus to show his driver's license. The officer said the driver told him his brother had his pocketbook with his license in it. The brother produced the license, but Patrolman Williams said a check showed that it belonged to Lester Baker and not his brother who was driving the car at the time.

While it is illegal for anyone to allow another person to use his permit, very few violations have been uncovered. The cases will be tried in County court here. Columbus stands to be punished for driving without a license and his brother stands to lose his license for allowing someone to drive his car knowing that the person did not have a license and also for allowing another person to use his permit.

## PLAN SPEEDED INSURE CROPS

### System of Insurance Suggested to Combat Droughts

Washington, Sept. 21.—(AP)—Acting under a mandate from President Roosevelt, officials speeded plans today for an "ever normal grainery" system of crop insurance and a long-time program designed to combat drought on the great plains.

Before departing from Washington last night to attend his mother's 82nd birthday party at Hyde Park, N. Y., the president announced the appointment of two committees to work out a permanent "drought and land use program" for submission to the next congress.

Secretary Wallace heads the new five-man committee to work out a plan of "all risk" crop insurance in cooperation with national farm organizations.

Morris L. Cooke, rural electrification administrator, was named chairman of a special committee of eight to report by January 1 on a "long term program for the efficient utilization of the resources of the great plains area."

In a letter to Wallace and the other members of his committee the president said:

"The government's long-time drought and land use program should be completed and put into operation at the earliest possible moment and immediate steps are to be taken with this objective."

## 968 Pitt Farmers Receive Payments From Government

### Checks Are For 1935 Cotton Ginning Certificates Which Were Not Used and Surrendered

Nine hundred and sixty-eight checks, totaling \$3,288.92 were received here today by R. R. Bennett, farm agent, for delivery to farmers who surrendered cotton ginning tickets to the Federal government.

Less than a thousand certificates were surrendered by Pitt farmers who did not produce as much cotton as they were allowed under the old Agricultural Administration.

Several of these were thrown out and the checks received here today are thought to be practically all that is due farmers in this county.

If a farmer had ginning certificates in excess of the amount of cotton he had, he turned them over to the Federal government, who in turn sold them to farmers in counties and states who did not have certificates equal to the amount of cotton produced.

Planters who surrendered the certificates were paid so much per pound for the amount of cotton each certificate represented.

All of the checks were small as none of the certificates surrendered called for any large amount of cotton.

## Auto-Train Wreck Fatal To Woman

Kinston, Sept. 21.—(AP)—Miss Bertha Gray was killed and Miss Willie Beard critically injured today when their automobile was struck by an Atlantic and North Carolina freight train at lines junction near here.

Miss Beard is an employee of Caswell training school. Witnesses said the car was dragged nearly 300 yards.

## MIDDLE MARTS OPEN TUESDAY

### Farmers in Belt Happy Over Good Price Prospects

Raleigh, Sept. 21.—(AP)—Farmers over the North Carolina middle belt were happy today at prospects for good prices for their tobacco when sales start tomorrow.

Warehouses at Durham, Lenoir, Carthage, Henderson, Fuquay Springs and Warrenton were filling.

From Oxford reports said farmers were expected to offer more than 750,000 pounds for opening sales.

Offerings of good quality were filling the floors of Sanford warehouses and reports said farmers in that area are expecting good prices.

An estimated 400,000 pounds were on warehouse floors at Henderson by noon today with thousands of pounds pouring in hourly.

R. B. Saunders, warehouse manager of Aberdeen, estimated 300,000 pounds would be sold on the market there tomorrow. Farmers in this section declared their crops were the best in years.

Experts at Durham indicated more than 1,000,000 pounds would be on warehouse floors by the time sales begin tomorrow.

The nine markets last year sold 107,985,145 pounds at an average price of 19.61 per pound.

## ANSWER MADE BY PUBLISHER

### One Thousand Word Statement Cabled from Amsterdam

New York, Sept. 21.—(AP)—William Randolph Hearst, 73-year-old operator of 25 newspapers, published today a "reply to the president" in which he said he had showed Mr. Roosevelt "the support of x x x enemies of the American system of government."

The thousand-word statement was cabled by the vacationing Hearst from Amsterdam a few after the White House in statement said "A certain notorious newspaper publisher" was attempting to "make it appear that the President passively accepts the support of alien organizations hostile to the American form of government."

The memorandum said "such articles are conceived in malice and born of political spite."

Hearst's reply followed his newspaper's publication of an article asserting Russia and the communist party of the United States were taking part in the presidential campaign "on the side of the New Deal."

The White House made no comment beyond its original statement, but Earl Browder, communist candidate for president said:

"The Hearst - London campaign must, indeed, be weakening if it needs such desperate lies to bolster it up."

## GOV. FUTRELL HAS PROPOSAL HELP TENANTS

### Suggests Way Be Provided To Purchase Small Farms

### PLAN INCLUDES EASY PAYMENTS

### Governor Says Home- Loving People Will Insure The Country Against Invasion

Hot Springs, Ark., Sept. 21.—(AP)—Governor J. M. Futrell proposed today that the federal government make it possible for the tenant to purchase small, highly productive land.

He told his farm tenancy commission that a home-owning, home-loving people "will give our country more real protection against foreign invasion and conquest than the expenditure of millions on our armies and navies."

The governor's address, prepared for delivery at the commission's first meeting, laid the groundwork for a study by the 57-member state body of the share-cropper problem.

While the two-day conference convened, a federal grand jury organized at Little Rock and prepared to take up on Wednesday charges that peonage exists in the turbulent eastern Arkansas share cropper belt.

Complete and an "illusion of tenancy is a dream," Futrell asserted. "We may as well bear in mind the fact that worthless people can not be helped. The ultimate end to be obtained is a substitution of farm owners or farm tenants as far as possible."

"The federal government must have a hand in carrying out a policy of enabling would-be-owners to purchase lands at reasonable prices and on terms which an industrious tenant farmer can meet while making a good living for himself and family."

## Emperor Selassie Rushes to Geneva To Protect Rights

### League of Nations Committee in Session to Decide if Ethiopia En- titled to Sit in Assembly

Geneva, Sept. 21.—(AP)—With Haile Selassie flying to Geneva in an attempt to protect the rights of his lost kingdom, a League of Nations credentials committee met today to decide whether Ethiopia still is entitled to sit on the league assembly.

The assembly itself adjourned to await the decisions of the committee, which most observers believed would be a majority vote against seating the Ethiopians on the ground Selassie no longer is a reigning sovereign.

Selassie left London by plane, suddenly abandoning his plan to come to Geneva by train tonight.

The opening session of the 17th assembly heard from Manuel Rivas Vicuna of Chile a fervent appeal to "avoid war at any cost."

## Landon to Uphold Crop Insurance In Speech Tomorrow

### Republican Presidential Nominee Declares Question Should Be Given Fullest Attention

Topeka, Sept. 21.—(AP)—Governor Alf M. Landon said today that "the question of crop insurance should be given the fullest attention."

The Republican presidential candidate took this position in a two-paragraph statement which he said was an excerpt from tomorrow's Des Moines farm speech. It was given to newsmen when they asked comment on President Roosevelt's announcement of the appointment of committees to work out a crop insurance plan leading to "better permanent protection against drought."

Landon said the speech excerpt would remain in his address tomorrow night. It follows:

"I am going to mention a subject that is in neither platform—crop insurance. It is a question in which we have long been interested in Kansas. In fact, some of our Republican leaders in farm legislation have been in the forefront in working on it."

"We realize that there are difficulties, but insurance companies are writing policies today covering risks that they did not consider feasible a few years ago. I believe that the question of crop insurance should be given the fullest attention."

## 1936 TAX RECEIPTS SHOWING BIG GAINS

Washington, Sept. 21.—(AP)—Increases in all but 14 of 68 classifications of federal taxes were shown today to have pushed internal revenue receipts for the first two months of this fiscal year \$75,000,000 over the corresponding 1935 period.

Receipts for July and August this year were set at \$542,352,774.75, compared with \$463,900,853.28 for the period a year ago. This increase occurred even though agricultural adjustment taxes, which provided \$23,000,000 in the two 1935 months,

were eliminated under a supreme court decision last January.

Largest receipts from a single levy were listed under the capital stock tax, with \$109,428,128.44 for the 1935 period, compared with \$85,380,056.30 in 1935.

Liquor tax receipts increased substantially being listed at \$111,927,807.44 and \$91,456,281.18 for the 1935 period 1936 and 1935 periods, respectively.

Aggregate tobacco receipts likewise pointed upward from \$88,334,427.56 to \$97,539,912.62.

## Two Seriously Hurt When Plane Crashes Near City

### E. F. Pullen Taken to the Rocky Mount Hospital

E. F. Pullen, who was seriously injured Saturday afternoon when the plane in which he was flying went into a tail-spin and crashed on the Eastern edge of this city, was removed to the Rocky Mount hospital this morning.

He was still considered in a serious condition when he was taken from the local hospital to one in his home town.

L. E. Ross, local aviation enthusiast, who was a passenger in the plane when it crashed, was said this afternoon by hospital attaches to be "holding his own." Considering the seriousness of his wounds, he was said to be getting along fine.

While no x-ray pictures were made here on Pullen to determine if he suffered a broken back, it was known that he was seriously injured and it was feared his back was broken.

Ross, suffered breaks to both his legs, one of them having been broken in three places. His hip was badly injured and his face seriously lacerated and broken. His nose is broken and his teeth were knocked out.

The plane in which the two men were riding crashed on the edge of a ditch in a cornfield behind John Rivers' Service Station in College View when it failed to come out of a tail spin.

The airplane is owned by R. E. Lee, who is affiliated with the Rocky Mount Airport. Lee bought the plane from the Woody brothers of Rocky Mount September 16, and at the time of the crash, according to a flyer from Rocky Mount, the plane was being demonstrated to Ross, who anticipated buying it.

The plane was almost completely demolished. This was the first airplane crash to occur in Pitt county in several years, and is considered one of the worst ever to occur in this section.

## Workers in Plant at Goldsboro Out On Wage Protest

### Borden Manufacturing Employees Demand Increase in Pay and Correction of "Stretch-Out"

Goldsboro, Sept. 21.—(AP)—A number of workers of the Borden Manufacturing company, a textile firm, walked out today protesting an alleged "stretch out" system and demanding higher pay.

A striker's committee said 100 of approximately 300 had joined the crusade, but the mill management said "15 to 25" were out.

A committee of strikers conferred with the mill management and reports said increases of from 24 to 30 cents an hour in wages and correction of "stretch out" were asked. The management was said to have replied it could not pay more now because the plant was not making money but had planned for increasing wages as soon as business justified.

## Father of Patrolman Is Claimed by Death

Corporal L. L. Jackson of the State Highway patrol and Mrs. Jackson attended the funeral in Mebane yesterday of V. M. Jackson, father of the patrolman, who died Friday night.

Mr. Jackson died suddenly as a result of a stroke of paralysis.

## REBEL FORCES NEAR MAQUEDA

### Fascists Continue To Drive Despite Efforts of Government Bombing Planes To Scatter Advancing Troops Moving near Vital Highway Junction Only 40 Miles from Madrid.

(By Associated Press)  
Government militiamen retreated today before a relentless charge of Moorish legionnaires on Maqueda, vital highway junction 40 miles from Madrid.

Thousands of other government soldiers, meanwhile, organized into bombing squads, surrounded the shell-leveled pleasure in Toledo for a decisive assault on the insurgents besieged in the ruins of the fortified palace.

The well-drilled Moors drove forward near to Maqueda behind a shield of machine-gun bullets which left bodies of government troops in their path.

Government bombing planes sought vainly to scatter the advancing fascists and General Jose Asensio, commander of all government troops in Central Spain, ordered hasty entrenchments dug for a pitched battle. A radio appeal summoned all government rescue to their barracks to await orders.

Insurgents in the Alcazar still sent a steady stream of machine-gun bullets and hand grenades from behind the dynamite-shattered walls. Government commanders, alarmed at the increasing death toll in their own ranks, ordered a "no quarter infantry charge."

A dispatch to the newspaper *Diario Noticias* in Lisbon, Portugal, said the Spanish government cruiser *Jaime I*, three destroyers and a submarine had hoisted a white flag off Tangier and had proceeded to insurgent-held Ceuta, Spanish Morocco.

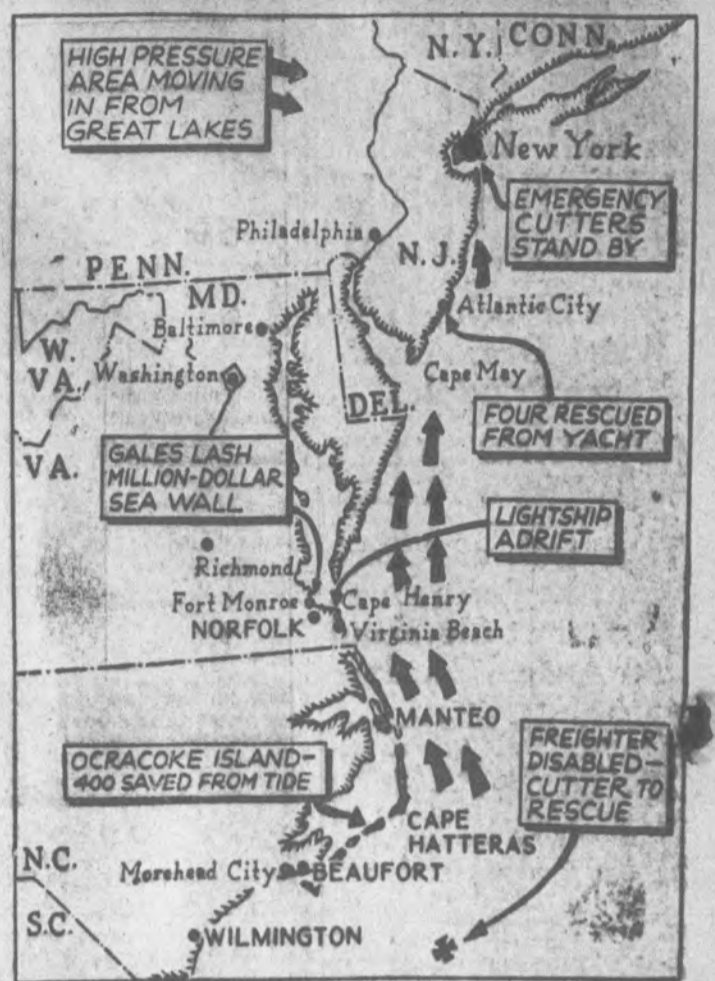

## LINT FARMERS GIVEN ADVICE

### Told It Would Be Folly To Flood The Market

Raleigh, Sept. 21.—Pointing out that North Carolina's estimated cotton crop of 556,000 bales is the smallest in more than a quarter of a century, M. G. Mann, general manager of the North Carolina Cotton Growers Cooperative Association, has warned farmers that "It is folly to dump your cotton on the market without regard for the highest price plus your full premiums for better grades and staples."

"With such a short crop starting in the face, far-sighted farmers certainly should strive to get every dollar they can for their cotton," Mr. Mann said. "This cannot be accomplished by 'dumping'."

Pointing out that approximately 75 per cent of the North Carolina crop is running 15-16 and better in length, Mr. Mann said that it is good business for the farmer to market his crop orderly and in a manner as to get the full premium for his better grades and staples.

"Our deliveries are running ahead of last year, and this in the face of

a short crop," Mr. Mann said. He attributed this increase in deliveries to the fact that thinking farmers are holding their cotton for higher prices which should result from a steadily increasing consumption by mills and an American crop this year of approximately two million bales below the 10-year average.

As another reason for the increase in deliveries, Mr. Mann cited the "Re-Purchase Pool" which was announced by the Cotton Association for the first time last year.

Under the "Re-Purchase Pool" plan a farmer can place his cotton with the Association where it will be classed according to Government standards. He can draw an advance of 75 per cent of its value upon delivery and when he is ready to sell he can ask the Association to quote him the highest price it can secure for his cotton. He can then ask his local buyer or cotton mill for a price, and if the price quoted on the outside is better than what the Association can offer, the farmer can get his identical cotton back and sell it to the one offering the most money.

"The 'Re-Purchase Pool' was tried out last year on a small scale to see if it would work and the results have been beyond all expectations," Mr. Mann said. "Out of more than 25,000 bales handled in this 'Re-Duke's' mentor.

Purchase Pool" of the 1935 crop, after furnishing the farmer the grades and staples of his cotton and the price we could obtain for him, and after the farmer, in many instances, had consulted the local buyers and obtained their prices, the Association has been requested to sell more than 90 per cent of the cotton on which it quoted a price. Even the few members who asked for their cotton back have told us they knew they received more by reason of having had their cotton graded by the Association.

"This is conclusive evidence that the Association can assist the farmer in getting the highest price for his cotton."

SWEDEN'S FARMERS

By ELMER W. PETERSON Stockholm, Sept. 21.—(AP)—Now and then a Swedish worker moves into a new little cottage, with a small cowshed and a piece of land—without paying down a penny for the privilege.

That sounds like a form of Utopia. It is, in reality, a part of the "workers' small holdings" movement—one of the most successful experiments in Sweden.

Today there are about 3,000 of these small holdings, with funds available for a further 2,500 for forest workers and others.

The plan is intended partly to relieve unemployment. It also is a gesture toward relief of the farm tenancy problem, with the stated object of "satisfying the social demand that the population of the country districts should be the owners of the land they till."

Loans Is Divided. Those aided by the movement have been forest workers and lumbermen subject to seasonal unemployment, along with agricultural laborers, fishermen and quarrymen.

The loans which make possible these small holdings are divided into two parts, the other permanent.

New York By JAMES McMULLIN ASSIGNMENT: Vice President John N. Garner came to Democratic National Headquarters in New York last week and indications are that he is going to stick around for a while. It is certain that he will take a far more active part in the campaign than he has hitherto.

New York sources close to the V. P. say that personally he would very much have preferred to stay home on the range. But the Democratic high command came to the conclusion that he would have to be drafted, and Jack responded to the call like the good party soldier he is.

Garner's special assignment will be to soothe business men and conservative Democrats generally. It is hoped that he will inspire enough confidence in such circles to win quite a few doubtful votes in key northern states for his chief.

RIGHT: A curious paradox lies behind the decision of the Democratic general staff to haul Mr. Garner out of his contented seclusion. Your correspondent has run into it on numerous occasions, and key men of both parties report that they encounter it frequently.

It amounts to this. Many a business man who has been a lifelong Democrat will, on the slightest provocation, shirk Roosevelt and his New Deal to shreds with vivid vocabularies. Yet these same harsh critics, asked if they do not view the possibility of Roosevelt's reelection with alarm, often snort a forcefully negative reply. They maintain with assurance that Roosevelt would turn definitely to the right in his second term and that therefore there is no real reason to worry about the Constitution, the federal budget or any other point on which conservatives take strong issue with the New Deal.

This contradictory viewpoint is sufficiently common among right wing Democrats to make it appear that plenty of worthwhile brands

may yet be plucked from the burning if the right people do the plucking. Jack Garner is rated one of the rightest for this mission.

SURPRISE: New York Republican leaders were enormously encouraged by the public turnout which greeted Alf Landon on his trip across the state last week.

Party chiefs of course mobilized their local organizations to make the best possible showing—but in several cases the crowds exceeded their fondest expectations.

Albany and Syracuse were good examples. The latter city, home of Clarence King—head of the Republican state executive committee—has an exceptionally efficient local party organization. Its corporals and sergeants were ordered to round up everybody they could at the railroad station. Assuming that they would do their stuff, Syracuse leaders looked for a gathering of about 8,000 at the meet. Instead, nearly 15,000 were interested enough in Landon to be on hand—a most gratifying surprise.

STATE: Plans are being completed for the New York Republican state convention. It has been settled that Colonel Frank Knox—vice presidential nominee—will be the number one speaker. This arrangement has so far been kept a carefully guarded secret.

Listed for the second most prominent spot on the program is District Attorney Martin W. Littleton, Jr. of Nassau County. He isn't very well known outside his own bailiwick, but insiders privately expect him to bring down the house. He is said to have inherited his father's remarkable oratorical talents.

Mr. Littleton is also being touted in worthwhile quarters as a possible dark horse nominee for governor in the event of a deadlock among the more obvious candidates.

CORDIAL: The following incident of Governor Landon's trip across upstate New York made quite an impression on those who witnessed it, although it did not get into print.

A rather nondescript group of Republicans—leaders of only minor importance—got aboard the

train at one station in the hope that the Governor would, at least receive them for a few minutes.

In due course this was arranged, and Mr. Landon entered the train where the group was eagerly awaiting him. With him was one of his chief lieutenants, who addressed the visitors as follows: "Gentlemen, the Governor is very glad to see you, and to greet you, but you will realize that he has had a hard trip and is very tired. He has done a great deal of handshaking in the past few days and I know you will excuse him if he doesn't greet you individually in that way."

At this point Mr. Landon interrupted by saying that this was nonsense, and immediately walked through the group shaking hands with everyone in it. The gesture was so spontaneous and cordial that it made a big hit.

# GOP ANXIOUS 'RIDE' DANIELS

## To Bring Race Issue Into Presidential Campaign

Reflector Bureau, Sir Walter Hotel. Raleigh, Sept. 21.—State Republicans say they are going to be able to use the race issue in politics without affront to the black man and with quite some embarrassment.

They will take their next text from the Democratic bible, the *Raleigh News and Observer*. They have run into the book before. For fully 25 of its 50 years they have met this race issue in state politics. The *Raleigh* paper which was wont in the old days to use red ink, nicknamed pokeberry juice, to emblazon the misconduct of the Republicans in their dealings with the black brother, now puts out the word that the Literary Digest presidential poll cannot be called complete until the negro and labor votes are counted.

Always the Democrats have seemed to get the bulk of labor's votes. The industrial centers seldom go Republican in North Carolina. High Point has been an occasional exception. But labor has had the state Democratic habit. Big business men generally have gone Democratic in the state. But Republicans declare that the former Democratic organ, the *Bible* of the party, says when the brother in black and his brother in overalls speak, there will be a new song in the Literary Digest.

Whatever embarrassments have been given to the *Raleigh* paper, it seldom has been caught with a black man on its back. It fought a great preacher in Raleigh 30-odd years ago because in a prayer meeting service he lambasted the white man for his treatment to the black man. In time the preacher packed up and left. It smote John Spencer Bassett, professor of history at Duke university, hip and thigh when he rated Booker Washington highest among southerners, Robert E. Lee excepted. It used pokeberry on Teddy Roosevelt for sitting to lunch in the White House with Booker T. Washington. It has assailed Wake and Raleigh politicians for soliciting negro votes against candidates in which the paper believes.

But now, say these Republicans, the organ which ground out such sweet music on race issue 30, 20, even two years ago, is playing new tunes. It always has doted on labor and hooks up the negro with the race cause. President Roosevelt will jar the Literary Digest when the black votes begin to come in. The Republicans swear they will go to town on that. For half a century they have had to endure abuse because the negroes generally voted for them. Now they grin a Billy Kerands over the *Raleigh* paper's proclamation that the negro vote will cause high blood pressure when the Digest peruses its own figures.

In that connection it is recalled that Democratic candidate William H. Smathers of New Jersey, counts on going to the senate of the United States over his Republican incumbent opponent. And the friendship of the negroes is the basis of that reasonable hope. This North Carolina man is considered by the New Jersey negroes a much better friend of their race than the senator who now represents New Jersey.

But that's New Jersey. North Carolina Republicans are doing research work to find some of the choicest epithets which Ambassador Joseph Daniels applied to them in the old days when they had inherited from the war the negro vote. The bright young sons of Mr. Daniels are running the paper, doing a good job of it, and incidentally, allowing the publication in their paper that Mr. Roosevelt is going to get the negro vote.

# TWO OFFICIALS GOING PLACES

## Ehringhaus and Bailey To Work For Party Ticket

Reflector Bureau, Sir Walter Hotel. Raleigh, Sept. 21.—Governor Ehringhaus and Senator Josiah William Bailey are going places this fall in the national campaign, according to Washington news, despite the repeated assaults on both.

The individual acts of Senator Bailey in the senate, some of which did not jibe with the presidential wishes, and the sundry mix-ups that Governor Ehringhaus had with Washington, nevertheless have turned neither against the success of the ticket. Senator Bailey thinks nothing could be more calamitous than the defeat of Roosevelt, and friends of Governor Ehringhaus declare that Governor Landon is due the presidency on his governorship of Kansas. Governor Ehringhaus might be accorded at least two successive terms or his record as North Carolina's executive.

Senator Bailey once led North Carolina into prohibition. He helped to dry a double score of places by legal option. When the state came to consider statewide prohibition he regarded it a mistake to dry places by state action that did not desire to be dried. He would wait. But when the party and the state chose to go dry by state vote he voted dry.

He took the same position in the nation. When the state had to vote in its legislature on ratification of the 18th amendment, he had to vote dry, but he did not believe that plan the best. He is very much in that mood today. Not all the Roosevelt acts suited him. Mr. Bailey is something of a partisan and a stickler for some of the old ways. But between Roosevelt and Landon he has no worries. He thinks the nation needs Roosevelt more than it did three years ago. And he can go out and tell the world about the President.

Governor Ehringhaus isn't often standing on a Bailey platform, but his excellency has no difficulty going passionately with Roosevelt. The Governor has found governing a vastly easier job in 1936 than it was in 1933. In the first year of Ehringhaus everything had to be slashed, in the last three is such a fine deficit that his political foe fly into a rage about it. And Washington likes to have Ehringhaus tell the public what Roosevelt has done. So much of the assault upon their position in recent campaigns can be explained by political exigencies of a campaign, but politicians do not see why it continues. The Republicans have a furious hatred for Senator Bailey. If they thought he is undermining the President they would not be violent toward Bailey.

But both men will be called into the national campaign and will be sent to sundry states. Both have had their assignments at earlier times, but President Roosevelt and Chairman Farley like the way they sun up the issues. There is some regret that these poor politicians do not understand the North Carolina pair.

North Carolina's 20 superior court judges are now re-enforced by four special and four emergency superior court judges. They send five times as much work for review in Raleigh as came here 20 years ago.

Incidentally, there is not alive now a judge who was on that bench in 1916, and two justices have died in the service within the past three years.

MIDWEST GAME THRIVES ON DROUGHT AND 'HOPPERS'

Pratt, Kas.—(AP)—The grasshoppers and drought, hard as they have been on crops, were a boon to the game supply in the opinion of Dan Ramey, state game supervisor. 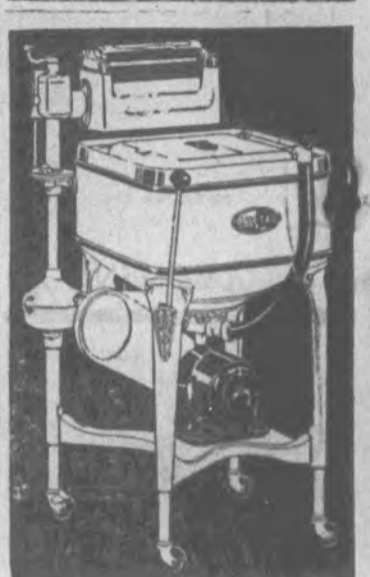
