Washington, Oct. 5.—(AP)—For the first time in many weeks, there appeared today some prospects that the schism in the American Federation of Labor might be healed before it becomes irremediable.

Tentative talk of a possible basis for peace was heard on the eve of the quarterly meeting of the executive council of the American Federation of Labor, a meeting at which the split of the labor organization is expected to be a major topic of conversation.

New York

LEADERSHIP: Was effective collaboration among nearly all of New York's leading banks and bankers last week when fancy speculative operations and a shortage of franc exchange threatened to make a hopeless hash of legitimate commercial settlements. It was on their initiative that Federal Reserve and Treasury authorities sought French assistance and gave their own in ending a ridiculously artificial tie-up.

But disgruntled financial muckster in their beards that the tangle would never have developed in the first place if the Treasury and the Federal Reserve chiefs had been alert to speculative machinations. There is art counter-attack of the record—that government agencies were sound asleep at the switch and had to be prodded into action by the despised private bankers.

What impressed insiders most was that the big New York institutions—despite the bitterness of the Harriman rift—really could get together and exert constructive leadership in an emergency. It's the first time they have done that in years.

RECEPTIVE: Steel leaders are privately worried about the rapid progress John Lewis' recruiting agents have made in recent weeks. The Committee for Industrial Organization has deliberately shunned the spotlight, but it field organizers have been very much on the job.

A few weeks ago the industry's moguls were confident that their company unions would stand firm against the blandishments of "outsiders." Now there are alarming indications to the contrary. Furthermore, the atmosphere of unrest is beginning to affect almost all of the important steel companies to some degree.

Widespread receptiveness to unionizing overtures dates from the refusal of Grant higher wage demands made by employee representatives of Carnegie Illinois—a subsidiary of U. S. Steel. There is evidence that a great many steel workers interpreted that turnout as proof that they couldn't hope to realize their aims under existing conditions, and that the only thing left for them to do was to join the Lewis forces.

ERROR: The blunt rejection was founded on the overconfident premise that the Lewis outfit would lie low until after election in order not to jeopardize Mr. Roosevelt's chances

UPHOLDS RULE ON AGE LIMIT

School Commission Head Says It Best For Children

Reflector Bureau.
Sir Walter Hotel.

Raleigh, Oct. 5.—The reason the State School Commission decided that no children would be admitted to the first grade this year if they became six years old after October 1 was because the commission felt it was better for the children and would help to reduce the number of "repeaters" in the first grade. Lloyd Griffin, executive secretary of the school commission said today.

The decision was not dictated by any belief that economy would result from it, on the assumption that fewer first grade teachers would be required, since a corresponding increase in the number of teachers will be needed next year, Griffin said.

"The decision of the board to limit the first grade enrollment only to children who would become six years old by October 1 was entirely because past school records showed that children under six years old do not make as good records as those six and older and because these same records showed an unusually large number of repeaters among the children who had started to school before they were six years old," Griffin said.

"Still another factor taken into consideration was the fact that with only seven elementary grades, children entering into high school at an age of 14 or 15 is not a good thing. So the commission, after consulting with educational leaders, felt it would be doing a real service to both children and parents by fixing the age of entry date so that the majority of children entering the first grade this year would be six years old when they started to school.

"There are undoubtedly cases where children who are only five or five-and-a-half years old could do first grade work, but they are exceptional. It is also a fact that these children will do still better work when they are six years old and make a consistently better record in all the other grades as a result of being a year older. When the parents understand the reasons for this decision, we are confident most of them will agree with us that it is better to exclude the younger children from school until they are six years old and better able to do the work."

How's Your Health?

Man and Food
In the early part of the last century the German philosopher Ludwig Feuerbach enunciated the famous phrase, "Man is what he eats." In the German a clever word play, "Der Mensch ist, was er isst." Philosophically the concept is rather thin, but physiologically it is a profound, though almost self-evident, statement. The latest developed science of nutrition is one of the most romantic and inspiring chapters in medical history. It is replete with hope for the future welfare of mankind.

No phase of medicine escapes the influence of nutrition. Medically, man, in health and disease, is indeed what he eats. While a man may be sick, though well nourished, he can hardly be considered well when badly nourished. Good nutrition does not require meticulous attention to numerous details of dieting. A little knowledge of fundamentals, some attention to the choice of foods and their preparation, and good nutrition can be attained. The foodstuffs should include good whole cereal grain, milk and its products, eggs, green leafy and root vegetables, legumes, fruit, meat and water. Simple! But it is disconcerting to see how few individuals will grasp and apply these simple nutritional facts.

On the negative side, nutritional deficiencies have numerous injurious effects. The glands of internal secretion and the nervous system suffer, as the thyroid gland does when iodine is lacking in the diet, and the sympathetic nervous system when there is a calcium deficiency. Rickets and softening of the bones arise from nutritional defects. Here we may consider the far-reaching effects of the consequent abnormal development of the bones (notably of the pelvis) on childbirth. A narrow or distorted pelvis renders normal parturition difficult or impossible.

The lack of certain food elements, notably fat, mineral elements and vitamins, influences fertility. When of a marked degree, this lack is responsible for sterility. In surgery, the effects of bad nutrition are evident in delay of healing in wounds and bone fractures. In neurology and in psychiatry, we find the nerve changes associated with the nutritional diseases, pellagra, pernicious anemia, and the nerve inflammation due to a lack of vitamin B. The lowering of resistance to bacterial infection, due to a want of vitamin A, is seen in the disease of the respiratory system, the nose and throat, and kidneys—all of which and more, can be appreciably prevented by good nutrition.

Raleigh, Oct. 5.—The Democratic campaign is gaining momentum daily in North Carolina, especially since the speeches by President Roosevelt in Albany Tuesday night and in Pittsburgh last night. Chairman J. Wallace Winborne of the State Democratic Executive Committee said today. The aggressive, fighting spirit shown by the President in his first campaign speeches is putting fresh vigor and enthusiasm into the Democratic workers here in North Carolina and encouraging them to put even more drive into their efforts, said Winborne.

"The manner in which President Roosevelt is carrying the fight to the enemy instead of waiting for the enemy to bring the fight to him, is already proving of great help to us and to the Democratic workers in every section of the country," Chairman Winborne said. "This aggressiveness on the part of the President and the pep and enthusiasm he is putting into his speeches, together with the clarity and incisiveness with which he is outlining the record and accomplishments of his administration, is proving very effective. The manner in which he pointed out that he is still fighting for the same things for which E. A. Smith and Senator Wagner started fighting for in New York in 1911, even though Smith and Wagner have ceased fighting, proved very telling, in my opinion. Penalty Provided By Statutes For Dynamiting Fish

Practice Said To Be One of Most Flagrant and Wasteful Violations of Conservation Laws

Raleigh, Oct. 5.—Dynamiting fish is one of the most flagrant and wasteful violations of conservation laws and game protectors throughout North Carolina are directing vigorous efforts toward eliminating such offenses. J. D. Chalk, State game and inland fisheries commissioner, said today.

An outstanding example of the vigor with which protectors are going after dynamiters of fish was cited by Mr. Chalk in Johnston county, where three prosecutions were conducted recently on this charge. The three defendants were found guilty and a fine of \$100 with costs of \$23.50 were levied against each defendant. Mr. Chalk believes that heavy fines of this nature will have a wholesome effect on checking possible future violations.

Commending E. P. Keen, game protector of Johnston county, Mr. Chalk wrote "I wish to congratulate you on your success in convicting the three parties who dynamited in Stone's Creek. This is one of the few dynamiting cases we have had this year. Most of the dynamiting has been done in the past in the streams of Western North Carolina but fires of \$150 and up with costs have put a stop to it and the kind of fines these defendants got, I am sure, will make an impression."

Besides being most unsportsmanlike, dynamiting fish, according to the commissioner, is needless destruction of virtually all fish life in the area affected. Young fish that can be of no value to the dynamiter, as well as all other fish are destroyed in this manner, he pointed out. The sight of wasted fish life in surrounding waters following an explosion should be sufficient, he said, to convince anyone of the evils of such a practice.
