Chief Executive Points To Improvement During Present Administration

Opens Ohio Campaign Before Rain-Drenched Thousands

SAYS SECURITY IS A NECESSITY

Recalls Unemployment Situation Three Years Ago and Says Something Had To Be Done

Cincinnati, Oct. 16.—(AP)—Opening his Ohio campaign before rain-drenched thousands in the University of Cincinnati stadium, President Roosevelt said today he had seen "tremendous improvement" over the country and the administration was planning for the "future security of the country."

"I don't mean just a living, just having enough to eat and a place to live in," he said. "I mean a living providing a decent diet, education, and a reasonable amount of leisure."

He said he was inclined to think that on November 3rd a decision would be made on whether "we shall continue to work for a greater security and a greater human happiness."

"I am not the least bit worried about the result," he added. "Security," he said, "ought to apply not only to individuals but also to occupation and business."

"That," he added, "is why the administration is trying to make a rounded picture, and work out something that will affect every kind of business."

He said he thought the audience understood why the government had helped with work projects. Three years ago, he said, the employment situation was so serious that "something had to be done and the question arose of finding the best kind of work to provide for the needy."

The question was put up to cities and local communities and they recommended the projects to the government, he said.

"And you know," he said, as he roared up from the crowd, "that this aided very much in the national recovery we've had in the last three years."

\$50,000 In Damage Sought As Result Of Hotel Slaying

Administrator of the Estate of Helen Clevenger Seeks Sum From Battery Park Hotel.

Asheville, Oct. 16.—(AP)—The murder three months ago of Helen Clevenger, blonde, 18-year-old college girl, was the basis today of a \$50,000 damage suit against the fashionable resort hotel in which the crime was committed.

As administrator of the estate, C. B. Clevenger, uncle of the New York university honor student, filed the action here against the Battery Park hotel charging that its negligence was "directly responsible" for her death.

Martin Moore, negro hallboy at the hotel, was convicted and sentenced to die for the crime. His case is now in the Supreme court on an appeal. He said he went to the girl's room to loot it and finding it occupied became panicky and shot her.

The complaint charged that the hotel "permitted a secluded back entrance to the hotel to remain open and unguarded" the night of the murder "in such a way as to constitute an invitation to intruders and persons with evil intent to enter."

The complain also set forth that the hotel failed properly to guard the halls and entrances and that on July 15, the night of the slaying, the night watchman did not visit the second floor, where Miss Clevenger had a room, for more than two hours.

ROBERT DAVIS ESTATE LARGE

Will Filed Here Reveals Number Personal Bequests

The will of the late Robert Lang Davis of Farmville has been filed in the offices of the Clerk of Court here showing a number of charitable bequests as well as the division of the bulk of the property among his nieces and nephews.

The exact value of the estate has not been determined as holdings are being checked under the direction of the clerk of court, as prescribed by law. It was estimated that the total par value of the estate, however, would be about \$1,500,000 or \$2,000,000, much of which is in land.

In addition to the real estate property, a large amount is in negotiable bonds and notes.

The largest single bequest was a \$100,000 trust fund provided for the "very poor and needy" of Farmville, a five mile radius of the town and for persons living on the farms of the late Mr. Davis.

At the expiration of 25 years the fund is to be turned over to the town of Farmville to be used as a permanent endowment for the poor and needy. The will stipulates that if Dr. P. Marion Davis, nephew of the deceased Mr. Davis, deems it wise to construct a hospital in Farmville, not more than half of the sum be used in constructing and equipping the institution, with the balance to be retained in trust to be used to defray expenses of those unable to provide hospital care and doctors' services for themselves.

A number of churches also were provided for in the will. The Farmville Primitive Baptist church built sometime ago by Mr. Davis, was awarded a \$5,000 trust fund, as well as a lot. The Tyson and Meadow Primitive Baptist churches each were awarded \$2,500.

Personal bequests provided in the will included the following beneficiaries, the amount ranging from \$500 down to \$10: Manley Liles, D. E. Ogleby, DeWitt Allen, G. E. Ballew, Fred Davis, J. L. Little of Greenville, Mammie Hines and sister, Mrs. Sheppard of Wilson, Lucy Davis, Dr. Annie Joyner, C. A. Lilley, Lynn Davis, Ben. Mewborn, Mrs. Blanche Paschall, Miss Neva Owens Shade Webber and Marcellus Bryant.

At the conclusion of the will Mr. Davis wrote: "My sincere wish and earnest recommendation is that accounts be accurately kept x x x that all debts and taxes be promptly paid, x x x and I do further advise my nieces and nephews to live soberly, honestly and humbly; do not squander that which I have left you; and leave off fast living."

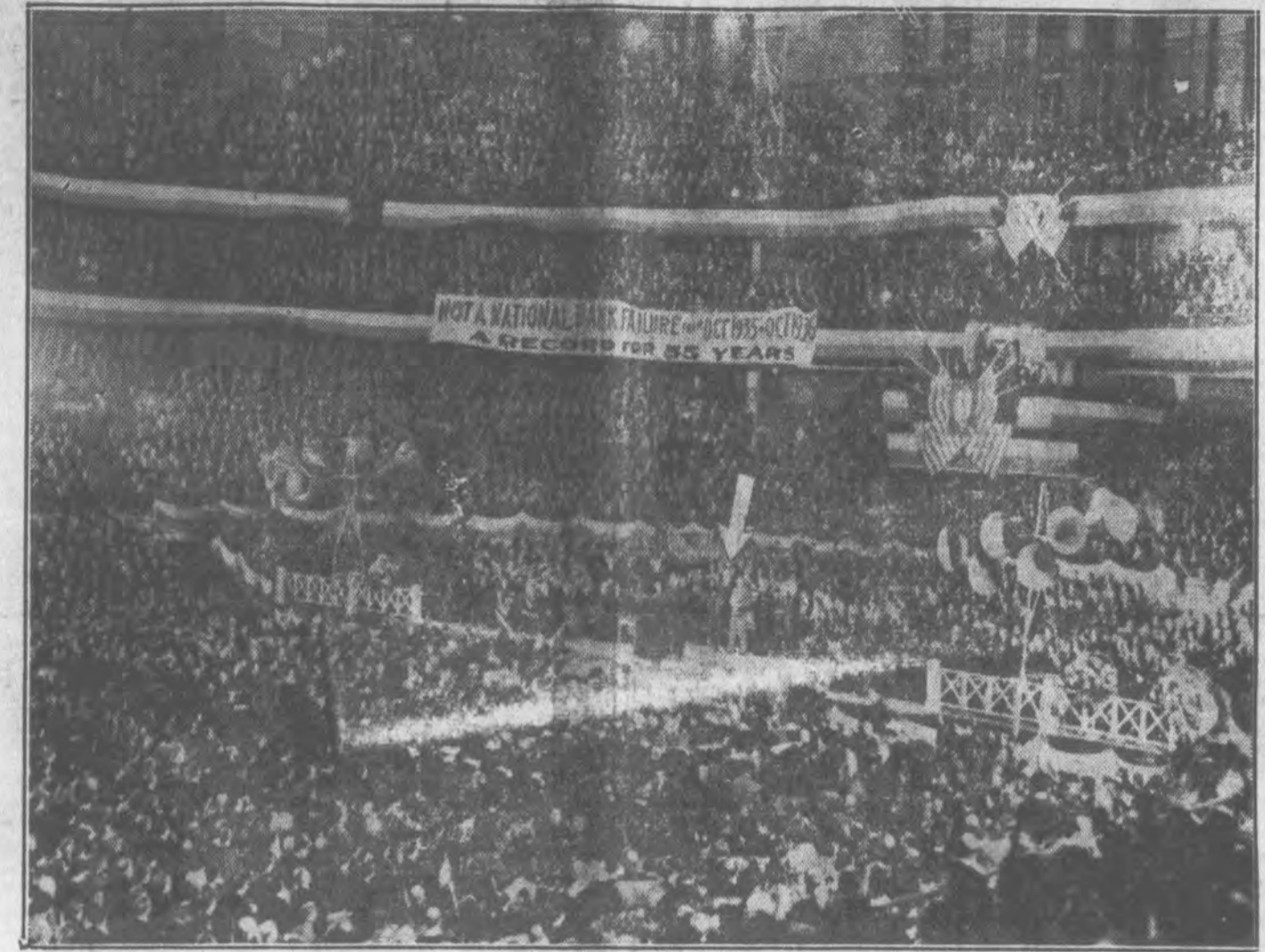

Roosevelt Presses Drive In Pivotal State Of Ohio

Seven Speeches on President's Schedule as Follow Up to Major Address in Detroit; Landon Plans Dash to California

(By Associated Press) While President Roosevelt pressed his drive into the pivotal state of Ohio today, Governor Landon announced surprise plans for a dash to California.

Seven more speeches were on Mr. Roosevelt's program today as followed up to a major address in which he said at Detroit last night that many manufacturers "must be planning, do far more than they have done to increase the yearly earnings of those who work for them."

Back in Topeka after his Lake states tour, Landon said he was going to speak in Los Angeles next Tuesday, expressing confidence that he would carry California. Yesterday he told Illinois farmers that New Deal spokesmen "are insidiously attacking the doctrine of the meretricious and of an independent judiciary."

Speakers Warn Attorneys of Bureaucratic Rule

Raleigh, Oct. 16.—(AP)—Col. O. R. McGuire, general counsel to the Comptroller General of the United States, and Frederick H. Stinchfield of Minneapolis, president of the American Bar Association, warned lawyers of North Carolina today that bureaucratic government in the United States threatens the rights and liberties of its citizens.

"The inevitable result and the practical consequences of our existing bureaucratic hopefulness of numerous governmental agencies, Colonel McGuire said, "has been summarized in a recent publication of the institute of government research, a privately endowed, non-partisan research organization as follows:

"So great is the complexity, that not merely the ordinary citizen seeking to protect his rights, but even a competent lawyer practicing in federal administrative and constitutional law can scarcely find his way through the jungle. Many agents of the government itself, sometimes the actual authorities who must make quasi-judicial decisions are uncertain and bewildered concerning these matters.

WEEK'S SALES AVERAGE 27.05

Highest Weekly Mark Struck During Current Season

The highest weekly average of the Greenville tobacco market, and what is thought to be the highest for the belt, was struck on the local market this week when 5,319,626 pounds were sold for \$1,438,831.65, an average of \$27.05.

The average for the week surpasses by far any mark struck this season and brought the season's average up to \$23.21, as compared with an average much lower during the earlier part of the season.

Yesterday's offerings of 874,352 pounds brought \$23,064.75, an average of \$26.54.

So far this season 28,162,833 pounds have been sold here for \$65,756.12, an average of \$23.21.

This year's season average compared with \$19.89 up to this time last year, when 33,109,414 pounds had been sold for \$65,872.63.

The figures show that while 5,000,000 more pounds had been sold up to this date in 1935, only about \$56,000 more money had been paid for the much larger crop than has been paid for the 1936 crop this year.

The \$27.05 average for the week compared with an average of \$23.70 during the corresponding period a year ago, when 4,511,060 pounds were sold for \$1,079,241.50.

Any comparison of this year's figures with those of last year shows the market much stronger for the present season, with the exception of smaller offerings, caused by the much shorter crop.

Raleigh, Oct. 16.—On a lot of second quality lemon wrappers sold for \$1 per pound yesterday on either the Goldsboro or Farmville tobacco markets.

The tobacco market news service reported the sale today in its joint report on officially inspected tobacco sold at the two places, but did not show which had it.

Orange leaf second quality averaged \$38; third \$33; fourth \$21.50 and fifth \$11 yesterday on the market. Smoking leaf first quality was \$43, second \$39, third \$32, fourth \$23.50 and sixth \$7.50; while fourth third quality went at \$42, fourth at \$39 and fifth at \$38. Lugs first grade averaged \$36, second \$30, third \$20 and fourth \$11.50.

Peasants Place Entanglement 20 Miles of Capital City

REBELS ADVANCE THROUGH MUD

Extreme Socialist Premier Assumes Command of War Ministry

(By Associated Press) Peasants of Spain, impressed by the Madrid high command threw up barbed wire entanglements within 20 miles of the capital today to stop a surge of fascist soldiers.

The peasants' squadrons worked feverishly to string the barricades; socialist militiamen poured into the trenches; and the newspaper voices of the left front government warned: "the situation is delicate."

At the same time Moscow speculated as to whether Dictator Joseph Stalin's message to Spanish communists, telling them the Soviets are giving them "every assistance in their power" foreshadowed an early open break with the international neutrality convention.

At the war ministry, Premier Francisco Largo Caballero, extreme socialist, assumed personal supreme command today. Reports to his desk said every officer of the Republican command had been slaughtered in the retreat from the Alberche river.

Food and warm clothing in the capital was scarce, although the situation was helped somewhat by relief funds from Russia.

Sliding through mud, the fascist advanced their battle front west of Madrid an average of 10 miles, snatching 16 mountain villages in their stride. On the main Madrid-Barcelona highway the strategic town of Navacerrada was but a few miles from the fascist trap.

Washington, Oct. 16.—(AP)—A proposal to establish a coast guard air station on the Atlantic coast between existing stations at Cape May, N. J. and Charleston, S. C. was before the budget bureau today for consideration as a recommendation to the next congress.

The coast guard asked the bureau to consider an item for the proposed new station and to include it in the coast guard's budget recommendation to congress.

Although the amount requested was not disclosed, coast guard officials said an air station such as was proposed would cost approximately \$500,000.

Consideration of a site, it was said, would not be undertaken until funds for construction were assured.

However, if the station is authorized it probably will be located some where on the North Carolina coast it was said.

A number of localities in North Carolina already are actively working for the proposed station.

Among these are Elizabeth City, Wilmington, Southport, Morehead City and New Bern.

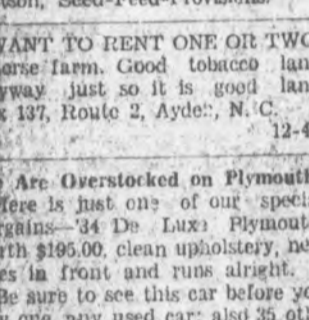

finance Corporation. With the exception of low interest loans to promote mortgage and railroad operations, and perhaps some loans on commodities, Mr. Jones thinks the lending authority of RFC may be safely permitted to expire January 31st.

Much legislation during present administration has created new and costly bureaus—divisions—groups. A tendency to make new agencies permanent may cause a fight in Congress. The CCC camps are now on the permanent budget, and Prof. Tugwell asks that his Resettlement Administration be put there.

Jesse Jones' statement may embarrass Pres. Roosevelt (if reelected) in proposing new legislation.

STATUS: Senator Byrd of Virginia still hopes to bring forth a program for consolidation of federal bureaus which will work for economy and greater efficiency. Everybody agrees that such moves would accomplish both of these ends, but hardly anybody expects to see the work done. Bureaucracy opposes consolidations which reduce the number of jobs.

Lip service is paid to consolidations by lawmakers who haven't the slightest intention of permitting the plans to go through. These sessions have constituted on this payroll, especially in agencies where civil service is ignored.

Scores of thousands of clerks are serving in emergency agencies, appointed by members of Congress.

Instead of merging or abolishing superfluous agencies the tendency is to press for a change in the status from emergency to permanent, and to place political appointees under civil service so that they cannot be removed.

OPPOSITION: Another strong factor that stands in the way of bureau consolidations is the jealousy of department heads.

An example of this was given by Secretary Ickes and Secretary Wallace at the last session of Congress. Ickes wanted his department name changed from "Interior" to "Conservation," and his bill provided for transfer of certain conservation bureaus to his department. Secretary Wallace promptly objected, and his influence was strong enough to pigeon-hole the Ickes bill.

Another effort will be made to jump all conservation activities in the Interior Department. This will be stubbornly opposed by Wallace and his bureau chieftains. They think that conservation is so linked up with agriculture that jurisdiction over both should remain in the Agriculture Department and maintain its powers.

UNTIED: A year ago an appeal from Dr. Townsend to his followers to support the G. O. P. candidate for President would have been regarded as a powerful lift. Whether it will help Landon as much now is questioned.

In states where the Lemke ruse cannot appear on the ballot, Dr. Townsend asks his supporters to vote for Landon. Some politicians believe this will make a decided difference in the vote in Landon's favor, but they also suggest that Townsend seems to have lost much ground in the same states.

The vote in Maine and in several important primaries indicate that the Townsend movement has less effect upon the presidential con-

district fights. Townsends appear to be pretty independent when it comes to making a presidential choice.

New York By JAMES McMULLIN VOLUNTEERS: Quite a few New York financial and industrial organizations are taking unusual interest this year in whether or not their employes vote.

Of course this interest is officially non-partisan. But just the same the impression has gotten across to a large number of white collar workers that it would be advisable for them to be in the political fashion. They have been made aware that their employes regard the defeat of Roosevelt as an almost sacred cause.

In some cases, the idea has been deftly conveyed to white collar people that they will be furthering their personal future careers by demonstrating praiseworthy political activity. Naturally it has to be pro-Landon to be praiseworthy.

In this way industry and finance are stimulating voluntary organization work in support of the Republican campaign which will at least partly offset the pitiful weakness of the party's county organizations. This is a practical contribution of considerable value. In previous campaigns, the efforts of volunteers have been piecemeal stuff compared to the smooth functioning of professional political machines. Not so this time.

READY: The third quarter statements of the largest New York banks showed that they all reduced their holdings of government securities between June 30 and September 30. Furthermore, although there was a slight rise in loans and discounts, nearly all of the proceeds of the sale of governments were kept in cash.

For more than two years bankers have been yelling their heads off about how New Deal spending was ruining federal credit—and yet the banks have kept on buying more and more government securities. Also they have issued warning after warning about the dangers of impending inflation. Now it looks—on the surface—as if they had at last decided to take their own warnings seriously.

But like so many obvious explanations, this isn't the true one. There is no slamm whatever in high financial quarters about the soundness of federal credit as government finances stand now. The real point to selling governments is this. Recovery is so firmly established that even the most conservative bankers can look forward to rapid expansion of private credit on a sound basis in the near future. This type of business will offer a much more profitable return to banks than the very low-yield governments they have been carrying. And they do feel they have had too large a proportion of the latter in their investment portfolios. So they are converting a small percentage of their federal securities into cash in order to be ready to take instant advantage of the new business opportunities they expect to meet up with shortly.

DIVERTED: Informed New Yorkers understand that Louis Johnson of West Virginia—ex-paternal commander of the American Legion who is now in charge of veterans' activities for the Democratic national committee—has his eye on Frank Hines' job as administrator of the Veterans Bureau.

Keen observers comment that it was smart politically to leave the Republican Hines unmolested in his post, all through this Democratic administration—to date. The head of the Veterans Bureau is inevitably the target for a lot of discontent, and it comes in handy during a campaign as 'hot as this one to have at least a portion of the discontent diverted from the usual attack on the party in power.

FORESIGHT: Tens of thousands of acres of southern pines have been quietly bought up since Dr. Charles H. Herty of Savannah developed a method two years ago of making newsprint out of all grades of these trees. Dr. Herty's recent discovery of fat in pines—opening up new commercial possibilities for bond and book paper, soap, paint and rayon from southern forests—should greatly enhance the value of these holdings.

News behind the news is the keen interest the United States government is privately showing in just who has taken up all this land. The newsprint angle is important, because hitherto about 65 per cent of all newsprint consumed in this country has been produced in Canada, mostly in mills controlled by British capital.

The British are traditionally foresighted about public matters. It would be nothing new for them to be picking up sources of potential competition for a song while said sources are still young, beautiful—and undeveloped.

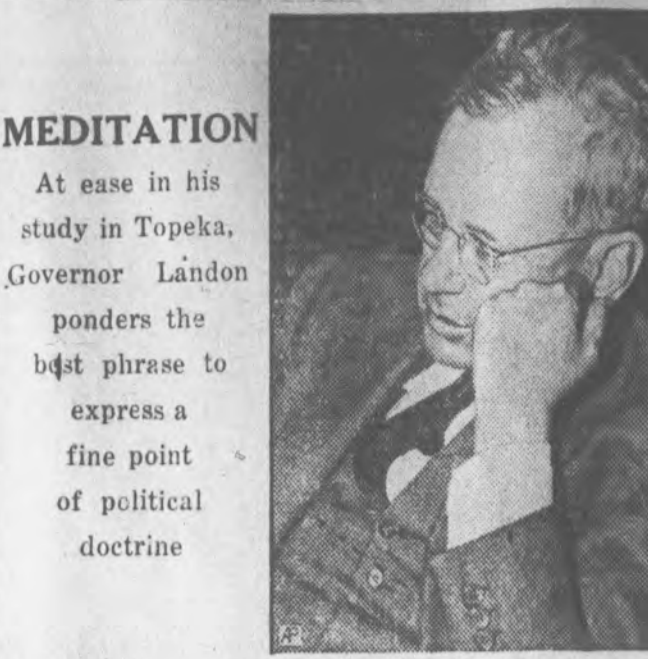
FORTUNATE: An outstanding southern banker with a national reputation remarks that bankers will never again rate the utilities a really worth-while investment field unless the latter can reach some sort of agreement with the government.

Of course if such an understanding is reached it will alter the picture completely and revive a genuine investment demand for utility securities. From this angle the attitude of Wendell L. Wilkie—head of Commonwealth and Southern—is important.

Mr. Wilkie happens to be directly under the guns. His company is the one most affected by TVA competition, and he is the one big-time utility leader invited to participate in power pooling conferences with representatives of the government. He is all in favor of realistic, peaceful and reasonable settlement of the disputes between public and

HOEY ENTHUSIASTIC OVER PROSPECTS FOR BIG VOTE

(Continued from Page One) that those Republicans who have been spreading it abroad that North Carolina might go for Landon are utterly ignorant of the real sentiment of the people in the state. We want to blast wide open the illusion that some Republicans have especially in other states, that because North Carolina went for Hoover in 1928 there is a possibility for it to give a majority to a Republican candidate for president again. "But in order to make the other states and especially the Republican National Committee sit up and take notice, it is going to be necessary for

every Democrat in the state, both men and women, to vote in this election so as to make the Democratic majority for both the state and national ticket so overwhelming that the Republicans will not only admit defeat now but lose hope for the future. I am confident, however, that this is going to happen.

"I have already been in most of the western counties, as well as in some of the eastern ones and I have never seen the Democrats so well organized or as enthusiastic as they are now. There is no doubt that Chairman Winborne and his assistants in Democratic Headquarters here have been doing a splendid job and are getting real results. During the past week or ten days I have made speeches in Polk, Macon, Graham, Transylvania, and Henderson counties and have visited Cherokee, Clay, Jackson, Watauga, Alleghany, Ashe and Yadkin counties and was delighted at the in them, despite the fact that many interest and enthusiasm I found of these counties in the past have either been regarded as Republican counties or as very close.

# SPOTLIGHT ON GRID BATTLES

## Football Again To Push Politics In Background

Raleigh, Oct. 16.—Football will again temporarily push politics out of the spotlight here tomorrow, with interest centering especially in the Duke-Georgia Tech game at Duke and the Carolina-New York University game in New York City, although all the State College boosters are much interested in the State College-Furman University game here tomorrow night and hoping that State will at last break its losing streak and start on a long-delayed winning streak for a change.

The "dope" now going around the State College campus and among States devotees here in Raleigh is that the team has at last hit its stride and will win the next four games, including the one with Furman tomorrow night.

Chief interest in most circles here this week-end is in the Duke-Georgia Tech game, however, and indications are that most of the state officials and employes who can take the price of a ticket and can get to Durham will be present in the Duke stadium when the whistle blows Saturday afternoon.

Betting is not heavy on the game but a slight majority are inclined to favor Duke, although almost everyone agrees the game is likely to be very close and one of the hardest in which Duke will participate this year. Since there is not much bet for Georgia Tech among either the State or Carolina boosters, most of them are pulling for Duke over Tech in this game.

Another factor of interest in the Duke-Tech game is that it will be a contest between two teams operating under widely different points of view towards the subsidization of players. Georgia Tech is in the Southeastern Conference, in which the open subsidization and employes of football players is officially approved and permitted, while Duke is a member of the Southern Conference, governed by the so-called "Graham Plan" which is supposed to prohibit the subsidization of football players in any way and is regarded as representing the opposite extreme from the Southeastern Conference plan.

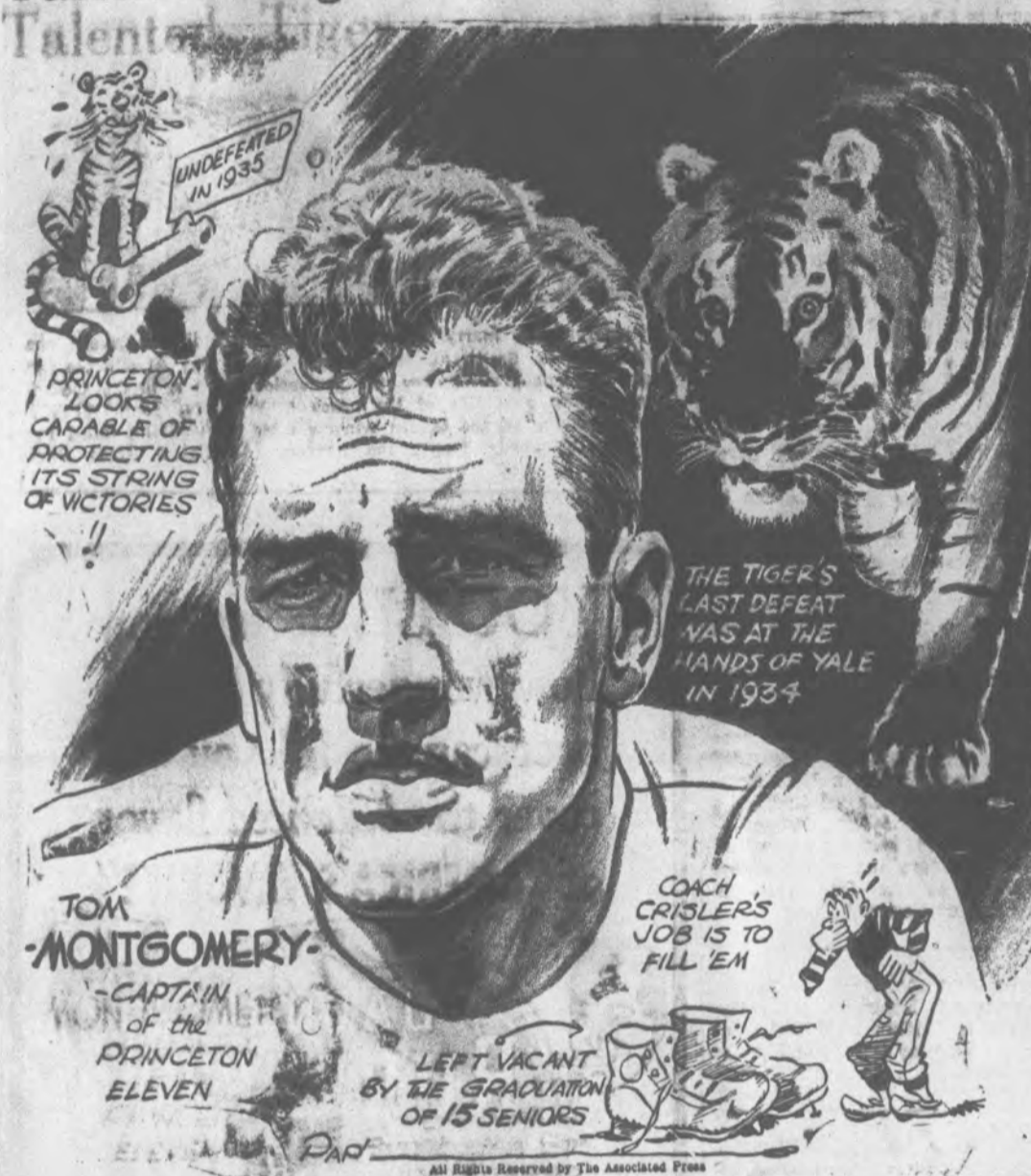

## HELPS ISLAND TO GET POWER

### State Electrification Body Works Out Loan Details

Reflector Bureau, Sir Walter Hotel.

Raleigh, Oct. 15.—The North Carolina Rural Electrification Authority is now working out the details of an application for a loan from the Rural Electrification Administration in Washington to provide electric service for the residents of Harker's Island, in Carteret county, some ten miles up Core Sound from Beaufort, it was learned today from officials of the NCREA. A survey of Harker's Island as completed a number of weeks ago by the state REA which showed that 100 of the 125 odd families on the island would use electricity and sign up as customers if a line should be built over to the island, which is about two miles from the mainland.

Three plans are understood to be under consideration for providing

electric service to the island, it is pointed out here, as follows:

1. To form a cooperative and borrow enough money from the REA in Washington to build a transmission line from the mainland to the island and about four miles of lines on the island, or about six miles in all.

2. To form a cooperative and borrow enough money to set up a generating plant and distribution system on the island.

3. To induce the Tidewater Power Company to build a transmission line to the island and provide service.

At first it was thought that the Tidewater Power company would be interested in providing service, but this company evidently does not want to build and maintain the two miles of line across the sound, part of which would have to be of submarine cable, unless and until the state builds a causeway and bridge are regarded as being very slim. So unless the Tidewater Power Co. changes its mind about extending its lines to Harker's Island, indications now are that a cooperative membership corporation will be formed to get a loan to build its own transmission lines from the mainland and over the island. Engineers for the State Rural Electrification Authority believe this would cost less and prove more

satisfactory than the installation of an independent generating plant.

Attorney for Knighten maintained that the daily collection sheet was not the official record and produced a docket sheet that showed the case had been noll prossed. Judge Phillips ruled that the daily collection sheet was the proper record, that the case had been called and failed, and that the Department of Revenue was only following out the law in revoking the license of Knighten.

If Knighten had permitted the case to go to trial earlier and had not sought so many continuances, he could have been found guilty and still not have lost his driver's license, it was pointed out here. For Knighten was arrested on July 6, 1935, five months before the state driver's license law went into effect on November 1, 1935. But by getting so many continuances, the case ran over into the period in which the new law became effective with the result that when the case was finally called and Knighten failed to appear, the new law was in effect and his license was revoked.

There are still some cases in which those charged with drunken driving seek to evade the new law by seeking numerous continuances or by taking appeals to higher

courts, Director Fulk said. But these methods no longer prove effective since the department now suspends the licenses of all drivers charged with revokable offenses whenever they appeal to higher courts or seek to evade a trial by setting their cases continued, Fulk said.

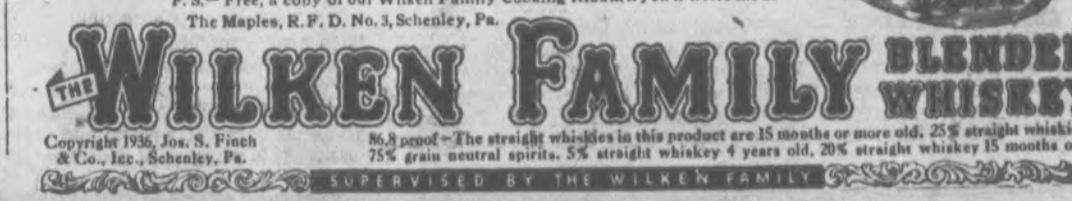

# HISTORY IS AID TO ROOSEVELT

## President Has Advantage of Increasing Business

Reflector Bureau. Sir Walter Hotel.

Raleigh, Oct. 16.—The entire political history of the United States will have to be disregarded and completely reversed if President Roosevelt is defeated, since all past history points definitely to his reelection. Governor-nominate Clyde R. Hoey pointed out here today as he paused between campaign speeches.

"The history of past presidential campaigns shows that in every case where a President has sought reelection with the tide of business increasing and prosperity on the upgrade, whether he was a Democrat or Republican, he has been re-elected," Mr. Hoey said. "This was true in the case of both Grover Cleveland and Woodrow Wilson, Democratic Presidents, and with Theodore Roosevelt and Calvin Coolidge, Republican presidents. For the people are always reluctant to vote against any President during whose administration business has increased and prospered."

"There is no doubt, of course that business has prospered greatly during the almost four years President Roosevelt has been in office and that the prosperity of the people far greater now than back in the dark, dreary days of 1932 and 1933, in spite of the howls of the Republicans and some of the big interests. For the balance sheets of business firms every where show that business is better today than it was three and four years ago and that manufacturers, mill owners, merchants and business men of all classes are making more money today than they were then. Cold, hard figures also show that the income of the workers in the lower pay brackets has also increased and that the per capita wealth of the people has almost trebled under the Roosevelt administration."

"This means that the people of the United States are going to reelect President Roosevelt for another four years, unless they forsake all of the rules and rudiments of political psychology in the past and utterly disregard everything that has happened in the past. But they are not going to do this, since the people as a whole are better informed and more intelligent than ever before. They are going to reelect President Roosevelt."

Discussing Symptoms  
"Yes, I took Mary to the doctor yesterday. I don't like her color, and she is nervous and jumpy as a cat. The doctor says she needs careful watching, and wants us to send her to the hospital for observation. But I can't bear to let her go. She is such a mother's baby. And she is really very good about noticing anything wrong. If she feels sick or tired she always tells me all about it, and I report to the doctor."

Mary, standing beside her mother as she went over the case, took it all in. Of course she was interested in her symptoms—no one more so. Grown-ups and children alike enjoy being the objects of solicitous attention. If Mary had had no symptoms she would probably have invented some, in order to hold the center of the stage. It would have been far better for her to go to the hospital even if it made both her mother and herself unhappy, than to become the focus of interest and attention at home.

The less a child knows about his symptoms the better. No matter how sick he is, his aches and pains, his temperature and pulse, his reflex actions and reactions should not be discussed in his presence; and least of all should he be made aware of any psychological peculiarities he may have.

The less conscious of his health, both physical and mental a child is, the easier will it be to make and keep him well. It is very easy to become a chronic aller, always finding or inventing some disability. A child who prides himself on being well is very apt to keep well. He will ignore the minor aches and pains which come to everyone and mean nothing. It is very easy to see when a child is really ill, but even then it would be a good plan for the parents to display as little concern as possible, even though very worried.

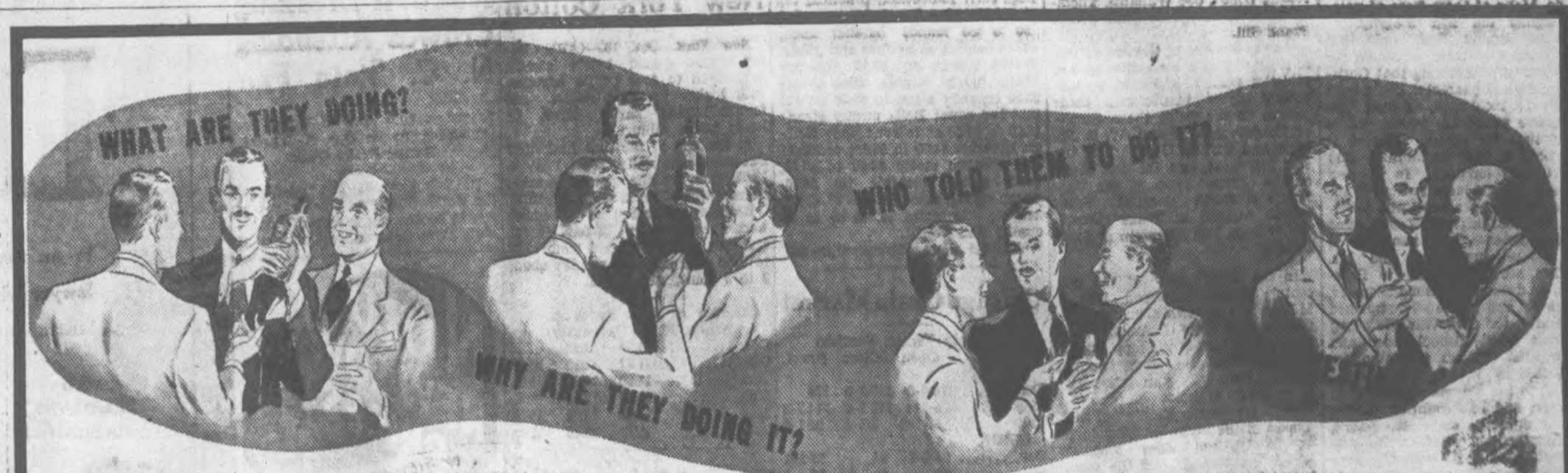

# PARISH PLANS SUNDAY EVENT

## Trinity Parish Homecoming Day Set For Sunday

Former students and faculty of Old Trinity School, Chocowinity, are to hold their first reunion, at the historic Chapel, one mile west of the present town, on Sunday, October 18, more than three hundred guests, from all parts of the State are expected to be present. About a dozen ministers and a large number of business and professional men, and many women, successful in varied fields will be among the assemblage.

The founder of Trinity School, Rev. Nicholas Collin Hughes, was born in Montgomery County, Pennsylvania March 4, 1882. In the early forties of the Nineteenth Century, shortly after his ordination to the priesthood, he came South and settled in New Bern, N. C., where his brother, Dr. Isaac Wayne Hughes was living. From this town, as a center, he started missionary work in several adjoining counties. In the Fall of 1848 he married: Adeline Williams, daughter of Dr. Robert Williams, who lived near Falkland.

In 1850 one of the churches served by Mr. Hughes, was Old Trinity Chapel, first built in Colonial days and had as one of its rectors, Parson Blount, a near relative of the Washington Blount, a minister of renown, and highly respected in that part of the state. Mr. Hughes built his home, at what was then known as Godley's Cross Roads, but is now Chocowinity.

The congregation of Trinity Parish was an agricultural people, independent, self-respecting and well to do. Many of them were of notable dignity and high integrity.

It was among these folks that Mr. Hughes started a school for boys and girls, believing that Christian faith and character, could most deeply be inculcated, during the formative period of youth. In a short time the school supplied a felt need in the community and surrounding territory. In a few years it became large enough to provide assistant teachers, and provision for boarding pupils who came from a distance, but seemingly, it was not self-supporting and Mr. Hughes accepted a call to Pittsboro, and later to Hendersonville, where he and his family remained until after the Civil War. How long the first Trinity School lasted, and under what auspices, is not known.

In 1866 or 67, Mr. Hughes returned to his old mission field in Beaufort and Pitt counties, serving Trinity church, and St. Peter's, Washington, and part of the time conducting a local school near Chocowinity.

After his son Nicholas Collin Hughes, Jr., who was born in 1880, had completed his collegiate education, and returned to assist his father, the school was reorganized, and the old name "Trinity School" was retained. Some of the early instructors were: Rev. Edgar Nymphus Price, Rev. Samuel Swarr Barber, Miss Bettie Roberson, Miss Fannie Waters, Miss Summerville, Rev. Hardy H. Phelps, Mr. Sleeman, an Englishman, Miss Mary J. Atkinson, Mr. John R. Hughes. The policy of the school at first was to employ outside teachers, but later it used some of its own graduates, they having pursued their studies in higher places of learning. Among the former pupil-teachers are: W. S. Bernard, professor of Greek at the University of North Carolina; Miss Mattie Winfield, professor of English at N. C. W. at Greensboro; Dr. W. P. Jacobs, who is now doing research work in India, ex. Israel; Harding Hughes, John. Among the clergy who were once

students are: Revs. H. R. Barber, M. A. Barber, W. E. Cox, Harry Harding, N. C. Hughes, Isaac Hugh-Hune, Thomas P. Noe, A. C. D. Noe, Francis Joyner, James Joyner, Lucian Malone, Cludius F. Smith, Robert Windy, ole Williams, Thomas Wingeat, George Burgess, George Frank Hill.

Trinity was one of the few schools of its day taking an active part in athletics. Some of the students who entered higher institutions, made records on the fields there. Stephen Bragaw, Sam Blount, W. P. Jacobs and Burgess Urquhart on the foot ball team, and Dr. Jim Mann on the baseball team at the University of North Carolina. Sonis Leggett football at Wake Forest, and William Von Eberstein of State College.

In the latter part of the 19th century Trinity developed into a Military school with Commandants usually from V. M. I. Among these were Captains Henry, Ship, Blackford and Scott, the former two and Captain Scott taking an active part in coaching athletics.

With the developments of high schools in the state, the attendance at Trinity and other preparatory schools dropped off, and the school passed into history in 1908.

Rev. Nicholas Collin Hughes, former Principal and son of the founder of the school will be the preacher for the occasion and other clerical members of the family will take part in the service. The Homecoming is being sponsored by the Rector Rev. A. C. D. Noe and the whole parish. Edmund Harding will be in charge of the musical program. Joe Patrick is chairman of the Invitation Committee and Ben Whitfield is chairman of the Entertainment Committee. Both chairmen and their committees of which the Woman's Auxiliary is a major part, are doing everything possible to make the visitors welcome and the occasion a great success. A picnic lunch will follow the morning service and an afternoon get-together meeting will be held in the parish house.

# Less Alarm Over Belgium Stand On Neutrality Pacts

French Sources Come to View King Leopold's Statement Merely Outlined Country's Policy.

Paris, Oct. 16.—(AP)—French alarm over newly asserted Belgium neutrality diminished today as officials analyzed King Leopold's declaration his country would seek to prevent martial entanglements.

With further thought French sources came to view the Belgium monarch's statement merely outlined a policy, rather than constituting a repudiation of existing security accords.

Paris awaited Belgium's answer to a four-point questionnaire designed to clarify the royal statements made Monday before a cabinet session military assistance.

France asked the Belgium attitude toward the Franco-Belgium pact, the Locarno treaty, further discussions of representatives of the original Locarno powers and the League of Nations.
