BLACK LEGION SOUGHT BY SET GOVERNMENT

Dayton Dean, Confessed Slayer, Gives New Facts

DECLARES CULT SOUGHT CHANGE

Members Quoted As Saying "Bullets Will Be Resorted To If Ballots Failed."

Detroit, Oct. 22.—(AP)—Dayton Dean, confessed black legion "executioner," testified today he had attended "about 500" meetings of the secret society and heard Arthur L. Lupp, Sr., of Detroit and Virgil Effinger of Lima, Ohio, advocate "changes" in the system of federal government.

Dean was called back to the witness stand for cross examination at the common pleas court hearing for 20 men including Lupp, on a criminal syndicalism indictment charging they plotted to overthrow the government.

Effinger, named by Dean as a "major general" of the night riders, escaped arrest after an extradition hearing in Ohio, but Lupp, accused of commanding the Michigan legion, was seized here.

Dean said Lupp and Effinger told at meetings in 1935 and 1936 of plans to revolt against the government.

"What did they say at those meetings," asked Lester L. Johnson, a defense attorney.

"A number of things," Dean replied. "We'd have to fight 'em and get the government. If it couldn't be done by ballots, it would have to be done by bullets."

Dean, one of eight men sentenced to life imprisonment for the black legion killing of Charles A. Poole May 12, said he "believed in" present system of government.

Asked if he had ever heard of violence advocated against Jews, Catholics or negroes at any legion meeting, Dean said: "Yes there was. They would have to take the government away from them."

Secretary Perkins Declares Industry Absorbing Labor

Estimates that 6,000,000 Unemployed Have Been Given Positions in Plants Since March, 1933

Washington, Oct. 22.—(AP)—Secretary Perkins estimated today that 6,000,000 unemployed had found industrial jobs since March 1933.

The labor department chief based her estimate on figures collected by the bureau of labor statistics, from samples taken from the payrolls of all principal industries.

Employment in September increased by 355,000 over August—the sixth successive monthly gain, she said. Weekly payrolls in September were \$2,500,000 greater than in August.

At the same time Miss Perkins expressed hope that the Pacific coast shipowners and maritime workers would reach a new agreement without strike.

The employment report showed that industrial payrolls had increased by more than one million workers in the year ended October 1. Miss Perkins said, while payrolls had risen in the year nearly \$32,000,000 weekly.

Manufacturing employment, she said, now stood at 90.6 per cent of its 1923 through 1925 average, the highest point since June 1930.

TWO NOMINEES HURL CHARGES

Landon Cries 'Regimentation'; Roosevelt 'Privilege'

(By Associated Press) Governor Landon, charging "regimentation" and President Roosevelt assailing "special privilege" pursued their campaign travels in widely separated sectors today.

The Landon train sped eastward from Phoenix, Ariz., where the governor declared that "regimentation of the individual and curb of his liberties under everyone of the New Deal's plans."

The Kansan's next major address is scheduled for Oklahoma City tomorrow.

After being greeted by Massachusetts crowds larger than any other in his campaign travels to date, Mr. Roosevelt said at Worcester, Mass., last night that the New Deal cut taxes for the "average American" and asked "are you willing to turn the control of the nation's taxes back to special privilege?"

In Ohio, with its 26 electoral votes, Col. Frank Knox drove with plans for eight speeches during the day and evening. In Indianapolis yesterday he said the United States would "be living under fascism today" but for the Supreme court.

The former chairman of the Securities Commission, Joseph P. Kennedy, addressed himself in New York to "average business men," urging them not to be "jockeyed into a position of antagonism to the rest of the nation because of a few stuffed shirts have lost their silk hats."

Replying to President Roosevelt's statement that the war for recovery had been won, Ogden L. Mills said "the question arises whether the statement is true and whether the war was worth the price." He said there were "eight million still unemployed and the price is America's freedom."

ROOSEVELT ON TOUR THROUGH CONNECTICUT

Makes Bid for State's Eight Electoral Votes

PLEDGES AID IN FLOOD CONTROL

Chief Executive Tells Cheering Hartford Audience That Prosperity Here to Stay

Hartford, Conn., Oct. 22.—(AP)—In a bid for the eight electoral votes of Connecticut, which went Republican in 1932, President Roosevelt declared here today that Connecticut was a "happier" state than it was four years ago and pledged the federal government to "do its share" toward flood control in New England.

Speaking extemporaneously before a cheering throng, the chief executive said he was here in a two-fold capacity.

"I am here to talk with your officials about floods," he said. "I am here also, I am told, as a candidate for President."

"The reason why your government in Washington has to keep in close touch with the states and cities," he said, "is the fact your river here crosses four states. The problem of floods involves more than one state."

He said the federal government stood ready to do its share toward flood prevention in the future.

"I am glad that prosperity is back with us again and, believe me, it's going to stay," the President said.

A big cheer went up with this statement.

After the speech he left for a motor tour of the state with stops arranged for half a dozen places.

PRICES STRONG ON LEAF MART

Season Average Continues to Maintain Incline

Offerings continue heavy and prices strong on the local tobacco market. \$44,512 pounds having been sold yesterday for \$222,859.04, an official average of \$26.39.

Although lower than the average on the first two days of this week, the figure remained far above the season's average and aided in postponing the general mark.

So far this season a total of 22,124,764 pounds has been sold for \$764,304.65, for an official average of \$23.78.

A comparison of the average on this market with others in the state shows the local warehouses to be paying higher prices. Figures released yesterday revealed that tobacco sold on the local mart brought approximately \$2.20 more on the hundred pounds than on any of the surrounding markets reporting.

Although the market got off to a somewhat slow start, offerings have been heavy and prices strong for the past several weeks. On the first two days of this week new high season's averages were set.

With prices remaining higher here than on other markets in the section, farmers from a wide area are bringing their product here to be auctioned off.

WASHINGTON (By Ira Bennett) COURAGE: Candidate Landon's decision to visit California caused a furor among political prognosticators. They asked themselves: "Can we be wrong? Can it be that California is not going hell-bent for Roosevelt?"

If Landon had headed for San Francisco his strategy would have been more obvious. There and thereabouts, labor upheavals are charged to Communist instigation, and much is made by G. O. P. speakers of alleged encouragement of unrest by the Roosevelt administration. But Landon headed for Los Angeles, a Roosevelt hot-bed. It is not supposed to be weeping over San Francisco labor troubles. Its huge proportion of voters hailing from grant-giver states is the backbone of Roosevelt's undoubted strength in California.

But Dr. Townsend's supporters of London may have changed the picture.

'Wally' May Have to Name 'Woman'

Ipswich, England, Oct. 22.—(AP)—Quickening interest in the Simpson divorce case centered today on the possibility Mrs. Ernest Simpson, American born friend of King Edward may be forced to identify the "unnamed woman" to gain her marital freedom.

By long tradition British divorce cases are reeled off generally by the simple expedient of the wife citing documentary "evidence" alleging misconduct on the part of the husband and a frequently anonymous correspondent.

Speculation was rife in legal circles, however, over the prospect that Justice Hawke will "clamp down" on such routine evidence.

Several judges, it was pointed out, have recently inquired against the practice, insisting that the "unnamed woman" must be named.

CROWD GREETED AL WITH 'BOOS'

Chicago, Oct. 22.—(AP)—Former Governor Al Smith of New York who "took a walk" from the ranks of the Roosevelt supporters, was given a tumultuous reception in which boos vied with cheers as he arrived today for an address tonight in behalf of the Republican presidential nominee.

In serious mood and wearing his familiar brown derby, the 1923 Democratic standard bearer walked from the train into the La Salle street station. A crowd which overflowed into the streets and beyond sent up a shout of approval. Then came boos which at times nearly equalled the cheers in volume.

Fifty policemen kept the crowds in order as Smith was greeted by a reception committee of 20 Landon Democrats.

The district meeting is held preparatory to the annual state-wide meeting to be held in the spring, possibly in March. A number of problems will be discussed at the sessions here, with sessions to be held by the various departments.

F. E. Bundy of Elizabeth City is president of the district association; C. D. Ward of Winterville, vice president, and Miss Blanche Hart of Contentnea school in Lenoir county is secretary.

Counties included in the area are Beaufort, Bertie, Camden, Carteret, Chowan, Craven, Currituck, Dare, Edgecombe, Gates, Greene, Hertford, Hyde, Lenoir, Martin, Pamlico, Pasquotank, Perquimans, Pitt, Tyrrell, Washington and Wilson.

The meeting to be held here is the largest annual gathering of teachers in this section of the state. Plans are being made to take care of the large number expected to descend on the city for the two-day sessions.

While the program has not been drafted, a number of prominent educators are expected to address general sessions, while persons prominent in their various fields will speak at departmental sessions.

NEW THREATS OF NEUTRALITY

Diplomatic Conflict Rises Anew in London as German and Italian Representatives Strike Out Against Soviet Russians Sympathetic to Spanish Socialists

Madrid, Oct. 22.—(AP)—The Spanish government placed the defense of Madrid in the hands of a new Supreme Chief tonight and sent a workers' reserve army of 100,000 men to all fronts around the capital.

Announcing a shift from defense to "smashing offensive tactics" to prevent invasion of Madrid, the government removed General Jose Asensio from command of the Madrid area and named as supreme chief of operations the 60-year-old General Sebastian Pozas, former minister of the interior.

The new proletarian reserve troops, it was announced, will relieve battle-weary militiamen and serve as the government's shock forces in its plan to carry the battle to the enemy, now in actual sight of Madrid.

Salamanca, Spain, Oct. 22.—(AP)—Spanish insurgents today were reported to have ordered their warships to sink the Russian ships carrying arms to Spain's government troops.

The reports, which were not immediately confirmed, said the insurgents were sending communication to European nations informing them of this decision.

(By Associated Press) Insurgents poked a new spearhead toward Madrid's fortified city limits today as diplomats of political opposite nations rumbled fresh threats over Spanish neutrality.

Disorder government troops fell back behind improvised barbed wire entanglements, just outside 10 miles from the capital after fascists moved strong forces into captured Navalcarnero "key city" of Madrid's defense.

In London, where the diplomatic conflict rose anew, German and Italian representatives struck out at Russian sympathy to the socialist Spanish administration. The Nazi and fascist diplomats intimidated their nations would spring into action if the Soviet dump overboard the 27-nation agreement to isolate the bloody civil war on the peninsula.

From their new field headquarters Navalcarnero platoons of General Jose Varela's insurgent troops pushed eastward to contact other fascist columns operating on the Toledo-Madrid highway. Once joined the southwestern army would strike together toward the capital, commanders declared.

The Madrid government accepted a French offer to evacuate refugees from the battle zones, following in the footsteps of similar British action.

French warships were prepared to steam toward Mediterranean ports to rescue the terror stricken non-combatants.

Mr. Burnette was a member of the Marlboro Free Will Baptist church.

Surviving are his wife, two sons, W. R. Burnette of the home, H. M. Burnette of Chicago, Ill.; two daughters, Miss Bert Burnette of the home and Mrs. Z. M. Dye of Louisville, Ky.; three brothers, G. H. and Herbert Burnette, of Farmville and J. A. Burnette of Buckroe Beach, Va.; three sisters, Mrs. Nan Tyson, Mrs. Annie Anderson, and Mrs. Mary Crawford all of Pitt county.

HOLDS RUSSIA SENDING ARMS

Germany Says Shipments Being Made in Guise of Food

London, Oct. 22.—(AP)—Germany has accused Soviet Russia of shipping arms to the Spanish government disguised as food, an informed source said today.

This source disclosed the German note to the non-intervention commission, transmitted to London prior to tomorrow's meeting of the group, contains seven points.

These are in two general categories:

1. A sweeping denial of all charges that Germany has shipped arms to the Spanish insurgents.

2. Several specific dates on which the Germans alleged Russian arms had been transported to Spanish government ports in the guise of food shipments sent by the Russian communist party for the relief of destitute government supporters in Spain.

An Italian reply to Russian charges of neutrality breaches is expected a few hours before the committee meets — at 4 p. m. tomorrow.

This, like Germany's note, will deny the Soviet accusations and make counter charges, it was understood.

A Russian spokesman, referring to the German note, insisted today the counter charges were not supported by evidence.

With a Soviet bolt from the committee regarded in many quarters as a foregone conclusion tomorrow the spokesman would say only this: "It depends on the course the meeting takes."

Death And Arrest End Careers For Youthful Bandits

One of Quartet Ends His Own Life Rather Than Face Arrest; Three Companions Under Arrest

Brownsville, Tenn., Oct. 22.—(AP)—Police said the short criminal career of a child bandit quartet from Illinois was ended here today with the body of one youth in the morgue and three companions under arrest.

These under arrest readily told officers and newspapermen how three boys organized in many quarters a week ago, later picked up a girl at Rockford, Ill., and climaxed a series by raiding a Memphis drug store in the heart of the business district last night.

This foray in the height of the 6 p. m. traffic rush netted less than \$60 and led to a pursuit in which the officers of several counties joined. After a series of gun duels with pursuers, the youths' automobile crashed into road machinery three miles south of Bells.

Detective Sergeant W. T. Pikington of Memphis said the death youth ended his own life with a pistol bullet rather than surrender. He gave the youth's name as Jimmy Magid, 15, of Chicago.

PLAN IMPROVE STATE'S ROADS

Extensive Highway Modernization Program Under Way

Reflector Bureau, Sir Walter Hotel, By J. C. HASKERVIL L.

Raleigh, Oct. 21—An extensive highway modernization and improvement program is now being planned by Chairman Capus M. Waynick of the State Highway and Public Works Commission that involves widening of several main highways in the Piedmont section of the state which now carry the heaviest traffic or the building of new roads parallel to existing highways. It was learned here today whether or not these roads can actually be modernized and improved, however, is not dependent upon obtaining the money necessary to build them it was pointed out. It is expected that some Federal Aid funds can be used on some of this work but a good deal of it, if done, will have to be done with state funds and will depend upon whether the coming general assembly provides any appropriation for

new highway construction, it is agreed.

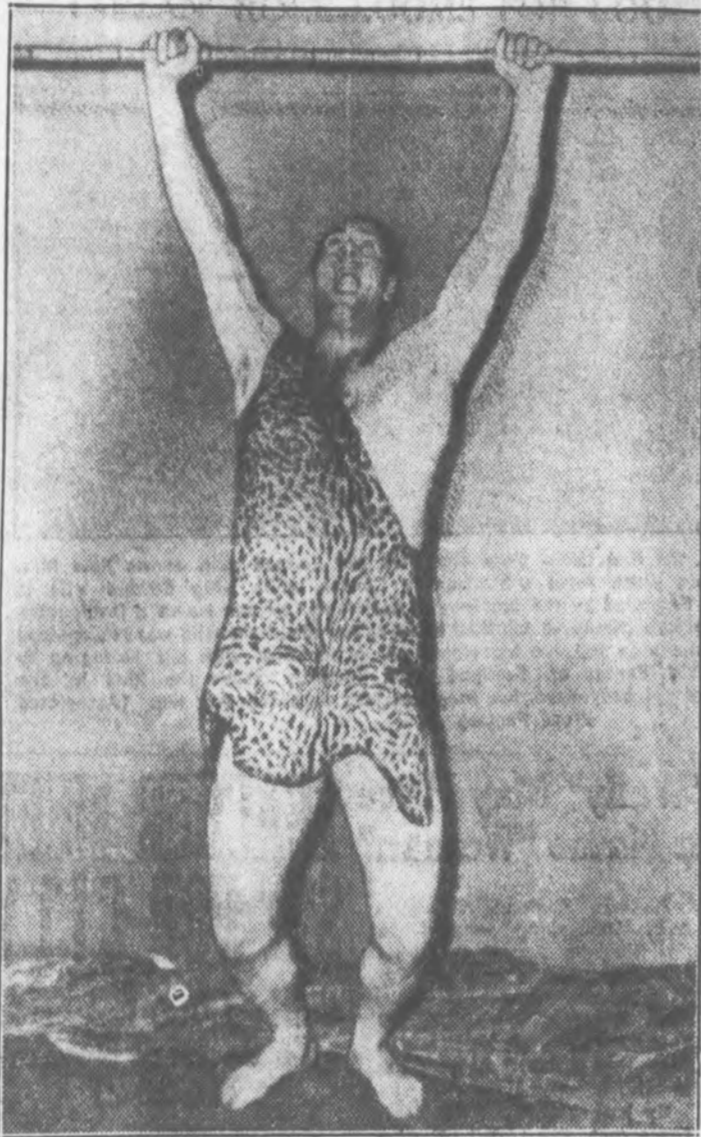
One of the principal projects now being outlined involves the widening of portions of Route 29 between Lexington and Spencer, probably means of a dual highway rather than by widening the present roadway. Chairman Waynick said today, although a final decision has yet been reached on whether it is low generally serves highway and safety engineers that dual highways are much safer than three-lane highways since each lane is limited to one direction traffic only and since to unimproved space between the two lanes is usually wide enough to prevent the glare from the headlights of cars in one lane from bothering drivers in the other lane. slightly more, it would be justified by the greater safety of the dual type of highway.

"There is no doubt that the dual highway is much safer and that it reduces the danger of accidents very greatly, while the three lane highways are more dangerous than the two lane roads," Waynick said. "The only question involved is that of the additional cost. But we are inclined to think the greater cost is justified by the greater safety of these double roads. And if there is any highway in the state which needs a dual roadway, it is Route 29, since it had the heaviest traffic in the state. The traffic on this highway all the way from the Virginia line to the South Carolina line is heavier than that on any other road in the state, averaging from 6,500 to 7,500 cars a day. But we are unable to tell now what we will be able to do next year and the year after, since we do not know yet how much money we will have available for new construction and modernization of highways."

Eventually, all of Route 29 should either be widened or made into a dual highway all the way from the Virginia line, just below Danville, Va., down through Reidsville and into Greensboro, also from High Point to Lexington to Salisbury to China Grove and then from Concord to Charlotte. Waynick said. This highway has already been widened into a 31 foot three-lane highway from Greensboro to High

Point and into a 40 foot highway from Charlotte to Gastonia, while a new cut-off is now being built around China Grove, Landis and Kannapolis from just above Kannapolis to Concord, for through traffic. But lack of funds has made it necessary to do this work a little at a time in very small projects. Waynick pointed out.

Another highway in this middle part of the state that needs to be relocated and rebuilt, is Route 311 from Winston-Salem to High Point, now an 18 foot highway with many dangerous curves, Waynick said. This road should be straightened and widened to at least 21 feet, Waynick agrees. But so far no money for this work is in sight.

A. A. U. W. Meeting
Sixteen Colleges and Universities were represented by the forty-two women who attended the dinner meeting of the Greenville branch of the A. A. U. W. held in the Parish House last night. The Woman's College of the University, at Greensboro, had the highest number, with Columbia University taking next place. The others were Duke, Peabody, Meredith, Winthrop, Randolph-Macon, University of Virginia, State Woman's College of Virginia, North Carolina University, Converse, New York University, University of Iowa, Earlham, University of West Virginia, and the Woman's College of Mississippi.

Mrs. J. E. Winslow, vice-president, presided in place of Mrs. Ficklen Arthur, the president. She announced that a letter of good wishes and regrets had been received from Mrs.

Arthur and by a unanimous vote the secretary was instructed to send her a message from the Branch extending good wishes for her speedy recovery and return, and telling her of the successful first meeting.

Mrs. J. H. Rose, who was introduced by Miss Grigsby, chairman of the program committee, gave an excellent account of the beginning of the A. A. U. W. and the history through the period of the merging of the sectional organizations into the association as it now stands. She began by telling the struggles in the late 1870's of a Boston mother to get her daughter properly prepared for Boston University and of the social ostracism and other disagreeable consequences the daughter had to bear after she had earned her two degrees.

On Nov. 23, 1881 a group of Boston women representing eight colleges met and made plans which culminated in the organization of the American Collegiate Alumnae. Other cities formed branches and the organization grew until regional directors were needed. The Western Collegiate Alumnae, formed in 1889, and Southern Association of College Women, organized in 1903, were all combined into one organization under the name of American Association of University Women and with the set-up practically the same as it now stands. Mrs. Rose showed that from the beginning emphasis had been placed upon research work, providing scholarships for those who could not carry on researches, and the sponsoring of forward movements that concern women especially.

The business meeting followed the program. The minutes of the last meeting in the Spring, which included the annual reports of the officers, committees, and delegates to the annual state and biennial sectional meetings, gave a survey of the year's activities of the local Branch. The guests, all of whom were eligible for membership, were able to get a clear conception of the work of the Association as well as its history and purposes. The record of the work of the local branch as presented by the secretary, Miss Jessie Mack, fitted into the pro-

gram, giving a concrete illustration of the wide range of the interests and activities of the organization.

Miss Grigsby announced that the basic idea for the year would be notable achievements of women, at some meeting, having as speakers women who have been eminently successful in some fields.

Other meetings will perhaps be devoted to panel discussions of problems of importance. Some of the meetings will be dinner meetings, others in the evening, with the third Monday in each month as the regular time of meeting unless there is some unavoidable conflict.

The Fellowship committee will have charge of the November meeting and Dr. Turner, chairman of the local committee announced that she hoped to have as the speaker, Dr. Delano, of Charlotte, the state chairman in charge of the fellowship work.

The report of the treasurer, Miss Louise Williams, showed that there was now some surplus in the treasury after a deficit had been wiped out in the late Spring.

A number of new membership cards were turned in and others were called for to be turned in later. The prospects are that in the

coming year the membership will be greatly increased and that it will be a banner year in every way.

The Alabama suit does not give rise to a dispute over jurisdiction, as Congress provided that the authority would be subject to suit in that district. The Nashville case challenges certain acts by TVA officials. The Alabama case strikes at the validity of the law itself.

CLEARANCE: Whether the government shall be the plaintiff or the defendant in litigation involving the validity of the public utility act of 1935 (the "death penalty" act affecting holding companies) is a question on which the Supreme Court will hear argument on November 9.

The government wishes to prosecute its case against the Electric Bond & Share Company. But ahead of that suit is another, brought by two utility concerns in the District of Columbia courts. It is a suit to enjoin the Securities Exchange Commission, the Postmaster General and others from enforcing the public utility act and to obtain from the court a ruling that the act is unconstitutional.

Judge Bailey of the District of Columbia court ordered a stay in this suit on request of Attorney General Cummings, in order that the government might proceed with the Electric Bond and Share Company case. His order was overruled by the District Court of Appeals, which ordered a hearing in the two-company suit. The Supreme Court

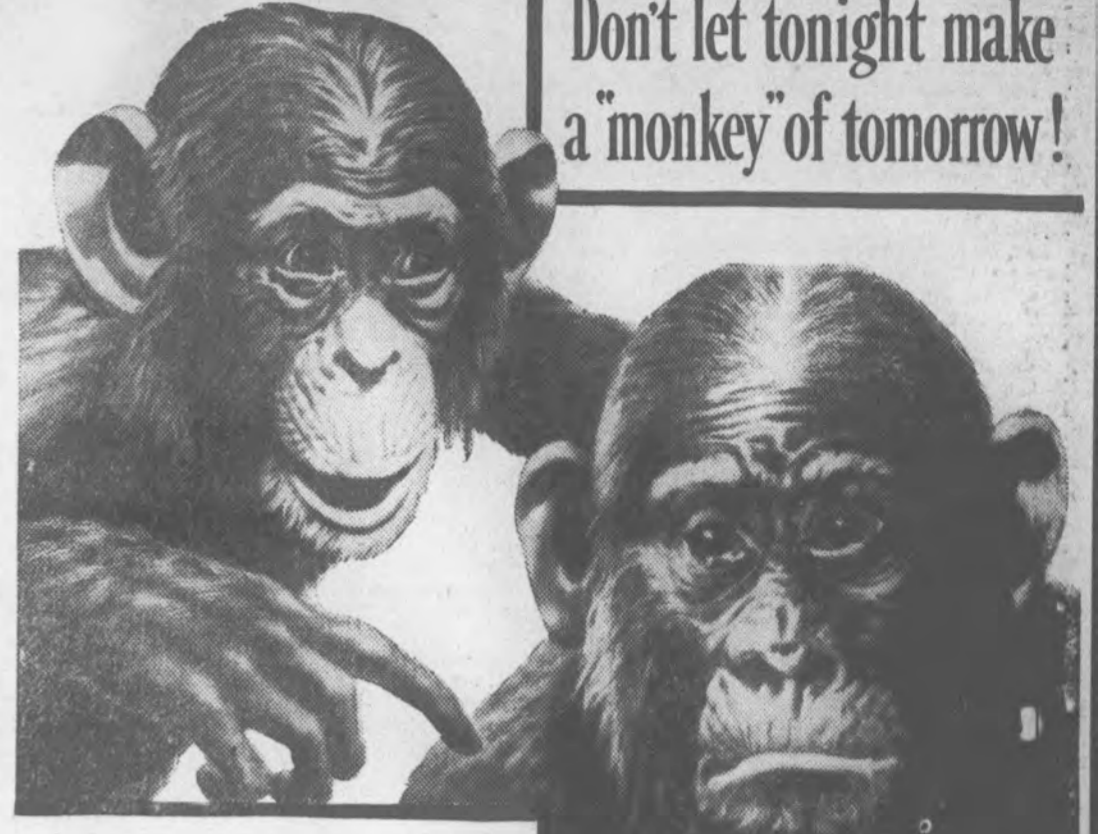

But a deadlock in the Senate is practically impossible—and it would elect a Democratic Vice-President. Then, if the House had failed to elect a President by Jan. 20, this Democrat chosen by the Senate would act as President. His name would be John Garner.

A Vice President has once had the duty of declaring himself elected President—John Adams. But he was not elected by the Senate.

It is possible that Garner might be called upon to cast the deciding vote as to whether he should be the Vice-President and acting President.

ACADEMIC: The House would continue to ballot for a President after Jan. 20. In the meantime Congress and the acting President could transact no business together—the House cannot set a ballot for any other business whatever.

N. C. State To Meet V.P.I. in Homecoming Day Contest

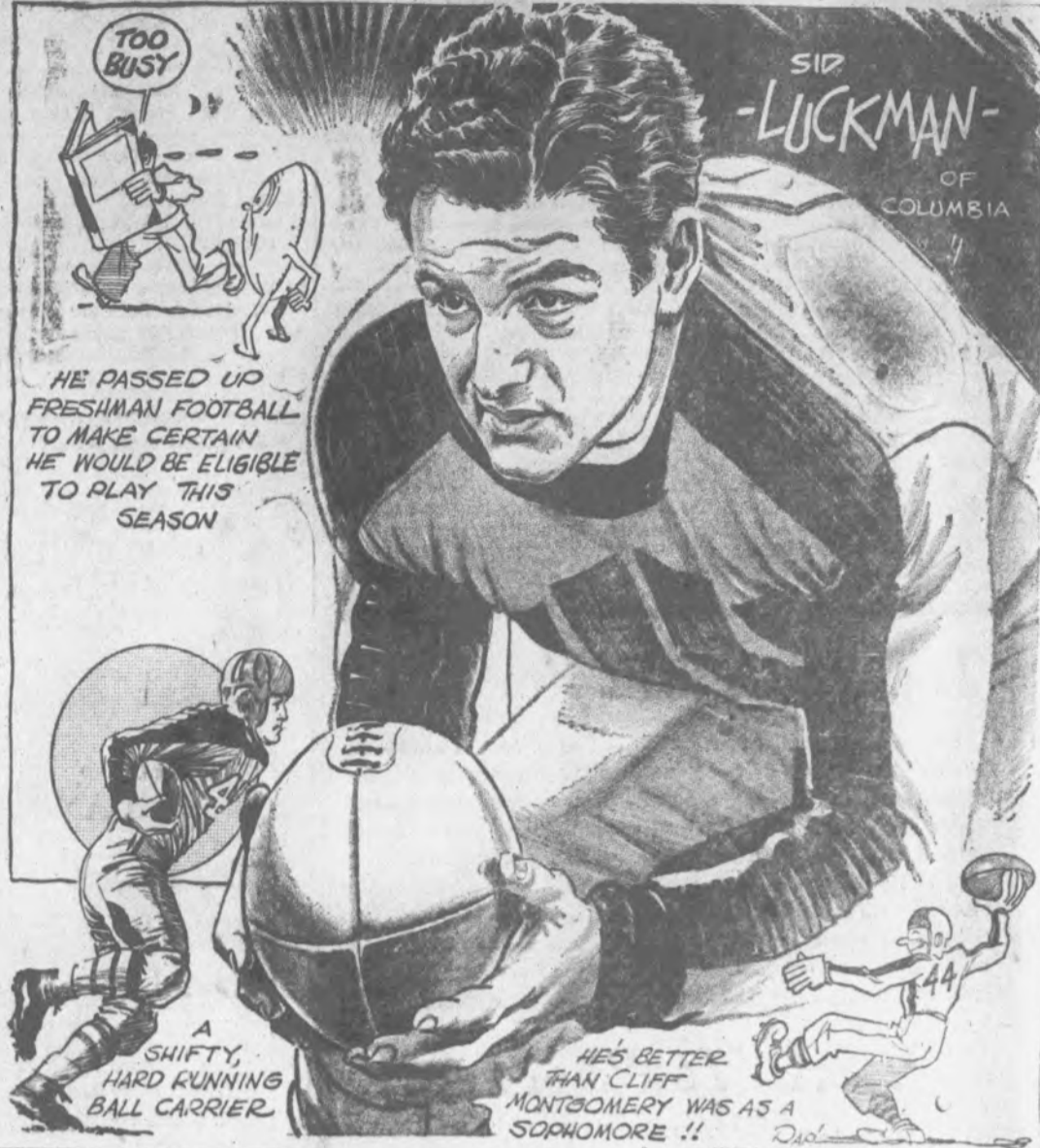
