DOCK WORKERS QUIT HEARING OF COMMISSION

Representatives Walk Out On Maritime Group

PROMPT ACTION IS INDICATED

Federal Government Expected to Take Hand in Widespread Strike on Coasts

San Francisco, Nov. 2.—(AP)—Representatives of the sailors unions of the Pacific walked out of the maritime commission hearing today declaring they would not submit controversial issues in the widespread maritime strike to the hearing.

The representatives, Harry Ludenberg secretary of the union, an attorney Aaron and Milton Sapiro informed rear admiral Harry G. Hamlet they objected to opening statements as the hearing opened.

"This is a fact finding commission," Aaron Sapiro declared. "We are not submitting controversial issues. Opening statements are fully out of line. This is an investigation."

Federal intervention in the strike appeared in prospect from three sources as seamen spread a "sympathy" blockade to eastern and gulf ports.

Officials of the United States labor department and maritime commission indicated prompt action. Employers were reported considering a request for navy "safety covers" on tied-up merchant ships.

Every coast port remained "closed" tight by the walkout called Thursday midnight by leaders of 37,000 ships and dock workers. Vessels arriving since the strike started fell under the blockade. The marine exchange here reported more than 140 vessels idle at west coast ports and Honolulu.

The seamen's defense committee in New York acting in defiance of no strike orders from official of the interventionist seamen's union claimed 57 vessels tied up at east and gulf ports in the sympathy strike. The committee claimed 2,300 men affected.

Pitt Court Terms Not On Schedules During This Week

Criminal Session of Superior Court Gets Under Way on Wednesday; No County Court To Be Held

Illness in the family of Judge N. A. Sinclair, who was scheduled to hold a term of civil court here last week and a criminal session this week, and Election Day have chances in court schedules in Pitt county.

No County court will be held tomorrow, it being Election Day and a term of criminal court originally having been scheduled to start today, but later postponed until Wednesday.

Judge Sinclair, who was kept at home last week by the illness of his daughter, advised local court officials that he would not start the criminal term until Wednesday of this week, Tuesday being Election Day. The civil term set for last week was completely abandoned.

The grand jury went into session today to consider cases laid before them by Solicitor D. M. Clark. The action was taken in hopes of speeding up the term when it convenes Wednesday.

No County court was held last week because of the scheduled civil term and with none this week, a large number of cases will be scheduled for trial when the tribunal convenes one week from tomorrow.

In the meantime Municipal court continues to sit at its regular Monday, Wednesday and Saturday sessions and send a number of cases up to the higher court.

Cupid Scores Heavily In County Last Month

Dan Cupid scored heavily Saturday, 15 marriage licenses having been granted by the Pitt County Register of Deeds' office to swell the total number for October to one of the largest for any month this year.

Of the total number issued during the period, 48 were to Negro couples and 23 to white persons.

Of the 15 granted Saturday 11 were for Negroes and only four were for white persons.

A total of 491 permits had been issued in the county this year through Saturday.

BOMBS HAILED NEAR CAPITAL

Insurgent War Planes Circle Over Madrid Suburbs

Insurgent war planes today unleashed a hail of bombs over suburban Vallecas, about two and one-half miles from Madrid, as the civil war neared the capital from three sides.

Three children were killed, eight adults wounded. Government commanders evacuated the civil population from Getase, another Madrid suburb, and hurried fresh reinforcements into the defense lines.

General Jose Varela's insurgent forces captured Brunette, 17 miles west of Madrid, after taking three other towns in bitter fighting.

The insurgent command reported at least 500 government troops were killed in the capture of the four villages and in a futile counter attack south of the capital.

The government said fighting was continuing on both sides of the Guadalaquivir, about 15 miles northeast of Madrid in the Sierrerra sector.

At Puenteblanca the government militiamen were entrenched only nine miles from the Madrid, city limits after a furious fascist surge, rebounding against a sudden socialist charge, forced the Madrid defense line back there.

Charlie Sugg, Jr. Again Finds Self In Toils Of Police

Negro Who Was Shot at Riot at Dance Here Held Under \$300 Bond For Breaking and Entering

Charlie Sugg, Jr., negro, who was shot at a riot at a negro dance here several months ago, and later tried and convicted of engaging in the disturbance, was bound over to Superior Court under \$300 bonds at a preliminary hearing in Municipal court this morning on charges of breaking and entering the residence of Rosa Norcutt while she was asleep.

The negro is scheduled to be tried at the next term of Superior court, which starts here Wednesday.

Pinnie Carr, negro, was taxed with the costs on a drunkenness charge; Ernest Reeves, negro, paid the costs upon conviction of engaging in riotous and disorderly conduct; Junior Dixon, negro, was sent to the roads for 30 days upon conviction of drunkenness; and Willie Evans, negro, was sent to the roads for 30 days for engaging in riotous and disorderly conduct.

Randal Biggs and H. C. Edwards were tried jointly for being drunk and disorderly and engaging in an assault. Biggs was fined \$5 and costs and Edwards \$10 and costs and given a 30-day suspended sentence.

William Cannon was taxed with the costs on a drunkenness charge.

BRITISH TARS SUFFER AGONY AT JAP HANDS

Details of Alleged 'Finger Nail Torture' Revealed

NAVAL OFFICER FACED THREATS

Three British Sailors Undergo Fiendish Treatment Following Arrest

Shanghai, Nov. 2.—(AP)—Details of the alleged "finger nail torture" of three British sailors by Japanese police were disclosed today by officials of the British Asiatic naval headquarters here.

The officials said a fountain pen was jammed under the finger nails of the sailor and then ink forced into the wounds to make him sign a "confession" sought by the Japanese.

The incident, which caused Vice Admiral Sir Charles Little, commanding the British Far East naval force, to postpone a visit to Japan, occurred at Keelung, Formosa October 7.

According to British naval officers, three seamen from British naval craft then stationed at Keelung were arrested by Japanese police for alleged non payment of taxi cab fare.

Upon protesting, British officers here said, the three sailors were pinned down by four Japanese police and beaten in the face by Japanese plain-clothesmen to "persuade" them to sign a confession of their refusal to pay the taxi cab fare and also of resisting the police.

At the height of the assault, British official's said, Lieutenant T. C. Packersford of H. M. S. Bruce arrived on the scene and requested that the sailors be released.

The Japanese threatened Packersford with imprisonment if he did not depart, officers here said, and after he left the Japanese assertedly resumed the assault on the three seamen and dislocated the jaw of one of them.

American Legion Fair to Meet All Obligations

American Legion officials said today that despite the inclement weather of last week, the Pitt county fair was a success to the point it was able to fulfill all its financial contracts and meet all its obligations.

"The two posts realized on profits from their efforts, but we are able to take care of everything, including the premiums for agricultural exhibits," said one official of the local post, indicating the legion was not disappointed at failing to realize any net earnings.

The fair association paid over \$700 in premiums and the cash prizes were available on the grounds Saturday. The exhibits at the fair were the best ever offered here and officials said that taking into consideration that this was the first time the Legion had sponsored the exposition, they considered them very good and representative of the best in the county.

The fair committees of the two legion posts already are looking toward next year, when they intend to put on an even greater fair.

Officials were checking up today on unpaid bills, before closing up the books and it was figured that receipts from the exposition would meet all expenses incurred in staging the exposition.

With a clean record behind it, the fair has laid the groundwork for next year, officials declared.

POLITICIANS: In the closing days of the campaign President Roosevelt has parried all questions about the policies he will pursue in the event of his almost certain election. His closest friends have failed to penetrate his armor of political silence.

Leading liberals, including members of his official family, lost their poise as they noted several unballooned moves obviously designed to woo the conservative vote. They were concerned over negotiations with power interests for establishment of a joint "grid" system, figuring it was a compromise with the utilitarians. They worried over Jesse Jones' promise of a revision of tax legislation that would wipe out or modify the levy on undivided corporation surpluses. Their chief concern was FDR's reputed assurance to three visiting Wall Street brokers that the securities and exchange acts would be softened at the next session. It seemed to the

Big Democratic Victory Assured For This State

Chairman Wallace Winborne Issues Final Call to Party

Raleigh, Nov. 2.—A tremendous Democratic victory in North Carolina is assured at the polls tomorrow, State Democratic Chairman J. Wallace Winborne said today, in issuing the final call to Democratic workers in every part of the state to be on the job from the minute the polls open until they close at sundown in order to get out every possible Democratic vote.

"We are ready to go," Winborne said. "The enthusiasm in the various counties and precincts is greater than it has ever been and we are confident that the county and precinct chairmen are going to do everything possible to get out the vote. I feel that we are better organized for this election than we have ever been before and that our majority is going to amount to at least 276,000 or even more."

Chairman Winborne and Secretary D. L. (Libby) Ward, after going over the estimates submitted by the county chairmen in the 100 counties, are confident that the Democratic vote will amount to approximately 523,801 and that the Republican vote will not exceed 247,232, while a good many doubt if it will be that large. But conceding that the Republicans may cast as many as 247,232 votes, Chairman Winborne is still confident of a Democratic majority of more than 276,000. In the 1932 general election, Roosevelt received 497,566 votes and Hoover 208,344 while Governor E. B. Rouseff received 497,657 votes for Governor as compared with 212,561 votes cast for Clifford C. Frazier, the Republican candidate for Governor.

As a result of the heavy increase in registrations this year, the intense interest in the campaign, both state and national, and the more intensive organization work done by the Democratic campaign managers (Continued on page two)

Princeton Democrats Hear R.W. McDonald

Princeton, N. C., Nov. 2.—(AP)—Dr. Ralph W. McDonald urged the reelection of President Roosevelt in a speech here today in which he said the President "has done more for the South than any chief executive this nation ever had before."

The Winston-Salem man said credit should be given the President for better farm prices and better business conditions. He urged each citizen to "definitely affiliate himself with one or the other of the parties and remain absolutely loyal to the party of his choice because only in this manner can responsible party government be maintained."

TOBACCO FEES ARE HELD VALID

Three-Judge Court Upholds Georgia Warehouse Law

Augusta, Ga., Nov. 2.—A three-judge Federal court, in a two to one decision, upheld Georgia's tobacco warehouse law today.

The law fixes fees warehousemen may charge for handling tobacco.

Judge W. H. Barrett of Southern District of Georgia, and Judge B. E. Holmes of New Orleans, concurred in the opinion, declaring the act was not confiscatory and that it did not infringe on either the constitutional right of the warehousemen or their status as persons engaged in interstate commerce.

Judge Bascom S. Dwyer of the Middle District of Georgia, dissented.

The warehouse fee law was passed by the 1935 legislature, but warehousemen attacked it before the 1935 tobacco auction season began. The difference between the old scale of fees and those provided by the law has been impounded pending final adjudication of the case. The impounded sum now exceeds \$225,000.

Secretary Wallace Denies Statement Attributed To Him

Declares He Never Advocated Keeping Price of Corn From Exceeding \$1 Per Bushel

Chicago, Nov. 2.—(AP)—Secretary of Agriculture Henry A. Wallace denied today reports that he was in favor of government action to keep corn prices from going above \$1 a bushel.

"Anyone who says I am in favor of setting a specific limit on corn prices at \$1 is an ignoramus or a liar or has been deceived by an ignoramus or a liar," Wallace said in a statement released through the Roosevelt agricultural committee here.

"What I am interested in are his policies which will maintain the income of the corn belt farmers at as high a level as possible year in and year out without injustice to other sections," he said.

The secretary in this statement referred to what he said were "partial quotations and deliberate omissions" of the "partisan press" as being responsible for the reports.

He said the Republican proposal to set an "absolute embargo" on corn imports even in years when the crop was less than 60 per cent of normal.

Patrolman H. B. Smith, who investigated the wreck, said that a warrant had been sworn out charging Paul Hill of Greenville, owner of one of the cars involved, with being drunk on the highway. Hill being drunk on the highway. Hill was quoted by Patrolman Smith as saying that he picked up two boys near Grifton and that one of them was driving the car at the time of the wreck. He said he did not know their names.

Hill suffered cuts about the chin, and the wife of the negro, Sebram Cox, who was driving the other car, also was injured.

Both Major Parties Express Confidence of Victory

WORKERS SEEK TO GET OUT VOTE

Roosevelt Permits Himself Little Rest As He Plans To Make Tours in N. Y.

(By Associated Press)

Across the vast expanse of America the tumult over gigantic issues died away today as the nation's only sovereign—the voter—prepared to wield the scepter and decide tomorrow who shall head his government.

From both major parties came strong expressions of confidence while all hands concentrated on one eleventh hour task:

"Get out the vote" was the injunction heard on all sides. The efforts of the party workers, combined with the more than usual natural interests in the issues, still indicated a record smashing vote, possible 45,000,000 despite ominous words from the weather bureau that a cold rain or snow might blanket much of the United States on election day.

James A. Farley, Democratic national chairman, declared that it would be a "swamp" giving President Roosevelt a bigger margin than in 1932. "Never before captured 50 of the 501 electoral votes."

Assistant chairman John P. Hamilton of the Republicans came back with declaration that he would predict an "absolute minimum" of 321 electoral votes for Governor Alf M. Landon, only 288 being necessary to elect.

President Roosevelt permitted himself little rest today. He planned to make a tour of his own Dutchess county and two other New York counties, then speak tonight to neighbors from a Poughkeepsie balcony and to the nation from Hyde Park.

His 90,000 mile trek through the nation finished, Governor Landon rested at Topeka, Kansas. He will make a 15-minute address to the nation tonight, then train for his home town of Independence, where he will vote. By tomorrow night he will be back in Topeka to receive the returns.

Gov. Alf Landon Insists Roosevelt Evaded Questions

Republican Presidential Candidate Declares Chief Executive Intends to Return Triple A

Topeka, Kansas, Nov. 2.—(AP)—Gov. Alf M. Landon said today "the plain inference" of President Roosevelt's Madison Square Garden speech was that "you're going to have the NRA, the AAA and everything else over again."

The republican presidential nominee made the statement in a press conference. Reporters asked whether he thought his democratic opponent's Saturday night address answered the questions he put to him in the same hall last Thursday.

"The speech speaks for itself," Landon replied. "It doesn't specifically answer my questions. The plain inference is that you're going to have the NRA, the AAA and everything else all over again."

## TOMORROW IS THE DAY

Throughout the nation tomorrow our citizens will go to the polls to elect a president and other national officers as well as state officials, and it is our prediction that it will prove a great Democratic victory throughout if the voters will go to the polls and vote their convictions. Because there are so many qualified voters that do not feel the necessity of voting, a minority of the eligible voters always elect the officers.

We take this final opportunity before the polls open to urge every qualified voter in Pitt County to go to the polls tomorrow and vote. In view of the manner in which our section has prospered under the New Deal we cannot see how our people can vote other than the Democratic ticket, but even if you are on the other side it is up to you to vote, for the wishes of the majority cannot accurately be determined unless most of the voters vote.

## THE AMENDMENTS

When you go to the polls to vote tomorrow you will be given ballots to vote for or against five Constitutional amendments. As we understand them there is only one of the five that should be adopted and that is the one that would increase the constitutional limit of the income tax rate from six to ten percent. There is no limit on the sales tax and there is no limit on the ad valorem rate on property, and we see no reason why there should be a six percent limit on the income tax rate.

The other four amendments, we believe would in the end prove detrimental to the best interests of our state and because of this we advise voting against them. When you go to vote, if you are in doubt about these amendments, it would be far better for you to vote against all of them rather than to let the dangerous ones be adopted. Whatever good there may be in these amendments can be redrawn, without the objectionable features, and resubmitted to the voters at a later election.

Under this spread-eagle system of contributing the Liberty Leaguers won't appear in official reports to the House of Representatives as major underwriters of the anti-New Deal campaign. But the Senate's agents will eventually publicize a consolidated contribution list disclosing how much cash some of those who "hate Roosevelt" dumped into the Republican pot.

**HAZARD:** Treasury officials are privately thanking their stars that a serious European bust-up did not occur before the presidential election. It would have made their stabilization agreement look like what Republicans suggest it is—a purchase of a "pig in a poke"—a blind bargain.

Had France cracked up, as everybody expects it will sooner or later, the Treasury would have faced two unfortunate alternatives. It would have had to support the franc with American money in the face of anarchy and revolution. Or it would have had to retreat from the battle ground of international exchange, thereby admitting that it had rushed in blindly. It would have become involved in European finance, which might have been a prelude to military commitments in the continental turmoil.

Several practical financiers advanced this argument during the original negotiations. They suggested that any stabilization agreement be deferred until within a week of election, thereby leaving less time for a debacle. Now it looks as if France will hold firm until after the votes are counted tomorrow night. And Secretary Morgenthau will sleep easier.

**SADDLED:** Candidates Knox and Landon have not always seen eye to eye during the presidential campaign. It is doubtful if two men running on the same ticket ever had so many disagreements. But an apparently authenticated story furnished the most delightful anecdote of the presidential contest. It seems that Mr. Knox planned to repeat in the West his charge that no life insurance policies were safe under New Deal operations. Mr. Landon, by phone, insisted that his running mate recite to him the text of his second attack. Mr. Knox did, and there was serious dispute over the language to be used. The presidential candidate insisted that it be tempered and qualified.

Mr. Knox agreed, but turning from the phone, he is quoted as saying to a friend: "Oh, I'm just like my old friend Teddy Roosevelt. I'm saddled to another McKinley!"

**BLOC:** The United States Senate is quite a comfort to New York anti-New Dealers. If Mr. Roosevelt is reelected tomorrow, as most of them privately expect, they figure that any radical legislation he may propose will be stymied by a combine of Republicans and conservative Democrats in the Senate. A confidential survey indicates that no less than nineteen Democratic Senators—all of them holdovers except Carter Glass—can be counted

depend before the end of 1936. A few months ago it was widely prophesied that Big Steel would issue bonds or a special preferred stock to clear up overdue preferred dividends. But continued expansion of earnings puts a natural wish to minimize payments under the new undistributed profits tax combined to alter the management's viewpoint. Big Steel's common stockholders can share in the rejoicing, as this new policy will probably mean a quicker resumption of their dividends also.

**INVENTORIES:** Delayed deliveries indicate shortages of quality goods for the Christmas trade. New York merchandising experts prophesy the strongest sellers' market ahead for this type of goods since 1923-29. Stores which are still buying hand-to-mouth may find themselves with sadly depleted inventories when the holiday rush gets going in earnest.

As a matter of fact, more and more merchants are abandoning the hand-to-mouth system that has prevailed for six years and are building up inventories again in anticipation of a sellers' market. This is significant—because merchandise inventories have not been rated an asset from the banking viewpoint since the depression began. So the new trend to long-term purchasing means that banks are once again permitting conservatively appraised inventories to be used as a basis for credit—another long step forward in recovery.

this year, Chairman Winborne is confident that both President Roosevelt and Mr. Hoey will poll not less than 52,000 votes. "It is not a question of whether the Democratic ticket will win, but only of how large the majority will be," Chairman Winborne said. "If the Democrats will go to the polls and vote as we are confident they will, even in the solidly Democratic counties in the east where the general election vote is usually smaller than the primary vote, there is no doubt but that our majority will go beyond 276,000 possibility as high as 300,000."

"Some Democrats are inclined to think that since there will be a large majority anyway, it does not matter whether they vote or not. But it does matter, since the size of the vote has a very definite effect upon the hopes and the morale of the Republicans, both within the state and nationally. For if the Democratic majority should slump, even a little, the Republican leaders would at once find encouragement in this fact and redouble their efforts to break down the Democratic vote still more in the next election. We know, for instance, that ever since 1928, when Herbert Hoover carried the state, the national Republican leaders have redoubled their efforts and increased their contributions in an effort to carry North Carolina again.

"So there is plenty of reason for our wanting to make the Democratic majority large in this election than ever before, in order to prove to the Republican leaders both here in the state and to the Republican National Committee that it is a waste of their time and money to try to carry North Carolina. We want to swat the Republicans so hard in this election that they will stay swatted. We also want to show the entire nation that North Carolina has implicit confidence in President Roosevelt, that it approves of the New Deal and wants to see it continued for four more years."

**BRACKS:** Reports received in New York indicate that many thoughtful people who prefer Roosevelt to Landon will nevertheless vote the Republican ticket. Their hope is to reconstitute a strong opposition party—taking it for granted that Roosevelt will be returned to the White House. They figure that effective brakes on the motor of government are essential to the successful functioning of a democracy.

**DRAFTED:** A veteran Democrat who has been out of the limelight since 1932 was recalled to a desk at national headquarters in the closing days of the campaign. Ex-Congressman Swager Sherley travelled a lot with FDR in the '32 campaign and served for a while as one of his closest advisers. Then he disappeared suddenly from the picture—even before inauguration—and has not been heard from since. But he headed the last-minute SOS of old friends. He was called upon because—as a member of the House Ways and Means Committee for many years—he was perhaps the most thorough knowledge of tax matters of anyone in the party. He was drafted to counter (anonymously) G. O. P. assaults on the tax front.

**REJOICING:** Informed financial men interpret the action of U. S. Steel's directors last week as extremely encouraging to the corporation's preferred stockholders. Not only did they authorize part payment of preferred dividend arrears out of earnings. They also amended the company's bylaws to allow "dividend action in respect to arrears on preferred stock dividends at any regular or special meeting of the board." This strongly implies further reduction of the arrears by a series of special dividend declarations whenever current earnings warrant them, instead of paying them off in new senior securities or even out of earnings at regular quarterly dates. Insiders look for another such divi-

# N. C. Patrol Radio To Let Contracts On Buildings For

Estimated 90 Days Will Be Required to Get System Ready to Start Operating in State

Reflector Bureau, Sir Walter Hotel, Raleigh, Nov. 2.—Contracts for the construction of the buildings which will house the five highway patrol radio stations over the state will be let within ten days, the date for the letting of the contracts already being set for November 9, Captain Charles D. Farmer, commander of the patrol, said today.

The specifications have already been published and bids called for. It is expected that these buildings can be erected by the time the broadcasting towers can be built and other equipment ready for installation.

It is expected that approximately 90 days will be required to get these houses built, the towers erected and all of the equipment installed. There will be one broadcasting tower 330 feet tall at each station. Several miles of copper wire will be buried in the ground, radiating like spokes in a wheel 600 feet in every direction from the base of each tower. This will give the stations greater sending power. The Division of Purchase and Contract and the board of award have already let the contracts for the most modern type of equipment and Capt. Farmer is confident that North Carolina will have the most effective statewide radio system in the United States. It will be the only exclusively state owned and operated radio communications system in the country.

## Talks To Parents

Tommy was absorbed in Thackeray's Vanity Fair. His mother felt that at 12 he was too young to understand and appreciate the book.

"Read some real boys' books instead," she insisted, "and leave the classics until you are older."

No matter how young they are, it is a great mistake to discourage children from reading the classics. It is quite possible that the author will miss much of what the author is saying, and that the beauty of style and form will go quite over their heads. But they undoubtedly are getting something or they would not be reading the book at all. If it is taken from them they are very apt to develop an aversion to it and never read it. If they enjoy it at this time, they are almost sure to reread it later on. In the meantime it is doing them no harm, and is developing an interest in and taste for good literature.

Most of the great thinkers of the world have been omnivorous readers. When other children were still in fairy tales they had read books meant for adults. The average child is capable of far deeper and better reading than is generally supposed, but he must have the material and opportunity for development within his reach. Comprehensive home libraries are, however, rare in this day of cramped quarters, and browsing is difficult in a public library.

Every home should be furnished with at least a hundred good books, and the children should be permitted and encouraged to read them as soon as they are able to do so. Homer, Virgil, Scott, Austen, Thackeray, Dickens, Shakespeare, the Bible, some anthologies of verse, an atlas, an encyclopedia and a dictionary, these and others like them are a sure foundation.

### Wine Consumption Throughout State Showing Decrease

Wholesale Dealers and Jobbers Quit Handling Spirits as Little Demand Made For Drink

Raleigh, Nov. 2.—The wine business is having a hard sledding in North Carolina and an increasing number of wholesale wine dealers and jobbers have either already stopped handling wines or are going out of business in the very near future.

Retail wine dealers, chiefly drug stores, cafes, oyster and beer bars are also selling much less wine than they did and some have stopped handling it entirely, reports indicate, although this is the time of year when an increase in the business usually takes place.

Here in Raleigh there is only one wholesale wine dealer and distributor still in business, while reports from Charlotte, Durham and other

cities in the state are that a number of wine wholesalers have either gone out of business or will go out of business as soon as they dispose of their present stocks, despite the fact that the state imposes no tax on wine and requires no license from either wholesalers or retailers.

Officials of the Department of Revenue, when questioned about the wine situation here today, said they knew nothing about it, since they had no contact with and no control over the wine business in the state. Nor did anyone connected with Department of Agriculture know anything about the reports of the slump in the wine business or the causes of the slump. For while the Department of Agriculture set up the rules and regulations for the sale and manufacture of wine in North Carolina, it is not charged with their enforcement, neither does it impose nor collect any tax on wine.

But a former wholesale wine dealer here, as well as several retail dealers frankly admitted there had been a decided slump in the wine business in North Carolina during the past six months and gave a number of reasons for this slump.

"The two principal factors in the decrease in the wine business in the state, according to these dealers, are as follows:

1. The state law which makes it legal to sell only natural, fermented wines, manufacturer in North Carolina from grapes or fruits grown within the state and of all alcoholic content of about 14 per cent, regarded as maximum obtainable in natural wines.
2. The fact that most of the demand is for the distilled or fortified wines with high alcoholic content of from 20 to 30 per cent alcohol, and that all of these wines are manufactured in other states and if sold here, are sold in violation of the Turlington Act in 'dry' counties and for violation of the county liquor control acts in the 18 counties which have county liquor stores.
