REBEL PLANES SHOT DOWN BY LOYAL CRAFT

Fresh Soldiers Hurred to Defense of Capital City

FASCISTS READY TO SHELL MADRID

Insurgent Forces, Reported Within Four Miles of City, Ready for Big Push

MADRID, Nov. 5.—(AP)—Heavy aerial artillery bombardment shook the outskirts of Madrid as fascist insurgents started the "decisive battle" for possession of the Spanish capital.

For the third successive day the wall of air raid sirens in the capital was almost ceaseless. Punctuated by the steady crash of artillery bombardments in suburban districts southwest of the city, the clamor sent residents scurrying to protection.

Squadrons of government planes released a prolonged rain of high explosive bombs over Alcorcon county, west of Madrid.

Plots of insurgent fighting ships dipped low over highways on the capital outskirts, machine-gunning government reinforcements on their way to the front.

Madrid, Nov. 5.—(AP)—Two insurgent combat planes were shot down today in a stirring "dog fight" directly over Madrid, while thousands of militiamen streamed out of the city to push a counter offensive from the city's gates.

Two other fascist planes, seemingly crippled in the aerial battle, fled back to their own lines.

Thousands of persons watched four government planes engage the enemy craft, diving and maneuvering in spectacular fashion at an altitude of 4,000 feet.

Suddenly the pilots of two fascist planes shot from their craft, their parachutes ballooning. The planes crashed.

Whipped to a fever fighting pitch, the fresh troops hurried forward amid the roar of a fierce artillery duel between fascists and socialist guns only a few miles beyond the outskirts of the capital.

A major and possibly all-decisive battle for the capital apparently was about to begin.

Insurgent commanders at Avila, whose forces were reported within four miles of the capital, declared fascist batteries were ready to fire "some well placed shells into the center" of Madrid.

With Petafe and Lega Nes, Madrid suburbs, already captured, the government counter offensive centered approximately seven miles southwest of Madrid.

Special Criminal Term of Superior Court To Be Held

Session Scheduled To Have Started Monday and Postponed Until Today, Called Off Altogether

The criminal term of Superior court scheduled to have been started here Monday and postponed until today, has been called off entirely on account of the illness of a daughter of Judge N. S. Sinclair, who was to have presided.

A civil term set for last week was called off on account of the same reason, but it was thought that the criminal term could be held. The grand jury was summoned into session Monday to pass on bills laid before it by the solicitor. Judge Sinclair's daughter, however, took a turn for the worse and the term was called off altogether.

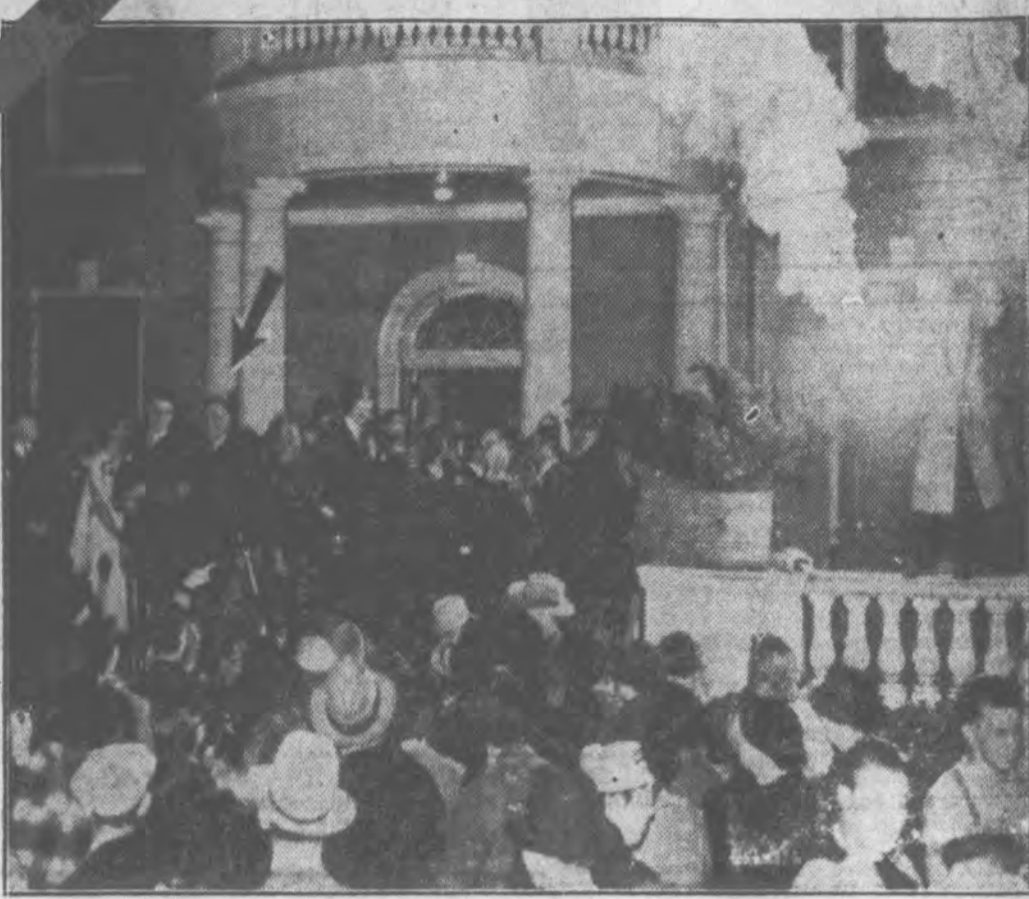
Plans are underway for a special term of criminal court to be held the week of November 30. Local officials said the governor's office had proffered the services of a judge for that time and the county commissioners were called to meet today to request the special term. It was understood Judge Paul Prizzelle was the only jurist available the week of November 30th and will hold the court.

Local officials are especially anxious for the special term as the fall is crowded with defendants awaiting trial.

A term of civil court is scheduled to be held here the week of November 23 with Judge F. A. Daniels of Goldsboro presiding.

NEGRO SLAYER LOSES APPEAL

Willie Tate to Die in Gas Chamber Friday, Nov. 20

Willie Tate, Georgia-born negro convicted at the April term of Superior court here of the murder of Alexander Warren, Bethel filling station employe, on the night of February 28, will die in the lethal gas chamber at State's prison in Raleigh Friday, November 20th unless he receives executive clemency.

The State Supreme court yesterday denied an appeal made for Tate by his court-appointed attorney, S. O. Werthington. The date of execution was automatically set as November 20.

In its batch of 32 decisions handed down yesterday, the court gave new hope to another negro convicted of a capital crime and sentenced to die, David Witherspoon, Caldwell county negro, was given a new hearing on a charge of assaulting a white woman.

Several other cases appealed from this county were included in the decisions handed down by the high tribunal yesterday. They included:

Counsel for Tate had contended that the negro should have a new trial because of error, but the high court ruled "No error" in the case. It had been contended that the confessions made by Tate should not have been admitted into evidence, since the defendant declared it was secured under duress.

Twelve Men Freed in Death of New Yorker

New York, Nov. 5.—(AP)—Police said today they had questioned and set free 12 men in connection with the slaying of R. Walton Ford, 35, an interior decorator, whose body, bound with a lamp cord, radio wire and belt, was found in his fashionable mid-town hotel yesterday.

Eight Persons Killed In Auto Wrecks Last Month

Eight persons were killed on highways in Eastern North Carolina during October, the monthly report of Lieut. Lester Jones, head of Troop A of the State Highway Patrol, revealed today.

These fatalities compared with 12 in the preceding month. During October the patrolmen investigated a total of an even 100 wrecks, in which 71 persons were injured, in addition to the number slain. In September the force investigated 81 wrecks, in which 62 persons were injured.

The patrolmen recovered property in the amount of \$4,723.30. Fines meted out by courts as a result of their activities totalled \$8,812.50 and for fines \$5,370.71, for a total of \$18,906.51. The officers also collected \$5,155.79, for a grand total of \$24,062.30.

The officers made 768 arrests, as compared with 751 in the previous month. Of the total number of ar-

Japanese Stabbed In Shanghai Area Provoking Alarm

Troops Rushed to Hongkew Sector Later Remored; Tension Added to Sino-Japanese Relations

Shanghai, Nov. 5.—(AP)—Japanese troops were rushed into the Hongkew section of Shanghai today after an unidentified person stabbed a Japanese civilian.

The troops were removed later. The victim received a deep wound in the neck as he was walking last night with his wife and child.

The attack added fresh tension to Sino-Japanese relations, which have been improving since the killing September 23 of one Japanese marine and the wounding of two others in an attack which Japanese officials said was made by an unidentified Chinese.

Three smart sleuths and administrators hold the call on the post of chief of the consolidated service. They are Joseph E. Murphy, acting Chief of the Secret Service; Elmer Irey, head of the Treasury Intelligence Unit; and famed Louis Glavin, who left the Interior Department to dig up election scandals for the Senate Campaign Expendi-

CHIEF JUSTICE HALTS APPEAL IN MOORE CASE

Rules Justices Considering only Record Proper

LAWYER FAILED TO FILE APPEAL

Attorney for Convicted Slayer of Helen Clevenger Seeks To Save Negro.

Raleigh, Nov. 5.—(AP)—The State Supreme court declined to hear oral appeal arguments today in the case of Martin Moore, Asheville negro, pleaded to die by gas for the slaying of Helen Clevenger of Staten Island, N. Y., on the ground the appeal had not been properly perfected.

Chief Justice W. P. Staver interrupted Stanford W. Brown of Asheville, Moore's counsel as the attorney explained the background of the case.

"The case on appeal isn't before us and we have no authority to take cognizance of that," the judge said. "We have nothing before us in proper form except the record proper."

Under rules of the court it will study the "record proper" and render a written decision at a later date. Usually such decisions briefly docket and dismiss the appeal or find the judgment of the lower court is affirmed.

Brown said he had no immediate plans, but added "if there is any method by which I can secure a hearing I will take the proper steps."

The state moved to docket and dismiss the appeal several weeks ago after Brown had failed to file his case within the required legal time, but on Brown's motion the court granted an order setting the case for argument this week.

Hyde Park, Nov. 5.—(AP)—President Roosevelt had as luncheon guests at his Dutchess county home here today Eugenio Cardinal Pacelli, secretary of state at the Vatican, who is visiting the United States, two American bishops of the church and the cardinal's secretary.

White House officials would not comment when asked if the meeting might touch upon the political speech making of Father Charles E. Coughlin of Detroit.

All they would say was the President was extending the Catholic dignitary a courtesy that would be shown any visiting personage from abroad.

HOUSING PLAN IS CONSIDERED

With Millions Votes Yet to be Tabulated, Roosevelt Assured of All But Two States; Senate and House Emphasize Crushing Triumph.

(By Associated Press)

With President Roosevelt's popular majority snow-balling toward the smashing figure of 16,000,000 as late returns rolled in, eager New Dealers busied themselves today with drafting suggestions for a broad program in the overwhelmingly Democratic 75th congress.

A vast low cost housing plan and "ever normal grainery" for the farm lands, crop insurance a drive to convert farm tenants into farm owners and American Federation of Labor efforts to obtain new regulation of wages and working hours—all these bulked large in the thoughts of powerful groups among the President's followers.

Mr. Roosevelt gave no intimation of how he felt as to details of the various proposals.

Though millions of votes had not yet been tabulated, the President's popular plurality also well past the 9,000,000 mark today. It already had set a new American record and was still climbing with indications it would pass 10,000,000.

Total votes cast also already had set an all-time record, reaching 49,297,133, with 11,331 voting districts still to be heard from. Of the total Roosevelt had 24,778,018 and Alf M. Landon 15,447,771.

The returns today seemed to clinch the indications of yesterday that the electoral score would read: Roosevelt, 533; Landon, 8, when congress goes through the formality of counting the votes in January. Landon still had only Maine and Vermont.

Late returns on Senate and House contests emphasized the crushing character of the Democrat triumph. With most contests already decided, it appeared the Democrats would have 78 of the 96 senators.

Pre the House, the Democrats had elected at least 329 members, a new high record. Eighty-nine Republicans had won seats, six progressives, five farmer-laborites and six chairs remained in doubt.

Former Long Ally Describes Arrest As Act of Revenge

Gerald L. K. Smith says His Incarceration Forerunner of Action to Come from 'Farley Dictatorship'

New Orleans, Nov. 5.—(AP)—Gerald L. K. Smith said today his arrest on election eve was a forerunner of the revenge the "Farley dictatorship" will take on those who have been critical of it.

Smith, former organizer of share our wealth clubs for the late Huey Long, was given a suspended sentence of 10 or 150 when he was convicted in night court early today on charges of disturbing the peace, reviling the police and using obscene language. Four companions, arrested with him were similarly sentenced.

"This arrest and incarceration is just a forerunner of the reprisals which we may expect all over America as the Farley dictatorship seeks revenge on those who have been critical of its regime," he said.

Smith and his companions were taken into custody at a hotel after he returned from a mass meeting at which he criticized the state's and nation's administrations.

SUCCESSOR TO POPE TALKED

Arguments on Many Sides Favor American Prelate

VATICAN CITY.—(Special Exclusive)—The highest Vatican circles are seriously contemplating Cardinal Hayes as possible successor to Pope Pius XI. The Holy Father's health during recent months has created great anxiety among the Cardinals in Rome and raised much discussion. Contrary to current reports, Secretary of State Pacelli is not being prepared for the Papal Throne. According to insiders, the tradition against making a Vatican foreign minister Pope will be upheld.

Two arguments favor the American prelate. Pope Pius feels that the United States is the ideal base for Catholicism's great drive against the "new heathenism sweeping the world." An American Pope would guarantee the fervid support of the wealthiest Catholic community in the world. And of all the non-Italian candidates, an American would give the Papacy a much desired neutrality. Nothing definite can or will be decided, of course, while the present Pope lives. But the trend is significant.

The Vatican itself resembles a general staff headquarters preparing plans and arms for a big offensive. Since the time of the Counter-Reformation, churchmen have, no such extensive reorganization of personnel and propaganda methods has been undertaken. The whole worldwide net of Catholic organizations and sub-organizations is being contacted directly from Rome and cleared for action. The Church is to be adjusted to modern political, social and cultural conditions. Appeal to the modern individual from pulp, press, and radio is the watchword. The Catholic Movement Rome's militant organization numbering millions all over the world, will be marshalled direct from Rome by Monsignor Pizzardo—next to Pacelli, the Holy See's shrewdest diplomat and politician—instead of by the local Bishops as before. The Priest's education is to be thoroughly revised and modernized—with special attention to modern propaganda methods. In addition there will be established in each country a central bureau, responsible only to Rome, to combat red agitation with every political weapon available.

The Spanish civil war has convinced the Holy Father that happened measures can no longer be pursued. The Church must fight, and at once. A stop-gap arrangement that seemed to promise a reconciliation with Hitler has broken down. Persecution of Catholic priests is beginning again, with the resistance from the people except in Munich where Cardinal Faulhaber's dominating personality holds a great following. Rome realizes that that example that the Church has lost contact with the masses. In France the prelate complain of the same tendency. And even in Italy, despite the peace between Mussolini and the Church, Fascist saber-rattling fascinates the young Italian far more than going to Mass.

High churchmen in Rome admit that Father Coughlin has taught them a lesson. They are almost unanimous in disapproval of the "Radio Pater" for his undignified attacks on Roosevelt and his political activity. But as one authority said to me, "Coughlin has shown us the way of getting at the modern man. He has embarrassed us by showing and using the political power of the Church so openly. And we have not dared to interfere for fear of American newspaper scolding. Interference from Rome. We shall curb him after the presidential campaign is over. But he has done us a great service by opening our eyes to possibilities. In Europe people are so accustomed to radio propaganda that the Vatican radio can have but little effect. We know how to tackle America, however, and that is our most important problem at the moment."

Cardinal Pacelli's trip is being watched with great interest. The Papal foreign minister has apparently advised the Holy See that the establishment of a Nunciature in Washington is inadvisable at the moment. He was frightened by the intensity of the election campaigns in the racial and religious groups, and feels that any tampering with Roosevelt or Coughlin at this time would lose a God of anti-Catholic

"Call off the premiere," cried the playwright quickly. "At this rate we'd be suckers to open."

Kaufman Gags

As gags and rehearsals usually go together, one is reminded of a typical Kaufman witicism that cropped up during rehearsals of "First Lady," that sly jibe at social Washington which amused New York audiences all last winter.

Jane Cowl was the star and she attended rehearsals wearing a gigantic fur piece. Jane also had on her glasses, the better to read her script, and while going thru her gestures the piece flew up and knocked her glasses to the floor. After this happened three or four times, the star came perilously near to exploding.

Kaufman, managing a straight face while observing this unofficial comedy, strode to the telephone and called Sam Harris, producer of the show. "We just had a most amusing scene here, Sam," Kaufman exclaimed. "Jane's fur piece woke up and dragged her half way across the stage."

The follow-up to this came several months later when Kaufman, returning from a holiday in Florida, dropped by the theatre and noted a few changes in dialogue that Miss Cowl had brought about.

Speeding to a Western Union office, he sent Miss Cowl this wire: "Saw your performance tonight and it was more magnificent than ever. Glad I can't say the same for some of the lines."

What He Wired Gaxton

You remember, naturally, that other telegram, inspired by Bill Gaxton in "As Thousands Cheer," Ducking in for a peep at his opus, George caught Gaxton in an extremely sour performance. "Am watching you from the back row," he wired. "Wish you were here."

Then there was the time Sam Harris offered Kaufman an interest in one of his gold mines. Harris has become an avid prospector and owns several extraordinarily worth while holdings. Giving Kaufman an enthusiastic sales talk, Sam waxed eloquent of the profits to be had from such a venture.

"Why," he exclaimed, "the first thing you see when you enter the mine is gold nuggets scattered around on the ground."

"I know," objected George "but you have to stoop to pick them up."

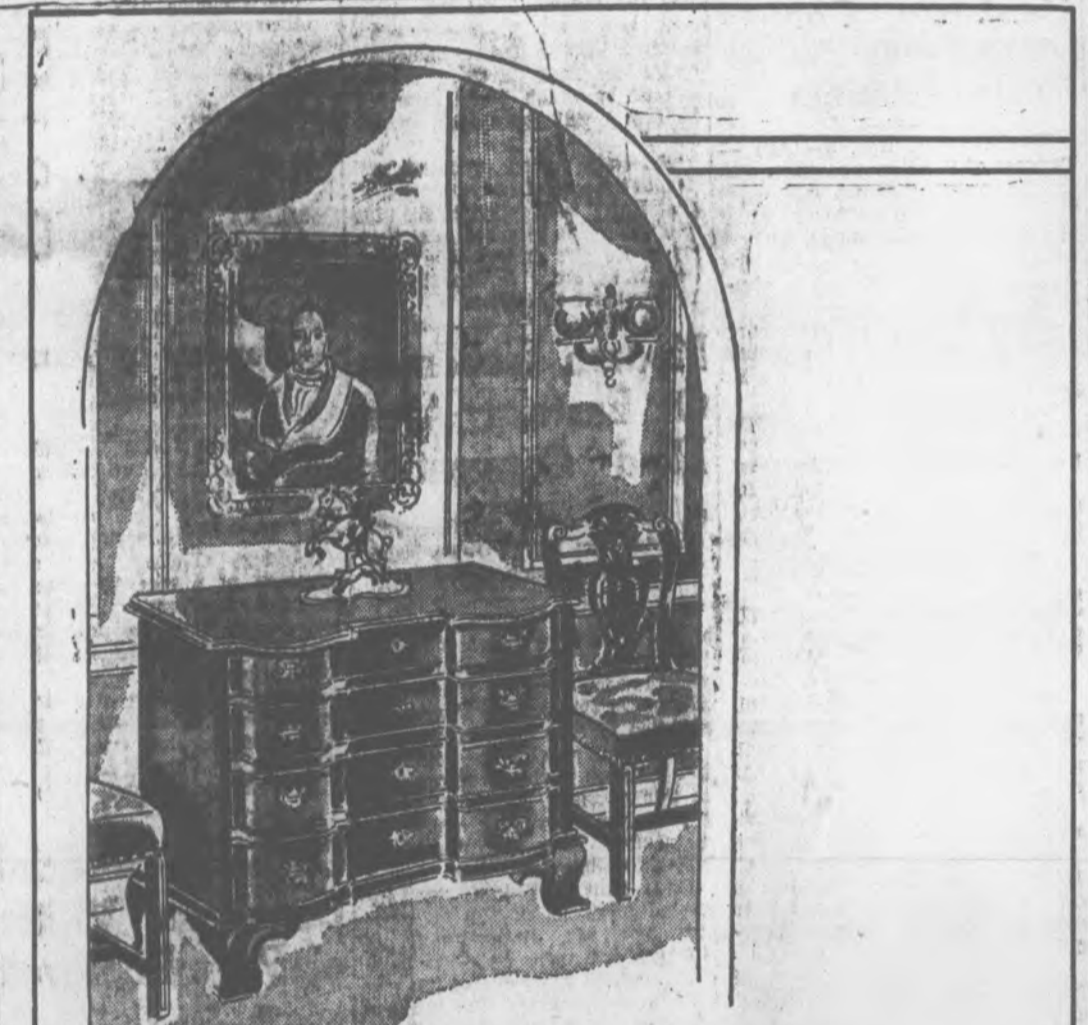

writing boys for the G. O. P.'s last minute attack on the law's tax features, which might have turned the tide under normal circumstances. Whirligig mentioned this situation some months ago. The Board's publicity chief declined to furnish information on the details of the act, including the payroll tax. He concentrated on explaining the philosophy of the measure through lectures to small groups, through ponderous tracts and similar methods. But he never issued to the press a factual study of the law or administrative decisions.

As a result, wage earners generally were ignorant of the provisions requiring them to pay 1 per cent of their income in return for old age and unemployment benefits. Therefore the Republican bombardment took them by surprise, and led them to feel that they had been bamboozled. Had this information been broadcast months ago it would have effectively stymied the Republicans' attack. At least it would have robbed it of any of the surprise element.

BETTING: Negotiations between TVA-ers and private utility interests are nearing the showdown stage, despite silence of the principal participants. Both parties are playing for high stakes, and are anxious to reach an agreement. Stripping the conflict of non-essential, here's the immediate situation: Commonwealth & Southern representatives—and they speak for the industry in this particular fight—went the administration to revise its yardstick so as to include all legitimate costs, and then confine its experimenting to the Tennessee Valley. That would, of course, mean a virtual surrender by FDR of his original position that he would stud the country with "yardstick" projects.

LESSON: A Roosevelt diplomat's wife recently taught a certain American railroad that it had incurred excessive expense for a \$25 fare—the diplomat's wife—he was congratulated. Additional passengers not only filled the extra Pullman but a second one. Now the train runs every night with two more cars than it ever carried before.

NOTES: Government will soon be regulating trucks and buses operating across state lines, including size and weight of vehicles, qualifications of driver and hours of service. . . . Washington holds the per capita lead for number of automobiles and telephones. . . . Argentina jumps to fifth place among countries doing business with the U. S. . . . France drops to seventh place. . . . Nearly 125,000 government clerks sent ballots to home states.

New York FIREWORKS: New Yorkers in close touch with Spanish affairs predict that General Franco—if and when he finally suppresses the loyalists—will have plenty of grief in trying to set up a strong and effective fascist regime.

It has never been made clear on this side of the Atlantic that the rebel forces comprise three diverse elements which will probably fly at each other's throats as soon as the common enemy is safely vanquished. Inside prophecies are offered that this will happen within three weeks after Madrid is occupied.

The three elements are: (1) outright fascists, like Franco himself and probably a majority of his officers; (2) monarchists, and (3) right wing democrats who want to restore a constitutional republic with the extreme leftists eradicated. We have not heard much about the third group, but in some ways they have been the backbone of the rebellion. They will resist fascism vigorously and as soon as Madrid is taken will move to have the Moroccan troops, which are Franco's main reliance, shipped back to Africa. That will probably be the signal for fresh fireworks.

RULING: The latest battle in a war that has so far lasted more than forty years will be fought it and when the power companies decide to resist the Federal Power

Commission's new order to make them keep their accounts on the basis of original cost. The F. P. C. has no authority to fix rates itself but utility men fear that the figures will be used for rate-making purposes.

The argument about the proper system for valuation of properties on which railroad and utility rates are based traces back to William J. Bryan and the panic of 1893. As a result of the panic, deflation had sent prices way down, so that the cost of reproducing a given railroad property at the time was obviously much smaller than the original investment cost. Bryan therefore contended that reproduction cost was the only fair valuation. He was shooting for lower rates. Lawyers for the railroads countered with equal fervor that original investment was the only reasonable gauge.

QUARREL: The Supreme Court has stuck to that broad principle in all rate cases that have come before it ever since. But the railroads and utilities have been on one end of a see-saw—advocates of cheaper rates on the other. Whenever we are in a period of falling prices, the former claim that original investment is the one proper formula, the latter that reproduction cost is the only answer. When the price level has been rising, both sides have fervently reversed their position without the slightest regard for consistency.

The second situation rules at present, which accounts for the Power Commission's insistence on original cost data, and the unwillingness of power companies to comply with the Commission's command.

The trouble is that the utilities might have difficulty proving, even to a sympathetic court, that they have been deprived of property by a simple demand for information by a government agency. On the other hand, if they comply, they may be setting a trap in which they will later be caught. The question is important as another phase of the "confiscation" issue in the relationship between government and industry. An old quarrel is to be revitalized in terms of the New Deal—and the power companies are at a disadvantage because they don't know which way to jump.

WISECRACKS: In this column yesterday we mentioned the Economists' National Committee on Monetary Policy—composed of leading conservative economists—and its readiness to fight the Committee for the Nation or any other agency which seeks to promote a managed money policy.

An official statement of "Purposes of Committee" includes the following: "To combat unsound monetary programs such as those of the inflationists, deflationists, and commodity dollar advocates."

"To educate the public as to the desirability of an early return to the gold standard." (That's getting down to cases.) "To make it clear to the country that much of the monetary advice given to the President is not representative of the opinions held by the great majority of the leading monetary authorities of this and other countries."

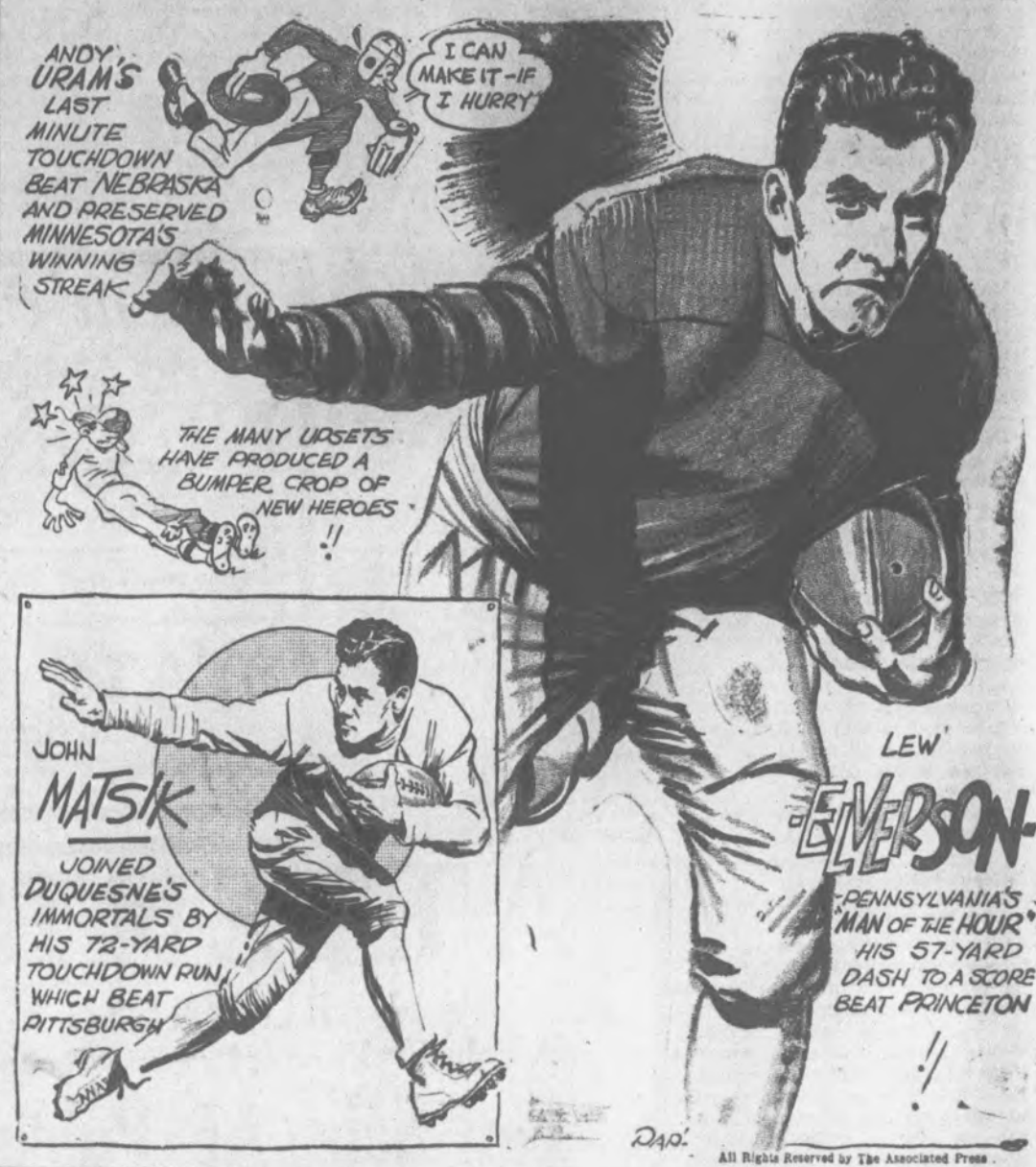

How's Your Health—

Know Your Colds

A stuffed nose, infected eyes, sneezing and the secretion of copious amounts of mucus do not of themselves establish the existence of a cold. These symptoms merely indicate that the upper respiratory system has been irritated and is reacting to the irritation in its physiologically definite manner. Sneezes, hay fever, grippe and

even emotional disturbances can give rise to this combination of symptoms, so generally interpreted by the public as signs of a cold. Hence it is valuable to be able to distinguish at least in a preliminary way the signs and symptoms of the common cold from those of some other, perhaps more serious, condition. This is advised not to encourage self-diagnosis, but rather to warn against the danger of considering the symptoms as pointing to "nothing more than a cold," when indeed they are due to a serious influenza, or a pneumonia. The common cold seldom if ever has a fulminating onset. The sufferer doesn't come down "of a sud-

den." There may be some headache and a general feeling of malaise. But there are no sharp pains in the chest, and seldom any sudden exhaustion. These latter symptoms are more suggestive of pneumonia and influenza, respectively. Fever is not usually present at the onset of a common cold. On the contrary, the temperature is more likely to be slightly subnormal. The patient frequently complains of feeling chilly or cold, and his skin feels dry and cold. At first the nose is dry and feels irritated, but within a few hours there appears a thin and watery discharge. Sneezing is usually common at this stage. Subsequently the nose becomes stuffy and the discharge changes from a watery to a thick consistency. The inflammatory condition may extend to involve the tonsils, the throat and the chest (bronchi).

The clinical picture then changes; there may be cough, fever and pain in the throat and chest. The uncomplicated common colds run their course in from three days to two weeks.

The common cold is one of the most widespread diseases. The majority of the population experience from two to four colds a year. By itself the common cold is not a menacing condition but, in that it lowers resistance, and "opens the way" for more serious disease, it represents a major health problem. "Colds" that begin with fever and pain, colds that hang on, colds that "knock the patient out," are not of the common variety. They should not be home treated. The patient should get to bed at once and call a doctor.

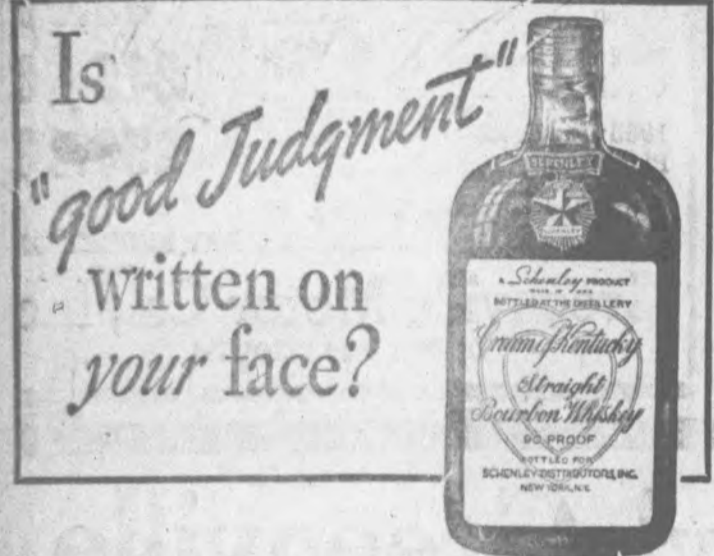

SEEK TO SAVE WILDLIFE AREA

Sherwood Forest in Pisgah Park is Ordered Closed

Reflector Bureau, Sir Walter Hotel, Raleigh, Nov. 5.—The first step in the development of another outstanding wildlife area in Western North Carolina was taken recently when the Board of Conservation and Development ordered the closing of the Sherwood Forest section of Pisgah National Forest in Haywood County to all hunting and fishing until further notice. J. D. Chalk, State Game and Inland Fisheries commissioner, announced today.

This track, according to the commissioner, contains some 30,000 or 40,000 acres and has recently been acquired as a part of Pisgah National Forest. Closing of the area to hunting and fishing was requested by the U. S. Forest Service, Mr. Chalk said.

Adjoining the Pisgah National Game Refuge, consisting of some 8,000 acres of land, the streams of Sherwood Forest are said already to be well stocked with fish and there is a considerable deer population on the area.

Closing of the area to hunting and fishing is said to be the first step in the establishment of a comprehensive wildlife management program, probably to be carried out cooperatively between the U. S. Forest Service and the State Department of Conservation and Development. Owners of the tract, according to Mr. Chalk have had the wildlife on Sherwood Forest under protection for some years.

Western North Carolina, in Pisgah National Game Refuge, and the system of State refuges on federal lands already provide the country with outstanding examples of wildlife management and the restoration of various species of game previously almost extinct in the area. Efforts to restore the deer population on the protected areas and the territory surrounding have been notably successful.

The Department of Conservation and Development, according to Commissioner Chalk, is about to undertake a comprehensive program for the purpose of restoring wild turkeys. Availing themselves of the benefit of experiences elsewhere, conservation officials hope these efforts will be successful.

given the state consistently good government for 36 years and that it has a definite program for the future of the state where the Republican party has none. The people of North Carolina, like the people of the nation, are too intelligent and too enlightened to trade something definite and worth while for nothing or to trade horses in the middle of a river. When they have something that has been tested and proven, they are not going to throw it away.

The results of Tuesday's election also show that the Democrats of North Carolina were "regular" and

that the Republican leaders were following a forlorn hope and a will-o'-the-wisp when they maintained that many "liberal" Democrats would bolt the party and vote for Roosevelt and Hoey, Chairman Winborne said. Instead, a great many Republicans voted for Roosevelt and Hoey or at any rate for Roosevelt, Winborne is confident.

"The reason that few if any Democrats bolted the Democratic ticket here in North Carolina is that here a Democrat is a Democrat first, last and all the time, even though they may differ among themselves and have hot primary campaigns," Chairman Winborne said. "When a Democrat gets in a voting booth and looks at the two tickets, he is going to vote the straight Democratic ticket every time. Perhaps some day the Republicans here in North Carolina will wake up to that fact and stop trying to stir up trouble among the Democrats in the hope of converting the losers into Republicans in the general election."

Whatever discrepancy exists between the total vote for President Roosevelt and the total vote for the state Democratic ticket, is not due to any ticket scratching by Democrats but to the many Republicans who voted for Roosevelt for President and who either did not vote any state ticket at all or else voted the Republican state ticket, Winborne is confident. However, a great many Republicans went all the way and voted the Democratic ticket both for President and state officials. Winborne pointed out, as indicated by the larger than usual Democratic vote in the decided strip in the size of the Republican vote.

"There is no other way to explain the large vote which President Roosevelt received in many of the normally Republican counties," the chairman said. "Take Davie county, for instance, which gave a majority to Roosevelt but which went Republican as far as the state and county tickets were concerned and where there was some 500 votes difference between the vote for President and the vote for Governor, with the normal Democratic vote remaining about the same. This was true in other counties, indicating that far more Republicans split their tickets this time than Democrats. North Carolina Democrats are Democrats and vote their tickets straight."

Several Counties Added To List In Democratic Ranks

Party Wins Seven and Loses Only One in Tuesday's Election; Six Counties Remain Republican

Reflector Bureau, Sir Walter Hotel, Raleigh, Nov. 5.—The Democratic party in North Carolina won seven more counties into the fold which formerly have been Republican and lost only one county which had been Democratic to the Republicans in the election Tuesday, with the result that 94 counties are now in the Democratic column and only six in the Republican, while one of these six Republican counties gave a majority to President Roosevelt, Secretary D. L. (Libby) Ward of the State Democratic Executive Committee, announced today on the basis of returns tabulated so far.

These returns are not yet complete or official but are not expected to be materially changed when the official figures are in.

The seven counties which heretofore have been Republican but which went Democratic in this election are Cherokee, Wilkes, Rutherford, Catawba, Lincoln, Randolph and Sampson. The one county which had been Democratic and which went Republican this time is Clay, a county usually regarded as being more Republican than Democratic. Clay deserted the Republican column in 1932 when it cast 1,341 votes for Roosevelt and 1,265 votes for Hoover.

The only six remaining Republican counties in the state are Clay, Madison, Mitchell, Yadkin, Davie and Avery, although of these Davie gave Roosevelt a majority. This means that there will be only six Republican members of the house 1937 general assembly and possibly two members of the senate, although the lead of both the Republican senators over their Democratic opponents is so small that it may be overturned later. But for the time being, Democratic headquarters here is conceding their election.

In the 1935 general assembly there were twelve Republican members of the house and two Republican state senators.

"The results of this election speaks for themselves and answer the claims made by the Republicans before the election that thousands of Democrats were going to vote Republican this time," Ward said.
