Governor Ehringhaus Says N. C. Security Law Adequate

STATE ATTORNEY APPROVED ACT

Controversy Over Definition of Word 'Required' in State and Federal Laws

Raleigh, Nov. 30.—(AP)—Governor Ehringhaus continued today to contend that North Carolina does not need a special legislative session to comply with the federal unemployment insurance law.

"We have a law which the attorney general of our state says complies" the governor said. "But the general counsel of the federal social security board of rules that it does not because it does not contain the same definition of the word 'required' as is contained in the federal act."

Thomas H. Elliott, 26-year-old lawyer, is the board counsel. The governor said North Carolina law permits an unemployment insurance authority to call for contributions from employers before they may qualify under the statutes, but does not require the constitution in the form of a tax which Elliott is necessary to comply with the federal act.

In Favor Building Sheds To Protect Rural School Kids

WPA Official Proposes to Construct Sheds to Protect Students While Waiting for Trucks

E. S. Askew, district public relations manager for WPA, has revealed that a movement is underway for constructing sheds in which school children can take refuge from the cold and rain while awaiting school trucks in the morning and after being unloaded in the afternoon.

Mr. Askew, in this city for a brief visit, declared that the School Commission was backing the proposal and quoted officials of that body as saying it would reduce the operating costs of the trucks by 20 per cent. It was explained that if the sheds are erected the children would gather at the points and the trucks would gather up many children at one time. Mr. Askew said that one-half of the children transported to and from school were picked up and discharged one at a time.

The WPA official also said the highway department was behind the movement, holding the plan would cut down the number of accidents and also would prevent slowing up of traffic while children were being loaded and discharged. He recalled that all vehicles are required by law to stop and wait when the trucks are loading or unloading children and said this necessarily retarded traffic to a great extent.

He quoted figures showing that there are 4,000 school trucks operating daily in the state, covering 6,000 routes of 15-mile average each day. He said that the average bus hauled 60 children per day, adding that half of these are single pick-ups.

Brower Appointed To High Position on Duke Memorial

Director of State Division of Purchase and Contract to Begin New Duties January 1

Durham, Nov. 30.—(AP)—Appointment of Alfred S. Brower, director of the state division of purchase and contract, as executive secretary of the Duke Memorial was announced by Duke authorities today.

The announcement said one of Brower's principal activities during the next year would be in promoting the university's centennial fund. Brower's resignation it was stated has been given to Governor Ehringhaus, and he is expected to begin his new duties about January 1. He has been director of his present agency since 1931.

Raleigh, Nov. 30.—(AP)—Governor Ehringhaus announced today the resignation of Brower and said his successor would be named after a conference with Governor-elect Clyde R. Hoey.

FORBES YOUTH DIES AT 10:15

Funeral Services from Home of Aunt Tomorrow P.M.

Dillon Forbes, 14-year-old son of Mr. and Mrs. Gus E. Forbes, died in the local hospital at 10:15 o'clock this morning of injuries he suffered Saturday when he was accidentally shot while he and a companion, Otis Evans, Jr., were duck hunting.

After having been shot the youth walked about a mile and a half to the country home of his parents. A discharge from a .22 calibre rifle entered young Forbes' back. He was rushed to the hospital and was given blood transfusions following an operation, but was unable to survive the wound and loss of blood.

Funeral services will be conducted tomorrow afternoon at 3 o'clock at the home of his aunt, Mrs. J. S. Barr of East Fifth street, with Rev. H. Frederick Jones of Baltimore, Md., but a former local pastor in charge. He will be assisted by Rev. T. M. Grant, new pastor of Jarvis Memorial Methodist church, and Rev. J. R. Potts, local minister. Burial will follow in the family cemetery on the Falkland highway.

Young Forbes was a sophomore in the Greenville High school and was popular both with his teachers and his school mates. He was a member of last year's baseball team, having played third base. He also was a member of Jarvis Memorial Methodist church.

Besides his parents, he is survived by two brothers, Gus, Jr., and Harold Forbes.

Governor-Elect To Name Holders For Many Posts

Raleigh, Nov. 30.—Governor-elect Clyde R. Hoey will have 30 appointive jobs to fill when he becomes Governor the first week in January. Some of these are direct appointments, some are made by commissions after the person desired for the post has been "suggested" to the commission by the Governor, and some are jobs as heads of divisions in departments with appointive heads, concerning the filling of which the Governor is generally consulted.

So with these three types of jobs included, most observers here agree that the new Governor will have from 30 to 35 choice jobs, with salaries ranging from \$6,000 a year down to about \$3,000 a year to pass around when he takes office, provided he does not intend to reappoint any of those now holding these offices.

The most desirable of the offices which the Governor will have to fill by appointment are regarded as being the two new Associate Justices of the State Supreme Court, at

Citizens Shown to Be Buying More Expensive Gifts

EXTRA PAYMENTS ARE BIG FACTOR

Predicted Christmas Shopping to Be 15 Per Cent Greater Than in 1935

Washington, Nov. 30.—(AP)—Secretary Roper said today that reports to the commerce department from all sections "clearly show that people are buying this Christmas more expensive types of gifts than for any season since 1929."

At the same time Roper made the first comment from an administration source on recent heavy dividend declarations. He said "the unprecedented distribution of corporation funds through bonuses and extra dividends is a most stimulating factor" in the Christmas buying surge.

"Progress reports" on Christmas business, the Secretary said, support previous predictions that the department stores' sales this season "will be at least 15 per cent greater than in 1935 and will closely approach the volume attained in the 1929 season."

"Reports give evidence of the fact that people throughout the country are in a much more progressive condition now than has been the case for the last seven years," he continued.

Nash County Man Is Held On Charge of Criminal Assault

Nashville, N. C., Nov. 30.—(AP)—C. A. Leonard, 25, son of a prominent Nash county resident of the Red Oak section, was held without bond in the county jail here today on a charge of committing a criminal assault upon Miss Mattie Casey, 21, of Rocky Mount.

A preliminary hearing slated for Saturday was proposed by a Nash justice after defense attorneys made pleas for an extension of time. The hearing was slated some time this week in Rocky Mount.

The young woman told officers that she went riding with Leonard Friday night and that the assault was committed near Red Oak. A medical examination corroborated this.

Miss Casey said she aroused her parents and told them of the attack after Leonard had brought her home.

Leonard was arrested a short time after by Nash officers.

Officials said the woman had a good reputation in Rocky Mount.

Fire Chief Gardner Warns On Insurance

Fire Chief George Gardner today advised property insurance policy holders who are using domestic oil heaters or contemplate such a heating system to check up on their policies and be sure fires caused by such a plant are covered.

Chief Gardner said that some policies have a clause which exempts the company from any liability if the fire is caused by oil burning systems and advised citizens to check up on this when renewing the insurance. He said that the old policies, which have been in effect for several years, were more likely to have the clause excluding fires caused by oil burners.

PRESIDENTIAL PARTY ARRIVES BUENOS AIRES

Delegates From 21 Nations at Peace Conference

ARGENTINE SHIPS ESCORT CRUISER

Roosevelt and President Justo of Argentina Exchange Warm Greetings

Buenos Aires, Nov. 30.—(AP)—President Roosevelt acclaimed by hundreds of thousands reached here this afternoon for the opening tomorrow night of 21 nations peace conference which grew out of his initiative.

The cruiser Indianapolis which carried the President on his 12-day trip from Charleston, S. C., docked amid the cheers of a huge throng on shore and the shrieks of whistles on hundreds of vessels in the harbor.

The cruiser reached the flower-decked dock at 1:34 p. m. James Roosevelt, the President's son, was the first ashore. He shook hands with Argentina's President, Augustin Justo and others in the reception group.

The visiting United States president descended the gang plank holding the arms of James Roosevelt, who had boarded the vessel. President Roosevelt got into a car waiting at the foot of the gangplank after greeting President Justo to whom he was introduced by United States ambassador Alexander Weddell.

Buenos Aires, Nov. 30.—(AP)—The United States cruiser Indianapolis, carrying President Roosevelt to the Inter-American peace conference at Buenos Aires, steamed slowly up the muddy Rio de La Plata river today escorted by nine Argentine warships.

More than 100 miles northwest delegates to the conference of 21 American nations looked forward to the president's arrival and the opening session at 6 p. m. tomorrow.

The Argentine capital was gaily decorated. The population took advantage of the general holiday. The presidential party was greeted off Montevideo, Uruguay, yesterday by the Argentine naval escort. Newspaper men and secret service agents aboard the cruiser Chester were transferred to the United States destroyer Phelps for the slow journey up the twisting estuary.

The Argentine warships saluted Mr. Roosevelt with 21 guns as the United States Chief Executive and President Augustin Justo of Argentina exchanged messages by wireless.

The Argentine president sent a message to Mr. Roosevelt saying, in part:

"The people and the government of the Argentine republic send forth a cordial salute of welcome and with unanimous feeling express the happiness with which they will receive your visit in the noble purpose which it inspires x x x."

Mr. Roosevelt replied, in part:

"I am eagerly looking forward to my visit, secure in the confidence that our mutual policy of the good neighbor will find fulfillment in the coming week."

Business And Roosevelt Begin To See Eye-To-Eye

The aura of better understanding which suddenly has enveloped the field of government-business relationship is becoming by all odds the most interesting phenomenon visible in the political heavens.

To this development, Mr. Roosevelt, on his side, has contributed notably. The tone and setting of his statement on re-employment, and his readiness to release Dr. Tugwell from his circle of official advisers are but two of several factors tending to eliminate business fear, distrust and dislike in Washington.

On the side of business, however, the signs are even more conspicuous. Every day brings some new manifestation that opposition to the President in important business quarters is weakening, that business confidence in that period of the future which will be spanned by the second Roosevelt administration is increasing.

THREE POWERS JOIN IN PACT

France, Great Britain and Belgium Said United

(By Associated Press) France, Great Britain and Belgium have formed what virtually amounts to a three-power military accord, informed sources in Paris said today, interpreting the projected pact as signalling a new western European alliance.

French Foreign Minister Yvon Delbos will announce the rapprochement Friday, these sources said, returning Britain's assurance of last week that the powers will come to each other's aid to repel unprovoked aggression.

Red Cross Roll Call Gets Under Way Here

The 1936 Red Cross Roll Call got under way here today at a breakfast attended by 21 workers, headed by Rev. W. A. Ryan, chairman of the campaign.

Workers took to the field with instructions to enroll every citizen as a member of the organization. Chairman Ryan said this afternoon that some few of the workers had submitted reports, but that he was unable to make any general report at present on how the drive was progressing.

REBELS AGAIN RAID MADRID WITH BOMBERS

Planes, However, Fail to Attack Center of Capital

OPTIMISM FELT BY DEFENDERS

Government Spokesmen Declare Back of Insurgent Attack Is Broken

Madrid, Nov. 30.—(AP)—Insurgent planes raided the capital twice today, bombing government lines in the University section and along the Manzanares river.

The fascists birdmen then wheeled back to their bases without attempting to bomb the center of the city.

The failure to take advantage of "perfect bombing weather" to attack the heart of the city itself puzzled military circles. The government pointed to the maneuvers as the latest indication that the back of the insurgent attack on Madrid had been broken.

The first insurgent air raid, shortly after midnight, loosed high explosive bombs around the Basco de Rosales.

Returning in mid morning the bombers ejected a squadron of government pursuit planes guarding the capital and dropped 10 projectiles, mainly among the University and Casa de Campo encroachments. Informed military circles attributed the failure to bomb the city proper to lack of gasoline and the fear of Franco's "mercenary pilots" to risk battle with the government's "now determined aviators."

A general feeling of optimism was felt throughout the capital.

Nine Cases Heard At Morning Term Of Mayor's Court

Two White Men and Seven Negroes Tried on Various Charges Involving Whiskey or Fire

Two white defendants and seven negroes were convicted in Municipal court this morning on charges involving whiskey or assault.

Speight Wadford was taxed with the costs on a drunkenness charge and Calvin Haddock was fined \$40 and taxed with the costs on a similar charge.

Isaac Joyner, negro, was fined \$5 and ordered to pay the costs upon conviction of assault. Carter Simpson, negro, was sent to the reformatory for 30 days upon conviction of a similar charge.

Clarence House and George House, negroes, were bound over to County court upon bond of \$200 each on charges of assault with a deadly weapon.

Charlie Green and Addie Green, negroes, were ordered held for trial in County court on charges of illegal possession of whiskey. Each was held under bond of \$50.

Claude Clemmons, whom Chief George Clark described as a "mean negro," was ordered held for trial in County court on charges of maintaining a disorderly house. Bond was set at \$200.

Several Injured In Wreck Here Saturday

Philip Croteh, Fred Arnold, John Hodges, Guy Evans and Dewey Buck all white men of Grimesland, cheated death shortly before 9 o'clock Saturday night when a Ford V-8 driven by Buck struck a Chevrolet driven by Morris Jones of Greenville Route 1, times over several times, and landed in a deep embankment adjacent to Stokes' Service Station on the outskirts of the city on Greenville-Bethel highway. The Ford was completely demolished and the Chevrolet damaged slightly.

The four occupants of the Buck car were rushed to Pitt General hospital for treatment. Three of the party received only minor bruises and were released Saturday night. Hodges, who was hurt seriously, and the others remained in the hospital, and was released Sunday.

Joyner, driver of the Chevrolet, and his companion, Miss Lillian Ruth Allen of Greenville Route 2, escaped unhurt.

Patrolman C. R. Williams, who investigated the accident, advised Joyner of the blame.

CO-OPERATIVE EFFORT BEST

At every Christmas season local civic organizations, churches, clubs and individuals do much in the way of bringing Christmas cheer to needy families in the community and of course this is a fine thing to do, but the efforts of the past have been more or less haphazard in the result that some of the families received help from two or three different agencies while others received no help whatever. In some instances families that had already been helped by one group sought and received further aid from other groups which of course is unfair when other families received no aid at all.

If our community is going to do a good job of taking care of our needy families during the holiday season there should be a co-ordinated effort and this is possible without some definite plans under which the matter can be handled. It is our idea that in order for as many families as possible to be helped, there should be one central bureau to which every needy case should be reported. These cases could be investigated as to needs and then given out to the persons or organizations who desired to help them. In this way more families could be given aid and duplications could be avoided. Likewise some families would be unable to impose upon individuals and organizations by soliciting aid after they had received it from another source.

To our own knowledge one family that received around \$40 worth of clothing and provisions two days before Christmas last year, as a result of The Reflector "Christmas Opportunity" campaign, then solicited and received aid from two other local organizations the next day, the organizations being unaware that the family had already been helped by someone else. This is one of many cases of duplication of effort and it seems to us that the way to render the best aid to the most needy families is to keep a definite record of each case and who is helping that particular family at Christmas time.

In the leaflet handed to each registering workman was a full explanation of what retirement pay he could expect if he earned such and such amount weekly. Not until this was made clear was the tax explained.

One part of the pamphlet listed just what employes could not share in the insurance—farm hands, domestics, and the like. Perhaps that made the sharers feel they enjoyed a sort of privileged status.

Now, should the act go out the window along with certain other New Deal enterprises, the individual workman, who may be a voter on any rectifying constitutional amendment, would know just how it affected him personally, and no mistake.

Incidentally, the information going into the hands of the social security board about what each man earns could provide the government first hand data on what might be expected from any income tax that reached down into the lower salary brackets. Much of this information is known now, of course, in a general way. Under the social security act it pays a wage earner to get credit for all he earns as it means more in the retirement envelope. Income taxes, on the other hand, work in the opposite direction.

Three-cent postage expires, next June 30 but don't get too hopeful of sending Aunt Susie a Fourth-of-July greeting for a penny less. The post office department does not expect to see the two-cent letter return for some time yet.

C.P. AND L. MAY REDUCE RATES

Fourth Reduction Expected Before First of Next Year

Raleigh, Nov. 30—A fourth reduction in its residential rates is expected to be made by the Carolina Power and Light Co. between now and January 1, it was learned here today from Utilities Commissioner Stanley Winborne.

The nature of this reduction or just how much it would amount to, was not revealed by Commissioner Winborne, who said that he could not make public the details of the reduction owing to the fact that a definite and final agreement had not yet been reached with the power company. But the reduction will be material and will bring about another substantial saving to the customers of this company, Winborne said.

The Carolina Power and Light Co. has already made three reductions in rates since Jan. 1, 1933, resulting in a saving of at least \$1,500,000 per year to its customers, as a result of negotiations instituted by the State Utilities Commission. Chairman Winborne pointed out. The Duke Power Company recently put into effect its fourth rate reduction during this same period. These reductions have saved its customers more than \$3,000,000 a year. Rate reductions made by other utility companies doing business in the state have resulted in a sav-

ing of more than \$1,000,000 a year to their customers.

"These estimates of the amount which has been saved to the public as a result of the rate reductions already made by the power companies in North Carolina at the instance of the Utilities Commission, and which total approximately \$5,500,000 a year, are made on the basis of business done at the time the rates were reduced and do not take into consideration the tremendous increase in the amount of electric current sold since the lower rates went into effect," Commissioner Winborne said. "If we should apply the old rates to the total amount of electric current sold the last three years and since the lower rates went into effect, the total saving would be at least \$20,000,000 a year instead of \$5,500,000."

An indication of the tremendous increase in the amount of electric current sold since the power companies started reducing their rates as a result of the first order issued by the State Utilities Commission in 1932 is shown by the fact that in 1935 the power companies in North Carolina sold 901,582 kilowatt hours of electric energy as compared with 1,097,221,348 kilowatt hours in 1932, an increase of 304,451,234 kilowatt hours. Commissioner Winborne pointed out. He indicated that a still greater increase in the amount of electric energy sold in the state is expected when the 1936 figures are compiled.

"It is now a recognized fact that the rates charged for electricity are among the lowest in the United States and virtually on a par with the rates at which the TVA is selling energy—and the TVA has no taxes to pay, while approximately 16 cents out of every dollar received by the power companies in North Carolina go to pay state taxes," Winborne said. No indication was given as to the nature of the new rate reduction the Carolina Power and Light Co. is

expected to make. But it is known that at the present time this company has two rate schedules, one known as the "immediate" rate and the second known as the "inducement" rate, slightly lower than the "immediate" rate and applicable to those who use larger amounts of current. It is believed that the Utilities Commission is now attempting to get the Carolina Power and Light Co. to agree to make the present "inducement" rate its regular rate for all users of current.

The "immediate" rate of the C. P. and L. Co. is as follows:
6 1-2 cents for the first 40 kwh.
4 cents for the next 60 kwh.
2 1-2 cents for the next 150 kwh.
E 1-2 cents for all kwh in excess of this amount of 250 kwh.

The "inducement" rate, which is applicable to all customers whose bills show they have used more current in any one month than in the same month a year ago, is as follows:
5 1-2 cents for the first 50 kwh.
3 cents for the next 50 kwh.
2 cents for the next 150 kwh.
1 1-2 cents for all kwh in excess of this first 250 kwh.

Commissioner Winborne is confident that the new rate reduction will be announced before January and perhaps even sooner.

How's Your Health?

Palpitation The word palpitation is derived from the Latin term palpitare, which means to throb. Palpitation is defined as the consciousness of the heart's action, whether fast or slow, regular or irregular. It is generally a disagreeable sensation. Sometimes to a sensitive person, it is very distressing.

Palpitation is a frequent complaint and one that brings the sufferer to the physician with the suspicion of his being a "victim of heart disease." Oddly, there is little common agreement among the patients on the meaning of palpitation. When required to describe exactly what they feel, some will report that their heart turns over. Others will say that they feel the feating in the chest, the throat, the eyes or ears. Still others will add to their complaint a feeling of pain in the region of the left breast and an inability to fill their lungs "sufficiently" with air.

What is the likelihood that one suffering such complaints actually has organic heart disease? In a recent survey of 900 consecutive patients attending a heart clinic and complaining of palpitation, it was found that roughly half were normal and without any cardiovascular disease. Of the other half, a third suffered from high blood pressure, another third from thyrotoxicosis (overactivity of the thyroid gland) and the remaining third of the condition known as paroxysmal tachycardia. The last is a condition in which the heart suddenly begins to

beat rapidly, maintains its rapid rate for a given period, then stops abruptly. Among those who suffer palpitation without any organic cause, the following appear to be common contributory conditions: Indigestion, particularly of the gas-producing variety. This is commonly observed in stout persons in whom the symptom is often worse in the evening and in bed at night. Obesity and overweight. Debility following illness, especially when the latter is of an exhaustive kind. Excessive intake of stimulants, such as coffee, tea and alcohol. Tobacco smoking. Anxiety, nervous excitement, fright and mental upset, especially in hypersensitive people.

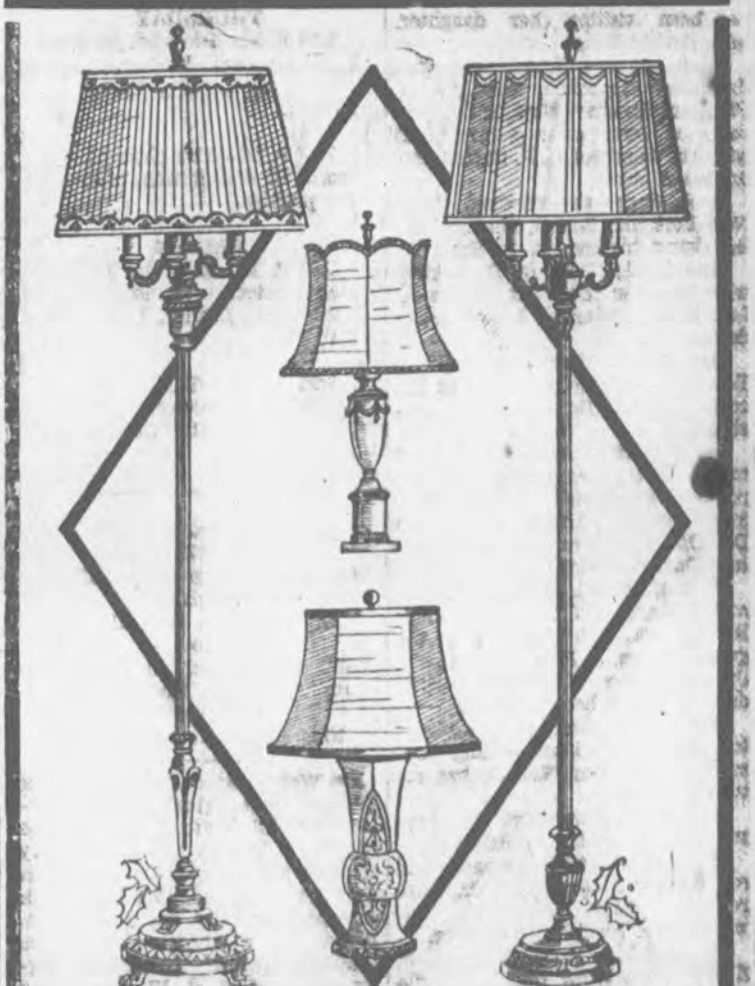
