KING PLEDGES UPHOLD HONOR OF HIS THRONE

All Birthday Anniversary Ceremonies Waived by Ruler

EDWARD SEEKING QUIET AND PEACE

Mrs. Simpson Guarded with New Vigilance Following Receipt of Notes

London, Dec. 14.—(AP)—George VI. Britain's new king, pledged to his parliament today "my constant endeavor with God's help and supported by my dear wife to uphold the honor of the realm and promote the happiness of the people."

His message was read first to the House of Lords while Edward, Duke of Windsor, sought relaxation in the guarded grounds of an Austrian castle and as a private citizen arranged to consult a Vienna specialist for an old ear affliction.

Into the new king's promise he injected the phrase "at a moment of great personal distress." It was George VI. forty-first birthday, but in the grave aftermath of the empire crisis created by his brother's love for a twice married American, he waived all anniversary ceremonies.

This action was in keeping with a call from the archbishop of Canterbury for nation concentrated anew to Christian sobriety.

Lord Halifax read the monarch's message to the House of Lords. It was transmitted to Prime Minister Stanley Baldwin for delivery to the House of Commons where members continued their individual oaths of allegiance to the king.

William Gallacher, communist member of the House of Commons, and several others refused to take oath of allegiance.

The dissenters substituted an "affirmation of good faith," but declined to swear the regular oath.

Troop Movement Started In China As War Looms

Tokyo Consults Germany on Tense Chinese Situation

Tokyo, Dec. 14.—(AP)—December 15 (Tuesday) The Domei (Japanese) news agency today received a Chinese report from Peiping to the effect the 105th division of the northeastern Chinese army going "outright communists" had revolted and seized its commander "young marshal" Chang Hsueh-Liang who last week imprisoned Chiang Kai Shek.

Reports from Shanghai said Chang Hsueh-Liang, imprisoned by Chiang Kai Shek after the latter had effected his freedom and staged a counted coup d'etat. The reports were not confirmed by Nanking government authorities.

Tokyo, Dec. 14.—(AP)—Tokyo consulted Germany, her anti-communist ally, today on reports the Komintern was behind the amazing seizure of Chiang Kai Shek amid Chinese predictions that China's overlord may face a firing squad if he still is alive.

Simultaneously it was reported the vanguard of a Chinese rescue expedition, pressing toward rebel-held Sianfu, had clashed with the mutinous troops of young marshal Chang Hsueh-Liang, who has seized Generalissimo Chiang Kai Shek.

Eight divisions of the Chinese central army, said Japanese dispatches from the mainland, were poised to assault Sianfu, which is presumed to be the place where Chiang Kai Shek is held.

Work has been started on the foundations of the station near Asheville, also the one near Salisbury and the concrete will probably be poured for these stations within the next few days. Excavation will start this week for the stations here near Raleigh and the one near Williamson, while work is scheduled to start on the Elizabethtown station early next week.

The houses for the sending equipment and operators are being built by the patrol on "force account" instead of under contract. Captain Farmer explained. As a result, a saving of about \$4,000 each is expected on each station structure. When contracts were called for on these station houses by the Division of Purchase and Contract some weeks ago, the low bids averaged about \$12,000 per house. These were rejected, the plans and specifications changed somewhat, so that it is now believed these station houses can be built for less than \$8,000 each.

They are being built of hollow tile and brick, in order to insure better temperature control.

In addition to providing space for the radio transmission equipment and an operating room, each station will have a dormitory room for the operators, a kitchen, repair shop and other facilities needed.

Since the stations will be in operation 24 hours a day, it was necessary to provide dormitory space and sleeping quarters for the operating staffs not on duty.

The patrol did not spend a penny for land for the stations, the land for four of the stations having been purchased by the counties and leased to the state for 99 years. The fifth station, here in Raleigh, is being built on state-owned land on the prison farm near the State Fair grounds.

REBEL FLEETS UNABLE SHAKE LOYAL TROOPS

Insurgents Batter for Two Hours at Government Lines

DEFENDERS HOLD OFF ATTACKERS

Wind Howls Down From Nearby Mountains as Fighting Is Renewed

Madrid, Dec. 14.—(AP)—Fleets of insurgent tanks, supported by infantry and machine gun units, battered for two hours today at government lines in University City, but slivering defenders held firm.

An icy wind howled down from the nearby mountains as the fighting broke out anew.

Defenders, however, said the long awaited insurgent "big push" had not materialized.

It was announced 60,000 non-combatants, men, women and children had been evacuated from the besieged capital in the past week. Of these many were children.

The socialist defense junta ordered complete reorganization of its militia forces in preparation for a bitter winter season.

While insurgent batteries threw occasional shells into the city, the defense forces were converted into "perfect" army units, the government said.

Committee Starts Preliminary Work For Public Forum

Executive Committee, of Which J. H. Rose is a Member, Maps Plans For Educational Program

The executive committee of the Seven-County Public Forum met in Goldsboro Friday night and made plans for the Forum, which will begin operations February first and continue through the month of June.

Superintendent J. H. Rose, a member of this executive committee attended the meeting.

This Forum, which was initiated by Dr. J. W. Studebaker, United States Commissioner of Education, is a federal project and is an effort to continue the program of educating the adults of the nation.

The Forum idea was started in Des Moines, Iowa, by the School Board of Des Moines, while Dr. Studebaker was Superintendent of Schools in that city. There were seven in America last year. This is the first one to be conducted in the south.

The seven counties included in the area are Pitt, Lenoir, Greene, Wilson, Wayne, Johnston, and Wake.

Dr. John Barclay, of Wilson, an aggressive and outstanding minister, has been released from his work in Wilson to take the position of full-time Forum leader and director.

There will be seven Forum Centers in Pitt county: one in the town of Greenville, one at East Carolina Teachers College, and five other centers to be named by D. H. Conley, County Superintendent of Schools. There will be at least two meetings in each Forum Center every month from February first to July first. The Forum speaker will usually do three things in a community. He will hold a program in the high school assembly program, during the morning; in the afternoon he will meet all the teachers of the schools; and at night, he will conduct an adult open forum.

The procedure is usually for the Forum leader to talk for forty minutes and then to carry on a discussion with the audience for forty more minutes. These Forum leaders will all be outstanding men brought here by the Federal Government, and their salaries will be paid by the Federal Government. They are usually men who have been released from some big position for a length of time, in order to do this work. More information concerning this vital public enterprise will be given later.

Pair Held In Connection With Bailey Axe Slaying

Deputy Sheriff Announces Arrests of Two Men

Wilson, Dec. 14.—(AP)—Deputy sheriff C. A. Brown of Bailey said today he had arrested Edgar Honeycutt and Tab Bunn, Nash county men, in connection with the axe slaying of Mrs. Mariah Bissette, 60-year-old Bailey woman.

He said Jesse Bissette, 35, son of the slain woman, still is being detained, but that no charges had been lodged against him.

Bissette was arrested after his mother's body was found in her home, the head crushed by a blow. A bloody axe lay near by.

Deputy Brown did not disclose why Honeycutt and Barnes were held, but officers had said they were looking for two men with whom Bissette had taken an automobile ride the night of the slaying.

# MAIN INTEREST ON ATHLETICS

## Regular Politics Showed in Background Around Capital

Raleigh, Dec. 14.—Athletic politics rather than regular state politics, are in the limelight here today and attention is turned more towards State College and the Chapel Hill unit of the University of North Carolina, than on the special session of the general assembly meeting here.

The interest in State College is in the meeting of the athletic council there today in which it is expected to decide whether or not it will offer Coach Harty W. (Hunk) Anderson another contract, whether it will retain Dr. R. R. Sermon as director of Athletics and otherwise settle the rather messy little of fish which has developed in the athletic department and which now threatens to involve Colonel J. W. Harrison, Dean of Administration, and possibly President Frank P. Graham of the consolidated University of North Carolina.

The interest in the Chapel Hill unit of the University is centered largely in the scrapping of the much famed "Graham plan" by the Southern Conference last week and the effect this may have on the future of President Graham of the University.

The tasks of deciding on a football coach next year and whether or not to offer Coach "Hunk" Anderson another contract is only a minor matter before the State College Athletic Council here today, those who have been delving into the State College football and athletic angle agree. The real task before the athletic council is for it to decide on a definite policy and determine who is going to run the athletic department out State, the athletic department at State, the or the coaches, it is agreed.

The council must also attempt to settle the bitter feud generally admitted to exist between the Dave Clark-Hunk Anderson faction among the alumni and students and the Dr. Sermon faction. There are some here who fear that unless this feud within the athletic department at State is not settled and settled quickly, it may get before the University trustees or even be thrown into the general assembly, which will convene in regular session in January. There are rumblings that it may lead to an effort to abolish football at State and that this effort would have the whole-hearted support of the Chapel Hill, Duke, Wake Forest and Davidson alumni in the general assembly.

**Plan To Transfer N. C. Hatchery To Fisheries Bureau**  
Surveys Being Made to Determine Boundaries of Property Preliminary to Passing of Title  
Reflector Bureau, Sir Walter Hotel, Raleigh, Dec. 14.—Title to the huge game fish hatchery near Hoffman in Richmond county which is being constructed as a Reclamation Administration project is expected to be transferred shortly to the U. S. Bureau of Fisheries, J. D. Clark, State game and inland fisheries commissioner, said today.  
Surveys are now being made to determine the boundaries of the hatchery property preliminary to the passing of the title of the station to the Bureau of Fisheries, Clark said.  
The commissioner said probably some 600 or 700 acres of land will be involved in the transfer. This includes the property on which the series of hatchery ponds in being developed, McKinney lake, and sufficient land on the headwaters of the lake to protect the water supply.

This hatchery, when completed, will be the largest unit for the hatching of warm water game fish in the southeast. It will provide, as designed at present, 29 hatching ponds containing approximately one acre each. In addition, there will be a series of rearing ponds containing about two and one half acres each.  
McKinney lake, which adjoining the hatchery property, contains some 75 acres and will be used in the cultural program. Some of the other lakes will also be used for natural pond fish culture and the rearing of brook stock for the hatchery.  
The dam impounding the waters at McKinney lake has been completed. Clark continued, and

# FDR Trip To Conference Spurs Peace In Homeland

By BYRON PRICE

The political implications of President Roosevelt's South American trip are more international than national, yet it is conceivable that when the event is viewed historically, it will be seen as an important force in the alignment of public sentiment here at home.

By design or otherwise, this venture into foreign fields fell at a most interesting moment. When he embarked for Buenos Aires Mr. Roosevelt left behind a nation which was in the first stages of convalescence from the wounds of a particularly bitter campaign. He had been the chief issue of that campaign, and his absence from Washington during the cooling off period naturally postponed declarations of domestic policy which might quickly have rekindled the fires of controversy and hatred.

It is worth noting also that the President chose this particular period to take up militantly the one cause in which there appears no appreciable division of sentiment among American voters—the cause of international peace. Even his bitterest pre-election foes must have felt a thrill of patriotic unity with this purpose.

It is difficult to conceive how any other possible course of action could have been better suited to apply curative medicines to the bruises inflicted by the campaign and election.

From this point forward, however, much depends on developments which cannot be foretold clearly. In view of past experiences—and particularly the European peace venture of President Wilson after the World War—it is going to be expected that whatever peace accord emanates from Buenos Aires will be examined very carefully by the American public.

If the conference can produce a program so lucid and so exactly defined as to remove all fears of unwanted involvement by the United States in the affairs of her sister nations, then it is natural to suppose that Mr. Roosevelt's triumph will be complete, and the curative medicine he has applied will be effective.

But if controversy and apprehension should surround the final handiwork of the conference, then Mr. Roosevelt might well expect quite a different result. A new issue of that sort, injected into the current post-election situation, might serve to rub salt on the old wounds and light up all of the old fires again.

Fortunately there probably will be no great delay in determining the nature of the Buenos Aires accord. Secretary Hull sailed from here on December 10, and he is expected to return in a few days. His return will bring back the conclusions of the conference, in completed form, before January 20, which is inauguration day. In these matters Mr. Hull seldom fails to accomplish his purpose.

A second factor yet to be assessed is the effect which Mr. Roosevelt's recent experiences, including his South American trip, may have upon the man himself.

Over a considerable period, in two continents, the President has been receiving plaudits such as few men have known in modern times. Will the campaign, plus the election victory, plus the ringing echoes of the southern trip, make an appreciable change in his outlook toward the national problems of the nation over which he presides?

Out of an atmosphere of zealous idealism touched with a hint of unreason, Mr. Roosevelt comes home to such sober, practical tasks as budget-balancing, industrial recovery, and the political guidance of a congress which, year in and year out, glances only occasionally beyond the three-mile limit.

What he does, what he says in his annual message to congress and in his inaugural address, unquestionably will be examined searchingly by those who desire to read the man's inner mind, after the experience of his recent past. That is one of the imponderables, at this stage, in the unfolding panorama of national destiny.

## WAR PRISONER SKETCHED WAY TO FREEDOM

Pittsburgh, (AP)—Lasko Gabor, art teacher at Carnegie Institute of Technology, sketched his way out of an enemy prison camp in the World War.

An Austrian lieutenant on the eastern front in 1916, he was captured by the Russians and interned with 250 other officers in a camp in the Ural mountains.

He helped publish a newspaper, printed from type another prisoner carved from wood, and illustrated by Gabor's woodcuts.

That enterprise attracted the attention of an official in a nearby town, and Gabor was taken to the village to sketch posters.

He won the friendship of a Russian girl who brought him a genuine passport to copy.

With the forged papers and a river steamer passage booked by the girl, he reached Ufa, got aid from the Danish consul, and finally made his way across the German border, then to Austria.

## Kentucky Weed Estimates Are Low

Louisville, Ky. (AP)—Information obtained by the Kentucky Department of Agriculture indicates that the state's barley tobacco crop this year will run between 100,000,000 and 120,000,000 pounds against 225,000,000 last year.

The department says its estimate is the consensus of people in a position to obtain the most reliable information, but that all agree the best estimate is only a good guess because some areas suffered from drought more than others.

# Man With Pince-Nez Punches Clock — So Kids Can See Saint Nicholas

NEW YORK. — (AP) — Nobody in the long line of employees knew that the man punching the time-clock ahead of them was Santa Claus.

To them, he was a man like themselves, of middle stature, clean-shaven, on time, who came through the employees' entrance, stopped at the clock, and picked up the key to his locker. Lots of them did that, many of them in exactly the same way.

But from there on, it was different.

The man who was Santa Claus went through the silent corridors of the huge department store till he came to a dressing room. There he removed his hat and coat, placed his pince-nez on a table, pulled on shining black boots, donned a red coat lined with white fur, and peering hard into the mirror, began to transform himself.

## Ready For Business

Wade of white cotton made his sparse eyebrows bushy. A white, foaming beard slipped over his chin and hooked onto his ears. Over his sandy-colored hair went a wig, and over the wig, a red and white hat. Suddenly he was fat, and jolly and red-cheeked.

With a sigh, he donned his pince-nez, folded his everyday clothes neatly, and stepped out of the dressing room. Next to the dressing room was a smaller room that contained a huge chair and a fireplace made of red paper. The man who was Santa Claus sat down, and his duties began.

Into the cubicle came children. Some stopped short as they entered the presence of Santa Claus, as if somehow they had not believed he would really be there. Some clapped their hands in joy. Some began to cry. One or two in the endless child procession tried to yank his beard, whispered nasty words.

The man who was Santa Claus had a smile for all, and a shake of the hand, and a cheery "What would you like from Santa?" ## Talks To Parents

### A College To Fit

All schools—especially all colleges—are not necessarily suited to every child.

John, who is fully developed both mentally and socially, who has a strong physique and is emotionally stable, may do very well in a big university where the individual is thrown more or less on his own resources.

Sam, who is ready for college, but whose brain has grown faster than his body, who has little social sense and is emotionally immature, might be better off in a smaller college.

Mary, who has never met boys and is just beginning to take an interest in them, might be all right in a girls' college. Or she might profit by the contacts of a co-educational institution.

Every child must be separately considered. Just because the family has always gone to Yale or Vassar is no reason to suppose that all the children will do equally well in those schools. Tradition is a very poor guide in choosing schools.

Of course it would be ideal if a child's brains, body, social sense and emotions kept pace with one another. But even the most careful, scientific upbringing will not assure this. Many children can pass all their preparatory examinations at 16 or even 15, and in all respects except the intellectual, remain mere children. To throw such a child suddenly into the freedom of the life of a big university is frequently unwise. Their dependence on home and guidance should be broken more gradually. Especially is this true of girls.

Sometimes a year abroad or in a junior college will help tide the child over and teach him to stand on his own feet. In any event, the result of careful thought, not merely a matter of family tradition or casual acceptance.

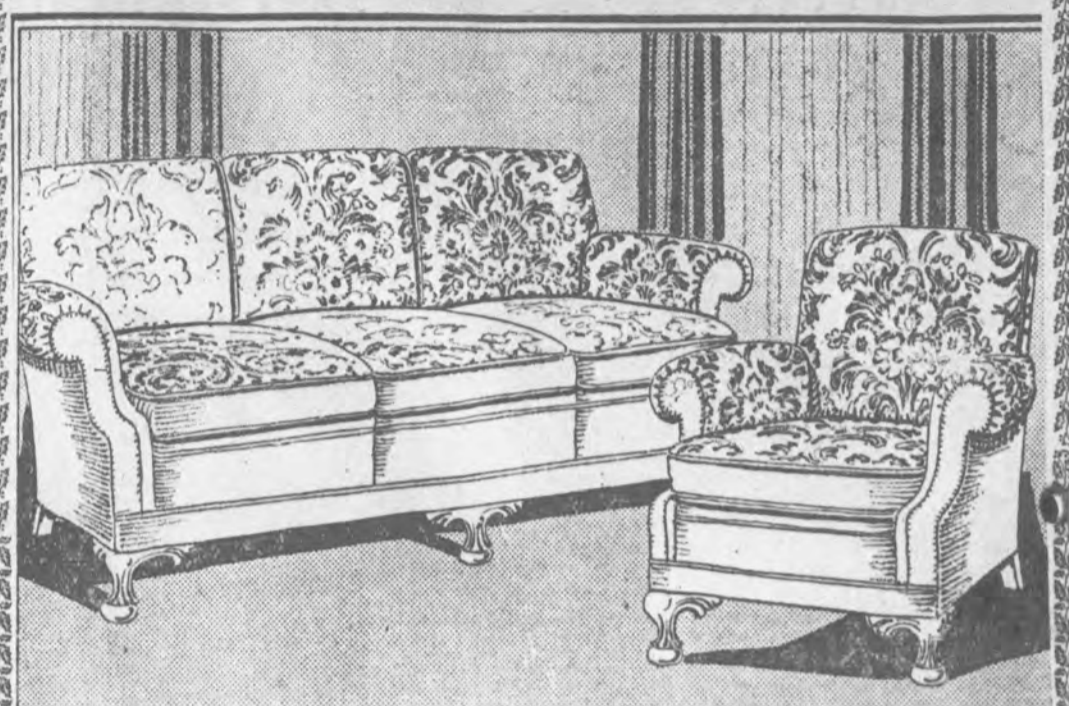
