U. S. AND ITALY OPEN TALK ON REVISED PACT

Negotiations Started for New Commercial Accord

EXISTING PACT SOON TO EXPIRE

Authoritatively Reported Deliberations Do Not Include Separate Trade Pact

Rome, Dec. 16.—(AP)—Negotiations for a new commercial accord between the United States and Italy have been begun to replace the expiring treaty of 1871, it was announced officially today.

The announcement also disclosed the denunciation today of the existing pact ineffective in one year. "For some months," an official communique stated, "commercial negotiations have been going on between Italy and the United States and the treaty drafts are now in the course of examination."

Today at Chigi palace Italian foreign minister Count Galeazzo Ciano and William Phillips, United States ambassador to Rome, signed a memorandum denouncing the agreement of 1871 which does not correspond to the necessities of the present.

Informed sources said the negotiations centered on a new commercial treaty, not on a separate trade agreement which will come up later.

Ayden Youth Wins Highest Honor In Scout Activities

Sammy Pierce Awarded Eagle Scout Medal at Ceremonies in Ayden High School This Week

Sammy Pierce, 15-year-old Ayden youth, has been awarded the highest distinction available in Boy Scout activities.

He was presented with an Eagle Scout badge at ceremonies in the Ayden High School this week. He has been a scout for three years, during which time he has won his 21 merit badges necessary to entitle a Scout to the high award.

W. M. Jenkins, principal of the school, had charge of the program. Rev. W. H. Brunson opened the ceremonies with a prayer, after which Mayor Bruce Eure made a talk in behalf of the Rotary club, which sponsors the Ayden troop.

Thelbert Worthington, chairman of the troop, introduced John J. Sigwald, Scout executive for this district, who presented the badge to Scout Master Frank Peterson, who in turn handed the medal to Mrs. Sam Pierce, who pinned it on her son, Sammy.

A pass good for the rest of the year was given the new Eagle Scout by the management of the Ayden theatre. The ceremonies were brought to a close with a prayer by Rev. Mr. Canady.

Pierce is the second Pitt county Scout to receive the Eagle award during this fall. Some time ago Kenneth Henderson, son of Mr. and Mrs. E. L. Henderson of this city, was presented with such a medal.

It was pointed out that only one Scout out of every 350 over the country attains such an honor annually. This area has only about 200 Scouts, thereby rating Scouts of this section far above the average.

Three Negroes Held For Larceny of Hogs

Chief of Police George Clark said today he thought he had broken up what he believed to be a ring of negroes who stole live hogs, took them to a secluded wooded spot and butchered them. He said some of the meat was sold, while the remaining was given away or eaten by the culprits themselves.

Three negroes, Cecil Newton, LeRoy Jackson and "Duck" Boyd are being held on the charges. They were arrested shortly after J. H. Blount had reported to police officials that some one had stolen two pigs from the Willoughby farm about three miles beyond the "Bamma" section, a negro settlement on the outskirts of the city.

Chief Clark said he soon located the meat, all but two hams, one of which had been sold and the other eaten. He quoted the negroes as admitting their guilt. The officer said he was of the opinion the negroes had stolen at least a dozen hogs and butchered them.

Hopes of Settlement Seen in Pacific Maritime Walkout

(By Associated Press) Extension of a glass workers strike to three hitherto unaffected manufacturing centers threatened today to curtail automobile industry operations. The federation of flat glass workers, refusing to accept a contract offered by the Libbey-Owens Ford company, called a strike of company employees last midnight in Toledo, Ohio, Charleston, West Virginia, Virginia and Shreveport, La., to support demands for union recognition and salary adjustments. Already idle were 6,000 Pittsburgh plate glass company employees and 13,000 Libbey Owens Ford workers at Ottawa, Ill. The two companies produce 85 per cent of the safety glass used in American made automobiles, as well as 70 per cent of the nation's window glass and 93 per cent of the plate glass.

DECLARE ARMY SEEKS RESCUE

Expedition Reported Formed to Seek Chinese General

Shanghai, Dec. 17 (Thursday)—(AP)—The Nanking government will give the rebel leader, Chang Hsueh-Liang a final chance to deliver Generalissimo Chiang Kai Shek safely, a high executive official said today.

Shanghai, Dec. 16.—(AP)—An army campaign to rescue Chiang Kai Shek if alive and avenge him if dead was reported unofficially to have been voted today by the executive governing committee of the Chinese government at Nanking. The report came from Chinese sources.

The goal of the punitive expedition reportedly would be Sianfu, the stronghold of Marshal Chang Hsueh-Liang, who kidnapped the Generalissimo, China's most powerful individual, last week. Official sources have been unable to state whether Chiang is (Continued on page six)

Mr. Duval advised all delinquents to go to City Hall within the next few days and settle their accounts and save the additional expense. It was pointed out that the laws of the state make it mandatory that suit be instituted against all persons who have not paid their 1933 property taxes.

State College To Offer Course For Leaf Growers

The course is the first in a new series of winter discussions to be offered by the N. C. State college for the purpose of assisting farmers and their wives in solving their farm problems.

The instructional staff for the course contains the names of high officials, including John W. Harrison, dean of administration; I. O. Schaub, dean of agriculture; C. H. Braun, extension entomologist; Dr. J. B. Cotner, professor of plant breeding; W. G. Finn, assistant director, East central division, Agricultural Adjustment Administration; E. Y. Floyd, tobacco specialist of the extension service and many other persons experienced in the growth, curing, grading and marketing of tobacco.

Rainfall in Last 24 Hours Varies Up to 1.60 Inches

Raleigh, Dec. 16.—(AP)—Lee Lenson, in charge of the weather bureau here, warned heavy rains of last night and this morning in central and eastern North Carolina would prolong and perhaps slightly increase, floods prevailing in rivers of the areas today.

Rainfall varied from only .04 of an inch in Asheville during the 24 hours ending at 8 o'clock this morning up to 2 inches at Wilmington, with Goldsboro having 1.60 inches and other records showing 1.72 at Smithfield, 1.10 at Kinston, 1 inch at Greenville, Tarboro and Morehead and .96 of an inch at Charlotte.

Goldsboro was warned to expect an 18 foot depth in the Neuse there tomorrow, four feet above flood levels, and Kinston was advised the overflow there would probably be about two feet in depth.

Greenville got advice to expect a bank-full Tar river with a stage of around 14 feet.

Chief Clark said other cases on the same charge were pending against the defendant at the present time. He said she was caught after a foot race with one of the officers.

Jesse Roberts, 16-year-old negro, convicted of crashing a red light and taxed with the costs and ordered to repair a car damaged was the only other case tried at the morning's session of police court.

PLAN ENLARGE N. C. RAILROAD FEDERAL BLDG. HEADS CONFER

Work Expected to Be Started Some Time in Early Spring

Plans have been received here for the extension and remodeling of the post office, the program to cost approximately \$75,000.

Blue prints and other data are here for interested contractors to study. Sealed bids will be opened in Washington on December 23.

T. T. Hollingsworth, postmaster, said he expected work to be started on the project in the early spring. The plans call for extending the building 32 feet in the back, leaving only a driveway between it and the office building directly behind the post office on Third street. Arrangements will be made for loading and unloading three trucks at the same time, while at the present only one truck can be handled at a time.

The postmaster's office will be moved back from where it is located now and the lobby enlarged. A wing will run parallel with Third street, on which side more lock boxes will be located, as will the parcel post window.

An appropriation for the extension and remodeling work was secured some time ago and it was announced at that time that the entire project would involve an expenditure of approximately \$75,000.

Dates Designated For Pitt Farmers Sign Applications

Task of Applying For Payments Under Conservation Program to Be Completed After Christmas

Farmers living in Beaver Dam township who are participating in the Soil Conservation program have been advised to go to the office of the County agent here on Friday and sign their applications for benefit payments.

On Saturday planters residing in Belvoir and Falkland townships will be expected to appear at the office and sign the blanks.

Announcement already has been made that Swift Creek farmers would be expected to sign the applications tomorrow.

At the end of this week planters from only five townships will not have signed the applications. The county agent's office is completing the task as rapidly as possible, one day being set aside for farmers in certain townships. It was explained that it was necessary for farmers to go to the office on the day designated. They were advised to bring their tenants and share croppers as they must sign the application with the landlord.

Three additional townships will be completed next week. Monday has been set aside for farmers in Farmville township, Tuesday for farmers in Fountain and Wednesday for farmers in Bethel. Growers in the two remaining townships in the county, Pactolus and Carolina, will be summoned to the office some time after the Christmas holidays.

Peace Conference Approves Motion Of United States

Plans Call for Consultation if Peace is Threatened

Buenos Aires, Dec. 16.—(AP)—A United States proposal for consultation by the American republics if American peace is menaced from within or without, won final approval today by the full inter-American peace conference, along with eight other projects.

The United States plan, only slightly modified as it passed through a committee, had the unanimous sponsorship of all the 21 American republics. It was described by United States secretary of state Cordell Hull as "epochal."

Hull's resolution urging all American republics to complete ratification of five existing American peace treaties which also had unanimous sponsorship likewise was quickly approved at the plenary session.

It reiterated a similar recommendation of the Montevideo Pan-American conference of 1933.

Fears Felt For Plane Occupants

Salt Lake City, Dec. 16.—(AP)—Belief seven occupants of a lost western air express transport plane never will be found alive was voiced today by pilot Jimmy James, aiding in the rain-hindered search.

Fighting weather conditions such as prevailed when the airliner carrying five men and two women disappeared yesterday, men in planes, on foot and on horseback searched grimly today in Wasatch mountain wilds.

In rain and fog half a dozen planes joined in late second day's hunt for the transport plane and its occupants—one a British stewardess who turned down romance for her job.

Edward May Make Reply To Stinging Criticisms

Former King, in Less Despondent Mood, Takes to Golf

Ft. Worth, Texas, Dec. 16.—(AP)—His headaches gone and his despondency vanished, the Duke of Windsor challenged his hostess to a golf game today and was beaten roundly by American-born Baroness Rothschild.

The prince's mood was considerably improved although reliable reports said he was still irked by the criticism of the archbishop of Canterbury.

Baron Eugene de Rothschild, at whose castle the former king is staying, disclosed Edward was deeply stirred by the radio broadcast Sunday in which the archbishop rebuked him and his friends.

It was said the self-exiled king might make a fiery answer to the archbishop's empire-wide censure. (Continued on page six)

Special Session Adjourns Sine Die at 12:27 P. M.

GOVERNOR PAID HIGH TRIBUTE

Resolution Praises Chief Executive For Calling Term On Social Security

Raleigh, Dec. 16.—(AP)—The special session of the North Carolina General Assembly adjourned sine die at 12:27 this afternoon after enacting into law the administration's unemployment compensation bill.

The clocks in the Senate and House chambers showed the hour as noon as stipulated in the resolution of adjournment, but the work was not finished so the gavel could fall simultaneously, to end the session, until 27 minutes later.

A bill to fix the time for filing the liquor study commission's report for December 23 was lost, temporarily, causing part of the delay. The unemployment compensation act, cause of the special session, became effective at 12:26 when it was signed by the Lieutenant-Governor and the Speaker of the House, H. Gregg Speer.

City Automobile Tags On Sale At City Hall

City automobile license tags went on sale yesterday and 44 plates were sold the first day. The tags went on sale simultaneously with the state tags.

With yellow letters on a black background, the tags are the same color as the state tags. City Hall officials said the same rules will be carried out by the state as to what time the new tags must appear on cars would be followed by the city. It was declared, however, that it would be necessary for automobile owners living in the city to display the plates, not just purchase them. The license tags sell for one dollar.

Last year 1,442 plates were sold and it was officially estimated that at least that number would be sold for 1937.

The Greenville tobacco market closed its 1936 season today, but arrangements have been made by the warehouses to take care of any farmer who has not sold all of his tobacco.

No figures were available today as officials were still checking on the season sales and averages. It was specifically pointed out that any tobacco grower who has not sold all of his product will find facilities here for the sale of his leaf, although the market officially came to a close at the end of today's sales.

Important matters regarding the activities of the office and including discussions on the federal farm program are expected to be taken up by the agents. The series of meetings will continue through Friday, but the signing of applications for benefits under the Soil Conservation program will continue at the office of the county agent here.

Einar Holboell, a postmaster of Denmark, in 1904 originated the idea of the Christmas Seal as a means of raising money to fight tuberculosis. Miss Bissell read a story about this and designed a seal to sell in this country. Her first sale, thirty years ago, raised \$3,000 which was used to open a hospital in Delaware for children with tuberculosis. To raise funds for the support of tuberculosis work, Christmas Seals are now sold in forty-two countries throughout the world.

Addresses Students
Dr. Herbert ReBarker brought an inspiring message to the College students yesterday during the assembly hour on "The Significance of Christmas."

"The only significance of Christmas," he said, "is that we are about to celebrate the birth of a babe. He was only a babe, but never was there born one like him. Christ differed from all others in that he had a philosophy of life from which he never departed. We are all kings, queens, princes and princesses if we have a philosophy of life and if we follow that philosophy."

"Fear not" were the words that the angels sang upon that first Christmas morning, and those same two words were used more by Christ than any others. "If we follow our philosophy of life," Dr. ReBarker said, "we are kings and have nothing to fear. We will never have to abdicate."

"Christ was the magnificent rebel of his time. We never think of Christ as being radical, yet, he stood up before the most prominent professing Christians in the church and called them hypocrites. How long would this king of preaching last in our modern church?" Dr. ReBarker asked.

"The key to the new philosophy which Christ brought into the world was 'Deny Thyself.' It differed greatly from Socrates' philosophy which was 'Know Thyself.' Just because Christ did live his philosophy, he was nailed to the cross."

"The new philosophy which Christ brought was a redeeming one," Dr. ReBarker brought out. "It saved mankind from the past, from ourselves, from indolence, from formality, from arrogance and conceit, from hypocrisy and from fear."

"If Christ saved us from all of those things, what did he save us for?" Dr. ReBarker asked in concluding. "He saved us for the future, for others, for love, and for service."

Two Figure Prominently In Committee Head Talk

Reflector Bureau, Sir Walter Hotel. By J. C. BASKERVILL. Raleigh, Dec. 15.—Representative D. L. (Libby) Ward of New Bern Craven county, is regarded by many here as being a very strong contender for the chairmanship of the house appropriations committee.

It is known that he is being very strongly recommended to Speaker R. Gregg Cherry for this post and a good many observers here are already confident that the 33 years old New Bern attorney now serving his second term in the general assembly will be named chairman of the committee which must decide just how much money each of the various state departments and institutions will get for each of the next two years—and which must also decide how much the public schools of the state will get, regarded as the most highly controversial question and the one around which the biggest fight in the general assembly will develop.

There are still those, however, who believe that Representative Walter (Pete) Murphy of Salisbury is more likely to be named chairman of the appropriations committee than any one else and a good many admit that at the present time no one knows who Speaker Cherry will appoint and that it is evidently a toss-up between Ward and Murphy.

Those who believe that Speaker Cherry will select his appropriations committee chairman from the west are confident that he will name Murphy, while those who think he will pick an eastern man for chairman of this committee predict he will name Ward.

Since it is generally conceded that Cherry will appoint Representative Victor S. Bryant of Durham chairman of the house finance committee and since it is agreed as being in either the east or the west, most observers agree that Cherry can select his appropriations chairman from either the east or the west without violating the custom and precedent that if the chairman of the finance committee is from the west, the chairman of the appropriations committee must be from the east, or visa versa.

Murphy has strong backing for the appropriations post from many of the members of the house from the western part of the state, not only because he is from a western county but because they believe he is the best fitted man in the house from the standpoint of experience and ability to handle this important post.

This will be the thirteenth time Murphy has served in the house and he is regarded as being one of the ablest thinkers and parliamentarians who has ever served in the general assembly. It is generally conceded that many of the alumni of the University of North Carolina, of which Murphy is an alumnus, are strongly backing him for the appropriations post in the belief that he will see to it that the University gets a better and more liberal deal from this session than it has from the last two or three.

Ward is also regarded as having

some very strong backing, including some from University of North Carolina alumni, as Ward is also an alumnus of the Chapel Hill institution, although he took his law degree at Wake Forest. It is maintained by those supporting Ward for the appropriations post that the University has nothing to fear from Ward whatever and that he will be just as fair to its request for a larger appropriation as Murphy would be.

It is also pointed out that Ward was a member of the appropriations committee in the 1935 session and that Murphy was not a member of the house in that session, with the result that Ward is already more familiar with the problems of this committee at this time than Murphy is. There are some who regard Ward as being more tactful, less talkative and generally more conciliatory than Murphy, who is known for his ability and willingness to say what he thinks and for his liberal use of biting sarcasm. A good many also believe that Ward would hold appropriations down better than Murphy and be more likely to prevent the "free spenders" from running away with the committee and the writing of an appropriations bill calling for more money than the finance committee can provide. It is also generally agreed that Ward, as secretary of the State Democratic Committee, is very close to Governor-elect Clyde R. Hoey, with the result that if Mr. Hoey indicates he would like to see Ward chairman of this committee, he will probably get it. Accordingly, a good many here now believe Ward is in a stronger position for chairman of the appropriations committee than Murphy.

Raleigh, Dec. 15.—A practical acquaintance with modern farming will serve Frank Gibson, North Carolina State College student, as a source of ideas for the program which he expects to follow as president of the student Agricultural Club.

Gibson, whose home is in the town of the same name, was reared on a 750-acre farm which extends from Scotland County into Marlboro County, South Carolina. He is well acquainted with the growth of cotton, which is cultivated on 250 of the 439 cleared acres, as well as corn and small grains. Modern improvements, including electrical conveniences, have been adapted to every operation of the farm. Nearly two-dozen mules are used in cultivating crops on the Gibson farm and a herd of dairy cattle graze on a well-seeded pasture.

Specializing in animal husbandry, Gibson is completing his fourth year at State College. He is also president of his social fraternity, Pi Kappa Phi.

Old Duke Graduates Attend Banquet Here

Professor J. M. Ormond, teacher in the School of Religion at Duke University, spoke to over sixty alumni and friends of Duke at the annual Duke Day banquet last night in the dining room of the Jarvis Memorial church.

Dr. M. T. Frizelle, of Ayden, president of the local alumni chapter, acted as toastmaster of the occasion.

In addressing the Pitt alumni of Duke, Professor Ormond, a native of Greene county, sketched the quantitative and qualitative growth of Duke University since its origin in Randolph county in 1838 as Union Institute. "Throughout the years Duke University has endeavored to exemplify in its teaching the spirit of the motto of the university, 'Education and Religion.'"

Mrs. J. B. Spilman Being Considered For Big Position

Belief Growing One Woman Will Be Named on the New Unemployment Compensation Commission

Reflector Bureau, Sir Walter Hotel, Raleigh, Dec. 16.—Speculation is increasing as to who Governor-elect Clyde R. Hoey will appoint as the two appointive members of the new Unemployment Compensation Commission, just created by the enactment of the unemployment insurance bill today.

The third member of the commission will be Commissioner of Labor A. L. Fletcher, who will serve ex officio. But the other two members must be appointed.

While these appointments will be made and announced by Governor J. C. B. Ehringhaus, it is generally conceded that the actual selection of the appointees will be made by

Governor-elect Hoey and that Governor Ehringhaus will merely give his approval to the two persons selected by Mr. Hoey.

The belief is growing in some circles that one of these appointments may be given to a woman, despite the fact that this commission will have to administer a fund of from \$12,000,000 to \$15,000,000 and which will get larger every year.

Some think Mr. Hoey will name Mrs. J. B. Spilman of Greenville as one of the commissioners. Mrs. Spilman is vice chairman of the State Democratic Executive Committee and organized the Democratic women of the state in the campaign before the election. She also was a militant Hoey worker and supporter in both primary campaigns.

It is generally believed that she will be given an appointment of major importance by Mr. Hoey. She has been mentioned as his possible choice for secretary of the State School Commission, but is now regarded as more likely to get a place on the unemployment com-

mission. No one seems to have a very definite idea as to who will be named chairman of the new commission. The name of E. W. G. Huffman of Salisbury, editor of The Carolina Watchman, a member of the 1931 general assembly and for the past four years, secretary of the Ways and Means Committee of the House in Washington, is being mentioned in connection with some important post with the unemployment insurance commission. Huffman is regarded as an expert on social security legislation, having assisted Congressman R. A. Doughton during the months the Federal bill was being written. Some think Huffman knows more about this legislation than any man in the state.

By Dr. Igo Goldston Acute Bright's Disease Bright's disease, so called after the famous English physician, Richard Bright, who first competently described the condition, is an inflammatory process affecting the kidneys, and technically called nephritis. Two main types of the

disease are recognized; acute and chronic. The acute form of the disease is caused by the action of cold or toxic agents. Exposure to cold and wet is one of the most common causes, and it is particularly prone to follow exposure after heavy drinking. Among the infectious diseases of which acute Bright's disease is a serious complication, scarlet fever is outstanding. Others are typhoid fever, diphtheria, measles, smallpox and chickenpox. Acute Bright's disease may also be associated with syphilis and with acute infectious infections of the throat, that is, cold and tonsillitis, may be complicated by acute Bright's disease.

Various toxic agents, such as turpentine and other wood and coal derivatives and practically all poisons, may cause acute nephritis. Extensive skin burns and severe eye injuries are frequently complicated by an acute inflammation of the kidneys. The symptoms of acute nephritis usually develop suddenly. The patient, frequently a child, becomes pale and develops a puffiness of the face or swelling about the ankles; pain in the back, nausea, vomiting and convulsions may be present. A marked change in the excretion of urine can also usually be noted. At first there may be a complete suppression of urine. Then the quantity of urine voided may be as little as four or five ounces. In appearance the urine is dark and cloudy. Upon chemical and microscopic examination, it will be found to contain albumin and various salts not normally present in the urine.

Every child suffering from an infectious disease must be considered a potential victim of acute nephritis. To conserve the kidneys and to protect them against serious damage, the kidney function of such children must be watched. At the suggestion of any abnormality, appropriate treatment must be instituted. Treatment necessarily varies with each case and with the primary disease condition. It is important, however, to keep the patient in bed, to keep him warm and to feed him a light liquid diet, consisting of such foods as milk, buttermilk, oatmeal, chicken broth. Above all, it is important to bear in mind that every such case requires prompt, judicious and expert medical supervision.

Brannon, extension entomologist with the Agriculture Extension of State College, has been offered the post of chief of the division of entomology of the State Department of Agriculture, to succeed Dr. R. W. Leiby, and has accepted the offer, it was announced today by W. Kerr Scott, recently elected Commissioner of Agriculture who will take office January 7. Dr. Leiby was notified a few days ago by Mr. Scott that his services would not be needed after January 15.

Fred Miller will remain with the State Department of Agriculture as superintendent of the department's test farms. Scott also said, provided Miller desires to remain. George M. Stephens of Asheville, who was offered the post of director of publicity and publications the job which has been held by Richardson for the past 12 years, has decided he will be unable to accept the job. Mr. Scott also said, Stephens is the son of George Stephens, one of the former publishers of The Asheville Citizen. Dr. Leiby, who he will succeed, is a native of Pennsylvania, but has been in North Carolina 21 years, for the past 12 years head of the entomology division of the Department of Agriculture. Peiping, North China, (AP)—The American Embassy radio tower, the highest structure in Peiping, and the dragon-topped gateways of the former Imperial Palace will continue to dominate the skyline here, according to General Sung Cheh-yuan, ruler of North China.

Shocked by the stark outlines of several multi-storied buildings going up here, General Sung concluded that they would be a blot on Peiping's classic landscape, and has prohibited further structures over two stories high.
