ADVANCE PLAN TO BRING END COAST STRIKE

Possible 'Break' in Form of Tentative Agreement

AUTO INDUSTRY FEELING PINCH

Walkout of 26,000 Glass, Auto and Au- to Parts Workers Continues Unbroken

(By Associated Press)
Union and employer spokesmen
cited a possible break in the 53-day
Pacific coast maritime strike to-
day in the form of a tentative
agreement submitted to members of
the sailors union.

On another strike front the au-
tomobile industry began feeling the
pinch of a walkout by 26,000 glass
automobile and automobile parts
workers with little headway appar-
ent in efforts to reach accord.

At Pittsburgh steel workers
launched an attempt to supplant
company unions with the form of
industrial organization advocated
by John Lewis. Claiming to represent
200,000 men in 42 eastern
mills, 244 delegates organized the
committee for industrial organiza-
tion's representative council to
carry on the campaign.

Harry Lundberg, chief of the
sailors union of the Pacific, said
settlement terms would be submitted
to members perhaps tonight.
The sailors union is one of seven
involved in the walkout.

Judge W. A. Devin Administers Oath To Mrs. Spilman

School-Mate of Late Husband Swears Local Woman in As Mem- ber Insurance Commission

After spending the week-end here,
Mrs. J. B. Spilman returned to Rail-
road last night and was sworn in
as a member of the State Unem-
ployment Compensation commis-
sion at noon today.

At her own request, Justice Wil-
liam A. Devin, of the State Supreme
Court, administered the oath of of-
fice. Justice Devin and Mrs. Spil-
man's late husband, were school
mates.

Mrs. Spilman was appointed to
the post on the commission by
Governor Ehringhaus, presumably
at the request of Governor-Elect
Hoey. Others on the commission
are Charles G. Powell and Commis-
sioner of Labor A. L. Fletcher.

The commission today was ex-
pected to complete its budget for
expenses up to January 1 and to
leave for Washington Tuesday for
final approval of the budget and
an allocation of administrative
funds from federal authorities and
to study administrative problems.

Thad Eure was also sworn in as
Secretary of State to succeed Com-
missioner Powell. At special
request, Superior Court Judge R.
Hunt Parker administered the oath
of office to Mr. Eure, who was elected
to that position for the term be-
ginning in January, but who agreed
to serve until that time under ap-
pointment.

Maxwell Urging State Car Owners Buy Plates Early

Commissioner of Revenue Says That Purchasing Licenses Before January 1 Will Prevent Wailing

A. J. Maxwell, Commissioner of
Revenue, is urging all North Caro-
lina motorists to purchase license
plates early in order to avoid the
annual rush which occurs yearly.
Maxwell pointed out that the
sales of license plates on the open-
ing days of sale ran about 50 per
cent ahead of a year ago. He added
that those purchasing plates prior
to the last few days before January
1, save themselves the great incon-
venience of standing in line for
hours waiting to be served.

Forty thousand more vehicles
have now to be licensed than in any
former year, meaning that a much
larger congestion will be created if
motorists wait until the last min-
ute to purchase auto license plates.
The local branch of the Carolina
Motor Club selling automobile li-
cense plates is likewise urging all
motorists to buy their tags at an
early date.

It is understood that no exten-
sion of time will be given for use
of old license plates on streets and
highways on or after January 1.

EDGAR SMOAK DENIED BOND

Held on Charge of Poisoning 15-Year- Old Daughter

Wilmington, Dec. 21.—(AP)—Ed-
gar Smoak waived a preliminary
hearing in the records court here
today and was held without bail on
a charge of murdering his 15-year-
old daughter, Annie Thelma, by
poison.

A murder charge against his
housekeeper, Mrs. Jennette Harker,
was dropped, but she was placed
under \$1,000 bond as a material
witness.

The entire proceedings required
only three and one-half minutes.
Mrs. Harker and Smoak were re-
turned to their prison cells im-
mediately after the hearing.

Wayne Death Listed Suicide By Officials

Goldsboro, Dec. 21.—(AP)—Police
listed today as suicide the death of
Jesse Lassiter, 23, killed by a shot-
gun blast at his home near La
Grange yesterday.

Fifteen minutes before he was
shot officials said Lassiter stopped
at a country store near his home,
shook hands solemnly with his
friends, saying "I may never see
me again and I want you to serve
as pallbearers."

French Aviatrix May Face Charge

Thought by Police to Be Principal in Aston- ishing Aerial Drama in Which Pilot Was Shot in Back While Flying in Mid-Air

Saley, Dec. 21.—(AP)—Madam
Marie Schmeder sought by French
police for shooting her co-pilot
during a flight over Villacoublay
yesterday was ordered held on a
technical charge today after crash-
ing her plane in a Sussex field.
British authorities detained the
woman flier, wife of a wealthy ma-
chine manufacturer, after French
police reported a warrant for her
arrest had been issued at Versailles.
Madam Schmeder flew from
France in the same plane in which
she was alleged to have shot Pierre
L'Allemand her co-pilot during a
flight Sunday morning.

GOMEZ VETOES COUNTY BONDS TAX ON SUGAR RETURN YIELDS

Way Paved for Ex- pected Impeach- ment Moves

Havana, Dec. 21.—(AP)—Presi-
dent Miguel Gomez has vetoed the
\$1,500,000 sugar tax bill, paving the
way for prospective impeachment
proceedings, instituted by his po-
litical opponents, Senator Octavio
Rivero announced today.

The senator said the chief ex-
ecutive had informed him of his ac-
tion during a conference in the
presidential palace.

The vetoed measure will be sent
to the senate this afternoon, Rivero
declared.

Negro Being Held For County Court Result of Accident

Bob Daniels, Negro Wanted on Whiskey Charges, Also Tried at Regular Monday Session

Cleveland Artis, negro, was bound
over to County court under bond of
\$300 following a preliminary hear-
ing in City court this morning on
charges of hit and run driving.

The defendant is charged with
having struck a pedestrian in front
of the college Saturday night when
a group of persons had gathered
following an accident between au-
tomobiles driven by L. M. Ernest and
Floyd Nichols, white men. Ernest
is confined at his home as a result
of the wreck, but his condition is
not considered serious.

Willie Lee Smith, negro, was
bound over to County court under
bond of \$100 on a charge of assault.
Milton Harris, another negro, was
acquitted on a similar charge.

J. H. Clark and Eugene Williams,
white men, were each fined \$10 and
costs upon conviction on separate
charges of drunkenness.

Bob Daniel, negro, was bound over
to County court under bond of \$300
on a charge of possessing illegal
liquor for the purpose of sale. His
wife, Lucy Daniel, was tried Sat-
urday and bound over under \$300
bond also.

1934 Death rate cut two-thirds in last 30 years

When the National Tuberculosis As-
sociation was founded in 1904 the
death rate from tuberculosis was 200
per 100,000. The latest figures show
that it has declined to 57 per 100,000.
However there are still 70,000 deaths
from tuberculosis every year, most of
which occur between the ages 14-45,
the productive years. Until tubercu-
losis is exterminated there can be no
let up in the campaign to prevent this
serious scourge.

Quake Death Toll Mounts As Rescuers Begin To Dig

All Communications With Razed Area Disrupted

San Salvador, El Salvador, Dec.
21.—(AP)—Official expressed fear
today of a mounting death toll in
the earthquake which razed almost
all San Vicente and killed at least
200 persons over the week-end.

Persons arriving in San Salvador
from the stricken provincial capi-
tal told stories of wholesale ruin of
shattered buildings and homes and
of rescuers digging out some 200
bodies in the first 10 hours after
the quake.

How high the death toll would reach
no one would estimate but govern-
ment officials dispatched all relief
available to the area.

Accurate reports were made in-
creasing difficult to obtain because
of the disrupted communications
between the quake area and San
Salvador.

Telephone and telegraph lines
were broken down by the quakes
and information could be had only
from those who fled inland from
the scene.

The Rev. N. C. Brooks, son of
Mr. and Mrs. N. C. Brooks of this
city was elected by the general
board of the North Carolina Bapt-
ist Convention at Raleigh yester-
day as secretary of the Baptist
Training Union. He succeeds Miss
Winnie Rickett, who tendered her
resignation last summer.

M. A. Huggins, general secretary-
treasurer of the convention told
fifty members of the Baptist Board
in North Carolina in session in the
First Baptist church, that all cur-
rent obligations had been satisfied.

Rev. Brooks was born in Green-
ville and is a graduate of Wake
Forest College and of the Southern
Baptist Theological Seminary at
Louisville, Ky.

Roosevelt Again Leads In List Of 10 Best Stories

New York, Dec. 21.—(AP)—The
most interesting news develop-
ments of 1936, from the American
viewpoint, as selected by J. M.
Kendrick, executive news editor of
the Associated Press.

1. Roosevelt
President Franklin D. Roosevelt
again was the key point of interest
and developments—all the more em-
phatically so with his overwhelm-
ing reelection over Governor Alf M.
Landon, of Kansas, the Republican
nominee, following a bitter cam-
paign, attack and defense of New
Deal policies.

Early in the year, the supreme
court held unconstitutional the ag-
ricultural adjustment act; likewise
the Guffey act. But the president
did not permit the power of the
supreme court to become a domi-
nant issue in the campaign.

Father Coughlin, Lemke and
Townsend flopped, so far as the
election was concerned.

The soldiers' bonus was paid. The
social security act went into effect.
The president opened the pan-Am-
erican conference in Buenos Aires
receiving a record-breaking recep-
tion.

Business conditions improved
generally throughout the country.
There was widespread wage in-
crease. There was a very sharp in-
crease in dividend payments, the
latter caused, in part, by the new
surplus tax laws. Unemployment
decreased, but remains very much of
a problem.

2. Mrs. Simpson
The Simpson affair, which be-
came known first through the Am-
erican press and then developed into
the issue between King Edward and
his government, headed by Prime
Minister Baldwin, after the news
finally was printed in England—a
story that goes into history with
other great romances. The sensa-
tion came only a few months after
the death of King George and cost
Edward his throne.

3. Wars
War and threats of war; Italy
won its war of conquest with Ethio-
pia. (Continued on page six)

COURT RULING GRANTS POWER TO PRESIDENT

Latitude Allowed In Handling of For- eign Affairs

AGREES RULE ON MORTGAGE ACT

Refuses to Review Case Challenging Constitutionality Of Check on Exchange

Washington, Dec. 21.—(AP)—
In a ruling generally interpreted as
having an important bearing on
forthcoming congressional consid-
eration of neutrality legislation the
Supreme court held today the Presi-
dent of the United States must be
given a large degree of latitude in
handling foreign affairs.

By a seven to one vote, it upheld
the constitutionality of the 1934
arms embargo act which authorized
President Roosevelt to forbid the
sale of munitions in the country
to the recent Chaco war be-
tween Bolivia and Paraguay.

Before adjourning for two weeks
over the holidays, the court agreed
to review a controversy involving
the constitutionality of the Frank-
lin D. Roosevelt act granting a three-year
moratorium on farm mortgages fore-
closures. Arguments probably will
be held in March followed by a de-
cision a few weeks later.

It refused to review a case chal-
lenging constitutionality of the 1935
act broadening federal regulation
of commodity exchanges. The ap-
peal was brought here in advance
of the customarily required ruling
by a circuit of appeals.

The court did not act today on a
petition for reconsideration of its
recent four to four decision upholding
constitutionality of the New
York unemployment insurance law
which supplements the federal so-
cial security act.

NO MONEY FOR GIFTS

From the day when his mother told him this, the joy seemed to go out of life for Sam. Mrs. Smith meant to be kind, she was trying. But she failed to understand Christmas and what it means to children.

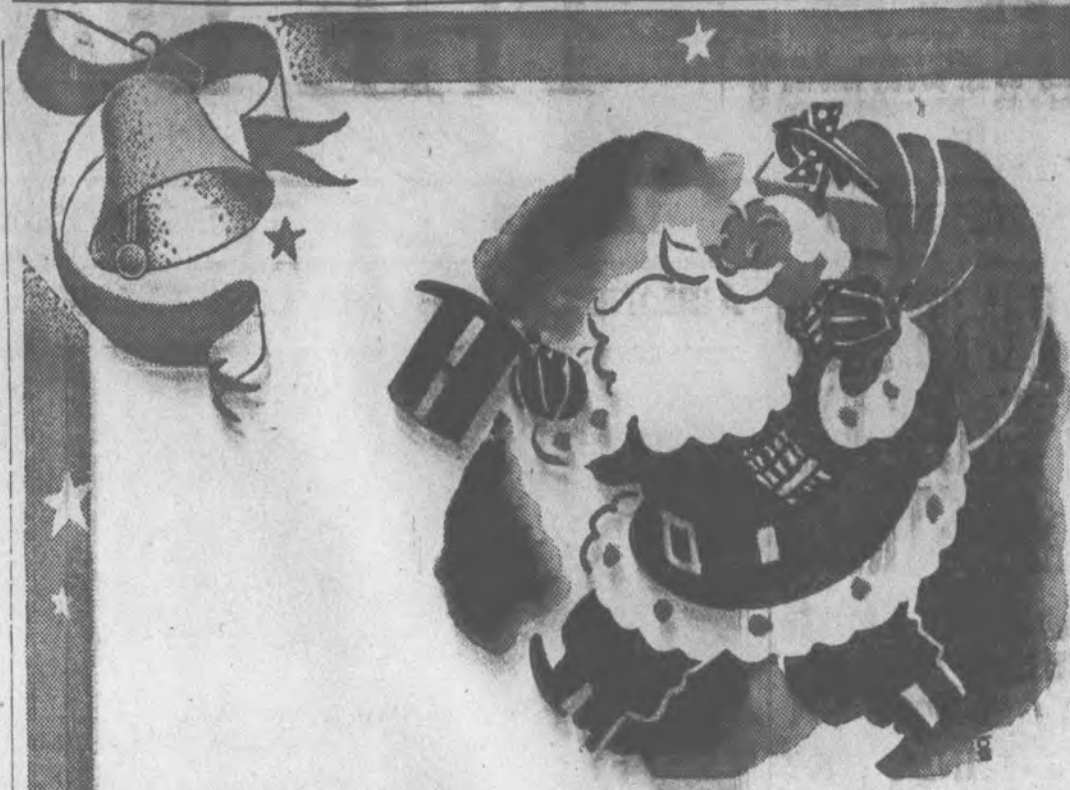

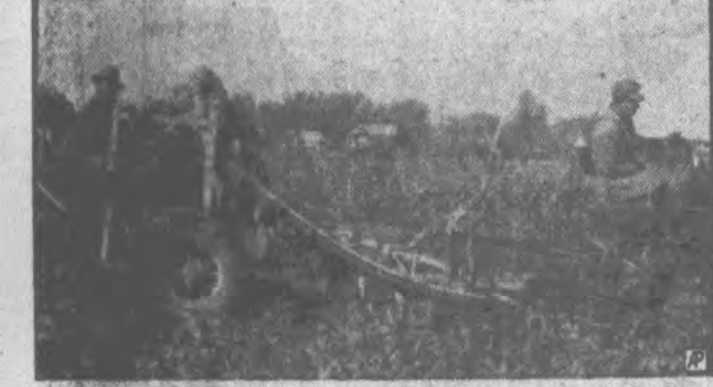

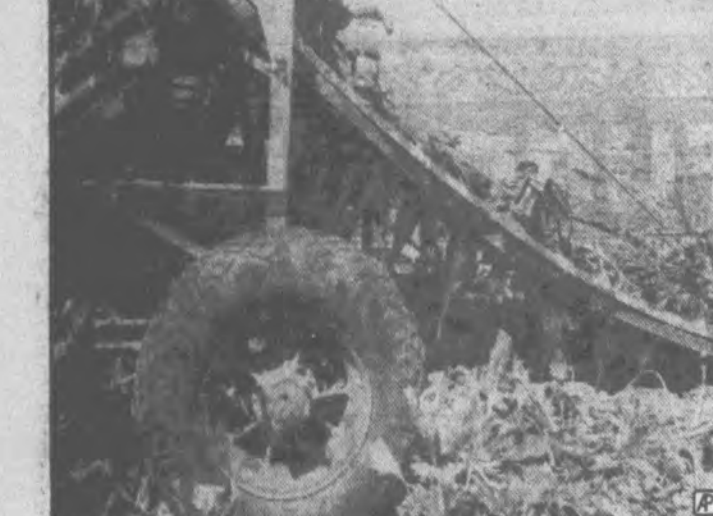

Machine Invades Sugar Beet Fields

Slip fingers of glistening steel may soon slice through the damp earth of the nation's sugar-beet fields, competing with thousands of Mexicans and Spanish-Americans who for 40 years have harvested the beets. The new harvester, experimented with for five years, now appears "practical" and probably will be manufactured in quantity production "comparatively soon," says the U. S. agricultural engineer who tested it recently near Fort Collins, Colo. Here is what he saw:



DOWN TO EARTH
The long, sloping snout scrapes the ground as the new sugar beet harvester ploughs down the field behind a tractor.



GOING UP
Pulled from the ground, the beets are drawn up an incline and topped by steel fingers.



BY MACHINE
This is how the beets look after the machine gets through.



BY HAND
This is the way the beets are topped by human workers.



WEATHER BOUND?
With anxious eyes, a typical beet field family considers the future. The machine, it is estimated, will do 12 men's work for \$7.00 an acre—a saving of \$4.00 over cost of manpower.

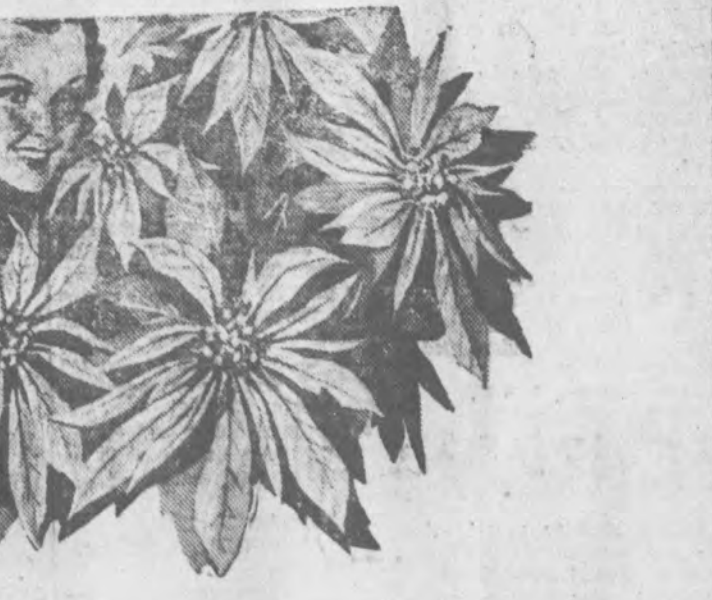

How's Your Health?

Edited for the New York Academy of Medicine

To Gargle or Not to Gargle? There is much controversy in medical circles on the value of gargles. This procedure, calculated to reach the back of the throat with medicated or non-medicated solutions, has been an ancient and honorable practice, followed by the public and recommended by the medical profession.

Recently, however, some doubting Thomases subjected gargling to a critical study. Barium-containing gargles were given to individuals and they were instructed to do their best while acute visioned scientists studied the reach of the gargles by means of a fluoroscope. Some of the researchers, arrived at the conclusion that gargles do not reach

beyond the front part of the mouth cavity; that they do not affect the tonsils or the back of the throat. Hence, as one medical journal phrases it, "each night the sound of churning rises from a million throats, and their possessors go to bed conscious of a good deed well done," but alas, it is all an illusion. However, the attempt to discredit the ancient practice of gargling has not gone unchallenged. Some physicians criticize these X-ray studies and offer their own experimental evidence to show that gargles do indeed reach all portions of the throat. Those of us who are on the sidelines watching this play of wit and science are convinced that the personal element deeply affects the re-

sults. Some individuals gag at the very suggestion of gargling, while others have remarkable control, or throat-insensitiveness. But there is still a way out of the seeming dilemma. There are frequent occasions in which it is desirable to "wash out" the throat. This is notably the case when the individual suffers from a head cold, from tonsillitis or pharyngitis. Gargling with a warm saline solution made by the addition of a teaspoonful of salt to a glass of water may with some individuals prove effective in relieving pain and in washing away the accumulated products of the inflammatory process. But an even more effective method can be employed. This consists in the use of a medium-sized soft

CONTROL PLAN RECOMMENDED

Counties Would Get Most Profits From Liquor

Reflector Bureau, 87 Water Hotel. By J. C. BASKERVILL. Raleigh, Dec. 21.—A combination state and county liquor control and liquor stores plan, under which the counties would get 80 per cent of the profits from the liquor stores and the state get 20 per cent, with the administration of the system centered in a state liquor control commission and county control boards, is recommended to the Governor and the 1937 general assembly by the special commission to study the control of alcoholic beverages in North Carolina, in the report and recommendations just submitted by Victor S. Bryant, chairman of the commission.

The findings and recommendations of the commission, exclusive of the model bill prepared by the commission, cover 32 legal size typewritten pages, while the many appendices and the bill fill almost as many more pages.

The report of the commission has nothing to say concerning the sort of election or elections to be held to make it possible for counties which desire liquor stores to have them. But the model bill prepared and appended to the report provides that a county-wide election must be held in each county and a majority of the voters approve the proposal to open liquor stores before any such stores can be opened.

Three members of the commission dissented from this section of the bill and have presented a minority report which would make it necessary for the qualified voters in every county in the state to vote on the proposed bill and approve it in a state-wide election before it could become effective. The three members who signed this minority report are Charles A. Hines of Greensboro, Judge L. R. Varner of Lumerton and John M. Robinson of Charlotte.

The other four members of the commission are in favor of enacting the bill as submitted, without submitting it to a vote of the people, and thus make it possible for any counties which want to hold county elections to proceed with them whenever they may desire. Enactment of the proposed bill would automatically repeal the Turlington Act, the state's 17 year old prohibition enforcement law in all except those counties which desire to remain dry.

It would also repeal the two present county liquor stores laws—the New Hanover and Pasquotank County Acts—under which 17 counties and two townships in another county now have county liquor stores. The four members who favor the enactment of the law without a state-wide referendum are Chairman Bryant of Durham; Donnell Gilliam, Tarboro; Roland F. Beasley of Monroe and Thomas W. Raoul of Asheville.

The commission in its report sets out that the bill has drawn as a suggestion for the general assembly to follow, if it so desires, is designed primarily with the idea of controlling the sale of liquor in North Carolina and to discourage bootlegging and its illegal sale, and not with the idea of bringing in large profits from the sale of liquor.

Present figures and calculations on which it estimates that if all the counties in the state should decide to have liquor stores, the total gross liquor sales would amount to approximately \$12,000,000 a year and points out that the gross sales in Virginia during the last 12 months under the state monopoly or state liquor stores system, amounted to \$12,145,972. It points out that for the 12 months period ending October 31, 1936, the 60 odd liquor stores in the 13 "wet" counties in North Carolina grossed \$3,213,351, although only about one-sixth of the state's population lives in these counties.

The principal provisions of the model bill submitted by the commission for the consideration of the Governor and the 1937 general assembly are as follows: 1. Creation of a State Board of Alcoholic Control of three members, one to be full time chairman, at \$6,000 a year, the other two to receive \$25 a day for the time they spend as members of the board, all three to be appointed by the Governor with overlapping terms. 2. That the board have supervision over all county stores and see that all the laws relating to the sale and control of alcoholic beverages be observed and performed, that it audit and examine all accounts, records and books of the county stores, fix prices, have power to remove members of county liquor control boards, to test alcoholic beverages and install laboratories for this purpose, to supervise purchasing for county stores, to fix opening and closing hours for all stores and have power to approve or disapprove regulations adopted by county boards and to fix salaries of members of county boards and of employees of county boards, also to approve or disapprove the amounts allowed for enforcement of the liquor control laws and to remove for cause, in its discretion, county enforcement officers employed by the county control board and that it shall have authority to set up a uniform accounting system for all county liquor stores. 3. That the Governor at all times shall have authority to remove any

or all members of the board for cause. 4. That Board of Alcoholic Control be created in every county which votes to have liquor stores, consisting of a chairman and two other members, to be elected by a joint meeting of the Board of County Commissioners, the County Board of Health and the County Board of Education, the chairman to serve for two years, one other member for three years and the other member for one year, the salaries to be fixed by these three boards meeting in joint session.

5. That no persons appointed a member of either the state or county boards shall be interested either directly or indirectly in any brewery, distillery or any other enterprise which bottles, distributes and sells alcoholic liquors. 6. That the members of the state and county boards and their employees shall be bonded for the protection of the state and the counties against loss. 7. That the County Alcoholic Control Boards shall have control over the importation and sale of liquor within their respective counties; have power to buy and possess liquors; to adopt rules and regulations governing operation of county liquor stores and to regulate duties of employees; to fix the hours for opening and closing liquor stores; have power to purchase and lease property and equip it for liquor stores; to borrow money, issue, sign and endorse checks and to do all the other necessary things as may be required in the conduct of the liquor stores; to investigate and aid in the prosecution of violators of this and all other liquor laws and to seize illegal alcoholic beverages; to fix the prices of all liquors sold in the county stores; to locate stores in the various counties and provide for their management by the selection of a manager and employees for each store and to discontinue the operation of any liquor store which may become unprofitable or which it regards as inimical to the welfare of the community in which it had been operated.

8. That no liquor shall be sold by the employees of a county liquor store except during the hours as fixed by the county board and that they shall not sell liquor to minors, habitual drunkards, a person who has been convicted of drunken driving and that the manager and employees of a store may refuse to sell to any person in their discretion. 9. That no liquor shall be drunk upon the premises of a county liquor store and that all stores shall be closed on Sundays, holidays and election days. 10. That the possession of any liquors not purchased from a county liquor store by a crime punishable by fine or imprisonment or both and that the manufacture or sale of any liquor, regardless of where purchased, also be a crime of the same nature. 11. That the advertising of liquors shall be unlawful in county stores or on

billboards or by radio. (No mention is made of newspaper advertising.) 12. That all expenses of the county and state boards be paid out of the proceeds of the sale of alcoholic beverages in the county stores, these expenses to include salaries of board members and all employees. 13. That the net profits be divided, with 80 per cent to go to the counties in which the stores are located, 20 per cent into the state treasury, nothing to cities and towns. 14. That only natural wines and beer of 5 per cent or less can be sold in other places than county liquor stores, thus requiring that ales and fortified wines be sold in liquor stores.

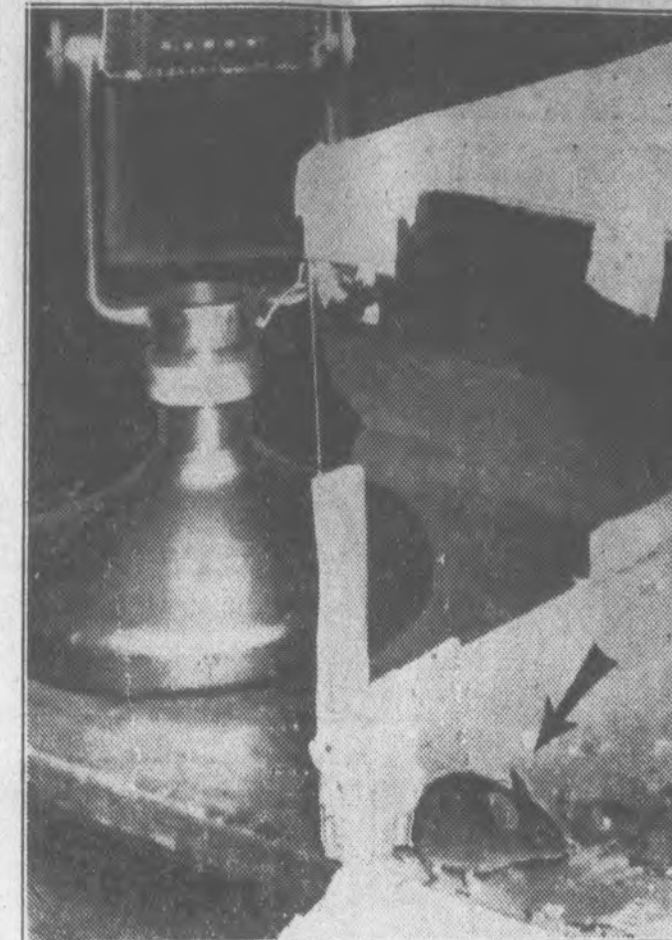
