CHANG TO FACE TRIAL BEFORE HEAD OF ARMY

Rebellious Marshal is Ordered to Face Authorities

CHIANG KAI-SHEK HEADS HEARING

Generalissimo Again Submits Resignation, But It is Refused Once More

Nanking, Dec. 30.—(AP)—Rebellious Chang Hsueh-Liang has been ordered to stand trial before the Nanking military commission tomorrow morning for his mutiny at Sian, authoritative quarters disclosed today.

Chiang Kai Shek, held captive by Chang for two weeks and then released in a sudden turning of the tables, will preside at the trial. Officials declined to speculate on the verdict, professing the belief "it is no routine matter, with the outcome already determined."

The Generalissimo, expecting to go today to the funeral of his elder brother, delayed departure.

Chiang again submitted his resignation from the high post he holds in the government, as an indication of the responsibility he feels for Chang's attempt to force war on Japan and inclusion of communist in the government.

The resignation was refused just as emphatically as a previous one. A month's leave of absence was granted to the premier to allow him to recuperate.

After he was freed and Chang voluntarily came to Nanking to "save the music," the Generalissimo recommended he be treated leniently.

Complete Signing Applications For Benefit Payments

Total of 3,050 Individual Contracts Signed at County Agent's Office During December

R. R. Bennett, Pitt county agent, announced today that farmers in all townships had completed signing applications for benefit payments under the Soil Conservation program and the forms were being sent to Raleigh.

The task, which was started two weeks before Christmas, was completed only this week. A total of 3,050 individual contracts was signed. It was estimated an average of three tenants signed the work sheets with the landlord.

The old Tucker building in which the agent's office is located was crowded by farmers, landlords and tenants, during the entire time the work sheets were being signed.

Already a number of the contracts have been sent to Raleigh and the office here will spend the rest of the week in preparing and transmitting the remainder to state headquarters.

Labor Difficulties Made More Tense By Strike Spread

Walkout of Fisher Automobile Body Company Employees Spreads to Additional Plant; Last of Line's Fleet Tied Up

(By Associated Press) Jackson, Mich.—A new strike of 100 employees of the Walter-Michigan company, accessories manufacturers, which began late yesterday continued.

Cleveland — Labor department cancellators renewed efforts to end a walkout of 7,000 Fisher body company employees, but union officials refused to accept a local settlement.

Kansas City—Picket lines at the Fisher body plant were ordered doubled. The plant has been closed since December 15.

Maritime: Jersey City, N. J.—The last of the Dollar lines' fleet of 14 ships was due to be tied up today with the docking of the President Harrison. Because of the maritime strike it will not be permitted to leave.

SEEK INCLUDE PLANES IN BAN

Quick Congressional Action Expected to Block Shipments

Washington, Dec. 30.—(AP)—Quick congressional action to block exporting of American planes and engines to Spanish Loyalists was charted today by administrative leaders in view of President Roosevelt's denunciation of the proposed shipments.

The president asked extension of the neutrality law giving him discretionary powers to ban sales of munitions in civil conflict.

He called the proposal of Robert Cuse of Jersey City, N. J., to send \$2,700,000 of airplanes and motors to the Madrid government, a perfectly legal act, but contrary to the country's interest.

(The state department had granted Cuse a license because the present neutrality law covers only embargoes on arm shipments in international warfare.)

Washington, Dec. 30.—(AP)—The name of the Vimalat Company, Ltd., of Jersey City, whose president, Robert Cuse, has obtained a license to export airplanes to Spain, figured in the 1930 congressional investigation of communist activities in the United States.

This was disclosed today as State Department officials, seeking some legal ground for revocation of the license, exhibited interest in the personal and business background of Cuse.

They said they were deterred from starting an official investigation of Cuse's conformation with all legal requirements in obtaining his license to ship \$2,700,000 worth of planes and airplane engines to the Spanish loyalists.

Pope's Condition Somewhat Better; Concern Felt Yet

Holy Father Reported to Have Spent Virtually Sleepless Night, But Condition Improved

Vatican City, Dec. 30.—(AP)—Pope Pius, reported to have spent virtually a sleepless night, was declared to have "improved somewhat" today.

Pain in his left leg diminished with disappearance of a blood clot that had obstructed circulation in the paralyzed limb, reliable sources said.

Despite the slight improvement, concern was felt throughout the Vatican, where it was feared the end might come momentarily.

PAIR ESCAPES DURING NIGHT FOR KIDNAPER

Two white prisoners, each of whom was being held on serious charges, escaped from the county jail shortly before daybreak this morning and no trace of them had been found this afternoon.

James M. Adams, tried at the last term of Superior court here on charges of participating in a ruse whereby J. E. Pinkham, Beaufort county farmer, was robbed of more than \$400, was one of the escapees.

He was being held in jail pending an appeal to the North Carolina Supreme court. The defendant had been unable to post the required bond pending the appeal.

Randolph Marshburn, one of three men being held for trial on charges of robbing the Turnage mercantile store of Farmville, was the other to make his escape. He was being held for trial in Superior court and his case was scheduled to have been tried tomorrow.

Officers quoted Marshburn as admitting his guilt following his arrest for the Farmville robbery. He was arrested while attending Greene county court.

The sheriff's office said the pair escaped by tearing up the concrete floor in the toilet of their cell and then sawing the bars in a second story window and leaping to a garage and then to the ground.

The time of the escape was set at about 5 o'clock.

Revenue Bill To Ask For Increase Of \$5,000,000

Raleigh, Dec. 30.—An increase of approximately \$5,000,000 a year in the appropriations for each of the next two years for the state institutions and agencies supported from the general fund, including the public schools, will be recommended by Governor J. C. B. Ehringhaus and the Advisory Budget Commission in the report and recommendations to be submitted to the general assembly, it was learned from an authoritative source here today.

This means that the new appropriations bill which will be submitted to the 1937 general assembly will call for appropriations amounting to approximately \$38,000,000 a year as compared with the present appropriations total of about \$33,000,000 a year.

For fiscal year ending June 30, 1937, calls for expenditures of not more than \$32,500,000 present indications are that the actual expenditures will exceed the amounts appropriated by at least \$509,000, so that the total expenditures this year will amount to at least \$33,009,000.

Search Continues For Pair Wanted For Brutal Attack

G. Lem Pleasant Said to Be Getting Along "Mighty Well, Considering"; Officers Spread Net for Two Young Assailants

A search for two young white men who are alleged to have brutally beaten, robbed and shot G. Lem Pleasant, local drug store owner and taxi company operator, on the old Stokes road Monday night has spread into Virginia, the two Carolinas and Georgia, but at mid-afternoon police headquarters announced that no arrests had been made.

Officers declared, however, the identity of the pair is known. It was stated by police officials that Bernard Moore, whose home is on the old Stokes road, and Bernice Aspinwall, native of Georgia who has been in this section recently, have definitely been identified as the pair who called a taxi at 7:10 Monday night, asked to be taken out on the old Stokes road, beat Mr. Pleasant on the head, robbed him of his money and watch and drove off with his automobile.

Hospital attaches said this afternoon that Mr. Pleasant was getting along "mighty well considering" the extent of his injuries. It was stated that he already had lost sight in his right eye and there were fears he would lose both. The victim of the assault was declared to have had a "good night."

Shortly after the attack Chief George Clark, father-in-law of the victim, began a systematic search for the two men—who were not identified at that time. Officers were rushed into Virginia.

The taxi was found abandoned in Dunn yesterday and the search was taken up from that place. Following the arrest of a suspect in Lillington, city and county officers went there this morning, but mesaged back here that the suspect was not either of the hunted pair.

Aspinwall is a native of Georgia and local officers have gone to that state to seek the pair, continuing their search through South Carolina.

Hitler Summons Leaders For Important Conference

Faced With Duce's Advice to Get Away From Spain

Berlin, Dec. 30.—(AP)—Adolf Hitler summoned the sub leaders of the Nazi Third Reich to important conferences today, said sources close to Rome, with Benito Mussolini's advice to get away from Spain.

German political strategists were called into consultation here after Hitler had returned to the capital to pay tribute at the grave of General Hans von Seeckt, post world war organizer of the German army, who died Sunday.

Neither Hitler nor his cabinet members were present at the actual funeral services which were attended by many representatives of the old imperial army.

Mussolini's advice, said reputable sources, was to withdraw from Spain as gracefully as possible. It Duce was represented as having washed his hands of General Francisco Franco and the Spanish insurgents and to have suggested Hitler follow suit.

Benjamin Langley Claimed By Death At Pactolus Home

Benjamin Daniel Langley, 68, died suddenly at his home near Pactolus this morning at seven o'clock. He had been suffering with a heart ailment for the past two years but had been able to keep doing the chores around the house.

Funeral services will be conducted Thursday afternoon at two o'clock from the home of his daughter, Mrs. LeRoy James, 117 West Second street, Washington, N. C. by Rev. D. W. Alexander, Free Will Baptist minister of Bethel. Burial will be in the Webb grave yard near Pactolus.

Mr. Langley was reared in the community in which he died. He was an influential farmer and spent his life at that vocation.

He is survived by his wife, who before marriage was Miss Sarah Teel of Belvoir community, and the following children: two sons, David H. Langley of Lees and Ben Langley of Williamston; two daughters, Mrs. LeRoy James of Washington and Mrs. J. A. Carson; one adopted son, Ray Langley; also two brothers, D. S. Langley, Washington and L. P. Langley of Greenville; two sisters, Mrs. Mary Tiplman, of Washington and Mrs. George Griffin, Greenville; also eleven grandchildren.

NATION FACES DECISIONS ON NAVY POLICIES

Decision on Naval Construction Must Be Reached

TWO OLD PACTS TERMINATE SOON

United States Also Must Determine Whether It Will Fortify Territories

Washington, Dec. 30.—(AP)—Momentous decisions on naval construction and far Eastern policy lie ahead of this country with termination at midnight tomorrow of the Washington and London naval limitation treaties.

Coincidence with the lapse of restrictions of the size of the world's fighting fleets for the first time in 15 years, these problems will be uppermost for solution by the administration.

First, whether two new battle-ships will be added to the American navy.

Second, what the United States intends to do about fortification of its territory in the Pacific.

Officers expressed general satisfaction with the American fleet's state at the year end and hailed progress toward the navy's objective of a combat flotilla of allotted strength by 1942.

Does Not Regret Slaying Accused Murderer Of Son

Mrs. Viola Wickline Serry, However, That Stray Bullets Struck Innocent Bystanders

Jackson Ky, Dec. 30.—(AP)—Mrs. Viola Wickline, who assassinated the accused slayer of her son before 150 horrified court room spectators here expressed, officers said today, regret she wounded two bystanders but no sorrow over the death of her victim, crippled 18-year-old Johnny Shepherd.

"Take me to jail," Jailer Will Combs vowed the small 41-year-old mountain mother was saying, "my child had to go; let him (Shepherd) die."

"He said she assumed sole responsibility for the spectacular killing. A deputy sheriff said Mrs. Wickline calmly professed stray bullets struck George Shouse wounding him seriously in the chest and inflicted a leg injury on Attorney Moses Noble, Howard Moore, another spectator suffered a knee bruise by a bullet.

Mrs. Wickline was removed to a new jail in an adjoining county because Combs said the county jail was "not secure."

Matricide Trial Comes To Halt As Jury Visits Scene

Lee Morrison, 33-Year-Old Cleveland County Man, Charged With Drowning His Mother

Marion N. C. Dec. 30.—(AP)—Trial of Lee Morrison, 33, Cleveland county man, was recessed today while the jury visited the Lake Tuckers spot where he allegedly drove his car into the water deliberately to end the life of his mother.

The State had produced evidence that Morrison, after several unsuccessful attempts, obtained a life insurance policy on his mother Sept. 1st.

She died October 2 as the car tumbled beneath the surface of the lake after Morrison leaped out.

Officers said Morrison told conflicting stories of his mother's death at first.

County Health Board Meets Next Monday

Three members of the Pitt county Board of Health are up for reelection at the regular meeting scheduled to be held in the health officer's office here Monday afternoon at 5 o'clock.

The law provides that the county superintendent of schools, chairman of the county commissioners and mayor of Greenville serve as members ex-officio. In addition two physicians and one dentist are elected to the board for terms of two years.

Dr. W. I. Wooten of Greenville and Dr. M. T. Prizelle of Ayden are the physician members and Dr. Paul Fitzgerald of Greenville is the dentist member. All three probably will be re-elected.

COUPLE SLAIN IN N. C. WRECK

York, Pa., Pair Killed in Accident Near Greensboro

Greensboro, Dec. 30.—(AP)—Mr. and Mrs. Jess Heilman, of York, Pa., met death, and Miss Grace Curran, also of York, was injured, when the car in which they were riding overturned near here this morning.

Mrs. Heilman was instantly killed and her husband died about three hours later at the hospital to which he was removed.

Se was 60 and she was 65. The car overturned down a fifteen-foot embankment when the driver apparently lost control.

Miss Curran, a school teacher, was not seriously injured.

Two Convicted In Superior Court On Homicide Charges

Second Degree Murder Conviction Meted Out to One Negro; Another Convicted of Manslaughter

Two negroes convicted on homicide charges in Pitt county Superior court, were given long sentences as the special term continued at a rapid pace today.

Cullen Green was convicted of second degree murder and sentenced to from 24 to 35 years and Charlie Evans, convicted of manslaughter, was given a term of from eight to 10 years.

Jesse Andrews and Johnnie Jones each were convicted of aiding and abetting in assault with a deadly weapon with intent to kill and each was given eight to 10 year sentences.

George Waters was convicted of receiving stolen property and was given a four month sentence. Willie Mumford was given a 16-month term following conviction on a larceny charge.

John Raskob had the job of reviving the Democratic organization after its terrific lacing in 1928 when dire predictions could be heard that the party might never rise again. Like Hamilton, Raskob had piloted the party in defeat, and was given the job of retiring campaign debts and of putting gas in the old buggy for 1932.

A substantial slice of the money Raskob had amassed in association with the Du Ponts in formation of the Democratic treasury was a personal loan. Raskob kept the organization alive with nearly a half million dollars of his own money. Came 1929 and the big break. The tide of prosperity, upon which President Hoover had ridden, turned into a depression which gave astute Charley Michaelson, Raskob's sabre-toothed publicity man, the weak spot he could attack.

At about this point the parallel in the two jobs ends. Hamilton, a Kansas lawyer, has no General Motors money of his own which he can feed into the party furnace. He has to go out into the field and get it.

His job is made peculiarly tough by the fact he can't go to any possible contributor with a promise of what the party policy will be.

What can Hamilton do? Many industrialists would like to see hope ahead that the corporate surplus tax will be repealed, Hamilton can't promise that, because the national committee didn't promise it.

The possibility of Du Pont money coming to the party rescue hinges only upon the fact that members of that famous powder, chemical, and automobile family paid out most liberally of all in the last campaign.

Besides, there might be a real family distinction in having had a hand in pulling both major parties from the brink.

FARMERS NEED TO MAP PLANS

Early January Good Time to Make Inventory

Raleigh, Dec. 29.—Early in January is a good time for farmers to make plans for the coming year, said E. C. Blair, extension agronomist at State College.

At this period, he pointed out, growers have time to plan their crop rotations and general farm management systems and to take inventory of the farm.

An inventory is essential in keeping accurate records of the farming operations, he added.

The extension service specialist at State College and the county agents over the State will be glad to help farmers in planning rotations and other farm operations, Blair stated.

The county agents will also supply growers with the names of bulletins on the different phases of agriculture which may be obtained free from the agricultural editor at the college.

Blair urged growers to lay in a good supply of lespedeza, soybean, cowpea, velvet bean, red clover, sweet clover, and other legume seed for planting later.

The demand for seed will in all probability far exceed the available supply, he warned, and the price is expected to advance considerably.

Finish plowing all land that is to be planted in the spring, including fields where winter cover crops are now growing, Blair advised, for the more freezing the plowed land can get, the better it will be.

To guard against bed mold, he suggested that tobacco seed should be sown in several beds, located on different parts of the farm, during the months of January and February.

OPPOSITION TO LIQUOR REPORT

Proposal Put Enforcement Under Board Is Opposed

Reflector Bureau, Sir Walter Hotel.

Raleigh, Dec. 30.—The proposal contained in the report of the state liquor control commission to put the enforcement of the liquor control laws under the supervision of the county Alcohol Beverage Control Boards instead of under the sheriffs, also the requirement that from five to 10 per cent of the profits from the sale of liquor in every county be used in enforcing the liquor control laws are going to meet with strong opposition in the forthcoming general assembly, according to rumblings already being heard here.

For while those who have studied the liquor problem and who are interested in liquor control rather than in profits from the sale of liquor agree that better enforcement would result and hence better control of the sale of liquor if the recommendations of the commission should be followed, most observers here doubt if these recommendations will be approved.

One of the reasons for this opinion is the belief that strong opposition is likely to develop from the sheriffs in the various counties against any move to set up a law enforcement agency outside the sheriff's office. The sheriffs will maintain that they, as the duly elected law enforcement officers in the various counties, should enforce the laws, including the liquor laws, instead of an appointed commission.

The county commissioners in the various counties are also expected to oppose any move towards using more than 5 per cent of the profits from the sale of liquor for law enforcement, if that much, since it is already known that most of the counties are interested in liquor stores more than the revenue angle than from the liquor control trade.

Those interested primarily in liquor control and law enforcement agree that the recommendations by the commission would do more to bring about strict law enforcement and the elimination of bootlegging than anything else, but doubt of the "court house rings" in the various counties will agree to them.

SECURITY JOBS TO BE FILLED

But No Appointments Likely Until First Next Week

Reflector Bureau, Sir Walter Hotel.

Raleigh, Dec. 30.—No announcement concerning the appointment of the various administrative officials in the new Unemployment Compensation Commission is likely to be made until Monday or Tuesday of next week, Chairman Charles G. Powell of the commission said today.

For while Chairman Powell has been interviewing applicants for jobs by the hundreds all week and has so far received more than 2,000 applications from job seekers, he is having difficulty in finding the type of men he needs for the more important jobs, he said today.

The other two members of the commission — Mrs. J. B. Spilman and Commissioner of Labor A. L. Fletcher — have also received hundreds of applications for jobs by mail, telephone, telegraph, and in person. But most of these are being referred to Chairman Powell, especially those applying in person.

It is estimated that at least 3,000 persons have applied for jobs with the new commission, when the applications to all three members are considered. It is not expected that more than 30 employees will be given jobs at this time, although eventually the commission is expected to need as many as 200 employees.

The more important jobs which the commission has to fill now are those of a director, a chief accountant, assistant accountant, statistician, director of public relations and perhaps two or three more jobs of this sort. All the others will be stenographers and file clerks.

Washington Daybook

Washington — Chuckles can be heard in Washington over the possibility (nothing definite yet) that Du Pont money will be called upon to pull the Republican party out of the doldrums as it pulled the Democratic party out after 1928.

First of Chairman John D. M. Hamilton's jobs will be to hunt out somebody with plenty of sugar cakes in the larder upon whom substantial levies can be laid.

John Raskob had the job of reviving the Democratic organization after its terrific lacing in 1928 when dire predictions could be heard that the party might never rise again. Like Hamilton, Raskob had piloted the party in defeat, and was given the job of retiring campaign debts and of putting gas in the old buggy for 1932.

A substantial slice of the money Raskob had amassed in association with the Du Ponts in formation of the Democratic treasury was a personal loan. Raskob kept the organization alive with nearly a half million dollars of his own money. Came 1929 and the big break. The tide of prosperity, upon which President Hoover had ridden, turned into a depression which gave astute Charley Michaelson, Raskob's sabre-toothed publicity man, the weak spot he could attack.

At about this point the parallel in the two jobs ends. Hamilton, a Kansas lawyer, has no General Motors money of his own which he can feed into the party furnace. He has to go out into the field and get it.

His job is made peculiarly tough by the fact he can't go to any possible contributor with a promise of what the party policy will be.

What can Hamilton do? Many industrialists would like to see hope ahead that the corporate surplus tax will be repealed, Hamilton can't promise that, because the national committee didn't promise it.

The possibility of Du Pont money coming to the party rescue hinges only upon the fact that members of that famous powder, chemical, and automobile family paid out most liberally of all in the last campaign.

Besides, there might be a real family distinction in having had a hand in pulling both major parties from the brink.

JUDGE FOLGER TO QUIT POST

Expected to Resign and Remain As Committeeman

Reflector Bureau, Sir Walter Hotel.

Raleigh, Dec. 29.—Judge A. D. (Lon) Folger of Surry county has just about decided that he would be Democratic National Committeeman for six months, with the result that he is expected to submit his resignation as a Judge to Governor J. C. B. Ehringhaus within the next ten days, according to reliable reports heard here for several days.

If Judge Folger submits his resignation, as he is expected to do now, it will make it possible for him to continue to hold his job as National Committeeman without further bombardment from the press and public and silence the demands heard from both since he was appointed Judge that he should resign either as Judge or as National committeeman and not try to hold two offices at once. It will also make it possible for Governor J. C. B. Ehringhaus to appoint another special Superior Court Judge—this time perhaps with the approval of Governor-elect Clyde R. Hoey—and this help relieve the pressure on Mr. Hoey as a result of the two seats on the State Supreme Court which he must fill.

Until recently Judge Folger was determined to remain a Judge and also as National Committeeman, regardless of the criticism which has been heaped upon him both in the press and in private, those who know him maintain. But recent developments are understood to have changed his attitude so that he has about decided to give up his judgeship and retain his post as National Committeeman, reports heard today indicate.

One of these developments is regarded as the realization that he would continue to be under fire and hence under somewhat of a cloud, so long as he insisted upon retaining both his judgeship and National Committeeman post.

A second development is regarded as being the revelation that he was appointed a Judge by Governor Ehringhaus without the knowledge or approval of Governor-elect Hoey, thus making it extremely problematical as to whether he would be appointed when his present term expires June 30, 1937, six months hence. Judge Folger was appointed to fill out the unexpired term of Judge Clayton Moore of Williamson, whose term would have expired June 30, 1937. Accordingly, Judge Folger has no assurance he would continue to be a Judge for more than six months longer, even if he should decide not to resign.

Another factor is believed to be that Folger's friends have persuaded him that he can be of more service to the Democratic party by remaining as National Committeeman—and perhaps pointed out that by remaining National Committeeman his law practice should increase to where his income would be much more than the salary of a Judge. They may have even pointed to what his predecessor C. LeRoy Shipp is credited with having done while he was National Committeeman and whose law practice is reported to have grown tremendously.

Still another factor in Folger's reported decision to resign as Judge is regarded as being the fact that he does not belong to the Hoey "machine" and that his appointment as Judge by Governor Ehringhaus is believed to have been largely a conciliatory gesture to the Sandy Graham faction in the Democratic party. Folger was campaign manager for Graham in his successful campaign for the Democratic nomination for Governor in the primaries last summer. Indications are that Mr. Hoey and his faction are still just about as bitter towards the Graham faction as they were during the campaign and as they still are towards the Dr. Ralph W. McDonald faction, which means that there is no lover for Folger in the Hoey camp. Accordingly, if Folger should resign now as National Committeeman, Mr. Hoey could fall to reappoint him as Judge next July, and Friend Lon would be out on his ear and just another successful campaign manager—than which there is nothing deadlier.

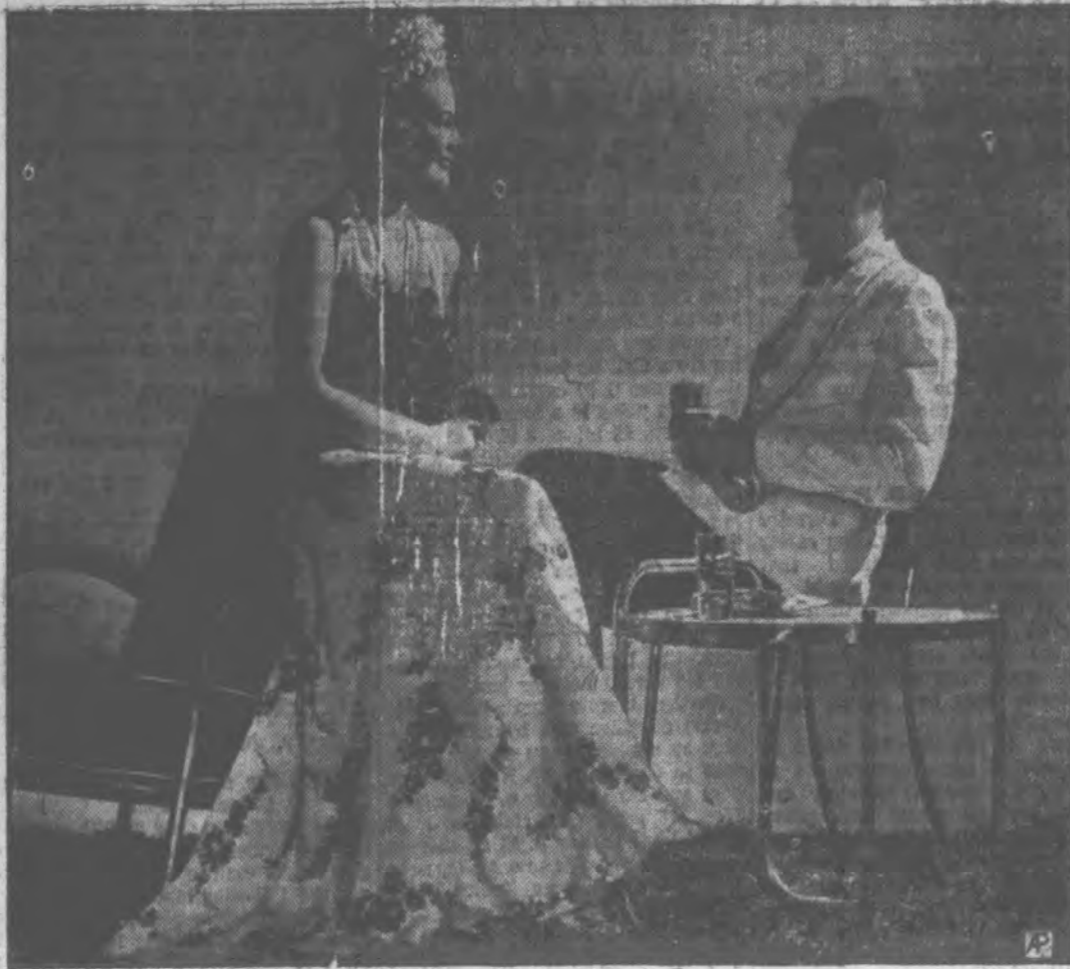
But if Lon resigns as Judge and stays on as National Committeeman, he will still be in a position to make Mr. Hoey and his faction come to him on National matters, while both Senators J. W. Bailey and Robert R. Reynolds will have to consult him about Federal patronage in the state. So indications are that Folger has decided to exchange a six months judgeship which meant only eventual political oblivion for four years of political importance.

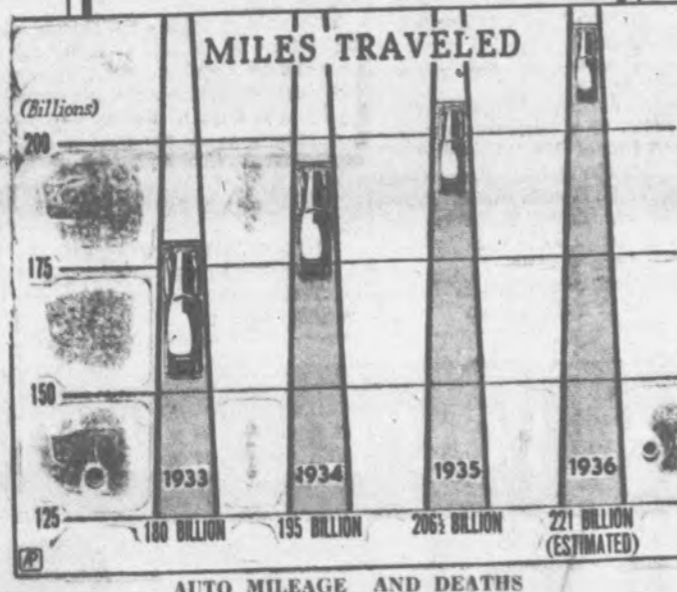
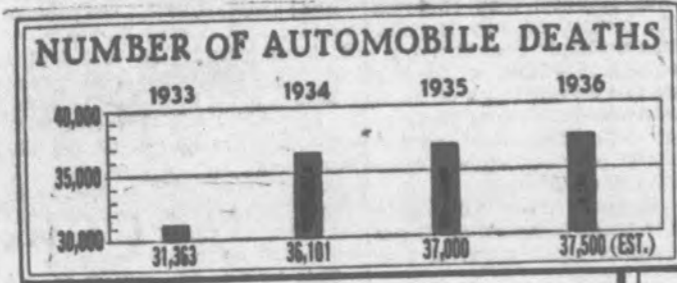
Full Skirts Swish On Frocks Especially Made For Evenings At Tropical Resorts

AUTO MILEAGE AND DEATHS

Chicago—(AP)—Auto accident deaths rose one per cent in 1936 but fell off remarkably in relation to mileage traveled, the National Safety Council estimates. It attributes the improved record to its safety campaign, opened the first of the year, in which 1,000 cities participated.

Judging from records of the first 10 months, the Council predicts that 37,500 persons—500 more than last year, will have died in auto smashes by the year's end. This represents a one per cent increase over the number killed in

1935 but the council considers it a good record because:

- 1. A greater number of cars than ever before was registered;
- 2. Traveled an estimated seven per cent or 4.1-2 billion miles farther than in 1935.

The chart shows how the picture has changed since 1934 when deaths were 15 per cent higher than 1933 with mileage up eight per cent. In 1935 deaths increased two and one-half per cent as mileage jumped six per cent over 1934.

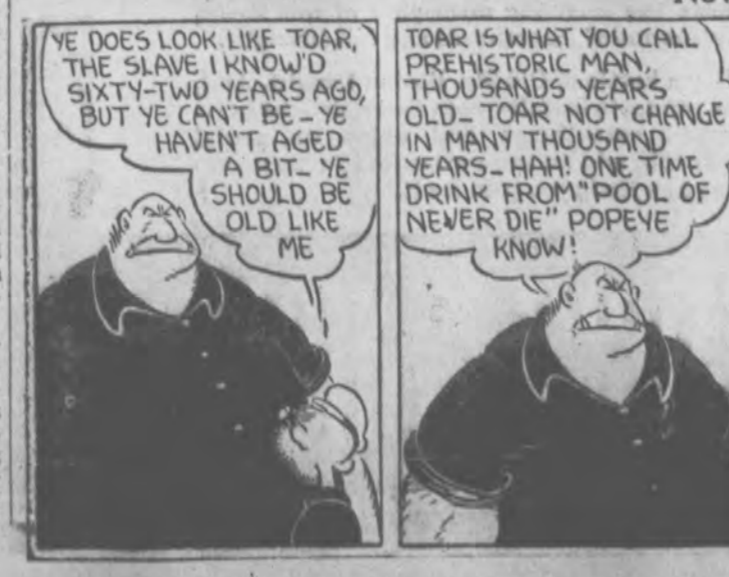

How's Your Health?
 Edited for the New York Academy of Medicine

Kidney and Bladder Stones
 Recognition of the fact that the urinary bladder may be affected by the presence within it of a stone or stones dates from the early times of antiquity. The frequent presence of stone formations in the kidney proper and in various portions of the funnel and tube-like channel which leads from the kidney to the bladder, is a more recent observation.
 Operation for the removal of bladder and kidney stones has become a highly developed and perfected surgical procedure. But surgery does not avail to solve the whole problem, for to begin with there is ever present the risk of the formation of other stones within the affected organ, and medicine, of course, is deeply interested in the prevention of both the primary and secondary stone formation.
 Much thought and study have been of late devoted to the origin of kidney and bladder stones, and an appreciable amount of progress has been made in our understanding of this condition. In the bladder, stones are likely to form when it is affected by a variety of pathologic conditions. Among these are included such conditions as urine retention due to prostatic enlargement, abnormalities in the excretory and formation of the bladder, fistula, ulcers and tumors.
 In various ways these abnormal conditions contribute to the formation of bladder stones which are

likely to form as long as the underlying pathology remains. The theories advanced to explain the formation of stones in the kidney proper are a little more intricate, but are related to those which are held to account for stone formation in the bladder. Of outstanding interest is the so-called dietary theory of stone formation. Experimentally it has been demonstrated that animals, ordinarily free from kidney stone formation can be made to suffer this condition by being fed a diet deficient in vitamin A. Apparently the vitamin A deficiency causes a degeneration of the lining cells of the urinary system, rendering them susceptible to infection. The infection in turn affects the chemical balances normal in the kidney excretions, and favors the precipitation of insoluble salts which form the stones.
 Added to vitamin A deficiency and infection is the factor of obstruction in the urinary outlet, which causes urine stagnation. These three conditions entirely account for the formation of kidney stones, undoubtedly play an important role, and are significant from a preventive viewpoint.

Talks To Parents
 By Brooks Peters Church
 In this day of excessive manuring, everyone's attention is naturally drawn to the hands. One notices them if they are not made up, because then they are exceptional and of course one's eyes are attracted to them if they are tended and cared for and emphasized by enameled nails. But the hand's formation is a clue to character.
 Whether one uses or can use one's hands, and how, has a great deal to do with one's mental development. The smooth, flabby hand of which many women are so proud often betrays a personality only partially developed. The really beautiful hand is fully developed, muscular and thin.
 Long tapering fingers do not necessarily mean artistic ability. The artist's hand is apt to be broad and thick in the palm from muscular development, and is always extraordinarily strong.
 The earlier in life that hand training is started, the better. The very little child should be encouraged to use his hands when he plays. He should be given fewer mechanical toys that run themselves, and more toys that require constructive ability. As he grows older, blocks, pencils and paper, hammer, saw, nails and lumber, needles and thread and scissors should become part of his equipment and care should be taken that he uses all of these tools and becomes skilled in their use.
 Girls and boys should be taught to value and care for their hands, not from the standpoint of beauty but of perfection as tools. If they are trained to function perfectly, real beauty will almost certainly follow, and surely the owner of these exquisite instruments will be a more rounded and complete person than the pampered darling whose hands are "beautiful but dumb."

what might be needed for social security purposes.
 But the budget commission has sliced between \$3,000,000 and \$4,000,000 from these requests so that indications now are that an appropriation of \$41,000,000 will provide enough for social security purposes as well as all other objects, unless the legislature decides to increase appropriations beyond the amount recommended by the budget commission.
 If the Advisory Budget Commission recommends a yearly general fund budget of \$38,000,000 without any provision for social security and then has to add another \$3,000,000 a year for old age pensions, it will have to provide \$8,000,000 a year more revenue than the state is now collecting, it is agreed. This

means that it will have to levy some \$8,000,000 a year in new taxes or increase those now in effect so that they will yield enough to bring in \$8,000,000 a year more than at present.
 But if the general assembly carries out the pledge of Governor-elect Hoye and the Democratic platform to put the exemptions back in the sales tax and remove the sales tax from meals in hotels, restaurants and cafes, it will reduce the present state revenue by at least \$3,000,000, so that it will then have to raise a minimum of \$11,000,000 in new revenue, the tax experts here point out. The job of trying to raise this \$11,000,000 in new revenue is what is expected to keep the legislature here for several months.

This, in turn, will swell the amount of new revenue the 1937 general assembly will have to raise \$8,000,000 a year and necessitate a budget of \$41,000,000 a year for agencies supported from the general fund, it is pointed out.
 This proposed general fund budget of \$41,000,000 a year is still far short of providing the amounts asked by the various departments and institutions, however. During the hearings before the Advisory Budget Commission, back during the fall, the state departments and institutions, including the schools, which are supported from the general fund, asked for a total of \$41,000,000 a year in appropriations, without taking into consideration

FOR STRICTER DRIVING LAWS
Compulsory Jail Sentences Favored for Offenders
 Reflector Bureau, Sir Walter Hotel, Raleigh, Dec. 29.—Compulsory jail sentences for drunken drivers and for reckless drivers endangering life, is not only favored by most of the motorists of the state who replied recently to a questionnaire sent out by the Carolina Motor Club, but by the State Highway Patrol and the Highway Safety Division as well.
 Captain Charles D. Farmer of the highway patrol and Director Arthur Fulk of the highway safety division, are both convinced that more severe sentences would do more to reduce accidents than any other on thing and would like to see the new general assembly, which meets next week, tighten up the traffic laws and impose heavier penalties.
 There is considerable doubt in legal circles here, however, as to whether the general assembly can enact laws imposing mandatory jail sentences or mandatory fines. And even if it is legal for the general assembly to fix minimum fines and sentences for certain violations, there is much doubt as to whether the judges would pay any attention to them.
 At the present time there are many judges who ignore the law imposing a minimum fine of \$50 and cost for drunken driving, it is pointed out, and who either suspend the fine upon payment of costs or impose a fine of less than \$50, frequently only \$10 or \$15 for this offense, although the law makes it mandatory that a fine of \$50 and costs be imposed. The judges take the position that they are supreme and that the legislature exceeds its authority and invades the judicial department of the state government in attempting to set up any mandatory sentence for any particular offense. It is further pointed out that most of the judges are elected, and hence cannot be removed except by the people in a regular election, with the result that the judges who become more popular and hence increase his chances or re-election.
 So while laws making jail sentences mandatory for drunken and reckless driving might be enacted, there is no way to insure their observance by the courts, most observers here agree.

The first injunction on how to catch a cold is, "don't try too hard." There are so many colds around you will catch one easily and without much effort. On the other hand, if you are really ambitious, you can hasten the process in following this way:

Irritate the mucous membranes of your nose and throat. Excessive sneezing, especially by lighting the next cigarette with the smouldering butt of the last will achieve this promptly.

Dry-sweep your home or your workplace so as to raise clouds of dust. The more dust the atmosphere contains, the better. Keep the temperature of your place as much above 67 degrees F as you can, and be sure that the air is really dry. This will help you to catch a cold.

SMOKE A LOT

Get Good and Tired.

Avoid exercise. Stay up as late as you can, being sure to accumulate a good debit of fatigue. If you have things to worry about, stew over them good and plenty so as to do a first-class job.

Never mind dietetic prescriptions. Just eat what you like, when you like and how you like. Over-eating and hasty eating are sure to help you catch a cold promptly. If you suffer constipation, just don't mind it, or else one of the well-known explosive cathartics which is sure to make an impression on your gastrointestinal tract.

Laugh At Weather.

Never mind the weather. Dress according to taste and not the thermometer. Particularly eschew warm socks or stockings, raincoats, adequate overcoats and umbrellas. In this way you will be sure to be caught in a sudden cold spell or in a rain, wearing insufficient clothing, and that will certainly help

INHALE DUST

Chilling your feet and ankles and chilling your head and neck is quite likely to cause you to sneeze promptly, and that is usually a good sign that you have succeeded in catching cold.

Be sympathetic and search out all those whom you know to be suffering from colds. Encourage them to talk loudly and to laugh and notice how the air bestirred is filled with sputum droplets. If you stay long enough and close enough to these persons you will be sure to absorb some of their contagion and your quest for a cold will be achieved.

Mingle With Crowds.

If you want further help in this direction, mix them, use their eating or drinking utensils, shake hands with them frequently and cordially, and then don't wash your hands before eating. If you have no immediate friends, who have colds for you to catch, just mingle with crowds wherever you can find them. The larger the

crowd, and the tighter the pack, the better are your chances for finding a cold.

Pros Can Be Hired Cheaper Than Semi-Pros is Reason

The Coastal Plain League may operate as a professional baseball circuit next summer.
