BILL PROVIDES PENSIONS FOR N. C. TEACHERS

Would Be Allowed To Retire After 35 Years of Service

STATE TO BEAR HALF OF COSTS

Measure Introduced By Rep. Siler to Provide Free Tuition For War Orphans

Raleigh, Feb. 20.—(AP)—Representative Sentelle of Brunswick introduced a bill in the legislature today to create a retirement system for public school teachers.

The measure would provide for pensions for teachers with 35 years or more of experience from a fund to which they had contributed equally with the state during their active teaching years. A nine-member commission would be created.

Teachers would contribute not more than five per cent of their annual pay and should, they retire before teaching 35 years of service, would get back their money with interest.

Sentelle said the plan "has very enthusiastic support" of the teachers and "is needed as the state should think of social security protection for its teachers and others in public service not covered under the federal social security program."

Rep. Siler of Chatham introduced a bill to exempt orphans of war veterans from paying tuitions at state institutions.

Fifty-six legislators passed 38 bills at a perfunctory meeting. The house adjourned in honor of Mrs. John Gray Blount of Washington, mother of Rep. Blount of Mecklenburg, who died this morning.

The local option liquor bill was not voted into law, but probably will be Monday.

The senate sent to the house the measure re-enacting present laws authorizing four special superior court judges.

The senate also approved joint resolutions adopted by the house to create a commission to celebrate the 150th anniversary of the signing of the federal constitution and asking North Carolina congressmen to support the Bulwinkle bill for coinage of a special coin to commemorate the signing of the Mecklenburg Declaration of Independence.

Senators voted to meet at 2:30 Monday afternoon to resume work on the biennial revenue bill and the proposal to put in a two per cent exemption sales tax in lieu of the house-approved three per cent levy with basic foods exempted.

Representatives do not meet again until 8 o'clock Monday night.

Little Success In Efforts To Better Labor Conditions

So-Called Liberals Who Favor Shorter Hours and Other Improvements Dissatisfied

Raleigh, Feb. 20.—So-called liberals, who favor shorter hours and tighter restrictions on employers of labor, are none too well pleased with the record of the current legislature on labor questions. They do feel, however, that some progress has been made in the right direction.

First blow was, of course, defeat of ratification of the federal child labor amendment. Many laborites frankly admit that they concentrated their heaviest legislative artillery on this project and that their defeat was therefore doubly discouraging, despite the fact that most observers feel they made a better showing than the original outlook forecast.

Now those who want better labor conditions are outspokenly disappointed at the courts that state child labor and maximum hour bills seem to be following.

Both these bills were presented in substantially the form the liberals desired. Both have been re-written, it is reliably reported, at the behest of big industrial interests in such a manner as to emasculate them to the point of futility.

In both cases Major A. L. Fletcher, state commissioner of labor, has accepted the changes dictated by big business and on this score he is becoming a fine target for labor folks to snipe at.

He is now freely charged with being something far less than militant in behalf of labor. He has, these critics declare, absolutely deserted the side of the worker and gone over, lock, stock and barrel, to the industrialists.

There will likely be much more of this talk before the end of this session.

PAIR HELD IN FLOGGING CASE

Sheriff Intimates Additional Arrests Probable

Shallotte, N. C., Feb. 20.—(AP)—Sheriff J. A. Russ of Brunswick county intimated today there may be some additional arrests in the Thanksgiving night flogging of Will Inman and Jesse Cox, but said he had nothing definite to announce along this line at the present.

"Things are liable to pop just any time," the sheriff said as he announced witnesses in the trial of the Rev. Vance Simmons and B. G. Simmons, arrested yesterday and charged with an assault with a deadly weapon in the "Christian" flogging of the two Freeland farmers would be summoned this afternoon or Monday morning.

An indication there may be at least one more arrest was seen yesterday in the affidavit of Cox in which he said "I can swear that I could hear one man's voice if I can ever hear it again I still know I can and he don't live in Brunswick county."

Labor Disputes in Nation Marked By Violence

(By Associated Press) A group of "sit-down" strikers maintained defiance today of court orders and a sheriff's demand to evacuate two factory buildings in North Chicago, Ill.

The strike at the Faunsteel metallurgical corporation, unlike those of a number of other current labor disputes in the nation, was marked by two outbreaks of violence.

Eighty-two strikers in the plant successfully resisted an attempt by 125 special deputies to eject them. Later strike sympathizers clashed with an augmented force of 200 deputies.

Some 600 employees of the Detroit plant of Farm Crest bakers, Inc., ended a two day sit-down strike last night and resumed work. They were granted a wage increase and union recognition.

More than 1,000 other Detroit strikers demanding high pay remained in factories of the Bernard Schwartz corporation, Webster Eschenlohr, Inc., the Mazer-Cressman cigar company and the Ferrer stamping company.

Some 250 coal diggers quit work at West Frankfort, Ill., charging the West Frankfort coal company with violation of its contract with the United Mine Workers union.

General Motors corporation reported 220,000 of 235,000 employees were at work and 13,000 idle since the automotive strike would return to their jobs next week.

Negroes Bound Over On Whiskey Charges

As a result of liquor raids on "King's Row" last night by City policemen, four Negroes, two women and two men, were tried in City court this morning and bound over to County court under bonds of \$200 each.

The four are William Hines, Viola Jones, Julius Price and Annie May O'Neal. They probably will be tried in the session of County court next week.

LeRoy Smith, Negro, was bound over to County court under bond of \$200 on a charge of assault with a deadly weapon.

Liquor And Taxes Problems of Week

With 28-Year-Old Ban on Liquor Repealed, Legislators Consider Revenue Bill and Strike Snag in Senate

Raleigh, Feb. 20.—(AP)—Repeal by the General Assembly of North Carolina's 28-year-old ban on liquor held the legislative spotlight this week as the mammoth \$75,000,000 tax bill struck a snag in the senate.

Under the option plan, counties which vote wet on the earliest date possible will be permitted to set up stores for the sale of alcoholic beverages early in April.

The upper branch, during a five-day period that saw 194 bills introduced in two houses, confined itself principally to consideration of the revenue bill in a committee of the whole and set the measure as a special order for Monday.

The house, meanwhile, passed a measure to provide free basal textbooks to elementary school children and received tax and school machinery bills.

Both branches approved a resolution to spend a legislative day in Edenton, the date to be decided by the presiding officers.

The house received a proposal to transfer the State Highway Patrol and division of Highway Safety from the revenue department directly under the governor and also a measure to create a State bureau of identification and investigation.

Solicitors would be allowed \$750 annually for expenses in another bill which hit the legislative hopper and registration of firearms would be required by a measure offered by several representatives.

For the purpose of payments to counties equalizing the cost of highway construction within the several counties, a measure that would authorize a bond issue of \$10,000,000 was offered in the house. A commission recently recommended that no payments be made to 80 counties which requested refunds.

Redraft of the maximum working hour bill of 55 hours a week for men and 48 for women was ordered by the committee on manufacture and labor as it reported unfavorably measures to provide a 40-hour textile week on the compact basis with South Carolina and Georgia, to limit continuous hours of work for drivers of commercial vehicles and to eliminate negroes as firemen on main line trains, minority reports on the three bills were rejected.

The house appropriations committee, which slackened considerably the furious pace it set in passing the spending bill last week in record time, took into consideration the Social Security Act measures which would provide assistance to indigent aged, dependent children and the needy blind. Committee action probably will be taken early next week.

Important bills killed in committee included the Brooks whipping post draft for drunken drivers convicted twice, a proposal for actual retirement of emergency judges and a move for a lower school age for beginners.

Senator Pittman (D. Nev.), author of the legislation said he would submit the committee report Monday and hope to bring the bill up in the senate for debate next week.

Fate of Three Trapped Under Roof Is Undetermined

Nashville, Tenn., Feb. 20.—(AP)—Seven firemen were hurt and three were trapped under a falling roof, their fate undetermined, in flames which destroyed one building and damaged another on the edge of Nashville's business district today.

Spectators expressed fear the missing men were dead, crushed by the debris. Physicians said none of the injured firemen rescued appeared to be in a serious condition.

The fire originated in the four-story building housing the W. E. Stevens manufacturing company. Only the walls were standing an hour after the alarm was sounded. The flames spread to an adjoining building.

Property damage was estimated unofficially at \$300,000.

State Law Enforcement Agency Bill Is Explained

Reflector Bureau.
Raleigh, Feb. 20.—In discussion of transfer of the state highway patrol from the revenue department and reorganization of the patrol, a companion bill setting up a new state law enforcement agency with quite wide and comprehensive powers and duties has been somewhat overlooked.

The bill, introduced by Con. C. Johnston, Iredell, and referred to his committee on roads, is entitled an act to establish a state bureau of identification and investigation and many of its provisions do little more than consolidate existing record keeping agencies under one head; but in addition the new bureau is given sweeping powers to act as a police agency.

First of all, the bill would create a bureau of identification and investigation under supervision of the division of public safety as part of the governor's office.

The governor would be given the juicy patronage plum of appointment and a Director of this bureau, with a salary which would no doubt be fixed at a very substantial sum. This director would then, in turn, appoint a sufficient number of

assistants and stenographic and clerical help.

Nor would the work of these "assistants" be confined to keeping identification records. The bill provides: "The director of the bureau, and his assistants, are given the same power of arrests as is now vested in the sheriffs of the several counties."

Here is plain authority for creation of a state police force of unlimited number.

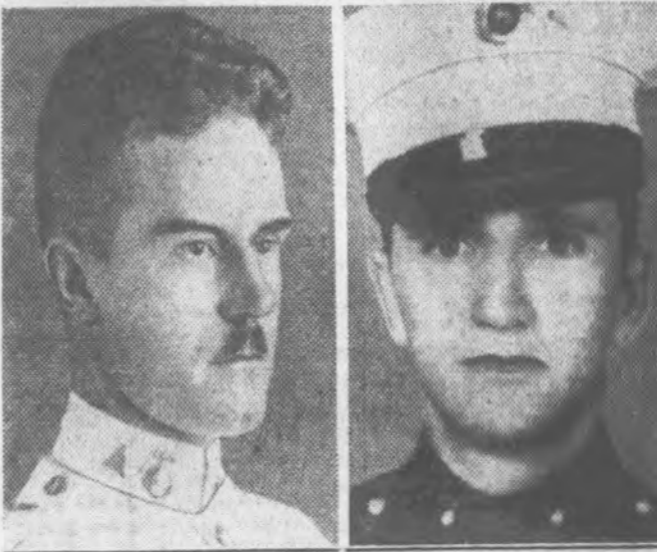
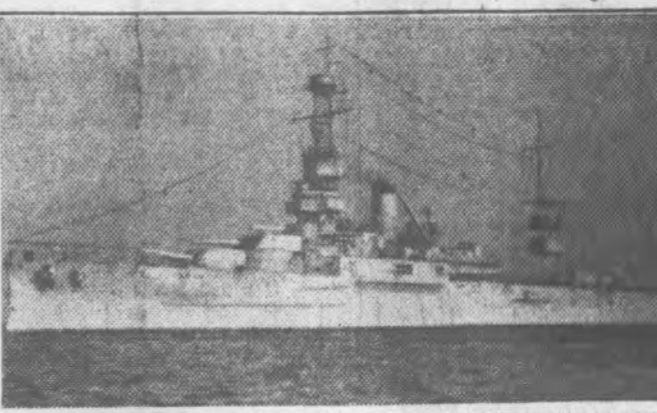
These police officers, the bill provides, "shall give assistance" to regular police officers, "at the request of the Governor."

The bureau also shall "through its director and upon request of the Governor" investigate and prepare evidence in the event of any lynching or mob violence in the State, shall investigate "in connection with elections, when requested to do so by the Board of Elections, and when so directed by the Governor."

On the record keeping and identification sides, the bureau would keep criminal statistics and receive reports now made to the Attorney General with respect to convictions.

FORUM DISCUSSIONS SUPPORTED IN PITT

Discussions Attended By 2,246 Persons During Week

Mrs. Louise Biles Hill of the "Seven County Public Forum" has just completed a week of forum work in Pitt county and has returned to Goldsboro, where she will be stationed next week.

While in Pitt County, Dr. Hill spoke to adult groups at Winterville, Belvoir, Gritton, Arthur, Chidoc, filled four engagements at the East Carolina Teachers' College, and held Youth Forums at four consolidated schools of the county. On Thursday afternoon Dr. Hill spoke to 459 pupils and members of the faculty at the Negro Industrial High School. In all she has addressed during the week 2,246 persons.

The subjects discussed in these meetings were "Southern Agricultural Problems and Suggested Solutions," "The Social Security Act—Is It Adequate?," "Unemployment—Causes and Suggested Remedies," and "The Cooperative Movement." At some of the high schools Dr. Hill spoke on "What Qualities in a Boy or Girl Are Necessary to Leadership?"

Forum technique was employed at each meeting. That is to say, outlines, bibliographies, and pamphlet material were distributed, subjects were discussed in short addresses, then longer periods were given to general discussion. As the speaker explained to the various groups, the success of a forum is measured by the number who take part in the general discussion and in the interest manifested there.

Although Dr. Hill is a Tennessee farm owner and has studied agricultural problems in this country, in Europe, and in Mexico, she explained in her addresses on "Southern Agricultural Problems" that it was not her intention to attempt to tell farmers how to raise cotton or tobacco or poultry, but to deal with the larger aspects of the agricultural question—the problems of surpluses, of marginal and submarginal lands, of population pressure, the South's "colonial economy," the problem of tenantry and other such questions. She recommended that every school principal purchase for the school library a copy of Dr. Howard Odum's book, "Southern Regions of the United States." The book she said had been called "the bible of the South," because it shows, through a survey made by the social research council, the assets and liabilities of the South and gives a clear-cut program of reform.

From the discussions in the forums through the week it was evident that the people were in favor of the President's recommendations with reference to the government's assisting worthy tenants to purchase land and the provision for crop insurance. The majority of opinion was decidedly in favor of the reorganization of the Supreme Court, to enable Congress to deal effectively with the agricultural situation.

Other discussions at the forums concerned taxation, diversification, soil conservation, methods by which surpluses might be absorbed, the effect of a high tariff on agriculture, and the necessity for farmers to organize.

LOYAL TROOPS REPORT GAINS

Embargo Be Clamped on Spanish Peninsula Tonight

(By Associated Press) Reports of government successes came from Valencia and Madrid today as Europe's nation made final plans for clamping an embargo on the war-torn peninsula at midnight tonight.

Portugal, not entirely favorable to the blockade plan, was expected to fall in line over the week-end allowing British inspectors to see that she does not send armaments to her neighbors.

The nation took official individual steps to punish volunteers for the war as hundreds of last-minute battle-minded men rushed toward the Franco-Spanish border, trying to beat the midnight deadline.

Government troops changing their tactics reported gains northwest of Madrid. Insurgents, Madrid said, were chased from covered Aravaca Heights.

BAILEY BUCKS ROOSEVELT IN ROW ON COURT

Wilson Quoted in Argument Against Proposals

BACKERS ASKED TO WHITE HOUSE

Senior Tar Heel Senator Says Real Purpose is To Validate Legislation

Washington, Feb. 20.—(AP)—President Roosevelt seeking all possible support for his judiciary reorganization program, arranged for two conferences with senators at the White House late today.

In the first group invited to the White House were Vice President Garner and these Democrats:

Robinson of Arkansas, the majority leader; Harrison of Mississippi; Ashurst of Arizona, chairman of the judiciary committee; Buckley of Kentucky; Black of Alabama; Byrnes of South Carolina; and Guffey of Pennsylvania.

The second group consisting of senators Frasier and Nye, North Dakota, Republicans; La Follette, Wisconsin progressive, and Schmitt, Democrat, Washington state Democrat.

In a radio address Senator Bailey (D. N. C.) quoted Woodrow Wilson's voice from the grave as an argument against the President's proposal.

Bailey said Wilson described as "outrages upon constitutional morality" attempts to increase the court's size.

The connection of court decisions and the justice of the North Carolina said he has abandoned for arguments for Roosevelt's reorganization plan.

"The real issue is now being avoided," he said, "and that is that it is desired to bring about the appointment of six additional justices of the Supreme court for the plain purpose of validating legislation which its authors admit would be held unconstitutional by the court as now constituted."

"There is a right way to change the constitution and that is by amendments submitted to the state legislatures or to the people."

On Monday American farm bureau federation officials will call to discuss the courts. They will be accompanied by Secretary Wolcott who has said farmers would support the President. He made that statement after the national grand organization of farmers, opposing increasing the size of the supreme court.

Rigid Regulation For All Firearms Proposed In Bill

Representatives Payler and Moore of Pitt Would Require Registration of All Weapons

Raleigh, Feb. 20.—Everyday now owning a usable pistol, revolver or machine gun in the state of North Carolina, and everyone hereafter acquiring a weapon of that type would be required to register it at the clerk's office of his home county, and to obtain a permit to own it, and to obtain a permit to own it, under provisions of a state-wide measure introduced by Representatives John Hill Payler and J. S. Moore, of Pitt, and Dave Dellinger, of Gaston.

Sponsors of the bill feel that it would limit possession and sale of these firearms, so readily available for gangster purposes, to those who have a legitimate reason for possession. They believe, too, it would make it much easier on law enforcement officers to trace ownership of weapons which might be used in crimes committed in the state.

Opposition to the measure is likely to develop among those representatives who feel that law violators would pay no attention to it while law abiding citizens whose only purpose in having firearms of this type is self defense and protection of property, would be put in unreasonable trouble.

The bill would require present owners of pistols, revolvers and machine guns to register them with the clerk of court within sixty days after ratification. Future acquisitions would be registered within 10 days, and subsequent sale, transfer or pledge would be reported within five days.

Unregistered firearms would be subject to confiscation. Clerks would be required to maintain special books showing names and addresses of owners, date of purchase and description of firearms.

Legislative Chaff and Chatter

Raleigh, Feb. 20.—All the talking in the House this session has been done by slightly more than half the membership. A checkup of the roster reveals that no less than 56 representatives out of 120 are on a "Roll of Honor" for keeping their mouths shut except when introducing bills, sending up amendments or on other formal and necessary occasions.

The other 64 have furnished all the oratorical displays, though many of these, in the words of a veteran legislative attaché, "haven't said what they were talking about."

Those who are growing uneasy about prospects for lower automobile license fees will probably be relieved when the House committee, headed by Con Johnson of Inlet, gets through its labors on the Administration highway department reorganization bill. The powers-that-be have so far followed the well-conceived strategy of getting their measures through one at a time. Just now they are bearing down on the road department shakeup.

It seems that Rupert Pickens is always a-picking on Tom Cooper, of New Hanover. Just about every time the legislator from down by the sea gets a bill on the House floor, the Guilford representative begins picking it to pieces. Possibly a haspover grudge from the reappointment fight.

When Pickens asked about a bill recently, Speaker Cherry said: "Can some committee member explain it—not to the gentleman's satisfaction—you can't do that—but just explain it?"

Even the author of North Carolina's perennial whipping post bill deserted his "baby" when it reached consideration in committee. The result, naturally, was a recommendation that the bill "do not pass."

There's a bill in the House to turn Madison county over to Democratic control by arbitrarily adding four members, named in the bill, to the board of commissioners.

Friday a discussion of a local bill resulted in numerous Representatives expressing the opinion that members should leave local legislation in the hands of the duly elected representatives.

Madison's Republican Representative Halsey saw his opportunity and rose. Recognized by the Speaker he said:

"Mr. Speaker and Gentlemen, I just want to say that I, too, am in favor of local self government."

The House made Carl Goersch, Jr., an honorary page Friday whereupon "Pete" Murphy rose:

"And I move you, Mr. Speaker, that Carl Goersch, Sr., be made not a page, but a whole book."

Unfortunately for the radio commentator and editor of The State, Mr. Cherry ruled the Rowan representative "out of order."

During reading of a bill Friday, Representatives C. W. Spruill and Enoch W. Wilson were holding very close converse. In fact, they became so interested they began to raise their voices a bit.

"The clerk will suspend," snapped Speaker Cherry, "until Bertie and Sampson stop holding hands."

Garden Notes

What to plant in March: Start seeds of tomato, pepper, egg plant, Bermuda onion seed in cloth-covered cold frames. It is best to sow the seed in 8 inch rows, dropping 25 to 30 seeds per foot of row. To get strong plants, thin to 2 inches apart in the row and when the plants are 2 1/2 to 3 inches tall, top dress them with about 2 inches of composted soil or rich woods earth. Lettuce plants grown from seed in window boxes may be transplanted to cold frames spacing the plants about 6 inches apart. As soon as the leaves begin to crinkle side dress with nitrate of soda.

Fertilize for the Cold Frames and Garden.

Broadcast and mix well with the soil 1 lb. of 5-7-5 fertilizer per 30 square feet of coldframe a week before sowing seed or transplanting plants.

For the garden, broadcast a liberal application of stable manure. Poultry manure is also good, but because of its concentrated nature it must be used with caution. For general purposes 3 or 4 one-horse wagon loads per acre is sufficient. If manure is not available a 5-7-5 fertilizer is satisfactory for all purposes. If applied in the furrow 15 pound per 70-yard row when rows are three feet apart is heavy enough for most crops. When commercial fertilizers are used in cold-frame or in the garden it should be mixed well with the soil a week or more before sowing seed or transplanting plants.

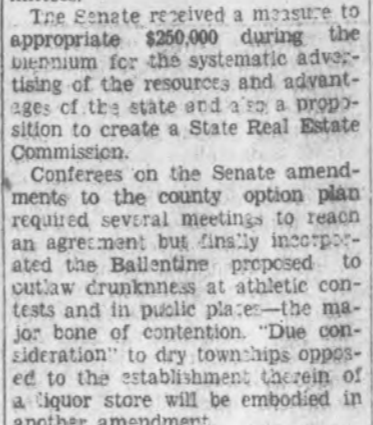
Crops to Plant Out in the Open: Jersey Wakefield Cabbage; Onion seed or onion sets of the White Bermuda, Valencia, Silver Skin and Yellow Globe Varieties; Thomas Laxton peas; Early wonder beets; Chatsenay carrots; White Milan turnips; Long standing Bloomsdale Spinach; Siberian Kale; Green Mt. and Irish Cobbler potatoes. Try growing cauliflower and Brussels sprout by sowing seed in the richest garden spot and thin plants to stand 18 to 20 inches apart in the row. About 4 weeks after the plants have come up side dress them with a little nitrate of soda repeat again with the soda 3 to 4 weeks later.

Asparagus: Every home garden should have an asparagus bed. Twenty-five plants will in the future provide a sufficient supply for a family of five. Broadcast a heavy application of stable manure and incorporate it with the soil by deep plowing or spading as deep as possible. Plant large roots in deep furrows spacing the roots 18 inches apart. If planted in rows, the rows should be 3 1/2 to 4 feet apart. Set plants 18 to 24 inches deep, spreading out the roots. Cover roots only about 2 or 3 inches of good rich top soil at first and gradually work the soil to the plants at each succeeding cultivation until the bed is level. For best results plant large one-year old roots of Martha Washington variety. Do not cut any shoots during the first growing season. Cut lightly the following spring. Too heavy cutting of the young shoots tends to weaken the crowns.

Dr. John Stubbaker, United States Commissioner of Education, who is promoting these forums, has expressed the hope that the states of the Union may take over the forum work and make adult civic education a permanent part of the educational system.

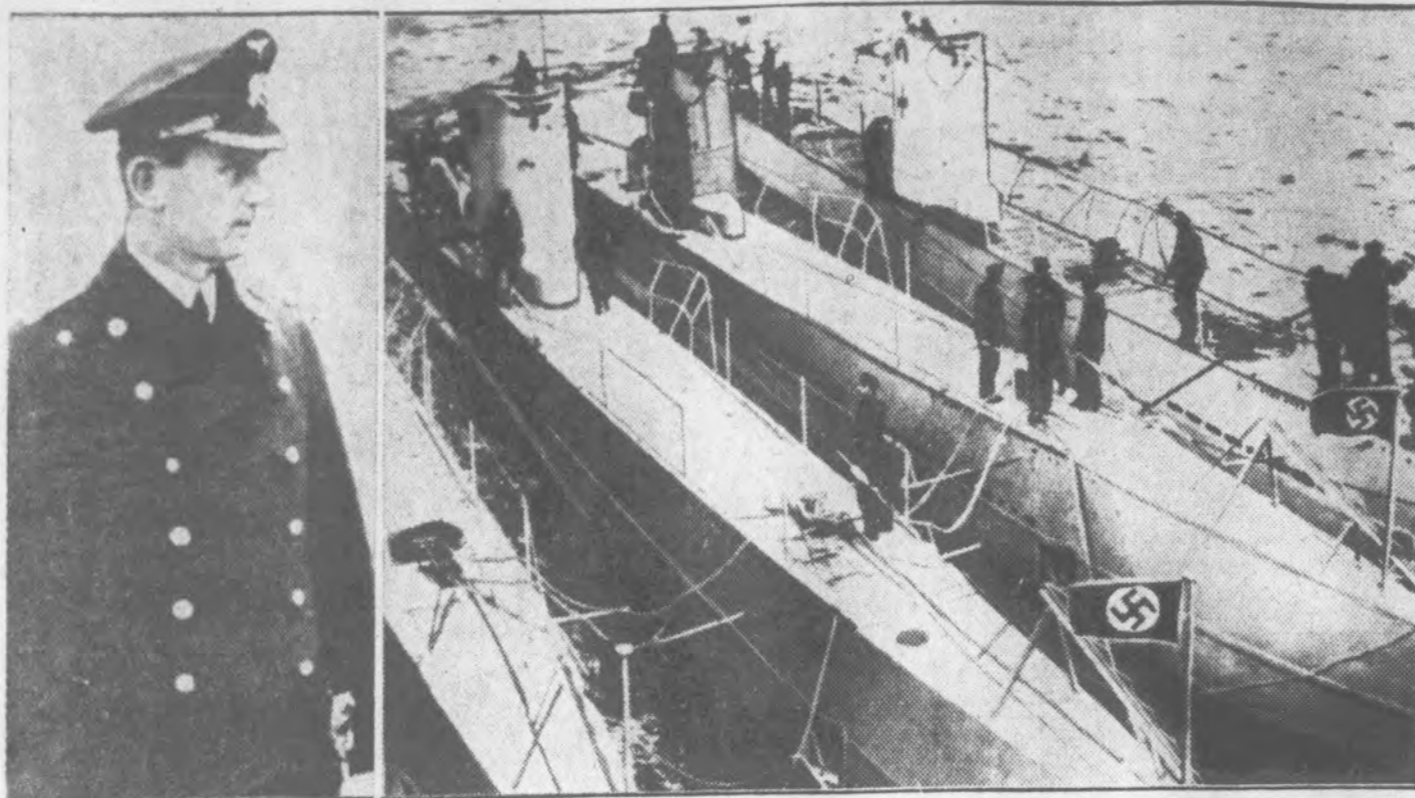
