

FIND BODY OF KIDNAP VICTIM IN ARGENTINA

Interest in Case Compared to That in Lindbergh Snatch

YOUTH STRIPPED OF ALL CLOTHING

Several Suspects Held In Case, But Officials Make no Definite Statements

La Plata, Argentina, Feb. 27.—(AP)—The unclothed body of baby Eugenio Irola, whose three-day kidnapping started Argentina as the Lindbergh case gripped the United States, was found today in the grime of a pig pen on the Baroni villa of his wealthy parents.

The little body, bearing a scalp wound and a cut on one leg, was discovered in an outlying park of the great villa about a mile and a half from the house.

The chubby arms were crossed over the chest. The clothing was not found.

An immediate examination was begun at the villa, where the blue-eyed two-year-old baby lived with his parents and six brothers and sisters, to determine the exact cause of death.

It was believed he had been killed Thursday, the day after he was kidnapped.

A Lecom police communique said merely the body had been found.

It gave no theory as to who carried the boy away from the flower-bordered garden of the place shortly after 7 o'clock Wednesday evening, while the baby's mother left his side to greet her husband, a wealthy sportsman and horse fancier, upon his return from another of his ranches.

The announcement said nothing to indicate whether it, or several suspects now held was believed responsible for the crime.

WOOLARD ENDORSED FOR HIGH POSITION

MADRID AGAIN HIT BY SHELLS

Comparative Tranquility During Past 5 Weeks Broken

Madrid, Feb. 27.—(AP)—Insurgent big guns sent shells into Madrid again today.

Breaking five weeks of comparative tranquility in the besieged city itself, the shells began breaking in the middle of the city and against business buildings.

At least one man was hit. Madrilenos, believing themselves safe from bombardment because of the cold, cloudy day, ran screaming for shelter. Children playing the streets scattered. Several passersby picked up the wounded man and carried him into a basement.

Earlier government leaders here and in Barcelona and Valencia declared that approaching international supervision to block outside military aid from Spain called for united, decisive action.

Imposition of the international plan to cover both the French and Portuguese borders and establish naval patrols, scheduled for mid-night March 6, has brought the government face to face with one of the most delicate phases of the war, they said.

Enlargement of General Jose Miaja's command to include the central front was regarded as one step in a swift attempt to take the upper hand over Insurgent before the double-edged ban goes into effect.

Crisis In Prospect For Tobacco Growing Farmers

Raleigh, Feb. 27.—Legislators from tobacco-growing counties are freely predicting a new and severe "crisis" as the result of the collapse of compact legislation.

The only hope of avoiding such a crisis lies with the companies which buy tobacco, these law makers believe, and most observers do not expect much in that direction. The result is likely, in fact probably, to be another "March on Washington" such as embattled growers staged in 1934 when short opening prices brought a closing of all warehouses in the state, largely through the vigorous action of Governor J. C. B. Ehringhaus, whose course throughout previous tobacco "crisis" is being more and more vindicated every day.

The views of Representative W. E. Fenner, Nash, chairman of the House agriculture committee, are illuminating and characteristic of the reaction of most legislators from the weed belt. "It's too late now to do anything at all about the 1937 crop," said

Assembly Passes Money Measures

Continuing Record-Setting Clip, Legislature Puts Two Most Important Duties Behind it During Week Just Ending

By RALPH L. HOWLAND Raleigh, Feb. 27.—(AP)—The general assembly, continuing its record-setting clip, disposed this morning of the \$78,000,000 revenue bill and the \$145,000,000 appropriations measure.

The tax measure passed the house on third reading early today, shortly after the representatives had approved senate amendments to the spending proposal.

Major items now standing in the way of adjournment are reorganization of the highway commission, free school textbooks and out-of-pocket assistance and child aid bill. So sure were legislators early adjournment that they asked presiding officers to appoint a calendar committee to consider all new bills. Old committees would be discharged. Such action under precedent is not taken until the closing days of the session.

Committee and floor sessions continued at top speed as bills were acted upon by the scores. Representatives introduced measures in a steady stream as warnings came from the chair that "you'd better hurry."

The revenue machinery bill, now being studied by a sub-committee,

is expected to be reported out next week. The group yesterday voted to recommend appointment of a commission to study and report to the 1938 general assembly the proposal on homesteads. Reinserted in the measure was livestock in the category of personal property to which the statutory \$300 exemption applies.

Veteran legislators predicted the machinery bill would "pass like everything else has because we want to get away from here."

A house sub-committee continued its study of the pending social security legislation with Ward of Craven, chairman of the house appropriations committee, fighting for elimination of county obligations to help the old and young. He proposed to place the entire burden for participation in the program upon the state and federal governments and fix the maximum monthly payment to the aged at \$20 instead of \$30. The maximum monthly award to families having dependent children would be \$50 instead of the senate approved \$65.

"If, in two more years, we find greater needs we can do something about it then," Ward said. "Many of (Continued on page two)

SENATE HOLDS MOVE TO STAY BRIEF SESSION SMOAK DEATH

House Passes Revenue Bill in Early Morning Session

Raleigh, Feb. 27.—(AP)—Eight senators passed 19 bills in a perfunctory legislative session today.

Measures enacted into law would ban sale of gasoline to intoxicated drivers in Cumberland and Johnston counties and prohibit sale of alcoholic beverages in a Wilkes township. One sent the house would prohibit the sale of intoxicants near a church in Union county.

House members rested after an early morning meeting a few minutes after midnight, at which they finished work on the \$76,000,000 general fund biennial tax bill.

Next meeting of the legislative divisions will be held at 8 o'clock Monday night.

Among the bills the senate passed and sent to the house was HB-414, Eagles of Edgemore, to change penalties for public drunks in Edgemore.

Local Bills Flood Both Branches As Close Draws Near

With Adjournment in the Air, Legislators Rush Madly to Get Pet Measures Enacted Into Law

Raleigh, Feb. 27.—The panic in adjournment is in the air and every legislator who has a pet project is rushing madly, wildly about the business of getting it enacted into law before it gets caught in the jam that always develops in the dying days of the session.

Of course all this unseemly haste makes for the enactment of half-baked, unnecessary and often positively vicious legislation, but nobody seems to think about it that way, or to care about it even if he does.

Friday's session in the house was a good sample of what's going on. For more than one and one-half hours the people's representatives did nothing except suspend the rules and rush through all the local bills that anybody could then think about.

It seemed that a great emergency had arisen all over the state. This bill—"A purely local measure. Mr. Speaker,"—had to be enacted by March 1st or the people would perish. That bill—"A purely local matter. Mr. Speaker,"—had to be enacted by March 1st or the stars would fall, it appeared.

Grinly Speaker Gregg Cherry stuck to his hard and fast rules that every bill for which rule suspension and immediate passage is asked must be read. Wearily the clerk intoned the many, many sections which "The General Assembly of North Carolina Do Enact." Languidly the House members listened or appeared to listen. Feebly some few squeaked "Aye" whenever the occasion demanded.

CONGRESS HAS MUCH TO SHOW FOR WORK

Still Faces Dispute Over Enlarging Supreme Court

Washington, Feb. 27.—(AP)—Congress had two "hard-fought" new laws today for its week's work, but still faced a puzzling stalemate in the dispute over enlarging the Supreme court if older justices do not retire.

While the senate passed the reciprocal tariff act in almost routine fashion and the house dangled on minor matters, many members of both branches put in real work preparatory to an historic struggle over judicial reorganization.

The speed and ease with which President Roosevelt's tariff bargaining powers were renewed for three years illustrated how the court issue had placed other legislation in the background. Instead of the long consideration expected when the session started, the administration won in the senate 58 to 24 after a minimum of argument.

The bills to let Supreme court justices retire at full pay at 70 was passed by the senate yesterday in less than an hour. Some who made that 76 to 4 vote possible expressed the hope this measure would help to settle a larger court question, as it might if some justices retire.

Visitors to congressional offices could see why so many legislators spent hours at their desks. Senator Vandenberg (R. Mich.), for example, looked up from a stack of mail several inches high to say he had received 700 letters that day.

"And only 25 supported the Roosevelt judicial proposal," he said.

Among developments of the week the house Ways and Means committee approved a stringent price fixing bill for the soft coal industry to replace the invalidated Guffey law.

CLUE STUDIED IN KIDNAPPING

Possible New Lead Is Discovered in Mattson Abduction

Redlands, Calif., Feb. 27.—(AP)—Officers studied somewhat skeptically today a possible clue to the kidnapping—slaying of 10-year-old Charles Mattson at Tacoma, Wash., given by a man who may have seen the boy with the kidnapper while still alive.

Police Sergeant Bert Parr said Dan Early, 42, of Los Angeles, told of meeting a man in Seattle last January 6 who had a young boy in his car and talked the kidnapping.

Early's description of the man, whom he knew only as "Frank" corresponded with that of the kidnapper.

Little Charles was abducted December 27, and was found slain near Everett, Wash., January 11.

Damage estimated at \$100 by Fire Chief George Gardner was caused at the home of R. D. Harrington at the intersection of Fourth and Holy streets this morning when fire broke out in an upstairs room as the result of what was said to have been a defective fuse.

Bond Issue Sole Hope For Secondary Road Program

Reflector Bureau, Raleigh, Feb. 27.—A new highway bond issue offers the only hope for any material improvement in the secondary or county highway system in North Carolina, now that the general assembly, has already adopted a revenue bill which earmarked \$4,500,000 of highway revenue for possible diversion into the general fund to be used for current state expenses. It is being generally agreed here today.

As a result, Chairman Capus M. Wayne of the State Highway and Public Works Commission said today he would no longer oppose a bond issue to be used on the secondary roads, but instead would actively support such a bond issue proposal. It is also reliably reported that Governor Clyde R. Hoey will support a bond issue proposal, provided the bond issue does not exceed \$10,000,000.

Accordingly, it is expected that Senator W. I. Halstead of Camden county, author of the bill now before the senate calling for a \$25,000,000 bond issue to be used exclusively on the county roads, will rewrite his bill so that it will call for a bond issue of only \$10,000,000. In fact, Senator Halstead has indicated he is already preparing a substitute bill to this effect.

The reason for this is that most of the lawyers who have been studying the proposal are convinced that under the new debt limitation amendment adopted in the November, 1936, election, the state cannot issue more than \$10,000,000 in new bonds during the coming biennium, in addition to the permanent improvement bonds, now expected to exceed \$2,000,000, which this general assembly is expected to authorize for new buildings or for repairs to present buildings at various state institutions.

"I have been opposed to the principle of any more borrowing by the state for any purpose whatever, not even more roads, until more of its present indebtedness is paid off," Chairman Wayne said. "But now that the general assembly has decided to divert \$4,500,000 of highway money to the general fund—the money which we had been intending using on the county roads—I am now frank to admit that the only way I see of getting any money at all to improve the county highways in addition to the most necessary maintenance, is from a necessary maintenance, is from a necessary maintenance, is from a necessary maintenance. (By Associated Press) Troublesome week on the labor conflict front ended today with new tests of strength indicated. With an estimated 20,000 workers still idle because of controversy, many of which involved the sit-down strikers, Home Mart of the United Automobile Workers Association took occasion to stress this strike weapon was "still effective."

His remarks in New York apparently were motivated by get-back-to sit-downers during the week at Waukegan, Ill., and Santa Monica, Calif.

Governor Elmer Benson of Minnesota, championing the cause of striking utilities workers in Minneapolis, announced through his secretary he was prepared to take over the strike-bound North States power company plants if he finds authority in law.

The first outbreak to mar the peaceful mood of a score of Detroit labor disputes resulted in injuries to a woman and two men at the Ferro stamping company when lead pellets were hurled in a row between union and non union forces.

In the continuing argument over the sit-down strike at least three governors have voiced opposition to this technique.

Governor Henry Horner of Illinois said there was "no warrant in law to justify a so-called sit-down strike." Governor Wilbur Cross of Connecticut and Harold Hoffman of New Jersey warned they would tolerate no sit down strikes in their states.

The senate roads committee will meet Tuesday in closed session to consider the administration - sponsored highway reorganization measure. Another highway bill - providing a \$25,000,000 bond issue for improvement of secondary roads - will be considered as a special order next week. Senator Halstead of Camden, the introducer, succeeded in having the bill withdrawn from the finance committee and placed on the calendar.

The liquor question, which brought the Dry Forces to Raleigh by the thousands, was settled at least for two years when the legislature ratified the Hanford county option measure.

Amendments reducing the appropriations bill by approximately \$35,000 were adopted by the Senate during a four-day deliberation of the measure. All changes were approved by the house.

Senate revisions in the revenue bill would continue the three per cent tax on meals, place a 4 1/2 per cent tax on gasoline pumps and levy a three per cent sales tax on building supplies, with exemptions.

The house concurred in the proposals with negligible opposition. The Ingram measure to provide for the appropriation of \$100,000 for establishment of the North Carolina State School Insurance Fund was introduced and referred to the Senate committee on education.

The Long bill to provide for the appointment of a commission to study the advisability of establishing a four-year state medical school passed the senate and was sent to the House.

A rerafted child labor bill, approved by the State Department of Labor, was reported favorably by the Senate welfare committee and placed on the calendar. The house recently killed a proposal to ratify a proposed federal constitutional amendment prohibiting labor of children under 18.

The legislature will go to Edenton when it has disposed of major legislation but the date has not been decided. "We're thinking about going Tuesday week!" said President Horton.

The week ended with the senate debating a measure to allow divorce on the grounds of one-year separation. The bill was passed on second reading with Senator Martin of Davidson opposing it.

have never been improved even with sand, gravel, crushed stone or even clay or topsoil. "I had believed that if the general assembly would not divert any of the highway funds, so that we could have increased the amount for county road work by the \$450,000 which it has since diverted, that we could get along without a bond issue," Wayne said. "But now I am convinced that the only hope of improving the county roads at all during the next two years is by means of a bond issue. And we really need \$35,000,000 instead of \$10,000,000. But that will be better than nothing."
