## CAMPAIGN OF UNION FORCES PUSHED AHEAD

### Opposing Unions Gather in Capital to Intensify Drives

### C. I. O. LEADERS CLAIM VICTORY

### United Textile Work- ers' Officials Look- ing Toward South- ern Cotton Mills

(By Associated Press)  
Against the general background of the growing struggle for control of organized labor, new troubles in the automobile field broke out today.

Rickard Frankenstein, organizational director of the United Automobile Workers of America, announced this morning in Detroit, strikes had been called in all major units of the Chrysler corporation in Detroit.

Two sit-down strikes developed in Michigan and the Chrysler corporation rejected a demand from the U. A. W. A., an affiliate of the C. I. O., for recognition of sole bargaining agency of the concern's 67,000 employees.

More than half the 10,000 employees of the Hudson Motor car company, which has been engaged in discussions with the U. A. W. A. has been affected by a sit-down. Among union demands was one for a blanket increase in wages.

Opposing forces in the battle for control of organized labor gathered in Washington today to intensify unionization campaigns.

Their deliberations presaged a widening in the bitter rift between the American Federation of Labor and the committee for Industrial Organization.

Enrollment of some 1,250,000 workers of the far-flung textile industry under the C. I. O. banner was regarded the next goal of John Lewis' group, whose leaders already claim about 2,000,000 members in several industries.

Elsewhere in the capital, President William Green of the American Federation of Labor and 50 seasoned organizers planned to enlist the support of workers in the agricultural, gasoline stations, aluminum, cereal and cement industries, and fighting the C. I. O. all along the line.

United Textile workers' officials, who claim about 75,000 members, considered the possibility of a sit-down strike as a weapon in an impending drive in Southern cotton mills.

C. I. O. leaders claimed several victories over the week-end.

Meanwhile strikes harassed scores of business and industrial establishments on the wide front.

At Akron, Ohio, 10,000 employees of the Firestone Tire and Rubber company, who were made idle by the closing of the factory last week, waited for an agreement between company officials and representatives of the United Rubber Workers of America.

Strikers at the Bethlehem Steel corporation's Lebanon (Pa.) plant voted demands the C. I. O. be recognized.

## Large Police Court Disposed Of Here By Mayor Of City

### Negro Charged With Shooting Another Ordered Held Without Bond; Eight Fined For Gambling

Mayor M. K. Blount disposed of one of the largest city court dockets in some time this morning, when one Negro man was ordered held without privilege of bond for shooting another, eight were fined on charges of disorderly conduct growing out of a gambling game, and several other cases were aired.

J. D. Moore, Negro, was ordered held pending the condition of Henry Clemmons Smith, another Negro, whom Moore is alleged to have shot at a dance at Flemming school Friday night.

Eight Negroes, Preston Brown, Dick Brawley, Buster Cook, Otis Briley, Jesse Smith, Edmond Carr, William Hardy and Joe Gray were fined \$10 and costs each following conviction of disorderly conduct. The eight were accused of engaging in a crap game.

George Gorham, Negro, was taxed with the costs upon conviction of engaging in disorderly conduct.

W. W. Stokes, white man, was bound over to County court under bond of \$100 on charges of reckless driving.

Ben Beecham, another white man, was fined \$10 and taxed with the costs upon conviction of public drunkenness.

## WILSON JAILED RESULT STRIKE

### Admitted Leader Is Booked on Charge 'Disorderly'

Johnnie Wilson, local white man, who admittedly was leader of a "strike" on the post office project here, was lodged in City jail this morning and charged with disorderly conduct.

Wilson was taken to the police station after he and about a score of white men and Negroes gathered about the project with the announced purpose of picketing.

Chief Clark said one of his men instructed the group to disband and all moved along with the exception of Wilson. Officers then took him in custody.

The "strike" started here Saturday morning when Wilson and several Negroes refused to work, giving as the chief cause the treatment they received at the hands of the superintendent, William Morrison.

The men stated at first they anticipated a sit-down strike, but when ordered to move off the property immediately complied with the request. Early this morning the group of non-workers was augmented by several other persons, both white and colored. Wilson said they were sympathizers, but a number of them went to work when given a chance to do so after officers had dispersed the crowd.

Morrison was not in the city this morning and had not returned when the group was disbanded. Two men went on the job before the crowd was dispersed.

Once launched on their "strike" the students demanded greater freedom in entertaining visitors, use of radios, more frequent social functions, and abolition of censorship which, they said, the faculty exercised over telegrams.

The girls went about their usual tasks today, which is the usual weekly holiday for the classes. The school is a self-help institution.

## 'QUAKE FELT IN BAY AREAS OF SAN FRANCISCO

### Articles Are Knocked From Shelves In California Cities

### NO REPORT MADE OF ANY DAMAGES

### Movement Described In Some Sections As Worst Since 1906 Disaster

San Francisco, Mar. 8.—(AP)—Residents of San Francisco Bay regions were awakened from sleep by an earthquake at 2:32 a. m. today which knocked articles from shelves in Bay cities.

Police at Albany and the sheriff's office in Martinez said the movement there was the sharpest they had felt since the 1906 San Francisco disaster.

The quake started an Albany burglary alarm ringing. Hercules Logan, night deputy in the sheriff's office at Martinez reported the quake shook the granite building "like it was nothing."

He heard of no damage, however. Thousands were awakened by the shock, which the coast guard station at Fort Funston described as "sharp."

Telephones at newspaper offices rang almost continuously for an hour after the quake.

Bottles on liquor store shelves were shaken to the floor and broken in an Albany store. A crowd of men gathered in front, waiting for the proprietor in hopes of helping dispose of the salvage.

The shock was less severe in San Francisco where the telephone company reported hundreds of calls by stamned residents.

## REBELS START SHARP ATTACK

### Offensive Launched in Sector Northeast of Madrid

Madrid, Mar. 8.—(AP)—Insurgents launched a sharp attack on a place in the upper Guadalupe sector northeast of Madrid, apparently in an effort to encircle this besieged city from a new direction.

Insurgent artillery killed and wounded several persons in the outlying district of Rastro earlier in the day as hail and heavy rainstorms brought temporary peace to Madrid's front line defenses.

Shivering, rain-soaked militiamen stayed in their trenches ready to repulse any surprise attack in a fresh offense that the Madrid high command expected soon.

Insurgent battalions were concentrated on the Jarama sector, southeast of the capital, and northwest of it, both sections being heavily shelled by the government yesterday.

## LABOR BEHIND PRESIDENT IN COURT BATTLE

### Executive Scheduled To Take Air Again Tomorrow Night

### SUPREME COURT DEFERS RULINGS

### Another Opinion Day Passes With No De- cisions on New Deal Acts Forthcoming

Washington, Mar. 8.—(AP)—Labor leaders who fought for President Roosevelt's re-election sternly aggressively today in support of his court reorganization plan.

About 600 met here at a convention of labor's non-partisan league to hear the plan lauded by some of its leading advocates and to urge congressmen to uphold it.

Senator La Follette (Prog.-Wis.) told the meeting in the struggle over the program "the strength of popular government in America will once more be pitted against the organized force of reaction."

George Berry, league president, declared the proposal should be enacted "to save America."

Assistant secretary of labor Edward McGraw declared the Supreme court had "nullified the will of the people."

At the White House attaches arranged for a conference between the president and representatives of 16 farm organizations.

The president has scheduled his second broadcast on the court proposal tomorrow night at 10:30 (EST).

The high court passed another opinion session today without ruling on one major administration law—the Wagner labor relations act, pending before it.

It failed also to give a decision on the Washington state law establishing minimum wages for women. Decisions on both laws were thus deferred for at least two weeks.

Halstead, Ritter, former Florida federal judge, convicted by the senate of charges of "bringing his court into scandal and disrepute," lost in the Supreme court his attack on the validity of the senate impeachment proceedings in which he was convicted.

Echoes of the controversy over the court sounded in a capitol committee room when members of a senate sub-committee told farm leaders "there is grave doubt about constitutionality of proposed crop insurance legislation."

Some Opposition, However, Voiced On Measure to Extend City Limits At Public Meeting

Three bills affecting Greenville went to Raleigh today to be introduced in the legislature after they had been discussed here Saturday night by members of the Board of Aldermen, departmental heads, Pitt county's delegation at the General Assembly, and private citizens.

Several citizens opposed the measure to extend the city limits, but Mayor M. K. Blount argued a rousing closing argument as the meeting Saturday night in which he declared that it was the Mass of the Board of Aldermen to go ahead with a bigger and better Greenville and declared this could not be done by sitting still and doing nothing.

He brought out that the people affected in the proposal would not have to pay any gigantic taxes and urged them to cooperate with the Board in its efforts to expand the city and "not let it get bottled up."

The other two measures sent to Raleigh for legislative consideration would set up a civil service commission for city policemen and firemen and establish a little social security for the members of the city and police departments.

## PEACE ACTION

**The Church and War**  
Below, from church groups showing the attitude of a number of churches on war, or their programs against it. All of the bodies quoted have local churches in Greenville. Are you acquainted with the peace program of your church?

The Disciples of Christ, in international convention in 1928, called to the attention of its ministers, teachers and editors, "the importance of cultivating an intelligent interest in all peace movements, and in refraining from all utterances that would foster international ill will or hatred."

In 1930 they said in part: "We hold it to be the duty of all good citizens to support the state up to the point where obedience to man becomes disobedience to God, in the firm conviction that the state has bound itself by the terms of the Kellogg Pact never to resort to war for the settlement of any dispute, whatever its origin..."

The Presbyterian Church, U. S. (known as Southern Presbyterian Church), declared in its 1928 General Assembly that "the church should never again bless a war, or be used as an instrument in the promotion of war..."

In a committee report adopted by its General Assembly in 1936, we find: "It is our deep conviction that in such a time as this the Christian Church needs to proclaim with ever greater emphasis that ideal of a warless world which is set before us in the Word of God, and that individual Christians should be striving to claim for themselves the challenging promise of our Lord, 'Blessed are the peacemakers, for they shall be called the children of God.'"

The Protestant Episcopal Church, General Convention of 1928, declared: "We assert our solemn judgment that warfare as an instrument of national policy, or as a means of settling disputes between nations should be renounced. Such warfare... is a crime on the part of a nation, and so to be held by followers of Christ..."

In 1931 it declared: "We believe that as the Christian conscience has condemned infanticide and slavery and torture, it is now called to condemn war as an outrage on the fatherhood of God and the brotherhood of all mankind."

The Southern Baptist Convention, 1933, said: "If the peoples of the world shall become deeply imbued with the spirit of peace and resolutely determine to renounce war and to refuse to engage in war, our present civilization may be saved from suicide."

The Methodist Episcopal Church, South, General Conference, 1930, said: "Christian people all over the world must mold public opinion and mobilize the agencies of peace as to compel the nations of the earth to abandon war in fact and not simply by treaty."

## Claim Pipe Lines Will Boost Ports Of North Carolina

Under Proposal Entire Gasoline Requirements Could Be Distributed Through Ports of State

Raleigh, Mar. 8.—Pipe lines for distribution of gasoline and petroleum products, virtually assured by passage of the bill giving the right of eminent domain to aid in their construction, will be of inestimable aid to the ports of North Carolina, in the opinion of those familiar with the present methods of distribution.

At present much of the gasoline distributed in North Carolina comes from the ports of Norfolk and Charleston because of the fact that the Virginia and South Carolina cities are just about as close to the interior markets as are either Wilmington or Morehead City. Of course, Wilmington is a large distribution center, probably handling about as much gasoline for North Carolina points as Norfolk and Charleston put together. Morehead City is still a negligible factor as little progress has been made in attracting traffic through its newly constructed harbor and terminals.

In the opinion of many experts no great progress will ever be made and the vast sums expended there are going to be a total waste of the government's money.

But with pipe line distribution, out-of-the-state companies, being barred from exercising the right of eminent domain, the entire gasoline requirements of the state will no doubt be distributed through North Carolina's ports—principally Wilmington. This will result in a big increase of business.

First pipe lines will probably be built by a company headed by Harris Newman, Wilmington, a former state senator who has already formed his corporation and who has been actively lobbying for passage of the pipe line bill for several weeks.

It is generally believed that this influence was very powerful in overcoming the last-ditch opposition of the railroads.

# GASOLINE BILL EXPECTED PASS

## Measure Providing for Inspection Probably Be Enacted

Raleigh, Mar. 8.—The gasoline inspection bill is back on the house calendar for passage on second reading tonight or tomorrow and Representative Oscar G. Barker of Durham, together with Representatives Libby Ward of Craven and Thomas S. Royster of Granville, sponsors of the bill are confident the bill will pass as amended, in spite of continued bitter oppositions from the gasoline and oil company lobbyists.

The bill was defeated in the house by a vote of 47 to 46 Friday afternoon, with Speaker R. Gregg Cherry casting the deciding vote against it. A motion was then made to reconsider the vote and send it back to committee to remove the section requiring ports of entry for gasoline shipments into the state. The bill was revised so as to eliminate the ports of entry section and reported back into the house Friday night, taking its place upon the calendar.

"I feel confident that the house and senate will now pass this bill, since most of the members of both houses now realize it is a bill that will protect gasoline users and save them hundreds of thousands of dollars a year," Representative Barker said today. "For the last 1,000,000 automobile and truck users in the state thousands of dollars are being taken from them by adulterated gasoline—but it will also assure the state of getting more revenue from gasoline taxes."

For the vigor with which the gasoline and oil company lobbyists have been fighting the bill has convinced the advocates of it that the state is by no means collecting as much in gasoline taxes as it should be collecting. "I know it is a good bill and that it will benefit the public, otherwise the gasoline interests would not be fighting it the way they are."

The bill was written by Representative Barker, Ward and Royster as a result of the findings of the state gasoline investigation commission which was authorized by the 1935 general assembly and appointed by former Governor J. C. B. Hollis. Representative Barker was chairman of the commission and Ward and Royster members of it. The commission found that the state's gasoline inspection laws and specifications were 20 years out of date and recommended their revision in order to protect the motorist in the state as well as the state itself. Barker is convinced the state has been losing hundreds of thousands of dollars in revenue every year for years as a result of the old and outdated inspection laws. The present bill brings these laws up to date and has enough teeth to compel their observance by the gasoline companies and unethical filling station operators, even with the ports of entry section eliminated, Barker maintains.

The section to which the gasoline companies and the opponents of the bill objected most vigorously when the bill was under debate Friday, was that which would have permitted the Commissioner of Revenue to set up ports of entry along main highways entering the state and have required all trucks transporting more than 25 gallons into the state to register and declare the amount of gasoline or oil being transported into the state. But indications are that the "gasoline trust" is opposed to the entire bill and was merely using this section as a smoke screen to defeat the entire bill.

The principal provisions of the bill are as follows:

1. The creation of a state gasoline and oil inspection board, to serve without salary, to assist the Commissioner of Revenue in setting up definite standards for gasoline and oil sold in North Carolina.
2. The requirement that every gasoline dispensing pump must have displayed on it the grade of gasoline it dispenses, as fixed by the state board.
3. The employment of more gasoline inspectors who shall inspect gasoline sold from retail filling stations as well as from bulk plants, and for the analysis of samples taken from these stations to see that the state standards are being maintained.
4. That gasoline inspectors shall have authority to stop tank trucks on the highways and take samples of gasoline for testing and analysis, and also have authority to test and inspect all pumps to see that they give proper measure.

### NEWS PHOTOGRAPHER DOUBLES AS PREACHER

Tulsa, Okla. (AP)—Week days Krupnick is a news photographer, on the job wherever a story is breaking. Sundays he is a layman preacher, traveling hundreds of miles to deliver his message to church congregations. A Jewish convert to the Christian faith, Krupnick has spoken to thousands of persons of all denominations in Oklahoma, Kansas and Missouri. Krupnick accepts no money for his sermons. Because of his emotional appeal on the platform, he is known as the "weeping preacher."

### Sites Chosen For Two New Markers In Western N. C.

Historical Spots In State to Be Officially Designated by Department of Conservation

Raleigh, Mar. 8.—Texts for two new historical markers, one to be located in Rowan county and the other in Lincoln, have been completed and forwarded to the forestry for casting. R. Bruce Etheridge, director of the Department of Conservation and Development, announced yesterday.

The Rowan county marker will be for Thyratra Presbyterian church, founded almost 200 years ago. The heading and text will read as follows:

"Thyratra Presbyterian church. Founded about 1763. Present building completed 1860. Grave of Samuel E. McCorkle, 600 yards north." It will be placed at Mill Bridge near the intersection of the road that leads to Barber.

The Lincoln county marker will be in celebration of historical Schenck - Warlick Mill, and will read:

"Schenck - Warlick Mill. First cotton mill in State. Built before 1816. Site 1-2 mile north." The location of the site will be near Greensville, near Lincolnton.

With the two texts recently completed, the number of sites erected or in process of casting or placement has reached 103. These are scattered throughout North Carolina.

Marker sites are selected and texts prepared under direction of the State Historical Commission with the advice of historians representing the so-called "Big Five" colleges of the state. Erection is under supervision of the State Highway and Public Works Commission, cooperating with the Department of Conservation and Development and the State Historical Commission.

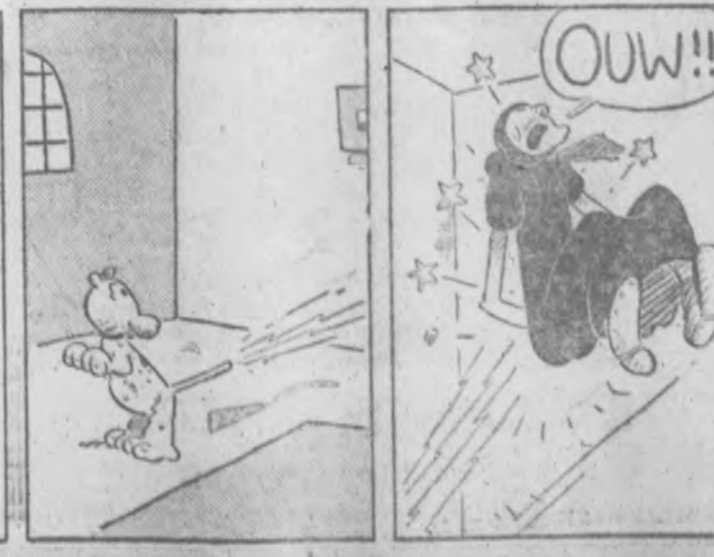

Washington Daybook

WASHINGTON — President Roosevelt left no doubt in his opening series on the Supreme Court that he can hit just as hard as his enemies have said — which seems now hard enough.

Even before he turned his fire directly on the Supreme Court it was well nigh impossible to find in Washington any deep doubt that he would get what he wanted in the way of authority to appoint new members of the body.

If any Democratic members of congress questioned it, they need no longer doubt that the President intends to measure their loyalty to the Democratic party by his measure of their support for his Supreme Court proposal.

Neat Argument. It fell to lesser lights in the administration to hammer out one of the neatest eapons of argument the President used. Reduced to its simplest terms it is: The louder they howl, the more they need the cure.

As refined by the President it came out thus: "This new roar against the court plan is the best evidence in the world that we have begun to keep our promises, that we have begun to move against conditions under which one-third of the nation is still ill-nourished, ill-clad, ill-housed."

Wilson's Battle. Prospects that the court battle, regardless of Presidential urgency, will last a long summer recalls another battle by another Democratic president over another important issue that lasted through a long summer 24 years ago — and the President won.

In his first year President Wilson put forward the federal reserve proposal and thereby brought upon himself a mass of accusations that he was seeking to give the federal government a strange hold on the nation's financial agencies.

Except for an occasional hurried and worried trip to Maine for a week-end with his family, Wilson stayed in Washington through a hot summer and weary fall and kept congress here also sweating in chambers devoid of air conditioning.

Roosevelt follows a different course. He would not postpone his usual early spring trip to his "other home" in Warm Springs, Ga. — and even before leaving he was making plans for a fishing trip among the fresh water shallows in the Gulf of Mexico.

He has come to the conclusion that the health of the President of the United States is a valuable public property.

The fact that the speaker for this second victory dinner will be Harold L. In fact, reports current over the week end are that Senator Bailey rushed down here Friday from Washington and tried to squelch the plans for the second victory dinner on the grounds that such a dinner would be "an insult to Senator Tydings". It is understood that one of those to whom he made this objection informed the Senior Senator that "Tydings had insulted the North Carolina Democrats" in his speech here at the first dinner and that the Democrats down here did not give a rap whether Senator Tydings regarded the second dinner an insult or not.

It also began leaking out here today that many of the Democratic ladies who met and were with Mrs. Tydings while she was here last week are still seething over many of the remarks she is reported to have made concerning the President, said to have been anything but complimentary, and at her apparent sarcastic, patronizing and condescending attitude toward the President and the New Deal. There is no doubt that the Tydings family is decidedly in the dog house in North Carolina right now.

# WARS AGAINST DREAD FUNGUS

## Agriculture Department Wages Campaign on Disease

Raleigh, Mar. 7.—Destruction of more than a million wild and cultivated currant and gooseberry bushes in North Carolina by the State Department of Agriculture in co-operation with the U. S. Department of Agriculture has saved the state from the dread fungus disease known as white pine blister rust. C. H. Brannon, Department Entomologist, announced today.  
"Blister rust of white pine is a fungus disease which requires two different types of host plants to complete its life cycle," the Entomologist explained. "These hosts are white pines, which it kills, and currant and gooseberry plants on the leaves of which the disease grows during the summer months. By destroying all cultivated and wild currant and gooseberry bushes within 900 feet of the white pine trees, the tree can be protected from the disease, since it cannot spread directly from one pine to another."  
The State's white pine resources are valued at more than \$2,000,000 for lumber and ornamental white pines are valued at many millions more.  
"White pine is an important factor in replacing the blight killed chestnut, thus adding to its value for reforestation and soil conservation work," Mr. Brannon said.  
White pine blister rust control work was begun in North Carolina in 1924. Up to the present, the disease has not been found in this state, but there are heavily infected areas in Virginia, Maryland and adjoining states.  
At present there are 90 WPA workers working in five Western North Carolina counties destroying currant and gooseberry bushes. The number of men is expected to be increased to 200 this summer. "It is believed the program of control will be three-fourths completed by July 1," Mr. Brannon said.

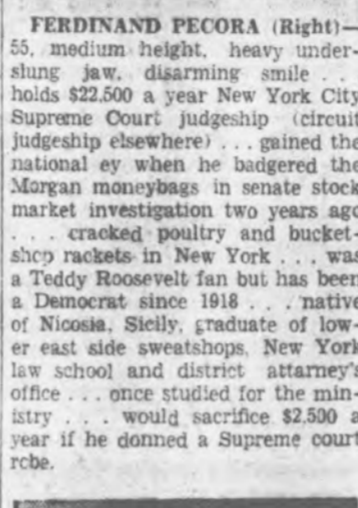

# PLAN TAKE UP BILL TONIGHT

## School Machinery Act Expected to Reach House Floor

Reflector Bureau. Raleigh, Mar. 8.—The school machinery bill, which has been undergoing study and revision by the house finance committee for the past week, is expected to be reported to the house tonight, as amended by the committee and take its place upon the calendar for action Tuesday or Wednesday, depending upon when the house gets to it.

Since it is a tax measure, it will have to pass three readings on successive days so that it cannot pass third reading in the house until Thursday or Friday and will then have to pass three readings in the senate.

The school bill as amended by the house finance committee, leaves the State School Commission virtually as it is now constituted, with the Lieutenant Governor as chairman and the State Superintendent as vice chairman and as a regular member of the commission instead of as an ex-officio member.

As reported out by the house education committee, the machinery act provided for the removal of the Lieutenant Governor from the School Commission and would have made the State Superintendent of Public Instruction chairman in his place. The finance committee, however, decided it was not wise to make the State Superintendent the head of the commission which supervises the allocation and spending of more money than any other agency in the state.

During the next two years the school commission will supervise the spending of almost \$25,000,000 a year, which is more than the State Highway and Public Works Commission spends each year.

It is understood that the provision to make the State Superintendent chairman of the commission did not have the approval of Governor Hoey, who felt that the State Superintendent had enough to do in carrying out the duties of his office and in looking after the curriculum, certification of teachers and the raising of the educational standards of the schools, without taking over the job of supervising the spending of \$25,000,000 a year.

Indications are, however, that the school forces will make a strong drive in the house to get the bill changed back so that the State Superintendent will also be head of the school commission.
