MANY BELIEVE FATE OF SPAIN CLOSE AT HAND

Bitterest Battles Rage On Widely Separated Fronts

REBEL SUCCESS MAY BE AT STAKE

Cuban Government to Cooperate With Mexico in Seeking Means To Halt Conflict

(By Associated Press) Two of the bitterest, bloodiest and most important battles of the Spanish Civil war raged on widely separated fronts today.

In the Northern sector, near Bilbao, the Spanish government rushed mobilization of all available fighting men to repel a big insurgent advance and sent its militia-men up a 4,000-foot mountain peak to block one segment of the assault.

Par to the South, in Cordoba province, opposing armies still were locked in a serious struggle for the possession of a rich mining country. But there the Insurgents were on the defensive.

The success or failure of the Insurgent drive in Northern Spain was construed in many quarters as likely to have a decisive effect on the future of Insurgent General Francisco Franco particularly in view of recent losses in the Guadalupe sector, Northeast of Madrid.

Should he capture Bilbao, more than 200 miles North of Madrid on the Bay of Bilbao, he would be in position to control all points along the Spanish coast and cut off ready accessibility of supplies for government troops there.

In the Cordoba sector, government troops launched a double attack designed to trap 15,000 Spanish and Italian Insurgents in what was said may be one of the greatest mass slaughters of the war.

Meanwhile in Havana the Cuban government announced it would cooperate with Mexico in seeking some means to end the eight-months' long bloody conflict.

Work On State Building Expected To Start Soon

Reflector Bureau, Raleigh, April 3.—Work on the new state office building authorized by the recent general assembly will be pushed as rapidly as possible and will not be delayed by any failure to sell the bonds immediately, Governor Clyde R. Hoey said today.

For the state to borrow temporarily all the funds it needs from the large surplus accruing daily in the state's general fund until such a time as the bonds can be sold most favorably, Governor Hoey pointed out.

He has asked State Treasurer Charles M. Johnson to call a meeting of the commission named to supervise the construction of the building at an early date so that there will be as little delay as possible in getting the building started.

"It is absolutely imperative that this new building be started and completed as soon as possible, since the work of the state is suffering greatly from lack of proper office space," Governor Hoey said. "Many of the departmental offices are so

Soft Coal Industry Withdraws From Conflict Scene

BIG THREE CAR PRODUCERS HIT

Sit-Down Halts Assembly Lines at Kansas City Ford Motor Company Plant

Wilmington, Del. April 3.—(AP)—Mayor Walter Bacon announced today the strike called by the Central Labor union had been canceled at 2 o'clock this afternoon.

The cancellation does not affect the 19-day truck strike which was the cause of the calling of the city-wide strike by the Central Labor union to enforce a settlement.

(By Associated Press) Withdrawal of the soft coal industry from the scene of industrial conflict left the automotive industry as the major trouble spot on the strike front today.

Signing of a new two-year contract after a one-day shutdown of all soft coal mines dissipated the threat of a strike involving more than 400,000 miners.

The compact puts more than 300,000 members of the United Mine Workers of America in line for an \$85,000,000 a year pay boost. But the U. M. W. withdrew demands for a 30-hour week and other concessions respecting working conditions.

All of the "Big Three" car producers were beset by labor trouble, the Ford Motor company joining.

Florida Bar Association Opposes Reorganization Plan

Coral Gables, Fla., April 3.—(AP)—The Florida Bar Association adopted a resolution today, 124 to 37, opposing President Roosevelt's judiciary revision bill.

The vote followed an address by Frederick Stinchfield, American Bar Association president, who predicted an all-powerful central government should the Roosevelt proposal be enacted.

Speaking to the Florida association on the final day of its annual convention, Stinchfield said: "The necessary consequences of course will be an all-powerful central government, with the rights of the states entirely subordinated to Congress and the executive, or to one of them, depending upon the era."

STRIKE HOLDS ATTENTION ON CAPITOL HILL

Sit-Down Strikes Supplant Supreme Court Issue

GROUP SEEKING BAN TECHNIQUE

South Carolina Senator Asks Senate to Express Itself On Method of Strikes

Washington, April 3.—(AP)—Sit-down strikes supplanted the Supreme court issue as the center of congressional interests today.

Senator Byrnes (D. S. C.), sometimes an administration spokesman, asked the Senate to express itself on the sit-downs by offering an amendment to the Guffey-Vinson coal control act, declaring it would be against public policy for miners to remain on company property after written notice to leave.

It was evident Byrnes was not speaking for the administration on this occasion. Senator Robinson of Arkansas, Democratic leader, tried desperately to sidetrack the amendment by sending it to a committee.

Senator Bailey (D. N. C.) objected and demanded a vote. Other senators joined in the argument. The result was adjournment until Monday without voting.

The House rules committee approved a resolution by Representative Dies (D. Tex.) for an investigation by a special committee of seven of all phases of sit-down strikes. It will come up for a House

Pre-School Clinic To Be Held In All Greenville Units

Children Anticipating Entering School For First Time Next Fall Expected To Be On Hand

The annual pre-school clinic will get underway here Monday morning under the direction of the Pitt County Health department.

Examinations will be given at West Greenville school Monday, Third Street school Tuesday, the Training school Wednesday and the Fifth Street school, colored, Thursday.

Examinations are scheduled to begin at 9 o'clock each morning.

The services of dentists have been secured to examine the children's teeth. Dr. A. M. Schultz will be at the West Greenville school, Dr. B. McK. Johnson at Third Street and Dr. Paul Fitzgerald at the Training school. No dentist has been secured as yet for the colored school.

Parents having children who anticipate entering school for the first time next fall are urged to have them at one of the schools. Dr. N. Thomas Ennett, health officer, declared it was necessary that all children who will enter school attend the clinic in order that they may learn of any possible defects and have them corrected.

Children also will be vaccinated. It is mandatory, under state law, that all school children be vaccinated against small pox and health officials are urging them to be inoculated against diphtheria.

The clinics already have been completed in the county schools and were attended by more children than any previous year. At Chicof 66 children were examined.

Several Candidates Out Head Liquor Commission

Reflector Bureau, Raleigh, April 3.—The name of T. J. Murphy of Greensboro is looming large among those being mentioned for the appointment as chairman of the new state Alcoholic Beverages Control Board, which Governor Clyde R. Hoey is expected to name any day now.

A flood of endorsements has been received by Governor Hoey in behalf of F. Webb Williams of Elizabeth City, author of the Pasquotank Act of 1935 and generally regarded as the "daddy" of the liquor stores control system in North Carolina. W. D. McMillan of Wilmington chairman of the New Hanover ABC board and at one time regarded as the chief contender for chairmanship of the state board; of Walter (Pete) Murphy of Salisbury, one of the outstanding "wet" leaders in the state; of Thomas Woodard, a member of the Wilson county ABC board and former chairman of the board of county commissioners in Wilson county; of Outlar Moore of Lumberton, former secretary of the State Dem-

ocratic Executive Committee and assistant campaign manager for Governor Hoey; and others.

No one has any idea as yet as to whom Governor Hoey will appoint chairman of this board or who will be the two part-time members, since all observers here agree that Governor Hoey has remained as mum as an oyster with regard to his forthcoming appointments. But it is known that more endorsements have been received for Webb Williams than for any other candidate and that many of these are said to be very strong.

A good many observers still believe Williams is at the top of the list among those being considered and that if he is not appointed chairman he will at least be named one of the two part-time members of the board—at \$25 a day and expenses when the board is in session.

The biggest thing in the way of Williams appointment is regarded as being geography and the fact that he is from the Albemarle section. (Continued on page two)

SPAIN OUT FOR ALDERMAN JOB

Announces for Office To Be Vacated By Vernon Parrish

Jack Spain, Greenville attorney, insurance official and former County court solicitor, today formally announced his candidacy for the position on the Board of Aldermen to be vacated by Vernon Parrish.

Mr. Spain will seek one of the seats filled by the Second Ward. He is the only candidate to announce formally for the post, although it is understood that J. Hicks Corey will seek the seat.

So far this is the only contest for one of the five seats to be filled this year. Other aldermen up for re-election, all of whom have said they expected to run, are L. B. Fleming of the First Ward, A. C. Tadlock of the Fourth Ward and A. E. Hogwood of the Fifth Ward.

Mr. Spain declared that he decided to run for the post only after Alderman Parrish had announced publicly and assured him personally that he would not seek re-election.

The only other race so far in the city election is one for the post of mayor between the incumbent, M. K. Blount and H. H. Duncanson, who is retiring as alderman. No candidate has filed so far for the position to be vacated by Mr. Duncanson.

Validity Of New Tax Declared Be Certain

Raleigh, April 3.—(AP)—Harry McMullen, assistant Attorney General, today told Revenue Commissioner A. J. Maxwell "all doubt" as to the validity of the use tax adopted by the recent legislature on building materials sold in this state had been removed by a decision of the U. S. Supreme court Monday.

Maxwell said North Carolina would raise about \$300,000 annually from the levy.

President Desires Restoration of Land-Buying Proposal

COMMITTEE TO MEET TUESDAY

Measure Authorizing Expenditure of \$50,000,000 Is Defeated On First Vote

Washington, April 3.—(AP)—An administration leader said today President Roosevelt had expressed the hope the House Agriculture committee would restore a land-buying proposal to farm tenancy legislation.

The committee voted 13 to 13 Wednesday against authorizing the Secretary of Agriculture to spend \$50,000,000 a year to buy farms for resale to tenants and share-croppers on easy credit terms.

It expects to decide Tuesday whether to reconsider this vote.

The administration official, who asked his name not be used, said the President believes Congress should authorize an experimental program of aiding tenants to acquire their own farms. Mr. Roosevelt advised last week, however, against too great an expenditure.

The committee may decide Tuesday whether it will approve two other administration recommendations for a \$75,000,000 rehousing loan and a \$70,000,000 sub-marginal retirement program.

Probe Continued By Detectives In N.Y. Triple-Slaying

Police Still Have Only Three Suspects to Guide Them in Solving One-Wool-Old Murders

New York, April 3.—(AP)—One week ago tonight a staid, middle-aged murderer took the lives of three persons in a Beekman Hotel apartment, and today police detectives still had only their suspicions to guide them in trying to solve the case.

They had what they called "suspect number one," the grayish, old Joseph Gedeon, husband of one of the victims, but after many hours of questioning charges him only with possession of a firearm without a license.

Gedeon, father of Veronica, 20, model, who was strangled to death with her mother, Mary, was free on bail. Police examined assorted needles in his tony upholstery shop, but were loath to say exactly what kind of weapon was used to kill the third victim, Frank Byrnes, a roomer in the Gedeon household.

(Continued from page one) tion from which former Governor J. C. B. Ehringhaus selected so many of his appointees.

If Williams was from the Piedmont or the western part of the state, there would be little doubt as to his getting the chairmanship of the new state ABC board, most observers here agree.

Especially those in the Albemarle counties—having been at the state pie counter for four years and with the Piedmonters and Westerners now pushing and showing to crowd them out and get up to the counter, the betting is now decidedly unfavorable for either Williams or McMillan.

Nor has the campaign for the appointment of "Pete" Murphy of Salisbury as chairman of the new ABC board clicked quite right. For while "Pete" is liked by every one who knows him, is regarded as one of the ablest parliamentarians in the state and has served in more sessions of the general assembly than any other person in the state, the reports are that he has very little chance of being named chairman of the board, or even a member. The main objection to "Pete" seems to be that he is too openly in sympathy with the "wets" and hence would not be sufficiently interested in the control features of the new liquor law.

On the other hand, there are indications that the qualifications of T. J. Murphy of Greensboro measure up very closely to those regarded as necessary. It is understood that Murphy, a former mayor of Greensboro, also a former member of the city council and for years a wheel horse in the Democratic party there, is a personal dry, but a believer in the county stores system of liquor control. Murphy is not a young man, but still not regarded as being too old for the job—he is understood to be about 65 years old. It is also understood that Murphy has been and still is a close personal and political friend of E. B. Jeffers, Greensboro newspaper publisher and former chairman of the State Highway Commission.

It may be of course, as some observers here are saying, that the name of the man who will be appointed chairman of the new liquor control board has not yet been mentioned. For a good many are predicting that this appointment, when announced, will be a complete surprise. But a large number here the past few days have become convinced that T. J. Murphy is looming larger in the liquor control board picture right now than a good many seem to think.

GOOD CHANCE FOR HIGHER BASKETS, WITTE BELIEVES

Laramie, Wyo. (AP)—Willard A. (Dutch) Witte, Wyoming university athletic director and a member of the national basketball rules committee predicts the committee will give thoughtful consideration to proposals the baskets be elevated.

Baskets 12 feet above the floor have been urged by Dr. F. C. (Phog) Ajzen, basketball coach at the University of Kansas for many years. They are now 10 feet from the court.

"Big men, especially in the east, are giving the committee plenty of cause for concern in the matter of interfering with basket shooting," Witte says.

"Many players are tall enough to jump in front of the basket and knock the ball away. This spoils the game since offensive teams thus are prevented from scoring with last legitimate shot."

Tax Collections Pleasing To High State Officials

Reflector Bureau. Raleigh, April 2.—The collection of more than \$11,500,000 in state revenue in the month of March has caused a smile that won't come off to spread over the faces of Governor Clyde R. Hoey and Chairman Capus M. Wayne of the State Highway and Public Works Commission, in addition to the smiles won by Commissioner of Revenue A. J. Maxwell and Assistant Commissioner W. J. Spain.

The Governor and Chairman Wayne said in this record the indication of a general fund surplus of between \$6,000,000 and \$7,000,000 when this fiscal year ends July 1. If the surplus is anywhere near as much as \$7,000,000—and indications are it will amount to about that instead of the \$4,000,000 estimated when the general assembly was here—it means that no money will have to be diverted from the highway fund to the general fund during the next biennium. And that is what is making both the Governor and Wayne smile. For under the terms of the new revenue and appropriations acts, not a single penny of highway revenue can be diverted into the general fund until every penny of general fund revenue and every dollar of the surplus have been exhausted.

This means then, the Governor points out, that it will be unnecessary to divert any money whatever from the highway fund the first year and probably none the second year, thus leaving some \$4,200,000 more of highway revenue available for highway maintenance and construction than had been anticipated. As a result of the fine showing being made by the general fund and indications that it will be more than adequate to meet all the appropriations made by the 1937 general assembly, Governor Hoey has indicated that he expects to start increasing the highway department allotments, especially for county road maintenance, by at least \$2,000,000 the first year and by as much the second year, if revenue collections stand up as well as they now are.

MEN TEACHERS INCREASE IN UNITED STATES

Washington, (AP)—The proportion of men teachers in the schools of the United States is increasing steadily. About 23 per cent of all teachers were men in 1933-1934 as compared with 21 per cent in 1931-1932 and 20 per cent in 1929-1930. Although there was a decrease of 21,061 teachers in the public elementary schools between 1932 and 1934 there was an increase of 7,124 in the number of men teachers.

to appear on a stage here. The artist at times played with such fire and sometimes almost fury, that it was hard to realize so much volume could be forced from a piano; then again with such softness and sweetness it seemed independent of the instrument.

The artist's masterful technique gave him complete command of all the mechanics of the instrument and his playing was clean and clear and marked by excellent rhythm. The first part of his program was made up of a Schumann number, "Symphonic Etudes, Opus 12" in four parts, and a "Grandes Variations" of a Liszt arrangement of Bach in two parts. The second part of the program was composed almost entirely of Chopin and Liszt numbers, most of which were familiar to the audience.

He brought out poetic quality of Chopin's "Mazurka" and "Berceuse" as well as he did the brilliance of Liszt's "Hungarian Rhapsody." He played the Chopin "Chant Polonoise", Maiden's Wish, as if it were a folk dance. He gave a touch of individuality to the Chopin Waltz. Perhaps the favorite with the students was the Liszt "Liebestraum."

The musicians, perhaps enjoyed the opening number by Schumann with its fine quality of tone, deep, resonant and sympathetic, and its strong accents. His second number, "Grandes Variations," beginning with crashing harmonies followed by beautiful passage, liquid in quality, showed that "through great adversity and bitter trial the soul strives toward the Christian goal." In the second part, "The Chorale," which was the realization and resulting emotional exaltation, lovely singing quality, at times almost prayerful, was a marked feature.

The musician was generous with his encores, at the end of the program responding with four numbers. The audience sat still, calling for more, not moving until the artist announced the end by closing the piano.

The student- teachers from the College were present and showed great interest in the program.

Plan To Contract For Hickory-Lenoir Road

Reflector Bureau. Raleigh, April 3—A project calling for the widening of U. S. Highway No. 321 between Hickory and

Lenoir will probably be included in the next highway letting, slated for the week of April 13, it was announced here today by Louis W. Payne, assistant state highway engineer.

The project calls for the widening of 11 miles of this highway, working from Lenoir back towards Hickory to a width of 20 feet, on the straight portions and even more on curves. A few portions of the road may also be rebuilt and some of the curves made less sharp. Eventually it is planned to widen the highway for the entire 19 miles between Lenoir and Hickory.

Another project, calling for new concrete paving between Hendersonville and East Flat Rock has also been approved for inclusion in this next letting, Payne said.

Insect Control:
1. To poison free beetles in plant beds use the following materials:
1. One per cent Rotenone dust at the rate of eight ounces to the 100 square yards of bed, or
2. A mixture of Paris Green, 1 pound; Arsenate of lead, 5 pounds; applied at the rate of one-half pound of the mixture to the 100 square yards of bed. Remove the canvas and apply when plants are dry.
