COURT REFORM AS NOW DRAWN SURE TO FAIL

Survey Shows Compromise Necessary For Win

COMMITTEE POLL REVEALS STATUS

Nine Out of 18 Members Declare They Will Oppose Measure In Present Form

Washington, April 24.—(AP)—A new survey of the closely-divided Senate Judiciary Committee disclosed today administration supporters must compromise in order to win preliminary approval of the court reorganization bill, unless some members change their minds.

Nine Senators, or half the committee membership, said they would vote against the measure as it stands, although not all would be quoted by name. Another was non-committal.

Even if the administration should win the non-committal vote, it could muster only a tie. Ten votes would be required in the committee of 16 to recommend passage of the bill.

If the non-committal Senators should decide to vote against the bill it could get to the Senate with only an unfavorable report. A tie vote would send it to the floor without recommendation.

Unless President Roosevelt agrees to modification, the count showed there was little likelihood a compromise would receive a committee majority vote.

Meanwhile proposals to slash federal appropriations by 10 per cent and to slice \$500,000,000 from President Roosevelt's relief estimates gained fresh support in the Senate appropriations group.

Although some committee members described a fixed horizontal cut as unadvisable, a majority said they would accept it if it proved the only means of balancing the budget by July, 1938.

Peabody Faculty Member To Speak At Local College

Dr. Honor A. Webb, Chemistry Department Head and Editor of 'Current Science' to Be Here

Dr. Honor A. Webb, head of the Chemistry Department at George Peabody College, Nashville, Tennessee, and Editor of 'Current Science,' will be featured by the Science Club of East Carolina Teachers College on Friday night, April 30, at 8 o'clock.

At that time Dr. Webb will speak on 'Enriching the High School Science' and since the meeting will be open to the public, a large number of teachers in this section of the state is expected to attend.

Invitations to attend the lecture already have been accepted by Professors Satterfield and Showalter, of N. C. State College; Professor Preston, of the University of North Carolina; and Dr. Highsmith, of the State Department.

On the morning of the following day, May 1, Dr. Webb will conduct an Open Forum in the College Science Building, answering whatever questions come from the floor regarding the organization of science clubs. Preceding this discussion, Primrose Carpenter, a member of the local club, will give a cross-section view of the activities of his organization during the past year.

WOULD BETTER COTTON TRADE

Association President Deplores Tariff Regulations

Memphis, Tenn., April 24.—(AP)—Ben J. Williams of New Orleans, president of the Southern Cotton Shippers Association, predicted today the South would reach the American standard of living when the tariff problem is properly handled and industrial prices are permitted to seek a common level with agriculture.

Williams, making the president's annual address, sounded a plea for a "subsidy for cotton production to offset the high tariff of our credit nations," adding shippers should not appeal "for payment for idleness and non-production."

He said there was "no doubt" of failure to regain lost cotton markets "unless we take into account immediately the financial and economic situation of the world and until we are willing to accept more dollars in exchange for cotton."

The South's normal export of cotton is 8,000,000 bales, he said, the general increase in world consumption should now make it about 11,000,000, but "our exports have dwindled to about 5,000,000 bales."

"It is important to mention that our exports of manufactured goods have increased," he said, "and our imports of manufactured goods have decreased, both trends being at the expense of our agricultural products."

Provide Another Auto Parking Lot

Efforts on the part of Chief of Police G. A. Clark and Mayor M. K. Blount to relieve the parking situation in Greenville already is netting results and plans are going forward to provide even more lots for the convenience for local motorists and visitors.

The lot between the homes of Mrs. G. B. W. Hadley and Mrs. Virginia Perkins on Evans street has been secured by the city officials to be used for parking. The plot will extend all the way through to Cotanche street and will take in property belonging to the Quinn Miller company and L. B. Garris.

The space will be lighted and a city officer will be assigned to be on duty for a time at least.

The city street department will clean up the plot and put in shape for parking. Cars will enter and leave from the Evans street side.

The city already has provided a parking space behind stores facing Fifth street, vehicles entering from Cotanche street.

Result in Two Deaths, Many Injuries and Heavy Damage

Benton, Ark., April 24.—(AP)—Tornado winds, lightning and hail left two dead, more than a score injured and thousands of dollars property damage today in widely separated sections of the South.

The dead: Herman Zinn, 30, Benton, Ark., farmer.

J. H. Howard, 46, Cullman, Ala., farmer.

Zinn died when a tornado demolished his home and swept through the North section of this town of 3,445 population last night, leaving about 30 persons injured and a block of the residential section in ruins.

Howard was killed by lightning yesterday near Cullman, bringing Alabama's April storm death toll to 11. Severe hail stones were reported in other sections of Alabama.

JUDGE ALLOWS DEFENSE PLEA

Refuses to Expunge Evidence in Behalf Of Denhardt

New Castle, Ky., April 24.—(AP)—Circuit Judge Charles Marshall today overruled the commonwealth motion to strike from the record George Baker's statement Brigadier General Henry Denhardt "could not have killed" Mrs. Verna Taylor.

Commonwealth Attorney H. E. Kinsolving, Jr., moved to expunge the statement upon convening of court today for the second day's testimony in the state's efforts to convict the bald war veteran for the murder of his comely fiancée on a road near here last November 6.

For half an hour opposing counsel and the judge argued in an ante-room and then the judge came out and refused to strike out the statement.

Baker had testified Denhardt came to his home that night to telephone for a mechanic to repair his car which was stalled. Baker said he heard two shots, a loud one "pop" as he described the second one. His statement made at Denhardt's examining trial and reiterated yesterday was:

"I don't know this man (Denhardt) and I don't know this woman (Mrs. Taylor) but Mr. Denhardt couldn't have killed her because I was with him when the second shot was fired."

Sentence White Man For Beating Spouse

Adron Smith, Greenville white man, was sentenced to two terms of 30-days each on the roads today on charges of drunkenness and beating his wife.

This was the only case tried at the regular Saturday morning session of police court.

A. E. HOBGOOD TO RUN AGAIN

Present Alderman From Fifth Ward Announces

A. E. Hobgood, who is completing his eighth year as alderman from the Fifth Ward today formally announced his candidacy for re-election.

R. Troy Burnette is the other announced candidate for the office.

A. C. Tadlock is the only member of the present board whose term expires this year who is without opposition in the primary-election on May 3.

April 27, five days prior to the election, is the deadline for filing for alderman. The time expired yesterday, 10 days prior to the election, for filing for the office of mayor.

Two candidates are out for the office of mayor. They are the incumbent, M. K. Blount, who has served for about a year and four months by appointment to fill the unexpired term of the late R. C. Flanagan, and H. H. Duncan, present alderman and mayor pro-tem.

C. A. Musselwhite is opposing L. B. Fleming, incumbent, in the First Ward. Jack Spain and J. Hicks Corey are contesting for the post from the Second Ward.

Mr. Hobgood was appointed to fill the vacancy caused through the resignation of R. M. Garrett and since has been elected to the office.

Frank Dunlap Slated For Highway Commission Post

Reflector Bureau, Raleigh, April 24.—Frank L. Dunlap, present Assistant Director of the Budget, is expected to be appointed the new chairman of the State Highway and Public Works Commission to succeed Chairman Capus L. Waynick, who is now not expected to be reappointed by Governor Clyde R. Hoey.

Until the last two or three days friends of Waynick have been convinced that he still had a good chance to be reappointed chairman, despite the fact it was agreed that Governor Hoey was trying to find some one else for the highway job, had offered it to one or two others. But they felt that in the end the Governor would come back to Waynick and reappoint him, by a process of elimination.

But in all of the speculation indulged in so far, the name of Dunlap has not been mentioned until the last day or so. Yesterday there were reports both from Washington, D. C., and from sources close to the Governor that Dunlap was now regarded as more likely to be named

Secure Extension For Tenth Street

State Highway and Public Works Commission Expected to Let Contract For Link Connecting With Washington Road

Extension of Tenth street and the construction of a hard-surfaced highway linking it with the Washington road within the near future is practically assured.

The proposal is part of an extensive program inaugurated by city officials several months ago. It is linked with the widening of DeKintzen avenue, construction of the underpass at the cotton mill and moving of the Atlantic Coast Line passenger station. The underpass has been completed and work is going forward on the road leading up to it.

The station has been moved and other changes made at the site to improve the traffic situation. When, and if, the Tenth street project is completed the traffic problem will be greatly improved for the city, according to the expressed belief of those familiar with the proposal.

A map showing the proposed route has been posted in the court house by the State Highway and Public Works Commission, indicating that the project is nearing a reality. Surveys have been completed by State engineers. Officials now are signing up property owners

for a right-of-way. Most of those approached, it was stated, are cooperating in efforts to get connecting link.

Mayor M. K. Blount, who has been behind the project for some time, said today he hoped the Highway commission would let the contract at its next letting, about the middle of May. The project already has been approved by the Federal Bureau of Roads and letting of the contract is understood to be the next step.

The proposed route calls for the extension of Tenth street and a hard-surfaced connecting link with the Washington road. The proposed two-mile stretch will come out at the hill beyond the cemetery and at the curve at Williams' filling station. It will parallel the South side of the proposed city park. The city park, which is to be developed across the highway from the cemetery, will be in between the two highways. The new highway also was in mind when efforts were started to establish the park.

MADRID AGAIN HAS CIVIL RULE

General Miaja To Concentrate On Fighting Rebels

(By Associated Press) Civil rule came back to Madrid today.

General Jose Miaja, the military dictator, was deprived of his civil powers over the city of a half a year ago and instructed to devote all his energies to fighting Francisco Franco's Insurgents.

A heterogeneous anti-Fascists city council took command of the city's civil affairs.

Low, black clouds stopped a vicious 12-day insurgent artillery bombardment, which had taken the lives of more than 250 Madrilenos.

In the North the Insurgents, reputedly reinforced by 1,500 regular Italian artillery men, pressed on to El Orto, one of the obstacles to their capture of Bilbao.

New food ships left France with supplies for Bilbao. The city's Basque defenders were already cheered by arrival of food on three British freighters which got in yesterday, running an attempted insurgent sea blockade.

In Rome it was announced Spain would be one of the subjects which German General Hermann Goerring and H. Duce will talk about Monday. Some thought Mussolini was reconciled to a compromise on Spain and would not help Franco any more.

Deputies Arrest Man Transporting Liquor

Wille Howard, Goldsboro white man, was in jail here today awaiting trial on charges of transporting illegal liquor. He was arrested by members of the sheriff's office last night.

Officers said 35 gallons of bootleg whiskey was found in the car driven by Howard, who was alone. The man was taken in custody about 10 o'clock. He was apprehended on the Farmville highway.

Accident Patients Declared Bad Pay

Raleigh, April 24.—(AP)—Dr. Fred Hubbard of North Wilkesboro told the tri-State Hospital Conference today that caring for victims of automobile accidents is "the greatest problem" with which American hospitals have to contend.

In 1935, Dr. Hubbard said, 265,000 patients were treated at hospitals. They were billed \$17,000,100, he said, but only \$8,670,061 of it ever was collected.

The physician urged "compulsory automobile liability insurance" and said the car was similar to a "Frankenstein monster that threatens to destroy its maker." He said it was "force both for good and evil."

The three-day conference ended at noon.

NEW GAINS ON LABOR FRONTS EASE TENSION

Ford Motor Plant Is Evacuated After Six-Hour Siege

CALL PARLEY ON CANNERY STRIKE

National Labor Relations to Supervise First Election On Bargaining Agency

(By Associated Press) Evacuation of a Ford Motor Company plant by sit-down strikers and a peace parley in a riotous cannery strike eased tension in two major California labor disputes today.

At the opposite end of the continent, New York's union officials discussed the possibility of a strike by 25,000 railroad employees in a dispute over wages.

The 600 sit-downers at the Ford assembly plant in Richmond, Calif., made their exodus early today, 11 hours after taking possession as a protest against alleged discrimination in the departmental transfer of 12 unionists.

U. A. W. A. officials, who urged the strikers to evacuate, said, dispute would be settled in a day or two. A representative of the American Federation of Labor, said the federation had sought recognition as a bargaining agency for Ford employees.

A tentative agreement on wage increases and union recognition was in prospect in the bloody cannery strike at Stockton, Calif. Representatives of opposing forces who met with Governor Frank Merriam jointly stated they were "not far from a satisfactory solution."

The conference followed a clash between pickets and sheriff's deputies and state officers in which half a hundred officers were injured, two seriously.

Four persons were hurt in demonstrations against a food store chain at Cincinnati, scene of a meat cutter's strike.

Leaders of the Brotherhood of Railway and Steamships clerks, freight handlers, express and station employees said the threatened New York railroad strike involved a refusal of major roads running into the city to grant a 20 cents an hour wage increase.

The National Labor Relations board will supervise the first election in the automobile industry under the Wagner act. Packard Motor car company workers will decide whether the U. A. W. A. shall represent them. Alvan Macauley, Packard president, said it would "definitely settle the question."

N. C. Strawberry Markets Opened; Crops Half Normal

Although Rainy Weather Cut Down on Quantity, Prices Considered Good For Fair Grades

Reflector Bureau, Raleigh, April 24.—All of the strawberry markets in the state are now open, the Burgaw market opening today, it was learned from the Department of Agriculture. The markets in Wallace, Chadbourn and Rose Hill have been open most of this week.

The outlook is for only about half a crop, however, and for only fair quality, although prices are quite good, averaging from \$4.50 to \$5 a crate for the better grades.

The reason for the short crop is the cold, rainy weather during the past month or six weeks, which has not been favorable for good bearing or proper ripening, and which has materially reduced the size of the crop. Another big factor was the unusually warm weather in January and February, with the result that many of the plants blossomed then, only to be damaged by frost and freezing in March.

Last spring it is estimated that strawberry growers shipped more than 1,400 carloads of berries by train and truck. This year it is believed that not more than 800 car loads will be shipped.

It is hoped, however, that owing to the short crop the prices will be higher than usual and that as a result, the growers will not lose as much as otherwise would be the case.

Kiwanis Club Program
Dr. Dorothy M. Snyder, of the Art Department of East Carolina Teachers College, and Howard Bailey, of Raleigh, State Director of the Federal Theatre project, spoke at the regular meeting of the Kiwanis club held at the Woman's club in connection with the annual Community Fine Arts Festival, in progress there.

Judge Dink James presided and introduced the speakers of the evening.
Dr. Snyder, a graduate of New York University, always a charming speaker, spoke briefly and entertainingly on the subject, "Art in America," giving its historical background, its present trend and a futuristic glimpse of its possibilities. 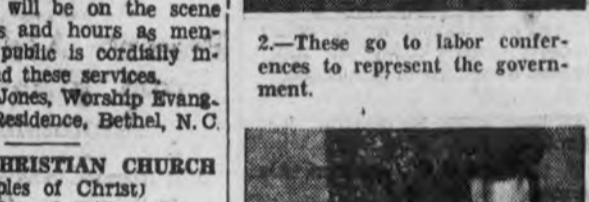

alcoholic beverages are observed and performed.

2. To audit the accounts, records and books of county boards and stores.

3. To approve or disapprove the prices fixed for alcoholic beverages by county boards and to maintain uniform prices in all the liquor stores in the state.

4. To remove any member or members of county liquor boards when in the opinion of the state board such member or members may be unfit to serve.

5. To test any and all alcoholic beverages which may be sold and to install and operate such apparatus and laboratories as may be needed.

6. To supervise the purchasing of liquors by county boards when it is regarded advisable for it to exercise such powers, and have full authority to disapprove any purchases and to inspect all invoices, papers, books and records.

7. To approve or disapprove all regulations adopted by county boards for the operation of county stores and for the enforcement of the ABC laws.

8. To require not less than 5 per cent and not more than 10 per cent of the net profits from the sale of liquor in the counties having liquor stores to be used for the enforcement of the ABC laws.

9. To remove officers employed, elected or appointed in the counties where liquor stores are located in case of violation of the terms or spirit of the law.

10. To approve or disapprove the opening of county stores, except in the county seat of each county which may vote for ABC stores, and to give due consideration to the welfare or morals of the community and to approve the location of any additional stores which may be opened from time to time.

11. To have the authority to close any of these additional stores at any time it may decide such additional stores are not operated efficiently or may be inimical to the welfare or morals of the community, or for any other cause as the board may decide upon.

12. To require the use of a uniform accounting system in the operation of all county liquor boards.

13. To grant or refuse to grant permits to any person, firm or corporation selling alcoholic beverages in North Carolina and to require that applicants for such permits furnish such information as may be required by the board as a condition precedent to obtaining such permits.

14. That the state ABC board shall have such other powers which may be reasonably implied from the granting of the express powers named, together with such other powers as be incidental to or convenient for carrying out and performing the powers explicitly given in the law.

15. To permit the establishment of warehouses for the storage of alcoholic beverages within the state and to prescribe rules and regulations for these.

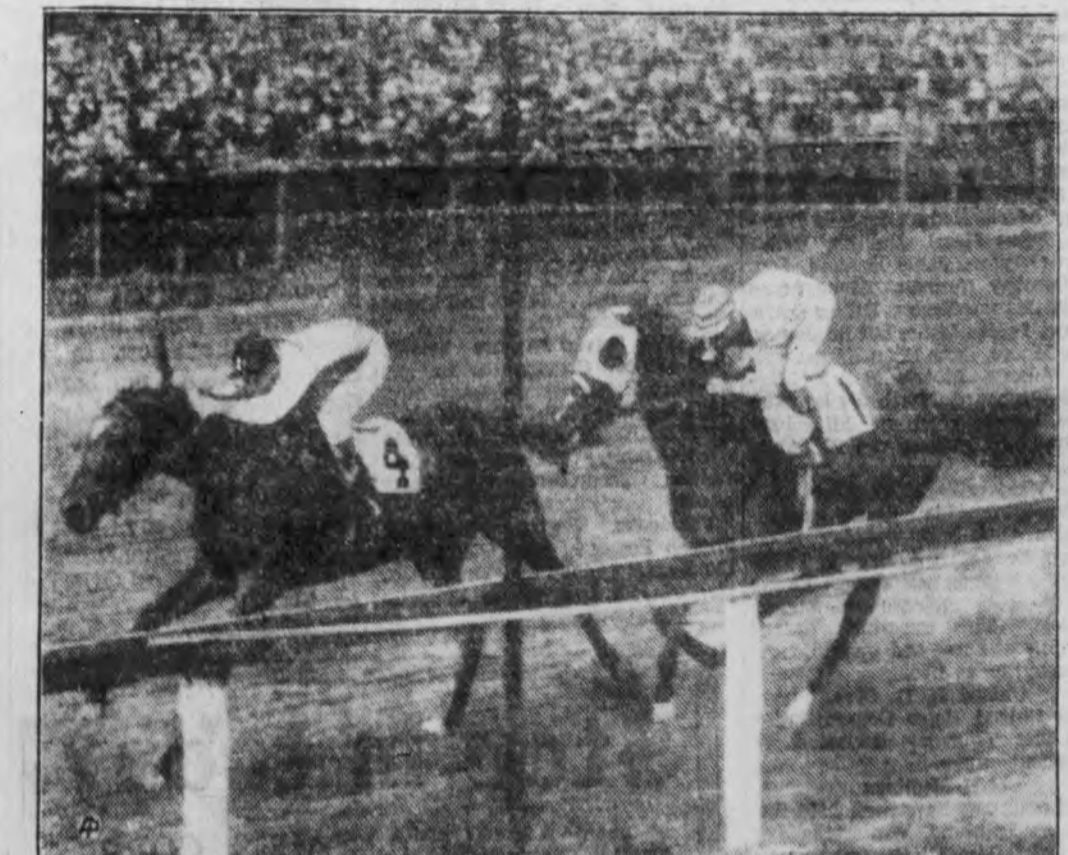
New State Liquor Board To Have Plenty Of Work

Reflector Bureau, Raleigh, April 24.—The new State Board of Alcoholic Control, already generally referred to as the State ABC board or the "state liquor board," just appointed by Governor Clyde R. Hoey, is going to have plenty of work to do, according to those who have been studying the act creating it and outlining its powers. The new board also has very wide powers in that it is charged with the administration and enforcement of the liquor control law throughout the entire state, with authority to remove the members of the various county liquor control boards or of law enforcement officers in the counties serving under this act.

The board, composed of Cutler Moore, Lumberton, as chairman and of F. Webb Williams, Elizabeth City and Thomas J. Murphy, Greensboro, as part-time members, is expected to meet here Tuesday or Wednesday of next week to be sworn in and to hold its first meeting. It must supervise the opening of any additional liquor stores in any counties which may vote for such stores under the 1937 act. The duties of the state liquor board, as set out in Section 4 of the 1937 liquor control act, are as follows:

1. To see that all the laws relating to the sale and control of alco-

NORTH CAROLINIANS IN NATION'S CAPITAL

By PAUL BARKLEY (AP N. C. Correspondent) Washington, April 24.—(AP)—Words of praise for Representative Robert L. Doughton of Laurel Springs, fell this week from the lips of Senator Robert R. Reynolds of North Carolina.

Doughton, known to his constituents as "Farmer Bob," has been widely mentioned in North Carolina as a possible opponent against Reynolds, known to his followers as "Our Bob," in next year's Democratic senatorial primary.

Reynolds, however, in a nationwide address Thursday night on the problem of taxes, paid tribute to his colleague who as head of the House Ways and Means Committee wrestles with the question.

"Upon his shoulders falls the burden of guiding tax legislation in the house, where all revenue measures must originate," Reynolds said.

"I am confident that when the time for tax revision comes, he can be counted upon to aid in bringing order out of chaos in our present system of taxation. Such a program will have my unqualified support."

Washington Daybook

By Preston Grover

Washington — Congress took one glance at the President's relief budget message and began settling housing and farm tenant legislation short.

When the President said "an increase in appropriations would of course nullify our efforts to prevent a deficit in 1938," he virtually asked congress to knock off the welfare business as far as convenient and stick to the business of balancing the budget. That, now, is the best welfare work.

"While I recognize many opportunities to improve social and economic conditions through federal action," he said, "I am convinced that the success of our whole program and the permanent security of our people demand that we adjust all expenditures within the limits of my budget estimates."

To undertake farm tenant legislation, even on an experimental basis suggested by the President before he heard the bad news about tax collections, would cost about \$50,000,000 initially and more thereafter each year.

The Wagner housing bill proposes that the government shall back a \$1,000,000,000 loan fund for home building and in addition put up an annual subsidy to make it possible for poorer people to have nicer homes for less rent. That item was expected to run about \$40,000,000 spread over the next four years.

The President made it quite clear that as far as the budget was concerned he wanted to do the cutting, not congress. He suggested that congress go ahead and appropriate in line with the budget. He conceded this would bring on a deficit of \$418,000,000 for 1938, largely because of lagging revenues. But, he added:

"I propose to use every means at my command to eliminate this deficit during the coming fiscal year."

He proposed to do it by two means: first by not spending as much as he asked congress to appropriate, and second by liquidating assets of certain emergency agencies.

Actually that is asking that the executive do what has been the job of congress in past years. Congress is still in session and should balance its own appropriations to balance the budget. But the President has asked to do it and it is a safe bet congress will agree, if for no other reason than that congress does not like the job of cutting, anyway.

This situation, outlined in the message, sets out sharply a decided drift evident in the past two years toward giving the President the governing hand in how to spend the public money.

Alvin C. York, Speaker Here Monday, Also Behind Move

The Emergency Peace Campaign's sweeping "No-Foreign-War Crusade," in connection with which Sergeant Alvin C. York will speak here Monday night in the Campus Building of the local college, was opened in auspicious fashion on April 6—the 20th anniversary of America's entrance into the World War—with a national broadcast by three of the nation's most distinguished figures: Admiral Richard E. Byrd, honorary chairman of the Crusade; Mrs. Eleanor Roosevelt, enthusiastic backer of the peace movement; and Dr. Harry Emerson Fosdick, eminent New York minister and Campaign Chairman.

"This Crusade," declared Admiral Byrd, "gives us a chance to go into action on one of the many battle fronts against War—I appeal to the people of this country to fight the defeatist attitude. Go into the greatest and most worthwhile struggle of all—that of battling for world peace. The United States is flattered by a combination of happy circumstances to take the leadership in the struggle to bring about the good neighbor attitude among the great family of nations."

Dr. Fosdick in his address said, "Let us bring the democratic process into the peace movement and rejoice in the provocative and educative effect of free discussion among people who have a common aim, namely, to keep the world out of war, and if the world goes mad and chooses war to keep this country out of the conflict!"

Mrs. Roosevelt warned that another World War would be suicide and urged the women of America to bring home to the women of other nations their desire for peace and emphasize the recourse to law rather than force in settling differences between nations.

Sergeant York is expected to bring an emphasis gained from his personal participation in the World War in his speech here Monday night, one of 2000 cities throughout the nation which will be contacted by the Crusade, launched by the April 6 broadcast.

Campaign leaders are optimistic over the outcome of these meetings—which are reaching business men's groups, veterans' associations, churches, women's clubs, parent-teacher associations, labor and farm unions—and foresee the establishment of permanent and solid peace organizations in even more than 2,000 communities to carry on the work of the drive to keep the country out of war, whether European or Asiatic.

Hotel and restaurant employees, mercantile and machinery workers already are protected and other occupations will be brought under the law as the workers apply. But ma hasn't heard anything about the 8-hour day, 6-day week with a \$14.50 weekly minimum for hotel and restaurant employees and \$13.20 for other specified businesses.

These are the standards set up by the state welfare committee in 1921, eight years after the legislature passed the law for the protection of lives, health and morals of women and minors.

The law was little enforced, however, and brought virtually no change in the lives of the 125,000 to 150,000 women, state officials estimate its effects.

Now the women paid less than the minimum could sue employers just like the former Wenatchee hotel chambermaid who brought the test case, and collected a total of \$100,000, Assistant Attorney General W. A. Toner estimates. Toner defended the law before the high court.

The state welfare committee will meet shortly to map out a course for strict enforcement of the law through a field staff and for extending the provisions to unprotected occupations.

Alice Lord, instrumental in getting the law passed originally, and other Seattle central labor council leaders plan to co-operate in enforcement but lean toward organization rather than statute as the best means of improving working conditions.

For example, they compare the union's minimum of \$15.00 weekly plus meals for waitresses and chambermaids with the \$14.50 without meals provided by the state law. The state permits the employer to subtract 95 cents a day if the waitress chooses to eat at the restaurant, leaving her \$8.80 for the week.

Ed Sorger, state safety supervisor, believes the state's scales should be changed now to meet modern conditions.

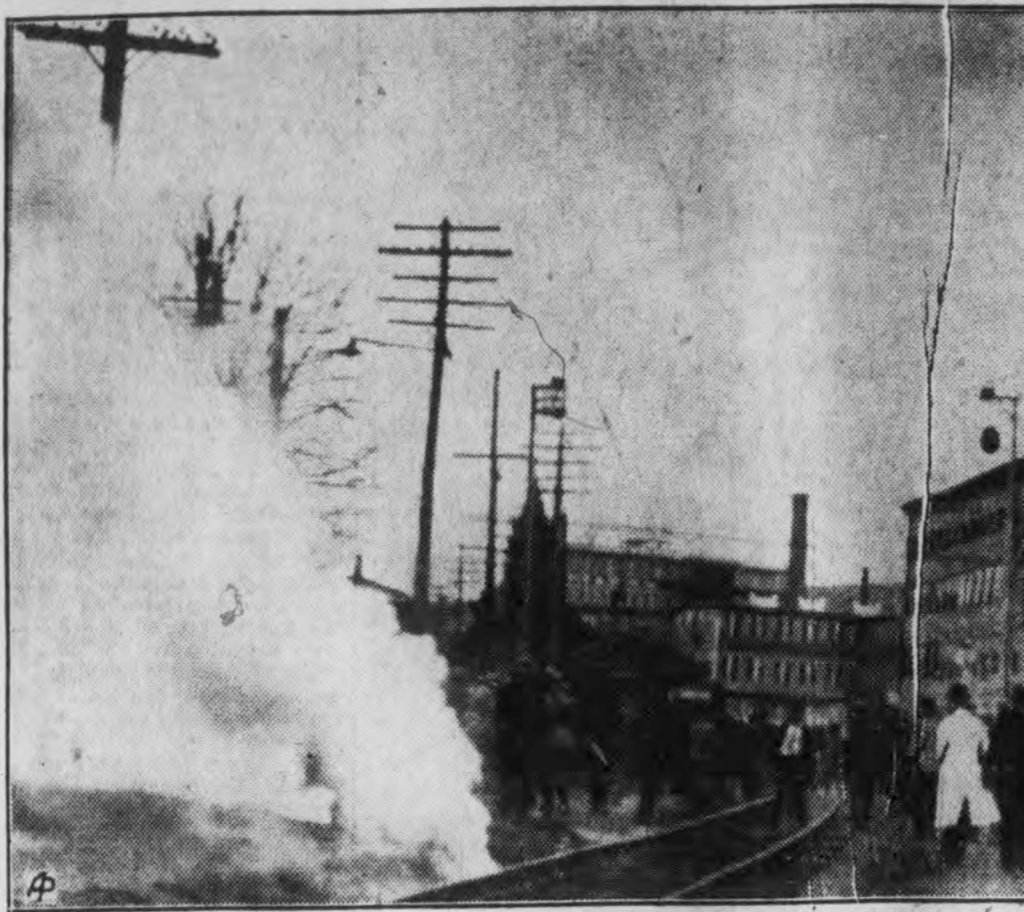
WELL KNOWN MAGICIAN TO APPEAR AT UNC NEXT WEEK

FIELD AGENTS TO TOUR STATE

Unemployment Compensation Maps Plans

Raleigh, April 24.—The ten field representatives of the North Carolina Unemployment Compensation Commission, who have covered the larger cities from Raleigh westward in the past six weeks, are now split into two groups of five each, one going eastward and the other westward, for visits to the second group of cities and towns in their efforts to contact all employers who come under the provisions of the Unemployment Compensation Act.

The field force has already visited Raleigh, Durham, Greensboro, High Point, Winston-Salem, Charlotte, Asheville and Salisbury and Statesville. They have found hundreds of employers who were subject to the act, but who had made no reports. Their trips are for the purpose of assisting any employers who come under the act to make their reports properly. Charles G. Powell, chairman of the commission, announced.

Present plans call for a division of the ten men into two groups, one going eastward, the other westward. In the eastern group, probably, will be John P. Cooper, Raleigh; A. L. Dozier, Jr., Rocky Mount; Malcolm M. Young, Durham; D. D. S. Cameron, Southern Pines, and Minton H. Dixon, Elizabeth City, who is now out because of illness. He expects to join the group soon. On the western trip the men will probably be Sterling O. Manning, Charlotte; James L. Blum, Winston-Salem; Charles A. Taylor, Asheville; L. L. Umstead, Greensboro, and Henry H. Hickman, Gastonia.
