MOVIE CENTER FACES THREAT OF WALKOUTS

Ten Thousand Union Employees Involved In Dispute

STRIKES CALLED BY FOUR UNIONS

Full Effect Not to Be Realized Until Monday as Activities Curtailed Saturdays

Hollywood, May 1.—(AP)—The multi-billion dollar movie industry was confronted today with a possible mass walkout by some 10,000 union employees of studios, including many prominent players.

Four unions were called out on strike last night when representatives of studio executives withheld decisions on union demands for a closed shop, as well as union recognition. The other unions in the newly formed Federated Motion Picture Crafts, strike-sponsor, voted to defer until today any decision on joining the strike.

More than 2,500 members of the Scenic Artists Painters, Draftsmen and Hair Dressers unions were invited in last night's strike call. They were instructed not to go to work today.

President Charles Lessing of the Federated Crafts, declared the unions would not go through picket lines of the striking unions.

He said, however, full effect of the strike may not be evident until Monday. There is little studio activity on Saturdays.

Pat Casey, labor conciliator for the film producers, declared they would wait to see the effects of a strike before deciding on the union demands.

A hundred scantily clad girls in the Paramount studio picture "Artists and Models" worked most of last night after being informed a strike might prevent renewal of the elaborate make-up for other scene shooting today.

Noted Southerner Named For Office By Judge Meekins

Thomas Dixon, Native North Carolinian, Selected as Clerk of Eastern N. C. Federal Court

Raleigh, May 1.—(AP)—Thomas Dixon, 73, author, lawyer, legislator, preacher and lecturer, became Clerk of the Eastern North Carolina Federal Court District by appointment of Judge I. M. Meekins, a Republican, today.

Dixon, a Democrat who campaigned in North Carolina last summer and fall for Alf Landon, the Republican presidential nominee, claims Currituck as his home, though he has spent much time in New York in recent years. The State Republican Committee reported it paid his campaign expenses last year.

"I need the money for a back lot of security as I carry on my program I have followed for 20 years," Dixon said when asked why he decided to take the job.

The post of clerk was relinquished yesterday by Capt. Samuel Ashe, 97, Confederate veteran and himself an author of note. He is a Democrat.

Judge Meekins revealed he had offered Dixon the clerkship on April 3 and it had been accepted April 5. He swore in Dixon this morning.

Dixon immediately reappointed all deputy clerks including: George Green, of New Bern; John B. Respass, of Washing and G. L. Parker of Wilson.

Burlesque Shows Refused Licenses

New York, May 1.—(AP)—License Commissioner Paul Moss brought the city's burlesque situation to a dramatic head today by flatly refusing to renew the licenses of 14 theatres where strip-teasers were practicing their art.

Strip-teasers, and male comics, too, more than a little alarmed by the sales of protest raging around them recently, had turned contrite at the last minute and tried to temper their shows. But the Commissioner took heed of organized complaints and turned down the license application of the theatre owners.

In a statement the Commissioner specified the Oltine Theatre on Forty-second street, but explained what he said about this theatre was applicable to the other 13.

Bethel Observes Big Day As Governor Hoey Speaks

Bethel, May 1.—The big day in the Bethel High School commencement exercises was observed Thursday, when Governor Clyde R. Hoey addressed the seniors and patrons who turned out in large numbers despite the bad weather.

M. O. Blount made the address of welcome to the speaker, declaring that Bethel considered it a great privilege to have the Chief Executive deliver the commencement address.

Following a brief preliminary program, Governor Hoey made his talk after which he presented the graduates with diplomas.

Three cogent phrases of advice, developed from three different ancient civilizations, were commended to the 27 graduating seniors by Governor Hoey.

The Greeks contributed the command, "Know," the Roman civilization, with its law and order reigning supreme, left as its heritage, "Control Thyself," and the Hebrew religion, out of which grew Christianity, makes the demand, "Deny Thyself," the Chief Executive told the group.

"By accepting these advices left to us by older civilizations, you young people of today can serve your community, our State, our nation and your generation so that you can leave behind a heritage such as has been left you by your pioneering forefathers in this country," Governor Hoey told the seniors.

Duke Of Windsor Plans Bridal Trip

St. Wolfgang, Austria, May 1.—(AP)—A report the Duke of Windsor and his bride would honeymoon at Count Paul Muenster's castle near the Yugoslav-Italian-Austrian frontier was current here today.

It was thought they would remain there several months amid the Alpine beauties of a Southern Austrian province. The 40-room castle, a vast pile of gray masonry, stands near Arnoldstein Carinthia.

HITLER FLAYS AT CLERGYMEN

Threatens to Revoke Licenses If Community 'Disturbed'

Berlin, May 1.—(AP)—Adolf Hitler threatened bluntly today "to withdraw the clergyman's license" from any who try to "disturb our community spirit."

He lashed out at opposition Catholic and otherwise, in a speech at the Lustgarten, often the scene of wild cheering Nazi gatherings. But today's reaction was one of moderate applause.

Some 50,000 workers gathered in the huge square. An unbroken wall of 45 foot Swastika banners flanked the square on both sides.

Many women and some men fainted under the hot sun. "If anybody tries through ecclesiastical sermons or other religious measures to disturb our community spirit we will simply withdraw the clergyman's license from such," Hitler cried.

"It will not do for certain circles to criticize our morals when they have the greatest reason to be concerned about morals in their own ranks," he said.

WOUNDS FATAL TO N. Y. JUDGE

Justice O'Neil Succumbs to Stabbing By Mystery Man

New York, May 1.—(AP)—Justice John O'Neil of the Municipal court died today of stab wounds inflicted by an unidentified assailant.

The Justice's condition had been critical almost from the start. Hope was revived yesterday, however, when he showed more strength and declared:

"I'll pull through. I'll make it all right."

Justice O'Neil was stabbed in the back last Tuesday while waiting for a bus en route to his office.

As the assassin ran, the Justice stiffened, said not a word, but walked back to his apartment slowly, informed his wife he had been attacked and was going to a nearby hospital. He collapsed a few seconds later.

Justice O'Neil had served on the bench 11 years and was known as an official without an enemy.

Witnesses of the stabbing said two men wearing tan polo coats approached the Justice as he waited for the bus and one of them appeared to be "patting" him on the back.

BRITISH SHIPS IGNORE THREAT OF INSURGENTS

Already in Bilbao To Evacuate Children From City

REBELS REFUSE RESPECT VESSELS

French Ports on Bay of Biscay Instructed to Receive Refugees From Besieged City

Hendaye, Franco-Spanish Frontier, May 1.—(AP)—The captains of nine British merchant men, ignoring Spanish insurgents' refusal to respect any foreign ships inside their Bay of Bilbao blockade, attempted to evacuate as many children as possible from Bilbao.

The captains of the nine ships, which already have reached Bilbao, said they hoped to be able to remove between 4,000 and 5,000 children to St. Jean de Luz around the bend of the Bay of Biscay.

They announced their plan after a conference with the British Consul at Bilbao, R. C. Stevenson.

In London authoritative sources disclosed British merchant men aided by British warships, would remove Bilbao's civilian population whether or not General Francisco Franco consents. War ships have been ordered to protect refugee ships outside the three mile limit.

All French ports on the Bay of Biscay already have been instructed to receive refugees from Bilbao and told to expect the first of thousands today or tomorrow.

General Franco, virtually defying Great Britain and France to remove noncombatants from Bilbao despite the sinking of the battleship Espana, back-bone of his Bay of Biscay fleet, curtly notified the British ambassador to Spain that men-of-war would not be pledged to respect foreign ships removing Bilbao civilians.

Deadline Set For Participation In Soil Conservation

Two Additional Shipment of Checks For Payments Under the 1936 Program Received Here This Week

Two additional batches of Soil Conservation benefit checks were received by the county agent here this week for distribution to farmers participating in the 1936 federal crop program.

The payments were for \$36,000 and \$20,000 and brought the total received here to far to \$462,561.43. The amount was made out to 5,154 persons, both landowners and tenants having received payments. The money represents 1,883 applications, or contracts, under the program.

R. R. Bennett, county agent, announced that all farmers wishing to participate in the 1937 program must have their applications in by June 1. Agent Bennett also called attention to the fact that all changes in ownership or leases had to be recorded at his office immediately.

The June 1 deadline for signing the work sheets has just been decided and the farm agent urged all farmers who have not as yet executed a contract to do so at once. He said that by filing an application a farmer would be eligible for any benefits he might earn, but added that if no application was signed he would not be able to participate in the benefits.

Pitt has received more than any other county in the state from 1936 benefit payments. It also is due to receive the greatest amount when all payments are in. Mr. Bennett estimated that Pitt farmers would ultimately receive \$600,000 under the program, the largest amount due any one county.

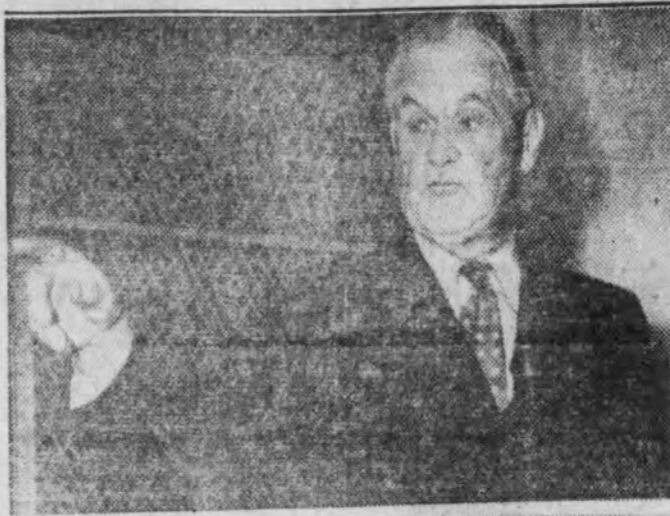

COUNTY BEGINS SEES CLEAN-UP HALF HOLIDAY IN COAL MINES

Employees Get Half Day Rest On Saturdays in Summer

All Pitt county offices began today observing a half holiday on Saturday afternoon, the action having been ordered by the Board of County Commissioners at its recent meeting.

The schedule is to run through August. Although no action was taken on the customary half holiday on Wednesday afternoons during the summer months, it is generally believed the Saturday holiday will take the place of the usual mid-week vacation.

No announcement has been made by the Chamber of Commerce as to when, or if, stores will begin observing a half holiday on Wednesday afternoons, but it is understood the custom will be resumed later in the summer.

Regardless of which day the half holiday is observed, it is understood that practically all business in the city will close a half day.

Member Of Police Force Active Quarter Century

W. L. Brewer, who has been on the Greenville police force for the past 23 years, will celebrate his 58th birthday anniversary Monday. Not one of the four men who were on the force when he came here from Bethel is connected with the city at the present time. Two of the four are dead.

Chief George Clark said that Mr. Brewer would be given Monday off to observe his birthday.

Mr. Brewer came here from Bethel immediately after liquor dispensaries were closed and has been on the force since that time. He was a special officer in Bethel before the state went dry.

When he came here Capt. Tom Smith was chief of police. Others on the force were Ed Briley, who later went to Washington and died while on the police force there, and

Ashley Bland, who is connected with the insurance business now. Mr. Brewer recalled that Greenville was a much smaller city then than now and cited as an example of its growth the fact that the only hard surface street in the city 20 years ago was between the court house and the Atlantic Coast Line depot, that being brick.

As to crime now and then, the veteran police officer declared that there are more petty crimes now than then, but declared there is much less serious fighting and cutting scrapes now. He observed that a greater portion of the crimes today are against property, such as larceny, etc., and not against the person. He blamed automobiles for a good portion of the present day law violations, recalling that there were no automobiles in his early days as peace officer.

NEWLY NAMED N. C. OFFICERS ARE SWORN IN

Fourteen Recently Appointees Take Office Officially

WAYNICK FIRST TO TAKE OATH

Highway Commission Announces That No Changes in Personnel to Be Made Now

Raleigh, May 1.—(AP)—Fourteen newly appointed state officials took their oaths of office today before Governor Hoey and the Chief Executive advised the new Highway and Public Works Commission "to study your jobs before you make any sweeping changes in personnel."

First to be sworn in by Chief Justice W. P. Stacy of the Supreme Court was Capus M. Waynick, retiring highway chairman, who this morning became director of the Division of Purchase and Contract.

Frank Dunlap, retiring Assistant Budget Director, then took office as Highway Chairman, and the ten new Commissioners then were sworn in.

Then Robert Deyton, succeeding Dunlap as Assistant Director of the Budget Bureau, and Buren Jersey, reappointed member of the Industrial Commission were sworn.

After pictures were made the Governor spoke briefly: "I am delighted to have you associated with me in this capacity," said the Governor. "I know changes will come along, but I would advise that you not start in by making changes in personnel. I think those ought to await until you study your jobs and contact the people. x x x"

The Commissioners then held their first executive session and a few minutes later announced there would be no immediate personnel changes.

Thousands March In Observance Of Official May Day

Traditional Celebrations In Streets of European Capitals and Other Cities Over World

(By Associated Press) Thousands marched, cannons roared and bands blared the Internationale over the world today in traditional May Day celebration.

One bomb death occurred in Warsaw, where Polish Socialist and Communist engaged in a celebration. A child was the victim. Several others were hurt.

Huge throngs jammed streets of European capitals in what was termed the biggest May Day parade in New York's history proclaimed proletarian solidarity.

There and in many other American cities additional police were held in reserve.

Cossacks paraded in Moscow Red Square before Communist Chief Joseph Stalin, a half million persons gave the clenched salute in Paris and German workers heard from Adolf Hitler in Berlin the time for higher wages had not come.

At Chicago, labor and political groups called a demonstration by 10,000 marchers. Extra policemen were posted at strategic points.

A walkout of 25,000 bus men signaled May Day in London. The strike for slower bus schedules and shorter working days crippled the city's transportation system in the midst of the coronation season.

Speaks at College As an expert educator, as teacher advancing thought in his subject, science, as editor stimulating young people to write interestingly on science, as a College professor who had trained the sponsor of the Science club, Miss Lorraine Hunter, and as classmate of Dr. Meadows, president of the College, Dr. Hanor A. Webb talked last night to his audience, largely composed of science teachers and student members of the Science club on ways and means of getting girls and boys engaged in activities that would lead them into greater interest in science. The Science club he used as the medium, rather than the classroom, and even said it could be a hobby club as it gives each one a chance to follow his bent. Young naturalists will be collecting insects and everything in nature except birds' eggs, from flowers and leaves of plants to samples of the hair of different animals, as one child did.

Photographs and drawings could model whatever was too big to be brought in as samples, he said. All must be properly mounted and labeled in true scientific form, he emphasized, if the collections have any value. "We have become city dwellers and country lovers," he said.

Examples of "Current Science," the high school paper of which he is editor, he distributed and used as illustrations of how students could use their scientific material in creative writing.

A hundred thousand high school readers are reached through Dr. Webb's publications and he is greatly interested in discovering and training the writers of the future.

Jokes, catchy illustrations and humorous side quips kept the audience highly entertained. The open forum on science problems in the high school and on science clubs held this morning was led by Dr. Webb.

Durward Stowe, a member of the Senior class, who is president of the Science club, presided over the meeting last night. The officers are Miss Fannie Brewer, the vice-president; Miss Hattie Holland, secretary; and Miss Catherine Albritton and Roy Barrow, treasurers. Miss Brewer was hostess at the dinner last night and presided over the open forum this morning.

Prof. Satterfield and Sowell, of State College; Prof. Preston of the University, and a number of teachers of science in the high schools, arrived yesterday afternoon and have been participating in the meetings. Among those science teachers present from a distance were: Dr. Singer, State College; Miss Sarah Gurley, Roanoke Rapids; Miss Frances Newsome, Roanoke Rapids; Miss Margaret Lee, Allamand, R. S. Plan To Complete Five Patrol Radio Stations Shortly

All Houses and Steel Towers Should Be Ready May 15 to Begin Installing Interior Equipment

Reflector Bureau.

Raleigh, May 1.—All of the houses and steel towers for the five high-way patrol radio stations in the state will be completed by May 15 and be ready for the installation of the transmitters and interior equipment, Captain Charles D. Farmer, commander of the patrol, said today. He hopes that all five stations will be ready to start operating by June 1, since the transmitter has already arrived in Asheville for the station there, while those for Salisbury, Raleigh and Williamston have already been shipped, should arrive within the next two weeks.

"The building of the radio houses and towers has been completed at four of the five points, the one at Elizabethtown being the only one not yet completed," Captain Farmer said. "But work has started on the tower at Elizabethtown and it should be completed by the latter part of next week. The houses have been completed except for the installation of the interior mill work and equipment, and all of this will be done within the next two weeks. The installation of all the ground wiring around the radio towers will also be completed within the next week or ten days. So I feel safe in saying that the houses and towers will be completed and everything will be ready for the installation of

the 1,000 watt transmitters by May 15."

It is expected that the General Electric Company, makers of the transmitters, will send some of their own engineers to superintend the installation of these transmitters and to test out the entire radio system, before it is turned over to the state.

The short wave receiving sets for 60 highway patrol cars and 90 motorcycles have also been ordered and will be installed in the cars and on the motorcycles by the time the sending stations are ready for operation. It will then be possible for these stations to keep in constant communication with all the 120 highway patrolmen at all times, since the stations will reach into every county and corner of the state.

State Liquor Commission Adopts New Regulations

Reflector Bureau. Raleigh, May 1.—Uniform price lists for all the state-county liquor stores operating in North Carolina will become effective May 14. It was announced today by Chairman Cutler Moore of the new State Alcoholic Beverages Control Board.

The decision was concurred in by P. Webb Williams of Elizabeth City and Thomas J. Murphy of Greensboro, the two other members of the board. It was also decided that the new 7 per cent state sales tax would be included in these prices and not added to them, despite the fact that many of the county boards in the 18 counties already operating stores wanted to add the 7 per cent state sales tax to the uniform prices that will be fixed by the state board. But the board decided that since the county stores are making a profit of from 50 to 55 per cent on the basis of present prices that they can well afford to absorb the 7 per cent state tax rather than pass it on to the buyers.

The new uniform state price list will be based on the prices now being charged in the stores near the Virginia border and which are virtually identical with the prices

form prices in Virginia." Chairman Moore intimated that later on, if prices should be reduced by the distillers, the state prices would probably be further reduced. He and the other board members also believe that the individual stores from now on, as members of the state system, can get better prices from the distillers and distributors than they have been getting in the past and that this reduction in wholesale costs will partially offset the 7 per cent state tax.

The board spent several hours Friday in conference with Robert G. Dayton, Assistant Director of the Budget, in preliminary discussion of various accounting plans with a view to working out a uniform plan for all the stores that will entail a minimum of time and work but which will still keep an accurate check on all sales and expenditures. The board at first contemplated trying to put this new accounting system into effect May 14, but on the advice of Budgeteer Dayton, it was decided to wait until June 1 to put this into effect. Dayton pointed out that considerable time will be needed to work out a uniform stock list, code numbers for the stock, a daily sales record sheet that will keep a daily record and invoice of all sales and stock on hand and the many other details involved and the board members agreed with him.

Indications are that the board is going to make a careful survey of brands which have sold best in the county liquor stores and from these select some 250 brands, which will be the uniform stock in all the stores from now on. It is understood that at the present time the Pasquotank county stores handle 276 different brands of liquors, the Nash county stores handle some 500 different brands, the New Hanover stores some 290 different brands, and the other county stores between 250 and 300 brands. It is also agreed that a good many of the stores have large stocks that they cannot sell, that some are having "liquor sales" and offering these slow brands at out prices.

New Cocktail Law Expected To Help Hotels And Cafes

Statute Allows Operators of Eating Places to Serve Mixed Drinks if Made With Wine Base. Reflector Bureau. Raleigh, April 30.—The state's new "Cocktail law" undoubtedly passed by the 1937 general assembly in the rushing last days of the session without realizing what the law really was about, is being relied upon by hotel and cafe operators over the state to greatly help their business from now on, regardless of whether they are in "wet" or "dry" counties—especially during the summer months.

For under this "cocktail law" it will be legal for Grade A hotels and restaurants to serve cocktails. If made with a wine base, as well as natural and fortified wines if the alcoholic content is not more than 24 per cent by volume.

So while legal "hard liquor" will not be legally obtainable in at least 70 of the state's 100 counties for some time yet, the thirsty tourist or those who like to sip a cocktail be-
