## STRIKE TENSION SPREADS

### League Council In Compromise

#### SPANISH PLEAS SIDE-TRACKED

#### Behind-the-Scene Row Brews Over Foreign Intervention

Geneva, May 29.—(AP)—The League of Nations council compromised in the face of a behind-the-scenes dispute over foreign intervention in Spain today and adopted a resolution calling on every league member to respect the territorial integrity and political independence of every other nation. It did not, however, give formal recognition to the Spanish government's contention, that territorial aggression had occurred in Spain.

The Spanish government has accused Italy of such aggression and in lesser measure has assailed Germany for allowing its Nationals to fight on the side of the Insurgents. Elsewhere, London reports said, Italy and Germany accused the Spanish government of bombing Italian and German naval vessels participating in the neutral patrol of Mediterranean waters East of Spain and thus complicating international efforts to halt the civil strife. Soviet Russia, meanwhile, gave assent in principal to British proposals for a truce in the Spanish hostilities, but made the reservation that the Insurgent first must withdraw all foreign troops and cease war activity. #### KILLED DURING BANK ROBBERY

#### Heavily Armed Bandit Shot During Daring Hold-Up

Lapel, Ind., May 29.—(AP)—A heavily armed robber identified tentatively as Lester Howard, 24, of Anderson, was killed here today in a daring hold-up of the Standard Elevator company. Another hold-up man who entered the office with the first man fled amid a hail of gun fire, jumped into a car in which a third robber was waiting and escaped, driving toward Anderson. Deputy Sheriff Carl Dennin said the two fugitive gunmen drove into Anderson at a high rate of speed, collided with an automobile there and fled on foot from the wreck. Anderson police hastily set up a dragnet, but were unable to find trace of the men immediately. William Clifford, elevator company manager, said the robber who was killed scooped \$300 from a cash drawer and took pocketbooks from him and four other men who were in the office. The loot was recovered.

#### Ambassador Daniels Holds Citizens Rely On Government

Wilmington, May 29.—(AP)—Joseph Daniels, of Raleigh, United States ambassador to Mexico, said today the "doctrine of 'laissez faire' is on the scrap heap," and people properly look to the government to touch life at every point necessary for the public weal. Speaking at exercises dedicating the new \$250,000 postoffice here, Daniels asserted "there is a duty laid upon public administration to find a way for education, employment, regulation of working conditions, safeguarding public health, providing pensions for the aged and (Continue on page four)

#### Concerned Over Safety of U. S. Representative

Washington, May 29.—(AP)—Acting Secretary of State Sumner Welles announced today that the State Department seriously concerned for the safety of its representatives, was considering the possibility of removing the temporary American embassy from Valencia Spain. The Spanish seaport, temporary seat of the Loyalists government, subjected to a terrific insurgent aerial bombardment yesterday in which more than 200 persons were reportedly killed. Welles said the administration officials were very disquieted over the dangerous situation prevailing in the temporary capital. #### TIGHTENED BY BLOODY RIOTS

#### Six Policemen And 15 Marchers Hurt At Chicago

(By Associated Press) Bloodshed in the Calumet region of Illinois and Indiana increased tension along the entire steel front today. Pickets tightened their ranks, unionists rallied their forces in mass meetings, and the chief active strike leader predicted eventual victory over three independent steel firms—Inland and Republic Steel corporations and the Youngstown Sheet & Tube company. Six policemen and 15 marchers, including a woman, were hurt in a clash at South Chicago last night. A force of 50 officers battled a crowd of 500 demonstrators who tried to march on the Republic plant, only unit operating in the Calumet district.

Philip Murray, chairman of the C. I. O. Steel Workers Organizing Committee, predicted victory for the strikers in a speech at Campbell, Ohio, "they (the companies) can't beat us." More than 72,000 workers were idle in the strike called in an effort to obtain recognition of the S. W. O. C. as collective bargaining agent for its members, or government supervised elections to determine whether it should represent all workers in the independent mills. Latest of the steel plants to close were one in Monroe, Mich., and two in Pittsburgh. The Ford company's announcement (Continued on page four)

# To Consider Justice Department

## GROUP CHOSEN SUBMIT PLANS

### Commission Authorized by 1937 General Assembly

Raleigh, May 29.—"New rules and regulations governing the enforcement, application and administration of the North Carolina Sales Tax, will be divulged and promulgated by A. J. Maxwell, State Commissioner of Revenue, at the thirty-fifth annual convention of the North Carolina Merchants Association which is to be held in New Bern on June 7-8," said W. L. Dowell, executive secretary of the State Merchants Association.

"Mr. Maxwell, who is recognized as the highest fiscal authority in North Carolina, has efficiently served the State for more than a third of a century. He was Principal Clerk of the State Senate from 1901-1910; Clerk North Carolina Corporation Commission 1910-1917; Member Corporation Commission 1917-1929; President National Association Security Commissioners 1927; Vice President National Association Railroad and Utilities Commissioners, 1929; He was appointed State Commissioner of Revenue by Governor Gardner in March 1929, reappointed by Governor Ehringhaus in 1933, and reappointed for the term expiring in 1941, by Governor Hoey. He is President of the National Association of Tax Administrators and in addition to his duties as Revenue Commissioner is Chairman of the State Board of Assessment and a member of the Local Government Commission."

"The recent session of the Legislature enacted a law empowering and directing the Commissioner of Revenue to devise, promulgate, and enforce regulations under which retail merchants shall collect the sales tax from their customers and Commissioner Maxwell has consented to divulge the new regulations, which becomes effective on July 1, 1937, at the State Merchants Convention in New Bern," continued Mr. Dowell.

"The law directing the Commissioner to devise these rules and regulations, gives him exceedingly wide discretionary power and authority. The law specifically authorizes the Commissioner to adopt regulations requiring merchants to use tokens or stamps, or any other method which he might deem practical, in order that the amount of the tax collected by the merchant from the consumer shall be as nearly three per cent of each purchase as possible. It further gives him the power to change, alter, or entirely disregard the present 'bracket system' which requires the collection of a penny tax on sales ranging from ten cents to thirty-five cents and also permits the Commissioner to stipulate that no tax may be collected by the merchant unless the sale reaches a much higher figure," said Mr. Dowell.

"In connection with raising the bracket to fifteen or twenty cents before merchants would be permitted to collect any tax from their customers, it should be borne in mind that merchants are required to pay the sales tax on their total gross volume of business and under such a requirement a tremendous hardship would be imposed upon those merchants who have a large number of sales falling under those figures, for as stated, merchants must pay the State three per cent upon their total gross sale regardless of the figure at which the regulations permit them to begin to collect the tax from consumers."

"Whether the new regulations will change the present 'bracket system' or adopt the token or stamp system, the law stipulates that when such regulations are promulgated by the Commissioner they shall have the full force and effect of law, and that 'any merchant who violates such rules and regulations shall be guilty of a misdemeanor and, upon conviction, shall be fined not less than \$5 nor more than \$500, or be imprisoned for not more than six months or both, fin-

### Estimates on Cost of Social Security Released

Raleigh, May 29.—(AP)—The statistical division of the State Board of Charities and Public Welfare released estimates today that the 100 counties must contribute \$1,301,154 to the old age assistance and aid to dependent children social security programs during the fiscal year starting July 1.

A total of \$901,154, including a \$100,000 equalization fund made available by the state, will be allotted aid for indigent aged and \$500,000 for aid to children.

The figures, the division said, indicated the total cost of the first years social security program exclusive of aid to the blind, would be about \$5,104,616, as the state

and federal governments, also made contributions.  
 Pitt county will be required to contribute \$15,518 for the aged and \$8,520 for children.

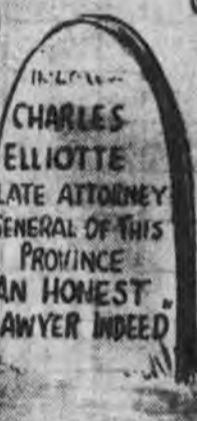

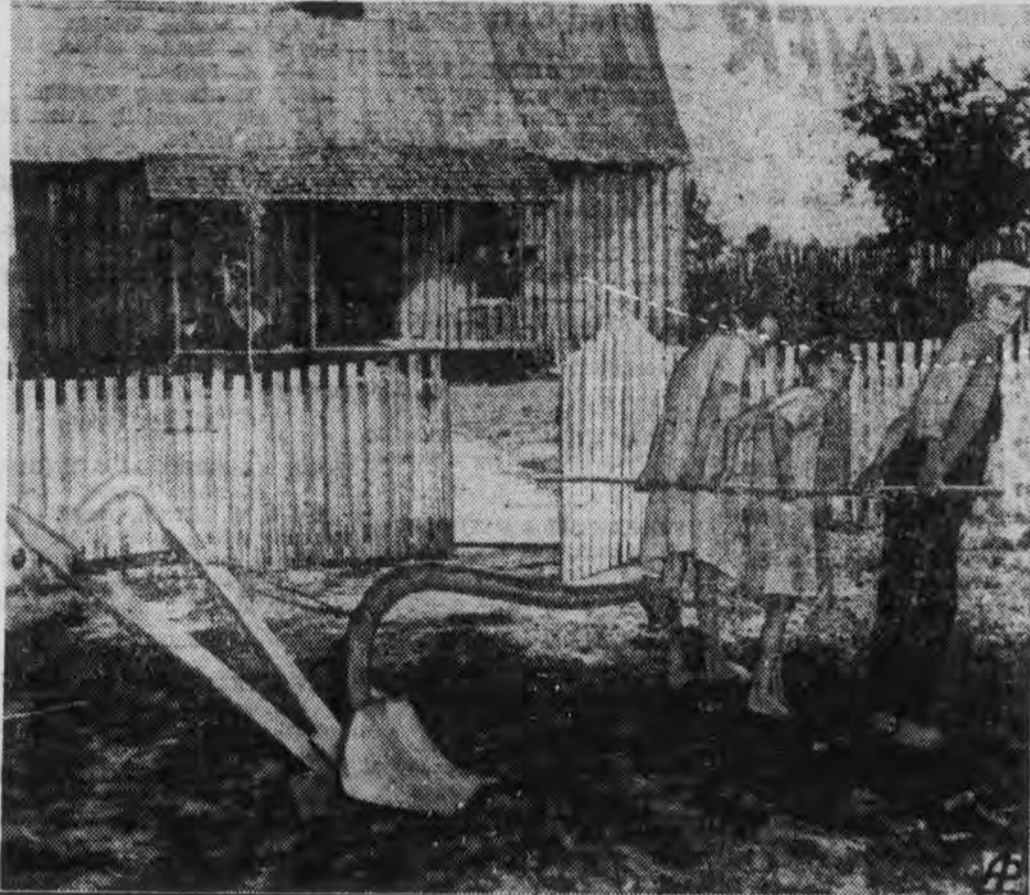

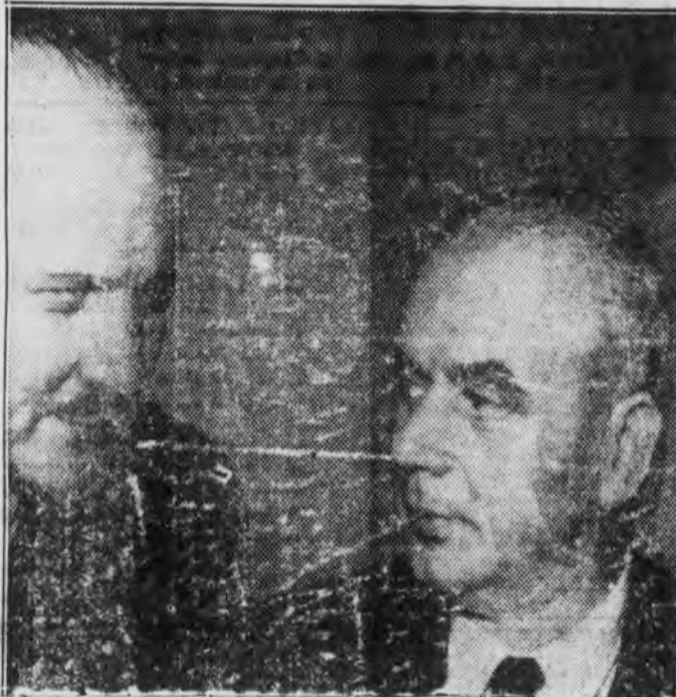

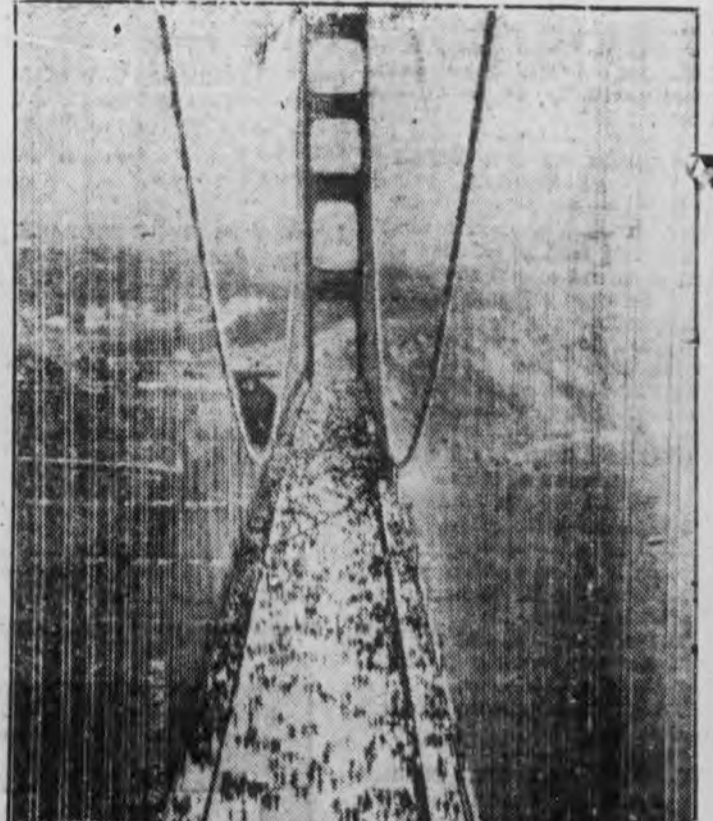

### Former Wake Forest Athlete Staging Real Comeback

Alfred Stanley Joyner, who is out-fielding for the Ayden Aces and who might be more easily recognized under the cognomen of 'Monk' is staging his comeback on home soil. The native Tar Heel, born and raised in Woodland, once had a bright outlook as a professional player, but in the middle of the 1935 season he injured a hand while playing with Wilkes-Barre of the New York - Penn League, a Class A outfit.

'Monk', at one time, looked like such a good prospect that he was signed by the New York Giants and released to Minneapolis and Nashville for seasoning.

Now it appears that Monk is to be lost to the Coastal Plain league, for at the rate he is going he is sure to be snatched from class D ball.

Monk, who learned to play baseball in his front yard under the tutelage of his father, who at one time was a star athlete at Oak Ridge, has literally "set the Coastal Plain league on fire."

He is leading the league in hitting, having made 29 hits in 43 times at bat to mark up the high average of .426.

As if this were not enough for one day, along comes the announcement that he has taken over the duties of manager of the Ayden team, replacing Nick Harrison, former International league hurler.

Monk was not the only baseball star in his family. His brothers, Key and Powell, the latter known in sports circles as "Pete," also had their day in the sport, but gave it up to enter different professions. "Pete" is a successful physician at Enfield, while Key is practicing law in his home town, Woodland.

An alumnus of Wake Forest, Monk was an all-state player for several years and his college career netted him a grand batting average that was over the .350 mark.

In 1932 when the Deacons won the state title, Joyner's great batting is still recalled by close followers of the collegiate doings. He hit two home runs to defeat North Carolina State by a 2-1 count in a game that had the title at stake.

Playing independent ball for Edenton in 1933, he led the A'be marble loop in batting and home runs and was taken aboard by Baltimore late in the season, finishing at Johnstown in the Middle Atlantic loop.

It was in 1934 the Giants got hold of his services and farmed him around the country. At Wilkes-Barre in 1935, he was batting .303 in fast company when his hand injury relegated him to the shelf.

## How's Your Health?

### Pyorrhea Promoters

By DR. IAGO GLADSTON  
Pyorrhea may involve one tooth, several adjacent teeth or one or both jaws.

The condition may develop acutely following an infectious disease which debilitates the individual. When the condition is local, it may be the result of an inflammatory periodontitis, due to ill-fitting bridge or crown, or to other forms of local injury.

Pyorrhea is associated with scurvy and has been lately charged, in many instances, to dietetic deficiencies, notably the lack of vitamins A, C and D.

Disease conditions closely resembling pyorrhea have been produced in experimental animals by keeping them on deficiency diets. An authority on rare diseases says:

"It is well known that the gums of children suffering from nutritional deficiency show a tendency to spontaneous gum bleeding and other signs of pathologic change. In chronic periodontal disease (pyorrhea alveolaris) a history of bleeding gums have occurred during childhood is commonly obtained. Such facts may legitimately be

regarded as evidence that early dietetic deficiencies act as a predisposing cause of inflammatory infections of the gums and alveolar process."

Infections arising at or near the marginal ring of the gums surrounding the teeth are also considered important contributing causes to the development of pyorrhea alveolaris. Such infections are favored by bad oral hygiene. A German authority has called the first stages "schmutz-pyorrhea" (dirty pyorrhea.)

Neglect of oral hygiene is followed by the depositing of tartar on

the neck of the teeth. This tartar acts as a local irritant and initiates those processes which, if unremedied, lead to a full-blown case of pyorrhea.

The listed contributing causes of this condition also suggested the ways of its prevention. Foremost is the periodic visit to a dentist for a general and complete inspection of gums and teeth, and for such cleansing and scraping as the teeth may require. Such dental attention is particularly indicated following every debilitating disease and during pregnancy as well as after delivery.

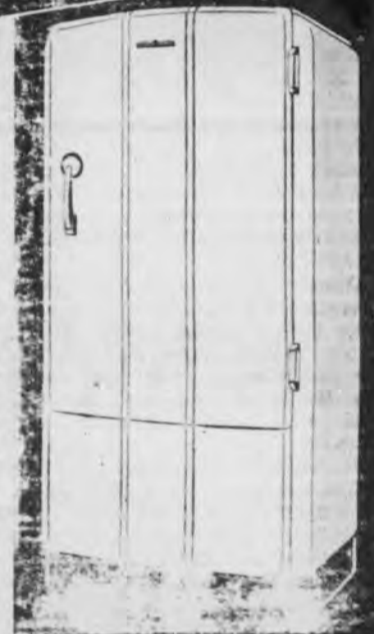

# Survey Shows 800 Pitt Dependents

## ELIGIBLE FOR SECURITY AID

### Of Total, 424 Over 65 Years Old and 377 Needy Children

Estimates compiled by the North Carolina Board of Charities and Public Welfare indicate that approximately 801 residents of Pitt county will be eligible for aid under two provisions of the state's Social Security program, which becomes effective on July 1.

One June 1, the various county commissioners and county Boards of Welfare are expected to make public their estimates of the additional tax levies required to provide for Old Age Assistance and Aid to Dependent children.

A tentative survey shows that in Pitt County 424 persons beyond the age of 65 years, and 377 dependent children under 16 are entitled to receive benefits enumerated in the legislation adopted by the 1937 General Assembly.

Persons desiring assistance must apply to the local County Board of Welfare, where they will be granted interviews and allowed to file written applications if their cases are considered worthy.

Applicants for all phases of assistance must show that they do not have sufficient income or other resources to provide a reasonable subsistence "compatible with decency and health."

Those applying for Old Age Assistance must show that they are more than 65 years of age; that they are not financially able to care for themselves properly; that they are citizens of the United States; that they have lived in North Carolina for five of the last nine years; that they are not inmates of any public institution, and that they have not made a transfer or assignment of property "for the purpose of making themselves eligible for assistance."

Applicants for Aid to Dependent Children may be either the mother, father, grandmother, grandfather, or certain other relatives who have children in their keeping, but whose income is insufficient to care for them properly. Children receiving benefits must be less than 16 years of age, and must have been born or lived in North Carolina for at least one year prior to the filing of the application.

Financial assistance to the aged will not exceed \$30 a month. Children may receive as high as \$18 a month for the first child in a family, with a maximum of \$12 for each additional child, up to \$65 a month, for any one family.

### Official Requests Citizens Destroy Breeding Places

Chief of Police George Clark, who also heads the city street department, today called on the citizens of Greenville to aid in reducing the mosquito plague which apparently has descended on the city since the weather turned warm.

"If the people, themselves, would take action," he said, "conditions could be greatly improved." He said that he gets complaints after complaint and upon investigating finds that breeding places are right in the back yards of those registering the complaints.

Mr. Clark said he would go to a person's house upon receiving a complaint and find perfect breeding places for the warm weather pests. He declared that fish ponds, gutters, tin cans and many other similar places were found on premises.

"We can not make a house to house canvass of the city," declared Mr. Clark, "therefore we are calling on the citizens to make a check-up of their own premises and remove all breeding places."

He declared that mosquitoes from the river seldom found their way up into the city, adding the mosquitos which bother the people of the city are bred right in their own back yards.

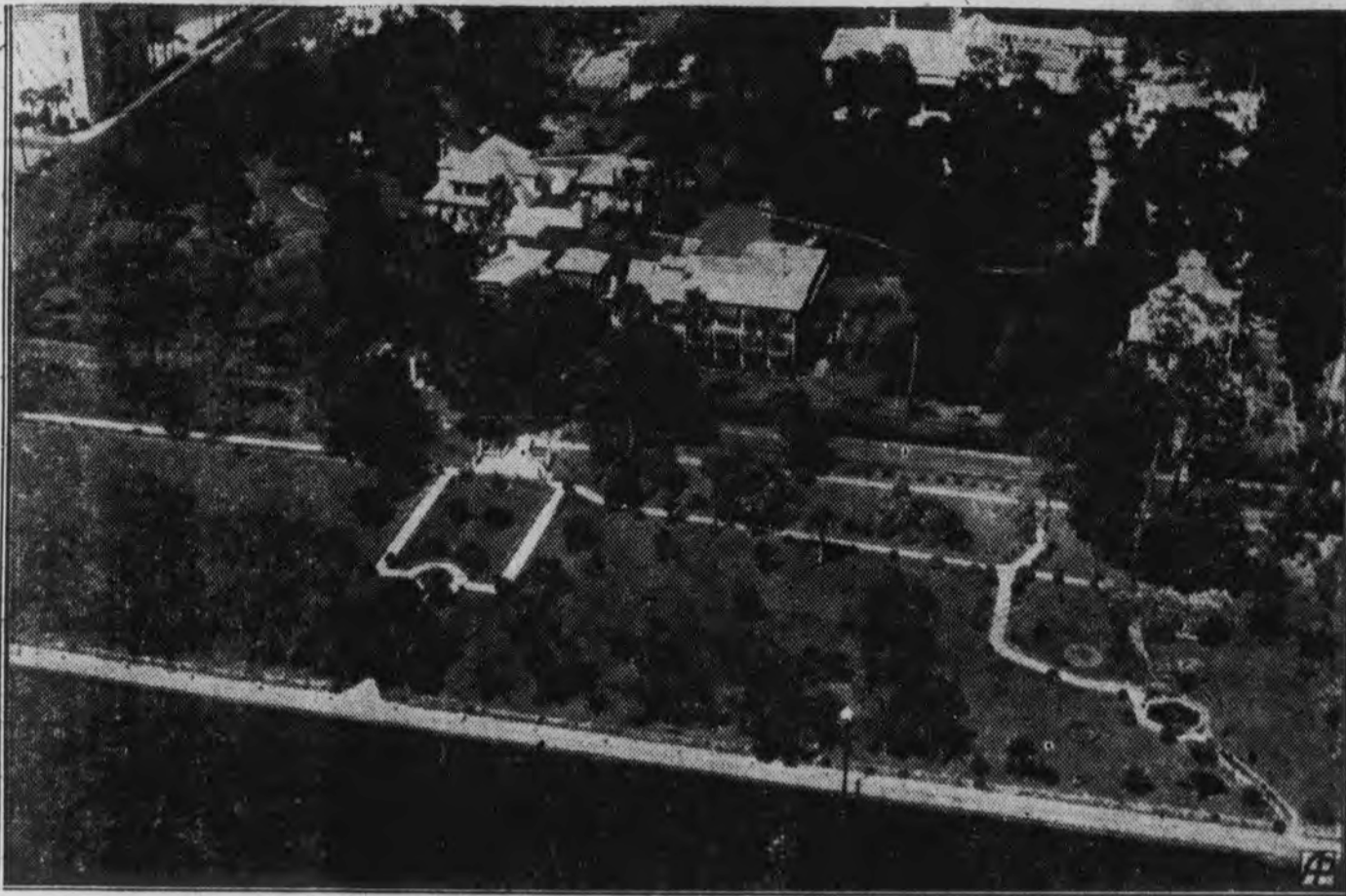

# Rockefeller Dies: 'WORLD'S RICHEST MAN' FAILS TO ACCOMPLISH AMBITION—TO REACH 100



It was in this winter home, The Casements, at Ormond Beach, Fla., that John D. Rockefeller, Sr., financier and philanthropist, died in his 98th year. In the foreground of this new airview are the formal gardens sloping down to the Halifax river. Rockefeller's body was taken from this home and sent by special train to the Rockefeller estate at Pocantico Hills, Tarrytown, N. Y., for private funeral services. Burial was in Cleveland, Ohio, where he began his business career as a \$4.50 a week bookkeeper's assistant in 1855.
