TOWNSEND AIDES RESIGN

Legislative Deadlocks Weaken

COURT REFORM KEY SITUATION

Few Members Expect Adjournment Before Late in August

Washington, June 5.—(AP)—Deadlocks on several major legislative issues are beginning to break, leaders said today, following hints of compromise on the Roosevelt court bill.

"That bill is the key to the situation," said Senator Harrison (D-Miss.), surveying the problems facing Congress at the start of its sixth month.

Although the outcome of the court battle was regarded as uncertain by many legislators, they noted disagreements over the proposed tax inquiry, farm tenancy aid and relief funds gradually were being settled.

Some issues, such as government reorganization and regional planning, remained highly controversial. Consequently few members expected adjournment before late August.

Meanwhile, Chairman Connery (D. Mass.) of the House Labor Committee expressed the belief a tax on all machine power would be a necessary sequel to the administration's wage and hour bill.

He envisioned a tax on horse power as a measure of meeting the replacement of man power by machines, a problem, which he said the nation ultimately must face.

The wage and hour bill, he said, would bring about a temporary period of prosperity, but, he declared, the pressure on industry to find means of efficient operation would result in many new labor saving devices.

Nootsch, Austria, June 5.—(AP)—The Duchess of Windsor put on a simple figured house dress and toured the "haunted" rooms of Wasserleonsburg castle today with a happily critical eye.

As she poked about this storied place that is her honeymoon house a host of spectral knick-knacks, dust gatherers all, went promptly out. She confined them to an exile in the attic on just one look.

The Duke and Duchess, late in arrival last night, were late in getting to bed. Then Wallis, in her figured house dress, received the house staff and talked about meals and her tour of inspection.

STRIKE STATUS HELD IN DOUBT

Non-Committal Statements Issued Following Parley

(By Associated Press)

Non committal statements from Ohio's Governor and Philip Murray, chairman of the Steel Workers Organizing Committee, on their conference at Columbus left in doubt today the status of peace negotiations in the seven-state steel strike.

Governor Martin Davey repeated he was "hopeful" and Murray said the conference was "satisfactory," but long picket lines were maintained at the steel mills.

The Governor indicated he would follow up the peace parley by another conference with officials of the Republic Steel Corporation and Youngstown Sheet and Tube company. Both companies and Inland Steel are involved in the strike.

A force of deputies, armed with rifles and tear gas, was mobilized at the sheet and tube plant at Youngstown after a box car of food was run into the strike-closed property. Pickets apparently were taken by surprise. Later a group of men cut rails leading to the plant with acetylene torches.

In Northern Minnesota the S. W. O. C. started its drive to unionize iron miners who dig most of the ore for the nation's steel mills. Rep. John Bernard of Minnesota predicted a strong miners' union would be established.

OUTLINE TASK FOR CONGRESS

Leaders Agree With Executive on Seven-Point Program

Washington, June 5.—(AP)—House Democratic leaders agreed with President Roosevelt today on a seven point preferential legislative program for action this session, headed by the judicial proposals.

Other measures which Rep. Rayburn of Texas, majority floor leader, said would be pushed for final disposition were:

Extension nuisance taxes and prohibition of tax dodging, farm tenancy aid, low cost housing, wages and hours legislation and conservation planning and power authorities.

With Rayburn at the White House conference were Speaker Banzhoff and Rep. Vinson (D. Ky.) a member of the ways and means committee.

Rayburn said the dirt bill was discussed in a general fashion.

The Texan warded off questions on whether a court compromise was mentioned.

Rayburn predicted the House could pass Thursday the bill to extend about \$500,000,000 of so-called nuisance levies.

REBELS DRIVE TOWARD GOALS

Bitter Fighting Reported Just Outside Bilbao and Madrid

Hendaye, Franco-Spanish Frontier, June 5.—(AP)—Five American-made planes were reported by an insurgent communique today to have been shot down in a "dog fight" with insurgent airmen on the Biscayan front.

The headquarters' statement gave no further information.

(By Associated Press)

Insurgent artillery pounded Bilbao's "el Gallo," the besieged capital's last ditch line of concrete trenches, today.

Sections of the Insurgent general's line of 800 artillery pieces opened the bombardment while unconfirmed French border reports said a "time bomb" caused the plane crash Thursday that killed Insurgent General Mola and four of his officers.

The rumors, although without any substantiation, were persistent.

Fighting on a new front at the side door to Madrid flared into a major battle.

Government machine gun crews were said to have beaten back an insurgent counter offensive of combined infantry artillery and air forces about 33 miles northwest of the capital.

Insurgent war planes trying to hold General Jose Miaja's forces from a place about six miles north.

Amelia Earhart Delays Take-Off

Fortaleza, Brazil June 5.—(AP)—Amelia Earhart postponed her take-off here today to have her round-the-world monoplane inspected.

She probably will remain over at least until tomorrow at this Northeast Brazil fort, 287 miles from Natal.

OPPOSE FIGHT ON ROOSEVELT

Quit Because of Public Utterances Attacking Executive

Chicago, June 5.—(AP)—Twelve officials of the Townsend national organization resigned today because of "repeated public utterances x x x attacking the President and his administration" which they attributed to Dr. Francis Townsend, leader of the old age pension movement.

The officials criticized Dr. Townsend's attacks on "legislation not associated with the aims of the organization" in a formal statement.

The mass resignations, J. W. Brington, vice president and general manager of one of the 12 officials, said, were addressed to Dr. Townsend and effective today. He said the resignations had been accepted "verbally."

A statement released by Brington said:

"We feel that our services are of no value to those who contribute to our salaries in view of your repeated public utterances in the press and on the platform attacking the President and his administration, whose support and good will we must have if we are to secure enactment of the general welfare act during the next four years.

"As you already know, we are not in accord with your activity in using money contributed to you in the Townsend organization to carry on a fight against legislation proposed by the President which has no bearing on the Townsend plan x x x x."

HIGH SHERIFF IS ACQUITTED

Freed On Impeachment Growing Out of Lynching

Montgomery, Ala., June 5.—(AP)—Sheriff J. L. Corbitt of Henry county was acquitted today by the Alabama supreme court of impeachment charges growing out of the lynching of a Negro February 1.

This action followed the Supreme court's taking under advisement his case after Attorney General A. A. Carmichael warned "if we don't enforce the constitutional clause on lynching, Congress will pass an anti-lynching bill. There has never had been no indication when such a court would announce a verdict. Corbitt was charged with negligence, in grave fault, connivance and cowardice" in connection with the lynching of Wesley Johnson, Negro charged with attacking a white woman.

Carmichael did not touch further on the question of Congressional anti-lynching action.

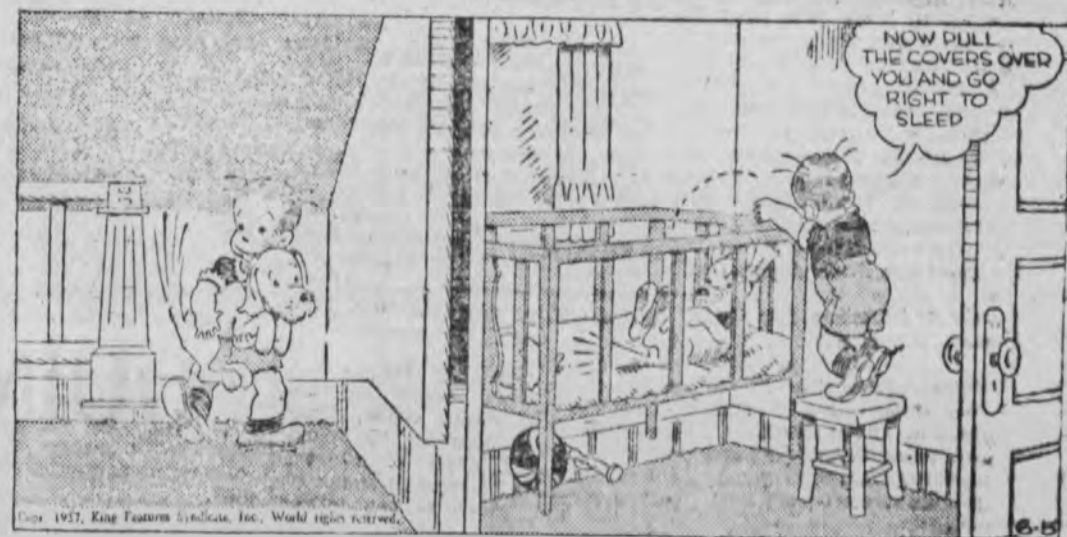

Spread small rounds of white bread with cream cheese mixed with butter. Then top the rounds with a thin layer of pineapple marmalade or crushed pineapple. The latter should be well drained.

# ALUMNAE HEAR COLLEGE HEAD

## President Speaks On 'Yesterday, Today and Tomorrow'

The steadily increasing efficiency of the public schools of North Carolina and the part played in their development by East Carolina Teachers College was brought out by President Leon R. Meadows this morning in his address at the annual meeting of the Alumnae Association of the College. President Meadows' topic was stated as "Yesterday, Today, and Tomorrow; or, Fifty Years of Education in North Carolina."

To an interested audience Dr. Meadows described, first, the "Yesterday," or the educational situation in North Carolina twenty-five years ago, when the College Alumnae Association was organized.

In the main, he said, the state had then the one-teached school which lasted from four to six months during the year and was taught by a teacher with less training than is now given a four-year high-school graduate, one who was paid, accordingly, from \$100 to \$240 a year.

There was a large percentage of illiterate adults, and many communities were inaccessible because of poor roads.

"Yesterday," said the speaker, "is history."

"Today" was described as a time of improvement of the past. The schools now are consolidated, but still not well equipped. They run eight or nine months under much better trained teachers, teachers with an average of more than three years of college work, teachers who are paid from \$800 to \$900 a year.

"Last, Dr. Meadows presented a picture which he called "Tomorrow" or "Prophecy."

Twenty-five years from now, he predicts, not only will school buildings be larger and better equipped, but the session will run on a twelve months a year basis, with intervals for vacation similar to the present Christmas holidays.

"There will be no illiterates in our 'Tomorrow,' among our normal citizens," said President Meadows, "and the course of study will meet both the practical and the cultural needs of our people."

Over this span of fifty years there has been, and is to be, a great growth and development in the public schools of the state, and in his growth East Carolina Teachers College has played a part her graduates may well be proud of.

After the welcome to the new Alumnae Miss Irene Williamson president of the two-year class responded most graciously for the fifty members of the class who are the "D's" to graduate in

June. Miss Ruth Cagle, president of the A. B. class responded for the 109 members of her class who will have degrees conferred upon them on Monday.

Mrs. Luella Lancaster Stancill of Winterville was elected president of the Alumnae association. Chosen for vice president was Miss Wita Bond of Rocky Mount and for secretary treasurer Mrs. Augusta Woodward Marcom of Raleigh.

Two members of the first graduating class of the college were on hand for the activities today. They were Mrs. Nell Pender Moore and Miss Estelle Green.

The outgoing officers are: President, Mrs. Christine Vick Joyner; Vice-president, Mrs. Ivy Modlin Cook; Secretary-Treasurer, Miss Emily Smithwick; Executive Committee, Miss Elizabeth Smith, Miss Wita Bond, and Mrs. Mabel Thomas Turner.

The Alumnae luncheon was held in the College dining halls at 1:00 o'clock, music was furnished by East Carolina Teachers College Orchestra directed by Dean Tabor.

"Daisy chain" exercises will be at seven p. m. on the front campus.

The program of the music recital last night which was one of the loveliest ever given at the College was all modern music except for selections by two of the musicians. It contained numbers of beautiful symbolism such as "The Swan," by Palmgren, played by Miss Edith Dixon; and "Lo Cathedral Engloutie" by Debussy, played by Miss Elizabeth Tolson.

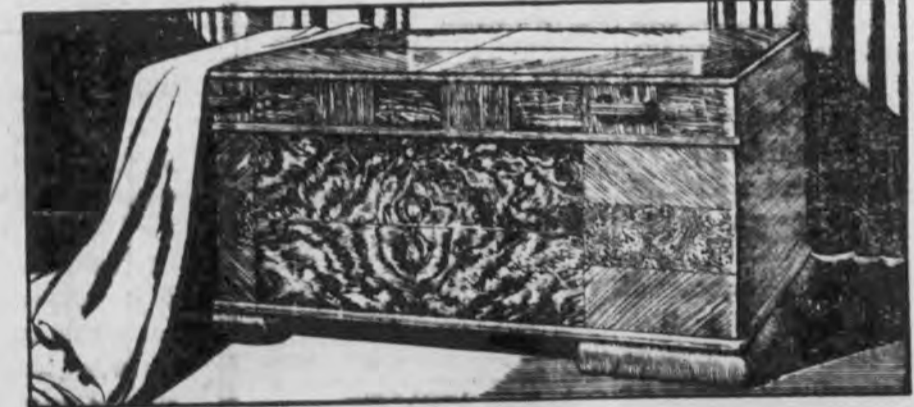

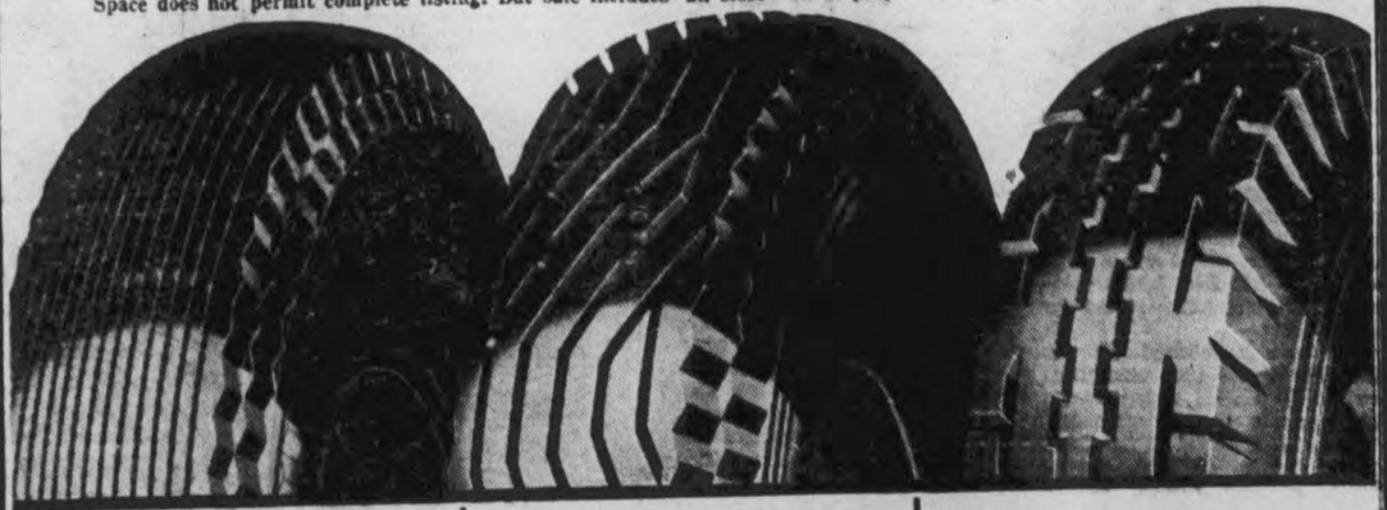

In all probability, Michael was searching the house for me by that time. Nevertheless, the odds were against my getting another chance to think things out alone. Time was pressing. The dial of my watch registered 2:45. I imagined that the boat from shore would be at the Bluff by eight o'clock at the very latest. That left us a little over five hours. I forgot old Higgins locked in his room waiting for the police. I forgot everything. Feverishly I pored over those scribbled sheets.

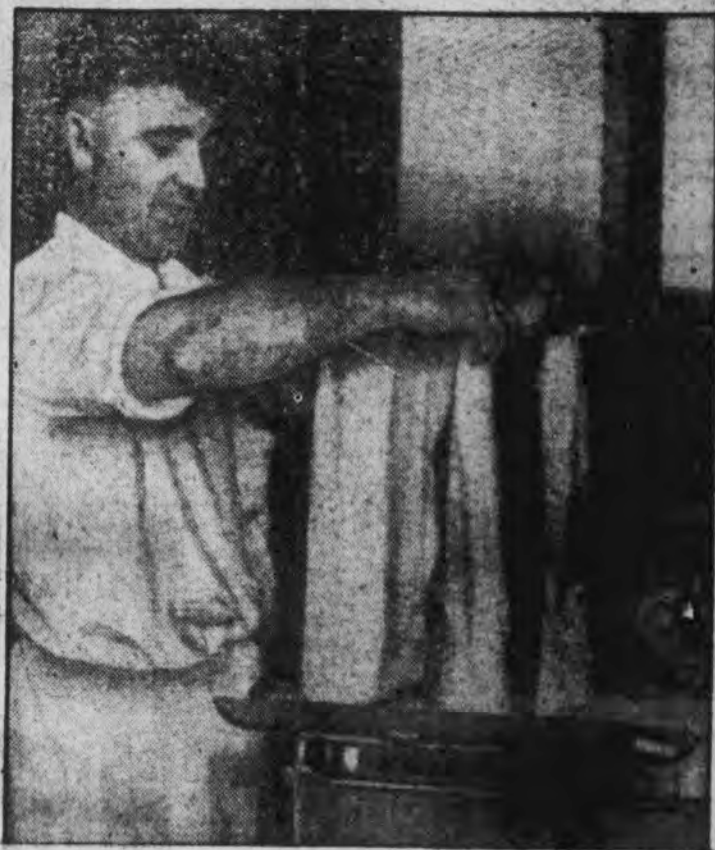

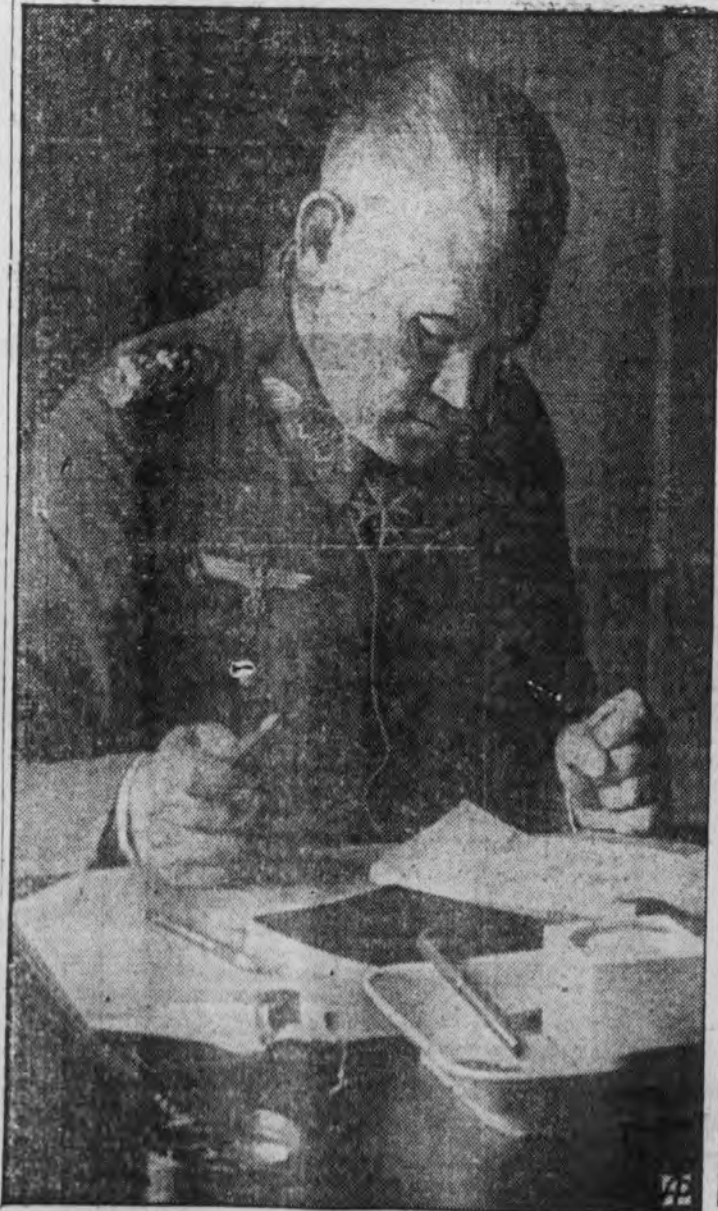
