LEADERS MOVE END CONGRESS AT EARLY DATE

First Step Taken In Winding Up Business of Session

WAGE AND HOUR BILL PENDING

Conference Held To Discuss 'Must' Legislation But No Decisions Reached

Washington, July 26.—(AP)—Congressional leaders arranged today for immediate senate consideration of the wage and hour bill as the first step in winding up the session.

A bill by Senator McCarran (D-Nev.) to limit the length of freight trains was at the top of the senate calendar.

Majority Leader Barkley (D-Ky) said, however, if it was not disposed of by late afternoon he would have it laid aside for the labor standards measure.

The rest of the legislative schedule which the administration wants congress to enact before going home was not disclosed.

Congressional leaders conferred this morning on the legislative situation. Later Speaker Bankhead said no decision had been reached on what items would be pushed.

Meantime Chairman McCarran (D-Nev.) forecast a senate judiciary sub-committee drafting a bill to alter lower court procedure would finish its work by tonight.

He said the sub-committee had agreed to leave out of the bill, which replaces the shelved administration court bill, any effort to regulate receiverships.

Birth Of Aviation To Be Celebrated On Roanoke Island

Aviation Day to Be Observed at Old Fort Raleigh. Few Miles From Scene of First Flight

Manteo, July 26.—The "banks" dwellers are observing two birth-days on Wednesday, July 26 when "Aviation Day" is celebrated at Old Fort Raleigh. All this summer the Virginia Dare anniversary is being celebrated on Roanoke Island in what the committee insists is a "birth of a nation" fête.

On Wednesday the birth of aviation will be noted, because only a few miles from where the Fort Raleigh adventurers vanished into the wilderness the Wright brothers saw their little craft soar crazily into the constant breeze.

"Aviation Day" will be characterized by a moderate tone, for Manteo has not learned the intricacies of bullhous. But it will emphasize how surprisingly recent is the age of the airplane.

Dr. LaDue will show you, if you want to see them, those amazing dispatches he sent for some feverish reporters three decades ago. He said he has the original file.

Chinese Situation Most Acute Since First Skirmishes

Country Again Teeters on Brink of War Following One of the Bloodiest Battles in Sino-Japanese Dispute

(By The Associated Press)

North China teetered again today on the break of war. Japanese military planes blasted barracks of the 38th Chinese army division and Lieut-General Katsuki, commander of the Japanese army in North China, issued a new ultimatum.

The situation apparently was more acute than at any time since the first flare-up, July 7, when Japanese and Chinese troops clashed at the Marco Polo bridge west of Peiping.

General Katsuki warned the Japanese army has drawn up all available strength for a "drastic" punitive campaign if "recalcitrant" Chinese 37th division troops are not removed, fulfilling the ultimatum from the embattled Peiping area by noon Wednesday.

General Sung Cheh Yuan, North Chinese commander and chairman of the Hoeph-Chahar political council, was reported without confirmation, to have ordered his men "retreat."

Chinese troops fled from their barracks midway on the Peiping-Tientsin railroad under the aerial attack and were strafed by the Japanese planes.

Hundreds of Chinese soldiers and civilians were said to have been killed in a 10-hour battle at the spot and the town Langfang heavily damaged. The Domei (Japanese) news agency said Chinese forces were "in full rout" northwest from the town.

The battle, one of the bloodiest of the intermittent fighting in the dispute between Japan and China over economic domination of the North China province of Hoeph and Chahar shattered a week's truce between local Chinese and Japanese military authorities.

MANY INJURED IN ACCIDENTS

Two week-end wrecks in this immediate community caused serious, but not critical, injuries to a number of persons, and also resulted in the filing of charges against several for violation of traffic regulations.

Two cars collided about three and one half miles from Greenville on the Washington highway about 8:15 o'clock last night. One car was driven by E. B. House, who was traveling toward Washington. The other was operated by Mrs. Archie Roebuck, who was slightly injured.

Mrs. Nora Taylor was riding in the car with Mrs. Roebuck, but she was not injured. House, also escaped injury.

Corporal L. L. Jackson, who investigated the wreck, said it appeared to be as much one driver's fault as the other's and no one was arrested.

Three automobiles and mule and cart were involved in a wreck Saturday night two miles East of Flemington's crossroads on the Belvoir road.

A mule and cart driven by John Duncan, Negro, was struck by a small coupe operated by Lonnie Thigpen, Negro. The driver of the mule and cart suffered a possible fractured spine. Thigpen's left arm was lacerated and his hip possibly fractured.

Emma Whitaker, riding in the coach suffered a simple fracture to her left leg and her right leg was badly lacerated. Leader Hardy, Negro, another occupant of the car, was lacerated and bruised.

Corporal Jackson said Duncan would be charged with driving a horse-drawn vehicle without a light and accused Thigpen of reckless driving.

Before the wreck could be cleared from the highway, James Anthony, 52-year-old Negro, drove his automobile into the wreck. He was charged by the officer with driving while drunk and also with reckless driving.

Robert Cannon, 18-year-old white boy, drove his car into the wrecked vehicles and suffered bruises and a broken tooth. He was charged with driving reckless and with improper lights.

Marvin Linger had his back bruised and Chetuis Holland suffered shock and bruises. They were riding with Cannon.

In all seven persons were taken to the hospital.

Meanwhile elsewhere in the state two Nash county youths were killed last night when their car crashed head-on into a bridge abutment near Zebulon. The bodies of the boys, Vernon Rhodes and Wesley Finch, were sitting upright in the automobile when investigating officers arrived at the scene.

Roosevelt Making Plans To Come To This State

Expecting to Attend Roanoke Island Celebration August 18

Washington, July 26.—(AP)—The White House announced today President Roosevelt, if possible, will attend an historical celebration at Roanoke Island, North Carolina, August 18.

The occasion marks the 350th anniversary of the birth of Virginia Dare, the first white child born in America.

White House aides said the President would participate in the celebration if the congressional situation is such as to permit his absence from Washington then.

Tentative plans had been made for the chief executive to go to Elizabeth City by train from Washington and thence to Roanoke Island by a coast guard cutter. On his return he will motor to Norfolk, Va., and board the presidential yacht Potomac at the navy yard there to return to Washington.

White Men Jailed After Altercation

Two local white men, B. B. Tate and J. A. Prohock, spent last night in jail following an altercation in which the former was injured to the extent a physician had to be summoned at a local hotel last night.

Chief G. A. Clark said Prohock told him that Tate went to his room, uninvited, while he was out, drank a quantity of whiskey that was on the dresser and took charge of the room.

Prohock is alleged to have beaten Tate severely and to have thrown him down the steps. Both men were taken to city police headquarters and a physician was called to treat injuries suffered by Tate. Chief Clark said the injured man might lose the sight in one of his eyes as a result of blows on the head, but said he did not believe he was critically injured. A physician examined him this morning and the possibility of removing him to the hospital was being considered.

Department Added At Chicod School

Pursuant to a decision made at the last meeting of the Board of Education, it is now planned to establish a Home Economics department in the Chicod High school to be ready for the term of 1937-38.

Since the board has decided to renovate Hollywood school with winterville, Chicod, and Grimesland and the Hollywood building will not be needed any longer for school purposes, the board is planning to dismantle this building and move it to Chicod where it will be made into a Home Economics department and a club house for the women of the Chicod district.

Board members said they felt that by doing this Chicod school will be enabled to offer a well regulated social and educational program to the young girls and women of the Chicod neighborhood.

The next meeting of the County Board of Education will be held Monday, August 2.

Plan Demonstration At State Tobacco Test Farm

Raleigh, July 26.—Hundreds of growers from all over the state will gather at the N. C. Department of Agriculture's tobacco test farm at Oxford Thursday to view 25 years of tobacco research progress at the station's fifteenth annual field day.

A. A. P. Seawell, attorney general of North Carolina, will be the principal speaker.

Other speakers will include: Commissioner of Agriculture, W. Kerr Scott, who will deliver the address of welcome; Colonel J. W. Harrelson, dean of administration, State College; Assistant to the Commissioner, D. S. Coltrane, who will speak on "New N. C. Seed Law," and Dr. J. S. Dorton, manager of

the North Carolina State fair, and Miss Ruth Curren, state home demonstration agent.

John W. Goodman, assistant director of the North Carolina extension service, chairman for the occasion, will be introduced by Fred E. Miller, director of the State Department of Agriculture's test farms.

Dan M. Paul, Granville county farm agent, will be chairman of the agricultural contests. In the afternoon a singing contest, open to rural churches and granges, will be conducted under the direction of Frank E. Parrott.

MANY HURT IN NEW VIOLENCE AT CLEVELAND

Rioting Flares Anew at Republic Steel Plant

ARREST ELEVEN AFTER BATTLE

Strikers March On City Hall to Register Protest Against Police Action

Cleveland, July 26.—(AP)—Steel strike violence broke out anew today. At least 20 persons were hurt in rioting at Republic Steel Corporation's Corrigan-McKinney plant in Cleveland. Eleven were arrested.

Clashes occurred when police broke through CIO picket lines.

Tom Glowacki, 51, picket, suffered critical injuries when he was run down by a car containing four men trying to enter the plant. Two policemen were hurt.

Some 1,500 strikers and sympathizers, witnesses said, massed around one of the approaches to the plant's main entrance. About 100 officers, many on horses and motorcycles, tried to clear a path.

At first only boos and cat-calls came from the crowd, but as more cars carrying non-strikers passed through the line rocks flew from the strikers, police said.

In melee which followed, Mounted Patrolman Rowley Ozer was hit in the back of the head. He remounted and charged the crowd of 300 on the sidewalks, witnesses said, bringing his night stick down on the head of a striker, Malibio Mianzo, 35, who collapsed under the blow.

After the violence, first time since Republic reopened its Cleveland plant July 8, the strikers marched on city hall in a protest against police action. Their ranks swelled and the milling crowd was estimated at 5,000 persons.

Eure Cracks Down On Security Firms Outside Of State

Secretary of State Charged With Administration of North Carolina's Capital Issues Law

Reflector Bureau Raleigh, July 26.—Secretary of State Thad Eure, since he has taken over the administration of the state's "blue sky" or capital issues law, is "cracking down" on out-of-state security firms which try to get special issues approved for sale in the state, unless they first are sponsored by one of the 30 or more registered and licensed security dealers in North Carolina, he revealed today.

"This policy first protects the people in North Carolina, from being offered unsound securities. It next protects the licensed security dealers in the state by giving them an opportunity to study and investigate these issues before approving them," Secretary Eure said. "Finally it protects the firms issuing the securities and helps them maximize them since they are certain of being able to advertise them as meeting all the requirements of the North Carolina law, once they have been approved."

Secretary Eure exhibited a letter from a firm in Boston, containing checks in payment of all the license fees needed, amounting to several hundred dollars, wanting to get approval for the sale of some \$100,000 worth of securities in North Carolina. But Secretary Eure is returning the letter and checks and informing the firm that he will not give his approval to the sale of the securities until they have first been approved by one of the licensed security dealers here in the state. So that the thing for the firm to do is to get the approval of some such dealer to begin with.

Last week Secretary Eure declined to approve the security offerings of eight other out-of-state firms unless and until they complied with the requirements of his office and of the law. He is convinced this procedure will result in the offering of only the highest grade of securities in the state and in greater protection to investors.

Woman Takes Life At Home in Maury

Mrs. Lizzie Hines Tunstall, 62, died at her home in Murry yesterday morning by what was said to have been self-inflicted knife wounds.

Mrs. Tunstall was declared to have stuck a knife in her throat and to have died almost instantly. Dependancy over ill health was given as the cause.

She was a member of a prominent family, being the daughter of the late J. S. and Elsie Hines, formerly of Ayden. Her husband, W. A. Tunstall, died about two years ago. She is survived by one brother, P. R. Hines of Greenville; three sisters, Miss Lena Hines, Mr. Emma Allgood and Mrs. W. M. Carter, all of Ayden, and several nieces and nephews.

Funeral services were conducted at the home of a sister, Miss Hines in Ayden at 4 o'clock this afternoon. Interment was in the Ayden cemetery.

China Plans \$4,000,000 Bridge

Hankow, China.—(AP)—Bridge construction work, which in China has lagged far behind the building of new highways and railroads, is being pushed. A steel span across the Yangtze river at Hankow is planned.

The bridge will connect the Canton-Hankow and the Peiping-Hankow railways and will cost more than \$4,000,000.

Minerals Everywhere
They fly in here from hundreds of miles around. Apparently the

whole country is highly mineralized.

The section is not spotted yet—doors are left open safely, and platinum is tossed around like so much coal. Nothing is ever taken—or hasn't been so far.

The first mail since early April arrived near the end of June, so reading matter never is thrown away, but is passed from hand to hand until entirely worn out.

I arrived here with exactly 50 cents in my pocket. I've traveled afoot and by plane. I've done a little typing, a little cooking, some writing. I lived in the new road-house (Hotel) to you folks "outside", then moved to a house-scow (used for lightering cargo from ships to this wharfless waterfront), and am now enthroned in the attic of the trading post where I sleep on all kinds of smelly wolverine, squirrel, fox and bear skins.

My chair is a gas box and my desk a rooled oats carton.

We've had no newspapers of recent date and our radio connections are just radio telephone between camps so we're highly ignorant of what is going on in the world, save by word of mouth

from airplane pilots and new arrivals.

Planes Carry Freight
Weather conditions change suddenly here and pilots are forced to work fast when they can.

Pilot M. M. Saaseen, a veteran flyer, formerly of Los Angeles, has freighted tons of equipment to nearby prospect camps. At one, he lands on an mountain top 50 feet wide and 300 feet long, with an incline at each end.

It's a great country, but a wet one—in 1934, the first year of major prospecting, there were three days it didn't rain!

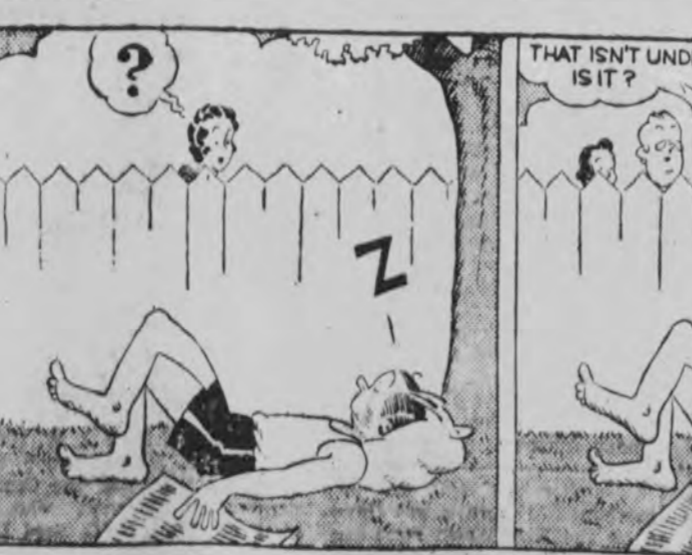

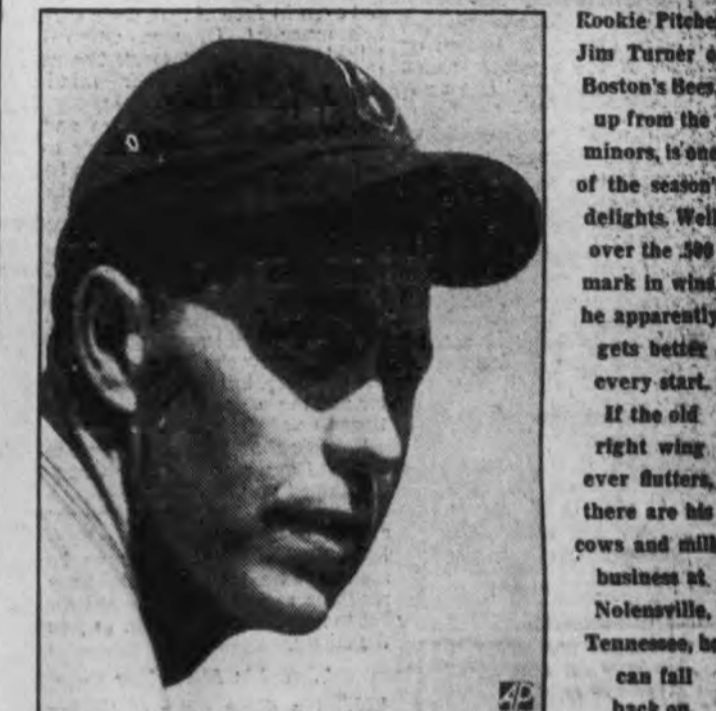

Washington Daybook

Washington On the day Senator Robinson's soldier in the New Deal was buried in Little Rock, Ark., there died in Oak Bluffs, Mass., one of the most militant foes of the New Deal, Dr. H. Parker Willis. This professor of banking at Columbia university took one deep sniff of the New Deal early in its existence and thought it bad. From then on he scarcely missed an opportunity of slashing at it with pen and tongue.

Treasury Foe The "brain trust" was anathema to him. He said: "It is amazing how simple our industrial and trade mechanisms are to the advocates of 'planned economy.' Hearing them expound their over-simplified doctrines of arbitrary increases in wages and prices and of the benefits supposed to flow therefrom, one would suppose it possible to raise the price in the one branch of industry without at the same time raising the costs in another."

Willis was in his early 40's when he and Senator Glass drafted the Federal Reserve act. He became secretary of the Reserve board and later director of research, and continued as consulting economist until the time of his death.

Early in the board's existence he detected and denounced the increased sway of the treasury department over Federal Reserve policies. Senator Glass similarly came to be a critic of this tendency and sought to end it with the banking act of 1935 by removing the secretary of the treasury from ex-officio membership on the Reserve board. He accomplished the removal but certainly the treasury's increasing domination of the national credit and monetary systems was not abated.

Panic Harbinger Willis' reputation as a financial adviser brought him to Washington as a consultant, occasionally, even after the advent of the New Deal. He had a hand in drafting the banking act of 1933. Frequently he was called abroad and his analytical writings about the American financial scene were in demand in Europe as much as here. He was author of something near a five-foot shelf of books on banking and finance.

If ever there was a financial writer who had a "panic in his breast" about the Roosevelt administration, it was Willis. To him dictatorship, or something akin to it, lurked in well nigh every move.

HOEY EUTHUSIASTIC OVER VISIT TO ROANOKE ISLAND

where the play is presented, is one of the most striking I have ever seen," Governor Hoey said. "The audience sits on seats built on the shore as it slopes down to the waters of Roanoke Sound, while the stage itself is built out over the sound. The moon was shining the night I was there and saw the play, making the setting appear even more natural and more impressive. The effectiveness of the play is increased as a result of the weaving in of a beautiful musical theme and the introduction of impressive musical numbers sung by the chorus from the noted Westminster Choir school and the big electric organ. It is worth driving hundreds of miles just to see this play and hear the music that goes along with it."

Governor Hoey was impressed by many things during his visit to Roanoke Island and Old Fort Raleigh, but he said that the three things which impressed him most were:

1. The complete absence of mosquitoes.
2. The very adequate facilities for taking care of visitors, both with regard to housing and feeding them.
3. The manner in which the producers of "The Lost Colony" had worked out the amplification problem so that every word and every line spoken on the stage of the water-side theater can be heard by every person in any part of the outdoor amphitheater which seats about 3,500 people.

"I was amazed by the fact that there were no mosquitoes on Roanoke Island or if there were any, I did not see them," Governor Hoey said. "I understand that there was some trouble with mosquitoes at first, but they seem to have solved it completely."

"I was also surprised by the arrangements which have been made to take care of the thousands of people who are now visiting the island almost daily. For in addition to the excellent facilities offered by the hotels in Manteo, virtually every resident of the island has thrown open his home to visitors, so that when space is exhausted in the hotels and tourist homes in Manteo accommodations may be found in scores of other homes all over the island. The result is that while the people of Manteo and Roanoke Island are already entertaining thousands of visitors each week, at no time so far have they come anywhere near exhausting their housing facilities. So no one should stay away from Roanoke Island or give up seeing the 'Lost Colony' for fear that they cannot find a place to stay at night or that they cannot find adequate eating facilities."

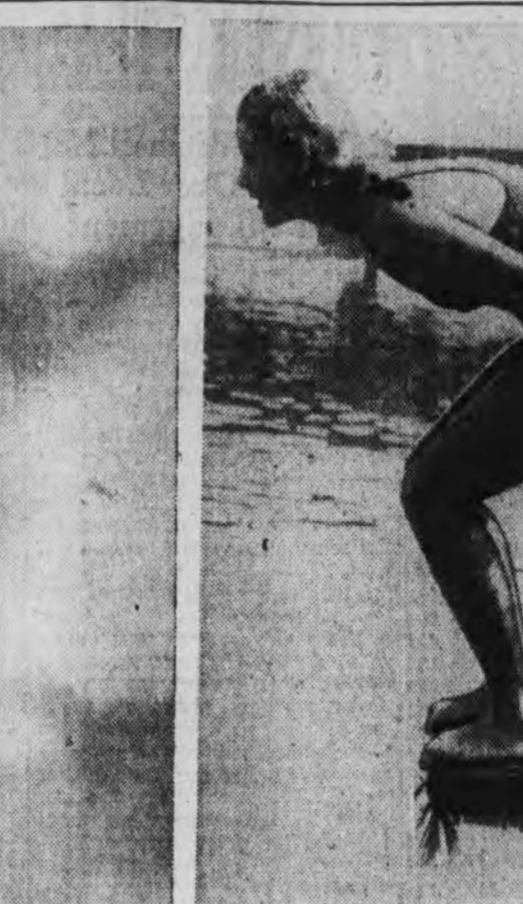

SAN FRANCISCO (AP)—If California girls fail to win any swimming championships this year they can't alibi themselves on the grounds of homesickness.

Heretofore the state's mermaids have not upheld the prestige that California enjoys in tennis, track and other sports that presumably blossom in a year-round outdoor climate.

"The girls get homesick in those eastern meets," explains Lincoln V. Johnson, president of the Pacific

association of the A. A. U. "The big-time competition gives them stage fright. I don't believe they do their best."

This year, for the first time, the A. A. U. senior women's championships will be held in California—in San Francisco's Fleischacker pool on the ocean front. A thousand feet long and touted as the largest pool in the world, it will be cut off at the standard 50-meter distance for the national outdoor meet.

To win laurels California looks largely to Dorothy Sundry of San Francisco.

Seventeen-year-old Marion Falconer, who swims the 440 in 6 minutes, is another California hope, as are Peggy Neal, a sprinter, and Patsy Robinson, a diver and medley swimmer. In Los Angeles Ruth Jump and Marjorie Gestring have been attracting attention in platform dives.

Gallery attention will center on Catherine Rawls, the Florida star, who took the senior diving and medley swim championships at last year's competition at Oriental Beach, Brooklyn. Toni Redfern, of New York, who won the 100-meter free-style, and the Kompas sisters—

Elizabeth and Erna—will be among the 1936 stars who will compete. A keen contest is expected when Miss Rawls tries to take the 220-yard breast-stroke from Iris Cummings of Los Angeles. Last year, the westerner beat her out.

Eleanor Holm Jarrett, Dorothy Poynton Hill and Lenore Knight Wingard will be absent this year, by reason of having turned professional.

The meet will be held September 3-6, just in time for the American swimmers now in Japan to compete. The men of the traveling troupe will put on some exhibitions.

Search For Cleveland's Torso Killer Leads To Another Headless Body

CLEVELAND (AP)—Somewhere in Cleveland today—perhaps in the drab areas on the city's fringe, or in the frowsy flats of its underworld or even on train and respected streets of its residential districts—there waits the torso killer of Kingsbury Run.

Ten times in 34 months the knife of the killer has claimed a victim. Ten times a headless body has confronted detectives with a new but unvarying mystery.

The killer's methods have varied little since September, 1934, when the first body was found. All were nude and decapitated. In most cases arms were severed at the shoulder blades, legs at the hips. In some cases arms and legs were cut into segments.

Experts at Loggerheads
Because the bodies of five victims were found in or near a dirty little stream known as Kingsbury Run the killer was given its name. The last three bodies—almost as an answer—have been found far from its narrow banks on the southeastern rim of the city.

What kind of man could behead six men and four women and not be found? Where could he live and inflict his cruelties? Who could pick eight persons out of a city of nearly a million whose disappearance would excite no inquiries?

These are questions detectives have attempted to answer by arresting hundreds of suspects. Psychiatrists, psychologists and criminologists have studied the handiwork of the mad killer without agreeing on his motives or compulsions.

'Friendship' Seen As Lure
Only two of the ten victims ever have been identified. The fourth victim was placed through fingerprints as Mrs. Florence Pojillo, 41. She had been arrested once in a vice raid.

One male victim, Edward Andrassy, 28, was identified by relatives. Police records on the lives and habits of Andrassy and Mrs. Pojillo amount almost to biographies, but there is nothing to show why they were singled out for such violent deaths.

Dr. Samuel R. Gerber, coroner, who has made a minute study of the work of the maddened killer, believes "friendship" is the lure which brings the hapless victims into his hands. The absence of marks of violence on the bodies, other than the knife cuts, indicate, he says, that the victims were attacked when "asleep, unsuspecting or drugged."

He Knows Anatomy
Dr. Gerber pictures the killer as a cool, shrewd soid who has acquired knowledge of anatomy either as a doctor, hunter, game warden or butcher. He is well acquainted with the city and able to gain the confidence of his victims. Disposition of the bodies, some quite heavy, would require a muscular person.

Dr. Gerber is convinced that one person is responsible for all of the killings.

"If more than one were involved," he says, "they would begin to fall out at all on each other."

One thing the coroner can't understand is "the apathetic attitude of the public concerning the killings."

"The victims usually are not known," he said, "and apparently their deaths fail to stir up any resentment."

Detectives Scout Area
One of the most gruesome discoveries in the Kingsbury Run area was that made by two boys hiking down a gulch. Coming upon a bundle, the poked it with a stick—and a man's head rolled out.

Detectives have almost lived in the section since the bodies were found there; they have brought in hundreds of suspects for questioning; they have examined hundreds of pieces of blood-stained clothing and cleaning establishments and followed tips day and night.

One suspect lived in a cave. Another had the reputation of eating chickens and rabbits without cooking them. Police were never able to explain the presence of chicken feathers on Mrs. Pojillo's body.

Dozens of persons living in the stacks which dot the district were taken into custody and questioned. Numerous persons found with meat cleavers or long knives in their possession were brought in and questioned for hours, only to be released. Detectives spent weeks searching for an escaped patient from an asylum for the insane on

the information that he had returned to his home in the Kingsbury Run district and had been observed peering into windows in the neighborhood.

'Right Where We Started'
The inevitable Oriental—who was seen frequently near Kingsbury Run carrying a market basket and snipping off weeds with a long knife—was questioned. He said he made medicine from the weeds.

One man questioned had talked a great deal about transplanting the human brain from one body to another. Dozens of others questioned had babbled about the killings while intoxicated.

Two detectives followed a trail of blood for two days only to discover that it had been made by an injured dog. Every possible bit of information was investigated and Police Chief George J. Matowitz encouraged citizens to call in with more.

A man who habitually read books in a cemetery was questioned and allowed to go on with his reading.

Each new discovery of a torso has brought a new flood of gossip, new stories to investigate but each has left detectives—as James Hogan, chief of the homicide squad put it—"right where we were the day the first body was found."
