Insurgents Open Bombardment On Madrid Defenses

BATTLE RAGES OUTSIDE CITY

Rebel Troops Press Hard Against Spanish Capital on Four Fronts, Leaving Big Losses Among Government Defenders

Hendaye, Franco-Spanish Frontier, Aug. 2.—(AP)—Insurgent artillery opened a bombardment of Madrid's outer defenses today after driving a spearhead in Spanish government lines west of the capital.

Battles were fought on three other fronts.

General Francisco Franco's troops pressed hard against government defenses today after driving a spearhead in Spanish government lines west of the capital.

Government forces had about 1,000 casualties in the Asturian attack, the insurgent report said. At Cuero troops numbering 6,000 rushed against insurgent lines only to be caught in a cross fire of rifle and machine gun bullets.

Two hundred bodies were left dangling in barbed wire entanglements when the attackers retired, the report said.

On the Teruel front, where insurgents have tried to cut communications between Madrid and Valencia, government capital, Franco's forces conquered new positions in the Carbonera mountains. Since the offensive started insurgents have advanced approximately 56 miles.

Insurgents reported that a drive into the government's Madrid lines west of the capital that met only slight resistance.

Government sources said Italian troops with General Franco's army apparently had been withdrawn from the Santander front on the Biscayan coast.

Bitter fighting also raged on the southern front, but the government declared insurgent attacks had been repulsed.

KEEL REPORTS MARKETS GOOD

Local Warehousemen Optimistic Over Tobacco Season

R. V. Keel, Greenville tobacco warehouseman who attended auctions on Georgia and Florida markets Thursday and Friday, reported upon his return here today that prices were considered good and farmers apparently were satisfied with the way their product was selling.

Mr. Keel said the Georgia opening would indicate that prices in this belt would be good when the market opens August 26.

He said common grades were up a little, while good tobacco was a little off. He declared that the opening prices Thursday morning were "right fair" and added that prices increased two or three dollars per hundred in the afternoon and fell back about four dollars Friday morning. He figured that the market had struck its normal level and prices would average around \$23 or \$24 per hundred.

He observed that the crop was "mighty good" in that belt, but added that the crop was not as large as last year's.

The local tobaccoists visited the Lave Oak, Fla., Valdosta, Waycross, Habra and a number of other Georgia markets. He said the tobacco was about the same in all places and estimated that most of it was selling at prices between \$20 and \$25, but added some was being sold for as low as one dollar a hundred.

Other local tobaccoists who attended the Georgia opening were practically of the same opinion as Mr. Keel.

Hopes To Improve Secondary Roads

Raleigh, Aug. 2.—(AP)—Vance Baise, chief highway engineer, said today the special \$2,000,000 allotment for betterment of secondary roads made by Governor Hoey would be used "to strengthen as many as possible of the weak spots on principal farm-to-market roads and school bus routes."

Baise said the money would fix up a small percentage of the weak spots.

By divisions the money has been allocated to division engineers for expenditure under their direction as follows:

First, \$184,280; second, \$185,560; third, \$185,440; fourth, \$202,340.

Delay Crack Down On N.C. Labor Law

Raleigh, Aug. 2.—(AP)—Labor Commissioner A. L. Fletcher said today he had instructed his inspectors to try to "educate" employers in the state before "cracking down" on them to enforce the new maximum hours and child labor laws.

With 10 instead of seven inspectors, Fletcher said he expected to complete check of employers in the state every six months, instead of once about every nine to 12 months.

Fletcher said C. L. Beddingfield with headquarters at Fayetteville and J. R. Bulla with offices at Greenville, would check factories in the east.

J. E. Winslow Named On Farm Debt Group

FREE TO NAME COURT JUSTICE

Roosevelt May Fill Vacancy At Any Time He Chooses

Washington, Aug. 2.—(AP)—The White House announced today Attorney General Cummings had held that President Roosevelt could fill the current supreme court vacancy whenever congress was in session, in recess or adjourned.

The resident had requested the informal opinion by the attorney general.

Stephen Early, White House press secretary, said Mr. Roosevelt had not decided when he would appoint a successor to Justice Willis Van Devanter, who retired June 2.

Early said Cummings' opinion was based "both on precedent and on law."

The text of the opinion was not made public.

The opinion was asked, "Early said, 'to clear doubts away which have been expressed in various quarters regarding the time when an appointment to the court should be made to comply with the law.'"

The fact that the vacancy occurred while the senate was in session was the basis for the uncertainty expressed in some official quarters as to when it should be filled.

WANTS JUSTICE APPOINTED WHILE SENATE IN SESSION

Washington, Aug. 2.—(AP)—Sen. Vardenberg (R-Mich.) offered a resolution today asserting it was the "sense of the senate" that Supreme court appointments should be made only when the senate could act before nominees began service.

He acted after it became apparent that President Roosevelt might not appoint a successor to Justice Van Devanter, retired, until congress had adjourned.

Thus the senate would have no chance to pass upon the appointment until next January.

The appointee could sit on the bench from the beginning of the fall session until that time. He could continue in his position if the senate confirmed, but would not be able to do so if it refused confirmation.

Vandenberg asked that the resolution "lie on the table to await consideration" without going to committee.

Chairman Ashurst (D-Ariz.) of the judiciary committee and Democratic Leader Barkley of Kentucky, both insisted the resolution should go to the committee. Vandenberg, however, kept the resolution on the vice-president's desk.

SPEAKER SAYS CONGRESS NOW NEARING CLOSE

Bankhead Feels Program Can Be Completed Soon

WAGE-HOUR BILL DUE NEXT WEEK

Senate Judiciary Group Recommends Recess Study Or Court Change

Washington, Aug. 2.—(AP)—Speaker Bankhead said today he felt congress was "on the home-stretch."

"We now know what the program is," he told news-men, "and I think we have a chance to dispose of all the major matters wanted by the administration before adjournment with the exception of a general farm bill."

House leaders, he said, hoped to dispose of a sugar bill this week and take up wage and hour and housing legislation next week. His statement was taken as an indication that he believed the house would pass the wage and hour bill.

A bitter fight already is developing over it, however, Rep. Rankin (D-Miss.) predicted in a statement that "this measure is doomed." He

Dissatisfaction Spreads With Roosevelt Activity

Reflector Bureau By J. C. BASKERVILLE

Raleigh, Aug. 2.—More and more dissatisfaction is being expressed here both in official and law circles with the manner in which some of the "New Deal" divisions are functioning in Washington and the manner in which they are retarding instead of assisting in economic improvement and development here in North Carolina. The state government generally, as well as the people as a whole have been becoming increasingly disgusted with the Federal Rural Electrification Administration and the manner in which it has sought to impede rural electrification in the state by power companies and city-owned utilities.

This dissatisfaction is now spreading to the Federal Power Commission, which last week refused to grant a permit to the Carolina Aluminum Company for the construction of a \$6,000,000 dam across the Yadkin river near Tuckertown, with the result that the company was forced to cancel its contract for the construction of the dam, which had already been let, and for some \$1,000,000 worth of machinery and equipment. This

project, which the company had planned to start immediately, would have given employment to several hundred thousand men for at least two years and would then have provided increased employment in the aluminum plants at Badin, which were to be enlarged to use the additional power produced at the new dam.

The construction of this new dam across the Yadkin river would have done more to hasten recovery and end unemployment in the counties in this area than anything that has been proposed in several years, and the merchants and business men were already feeling the results of better conditions as the engineers and workmen were already starting to come in to go to work.

A resident of Stanly county who was here today, pointed out "Several of these engineers had already traded for new cars, had rented houses and were preparing to set up construction camps. Now that the Federal Power Commission has held up action on the dam project indefinitely, the contract has been cancelled, the engineers are turning back their new cars and moving on."

Tentative Budget Adopted For Pitt

The Pitt county Board of Commissioners tentatively adopted the 1937-38 budget today, calling for expenditures of \$427,172.50, an increase of \$108,408.50 over the \$318,764 figure for the fiscal year just ended.

A big per cent of the increase, however, was for debt service, an item over which the present board exercises no control. Funds to be paid on bonds and interest during the 1937-38 period total \$259,292, an increase of \$82,292 over the past year's figure.

The general fund calls for appropriations of \$96,754.50 during the new year, compared with \$95,000 during the last 12-months period. A slight decrease was made in the county home appropriation, \$11,470 having been allocated as compared with \$11,706 for 1936-37. A decrease also was made in the Health department budget, \$13,648 having been

allocated against \$13,776 for the previous year.

Administration costs of outside poor and relief were shifted to the Social Security fund this year and the allocation for this item was reduced from \$21,280 to \$10,508. The county, however, had to assume new responsibilities to meet Social Security requirements, an item not in last year's budget, and \$35,500.

A statement on taxes levied and the percentage collected for each year since 1927 was presented the board this morning, showing that 94.59 per cent of all taxes levied since that time have been collected.

The figures show that in the time since 1927 \$5,680,593.17 in taxes have been levied and \$5,373,789.83 collected.

One Killed, One Injured When Train Hits Truck

N. C. Fisheries, Inc., Truck Struck Near Grimesland

A man identified by Coroner A. A. Ellwanger as Joseph Nassef, 35, of New Bern, an employee of the North Carolina Fisheries, Inc., of Morehead City, was instantly killed this morning when the fish-laden truck in which he and another man were coming toward Greenville was struck by a Norfolk Southern passenger train.

The wreck occurred at Wilson's Crossroads at about 11:15 o'clock. Coroner Ellwanger declared that the train, Number Two, travelling from Raleigh to Norfolk, dragged the truck 150 or 175 yards down the track. The two men, however, were hurled from the vehicle near the crossing.

Nassef was killed instantly, but his companion, L. W. Gillikin of Morehead City, was taken to Tayloe hospital in Washington, but physicians were unable immediately to determine the full extent of his injuries. It was said he possibly suffered a fractured skull and also a fractured hip.

Nassef, who was brought to Williams funeral home here, was injured about the head and body. Coroner Ellwanger said he was badly broken up and it was impossible to tell whether body or head injuries caused death.

The truck was practically torn to pieces and fish and shrimp were scattered for several hundred yards. Coroner Ellwanger said that the signal at the crossing on this side of the track had been struck by another truck earlier this morning and it was not known whether the one on the Grimesland side of the tracks was operating or not. He said, however, the railroad tracks were visible for half a mile down the road.

Coroner Ellwanger declared Gillikin said that Nassef was driving the truck.

Establish Hours For Curb Market In City

The buyers will be admitted at 7:30 in order that all may have an equal chance at fresh produce before it has been picked over.

Inquest Conducted Into Fatal Wreck

A coroner's jury rendered a verdict of "unavoidable accident" today following an inquest into a wreck in front of the Norfolk Southern railway depot Friday in which Ella Teel, 81-year-old Negro received fatal injuries.

The Negro woman was struck by an automobile driven by W. V. Bisette of Wilson. She was taken to the hospital and died Saturday night.

PLANES BLAST ARMY CENTERS

Authoritative Reports Indicate Chinese Central Government Concentrating Its Forces to Offer Organized Resistance

Peiping, Aug. 2.—(AP)—Japanese, now completely in control of China's ancient capital, closed the gates of Peiping today, virtually imprisoning Americans and other foreigners within the walls as squadrons of Japanese war planes blasted a path for a thrust deep into China.

Japanese authorities said their planes had been bombing Chinese army concentrations at Paochingfu, capital of Hopeh province, 85 miles to the southwest for the last 24 hours. Japanese scouting planes were ranging as far south of Tsingan in Shantung province from 170 miles below Tientsin.

(Authoritative reports to Nanking from northern Shantung province corroborated a belief that the Chinese Central Government was massing men on the southern edge of the hostilities zone. They said troops were moving by railroad, evidently toward the Hopeh border.

(Native newspapers in Shanghai also reported the central government "increasingly preparing for war contingencies" at Haunghou, an important railroad junction in Kiangsu province, bordering the Hopeh-Chahar provinces in the south.)

Although Japanese asserted the area around Peiping was quiet, the erected heavy fortifications at both the east and south gates of the city. A United States army officer and missionary were halted at the east gate and refused permission to set out on a mission of mercy to Tungehow.

They wanted to investigate damage done to the American missionary school at the capital of the East Hopeh autonomous regime.

The Japanese army, heavily reinforced, was penetrating rapidly to the south along the strategic rail.

MISHAP FATAL TO LITTLE BOY

Killed in Freak Road Accident In This County Sunday

Dewey Lee Fornes, two-year-old son of Mr. and Mrs. William Godfrey Fornes of Hanrahan, was instantly killed yesterday morning at 8 o'clock when the car in which he was riding with the rest of the family wrecked after striking a piece of wood on the road near Calico's Crossroads.

Funeral services were conducted at 3 o'clock this afternoon at the burying ground on the Fred Hadlock farm near Shelburne in the presence of the minister of that community.

Besides his parents, the little boy is survived by two brothers, Albert and Harold, and two sisters, Geneva and Joanne, all of the home.

Mr. and Mrs. Fornes and their children were traveling on a dirt road when a wheel of the automobile struck one end of the piece of wood, lying lengthwise in the road. The other end flew up and hit the car between the radius rod and axle, lifting the car in the air and forcing Mr. Fornes to lose control. The vehicle ran down an embankment and turned over on its side, crushing the little boy's head. No other members of the family were seriously injured.

No other serious accidents were reported in this section over the week-end, although minor mishaps resulted in slight injuries. Alex Smith, Negro, was taken to the hospital Saturday afternoon where he was treated for cuts received in a wreck in front of Smith's place.

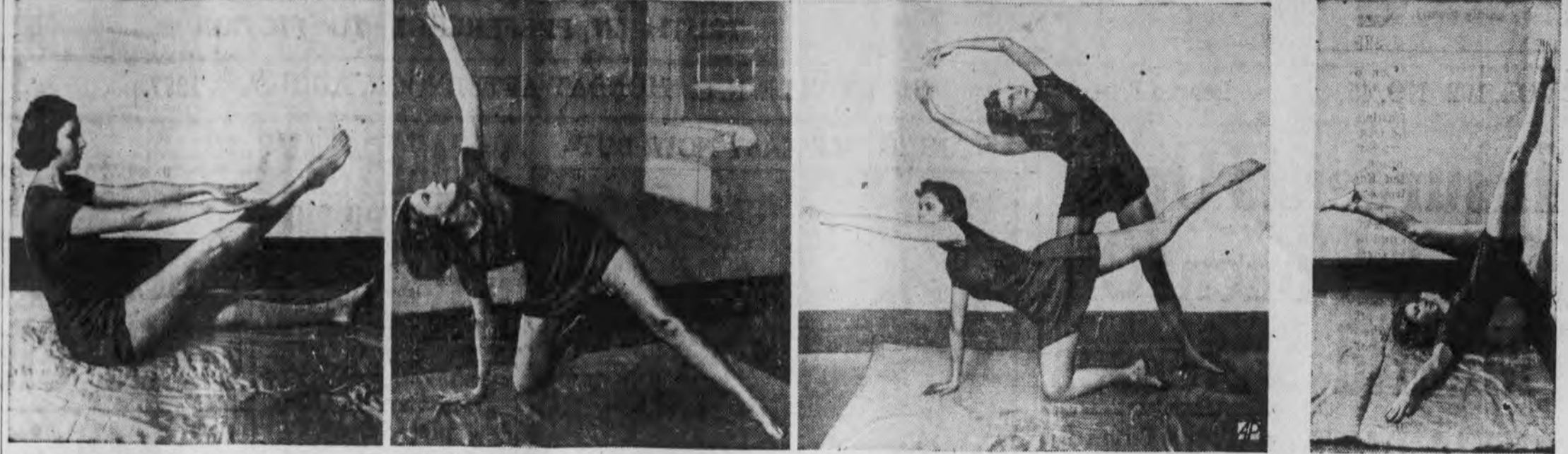

UPS AND DOWNS: For Silhouettes KNEELING STRETCH: For Shoulders COMBINATION: For Balance WALL-CLIMBING: For Hips You get on the exercise mat. The exercises shown here help one to grow slim gracefully. The first picture is the sit-down, sit-up exercise, fine for achieving a pleasantly slim silhouette. From a position flat on the floor; sit up, bringing the arms forward, at the same time slowly swinging one leg up and across the other. Alternate the leg movements. The particularly graceful exercises of the second picture remedies stooping shoulders and develops the bust. Start on the knees, palms of both hands on the floor. Swing the left arm backward slowly and at the same time and with the same tempo swing the left leg forward and out. Strive to keep the leg straight, foot flat on the floor. Turn the head to follow the outstretched arms, to attain one graceful line. Alternate with right arm and leg. Even two can be graceful at this business of exercise. The kneeling Mercury is doing an exercise like the preceding one, but extends arm forward and leg backward in a straight line. The standing figure swings both arms over the head, from a relaxed position with head bent and hands dangling. These girls are developing balance. To strike the acrobatic pose of the last picture, lie flat, hips close to the wall, legs up. Climb slowly until the legs are straight, then throw the weight on the shoulders, balancing on the heels. Swing the legs back, alternately as far as possible. This is particularly good for reducing thighs.

MODES of the MOMENT

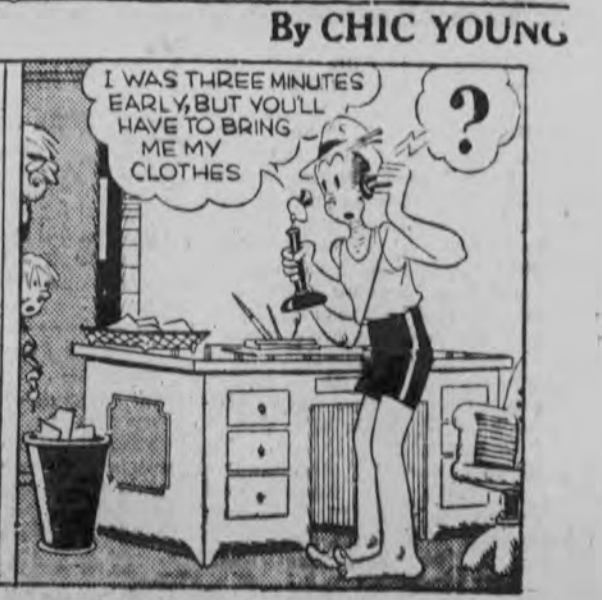

Washington Daybook
 By Preston Grover

Washington—Without being able to put a finger on the exact spot readers of the report of the National Resources Committee on "Technical Trends and National Policy" are likely to get a distinct feeling that the writers of this latest national brain tome want the federal government to have more control of the employment of new inventions.

There is much diligent research in the 288 pages of the document, but much of it reads as if it had been clawed out of the piles of theses that any university has in a back room, left there by scholars who wrote them for Ph.D.'s.

You go for a scholarly gallop charts and graphs to come to this through polysyllabic words, and prosaic conclusion:

"The outlook for the immediate future seems to be in the direction of further technological progress toward a level of productivity substantially higher than that attained prior to 1929. The rate of advance of course differs in different industries, but since our economic system has not evinced an ability to make this necessary adjustment fast enough, it may be expected that the dislocation occasioned by technological progress will continue to present serious problems of industrial economy and social readjustment."

Story of Inventions
 Somehow we have felt nearly everybody knew that all along. But somewhat more exciting is the conclusion of Bernhard J. Stern of Columbia university department of social sciences. He tells an enthralling story of the difficulty various inventions, such as the steam engine, railroads, gasoline motors, and airplanes, had in overcoming public and governmental resistance.

As each new invention has come along, he records, there has been opposition to it on the ground it would create unemployment, would destroy existing industry, or present such a preposterous aspect as to drive people insane in droves.

"In most countries," he says, of recent times, "there have been requests for scientific holidays" and a "moratorium on inventions," which have found echo in business and scientific circles."

He then steps out boldly to commend Soviet methods of fostering technological progress "as a means of achieving the governmental (Soviet) objective of a socialist, planned, large-scale economy for the satisfaction of expanding consumers' needs."

Bid for Red-Baiters
 He concludes with an assertion that the economic structure of a society is the principal factor in determining the speed of overcoming public and industrial inertia against new inventions. He hints that a planned economy which calls for government control, offers the best scheme under which the masses of the population may realize the benefits of new inventions. He says:

"Capitalism has inherent in its structure and functioning, factors which militate against such realization, and thus prevent industrial practice from keeping pace with scientific knowledge."

If that isn't a bid for the outcries of red-baiters, we've muffed it.

to other jobs—just because some bureaucrats in Washington want to take a slap at the Aluminum Company of America and Andrew Mellon President Roosevelt may be all right, but some of his appointees and bureaucrats there in Washington are undoubtedly nit-wits.

Others here are unable to reconcile the President's declaration urging private business and industry to expand and increase employment so that recovery may be hastened, with the tactics being employed by such governmental agencies as the Federal Power Commission and the Rural Electrification Administration to deliberately block expansion efforts by private industry. They maintain that there must be a screw loose some where in Washington, if not a whole flock of screws. Some think that the President either does not mean what he has said or that he as built up a New Deal Frankenstein that has gotten so out of control and veered so far to the left that the President does not seem to be able to get it back under control.

According to press reports from Washington, the Carolina Aluminum Company applied to the Federal Power Commission some weeks ago for a permit to build the new dam, believing that the permit would be granted without opposition, since four dams have already been built below this new dam site and one above it. But instead of granting the permit, the power commission called for an oral hearing before a special master, who raised the question as to the effect this dam would have on navigation in the Yadkin river, despite the fact that the Yadkin river never has and never will be navigable, that the U. S. Army engineers have so held, and that there are no locks in the five dams already constructed in this vicinity.

As a result, a good many observers here are wondering if the 1937 edition of the New Deal is not more interested in punishing power companies and in retarding private business expansion if backed by Republican capital, than it is in providing jobs for the unemployed and in hastening recovery.

ETIQUETTE

Convenience is the mother of good motoring manners.

Because guests, in the normal order of things, should have the choice seats, automobile etiquette demands that they enter the vehicle first.

Because rummy sets are difficult to get into, motoring custom insists that older people and women should not be asked to sit in them—unless, of course, they express a preference for rummy seats. (In case they do it's the gentlemen's duty to help them in getting there.)

And because it is more convenient—financially at least—for several people to ride in one car, it has become customary for friends of the automobile owner to insist on sharing the expenses.

Seven Cents A Mile
 Accepted estimates of motoring costs place the expense of owning and operating an average, low-priced car at around seven cents a mile.

That still leaves five and a half cents—to come out of the driver's pocket.

There's the oil. It averages around 30 cents a quart. It should be changed every thousand miles or so—well, it means \$1.50 if five quarts are used.

Other Expenses
 Other items of expenditure, besides the actual cost of the car itself and the insurance, include: new tires at least once every 20,000 miles—if the driver is lucky; greasing (every 1,000 miles or so); wax and paint (waxing to the tune of three or four cents will make a tremendous difference in the car's surface during snow storms in snow-storm territory); addition of freeze-proof liquid in winter; new spark plugs (every 10,000 miles or so); grinding the valves (every 20,000 or so) . . . and so on ad infinitum.

Consequently when the guest occupants of the car insist on paying for the gas—and even the gas and oil—what they're really paying amounts to just about a quarter of the expenses.

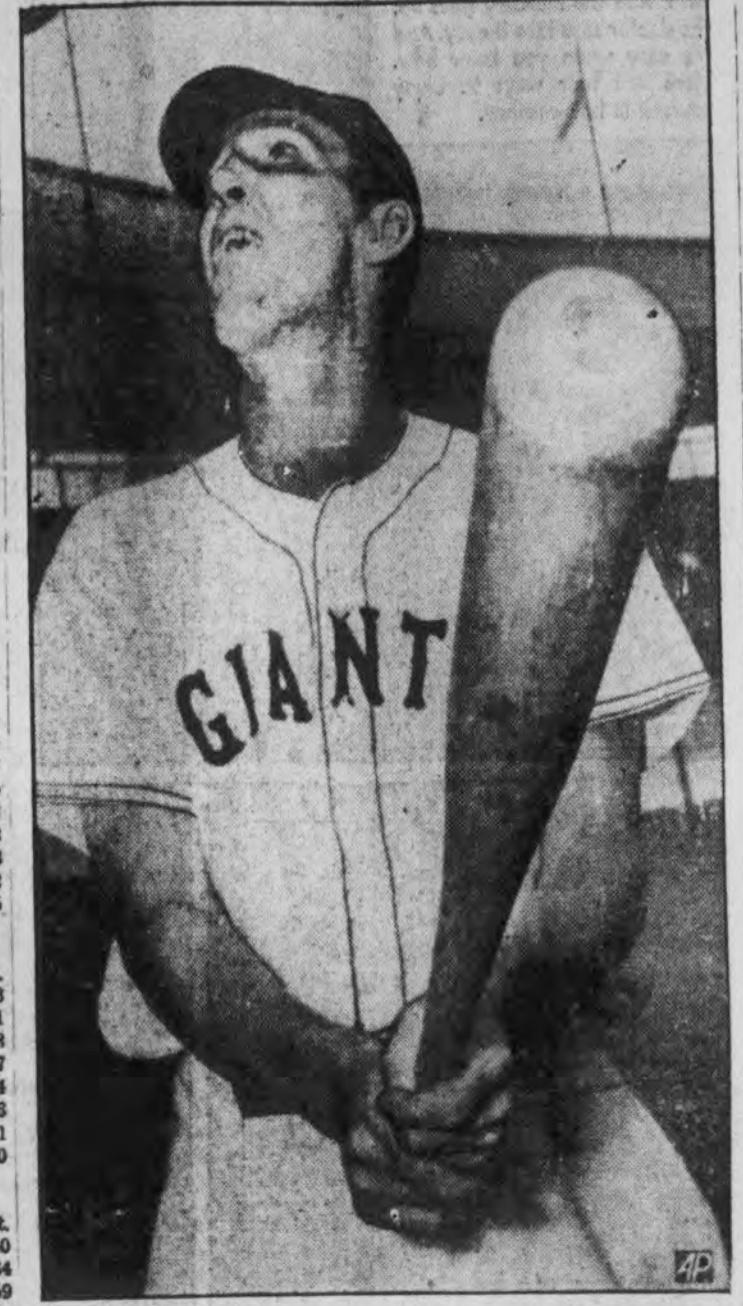

Navy's Coach Finds A Boxer - In Madeira

Funchal, Madeira—(AP)—In this city lives a leathery little Portuguese by the name of Antonio Cabegada who whips himself into fighting trim by lugging a heavy carrinho up a mountain side.

A carrinho if you're not up on your Portuguese, is a basket sledge used for steep descents. The one "must" on the list of every visitor to Madeira is a trip up the mountain to Ribeiro Frio Heights and then the 3-mile slide down the



steep cobble-stoned runway to the city of Funchal. This affords one of the main amusements—sledding among palm trees, and without snow. To Antonio Cabegada it affords not only an excellent conditioner for boxing, but a few extra escudos for his purse as well.

I have gone to no small amount of trouble in my travels to many foreign ports of call to look up boxers and to observe at close range their methods of preparing for a boxing match, but never before have I come across one, and a classy one at that, who whips himself into fighting condition by climbing a mountain side with carrinho on his shoulders after having guided his two or three passengers down the long steep incline in same.

Natives of Madeira are tremendously proud of Antonio, and rightfully so, for he is the greatest boxer ever developed on this 27x14-mile

island several hundred miles off the west coast of Africa. Not long ago Antonio made a voyage to Lisbon, Portugal, and knocked out the featherweight champion of southern Europe. On his return to Funchal most of the island population turned out for a demonstration.

Antonio is 21 years old and scales 125, and has the durability of a pack mule. He is endowed with more than a fair amount of boxing skill and is a murderous left-handed puncher who clubs his opponents to the canvas in much the manner of Jack Dempsey in his prime.

LIVE ANIMALS NOW ACCEPTED FOR AIR EXPRESS TRANSPORT

New York, Aug. 2.—Live creatures producing no offensive odor and not requiring water or food in transit may now be accepted in air express service provided the scheduled time in transit will permit their safe

transportation, the Air Express division of the Railway Express Agency announced today.

For the first time since air express service was started in 1927, the planes of the score of air lines over which Railway Express operates are equipped, the announcement says, "to handle a limited amount of live freight when the nature of such freight will not interfere with the safety and comfort of the passengers."

Change of policy, it was added, was due to increased speed, including overnight flights from coast to coast, and enlarged air temperature regulated cargo compartments.

By the new ruling, baby chicks in standard containers may be accepted in air express service when under the regular schedule they will reach their destination within seventy-two hours from the time of hatching. Started chicks will not be accepted for air express service, it was said.
