Chinese Death Battalion Completely Wiped Out In Defending Shanghai Area

HEAVY LOSSES BY BOTH SIDES

Estimated 1,400 Chinese and 3,000 Japanese Slain in Battle for Possession of Tazang, 5 Miles From Shanghai; Foreign Residents Alarmed

Shanghai, Oct. 18.—(AP)—Chinese authorities said today that a death battalion of 1,400 Chinese troops and more than 3,000 Japanese attackers were killed in a battle for possession of Tazang, about five miles northwest of Shanghai.

They described the engagement in which Chinese fought to protect the supply bases—as the heaviest single encounter in the Shanghai area since hostilities began.

Junior Stepp, white youth, was convicted of engaging in riotous and disorderly conduct and was fined \$10 and costs.

Louise Graves, Negro, was taxed with the costs upon conviction of engaging in disorderly conduct.

Raymond Butler, who said his home was in Chapel Hill, was allowed to go provided he get out of the city by noon after he offered a plea of guilty to public drunkenness.

Clarence Craft was convicted of drunkenness and was ordered to pay the costs of court.

William Coates, Negro, was convicted of driving without proper brakes and judgment was suspended upon provision he pay for damages caused to the automobile of the prosecuting witness.

Hubert Little, Negro, was taxed with the costs upon conviction of a drunkenness charge.

Challenge of Attempt To Subpoena Telegrams Denied

Washington, Oct. 18.—(AP)—Three Florida companies lost in the Supreme court today in an attempt to subpoena their telegrams.

The tribunal refused to review a decision against the companies by the Fifth Circuit court of appeals. The latter sustained the subpoenas as well as the 1933 "trust and securities" act under which the subpoenas were issued.

Justice Black was assumed to have participated in the action announced today in approximately 30 controversies appealed from lower courts.

FARMERS CALL ON COMMITTEE TO ENACT LAW

Shout Approval Of Compulsory Control of Crops

HEARING HELD WINSTON - SALEM

Senator Smith Of S. Carolina Pledges Support Movement To Aid Agriculture

Winston-Salem, Oct. 18.—(AP)—A farmers' meeting here today shouted approval of compulsory crop control as a remedy for the ills of agriculture.

The demonstration came when Senator E. D. Smith opened a hearing by a committee of senators appointed to sound out farm sentiment upon agricultural legislation and asked, "do you want compulsory control?"

"Yes, yes," came cries from the 500 farmers, representative of farm organizations, and agricultural officials.

"Do you want voluntary control?" Smith asked.

"Noes" filled the room. At the outset Smith pledged his support and that of his committee to a movement to "put agriculture on a footing where it belongs."

"I am tired of being the tail to the dog," the South Carolina legislator shouted. "Let's get to the other end and bark a while. I want you to rise up and speak out loud. It is your opinion that we want."

Dean I. O. Schaub of the North Carolina State College extension service told the committee there is a "great need" for crop control in the state.

"Participation in North Carolina dropped off when control went out with invalidation of the AAA and acreage increased," he said. Schaub urged that new farm plans be completed by congress before farmers get their own plans underway.

Strike Called In Western Carolina

Hickory, Oct. 18.—(AP)—Strikes were called today in three mills of the Shuford chain, two at Granite Falls and one at Longview, in protest against what leaders termed a "stretchout."

Two Shuford plants in Hickory were not affected. Labor leaders said 400 workers were out at Granite Falls. The plants involved there were the Granite Falls Carriage Company and the Granite Falls Manufacturing Company.

At Longview, a Hickory suburb, a workers spokesman said 150 employees had walked out. Mill officials said the plant continued to operate.

Employees of the affected plants are members of the CIO's textile workers organizing committee. Roy Lawrence, state director, was here today.

Italians In Spain Total Only 40,000

Rome, Oct. 18.—(AP)—The number of Italian volunteers in Spain was put at 40,000, including both combatants and non-combatants, today by the semi-official diplomatic information bureau.

A special bulletin was issued to combat what were called "fantastic figures" published abroad. "Of the 40,000," it said, "this is the truth; which fears no denial from any source verified or verifiable," adding that Valencia's volunteers are much more numerous.

Tobacco Selling High In Greenville Today

Reports from "Tobacco Town" today indicated that the day's average price would set new record. Tobacco was reported to be selling as high as \$90 a hundred pounds with numerous farmers receiving as high as \$80 per hundred pounds for some piles.

Offerings so far this year have totaled 42,492,840 pounds and have brought farmers \$10,961,907.60, for an official average of \$25.80 per hundred pounds.

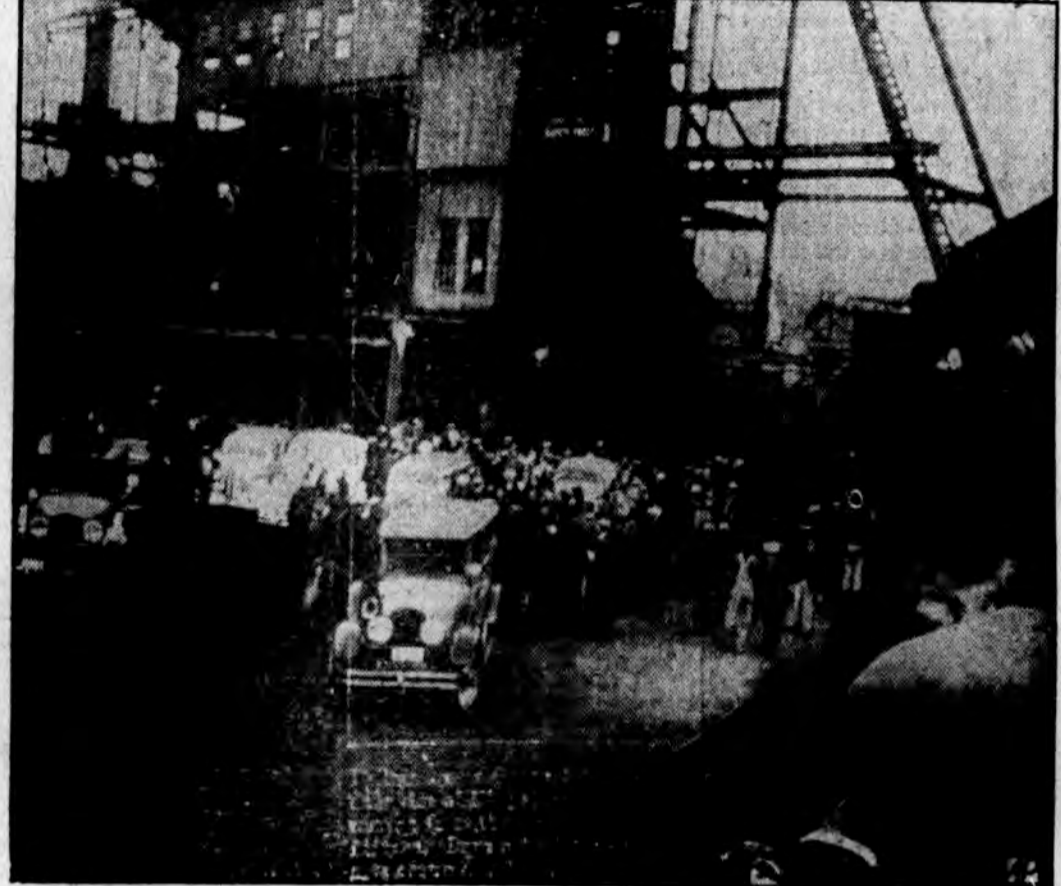
County Court Session To Be Held Tuesday

The 1937 edition of the Pitt County fair officially got under way today with a good crowd expected tonight if the weather permits. A large number of persons went out to the new grounds on the Falkland highway yesterday afternoon to get a pre-view of the exposition.

The two American Legion posts in the county—Farmville No. 151 and Pitt County Post No. 39—are sponsoring the exposition for the second successive season this year.

Already there are a large number of agricultural exhibits on display and farmers have until tomorrow at 4 p. m. to get their exhibits on the grounds. Judging of the various exhibits is scheduled for Thursday.

The Kaus United shows have brought one of the largest and best midways here ever to gather at a fair this size. In fact, two complete shows will be on the midway this week. May Let Franco Refuse To Call Off Volunteers

London, Oct. 13.—(AP)—Italy and Germany today held an ace, which informed sources said, may enable them to gain another diplomatic victory in the Spanish civil war non-intervention crisis.

Observers said Premier Benito Mussolini of Italy and Chancellor Adolf Hitler of Germany can agree to the Anglo-French plan for withdrawal of foreign volunteers from Spanish armies and then let insurgent General Francisco Franco scrap the plan by refusing to call off his foreign fighters.

Thus, he said, Germany and Italy were in a position which might permit them to prolong discussion over the problem and evade blame in the event that non-intervention machinery collapses.

The non-intervention sub-committee will meet in London Tuesday.

Prime Minister Neville Chamberlain presided at a cabinet meeting called primarily to consider prospective parliamentary legislation. A committee of experts meanwhile took up proposals to reinforce the neutrality committee's control on Spain's French and Portuguese borders and to abolish all forms of sea control except observation by neutral agents.

It was pointed out that although Franco orally has not agreed to a withdrawal of foreign soldiers, he has done so with a reservation. He has stipulated "equal withdrawal" of foreigners from both insurgent and central government forces as proposed by Italy.

British diplomatic quarters indicate, however, that Great Britain will ask for withdrawal of five men from the insurgent side to every one man called out of government ranks.

OFFICERS JAIL ASHEBORO MAN

Bill Cross Accused of Murder of Army Ranger

Raeford, N. C., Oct. 18.—(AP)—Sheriff D. H. Hodgins of Hoke county said here today that Bill Cross, 45-year-old Asheboro hunter, had been accused by three companions of killing Sergeant J. R. Mott of the Fort Bragg reservation early Saturday.

Hodgins made his announcement shortly before a coroner's jury re-assembled to resume an inquest started Saturday. Cross, the officer said, refused to make any statement.

The inquest was set for 1 p. m., but deferred until later in the day.

Cross and his three alleged companions on the deer hunting trip that ended in the death for the army ranger, were held in all waiting the outcome of the inquest. Hodgins said no formal charges had been preferred in connection with the slaying.

The officer said H. S. Rush, Jess Crofts and Walt Routh, all Randolph county men, had made statements to him in which they charged Cross with shooting Mott after the latter had told the Asheboro man he was under arrest.

Mott's body was found a short time later by G. E. Guinn, who went to investigate the sound of shooting near his farm.

FEAR NINETEEN PERSONS DEAD

Ship Located by Air Searchers Relatively Short Distance From Landing Field in Section Accessible Only by Difficult Wagon Road

Salt Lake City, Oct. 18.—(AP)—A giant "mainliner" of the United Air Lines lost 14 hours with 19 persons, was sighted in rugged southwestern Wyoming today, with first indications it either had been wrecked or burned. Whether anyone had escaped could not be determined until ground searchers reached the scene, which was expected to require several hours.

Nat H. Beddard, 70, prominent merchant and farmer of the Simpson community, died in the Pitt General hospital here Sunday morning after being in declining health for the past 18 months. He had been able to attend to his duties at his store and his farming interests until last Wednesday night, when he suffered a heart attack.

Mr. Beddard was a native of Pitt County. He spent his early life in the Suffield community, moving to Simpson when 23 years of age. He had been a merchant at Simpson for the past 46 years and was well known. He was a member of the Salem Methodist church, a member of the Improved Order of Red Men, a member of the Woodmen of the World, and was assistant postmaster of Chocod.

Surviving are his wife, Mrs. Pernie Campbell Beddard; three daughters, Mrs. Harvey L. Pate of the home, Mrs. Fred Edwards of Simpson, Mrs. J. W. McLawhorn of Ayden, and one sister, Mrs. G. B. Pate of Kinston.

Ruth Bryan Owen To Speak Here.

UNC PREPARES MEET TULANE

Green Wave Carolina Foe for Homecoming Day

Chapel Hill, Oct. 18.—North Carolina's football squad today got down to the serious business of preparing for its Homecoming Day stand against Tulane's powerhouse here Saturday. The contest will start at 2:30 o'clock.

Over in nearby Raleigh, the Green Wave football squad had just arrived from Hamilton, N. Y., following its inter-sectional engagement with Colgate Saturday. The Greensies will work out every day this week at State College and will come to Chapel Hill Saturday morning.

The elimination of the long 1899 mile trip will prove advantageous to the already favored Tulane outfit. Last season the Tar Heels left for New Orleans Wednesday night and arrived there Friday morning. The one day rest wasn't enough. The Tar Heels showed the effects of the long jaunt. And they met a better Tulane team at its strongest. The result was a convincing 21 to 7 victory for the Louisianans.

It appears now that North Carolina will catch Tulane at its peak again. After beating Clemson and tying Auburn in the mud, the Green Wave powerhouse struck with deadly accuracy against Mississippi and amassed the second highest score in the institution's history. Tulane tallied 13 touchdowns and six extra points for a grand total of 84 points. Mississippi College failed to score.

The Greensies uncovered two sensational sophomore halfbacks against Mississippi. And their names weren't exactly unfamiliar to Tulane supporters. Buddy Banker, brother of Bill, all southern halfback at Tulane in 1929, and Billy Payne, brother of "Fanny" of the 1931 Green Wave team, were contingent, stole the spotlight from the more experienced juniors and seniors.

Tulane's contribution to the one-sided tally was this: three touchdowns responsible for the fourth, and an 18-yard average gain. Here is what Billy did: four touchdowns and an 11-year average gain.

Tulane's line will be the heaviest to face North Carolina this season. From end to end the forward wall will average 290 pounds—11 per man more than the Tar Heels. The starting line ups: Elson Goodell, 175, and Ralph Wenzel, 210, ends; Ray Miller, 210, and Bill Kirchen, 215, tackles; C-Captains Norman Buckner, 195, and Normal Hall, guards; and Bernie Smith, 200, center.

Besides Sophomores Banker and Payne, the Greensies will offer a host of outstanding triple-threat, double threat and single threat acts. John Andrews, 200-pound All-Southeastern fullback last season and now Tulane's outstanding candidate for All-America honors; Ralph B. Bond, 160, triple-threat quarter; Bill "Dub" Mattis, 185, triple-threat halfback and punter; and Bill Flowers, 175, sped artist.

Tulane has a vast amount of reserve power and can put on a field second eleven almost on a par with the powerful first outfit.

CHINESE DEATH BATTALION COMPLETELY WIPED OUT

(Continued from page one) planes and naval guns. Colonel Gunn was killed and his force wiped out.

Chinese and Japanese air raids and anti-aircraft shelling caused increasing fears in the international settlement that Shanghai may suffer a repetition of the "bloody Saturday" catastrophe of August 14.

There was a growing demand among foreign residents for some sort of remedial action. It was learned that American and foreign consuls are asking their home governments to protest to both China and Japan against war planes flying over the foreign areas.

Japanese, failing to break Chinese resistance in the Chapel sector of Shanghai in 57 days of continuous assault, resorted to air bombardment of all Chinese communication lines and supply bases behind the lines.

The Japanese bombardment followed a Chinese raid which ended at dawn. Chinese planes made six forays over the international settlement and French concession to drop bombs along the Whangpoo river front and Japanese sections of the international settlement.

The bombardments were said to have forced Japanese to abandon their landing fields and transfer equipment to Wosung, 12 miles downstream.

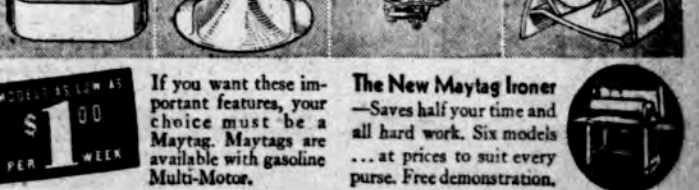

New York.—Win or lose, Fiorello H. LaGuardia appears likely to be elected by this majority campaign into a position of national prominence.

Just where he will and nationally is anybody's guess. The Democratic organization in New York City is opposing him, even though he has been stamped as pro-New Deal and has been kindly served by the national organization.

The Republican city organization is concededly hooking itself to his popularity mainly for what it can get out of it in the way of party build-up. While always nominally a Republican, he often has been so far out of party alignment as to look like a one-man party all by himself.

There is no national third party of major consequence yet, but some of the headiest observers in New York believe that when the time comes for that sort of movement to be launched, he will be near the head of it—provided the move starts before 1940.

Up From Alderman. La Guardia is an American-born Italo-Jewish son of an army bandmaster. Politics has been his life work and living since before the war, and like many another politician he was congressman and an ex-city alderman until, in 1933, he rode the crest of a reform wave into the mayor's office on a fusion ticket.

As the mayor of the country's largest city, he drew a given amount of attention, but the New Deal style suited him, and soon he became the speaking voice of a liberal following like nothing so much as the liberal following of President Roosevelt in the national field.

He put a restraining hand on the police, so union pickets came to see in him their special benefactor, for the six million or more citizens under his jurisdiction, he was entitled to draw generous portions of New Deal relief and reconstruction money, and he spent it speeding up the city's traffic arteries and in opening 400 playgrounds and pools for the poor and half-privileged.

He promised economy and relief from reputed Tammany wastefulness, but, in tune with the national administration, permitted total expenditures to climb. He chose police and fire commissioners from the career men in the departments, rather than rewarding political supporters, and went out of the state to snap up highly-recommended health and prison executives.

Played Ball His Way. His loyal supporters concede, however, that he was willing to "play ball" to a degree for political purposes down in the lower patronage ranks. Mostly it was "La Guardia ball" he played—so that Tammany starved and the Republican organization fared little better.

At the end of four years of mayoralship, impartial observers credited him with an administration freer than in a long time from political racketeering and efficient as may be expected in a political administration in a city.

At the end of that time he sought re-election without a party he could call his own. Still when you ask him if he is going to move into the national field from the mayor's office, he snaps back: "No, I'll be through with politics. I'm going to teach school out in Arizona. I'm too old. He is 55. I've been in office 34 years and campaigned 15 times."

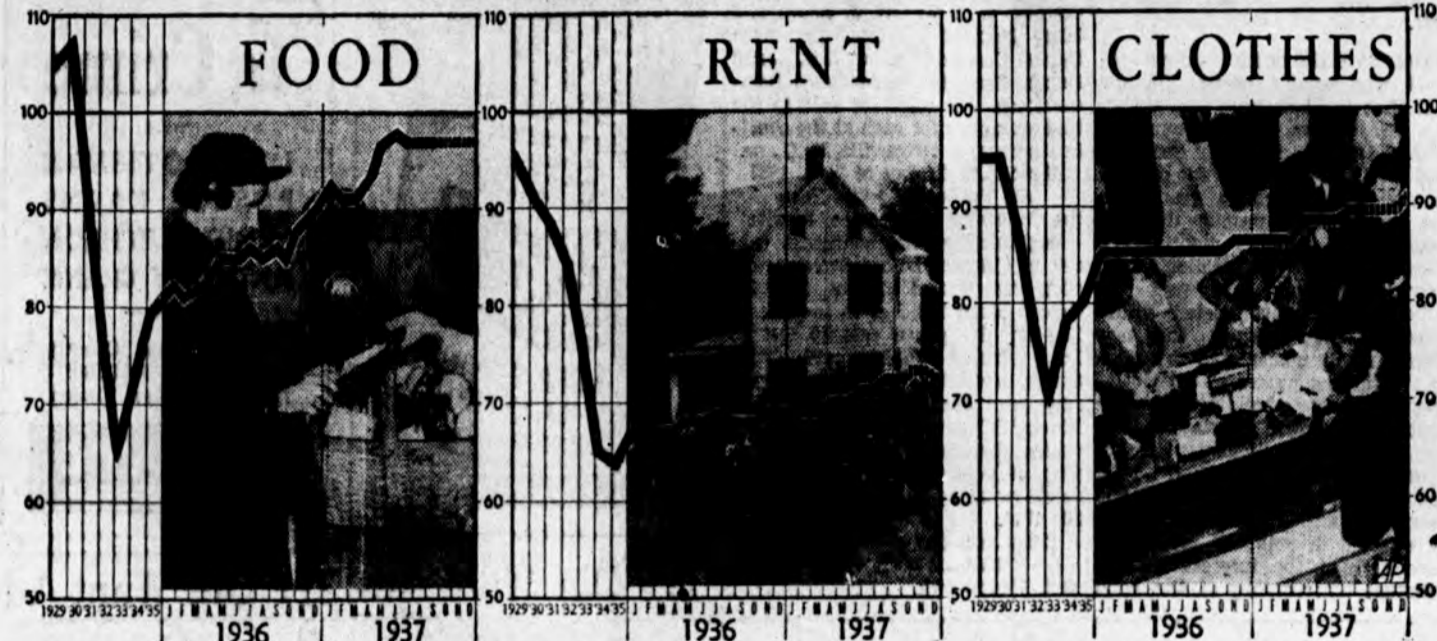
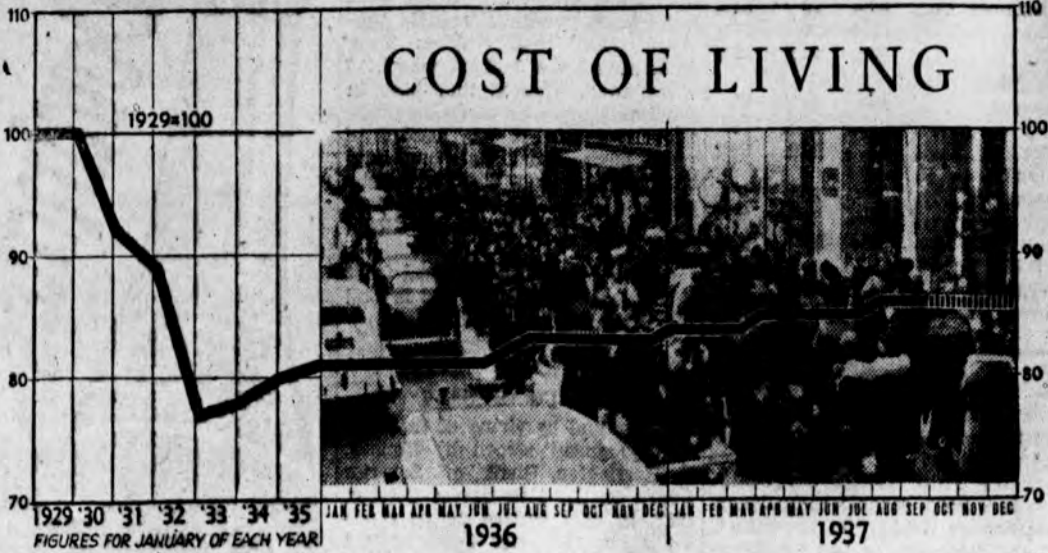
HOPE, LADIES:

Will America Aid League Of Nations Stop Japan?

(An American Statesman, Woodrow Wilson, conceived the League of Nations 20 years ago as an instrument for world peace. Now, in the face of a world crisis, American statesmen have approved the League's stand against Japan's invasion of China. Yet this is not the first time the United States and the League have gone along together. Here is an account of their relationship.)

The \$10,000,000 palace of the League of Nations on the slopes overlooking Lake Lemana near Geneva, Switzerland is the dream in stone of an American President, and American money (\$2,000,000, contributed by John D. Rockefeller, Jr., went into the construction of its magnificent library.
For centuries men had dreamed of an international league to keep the peace of the world. There had been holy leagues, leagues of war and leagues for the promotion of trade. But the idea of a league against war remained an unfulfilled hope.
It could not have been other-

nations.
By the firm establishment of the understandings of international law as the actual rule of conduct among Governments.
And by the maintenance of justice and a scrupulous respect for all treaty obligations in the dealings of organized peoples with one another.
Agree to this Covenant of the League of Nations.
There followed 26 articles providing for membership, representation, arbitration of disputes, guar-

antees against external aggression, reduction of armaments, mandates over "backward territories and and the establishment of a Permaraces." international cooperation
wise in ages when despotic power was in the hands of a few monarchs. The American and French Revolutions unleashed forces that made possible a concert of peoples, but not until after the bloodiest war in history did it take tangible form.
It was President Woodrow Wilson's insistence that made the Covenant of the League of Nations an integral part of the peace treaties that followed the World War. At the councils of the Allies he personified the spirit of idealism that had taken the United States into the war. More realistic was Wilson's secretary of state, Robert Lansing, who declared: "War will follow the treaties as surely as night follows day."
War has followed, but in 1919 few foresaw it. In these solemn words of the Covenant's preamble the nations of the world looked to the future:
"The High Contracting Parties, in order to promote international cooperation and to achieve international peace and security
By the acceptance of obligations not to resort to war,
By the prescription of open, just and honorable relations between

ment Court of International Justice.
The League has two stated aims:
1. To preserve peace and to seek a settlement of international disputes.
2. To organize in the most varied spheres the cooperation of peoples with a view to the moral and material welfare of humanity.
The League has done a tremendous amount of spade work in the humanitarian and allied economic fields, holding international conferences on finance and transit, health, armaments, intellectual cooperation, the white slave traffic and the illicit opium trade. In many of these, and in the work of International Labor Organization, a League subsidiary, the United States has taken an active part, paying its own way.
The League has a representative assembly which meets once a year; a permanent council meeting every third month, and a permanent secretariat.
Members of the League pay an annual contribution in gold francs.

Great Britain, for 1937, paid 2,490,531 gold francs. The Dominions added to this total. France paid 1,844,838 gold francs. Afghanistan paid only 23,060 gold francs.
The franc has a current exchange value of 32.67 cents, being based on the Swiss gold franc before devaluation.
It is in the international political arena that the League's works have been scrutinized most closely, applauded most and condemned most severely. Its detractors early charged it was a tool for the maintenance of the status quo in Europe after the world war.
Its apologists, first reading the roll of its good deeds, shake heads over the fact that the world's leading power, the United States, has chosen to remain aloof.

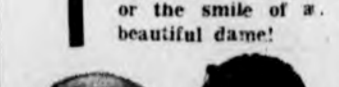

his ambitions to succeed Senator Robert R. Reynolds. Predictions of his chances have been extremely guarded, though everybody concedes that the Fifth District representative is a hard, capable campaigner and nobody thinks that the race is by any means in the bag for Reynolds.

Letting of the office building contract was notable chiefly for the fact that the bids were well within the \$675,000 available for construction of the new five-story structure and for the fact that it was decided to use North Carolina granite in the construction, despite the fact that this adds only slightly less than \$50,000 to the building's cost.

Predictions now are that the building will be completed within a year. When finished, the new building will immediately be filled to overflowing just as all presently available state buildings are. The continuous growth of state activities and the multiplication of bureaus has brought in their wake congestion of the worst sort. It has been estimated that the saving to be effected in rent will more than take care of the interest on and eventual amortization of the bond

issue for building an ew office structure.

The School Commission solved the vexing Garysburg school bus problem by receding from its previous stand that children there must attend the Jackson school, 10 miles away, whereas they have in previous years gone to Weldon, only two miles off. It was decided to route busses from Garysburg into both Jackson and Weldon, thereby giving the children and their parents choice as to which they should attend.
