REBELS BEGIN MASSING ARMY FOR NEW DRIVE

Seek to Sever Catalonia from Other Loyalist Area

ITALIAN TROOPS MOVING TO AREA

Consolidation Operations in Captured Northwest Being Concluded Rapidly

Hendaye, Franco-Spanish Frontier, Oct. 25.—(AP)—Insurgent General Francisco Franco today began massing troops at Zaragosa to cut Catalonia from the part of Spain still held by the government.

Frontier reports said heavy forces of Italian soldiers from Morocco were moving into Zaragosa. The Italian "black arrow" division also was reported moving to that sector.

Insurgent headquarters at Salamanca published a telegram from Premier Mussolini to Franco expressing "personal felicitations" for the conquest of northern Spain.

Earlier reports said government forces yielded ground on the Aragon front in northeast Spain to what officers called "superior numbers of insurgents."

Insurgents also reported a victory at Pueblo de Albornon, where infantry was said to have seized "troops abandoned by the enemy in which were found bodies, guns, supplies and clothing."

A government source said the insurgent charge there was defeated.

Francisco's aides on the Biscayan front in northwest Spain, where the insurgents last week ended their campaign with the capture of Gijon, said "consolidation operations were being concluded rapidly. Train service already has been re-established over principal Asturian lines, they reported.

Reveals Approval Of Hospital Here At Surgeons Meet

Announcement Made at Twentieth Annual Hospital Standardization Conference in Chicago

Announcement that the Pitt General hospital here again had been provisionally approved was made today at the twentieth annual Hospital Standardization conference, which opened in Chicago this morning with the Clinical Congress of the American College of Surgeons.

Being approved provisionally indicates that the hospital has accepted the minimum requirements laid down by the College of Surgeons, but for lack of time or other acceptable reasons has not yet been able to carry them out in every detail.

In announcing the list of 2,631 hospitals, Dr. George Crile, chairman of the Board of Regents, said: "The 1937 Hospital Standardization survey concluded two decades of successful effort by the American College of Surgeons to assist the hospitals of the United States and Canada in rendering better care of the sick and injured. Today 2,631 hospitals are awarded Full or Provisional Approval. At the end of the first field survey in 1918 only 79 hospitals were sufficiently well-equipped, organized and administered to merit approval."

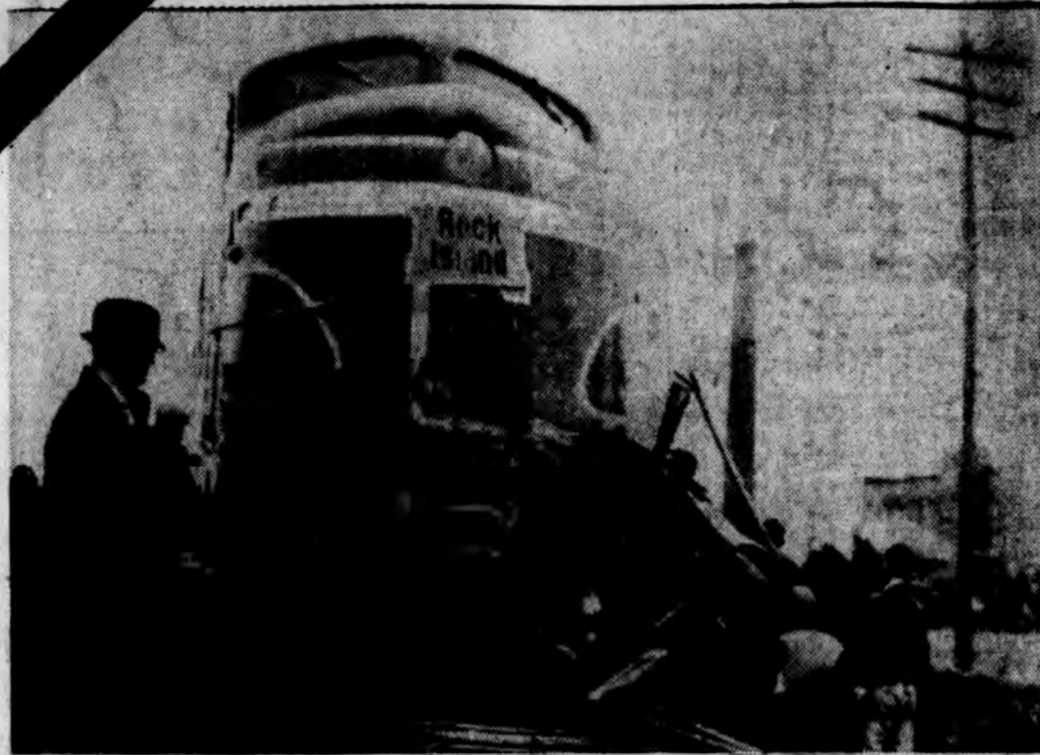
Commenting further upon the survey, Dr. Crile declared: "The fact that one out of every fourteen persons in the United States and Canada went to some hospital in 1936, with the probability that the same ratio will be maintained in 1937, suggests how important hospitals are to every community. At this rate, if we assume that different individuals each year enter hospitals, every 14 years the entire population of this country and Canada will pass through hospitals as patients. Even when it is granted that the same persons are likely to be patients several times during any 14-year period, it is evident the proportion who will be hospitalized is astonishingly large."

HOLDS RUSSIA GUILTY PARTY

General Araki Blames Communism for the Sino-Jap Strife

Tokyo, Oct. 25.—(AP)—Baron general Sadao Akari declared today that "it probably is necessary to strike directly at Russia," to eliminate the communist influence which many Japanese consider the root of the present turmoil in China.

General Araki who was Japan's minister of war during the Manchurian incident of 1932, recently emerged from retirement by way of Japan's new brain trust.

He advanced stern military measures and castigated Russian communism.

There are two principal causes of the present Sino-Japanese conflict, he general said.

The first stems from Chinese violation of the agreement signed after the 1922 fighting, which provided a demilitarized zone about Shanghai," he said. "As soon as possible Chinese built permanent fortifications and moved garrisons into them."

"Beneath this tangible fact lies the invisible influence of communism."

SCOTTSBORO BOY LOSES HIS APPEAL

Haywood Patterson Fails Escape Sentence of 75 Years In Prison

Washington, Oct. 25.—Haywood Patterson, one of the nine negroes involved in the famous Scottsboro case, lost in the Supreme court today in an effort to escape a 75-year prison sentence imposed by Alabama courts for an alleged attack on a white woman.

The high tribunal twice had saved the negro from the death penalty.

In announcing denial of Patterson's petition, the court said Justice Black "took no part in the consideration and decision of this application."

That removed any possibility of a challenge of Black's position on the bench on the ground that he was a former member of the Ku Klux Klan.

Before adjourning for two weeks the court agreed to review an appeal by the Duke power company attacking constitutionality of public works administration loans and grants for publicly owned hydro electric projects.

Argument on this case was set for December 6, along with debate on similar litigation previously filed by the Alabama power company, which the court consented last spring to review.

In the Duke case the fourth circuit court of appeals sustained a \$2,000,000 PWA loan and grant to Greenwood county, South Carolina for an electric plant at Buzzard Roost.

BATTLE RAGES ABOUT TAZANG

Japanese Spokesman Admit Army 'Slowed Down' Near Shanghai; Experts Predict Invaders Will Take Breathing Spell to Bring Up Heavy Machinery to Nanziang Front

Shanghai, Oct. 25.—(AP)—Gen. Chiang Kai-Shek's Chinese armies stopped the Japanese offensive today after six days and nights of heavy fighting on Shanghai front.

The Japanese army spokesman admitted that the general Japanese advance of "more than 100,000 men" aided by tanks, planes and continuous bombardment was "slowed down."

Destruction of bridges, mining of highway and acres of barbed wire entanglements halted the Japanese assaults.

British authorities, as an aftermath of the slaying of a British soldier by a Japanese war plane yesterday, issued orders to all their defense posts to fire without hesitation in self defense against any airplanes.

Simultaneously British officials made two reports on the incident. Seven Americans and about a score of other foreigners were endangered yesterday when a Japanese plane sprayed machine gun bullets near the western edge of the international settlement.

Bitter fighting amid the ruins of Tazang, strategic communications point about five miles north of Shanghai, still was in progress. Japanese asserted they had occupied villages west of Tazang.

Foreign military experts said they believed the Japanese would take a breathing spell to bring up heavy artillery with which to attempt a new drive toward Nanziang, well to the rear of Chinese lines.

The experts said they considered Chinese defending Kiangwan, northwest of Shanghai, in a dangerous position because of the possibility of their being cut off by a Japanese advance on Nanziang.

It was asserted, however, that Kiangwan is of little military value and Chinese probably will withdraw from that sector as quickly as rear defense lines are strengthened.

Informed observers estimated 160,000 Japanese with superior mechanized equipment, planes and war ships were engaged against 300,000 Chinese.

After Japanese warships bombarded the Kiangwan race course with heavy damage to the club house and grandstand, Japanese infantry advanced from the civic center and asserted they occupied territory on each side, including the commercial university with its race course as a no man's land.

The Japanese naval spokesman asserted Chinese still were falling back in the vicinity of Nanziang, while Japanese airplanes strafed them from the air.

Agriculture Dept. Aids Yam Growers In North Carolina. Growers of Early Sweet Potatoes In Eastern Counties Saved From Heavy Losses.

Reflector Bureau. Raleigh, Oct. 25.—The State Department of Agriculture has cooperated with the Federal Surplus Commodity Corporation to assist growers of early sweet potatoes in Currituck and Camden counties, who would otherwise have been hard put to save themselves from severe losses.

Assistance to the farmers was lent through Harry T. Westcott, associate marketing specialist of the department, who worked with federal commodity officials. Inspectors from the state department did the grading and certification of the potatoes.

Through the F.S.C.C. a total of 2,232 bushels was bought and distributed through North Carolina, West Virginia, the District of Columbia and Maryland. This is the equivalent of 70 car loads.

MANY CASES IN BELGIUM HEAD POLICE COURT TO QUIT POST

Usual Monday Morning Charges Aired Before Mayor

Projected Resignation Presumably To Deny Charges

Brussels, Oct. 25.—(AP)—The semi-official newspaper Independence Belge said today that Premier Paul van Zeeland would design tonight.

The projected resignation apparently was connected with van Zeeland's desire to combat charges by Belgian fascists that he received while premier unwarranted payments from the National Bank of Belgium of which he was formerly an officer.

Van Zeeland went before parliament last month, explained that funds he received were a bonus to which he was fully entitled and won a vote of confidence in his government, apparently ending the matter which fascists charged constituted a "national bank scandal" and which Van Zeeland labeled a "scandal."

Today, however, the Independence belge said that the Premier's resignation would come tonight to permit him to "resume his freedom and accept responsibilities" as a private citizen, presumably in further combatting charges against his administration of the national bank.

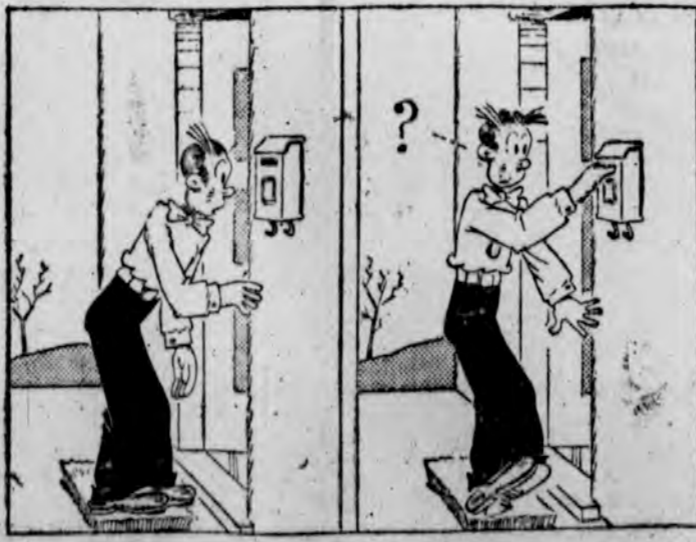

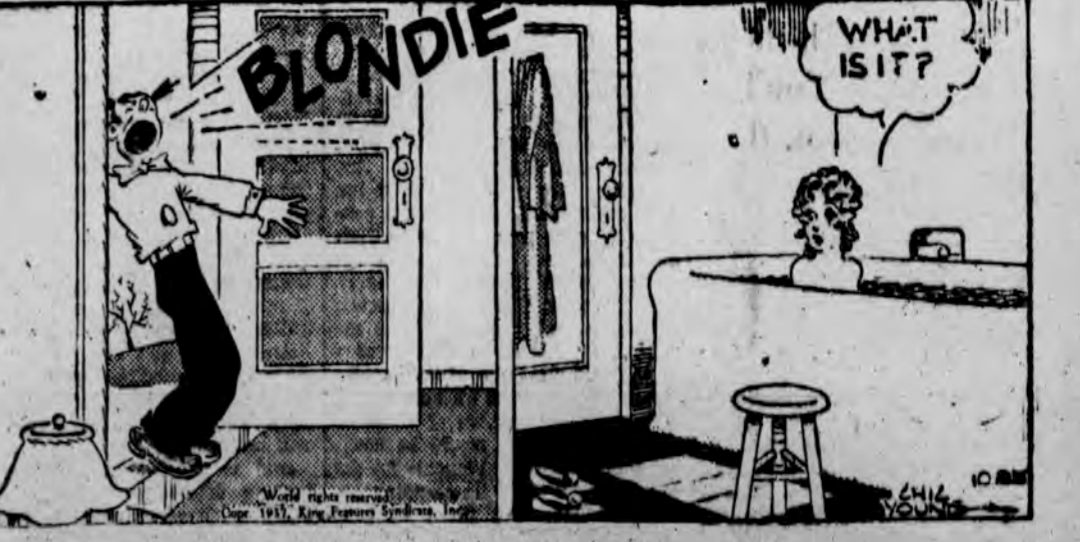

Tar Heels Start Work For Intersectional Game

Chapel Hill, Oct. 25.—North Carolina today started earnest preparations for its second outstanding intersectional football tussle of the 1937 season. The Tar Heels will meet Fordham's highly-touted Rams here next Saturday. New York University was beaten in the first intersectional test recently 19 to 6.

Fordham will be coming further south than it has ever been before. History shows also that the Rams have played one game out of its stronghold in New York City. That was in Boston in 1934.

Head football coach of the Rams is Jim Crowley. All-American half-back, whose grid exploits as a member of the famed 1934 Notre Dame Horsemen, are still ever fresh in the memories of American sportsmen.

Two of Mr. Crowley's three backfield playmates at Notre Dame couldn't get enough football in college so they are in the coaching business now. Elmer Layden is the head chief at Notre Dame. Harry Stuhldreher holds the head coaching strings at Wisconsin.

To date Fordham's record is most impressive. The Rams hold overwhelming victories over Franklin & Marshall (66 to 0) and Wayneburg (48 to 0). A scoreless tie with Pittsburgh. Rose Bowl champions last season. Is another high spot on the 1937 mark. The scoreless stalemate with the powerful Panthers is the third in as many years.

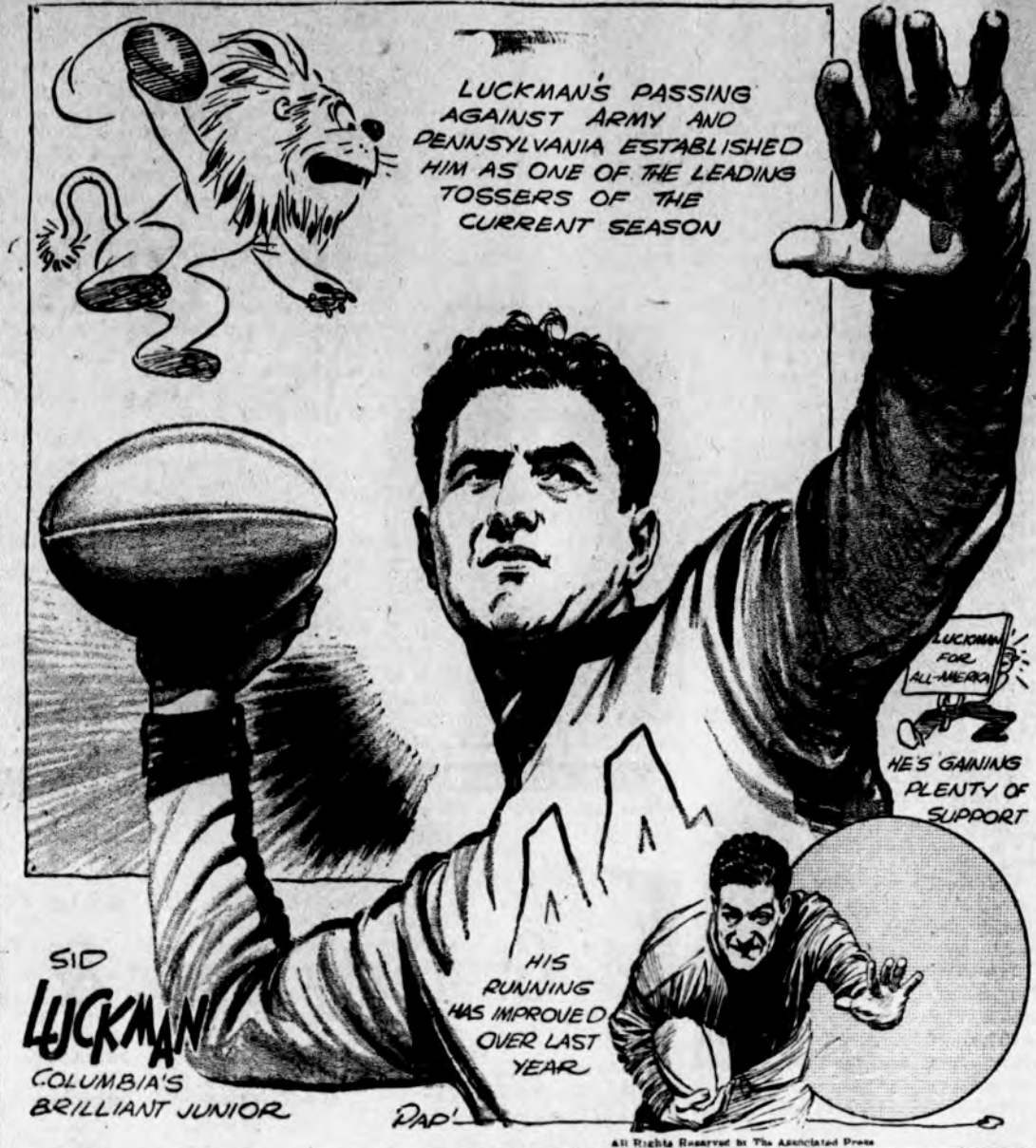

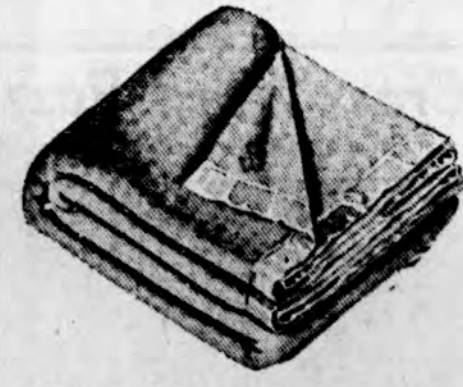

Raleigh, Oct. 25.—Every day or so something appears in publication of national circulation which answers the relatively few criticisms heard of the state's advertising program.

Latest is last week issue of the national news-weekly Time, the front cover of which is adorned with a picture of "Duke's Wade," depicting the Blue Devils coach lovingly hugging a pigskin.

Under the heading "Sports" Time gives a long review of the increasing strength of southern football teams, using the Duke-Tech battle of October 16 as something of a "theme song."

Anybody who thinks all this sort of publicity is spontaneous is exceedingly naive. It should be borne in mind that the state has already advertised in Time, and that it still has thousands left of the quarter million dollars appropriated for the purpose of making known to the world at large the outstanding points of the Old North State.

Returning from the Travel Tour worn to a frazzle, new men from Raleigh report that accompanying the caravan as it moved more or less majestically from one end of the state to the other was partly fun, but much more on the side of wearing, to say the least.

If there's anything on which the so-called experts don't give us advice, this correspondent would be glad to hear about it. Latest to emphasize this on our minds is Miss Ruth Currier, of State College, who has issued a release of one full page telling all and sundry how to decorate for Halloween.

Hard pressed for something to put in this column of brief items, this correspondent exclaimed in dismay: "I've got to find some shorts."

To which a bystander innocently (perhaps) remarked: "Why, I thought it was cold enough today for some jongs."

Officials of the U. S. Department of Agriculture's Farm Security Administration are trying to educate North Carolinians to the benefits of "community and cooperative loans."

Purposes of these loans are stated as: "To enable farmers to purchase equipment or provide services they are not able to purchase as individuals."

A conference of regional officials was held here the last of last week.

North Carolina's "quota" for adult education has been set at 16,876 by the WPA's national education Director L. R. Alderman. It is hoped that adult education under the department will teach at least that many illiterates to read and write.

To date 8,763 illiterate Tar Heels have been taught the fundamentals by the Adult Education program in which the WPA and the state board of education are co-operating.

Man About Manhattan

New York.—In an episode every bit as dramatic as any of the scores of dramas he has been identified with, Ray Henderson came to a violent, climatic death in Europe the other day.

The slender, affable representative of Katharine Cornell was flying from Egypt to Greece when his Imperial Airways plane plunged into the sea.

So it was with a strange sense of excitement that this department received, posthumously, this note from him:—It was a postcard from

"COME ON UP, THE AIR IS FINE"



Ball, Java, and he pictured a young girl with a basket of fruit on her head. With something akin to unconscious prophecy, he wrote: "This is one of the reasons why Ball is unsurpassable. To the glory of the Dutch it is still unspooled. The calendar has stood still a thousand years. I'd be content to do the same, but Miss Cornell's tour is progressing, and so must I."

Curiously enough, the first dispatch coming through identified Henderson rather anonymously as an "American traveler." This was an apt description, for he traveled incessantly. There is not a major hotel in America whose records do not include his signature. Nor is there any place in Europe or the Orient to which he had not been. Henderson always spent his summers in Europe. He especially liked Munich, where he went to listen to opera. He would travel any distance and go any place to hear opera.

This last was a sort of triumphal holiday-business tour for which Henderson had evidenced the keenest of pleasure. He was paving the way for the world tour by Miss Cornell in 1938. He went to Honolulu, and from there to Australia, then on into the Orient, after which he curled around to Ball. From there he traveled to Alexandria, and was then flying to Greece, with the goal in sight, when something went wrong and his plane fell into the sea.

Henderson, more than anything else, was your true traveler. He had few personal belongings, and in an hour's time he could pack for a trip to the end of the world. Broadway will remember, among other things, his unflinching cour-

tesy and his good manners. He was a press-agent purely because he would rather be a press-agent than anything else, and he brought to press-agency a sense of dignity which that slandered profession had never had.

He was also the most companionable of men, and he knew a tremendous loyalty. You could be talking with him in a bar, and if you inferred that Miss Cornell wasn't the world's greatest actress he would gently but firmly assail your lack of judgment.

We have in our files a note from him just before he left New York. It was attached to some information we had requested on Guthrie MacIntic, and it ended: "Well, I must be off. Au revoir in 1934." That was the day he left on that long, circuitous journey which took him, eventually, to Ball, where the calendar has stood still a thousand years.

highway contractors, if the President sets out to balance the budget by lopping off funds that have satisfied these groups for several years.

That will give you an idea what faces the average congressman. And you will have an idea, too, what will face the President when he sets out to convince the congressmen that they will have to make cuts in appropriations—and like it.

Interest Mounting

Add to that a bit of further cogitation. Lorrow the budget message aside for a few minutes and remember that the national debt is \$37,000,000,000—more than two times what it was six years ago. Now during these years of depression no reduction has been made in the national debt. Instead it has been increasing steadily. Interest on it in 1935 amounted to \$748,278,754. That is three-quarters of a billion dollars. Interest rates in 1935 were low. Recently they have been climbing slightly.

It is not inconceivable that the interest burden ultimately may exceed \$1,000,000,000 a year. In 1921 he computed rate of interest on the national debt was 4.3 per cent. It now fluctuates slightly, but is under 3 per cent. If the \$37,000,000,000 debt bore 4.3 per cent interest, that load would be about \$1,600,000,000—or nearly two times the 1935 outlay.

That means that if the government sets about to reduce the debt at the rate it did after the war, knocking it off at the speed of a billion dollars a year, several things must be done. First, \$695,000,000 must be raised to wipe out the current rate of deficit. Then the interest charge must be met. That may range from \$300,000,000 a year to two times that amount. Those two items sum up to a billion a year, or perhaps \$1,300,000,000.

Now add to that a billion dollars a year of debt retirement. That makes \$2,000,000,000 or more, depending upon the interest rate.

How To Raise Money.

There are only two ways to raise the money. One is to cut expenditures. That may mean fewer bridges and roads built back home, curtailed spending to help out the farmer, fewer warships, less relief spending, less of many things.

Another thing, generally agreed upon, is that it means more taxes. There may be more taxes in the higher brackets. But the treasury will tell you that taxing the big fellows won't raise enough money. Taxing the brackets between \$3,000 and \$50,000 a year brings in most of the money.

Your congressman may not get up nerve enough to raise taxes next year—what with an election coming on and budget cutting going on in the same breath. But either your present congressman or a braver one later may have it to do.

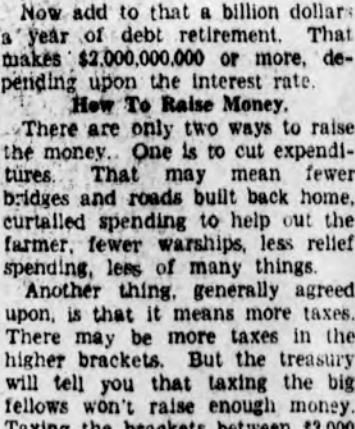
