JOB FACES CONGRESS

Italy Opposes Proposed Bans Against Japan

DEMAND MADE FOR SANCTIONS

Chinese Delegates Urge Action by the Brussels Meet

Brussels, Nov. 13.—(AP)—China's demand for what would amount to sanctions against Japan was dramatically opposed by Italy today in the Brussels conference seeking to end the Chinese-Japanese war.

The Chinese delegate, Dr. Wellington Koo, urged a conference decision to withhold war materials and credits from Japan and supply them to China.

This evoked immediate objection from Count Aldrovrandi-Marescotti, delegate of Italy, against which the league of nations decreed sanctions because of her invasion of Ethiopia and which has been Japan's friend at Brussels.

"That is entirely ruled out," said the Italian. "We are not here for that. It is entirely outside the scope of the conference."

Nevertheless the United States, Britain and French delegations presented the conference with the draft of a joint declaration stressing the illegality of Japanese military action in China and asserting (Continued on page ten)

Lambeth suffered a sprained ligament in his leg, but said it would not interfere with his attending the opening of the special congressional session Monday, although he and Branch abandoned their plans to attend the game.

CONCERN FELT OVER BUSINESS

Steps May Be Taken To Improve Economic Situation

Washington, Nov. 13.—(AP)—Congress will meet Monday to tackle unfinished farm and labor legislation in the special session already overcast by concern about the business outlook.

Although pledged to make crop control the first business, there were indications from some members that possible steps to improve the economic situation were uppermost in their minds.

Chairman O'Connor (D-N.Y.) of the house rules committee suggested Congress try to stimulate business by immediate tax revision. Many industrial leaders and legislators have contended the capital gains and undivided profit taxes were contributing to business recession and have urged their modification.

Speaker Bankhead, however, said tax revision was "too big a problem" for hasty action. He and other leaders went ahead with plans to stick to the legislation the President has asked: crop control, wage hour, government reorganization. (Continued on page three)

JAPS ARRANGE FOR SUPPLIES

Gun Boat Crosses Obstruction Across Whangpoo

Shanghai, Nov. 13.—(AP)—A Japanese gun boat successfully crossed the partly broken boom obstructing the upper Whangpoo river today after armed Japanese naval launches had swept the stream of mines, exploding several harmlessly.

The exploratory voyage up the Whangpoo and the trips of two other armed launches up the Soochow Creek indicated Japanese preparations to use both streams to transport military supplies to its armies advancing westward toward Nanking.

Japan declared officially they intended using Soochow Creek to transport supplies through the International settlement. Foreign defense offices avoided possible friction, recognizing the creek was an open waterway.

Restored quiet in Shanghai and Japanese naval plans to widen the breach in the boom to permit passage of destroyers up the stream was expected soon to make possible resumption of the waterway's normal traffic.

Japanese planes, widening their activities, bombed the railway station and warehouse at Ningpo and several concentration areas.

A number of fires were still blazing in Nantao, the native area. (Continued on Page Nine)

Agreement Reached Between Operators And Workers

New York, Nov. 13.—(AP)—Anthracite operators and mine union leaders today reached an agreement on their labor contracts, which expired in April. They had been conferring two days.

John Lewis, CIO chairman and president of the United Mine Workers of America, a conferee, said interpretations of existing contracts upon which both sides had been at variance, were now "clarified." He added:

Midnight, November 20, Deadline For Returning Cards Giving Local Unemployed Situation

W. W. Lee, chairman of the Citizens Committee to encourage local residents to cooperate in the federal unemployment census, declared today it was essential that cards being mailed to individuals be returned to the postoffice at once.

Midnight, November 20, is the deadline for returning the cards. Chairman Lee declared it was necessary that the cards be returned in order to provide an accurate estimate of the unemployed persons in this community.

Data gathered by the census is expected to prove of much benefit locally, in addition to providing the government with a true picture of the unemployment situation.

TARBORO ABLAZE

A Big Fire Raging In Our Neighboring Town

About 9:45 a. m. this morning the Daily Reflector received the following telegram from Tarboro:

The Bryan House is on fire, roof of building now falling in. It looks like the fire will be a serious one."

A few minutes later the following came:

"Fire spreading rapidly to adjoining buildings, business part of town seems doomed to destruction."

The Bryan House was a large frame building between two brick blocks in the heart of the town.

At 10:30 a. m., the telegraph wires burned down interfering with communications.

Capt. A. J. Griffin, chief of the Greenville fire department, notified Tarboro that Greenville was ready to serve them. However, the Rocky Mount fire department had already come to Tarboro's aid.

With the aid of the Rocky Mount fire department the fire was soon under control but not before a great deal of damage had been done.

The Morris Dry Goods Co., D. Lichtenstein Store, C. J. Austin Store, T. H. Gatlin's Store all were damaged to great extent. Hotel Farrar caught but was put out with only slight damage.

'Circus Night' At College

A large audience at the College Thursday night was conducted on a tour of circus grounds, including the parts where the public is not allowed, under the leadership of George Brinton Beal, author and "movie" photographer, who showed natural color moving pictures he had taken and gave a running comment on them.

This was the third number of the entertainment series.

The order and precision with which the circus is conducted, down to its smallest detail, seemed to impress the audience most.

Mr. Beal had caught the unloading of the huge wagons of the Ringling Brothers and Barnum Bailey circus, showing the difficult and dangerous jobs it involved for the man who, single handed, guided each big wagon by its tongue down the runway from the railway car, and the man, called a "snubber" who acted as a brake for the same wagons with a great cable which he had to keep unsharped and running smoothly for safety.

Only with every man doing what he was expected to do when he was expected to do it, said Mr. Beal, could that, and much of the other work of the circus, be done at all.

He pointed out how that precision made a circus able to move a regular town, 1700 or 1800 workers and performers, from place to place "without leaving a sliver behind" and without having confusion in the great mass of properties.

Mr. Beal said that elephants insist on picking up something in their trunks and so they are trained to keep in line with each one holding the tail of the one in front of him, to prevent their snatching things and people from the crowd.

The camel, he said, is the most vindictive and dangerous of wild animals in captivity. He kicks for

ward and in a circle, making a fatal wound.

Interviewed later, he added that if a camel gets a grudge against a person, he will kill that person on sight. But the keepers have learned how to manage this. They stuff some clothes of the person with straw and toss the figure to the camel. When the camel has beaten and torn the dummy to pieces, he is satisfied, and no longer pays any attention to the man himself.

His animal pictures were good.

He also showed the bareback riders, the trapeze artists, and other performers in action, and let the audience see how such performers begin to learn their difficult acts.

Mr. Beal is writing a book on circus life and circus people. Because of his great interest in "the big top" he has lived and traveled over the world with a number of troupes.

He is the only man ever to make authorized moving pictures of the inside of a circus.

HEALTH DEPT. REVIEWS WORK

Varied Activities Engaged in During Past Month

Dr. N. Thomas Ennett, Pitt county health officer, submitted to the Medical Society last night his monthly report on activities of the department, as follows:

"The major activities of the Pitt County Health Department for the month of October were: School health work, venereal disease clinics, maternal and infant welfare work, and hotel, restaurant and cafe inspections.

The statistics for contagious diseases for October are as follows: diphtheria, 12 cases; tuberculosis, 5 cases; measles, 1 case; scarlet fever, 1 case; whooping cough, 1 case; and no smallpox or typhoid fever.

The school health work is moving along satisfactorily; the principals and teachers are cooperating with the Health Department in a very fine way.

On Tuesday, November 9th, a venereal clinic was organized in Bethel. This clinic is conducted by the Bethel physicians and their service is on a voluntary basis. The Health Department furnishes the nursing service and drugs; the patients who are able, pay 25c per treatment; the money thus received is used to aid in the purchase of the drugs. Our next objective in the venereal disease campaign is to work out a plan for a clinic in Ayden.

The Maternal and Infant Welfare clinics and the Well Baby clinic are growing, but we still feel that we are not reaching anything like the number of expectant mothers we should reach.

The State monthly Orthopedic clinic, held every first Friday in the offices of the Health Department, continues to reach a large number of cripples.

The work in sanitation is being carried on energetically with special attention in the past month having been given to hotel, restaurant and cafe inspections.

One item of special interest from the standpoint of health education was the address of Dr. P. P. McCain, Superintendent of the State

Sanatorium, on Tuberculosis Control, November 4th, at the Greenville Woman's Club. This meeting was of special significance for the reason that it was sponsored by a lay organization, for, as you know, the control of tuberculosis is not so much a medical problem as it is a matter of lay education.

It would be a fine thing if the Parent-Teacher Associations and other clubs of the county would follow the example set by the Greenville Woman's club. In addition to tuberculosis, other public health problems of universal appeal are syphilis, cancer, heart disease, pellagra and malaria. Each of these diseases is of such importance to justify a mass meeting in each community of the county. The Health Officer offers his full cooperation in the arrangement of such meetings. Obviously, public health work can advance only as health information is brought to the public."

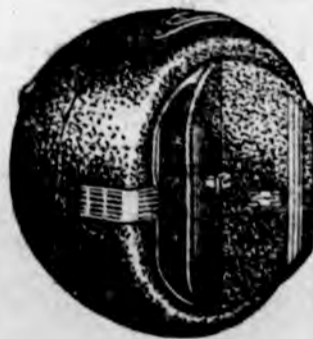

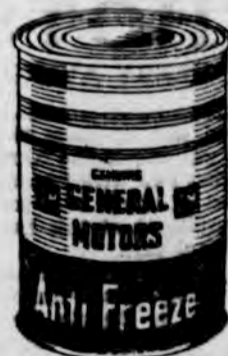

DIXIE HIGHLIGHTS

SLAVERY FORCED ON GEORGIA
THE TRUSTEES, HEADED BY GENERAL JAMES EDWARD OGLETHORPE, ORIGINALLY EXCLUDED SLAVERY FROM GEORGIA. LATER ECONOMIC PRESSURE COMPELLED ITS ADOPTION



The purpose of the trustees of Georgia, to whom a charter was granted June 9, 1732, was to establish a haven for debtors and to create a permanent class of small landowners. Although flourishing in every other colony, negroes and slavery were banned in Georgia under heavy penalty by the law of 1735, which was introduced in parliament by OGLETHORPE himself. In making Georgia unlike her neighbors, however, the trustees had imposed ideals that were destined not to last. Parliament, favoring England's profitable slave trade, was granting no favors and making no further appropriations to a colony prohibiting it! When Georgia did not prosper, as anticipated, it was blamed by slavery advocates to its exclusion. Settlers deserted Georgia for more favored colonies and petitions were

widely circulated. Under heavy pressure, the trustees finally yielded and the slave trade was admitted by law in 1750. Georgia, accordingly, relinquished her unique position as the only original free English-American colony.
In the autumn of 1765 the famous botanist, JOHN BARTRAM, stood on the banks of the Altamaha River in Georgia. While waiting to be ferried across to the opposite shore, he noticed a certain small spreading tree with dark green foliage. This was the *Gordonia Alatamaha*, or Franklin tree, from which all such existing plants are descended! Strange to say, no *Gordonia Alatamaha* other than the one Bartram discovered or its descendants has ever been found again in Georgia or any other part of the world.

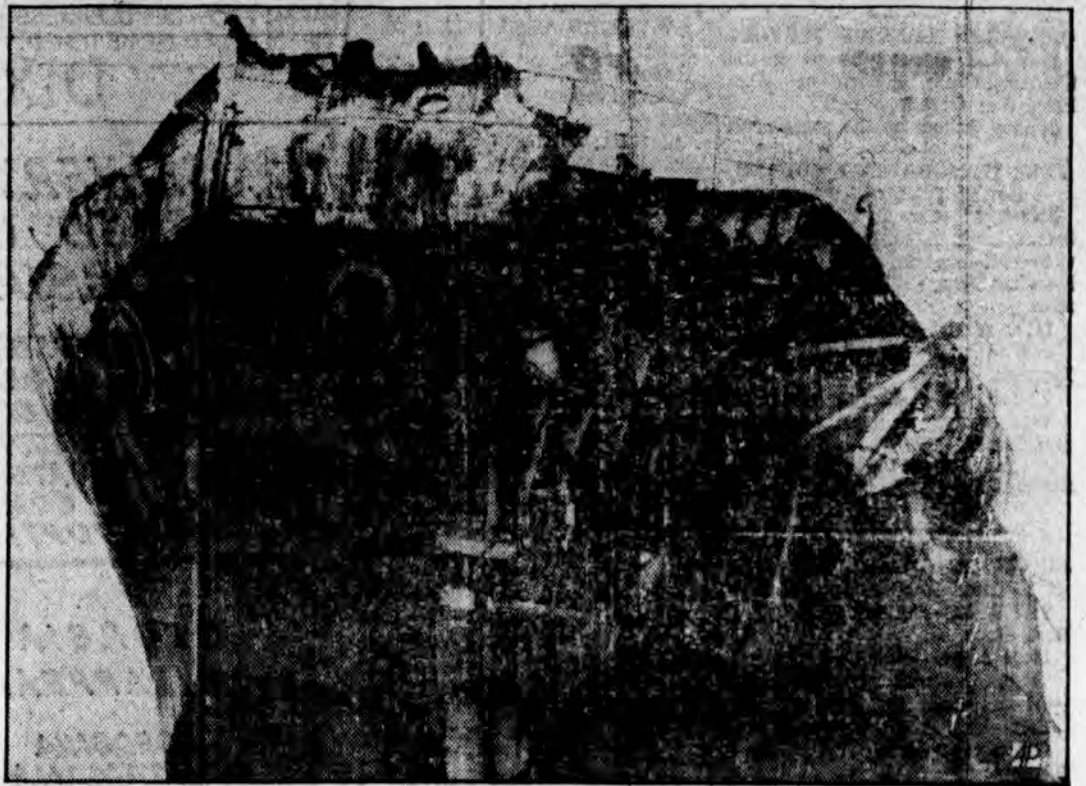

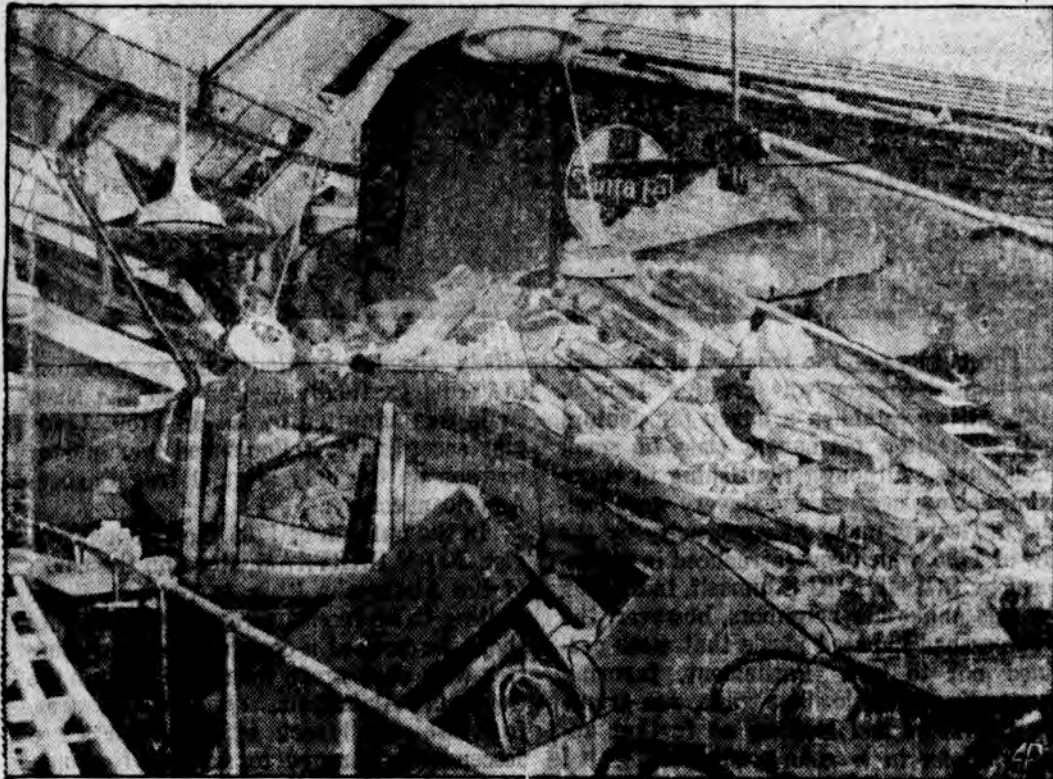

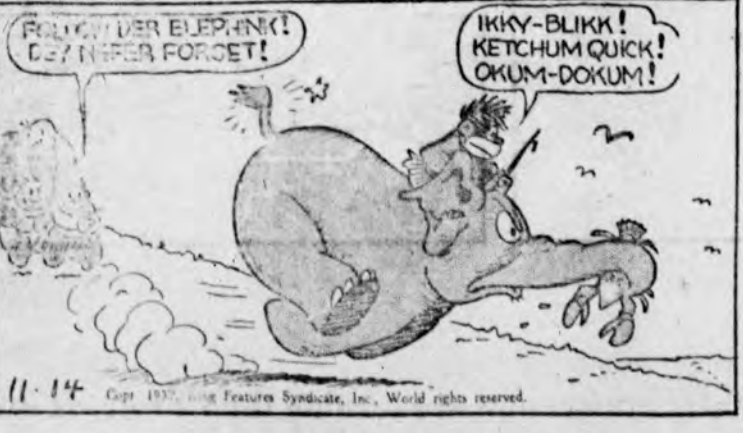

STATES JAPAN SEEKS OUTLET

Duke Professor Talks On Far Eastern Situation

Chapel Hill, Nov. 12.—The suggestion would probably be regarded in most quarters as impractical, but it would be a fine thing if a commission composed of representatives of neutral countries could be appointed to take over the government of China temporarily, with the view to bringing order out of chaos, Dr. E. E. Ericson of the University English Department told the Chapel Hill Rotary Club in an address at its meeting this week.

Dr. Ericson based his observation on a study of conditions in China during several months he resided there while teaching in the National Central University in Nanking in 1935.

He said he doubted whether Japan would take over much Chinese land, if winner in the present war, but he thought the Japanese would insist on some sort of control of China that would rebound to the benefit of Japan.

The situation in a nutshell, he said, is that Japan has a dense population crowded into a small territory. The nation is highly developed and efficient, with the best in machine technic and no labor troubles. The productivity is tremendous, and yet Japanese products have been shut off by high tariff walls almost everywhere. This state of affairs has forced Japan to the conclusion that China is the natural outlet for her products, Dr. Ericson said.

"There is little danger of our country boycotting Japanese products," Dr. Ericson said. "For one thing, such action most likely would have serious repercussions in our business world. Japan takes more than 50 per cent of the cotton we export, and we get much of our silk from that nation." Dr. Ericson described in detail the historical background for the events leading up to the present Sino-Japanese crisis.

National Service Lends Assistance To Game Division

Game Refuge Area Leased Without Cost for Period of 10 years From Forest Service

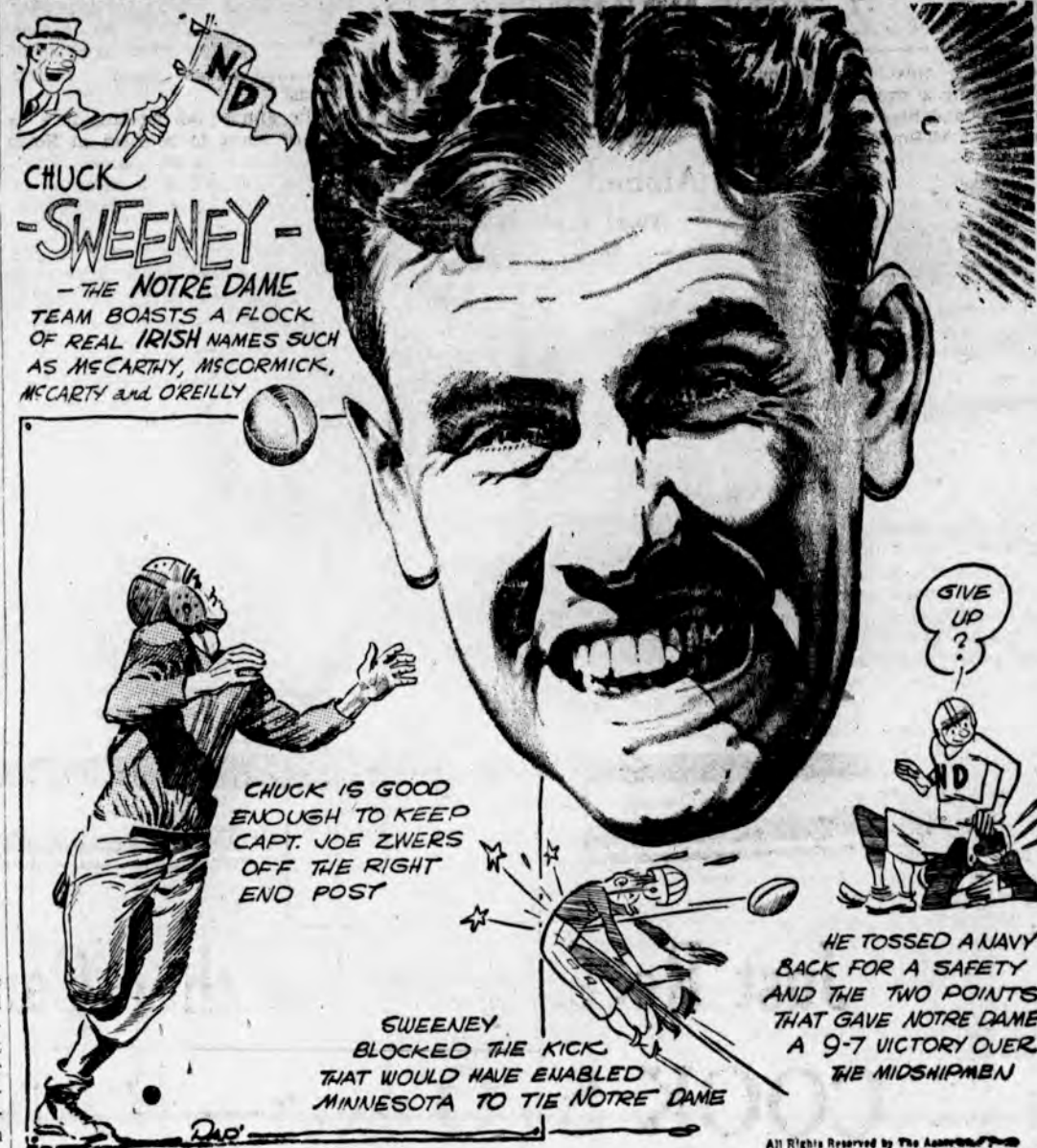
Raleigh, Nov. 12.—Much valuable assistance is being given by the National Forest Service to the game and inland fish division of the Department of Conservation and Development in its administration of the various game refuges, now being operated on a cooperative basis with the forest service, according to C. N. Mease, chief game protector. The game refuge areas have been leased by the state for ten years without charge from the National Forest Service and are located within national forests.

"While all law enforcement with in these game refuges will continue to be done by the game and inland fish division of the Conservation Department the National Forest Service is cooperating by providing roads, trails and mechanical equipment for development and maintenance of these areas," Mease said. "It is also building houses for our game protectors. Three houses are now being built, one each on the Mount Mitchell, Daniel Boone and Sherwood Forest refuges and others will be built soon."

In addition to making all forest service roads and trails available to the game protectors and rangers who patrol and refuges, many miles of new trails will be built along the trout streams and around the refuges, Mease said. Formerly, the state game protectors had to cut out their own trails. In addition, the foresters of the National Forest Service as well as the men in the fire lookout towers are cooperating by listening for dogs or poachers and reporting them to the game protectors.

F. Kelleher, whose father won monograms with Rockne; John McMahon, sJoe Zuendel and Charlie Theisen.

Among the "combinations" are: H. J. Burnell, French-Irish; Harvey Foster and Ben Sheridan, Irish-English; Chuck Sweeney and Thad Harvey, Irish-Scotch; Bill Hofer, John Kelly, who has a swiss father and a Scotch

SEES IMPROVED EGG BUSINESS

Farmers Can Expect Better Returns From Poultry

Raleigh, Nov. 12.—North Carolina farmers can expect improvement in several phases of the poultry and egg industry in 1938, according to C. F. Parrish, State College extension poultryman.

Basing his prediction on the annual outlook report of the U. S. Bureau of Agricultural Economics, Parrish pointed out that there will be a more favorable relation of feed prices to egg prices in early 1938 as compared with early 1937, and an increase in the spring hatch as compared with the spring of 1937.

Heavy production of broilers this fall and winter was forecast, but the Bureau said that prices will not be "correspondingly depressed" since there is a small supply of other meats.

Indications are that the size of laying flocks will reach "a cyclical low point in 1933," that "the rate of egg production per hen in 1938 is expected to be less than in 1937" and that "egg marketings are expected to be less."

Parrish stated that higher egg prices than in corresponding periods this year were forecast and higher prices for chickens in the first half of 1938 as compared with the first six months of 1937.

The Bureau also estimated a 10 per cent decrease in turkey production this year over last, and said that turkey prices are expected to be higher this season.

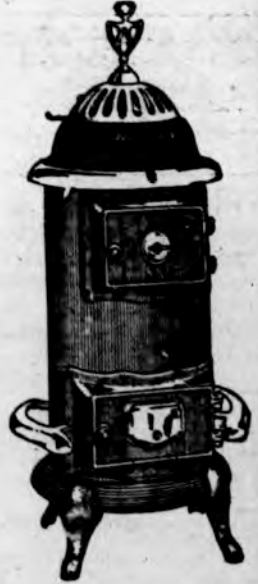

Wade Marr Speaker at Inter-City Session at Woman's Club

Sounding a keynote of idealism, Wade Marr of Elizabeth City, former District Governor and former International Director of Rotary, last night addressed approximately 260 Rotarians and Rotary Anns assembled in the Inter-City meet at the Woman's club.

Mr. Marr asserted Rotarians were often accused of being sentimentalists or idealists, but from personal observation, he stated he had found that permanent achievements of real worth were the results of idealism. "As Allen Streak, whom I hope to see as the next president of Rotary International, and I stood by the tomb of Napoleon," he said, "we were more than ever impressed by the differences in ideals. Napoleon lived selfishly for his own ambition. His was an ideal of destruction. On the other hand we saw the idealism of Christ, an idealism of unselfishness."

"There is a picture of writhing bodies, agonized faces for one; children bending on knees in prayer the other," he pointed out. Only by holding fast to ideals can

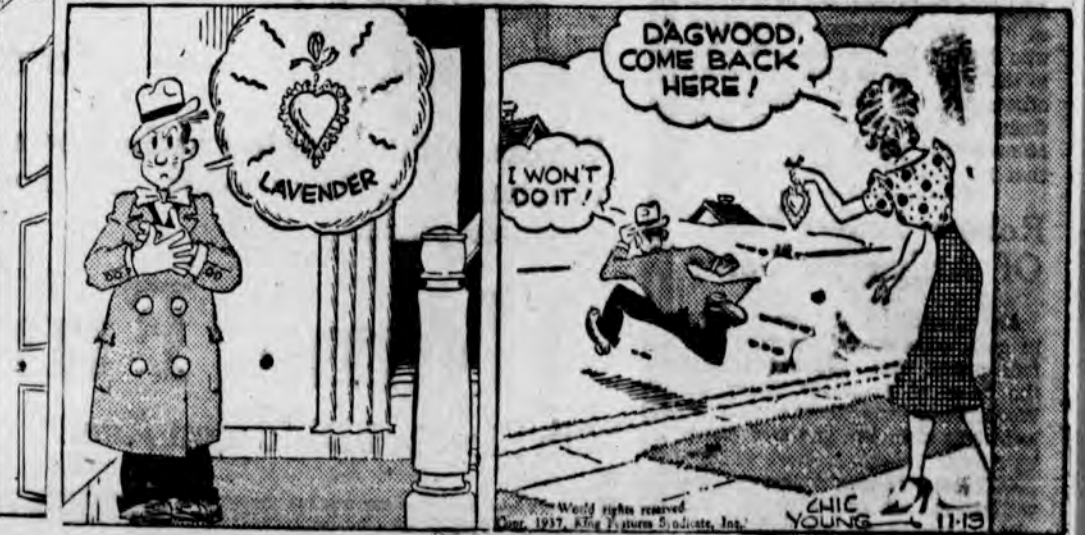

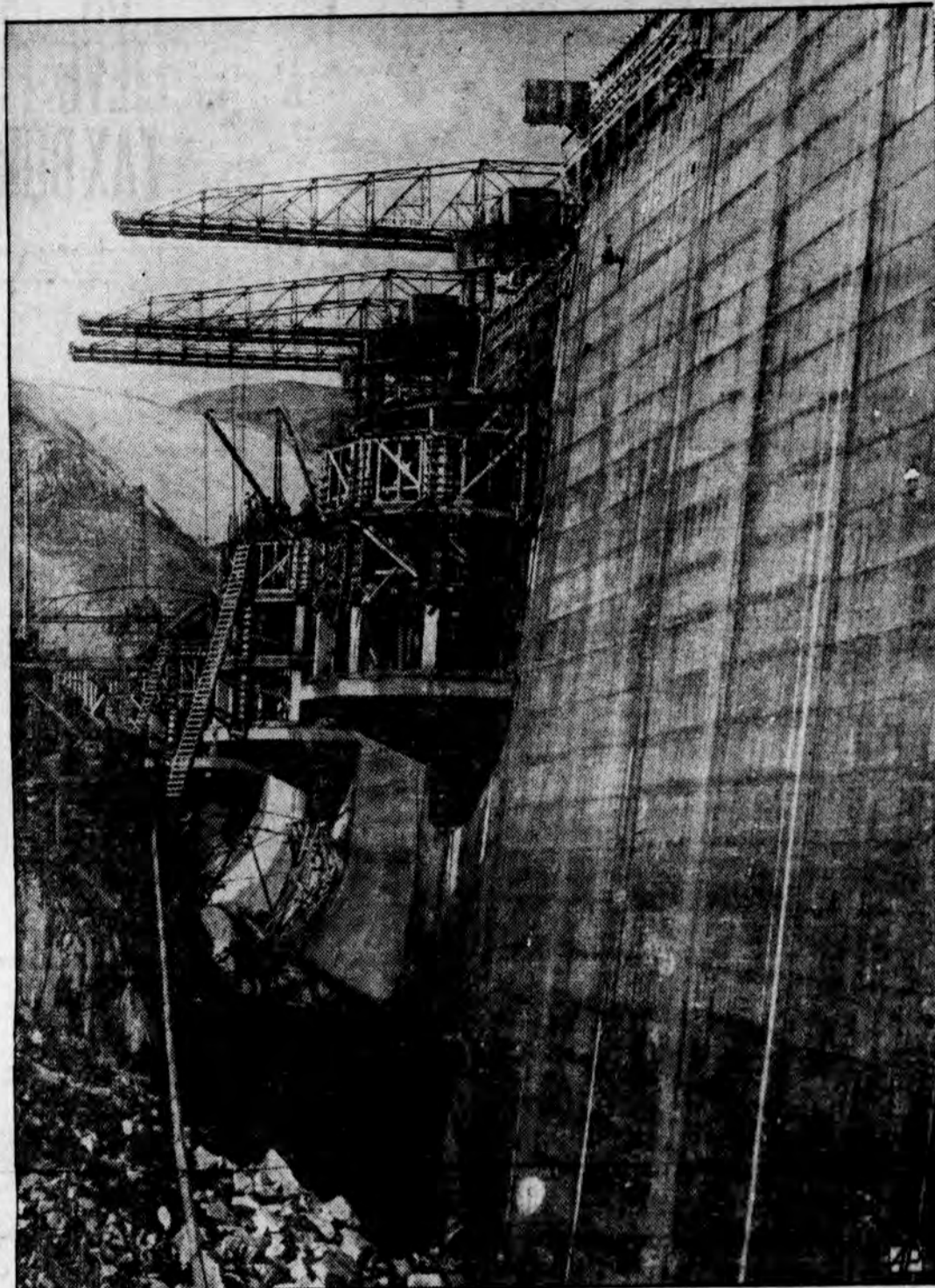
