

Congress Almost Ready To Start On Crop Control

WORDY DEBATE FILLS HOUSES

Word Comes From House Committee, However, that Farm Proposal Will Be Ready "Certainly by Tomorrow"; Senate Already Has Bill Ready For Consideration

Washington, Nov. 22. (AP)—Congress was ready almost to get down to work today on crop control legislation.

Both Senate and House continued the same sort of wordy debate that produced no action during the first week of the special congressional session, but the Senate had a farm bill to start on tomorrow.

A weary House sub-committee also wound up its discussions over an agriculture bill to establish an ever-normal granary and stabilize farm prices.

Majority Leader Rayburn (D-Tex.) said word from the committee was the legislation would be ready for the House by tonight, "certainly tomorrow." He predicted debate would begin by the end of the week. The measure drafted by the Senate Agriculture Committee had no revenue raising provision, but committee members said it complied with President Roosevelt's demand not to increase spending without compensating taxes.

Senator Pope (D-Ill.) said the final draft could hold costs within the \$500,000,000 already budgeted to the farm program. Some other members disputed this. Vice-President Garner, Speaker Bankhead and Majority Leaders Barkley (D-Ky.) and Rayburn of the Senate are House, meantime conferred with the President on speeding up legislative action.

Other developments: The President, on advice of physician and dentist, cancelled his Thanksgiving trip to Warm Springs, Ga., but made plans to go there and to the Florida coast on a fishing trip when he regains his strength. The Labor Relations Board won a Supreme Court review in its effort to enforce an order directing the Pacific Greyhound Lines, Inc., to withdraw all recognition from a labor organization it allegedly formed and dominated. No written opinions were delivered at this brief session before the court adjourned until December 6.

Chairman Relates Facts Pertaining To Seal Campaign

Large Per Cent of Funds Raised Through Sale of Christmas Seals Retained Locally

In connection with the Christmas Seal Sale Campaign, Wyatt Brown, Publicity Chairman, released the following facts today.

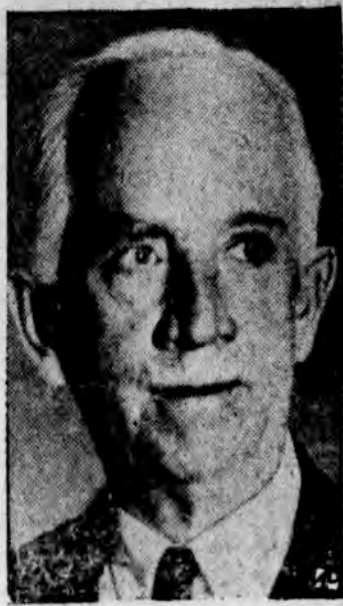
With reference to the proportion of the funds retained locally and the ways in which these funds are used in the control of tuberculosis, he calls attention to the fact that not only 75 per cent of the actual funds raised is retained locally, but a large part of the funds sent to the State and National Tuberculosis Association is returned to the community in the form of Seals, Seal Sale supplies and annual tuberculosis clinics. These clinics are held every spring in Greenville, Farmville and Ayden and are conducted by a state specialist in tuberculosis at no cost to the community. This means that practically 85 cents out of every dollar raised is used at home in the control of tuberculosis.

He also revealed some of the ways in which the money is used in Pitt County. Among these ways are: Providing milk for all cases of tuberculosis who are unable to do so themselves.

Providing milk, especially for children in tuberculosis homes. X-ray, for diagnosis. Pneumothorax treatments (Compressing the lung with air, thus giving the lung rest and a chance to heal).

Tuberculin tests, especially for children. Free Sputum cups. Transportation to and from the Sanatorium. In reciting these control measures (Continued on page six)

Anxious To Sail

NORMAN DAVIS BUSY ON DRAFT

Works With British Delegate to Brussels Parley

Brussels, Nov. 22.—(AP)—United States Ambassador at Large, Norman Davis and British Delegate Viscount Cranborne worked today on the draft of a new statement on the Chinese-Japanese conflict which may bring the Brussels conference to a close.

The document under discussion still must gain approval from French delegates who originally planned to return to Brussels Saturday, but put off their arrival until noon today.

In these circumstances postponement of this afternoon's meeting remained a possibility up until the last minute. A protracted delay was regarded as unlikely, however, since Davis was understood to be anxious to sail for the United States Thursday and British delegates want to get back to London.

The statement prepared by British and American delegates was a historical record of the conference's efforts to obtain peace in the Orient. It was understood to include nothing that could be construed as effective aid to China.

Conference delegates virtually admitted none of the nations represented at the meeting was in a position to take effective action to halt the Chinese-Japanese conflict.

GRANGE SEEKS EQUALITY FOR U. S. FARMERS

1938 Platform Just Released by National Organization

LIMITED IMPORTS ONE SUGGESTION

Statement Sets Forth That American Markets Should be Restored to Farmers

Harrisburg, Pa., Nov. 22.—(AP)—The National Grange announced today its 1938 "platform for agriculture," based on conclusions reached at the organization's recent 71st annual meeting. The platform included: 1—The American farmer is entitled to equality of opportunity and to a fair share of the national income.

2—There must be no legislation enacted which would result in either immediate or eventual regimentation of the American farmer.

3—The American market should be restored to the American farmer to the limits of his ability to produce efficiently; there should be no curtailment of crop production that would place him at a disadvantage and imports should be limited to those things which he can not supply; agriculture should be given equal protection with labor and industry under the tariff and those reciprocal trade treaties which are harmful to the farmer should be repealed.

4—The soil conservation service should be continued to help the farmer improve his land and diversify his crops, but it must not be used as a means to production control.

5—For those crops of which there are exportable surpluses and for which marketing agreements are undertaken the program should be adopted only after a vote of farmers affected and complete control should remain in their hands. Reasonable commodity loans should be made available to assist orderly marketing.

6—The family sized farm should be protected, in soil conservation benefits and taxation, on the same principle that provides basic exemptions for small income and bases taxation upon ability to pay.

Pontiac Strikers Leave Body Plant

Pontiac, Mich., Nov. 22.—(AP)—Strikers who had held the General Motors Fisher Body plant here since Wednesday evening, marched out at 11:30 a. m. today, led by Homer Martin, international president.

Martin, who entered the plant at 10 a. m., said when he emerged the strikers voted unanimously to evacuate the plant.

He said he would try to open negotiations on grievances which caused the strike.

Martin announced this afternoon Willard Hotchkiss of Chicago, former president of the Armour Institute at Chicago, would come to Pontiac tomorrow to arbitrate the strike issues. The strike, which began without warning Wednesday when a few hundred members of the night shift refused to work because the company insisted upon the suspension of four men which it blamed

for a previous unauthorized strike ended just as unexpectedly. The men had refused to heed appeals from the international offices and of the international executive board which was summoned into emergency session yesterday by Martin. The board recessed at 9:30 a. m., until 3 p. m., after issuing a statement describing the strike as "unauthorized and unsanctioned."

The statement came after 23 hours of almost continuous conferences. Although one striker guarding an entrance to the plant said the men "would turn a fire hose" on Martin if he should appear, Martin and his secretary, Miss Vivian Fox, went directly to the plant in a taxicab from the board meeting. Leonard Netzorg, Detroit U. A. W. A. attorney, who accompanied them into the plant, said he understood the strikers had invited Martin to appear before them.

SENATORS GET GROUP HONORS TOBACCO BILL

Proposes Regulation Through Marketing Quotas

Washington, Nov. 22.—(AP)—A tobacco control provision identical to the plans drafted by tobacco states representatives in Congress went before the senate today as a part of its agricultural committee's new farm bill.

Incorporated in the bill by Senator Elender (D-La.) it proposed regulation through marketing quotas in years the agriculture secretary determined a surplus existed. It would be applicable to flue cured, fire cured, air cured, burley Maryland, cigar filler and cigar binder types of tobacco.

Control would be compulsory in the event two thirds of the growers approved quotas in a referendum. A fifty per cent penalty would be imposed on tobacco sold in excess of quotas. The agriculture secretary would determine on each November 15 whether a surplus existed. On (Continued on Page Six)

What It Means: SOUTH AMERICAN DICTATORSHIPS

By MORGAN M. BEATTY AP Feature Service Writer Washington—The news that Brazil has joined the growing list of Latin American dictatorships has brought home to official Washington generally a fact that has long harassed the state department's inner circle, namely:

Radio waves are constantly undermining the Monroe Doctrine—our time-honored barrier against European political systems. (In case you've forgotten, President Monroe told European nations 114 years ago that he would keep hands off Europe, and yet the Doctrine is not being violated. Any nation may broadcast information and entertainment.)

Meanwhile, South Americans are growing more and more familiar with fascist and communist European radio stations—especially German, Italian and Russian—have been broadcasting news and entertainment programs to Latin Americans in their own languages for several years.

These broadcasts naturally reflect fascist and communistic systems in a highly favorable light and constantly use labels and terms that go with those systems. Some South American newspapers pick up this information daily and re-distribute it in printed form.

JAPAN ADVISES CHINA GENERAL TO SURRENDER

Message Dropped Over Nanking By Japanese Plane

CHINESE ENGAGE FLIERS IN FIGHT

Airmen, Apparently Checking China's Remaining Strength, Taken by Surprise

Shanghai, Nov. 22.—(AP)—Japan urged General Chiang Kai-Shek today to surrender.

A message was dropped to him by Japanese airmen making their first flight over Nanking since the government announced its transfer of the capital to Chungking about 1,000 miles further inland.

No bombs were dropped, only the message urging cessation of hostilities. It was released from a plane flown by one of Japan's ace pilots.

Chinese pursuit planes attacked the Japanese fliers, nevertheless, engaging them in spectacular dog fights over Nanking. One Chinese plane crashed.

The Japanese airmen apparently trying to determine the strength of the remaining Chinese air forces were taken by surprise. The aerial defenses, however, including little anti-air craft fire which was interpreted as a possible indication some batteries had been shifted to Chungking and Hankow to protect the new government headquarters in these cities.

The new Chinese fighting craft resembled their Japanese foe more than the types of Chinese planes seen until now.

The mysterious message "advised" Chiang to end China's resistance and surrender himself to the Japanese. A Japanese spokesman acknowledged a "personal message" had been dropped at Nanking, but would not disclose its text.

SURETE SEEKS CRUSH REVOLT

Pretender to Throne Denies Decision To "Reconquer" Power Has Any Connection With Present Revolt of Revolutionary Organization Now Under Investigation

Paris, Nov. 22.—(AP)—In the midst of police efforts to crush an armed revolutionary organization the Duke of Guise, pretender to the throne of France, issued a manifesto today announcing he had decided to "reconquer the throne of my fathers."

The Duke's son, the Count of Paris, immediately denied his father's act had any connection with the Cagoullards, or "hooded ones." He insisted it was a mere coincidence the manifesto was issued while the secret organization was being investigated.

Swiss police, however, thought differently. The count had been expected to issue his father's statement last night at a meeting of royalists at his villa in Versoix Switzerland, but Swiss police banned the meeting and "invited" him to leave the country.

Summary of Book Week

Once it was called Children's Book Week. Young people and adults objected because the whole family were reading. Then for a year or two the phrase "Good Book Week" was used. Finally it came to be known as Book Week, a simple easy term that is probably here to stay.

Why observe Book Week? Even the best of us need to be reminded of the value of reading the wisdom in the books which are waiting to be read. Children have entered the schools and ready for forming reading habits. New people have moved into the community and need to be invited to join the reading groups. These are some of the needs met by this yearly Book Week.

This effort to bring together the reader and the book. Who is interested in this week of reading publicity? All of us, publishers, book sellers, librarians, teachers, book scout leaders and others. About 10 per cent of the books borrowed during the other days of the week went to rural readers. The total figures for the week are as follows: Monday 220; Tuesday 198; Wednesday 215; Thursday 208; Friday 301.

In Friday's circulation figures were included 155 readings of books which had been loaned to teachers in the Bethel school. Nine other schools in the county have books out on this same plan at this time. Practically everybody who came into the library looked over the display of new books, and posters. He is being brought to Greenville by Dr. Lucile Turner of the college faculty, and Rev. Wm. A. Ryan of the Christian Church, and Rev. R. C. Grady of the Presbyterian Church, local members of the Fellowship.

In a letter of invitation issued by the local members to a group who through various means have designated their interest in the cause of Christian pacifism, it is stated that Mr. Nelson "will speak to us on the work of this movement. We hope it will be possible

(Continued from page one) Ideas and labels, such as "the corporative state," "centralized control," "economic expansion for the state," and the like.

One unofficial authority in Washington, who is in a position to analyze first hand reports from South America, puts it like this: "The fact is that the South American nations commonly labeled fascist are not fascist in the Italian sense; nor is the Latin American group that bears the communist stamp communistic in the Russian sense, South American dictatorships now are what they always were—minority groups or strong arm leaders controlling nations with the aid of armies."

Here's where the rub comes: United States officials—and many business men, for that matter—fear that the constant use of the political language and labels of Europe ultimately may lead South American nations and the world at large to believe communism and fascism of the European variety actually have taken root right at our own doorstep.

If that should occur, then these ticklish questions would have to be answered: **Ties Still Strong**
Would European fascist and communist nations be able to gain an economic perch in South America at the expense of the great democracies? And, more important, would such a movement finally force the United States either to defend the Monroe Doctrine or cease to consider it as a matter of foreign policy?

Only the future can tell, but for the time being it can be said on reliable authority that the economic ties between the United States and South America are holding fast. Brazil, the latest South American nation that has reverted to dictatorship, has taken pains to assure the United States that it has not gone fascist, contradictory as that may seem. Likewise, Argentina's President Augustin P. Justo reminded the "fac" of his country recently that "a natural economic ties were with two powerful democracies, Great Britain and the United

VIRGINIA GAME THANKSGIVING

Contest Still Ranks Ranks Tops in Minds Of Oldsters

Chapel Hill, Nov. 22.—For most of the oldtimers among the alumni the Carolina-Virginia Thanksgiving game is still the game of the year.

Every year about this time the coaches get letters from these ardent and enthusiastic supporters imploring them to apply pressure and try to equal or better the 66-0 high score made by Virginia in 1918.

These older alumni members well recall the streak of lean years—from 1905 to 1916—when they journeyed to Richmond year after year only to see the Tar Heels lose by close margins or bitter one-sided decisions.

Undismayed by successive defeats, they went to Richmond in increasing thousands each year, cheered themselves hoarse, and gave the University teams as fine support as it has ever received.

Finally in 1916 the Virginia domination was broken—that is, for the time being.

An inspired Tar Heel team upset the favored Cavaliers that year 7 to 0, midway of the third period when the game had all the earmarks of a scoreless tie. Bill Folger, sophomore halfback, broke off his right tackle for 52 yards and touchdown. The Tar Heels fought off two Virginia threats. Their alumni was jubilant.

The present football regime is strikingly similar excepting that Virginia has been going through the lean victory period. Only once since 1926 has a Virginia eleven beaten a Carolina team. That was in 1932 when the Cavaliers upset a favored Tar Heel team at Charlottesville, 14 to 7.

Prior to 1927 Carolina had won only 3 games, lost 20 and tied 3 in the Cavalier series. The records now give the Tar Heels 17 victories to 21 defeats and 3 stalemates.

The 1937 Cavaliers are an improvement over the 1936 edition. Under the able guidance of Coach Frank Murray, who turned out some of the best teams in the country at Marquette, Virginia played excellently against Navy, Maryland, Hampden-Sydney and William and Mary. The Cavaliers performed in mediocre fashion in other games. They will be striving for an encore in the Navy and Maryland performances. If they reach these pinnacles, the jinx may be broken.

Tobacco Likely To Bring N. C. Farmers Record Sum

Raleigh, Nov. 17.—North Carolina tobacco growers seem certain to receive a record-breaking sum from the third largest crop of the golden weed they have ever produced.

Based on the State Department of Agriculture's prediction of a crop of 577,190,000 pounds and the same department's October average price, 27.96 cents per pound, this year's crop will bring a grand total of \$161,382,324, approximately \$7,500,000 more than was brought by the 1919 crop, which sold at an average of 49 cents per pound to bring a return of \$153,898,172.

In October sales, Wilson of the New Bright Belt, led in volume as its many warehouses sold 30,386,393 pounds at an average of 30.20 cents per pound. The highest average price in the state was paid at Farmville where 8,656,884 pounds were auctioned at an average of 31.07 cents per pound.

In the Old Bright Belt Durham had the largest volume, 16,044,730 pounds and highest average, 28.49 cents per pound.

In the Border Belt, which opened before any other in the state, most warehouses had closed before the opening of October and only the tag ends of the crop were sold at Farmington, Lumberton and Whiteville.

In sharp contrast to the comforting figures for North Carolina farmers revealed by the tobacco reports of the Department of Agriculture stood the market price of cotton, which was so low that even with a near-record crop of the staple in prospect, the farmers will not get rich on the returns.

The estimated crop of 720,000,000-pound bales, if sold on today's 8-cent market would bring in all \$28,800,000. Under existing regulations farmers can under certain circumstances borrow 9 cents per pound from the government, a figure which would yield them \$32,400,000.

DUKE TO MEET PITT PANTHERS

Eastern Rose Bowl Contenders at Durham Saturday

Durham, N. C., Nov. 22.—Those terrific and terrifying Panthers of Pittsburgh—named by all the experts as one of the greatest football machines ever produced, a fact that the Pitt folks admit themselves—will strut their stuff in Duke stadium Saturday against Wallace Wade's Duke Blue Devils.

On the spot in every game this season with every foe pointing for that game alone, the Panthers have smashed along with sheer force, throwing a great second team into action when the regulars tired. The folks at Pitt rank their second eleven barely under the first.

It will undoubtedly be the greatest football team ever to appear in this section. The Panthers have reaped reams of publicity this season with their brilliant and thrilling exploits which have been led by one of the nation's greatest backs of all time—Marshall (Biggie) Goldberg.

It will be the first trip south for a Pitt team since 1929 when they met the Blue Devils in Duke stadium dedication game and ran up an overwhelming 52-7 victory. This year's team is rated far superior to the 1929 Panther outfit which later played in the Rose Bowl but Duke followers are hoping that there will be no such recurrence of that massacre of '29.

It is hard to make a review of the Pitt team of 1937. They have two good men for every position and three for some posts. Coach Jock Sutherland gives credit to that second team for Pitt's ability to pull games out of the fire in the final period as they did in those fourth period triumphs over Notre Dame and Nebraska—two teams which are among the nation's best.

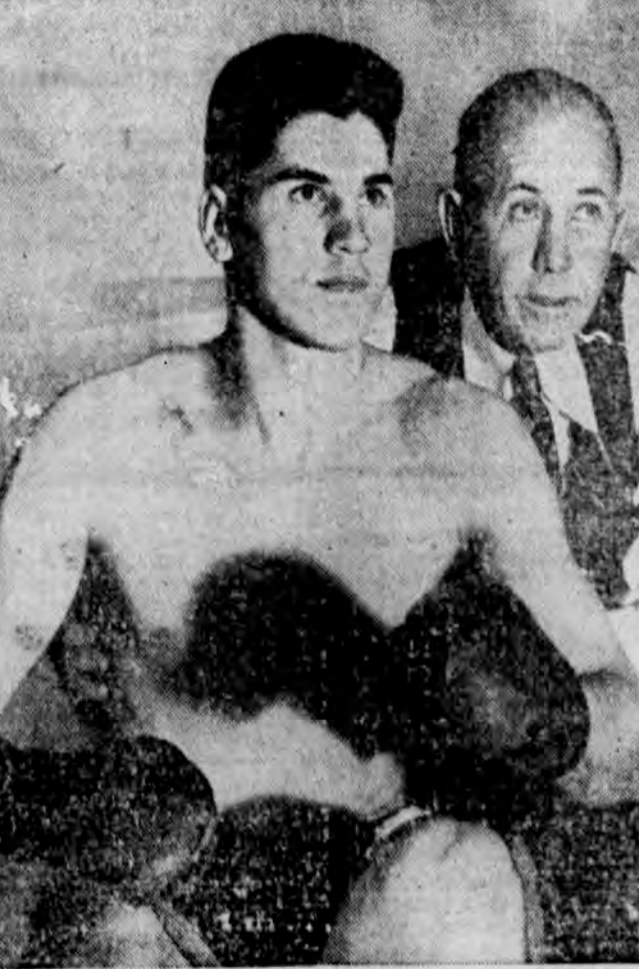

Detroit (AP)—John Leo McKernan is doing well again, thank you. Better known as Jack Kearns, the man who made and tossed away a cool two millions while managing Jack Dempsey and Mickey Walker, is earning a good income as a boxing promoter here.

Less than a year ago, Kearns came to Detroit and broke after 25 years in the fight game. The boxing business in Detroit was almost as flat as Kearns was. Several "angels" who had tried to revive it had only sad experience and thin wallets for their efforts.

Perhaps it was improvement in business conditions or the Kearns magic touch that helped the late Tex Rickard to create the million dollar gate, but Kearns succeeded where others had failed.

Kearns produced 16 shows during his first 10 months in Detroit. Not one was a loser at the box office.

The aging Maxie Rosenbloom has been his No. 1 attraction. Against Roscoe Toles, Detroit Negro heavyweight, Rosenbloom drew more than \$24,000.

When two months ago, the 34-year old Rosenbloom appeared in Detroit again, against Jimmy Adamick, youthful Midland, Michigan, slugger, customers paid \$20,000 to see Maxie take the decision.

Adamick, a slugger of the Jack Dempsey type, is under contract to Kearns for a number of bouts. Jack has strings on Buddy Knox, Johnny Whitfers, Roscoe Toles and other less known heavyweights.

Conservative estimates of Kearns' earnings from his promotions here so far this year are \$50,000. This sum is "chicken feed" compared to his earnings in the roaring 20's but Jack is getting by nicely on it because he isn't the nation's leading "check picker-upper" as he was in his younger days.

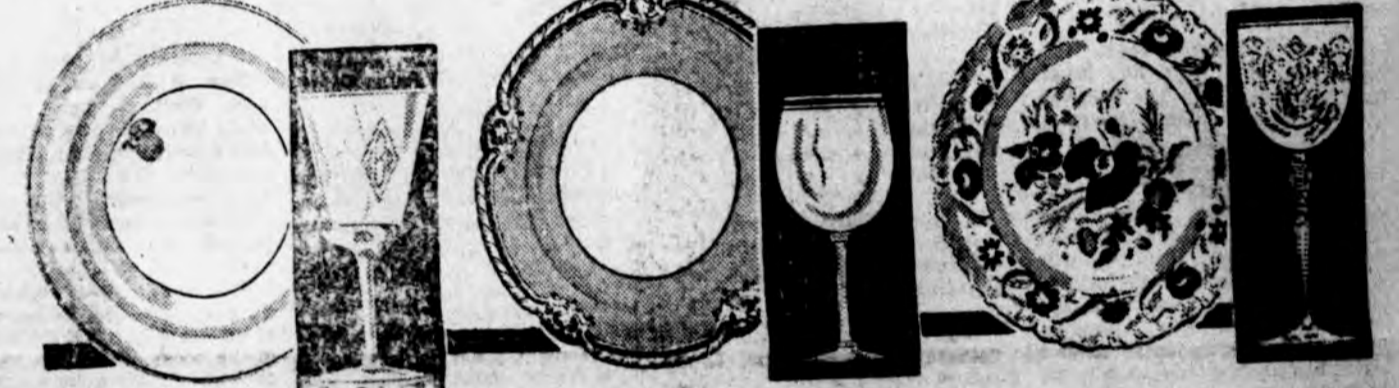

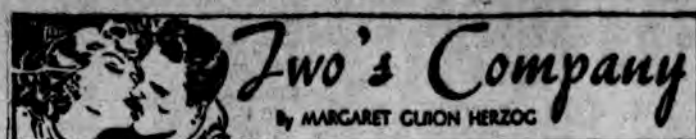

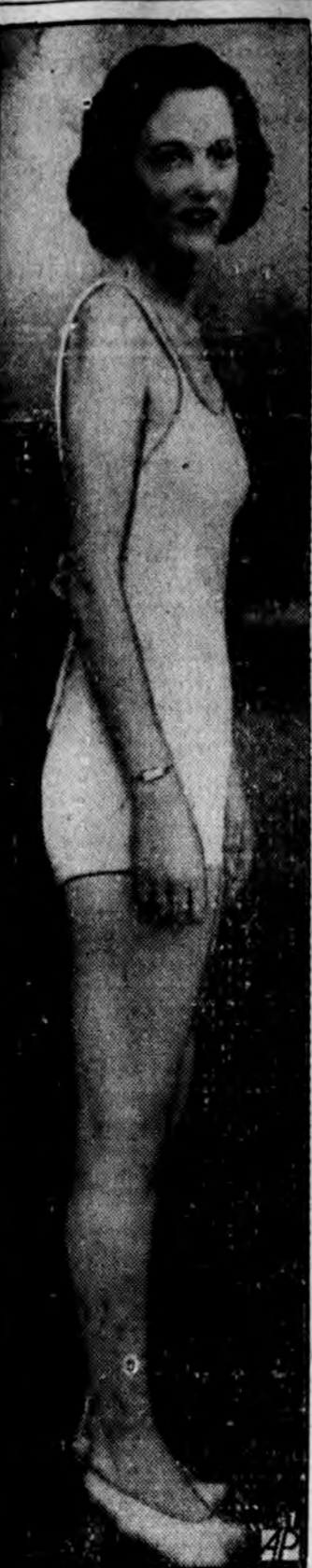

LAW ENFORCED AS TO DISEASE

Syphilitics Refusing To Take Treatment Jailed

Raleigh Nov. 22.—Syphilitics refusing to take treatment have been arrested and jailed in several counties. Dr. Carl V. Reynolds, State Health Officer, has been advised by local health board heads. He recently gave out an interview pointing out the provisions of Section 3, Chapter 206, Public Laws of 1919, which provides that if a person is known to have syphilis he or she may be cited to appear and take treatment. . . . nose who fail to do this may be jailed.

Arrests already have been made in the Chowan-Bertie Health District, and in Franklin, New Hanover, Surry, Wilson and Craven counties. Other arrests are expected to follow where patients are notified and fail to appear.

White people, Negroes, men and women are all being made subject to the law, it is disclosed in letters from health officers. Some of each have been placed in jail.

In some instances, the response has been so satisfactory that it was not necessary to make any arrests. However, the health officers indicate they mean business and will enforce the law more rigidly in the future.
