SEC. WALLACE OUTLINES PLAN TO AID FARMER

Proposes Six-Point Program in Address at Wichita

SAYS REAL ISSUE IS FAIR CHANCE

Declares Agriculture Must Establish Stability or Face Another Depression

Wichita, Kan., Nov. 23.—(AP)—American agriculture must establish its stability, Secretary Wallace declared today, or again become the nation's "forgotten industry" and carry the country back to another depression.

Addressing a group of Kansas wheat producers, he proposed a six-point farm program. In Washington the Senate was beginning deliberations in a crop control bill.

The present campaign for farm relief is a renewal of the old battle of "equality for agriculture," Wallace said.

The real issue, he declared, is whether "agriculture is to be given a fair chance."

The six-point program urged by Wallace was similar in many ways to the bill submitted yesterday by the Senate Agriculture committee.

1. Planning a wheat crop which would allow for an exportable surplus to give farmers their share of the world market.

2. Establishing "acreage goals" in line with sound soil conservation and the needs of the domestic and foreign markets.

3. Establishing the "ever normal" granary to store reserve supplies against drought years.

4. Crop insurance.

5. Retiring sub-marginal farm lands now contributing to surpluses.

6. Price adjustment payments to farmers financed by "anti-inflation" or processing taxes.

Held For Murder



Mary K. O'Connor, 19-year-old Philadelphia girl, was held on a charge of homicide in Camden, N. J., in connection with the Labor Day slaying of five-year-old Nancy Glenn. Detective Captain John Murphy announced he obtained a signed statement from her admitting the crime. According to this confession, police say, Mary quarreled with the younger girl in a field near Philadelphia, hit her on the chin, and then left her in a mudhole covered with a slab of tin.

STUDENT HELD BY DETECTIVES

Lawyer, However, insists She Be Placed in County Jail

Philadelphia, Nov. 23.—(AP)—Judge Harry McDevitt today ordered Mary K. O'Connor brought before him to determine whether she should continue to be held in the custody of Philadelphia detectives in the investigation of the slaying of five-year-old Nancy Glenn last Labor Day.

The order was granted on a petition for a writ of habeas corpus by the attorney for the 19-year-old physical education student. Hearing is scheduled for later today.

The girl was remanded to the custody of the detectives last night by Mayor Davis Wilson after he had heard Detective Captain John Murphy restate a statement he said the girl made in the child's death. The mayor fixed a hearing for next Monday.

The story he told was that Miss O'Connor struck the girl and knocked her down when she became angry at her teasing. Miss O'Connor left her for dead, face down in a puddle. An autopsy revealed water in the child's lungs.

Mayor Wilson ordered Miss O'Connor held by the detectives in order to be questioned further on her statement, which was read at the hearing.

Her attorney, William Gray, demanded she be placed in the county prison where detectives could not reach her for questioning and said he would ask the court to order her commitment during the day.

Anti-Lynching Measure Side-Track For Present

SEEK BRING OUT WAGE-HOUR BILL

President Calls in His Chief Advisors To Discuss Means Of Aiding Business

Washington, Nov. 23.—(AP)—The Senate went to work on long-range farm legislation today after side-tracking the anti-lynching bill.

As it did so, administration leaders trying to push forward with the President's program on another point, abandoned hope of getting the wage-hour bill from the House Rules Committee. The committee has refused since last summer to let the house consider the labor measure.

During the day a house subcommittee agreed tentatively to a complete revision of the corporate tax system. It would increase abandonment of undistributed profits levies on corporations with incomes of \$5,000 or less, and modifications on incomes greater than that.

The farm bill providing surplus crop control was called up in the senate as soon as Senator Wagner withdrew his motion to take up the anti-lynching legislation.

The latter measure has had the senate tied up in a filibuster. The action, however, merely deferred the anti-lynching controversy to a later date.

Soon after the house met Chairman O'Connor (D. N. Y.) of the rules committee announced his group refused to let the wage-hour measure come out to the floor.

When this became apparent the house Democratic leader Rayburn of Texas affixed his signature to a petition which would take the bill away from committee and bring it to a vote.

President Roosevelt meanwhile called in some of his main advisors to discuss ways the government can aid business.

Secretary Morgenthau and under Secretary Magill, treasury tax experts, were summoned first for a conference on latest treasury studies of taxes.

Chairman Averill Harriman of Secretary Roper's business advisory council, followed the treasury officials to the White House.

Foresees Return Of Upward Trend

Prophets Predict Renewal of Improvement in Business Either With or Without Aid of Federal Government

Raleigh, Nov. 23.—(AP)—Capt. Waynick, State Director of Purchase and Contract, said in a statement today recent purchases of commodities for the state reflect the downward trend in commodity prices, but the drop in textile prices and manufacturing probably would be reflected in state income tax figures next year.

"The question whether government can or will do anything promptly to change the downward trend in business is being debated," said Waynick. "But with or without governmental help, the business prophets foresee a renewal of business improvements by the middle of 1938 and some are predicting definite inflation."

Waynick said: "The beginning of the present movement of business to lower ground occurred early this year when the volume of production was affected, but even the shrewdest economist of the country overlooked the change for some months and were predicting a bigger volume of business and higher prices for the final quarter of the year."

"As a matter of fact, production volume has decreased sharply in all lines and the prices of raw materials have gone rapidly as a consequence."

SPECULATE ON MURDER TRIAL GERMAN TALKS NEARING CLOSE

London, Nov. 23.—Viscount Halifax reported today to King George at Buckingham palace, while the London press speculated vaguely about the result of his talks with Chancellor Hitler of Germany.

He already had reported to Prime Minister Neville Chamberlain and Foreign Secretary Anthony Eden on his visit to Hitler's home last week.

On one hand it was freely intimated the talks were successful for Germany. These quarters believed the Halifax journey would result in Britain's abandonment of the policy of seeking general European settlement.

The greater body of opinion, however, was the talks might lead to some sort of trade deal between the two countries. These persons insisted Halifax was instructed to keep Germany guessing about Britain's policy in Central Europe.

Hitler's declaration of yesterday that "in six years the countries will realize the necessity of taking practical steps" on the colonial question caused London to wonder whether Halifax had agreed to some sort of Anglo-German deal.

U.S. Ambassador To China Departs From Old Capital

Nelson Johnson And Staff Members Embark for Hankow

MAKING TRIP ON GUNBOAT LUZON

Several Aides Left In Nanking, However, As Embassy Follows Government

Shanghai, Nov. 23.—(AP)—U. S. Ambassador Nelson Johnson and members of his staff embarked today on the U. S. gunboat Luzon for the long Yangtze river trip from Nanking to Hankow, where a temporary embassy has been established.

Hankow and Hupeh province, one of the three cities to which the Central Chinese government had moved under the threat of an advancing Japanese army, lies about 280 miles by air southwest of Nanking.

Johnson left several aides at Nanking. While the American Ambassador followed the Nanking government on its withdrawal further into the interior, another United States gunboat steamed to the assistance of Americans at several Yangtze ports up the river from Nanking and a third United States gunboat was ordered to remain at Nanking.

Japanese navy planes hammered today at Wush, a point in Chinese defense lines half way between Shanghai and Nanking.

Although Chinese troops previously were reported in flight from Wush defenses, Japanese officers admitted Chinese still held the city. Japanese seemed confident their troops could reach Nanking this week.

At midday, Japanese said their forces still were five miles east of Wush. Japanese planes ranged far to the west in bombing forays.

Dr. H. H. Kung, Chinese Finance Minister, declared China is prepared financially to see the war thru no matter how long it lasts.

The Brussels conference on the Far Eastern situation was in adjournment until tomorrow, when it was expected to vote on a declaration admitting failure of its efforts to end the Chinese-Japanese war.

FINAL REPORT ON ROLL CALL

Total of 2,380 Members Enrolled For New Year

The final report on the Red Cross Roll Call was issued today by J. Nat Harrison, general chairman, showing that 2,380 members were enrolled in the recent campaign.

A telegram received from National Headquarters congratulated Chairman Harrison on the success of the Roll Call and declared "this represents greatest percentage gain of any chapter size Pitt county or larger during last five years. Your chapter's percentage of membership based on population is now more than double North Carolina's average."

The campaign was conducted with expenses amounting to less than \$20. Chairman Harrison reported.

Slot Machines Continue Struggle For Existence

Raleigh, Nov. 23.—Cats, despite their nine lives, are much easier to kill than slot machines. Latest move of the makers and operators of the so-called "One-Armed Bandits" is an unusual proceeding in Federal Court to enjoin enforcement of the state law passed by the last General Assembly.

PROMISES NEW DISCOVERY IN ARMED REVOLT

French Government On Verge Important Disclosures

FIND DOCUMENT IN POLICE RAID

Expanded Investigation By Surete Fails To Uncover Further Supply of Arms

Paris, Nov. 23.—(AP)—The government is on the verge of "important discoveries" in its drive to crush an armed secret revolutionary society, Marx Dormoy, Minister of the Interior, told the Cabinet today.

Numerous documents of great importance were seized in a raid during the night, Dormoy said. Details were kept secret. The raid was "somewhere in Paris."

Police today searched the luxurious apartment of a prominent engineering consultant in what they described as the latest foray in the hunt for evidence of the secret revolutionary society accused of plotting against the government.

The wife of the consultant, Madame Edouard Deloncle, told operatives her husband was travelling in Italy. The two-hour search produced a quantity of papers which were seized for further examination.

Officials of Surete Nationale said the extended investigation had failed to add to the large supply of arms and munitions already seized. Raiders had been active at Capnes, Lyon, Toulouse, Nantes, Marseille and elsewhere.

A Paris janitor found four small bombs without fuses on a sidewalk where police said they probably had been dumped by someone wanting to get rid of them.

She is survived by two daughters, Mrs. Fanny Jordan of the home, Mrs. M. P. Lewis of Beaufort County, four brothers, Fred Haddock of Shelmerdine, Jon Haddock of Swift Creek, D. H. Haddock of Greenville, Route 5, H. L. Haddock of Beaufort County; one sister, Mrs. L. P. Mills of Black Jack, and four grandchildren. She was a member of the Pleasant Hill Baptist church.

Before marriage she was Miss Maggie Haddock. About 35 years ago she married W. H. Walker, the father of her two daughters. He died about 10 years ago. Two years later she married Ransie Boyd. He died a year later. Most of her life was spent in the Shelmerdine community.

The Pontiff was critically ill a year ago. He suffered circulatory trouble, which from time to time have caused him considerable pain, particularly in the leg.

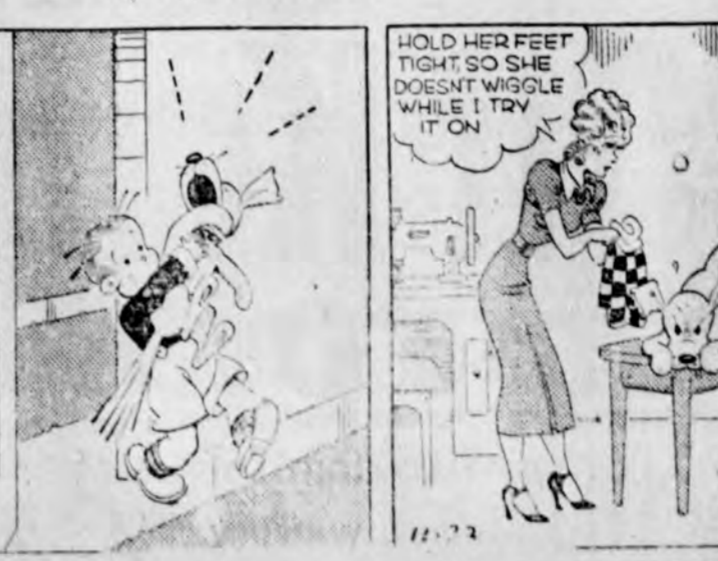

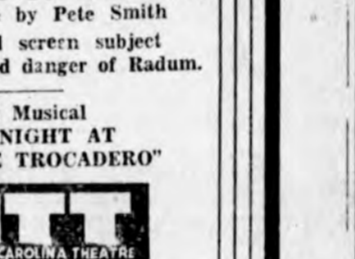
