SEEK RELIEF OF TAX BURDEN FOR BUSINESS

Administration and Congressional Leaders Confer

HARRISON BUSY IN CONFERENCES

House Agricultural Committee, Meanwhile, Completes Drafting Farm Bill

Washington, Nov. 24.—(AP)—Administration officials talked with congressional leaders today on the possibility of some quick action to assure business of an eased tax burden.

Chairman Harrison of the Senate Finance Committee, who up to this morning was insisting that nothing could be done immediately on the tax questions, was busy conferring with finance officials from the department.

He conferred first with Marriner Eccles, chairman of the Federal Reserve Board, and later with Treasury officials.

There were reports two proposals were discussed: 1. A simultaneous announcement from President Roosevelt and congressional leaders that business taxes would be revised.

2. Quick action this session on the bill being framed by a House tax sub-committee to modify the corporate surplus tax.

Harrison said the possibility of action at the present special congressional session depended upon the House.

The House sub-committee, however, worked this morning on levies other than on corporation.

While the tax sub-committee surveyed "nuisance taxes," those on movies, cosmetics, and the like, the Senate heard an Agriculture committee man say the pending farm bill was unconstitutional.

The bill, Senator Pope (D-Idaho) asserted, was based on the Constitution inter-state commerce clause rather than on general welfare provision that was the basis of the invalidated AAA.

The House Agriculture Committee, meanwhile, completed drafting its crop control bill, companion to the Senate farm measure.

Convening of the House itself was marked by delaying tactics on the part of opponents of the wage and hour bill.

Cox To Be Tried In Superior Court

Raleigh, Nov. 24.—(AP)—Chief Deputy Federal Marshal Henry Turlington said today Leslie Cox, Wayne county Negro, charged with killing a highway patrolman last June, probably would be turned over to Wayne county officers for trial in Superior court as soon as an order is secured from the Superior court judge.

Turlington said Cox was being held on a Federal charge of fleeing state jurisdiction.

No judicial hearing will be necessary, Turlington said, to secure transfer of Cox from Federal to state jurisdiction, by the resident Superior court judge or one sitting in the district in which Wayne county is situated, must sign the proper papers asking the transfer.

Pickets Guard Main Gates Following Demonstration

St. Louis, Nov. 24.—(AP)—Members of the UAW protesting alleged grievances went on strike today at the St. Louis assembly plant of the Ford Motor Company.

About 150 pickets guarded the two main entrances at the plant after an early morning demonstration in which some 1,200 men, many of them members of the other CIO union, swarmed around the buildings. There was little disorder.

Delmond Garst, regional director of the CIO unions, survey a picket line that at one time encircled the square block area occupied by the plant and said:

"The Ford plant will not operate today. We will maintain these strong picket lines and take whatever steps are necessary to carry out our plan."

Garst has charged the Ford Company discriminated against union members in reemploying workers after a seasonal pay-off, forced workers to sign loyalty pledges and fostered a company union.

Milton Johnson, plant manager, has denied the charges. He was not available for comment this morning.

Several men entered the plant on foot with police escorts to the jeers of the pickets and many cars entered with the men.

A. S. BURLERSON DIES IN TEXAS

Was Postmaster General Under President Wilson

Austin, Texas, Nov. 24.—(AP)—Albert Sidney Burlerson, Postmaster General in the cabinet of President Woodrow Wilson, died here today. He was 74.

Death occurred at home where he had been in declining health for some months.

He is survived by a widow, Mrs. Adelle Burlerson; three daughters, two sisters and six grandchildren.

Burlerson withdrew from public life when his second term as Postmaster General ended. He was a cabinet member from 1913 to 1921. Previously he had served eight terms as a Representative in Congress.

In recent years his interest centered in farming and ranching.

During the World War he had an active hand in the post service work on the selective draft, the conservation of food and fuel, distribution of industrial forces, and the sale of bonds and war savings and thrift stamps.

Members of the family said a private funeral service would be held this afternoon.

PASTOR GUILTY IN MURDER OF LOYAL WORKER

Punishment Fixed By Jury at Life Imprisonment

MINISTER CALM AT HEARING FATE

Declares He Is Victim Of Circumstances And Says He Will Ask for New Trial

Pittsfield, Ill., Nov. 24.—(AP)—The Rev. C. E. Newton was convicted today of slaying a loyal church worker and the jury fixed his punishment at life imprisonment.

A verdict was reached in six hours and 52 minutes. The Missouri country preacher had pleaded he was the victim of circumstances in the brutal hammer slaying last July of Mrs. Dennis Kelly, 45-year-old mother of Paris, Mo.

"I'm not surprised at the verdict because of prejudice in this case," said the sleepy-eyed pastor calmly when his fate was declared long before dawn.

"I intend to ask for a new trial. I will carry this to a higher court if necessary."

Then the 51-year-old minister conferred briefly with Defense Attorney Martin Turner and was taken back to jail unmanacled, as usual.

Circuit Judge Clay Williams, hurriedly summoned from home when the jury announced it had reached a verdict at 1:18 a. m. (CST), did not set a time for formal sentencing, but indicated it would be today.

Turner declared "This man is innocent of any crime. I am sure of that in my own mind." Merrill Johnson, state's attorney, (Continued on Page Six)

Stock Exchange Takes Disciplinary Measures

Wall Streeters Agitated by FEC Chairman's Warning

New York, Nov. 24.—(AP)—The New York Stock Exchange today took disciplinary action against a specialist in stock of Nash-Kelvinator for failing "to fulfill his duty" in that capacity.

"The governing committee," an announcement said, having found John J. Phelan guilty of the charge and specification, directed that he should be prohibited from acting as a specialist on the floor of the New York Stock Exchange for a period of three months and that he should be censured by the president of the Exchange.

New York, Nov. 24.—(AP)—Wall Streeters, particularly in Stock Exchange circles, were frankly agitated today by FEC Chairman Douglas' warning to the Exchange last night to reorganize along lines in keeping with the public interest.

Securities prices, however, were but slightly disturbed. The market opened quietly and in early dealings some leading shares dropped 50 cents to two dollars, only to recover partially in dull trading.

Leading bankers and brokers declined to comment formally, several asserting they would not "stick their necks out."

Meantime authoritative quarters said the exchange was proceeding with its own plan of reorganization. Dissatisfaction with that plan was said to have prompted Douglas' statement in Washington last night after weeks of negotiations between the Exchange and the Commission.

GIRL TESTIFIES TO AID MOTHER

Defense Rests in Trial Of Mrs. Sina Pope Godwin

Lillington, Nov. 24.—(AP)—The defense rested today in the second trial of Mrs. Sina F. Godwin, Dunn widow charged with the fatal shooting of Furman Godwin, her third husband.

Her 17 year old daughter by a former marriage, Hortense, testified Godwin was a violent man who often terrified her and her mother by threats.

After her testimony, Solicitor Claude Cannady began calling state witnesses in an effort to refute the defendant's claim she shot her husband in self defense after he had raped her.

Hortense corroborated the part of her mother's testimony to the effect Godwin became violent when "under the influence of narcotics or liquor."

G. A. Jackson Dunn Chief of Police who led the investigation after Godwin was found shot to death in June, 1936, was the first witness called by the Solicitor.

Mrs. Godwin as she start of her second trial in Harnett Superior court submitted a self defense plea.

FORTY KILLED DURING RAIDS

First Air Attack Since September 26 Comes As Foreign Sources Confirm Reports Long-Awaited Russian-Made Planes Have Arrived at the Chinese Capital

Shanghai, Nov. 24.—(AP)—Two Japanese bombing planes, protected by pursuit craft, dropped a score of projectiles today along the main thoroughfares of Nanking, killing 40 civilians.

It was the first time Japanese planes had struck within Nanking walls since September 26. The National Art Gallery was damaged in the bombardment.

While the pursuit planes engaged Chinese craft in a dogfight, the bombers passed through anti-aircraft fire to attack the Chinese emergency airfield between Nanking and Wuhu, a short distance up the Yangtze.

The bombardment came as foreign sources confirmed reports that long-awaited Russian long-awaited Russian-manufactured planes had arrived at the capital to bolster Chinese air forces. The Japanese raid was believed to have been an attempt to smash the new craft quickly.

Earlier in the day the 34 Americans and 28 other foreigners remaining in Nanking asked the Japanese to make their quarter a neutral zone to prevent possible destruction by bombs or shells.

United States Ambassador Nelson Johnson sent a similar request to the Chinese government.

Japanese authorities said they favored the proposal in principle, but added there were military considerations which the army had to take into account.

The two warring factions issued conflicting communications on the fighting along the Wush-Kiangyin line, 100 miles east of Nanking.

(Hongkong reports said Japanese planes bombarded Canton, killing about 100 civilians.

Richard S. Harris Dies At Falkland

Richard S. Harris age 62 died at his home in Falkland yesterday afternoon from a stroke of paralysis he suffered during the morning.

SECURITY ACT ADDRESS TOPIC

R. G. Parker Reviews Agency After Two Years' Operation

Elizabethtown, Nov. 24.—The progress which has been made in carrying out the provisions of the Social Security Act and its present status were reviewed today by R. G. Parker, regional director, Region 4 Social Security Board, before the sixth annual district welfare conference at Elizabethtown.

Outlining the purposes of the various titles of the act, Mr. Parker said: "The number of those receiving aid under the three public assistance categories: that is Aid to the Needy Aged, Aid to Dependent Children, and Aid to the Needy Blind, has reached nearly two million, who are at present receiving assistance at the rate of about \$420,000,000 a year." He added that most of the states had now passed legislation covering all phases of the act involving federal and state cooperation and that the Federal Old-Age Insurance program administered by the Federal Government, was well under way. However, speaking as a practical business man, he cautioned against trying to make too rapid progress or to attain the ideal by any short-cut. He stressed the fact that it is necessary to proceed slowly and to consolidate each step before taking another, and that the benefits paid must take into account the tax burden which they involve. A realistic program, he said, "must perform to be a compromise between the theoretically desirable and that which lies within the limits of practical attainment."

The British system is far simpler. Male workers and employers each contribute 4-1-2 pence, or about 11 cents a week, regardless of wages. At age 65 a pension is paid at the flat rate of 10 shillings per week, or about \$11 a month. The system is comparatively simple to administer, but it is clear that if a fixed contributory rate and a fixed benefit are paid, there must be adjusted to the lowest income group both as to ability to pay the tax, and as to value of benefits in relation to prior standards of living. This results in the benefit being too small to be of much value to the better paid workers. Also, a man who has worked all his life and one who has worked only intermittently receive identical benefits. The plan is not in any real sense social insurance.

"We must not permit the humane urge toward a social Utopia to blind us to economic realities. It makes no difference in what guise it is dressed up, the cost of social benefits is derived from the national income and from nowhere else. Every cent received by beneficiaries must come out of production, that is, out of productive labor or service. A man may raise ten bushels of wheat and give one to the hungry. He may give two or even three bushels, but a point can be reached beyond which he will not give, and cannot be forced to give any more. In other words there is a limit to taxation. And any sound social welfare program must recognize this. Unless we are willing to face the risk of having it fall of its own weight, it must perforce be a compromise between the theoretically desirable and that which lies within the limits of practical attainment."

SHORT SHOTS

Raleigh, Nov. 23.—Counsel in the Smoak appeal before the Supreme Court Tuesday seemed about to make an all-North Carolina affair out of the famous New York poison case of State vs. Molyneux, which was repeatedly cited as a precedent.

"It might interest the court to recall that the District Attorney who prosecuted that case was a North Carolinian," Attorney General A. F. Sewell said.

"And for the defendant there appeared another famous lawyer who originally came from North Carolina—Mr. Battle of Tarboro," interjected L. Clayton Grant, Smoak's counsel-in-chief.

"Was Molyneux a North Carolinian?" dryly queried Justice George W. Connor.

"Well, that's one time we ought to be glad North Carolina did not sit in the first seat," commented Justice W. A. Devin when Mr. Grant said no, Molyneux wasn't a Tar Heel.

Dwight McEwen, Wilmington attorney, found himself in a rather unusual position Tuesday when he argued for a new trial in the case of George Stevenson, Negro convicted of first degree burglary in Columbus county and under sentence of death. It was alleged the black entered with intent to ravish a white woman.

Justice Heriot Clarkson asked Mr. McEwen what he would say "or think if a mob lynched his client because some technicality of the law caused a reversal of the conviction."

"I'll give you a very different answer up here from what I'd give you if I were just a man down in the street," replied the attorney.

"No state in the south possesses a greater abundance and variety of opportunities for industrial development than North Carolina," says a recent issue of the News Letter, University of North Carolina publication.

Sorry of course, that President Roosevelt is having some trouble as the result of an abscessed tooth, Governor Clyde R. SWINE LIABLE TO INFLUENZA
Disease stalks in filthy pens in fall and winter

Raleigh, Nov. 22.—Swine influenza stalks through filthy pig pens in fall and winter, warns Dr. C. D. Grinnells, veterinarian of the N. C. Agricultural Experiment Station.

The heavy loss of young pigs killed by "flu" every year can be reduced materially, he added, by observing these precautions:

Keep the hog pens clean, and well supplied with clean "bedding" material.

Protect the swine from drafts and exposure in bad weather.

Isolate newly purchased hogs for at least 30 days to see whether they are affected with disease.

The fight against swine influenza is complicated by hog cholera, Dr. Grinnells continued. The two diseases resemble each other, and when pigs are weakened by one, they may easily succumb to the other.

Sanitation and vaccination will protect hogs from cholera, and sanitation and proper care will prevent influenza.

"But in cases where pigs are allowed to contract 'flu' he said, they can be treated by placing them in warm, dry, clean pens and feeding sparingly an easily digested ration.

Unique weakness or logginess in swine, a tendency to "pile up," are symptoms of trouble. It is "flu," cholera, or lung or intestinal worms.

It is hard to say, Dr. Grinnells answers, and the safest thing to do is to call in a veterinarian to diagnose the trouble and prescribe the correct treatment.

Careless Smokers Primary Cause Of N. C. Forest Fires

Reflector Bureau.
Raleigh, Nov. 23.—Careless smokers and recreationists were the primary causes of forest fires in North Carolina counties organized for protection against the "Red Demon" during the month of October, according to a report today by W. C. McCormick, assistant State Forester.

Of the 63 forest fires recorded last month, smokers, hunters, fishermen and campers were blamed for starting 35, considerably more than one-half the total.

Incendiaries were next in responsibility for flames in the woodlands, according to Mr. McCormick whose report shows nine from this source.

Brush burning operations were held accountable for six of the fires, seven were said to have been of unknown origin, and the others came from an assortment of causes.

Total destruction from the 63 October fires was estimated at \$4,097, while the area burned over was 3,945 acres. As a result of control efforts, the average area covered by each fire was held to 62.6 acres, while the average damage per fire was only about \$65.

The greatest damage was done to the young growth, which suffered to the extent of some \$2,605, with merchantable timber being damaged about \$1,210.

Of note in the fire situation last month, Mr. McCormick pointed out, is the fact that all of the flames and resulting damage to the woodlands in North Carolina was man-caused and were therefore preventable. Not one of the 63 recorded fires was started by lightning, the only source of origin in this state which could not be prevented, by the exercise of proper precautions.

Star To Become Legend in State Football History

Raleigh, Nov. 23—Eddie Berlinski will become a legend in football history at State College.

The popular back brought his college grid days to a brilliant close Saturday as he fought his heart out against Duke. State lost, 20-7, but to Berlinski went the glory of being the best back on the field.

Berlinski is the greatest State back since 1917—the year of Jack McDowell—and one of the most popular and colorful in the history of the game. State never had a player to love the game more or who had a more competitive spirit.

Berlinski was truly great against Duke. Wade Ison, in the Charlotte News said: "The Little Buzzer put on a one-man circus at the expense of the baffled Duke defense which time and again trapped Berlinski on one side of the line, only to have him reverse his field and run behind his own line of scrimmage back to the other end for spectacular gains."

"Defensively this little Wolf, sang his swan song in a blaze of glory, played a masterful game. His catching of Rooney's passes was in keeping with his other scintillating work and the tears that streaked down his face when Coach Newton took him from the game after Duke had led it away were those sincere tears that can come only from those who know they've given their all for alma mater and know that that all isn't quite enough."

John A. Parris, Jr., in Winston-Salem Journal: "If there had been another Eddie Berlinski and another Art Rooney, State would have been singing her victory song to-night."

Tom Best in the Greensboro Daily News: "Berlinski has been a lone Wolf. He has had to bite and claw every inch of his way. Hackney has had on all occasions as fine an escort as Dixie owns. The two boys put on a master show today."

"Berlinski was the one man on the field who could electrify alone. Sometimes he was caught behind himself, sometimes snaged between the fullback and the line. But Berlinski wasn't down until the referee said so. And so on as his legs would locomote. Berlinski was headed away from Duke. He stayed in 57 minutes and went weepfully off the lot as this was written to a meteoric career."

Berlinski's playin' days are over at State, but the real feats of the youngster will live on in the memory of those who love the athlete who gives his best, win or lose, and who plays for team and school glory rather than for individual glory.

When Berlinski checked in his togs Saturday after the game he turned to Artful Art Rooney, sophomore star back of the Wolfpack, and willed him all the football ability that was his that as a junior next year and a senior in 1939, Rooney might make football fans forget all about Berlinski of 1937. That's the kind of fellow Berlinski is.

"Rooney I am counting on you to make the fans forget all about me next season, and you can do it," Berlinski told Rooney, tears streaming down his face.

Rooney is the back State will look to next fall. The 1937 season was one of the best in State's grid history. Other outstanding stars besides Berlinski and Rooney were Louie Mark, center; Jess Tatum, Carroll Conrad, Mac Berry, ends; George Fry and E. V. Helms, tackles and Warren Wooden, guard.

PITT FAVORED TO BEAT DUKE

Season's Statistics of Two Teams Prove Interesting

Durham, Nov. 24—While the two teams have not met a mutual foe and at the best season statistics will mean little in Duke stadium Saturday, a glance at them is interesting.

Each team has played nine games this season. The Panthers have admittedly gone up against 9 tougher foes than the Blue Devils have faced but regardless of the strength of their foes, both teams have shown potent offensive attacks.

In those nine games, Duke has rolled up 2,437 yards by rushing which is exactly 97 yards more than the Panthers have made but where Pitt has held its opponents to 353 yards by rushing, Duke's foes have gained 1,080 yards. Duke has made 95 first downs to their opponents' 77 while Pitt has made 97 to 40.

Duke has gained about twice as much yardage as Pitt by passing but the Blue Devils have thrown just about twice as many aerials. The Panthers have tried only 69 passes, completing 29 for 328 yards. Duke has tried 165, 42 being complete for 663 yards.

Pitt's opponents have tossed 116 bombs completing 30 for 463 yards while Duke's enemies have thrown 139, completing 49 for 565 yards, giving Pitt about the same edge over Duke on defense against passes as they have on defense against running plays.

Marshal Goldberg and Harold Stebbins have done the heavy ground gaining for the Panthers, the former turning in 661 yards while Stebbins is credited with 470 yards. For Duke Eric Tipton has turned in a total of 565 yards with Emore Hackney, who has carried the ball less, totalling 465.

watch the Carolina team, one of the finest in the institution's history, play its final game.

Carolina rules favorite, but past results show the underdog often comes out on top. Virginia is playing its first season under the guidance of Frank Murray, who at Marquette turned out some of the greatest teams in the nation. The Cavaliers have played inconsistently this season. But they turned in first rate performances against Navy, Maryland, Hampden-Sydney, and William and Mary. An encore of these performances would mean a hotly contested affair and possibly an end to the Tar Heel domination of the past several years.
