SUB PROPOSAL FOR FARM BILL UP FOR DEBATE

Separate Measure Delays Final Vote On Crop Control

HOPE FOR FINAL VOTE BY NIGHT

Still Another Substitute Must Be Disposed of After McAdoo Proposal

Washington, Dec. 17.—(AP)—The Senate, after four weeks of talk on the "ever-normal granary" farm bill, debated today a separate measure submitted by Senator McAdoo (D.-Calif.).

Despite the delay entailed in consideration of the McAdoo bill, Senator Pope (D. Idaho), a member of the agriculture committee, expressed hope the ever-normal granary plan would reach a vote by night.

McAdoo's proposal would require the Secretary of Agriculture to ascertain the market for farm commodities each year and the amount available for markets.

The secretary then would fix a minimum price at which commodities could be sold on the domestic market. This would be based on cost of production, value of farmers' services and similar factors.

Another provision would provide for revising tariff laws to prevent imports from depressing domestic farm prices.

Secretary Wallace has expressed opposition to price-fixing farm measures such as McAdoo's contending they might interfere with the administration's reciprocal trade program.

Another substitute by Senator Lee (D. Okla.) embodying a domestic allotment plan required action after disposition of McAdoo's proposal.

Already weary of four weeks of debate, the senate remained in session until nearly midnight last night and was called back today at 11 A. M., an hour earlier than usual.

Palmetto Officers Pursuing Payne?

Columbia, S. C., Dec. 17.—(AP)—Chief of Police W. H. Rawlinson said at 2:15 P. M. today that Columbia police, county officers and highway patrolmen were in pursuit of a man he believed was Bill Payne, notorious North Carolina fugitive.

The man, Rawlinson said, officers thought was Payne, held up Police Chief Williams Rikard of Cayce, Columbia suburb, in Lexington county, took his pistol and escaped in the officer's car.

After this escapade, Rawlinson said, the man held up a roadhouse on the old Camden road near Camp Jackson.

Rawlinson ordered out additional city officers and highway patrolmen were dispatched to cover every highway leading out of the city.

Chief Rikard said he was almost positive the man who held him up was Payne. "He resembled the pictures that I have seen of Payne," he said.

Persons desiring to care for any case should bear in mind that Thrift shop is providing the information only. Baskets, clothes etc., are to be taken directly to the family, and not to the Thrift shop.

Case number two, a family living in a tent with no income and in great need was taken by the Eastern Star; Case number 13, a rural family composed of the parents and six children, has been taken by Mrs. Rick's Sunday School class of the Christian church; Case number 14 another rural family, the father in which is a World War veteran suffering with TB, will be cared for by the American Legion Auxiliary.

Lawyer and Wife Slain by Kinsman

Quitman, Ga., Dec. 17.—(AP)—Ler W. Branch, former president of the Georgia Bar Association and one of the state's outstanding attorneys, and his wife were shot to death in their home today.

Patrolman Grady Marable said the two were killed by Livingston Snow, Mrs. Branch's brother. Marable said he was called to the home by neighbors and captured Snow in the dining room after a brief struggle. Marable said the Branches were killed instantly, each with a pistol bullet through the head. "Livingston Snow was raving," the policeman said. "I understood he was mentally ill and that plans were being made to take him to an institution."

Marable and other officers took Snow, a retired pecan merchant to jail.

Russell Snow, another brother of Mrs. Branch, also was in the room when the tragedy occurred. Marable said Snow came into the dining room after the other three had started to eat breakfast, drew a pistol and shot Branch as he sat in his chair. Mrs. Branch tried to escape, but Snow eluded his brother and shot her as she ran, the officer said.

JAPAN BRANDS SOVIET ACT AS 'UNTHINKABLE'

Formally Charges Russia With Arresting Japanese

FOREIGN OFFICE FORWARDS NOTE

Newspaper Contends Soviet Union Continuing Strengthening Military Forces

Tokyo, Dec. 17.—(AP)—The Japanese Foreign Office today formally charged the Soviet Union with acting in a manner "utterly unthinkable in any civilized country" in connection with arrests of Japanese in Russia.

The Foreign office protested to the Soviet Embassy, citing what Japan called numerous cases in which Soviet authorities had arrested Japanese and held them without trial.

A memorandum accompanying the protest said Japan wished a "responsible" answer.

Almost concurrently the Tokyo newspaper Yomiuri charged that Russia was continuing to strengthen her military forces at Vladivostok, Russia's Far Eastern seaport.

Chinese press reports received at Shanghai said Russia had completed an underground airbase at Vladivostok capable of housing 150 planes and had reinforced her armed forces there by more than 85,000 men.

The Russian port at the Southern tip of a neck of Russian territory that curves around the Eastern frontier of Japanese dominated Manchoukou lies about 400 miles from the nearest Japanese coastline and about 650 air miles from Tokyo.

McDaniel Funeral In Enfield Today

D. H. Conley, superintendent of Pitt County schools, R. L. Little of Grimesland, member of the Board of Education and several principals attended the funeral services in Enfield today for E. L. McDaniel, who died in a Kinston hospital yesterday after two weeks of illness.

Mr. McDaniel was superintendent of the transportation service for the county schools. He had made his home at Grifton, but formerly was from Enfield. He is survived by his wife and three children.

County school principals attending the funeral were C. D. Ward of Winterville, Newman Lewis of Chicod, Henry Olesby of Grifton, J. H. Moore of Farmville, J. P. McRae of Grimesland, G. P. Carr of Stokes.

Robbers Believed Jailed In Durham

Sheriff S. A. Whitehurst today was in Durham, where three men believed to have robbed the M. O. Blount and Sons store of Bethel recently, were being held.

The three alleged robbers were listed as George Philmer, alias Dan Green, Gus Lockett and Ernest Thompson. They were arrested in Durham after a series of robberies in North Carolina and Virginia, all of which were similar to the one in Bethel. It was understood here the trio had been definitely identified as the men who robbed the Bethel store of clothing valued at \$1,000.

Pending the return of Sheriff Whitehurst it was not known whether the three would be returned here for trial or would be sent to some other place to face robbery charges.

Dr. Glenn Frank Head OF G.O.P. Committee

St. Louis, Dec. 17.—(AP)—The Republican National Executive Committee, in a four day caucus here, agreed upon Dr. Glenn Frank, former president of the University of Wisconsin, to head its policy formulating committee.

FOUR MEN HELD IN GIRL'S DEATH

Body Found in Room of Delegates to Labor Meeting

Pittsburgh, Dec. 17.—(AP)—Four delegates to this week's convention of the Steel Workers Organizing Committee were held on technical charges of murder today, while the police investigated the death of 30-year-old Rose Ault, whose nude body was found in their hotel room.

Inspector of Detectives Walter Monaghan said Jacob Zelkind and Morris Engald, both of Brooklyn, were being detained here and that New York police had taken Louis Green of Brooklyn and Fred Odenwalk of Coney Park, Long Island, into custody on murder charges, pending an inquest.

Monaghan said the four men came to Pittsburgh to attend the steel workers convention.

Coroner W. J. McGregor said he had not decided on a time for the inquest.

In New York, Green and Odenwalk voluntarily went to Brooklyn police headquarters today.

The men told Deputy Inspector John Gallagher they knew nothing of Miss Ault's death. When they and two other Brooklyn men, Zelkind and Engald, arrived in Pittsburgh Tuesday, they said, all four were assigned to the same hotel room.

Miss Ault later came to their room, they said. Green said he and Odenwalk were too busy with the convention work to pay much attention to her. She was still in the room, Green said, when he and Odenwalk left for home yesterday.

Tiber On Rampage Threatening Rome

Rome, Dec. 17.—(AP)—Troops were called out today to reinforce thousands of men in a struggle to keep the rampaging river Tiber from inundating central Rome.

The river swept through the city at its highest level in 67 years. Highways to Pisa and Naples were cut off. Authorities feared the Milvio bridge, dating back to 109, B. C., would collapse under the torrents.

Some of the patients of a hospital on Tiber Island were ferried to safety, while mothers were taken to upper floors when the flood crept into the first floor of the building.

Firemen reported two persons were drowned during the night, bringing the toll of lives to four.

Survivors Relate Story of Bombing

Shanghai, Dec. 17.—(AP)—How Japanese warplanes machine-gunned the small boat carrying wounded men ashore from the bombed United States gunboat Panay causing more wounds was told in detail tonight by survivors of the disastrous attack.

They confirmed earlier reports denied by the Japanese that such machine-gun fire harassed survivors, many already suffering from serious wounds incurred aboard the Panay, as they tried to reach safety ashore last Sunday.

In addition, survivors reaching here said Japanese army detachments in launches on the Yangtze and along the river banks, fired machine gun bursts at the Panay before she sank.

The river party also boarded the Panay after her crew and civilian passengers abandoned the ship for a hurried inspection just before she went under.

The United States gunboat Oahu, her flags fluttering at half mast, steamed into Shanghai tonight bearing the dead, wounded and rescued survivors of the Panay.

Two Japanese destroyers and the British gunboat Ladybird, conveyed the United States vessel as she steamed alongside the flag ship Augusta, ending her 220-mile trip down the Yangtze.

On board were the bodies of Storekeeper Charles Emsminger of the Panay; Capt. C. H. Carlson of the Standard Oil vessel Melian; Sandro Sandri, Italian newspaperman, and the Chinese quartermaster of one of three company craft destroyed in the Japanese attack Sunday.

The Oahu also carried some 60 survivors, 15 of them wounded.

Expect Find Bodies Of Two Alcatraz Escapees

Given Only A Chance In A Thousand To Survive

San Francisco, Dec. 17.—(AP)—Heavy shore patrols and Federal and police boats searched the waters of San Francisco bay today for two desperate criminals who escaped from Alcatraz Island's "escape proof" Federal penitentiary under cover of a dense fog.

Officials expected to find their bodies.

There was only one chance in a thousand, authorities agreed, that Ralph Roe, bank robber from Duncan, Okla., and Theodore Cole, kidnaper from Stearns, Okla., still lived.

During a half hour between regular counting of prisoners yesterday afternoon the pair broke two panes of glass in a window and escaped from the hidden from tower guards by the dense fog, they reached the outside wire fence where they jumped a gate.

After reaching rocks at the base of the cliff, officials said, the pair hid in caves on the island, plunging into a powerful ebb tide in an attempt to swim the mile and a quarter to San Francisco or slid into the water to make a rendezvous with a confederate boat screened from the 12 acre rock by the fog.

The entire island, cave and all, was searched repeatedly without revealing further trace of the men.

CITY GROWING IN POPULATION

New City Directory Just Released Shows Increase

The new Greenville city directory made its appearance here today, showing a population for Greater Greenville of 14,012, as compared with 13,220 two years ago, when the previous directory was published.

INVADING JAPS NOT SATISFIED WITH NANKING

Warfare Threatens to Spread To South China Coast

'LASTING PEACE' EXPRESSED AIM

Official Japanese Communicate States Far East Conflict is Far From Settled

Shanghai, Dec. 17.—(AP)—Chinese-Japanese warfare today threatened to spread to the South China coast in far flung attacks of Japanese forces "not satisfied" with the capture of Nanking.

The Japanese communicate proclaiming the formal triumphal march into the fallen Chinese Capital declared the "armed forces of the Empire are determined in their endeavor to carry on to a conclusion the purposes of the present expedition, establishment of lasting peace in the Orient."

Chinese sources expected a Japanese attempt to invade Kwangtung province and attack Canton, 60 miles Northwest of the British Crown colony of Hongkong.

Vice Admiral Kiyoshi Hasegawa's communicate declared the Japanese government was "not satisfied with the success of its armies with the capture of Nanking. The situation is far from being settled."

A group of American, British and Japanese gunboats, meanwhile, carried to Shanghai the dead, wounded and other survivors of the sinking of the United States gunboat Panay and destruction of three Standard Oil vessels. An American naval board started an investigation of the tragedy.

Forty Years Ago Today

Friday, December 17, 1897

THREE IN QUICK SUCCESSION
Greenville Has This Number of Fire Alarms Thursday Evening—Little Damage At First Alarm—But the Last One Is a Big Fire—John Flanagan Buggy Co. Factory Destroyed—Total Loss About \$10,000.

Thursday was full of excitement in Greenville, there being three fire alarms within a space of five hours. The first alarm was given between four and five o'clock when flames were seen bursting from a kitchen to a dwelling house on Dickinson avenue, belonging to W. T. Godwin. This building was only a few feet from the Presbyterian Church and also near to several other residences and people saw that if fire got a good hold there it would be serious. The Rough and Ready Fire Company (Colored), was first on the scene and with a good bucket brigade soon had the fire subdued. Hope Fire Company was also on hand but owing to the long distance the engine had to be carried to find water, the fire was practically out before a stream was turned on. The kitchen was burned and the end of the house considerably damaged. How the fire originated is not known.

The Second Fire.
The town had about settled down from this excitement when there was another alarm about 8 o'clock. This time the fire was seen on the roof of the house of George Dudley, colored, known as the old Nelson house on Front Street. The firemen were on hand again and stopped the fire before any damage was done.

The Third Fire.
About 9 o'clock the alarm sounded again for the third time. The fire was in the John Flanagan Buggy Company's factory, a place where frame buildings were very thick, most of them old and dry and there was plenty of fuel for a big fire to feed upon.

Both fire companies and hundreds of citizens were promptly on the scene and excellent work was done. And such a fine stream was pouring on the raging masses of flames in the wood room of the factory. There was so much shavings and inflammable material in this room that the fire was a stubborn one. They put out one side of the building and had just gotten around to attack the flames on the other side when a section of hose burst. It required some minutes to remove this section and couple again and in this time the flames gained such a headway that the factory could not be saved.

The firemen set to work to prevent the fire from spreading; playing the stream first on the burning building to deaden the heat as much as possible and then on the adjoining buildings. In this was the Hotel Macon, Mrs. Hoell's building, and O. Hooker's building, both were saved and at the same time the hook and ladder and bucket brigade saved the lively stables on the other side of the fire. That was splendid work for all these buildings were in imminent danger and had a close call. After two hours hard work the fire was entirely under control.

The Losses.
The entire plant of the John Flanagan Buggy Company including the long alley building which they used for undertaking and storage rooms, store building owned by F. J. Johnson, and two room kitchen and one small outbuilding on the Hoell lot, were burned. The Buggy Company lost the greater part of their tools, stock, material, and 27 buggies. Their loss was about \$5,000 and was covered with only \$800 insurance.

F. J. Johnson placed his loss at \$1,000 with no insurance. Mrs. Hoell's loss was about \$400 with no insurance.

Notes.
Two of the nozzlemen, Ed Flanagan and Ed Greene, were overcome by the heat about the time the fire

got under control. They held their position in the hottest part of the fire for about two hours and did some brave work. John Cheek was also overcome by the heat but all of them were soon all right. All of the firemen deserve commendation for their good work.

People living several miles in the country who saw the light of the fire came to town.

The fire demonstrated the fact that more hose is needed for our fire department.

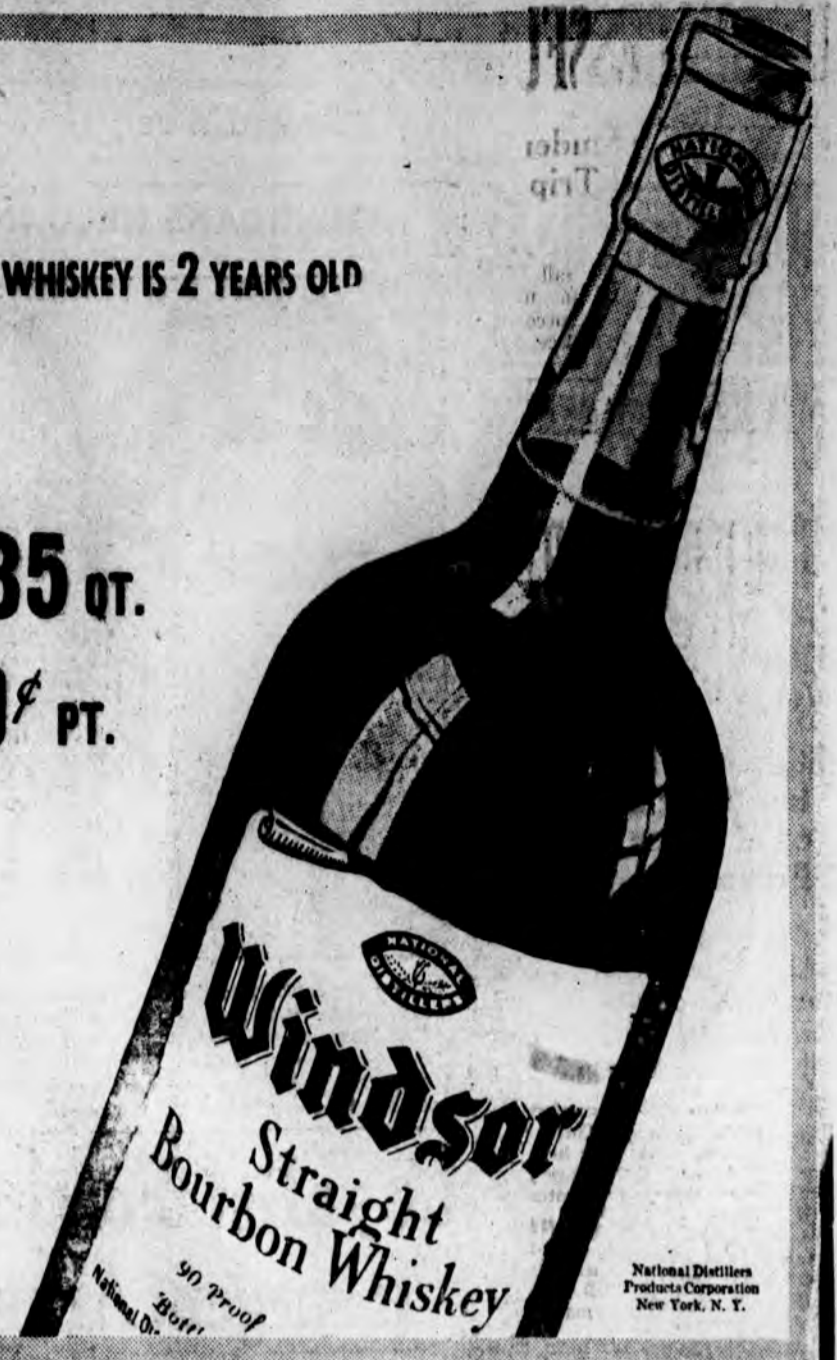

TERM AT STATE IS SUCCESSFUL

Most College Students Buy Round-Trip Fares

Raleigh, Dec. 17.—The fall term at N. C. State College, in many respects, was the most successful in the history of the college, Col.

J. W. Harrelson, administrative head, asserted today. "The spirit of the faculty, students, and alumni has been exceptionally fine," he said, "and our registration was 150 percent higher than for any previous quarter. The placing of all graduates of last year's class had a large part in this increased enrollment. "In many instances the demand for our graduates far exceeded the number we had available," he said. Dr. E. E. Randolph, head of the chemical engineering department, had requests for six men trained in chemical engineering from four processing and chemical plants of national reputation. The requests

could not be filled. The graduates were not available. Prof. A. F. Greaves-Walker had a similar number of requests from porcelain and structural clay plants with whose demands he could not comply with the same number of ceramic engineering graduates. Since 1901 Thomas Nelson, dean of the textile school, has not had enough graduates to supply the demand. The final registration figures for the fall term, according to W. L. Mayer, registrar, reached 2,106, and the number of students who dropped out of school during the term was smaller than for any other period in the history of the college. Final examinations for the fall term were concluded officially yesterday, and more than 2,000 students left for various parts of the United States. Through the consensus of student opinion was that the fall term finals "could have been together, but we can't see how," only the most pessimistic failed to buy round trip tickets as they left Raleigh.

Raleigh, Dec. 17—There may have
been "lay offs" in a number of in-
dustries in North Carolina during
November, but the stork continued
to make its rounds with even bet-
ter than normal frequency as 6,423
births were reported in the state
for the month.

All of which brought the total
births for the first 11 months of
1937 to 13,170, a gain of 6,996 over
the corresponding period of 1936.
Deaths during the same months of
1937 totalled 30,703, against 32,280
through November in 1936.

The state's net increase in popu-
lation, due to births in excess of
deaths, reached 42,467 for the 11
months of this year, thus maintain-
ing the rate of nearly 50,000 for the
year.

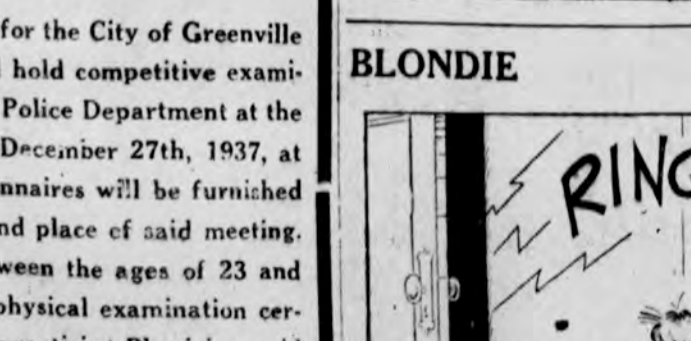

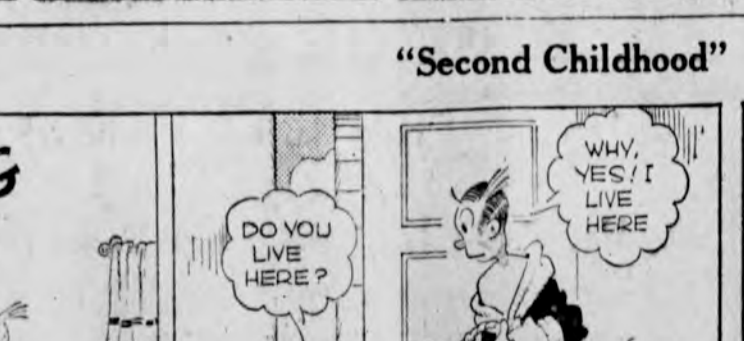
