CHINESE OFFER NO RESISTANCE FOR PORT CITY

North China Seaport of Tsingtao Occupied By Japs

CHINESE PREPARE DEFEND RAILWAY

Reinforcements Rushed Into Southern Shantung To Meet Advancing Japs

Tsingtao, Jan. 10.—(AP)—The Japanese navy tonight occupied this rich North China port without firing a shot. Landing parties of Japanese marines marched in without meeting the slightest opposition.

First of the forces of occupation to arrive was a contingent of four hundred marines which landed 18 miles from here and marched in. Shortly afterward Japanese troops entered the harbor and began disembarking additional marines. Five Japanese destroyers lay off shore.

The Japanese posted patrols and began lowering the white flags, which in accordance with previous Japanese demands, had been raised in token of surrender.

The only signs of Chinese hostility were the acres of dynamited, burned and looted Japanese cotton mills and other properties which the Chinese military destroyed before abandoning the city 10 days ago.

Meanwhile Chinese reinforcements pushed into Southern Shantung province to meet advancing Japanese who threaten the Loochow railroad, China's east-west life line.

A decisive battle for control of the area appeared imminent. Japanese forces were approaching from both the north and the south.

Cardozo Declared To Be Some Better

Washington, Jan. 10.—(AP)—Physicians reported improvement today in the condition of Justice Benjamin Cardozo, who they said recently had suffered "alarming" heart attacks.

They said, however, that the 67 year old jurist, who has been ill for a month, would not be able to return to the Supreme Court bench for some time and must be kept "absolutely quiet."

Dr. J. P. Ernest, Cardozo's personal physician, said consultations had been held almost daily with heart specialists.

Justice Cardozo suffered similar heart trouble in June, 1935, but fully recovered. He was appointed to the Supreme Court bench in 1932 by President Hoover and has been one of the justices most sympathetic to Roosevelt's administration legislation.

MAY BEGIN ON POWER PLANTS

Court Takes Action to Permit Immediate Construction

Washington, Jan. 10.—(AP)—The Supreme Court took action today which will permit four Alabama municipalities to begin immediate construction of Electric Power plants with loans and grants obtained from the Public Works Administration.

At the request of the government Chief Justice Hughes ordered that the Supreme Court's decision last Monday on PWA loans and grants be placed in effect immediately instead of waiting the customary 25 days to permit the losing litigant to file an appeal.

The court last Monday held that private power companies had no legal right to challenge PWA loans and grants for publicly-owned power plants.

Similar action was taken by the court last week to permit immediate construction by Greenwood county, S. C., of a power plant at Buzzard Roost.

Mrs. Barber was born and reared in Pitt county and spent her entire life in the Winterville community. She was a member of the Reedy Branch Free Will Baptist church, and manifested much interest in the activities of the church.

THESE FISHERMEN KNOW JUST WHAT TO EXPECT

Minneapolis.—(AP)—Minnesota fishermen don't waste time angling for pike in bass lakes.

The Minnesota lakes are classified by conservation zoologists so that fishermen will know which fish are most likely to be caught in the various lakes. Two hundred lakes already have been catalogued.

This zoological study also has shown Minnesota authorities which fish will thrive in the different lakes and has aided in restocking.

Murchison, du Pont Heard by Senate Investigators

Washington, Jan. 10.—(AP)—Two business spokesmen today denied before a Senate investigating committee that industry was striking or threatening to strike against administration policies. Both called for tax revision to restore investment confidence.

They were L. Mont duPont, the manufacturer, and Dr. Claudius T. Murchison, president of the Cotton Textile Institute.

Murchison told the committee his industry had "opposed with every power at its command the downward trend of business and resorted to production curtailment only with the utmost reluctance."

Murchison added it could not be charged that the industry "has engaged in any thought or action that might be interpreted as indifference to its social and economic responsibility or hostility to the general national interest or which has been referred to as a strike against the administration."

Washington, Jan. 10.—(AP)—Lammot du Pont told the Senate Unemployment Investigating committee the E. I. du Pont de Nemours and Company expects a 21 per cent drop in sales during the first half of 1938, compared with the first six months in 1937.

"I hope that this forecast proves erroneous," the president of the company told the senate committee, "but on the basis of careful estimates I can not be too hopeful of increased employment in our company during the first half of this year, for it is evident that we are in a pronounced recession."

DuPont said he had no "panaceas" to improve business, but that "government and business should take counsel together in a spirit of forbearance and cooperation." He asserted, however, that tax uncertainty, the fear of higher prices due to the rising public debt, uncertainty as to the value of money, the number of strikes and "fear of changes in and the manipulation of the legal rules under which business must operate" had contributed to "the present fog" of business.

Maxwell Explains Intangibles Levy

Pinehurst, Jan. 10.—(AP)—Revenue Commissioner A. J. Maxwell presented today the secretaries of North Carolina Merchants Associations a "primer" on the state's new intangibles tax law and concluded with an appeal for "wholehearted support and cooperation in making a success of this extremely moderate tax law."

"It is expected," Maxwell told the secretaries, "that the revenue at the greatly reduced rates will be greater than under the former, much higher rates by reason of a more general and complete disclosure of this class of property."

SEEK TO SHAPE GREAT BRITAIN JAPAN POLICY

Imperial Conference Summned to Meet With Emperor

Tokyo, Jan. 10.—(AP)—An Imperial conference was summoned today to meet in the presence of Emperor Hirohito tomorrow to decide formally "Japan's unshakable policy toward China."

The conference was ordered after Premier Prince Fumimaro Konoe placed before the Emperor the government's decision on future policy in China. Details of the plan were kept a strict secret pending a decision by the imperial conference.

Chiefs and vice chiefs of the army and navy general staffs, the Premier and the foreign minister, navy, home and finance ministers will attend the session.

Japanese press reports have said that the cabinet in two days of conference with the Imperial headquarters was drafting a program to "destroy the anti-Japanese administration in China."

The foreign office spokesman declared Japan was prepared either for peace or prolonged hostilities, and added that peace was impossible so long as China's Generalissimo Chiang Kai-Shek maintained his anti-Japanese attitude.

STATUES BROKEN IN 1812 RESTORED AT MISSION

San Juan Capistrano, Calif.—(AP)—Three images of saints which were installed in the old mission here the year the Declaration of Independence was signed have been restored to their pedestals. Toppled off and broken by the earthquake of 1812, they lay in pieces until recently repaired by order of the Rev. Arthur J. Hutchinson, pastor.

RALEIGH LAST WEEK

Raleigh, Jan. 10.—Two North Carolina officials went into action last week in behalf of the state and the South, in the important matter of discrimination in freight rates and wages.

Two North Carolina jurists, one a member of the state's Supreme Court, the other a Federal Circuit Court of Appeals judge, took places in the public eye as likely timber for the United States Supreme Court.

The pair who took up the cudgels for Dixie were Governor Clyde R. Hoey, who urged on President Roosevelt the necessity of a wage differential if and when a wage and hour bill is passed, and Utility Commissioner Stanley Winborne who went to Atlanta to look after the state's interests at a hearing on the railroad's request for a flat 15 per cent increase in freight rates.

Nothing much was printed about Governor Hoey's attitude at the Southeastern Governor's conference with the President, but it is a practical certainty that he did present to F. D. R. the views he is known to hold on the wage-hour bill.

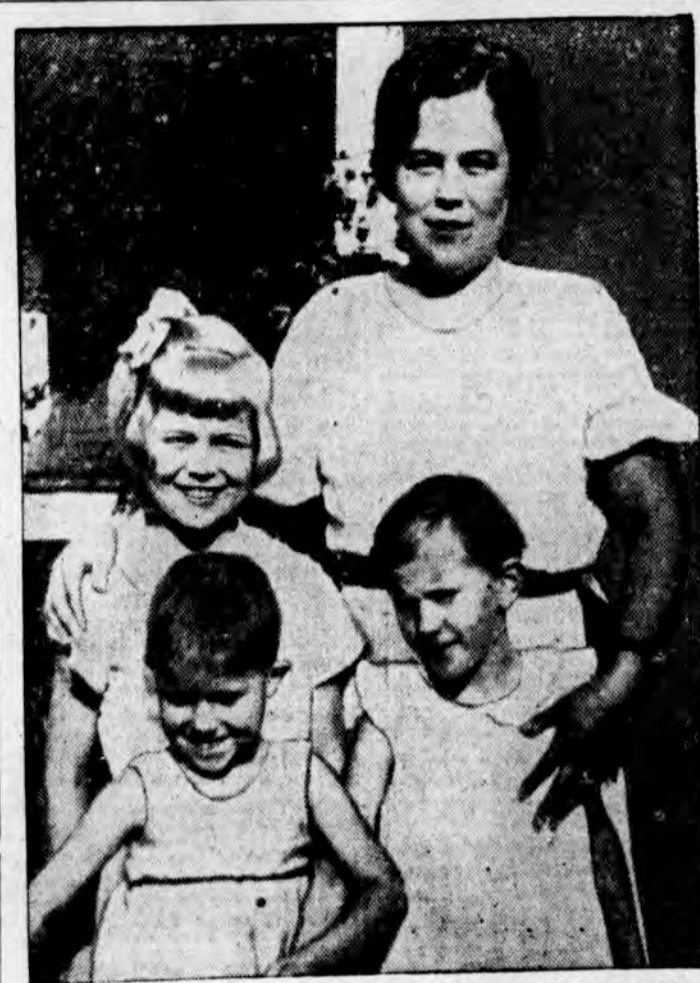
Commissioner Winborne reiterated to the I. C. C. examiners his previous contentions that a flat percentage increase in freight rates would add to the heavy differential already in effect against the entire South.

Chief Justice Walter P. Stacy and Judge Justice Miller of the Circuit court of Appeals for the District of Columbia, are known to be on President Roosevelt's list of eligibles to succeed Justice George Sutherland, whose retirement from the U. S. Supreme Court will take effect January 18.

Judge Stacy's name has been presented by the entire North Carolina Congressional delegation. Judge Miller stands high in the Roosevelt favor.

The week was brought to a close with a rousing Jackson Day dinner here to celebrate the raising of a \$12,500 contribution to the Democratic Congressional campaign of 1938. Donors gave \$25 each, no more no less, under a plan devised by

Insurgents Score Gains In Battle Over Teruel

Victories Indicate Conflict For City Far From Over

Hendaye, Franco-Spanish Frontier, Jan. 10.—(AP)—Fresh insurgent victories indicated today the battle for possession of Teruel was far from over, despite the government's success in crushing all resistance within the captured provincial capital.

Dispatches said government commanders had decided on counter attacks north and south of Teruel to offset insurgent victories.

The capture of La Coca, plus further gains by General Francisco Franco's troops in the Villastar sector southwest of Teruel threatened to cut the Government's communication between its flank elements and their supply base, the dispatches said.

Insurgent sources reported steady progress on the two wings had enabled them to form an arc around Teruel, while the government was concentrating on subjugating the insurgent garrison trapped within the city when Government troops took it in a surprise attack more than two weeks ago.

The surrender of this insurgent garrison and civilian supporters numbering about 6,000 was completed Saturday night, according to the government.

POPULAR VOTE FOR WAR BILL PUT ON SHELF

House Refuses to Consider Proposed War Referendum

CHIEF EXECUTIVE CONDEMNS PLAN

Speaker Bankhead Takes Floor to Read Letter from President and Oppose Bill

Washington, Jan. 10.—(AP)—The House shelved the proposed war referendum amendment to the Constitution today, voting against floor consideration of the proposal.

Speaker Bankhead announced the vote against the referendum was 209 to 188.

The motion went down to defeat shortly after the House had heard Speaker Bankhead read a letter from President Roosevelt condemning the amendment, offered by Representative Ludlow (D-Ind.).

The resolution would have authorized a constitution amendment which three-fourths of the states would have to approve calling for approval of the people in a national election before the United States could declare war.

The President warned that the proposal would "cripple any President" in his conduct of America's foreign relations.

It also would encourage other nations, the President said, to believe that they could violate American rights with impunity.

Bankhead left his rostrum to read the letter and to speak against the referendum. It was one of the rare instances he had taken the floor to discuss pending legislation.

Asserting he left his place as an impartial presiding officer with the deepest regret to speak against the legislation, the Speaker said: "I measure my words when I say that in my opinion this is the gravest question that has been submitted to the Congress since I became a member of the House 20 years ago."

He then described the referendum as a "radical and revolutionary attack on the fundamental basic principle of representative democracy."

Senator Harrison (D. Miss) took up the Southern battle against the anti-lynching bill in the Senate by reading to his colleagues a plea from Andrew Jackson for state's rights.

M. C. McFever, white man convicted of drunkenness, was taxed with the court costs.

Willie Watson and Jesse Johnson, Negroes, were fined five dollars and half the costs each on a charge of engaging in disorderly conduct.

Sherman Heath, Negro, was taxed with the costs upon conviction of a traffic law.

Heber Ross, convicted of drunkenness, was fined five dollars and taxed with costs.

Despite the fact that a title announces that the Panay scenes are presenting without editing or censorship, the Universal Newsreel commentator, Graham McNamee, provides a running tract of dialogue dripping with fiery tirades directed against the Japanese and having an unquestioned effect of arousing the American temper.

"Several pungent remarks have been made during the past few days on the news-reel coverage of the Far Eastern situation—a most interesting one from Walter Winchell, who in his newspaper column recently said that for the most part the (newspaper) editorialists refused to get hysterical over the Panay bombing and urged a keep-your-shirt-on attitude. But the news-reel narrators put on the big jimmy act—noticeably those over the soldier's eye.

"The attitude of the Administration in its tacit encouragement of the showing of the editorialized Panay films is possibly a taste of the type of propaganda which the people may be wished to when the Government wishes support for a desired program.

"It is essential, therefore, if one is to keep his balance, to divide what the news-reels are portraying—the actual scenes on the screen from the running comment. And if news went to formulate your own decisions without benefit of news-reel commentators, don't hesitate to let the news-reel editors know how you feel about it.

"In the Fox Movietone version, there is one scene—a long shot of a small boat of Japanese. We are told by the announcer, supposedly looking over the Panay before the bombing. Of course it is impossible to tell at just what point this bit of footage was taken. Paramount and News of the Day also carry scenes of the Panay disaster; and both contain biased editorial comment."—From Bulletin on Current Films (No. 49) of Moving Picture Department of National Council for Prevention of War.

Reflector Bureau

Raleigh, Jan. 8.—Of the many tons of peanuts purchased by the Peanut Stabilization Corporation in North Carolina this season, in an effort to stabilize prices, State Department of Agriculture inspectors have found 90.7 per cent to be in "Class A" according to Federal standards. A. B. Hatless, supervising inspector with the department's markets division, said today:

Harless explained that "Grade A" peanuts contain 50 per cent "meat" and are being purchased by the corporation at 325 cents per pound from the grower.

"Of the remaining nuts purchased, 8.1 per cent have fallen in Class B" — nuts containing a minimum of 60 per cent meat — purchased at 305 cents per pound, leaving only 12 per cent of the crop in Class C which was purchased for 285 cents per pound," Harless added.

The peanuts that have fallen into Class B and C so far this season were found to be prematurely harvested, picked before thoroughly dry or improperly stacked, or a combination of the three faults.

Harry T. Westcott, of the department's marketing staff, who has just returned from inspection work in the peanut belt, said that farmers are well pleased with entire stabilization program, feeling that it has been an economic salvation.

All State Department of Agriculture inspectors have reported that farmers generally agree that their peanuts this year have been of best quality in several years and are "highly pleased with the methods of grading used."

Westcott said that "Warehouse space is available for storage of the remainder of the entire North the peanut receiving points."

# 20TH CENTURY AUDUBON RECORDS SONGS OF BIRDS

(By THE AP Feature Service)  
ITHACA, N. Y.—The life of Albert R. Brand is a lyric.

He quit the stock market in 1928, before the big tumble. He retired at 39. And for 10 years he has been capturing bird songs.

The former stock broker has become one of the foremost authorities on the songs and calls of birds. In capturing those songs and calls on phonograph records, he is an ornithological pioneer. Brand started in the financial game at 15 as a banking house employee. He was so busy for the next 24 years he had no time for the kind of education he wanted. At 25 he was youngest member of the New York Stock exchange.

Built Recorder

"But just wait until we really grow up," says Marjorie. "We are going to be Olympic swimmers."

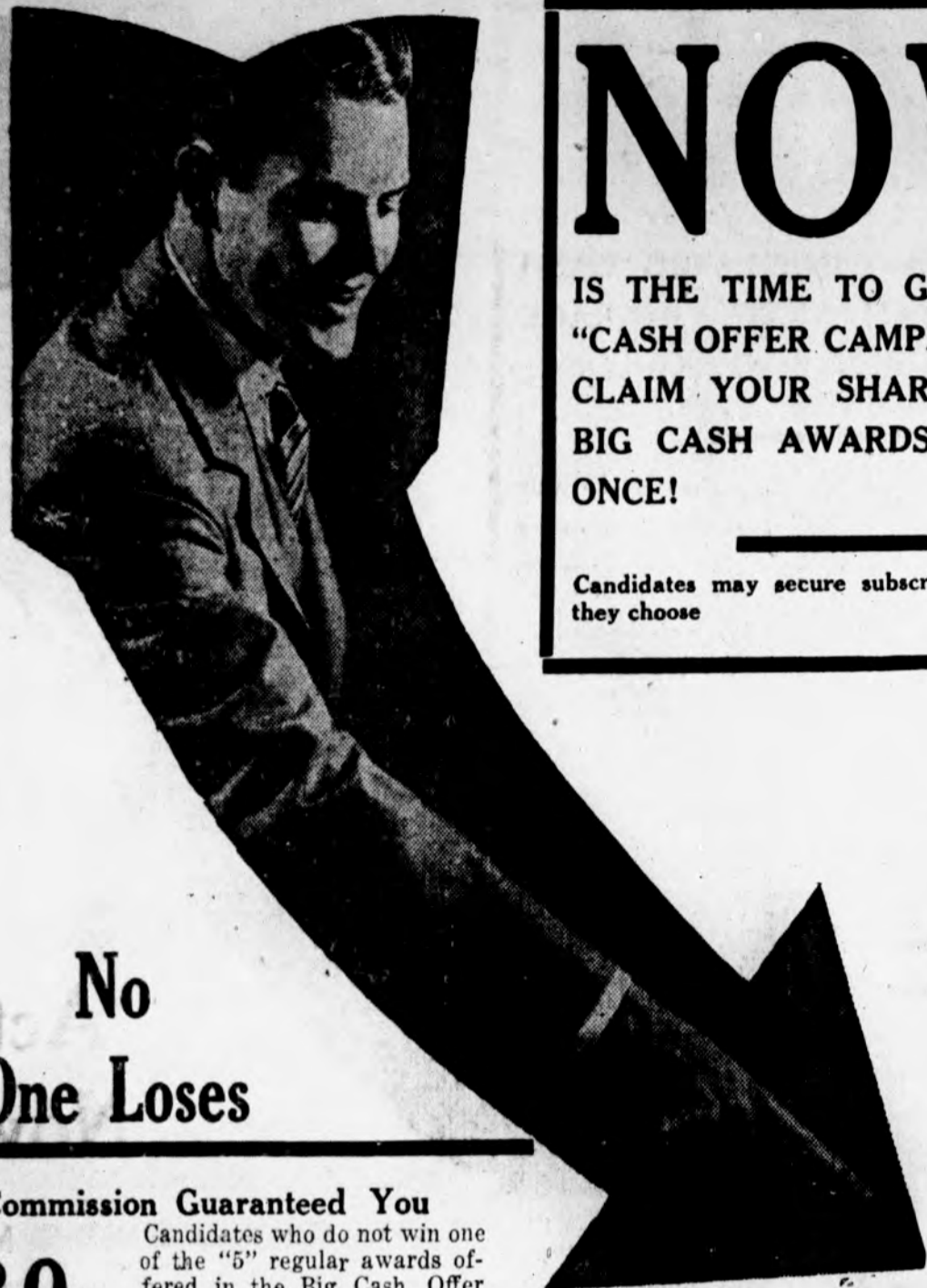

## RURAL LIBRARY PLAN FAVORED

### Campaign On Provide Books For Rural Residents

Raleigh, Jan. 10.—A campaign for the establishment of home demonstration club libraries over the State will be pushed this year, it was announced today. Several such libraries have been established, said Ruth Current, state home agent at State college, but there are still thousands of rural families without ready access to good books. In the 77 counties where home demonstration work is now being conducted, Miss Current has asked the agents to give special consideration to library work. Marjorie Beal, secretary of the N. C. Library Commission, has offered her help in the home demonstration library program and has recommended books of particular interest to rural families. Included on the list are fiction, biography, religious books for children, and books of an informative or educational nature. As an example of the interest club women have in good books when they have an opportunity to get them, Miss Current said the Johnston County home demonstration library loaned 183 books during the month of December. The women not only read the books, but they get members of their families to read them, too, and they also make reports on the books at their club meetings. The reports help other women learn something about more books than they can read themselves, Miss Current added. Reports from one woman also helps other women decide which books they want to read.

**FEW CONDORS LEFT. SURVEYS SHOW** Santa Barbara, Calif.—(AP)—The giant American condor which once ranged from the Columbia river to Mexico is reduced to a few small colonies in the California mountains, recent surveys have shown. Leonard Swanson of this city estimates that about 50 condors live in two colonies in the Santa Barbara national forest. Two small colonies also are reported in Kern county. In the spring an expedition will try to photograph the big scavengers in their native habitat.

## Advise Livestock Men To Purchase Cattle At Present

Reflector Bureau Raleigh, Jan. 10.—Livestock men of North Carolina will find it profitable to buy their feeder cattle between now and February 15th unless an unanticipated rise in the market occurs. Paul L. Fletcher, livestock marketing specialist for the State Department of Agriculture announced today.

Substantiating his contention that feeder cattle should be purchased at once, Fletcher said that "cattle prices seem to have been purged of an overdose of inflation resulting from drought conditions of 1936 and a rise in prices for medium and fairly good beef is indicated for the month of March and April." The marketing authority said that "it is estimated that the cost of producing cattle at the present time is about 8 cents a pound and with the abundant supply of feed in North Carolina, it is logical that the livestock growers afford to continue feeding animals now lacking sufficient condition necessary to yield a price in keeping with present production costs," adding that "medium to good feeder cattle can now be purchased at midwestern markets for six to seven cents a pound."

Reviewing the livestock market, Fletcher stated that "cattle prices have declined during recent months from 25 to 50 cent as compared to high prices paid last September with many cattle feeders who insisted on buying stock at that time bearing losses ranging as high as \$1,000 per carload."
