FRANCE RELIEVED ON CHAUTEPS FORM CABINET

Summoned For Task After Blum Fails In Efforts

CALM PERVADES CHAMBER'S HALL

Country's Restlessness Increased By New Discoveries Of Concealed Arms

Paris, Jan. 17. —(AP)—Camille Chautemps struggled in an anxious atmosphere today to form a new People's Front ministry to end France's four-day crisis precipitated when his own cabinet resigned Friday in the face of financial and labor troubles.

President Albert LeBrun summoned the Radical Socialist former Premier after Leon Blum, Socialist leader, failed to gain support for a "National Union" government. A strained calm pervaded the halls of the Chamber of Deputies and was evident throughout the nation as France's acute financial and labor problems continued unsolved because of the failure to organize a ministry.

The country's restlessness was increased by new discoveries of hidden arms in the Surete National's drive against Leftist and Rightist revolutionary organizations. After his conference with LeBrun, Chautemps indicated he would attempt to form a cabinet modeled substantially on his old People's Front government, retaining several of his previous ministers.

It was reported in the Chamber of Deputies that Socialist opposition was developing to a new Chautemps cabinet.

Nine Persons Face Police Court Here

Nine defendants, three of them white men, faced Mayor M. K. Blount in City police court this morning.

Peattie Jones, Negro, was bound over to County court under bond of \$200 on a charge of possessing whiskey for the purpose of sale.

Noah Harris, Negro, was ordered held under bond of \$300 to face a charge in County court of having liquor for sale.

Robert Lee Williams and Floyd Hardy, Negroes, were bound over to Superior court under bond of \$300 each on a charge of larceny of a cow.

Charlie Morgan, white man, convicted of drunkenness, was fined \$10 and taxed with court costs.

Ben David Sutton, also white, was taxed with court costs upon conviction of drunkenness.

Bo Peep Joyner, Negro, was convicted of drunkenness and was fined \$10 and ordered to pay costs of court.

Zeb Durham, white man, was convicted of selling merchandise without a city license and was ordered to purchase the permit and pay the costs of court.

George House, Negro, was convicted of assault and taxed with costs of court.

Judge Grady Here For Civil Session

A one week session of civil court started here this morning with Judge Henry A. Grady of Clinton presiding. The term will be followed next week by a criminal session of Pitt Superior court.

The civil calendar lists a number of cases, none of which is regarded as of general interest. The criminal calendar, also already published, carries a number of cases involving various charges.

Mother Of Principal Is Claimed By Death

Several Pitt county citizens attended funeral services in Elizabeth City this afternoon for the mother of C. D. Ward, principal of the Winterville school.

Mrs. Ward died suddenly Saturday afternoon. The funeral was held at 2 o'clock this afternoon.

Among those attending were D. H. Conley, superintendent of the Pitt county school system; J. P. McBryde, principal at Grimesland, representing the principals of the county; and representatives of the Greenville Kiwanis club, of which Mr. Ward was an active member.

PAYMENTS DUE JANUARY 31ST

To Mail First Checks For Unemployment Benefits

Raleigh, Jan. 17.—First checks for unemployment benefits in North Carolina will be delivered on Monday, January 31, just four weeks from the first Monday in January when claims were filed by unemployed workers, according to the present schedule. These four weeks include the two weeks of waiting required by the law, the third week for the benefits to accrue, and another week for reports to be examined, checks to be written and returned, and delivered to the worker.

The Unemployment Compensation Division will deliver every check due workers during the week beginning January 31. Three machines have been installed in the office in Raleigh for writing checks. Approximately 30,000 workers filed claims the first week, but there is no way of telling how many of these are eligible for benefits, or how many will be back at work before the waiting period and third weeks have expired. One-half, two-thirds, three-fourths, or any part of the 30,000 may be eligible finally.

The State Unemployment Fund collected in contributions of employers for 1936 and 1937 reached almost \$9,400,000 by the end of last week and E. W. Price, director of the division, estimates that the fund will be \$10,000,000 before the employed worker. The December first check is delivered to the unemployed by the end of the month. Also the commission has secured \$300,000 from its fund in the U. S. Treasury and deposited it in Raleigh to meet the first benefit payments. Other amounts as needed will be drawn from the fund.

The Commission has been advised that \$123,392.82 has been placed in the fund.

WHAT IT MEANS: Our "Bigger Navy"

Washington, Jan. 17.—(AP)—All this talk of the United States building "a navy second to none" boils down to this: Uncle Sam is getting into the naval rearmament race—five years behind the leaders.

In naval building, the United States has been marking time since the Washington naval treaty was signed in 1921.

That treaty halted the maddest building race the world had seen until then, and established the ratio among the three leading naval powers at 5-5-3. It meant Great Britain and the United States each could maintain 15 battleships to Japan's 9, and the rest of their fleets in like proportion.

The British and Japanese were happy to sign on the dotted line back in 1921, because the race was

Jap Invaders Believed Pushed Back on Several Fronts

CHIANG ON VISIT TO FRONT LINES

Generalissimo Of Chinese Armies Orders Troops Not Retreat a Single Inch

Shanghai, Jan. 17.—(AP)—Chinese armies of the Northern, Central and Yangtze valley fronts were reported today to have pushed back Japanese invaders in a series of counter-attacks.

Advices through Chinese channels said Generalissimo Kai-Shek, in a second visit to front lines, had ordered his troops "not to retreat a single inch."

Chinese reported that: 1—The Chinese light army organized from one-outlawed Communist units, inflicted heavy losses on Japan in central Shanghai province.

2—A Chinese force along the Yangtze river above Nanking pushed back Japanese outposts, occupied two villages near Wuhu and prepared for an attempt to recapture Wuhu itself.

3—A Chinese guerrilla unit captured Chwangsha on the Pootung peninsula opposite Shanghai, bringing a Japanese declaration of martial law in Pootung.

4—Outer Mongolian troops advanced against Paotow in the Northern province of Suiyuan. From Nanchang Soviet-manufactured airplanes raided Japanese airfields and military concentrations.

South of Shanghai a strong Chinese force on the South banks of the Chientang river was said to have blocked Japanese attempts to advance from Hengchow.

BRIEF RESPITE IN SPAIN'S WAR

Insurgent Air Raids Along Coast Only Activity

Hendaye, Franco-Spanish Frontier, Jan. 17.—(AP)—Insurgent air raids along the Mediterranean coast were practically the only notable activities today in the Spanish civil war.

Except for minor operations on the Granada front, where insurgents said they straightened their lines, ground forces engaged in little fighting.

Insurgent planes caused greatest damage at Cabana, near Valencia, where the government said five persons were killed and 40 wounded by bombs. One insurgent raider was reported shot down.

The Government said several bombs were dropped near a British vessel anchored off Barcelona. In the Teruel area, insurgent troops were reported resting from their prolonged effort to retake the strategic city and Government defenders were content to hold their ground.

BAILEY FEELS FARMERS RENT BILL DEFEATED TO NEIGHBORS

Imminent Show-Down Predicted on Senate Filibuster

Washington, Jan. 17.—(AP)—Predictions of an imminent show-down in the Senate's anti-lynching filibuster brought expressions of confidence today from both supporters and foes of the controversial bill.

Senator Connally (D-Tex.) leader of the Southern opponents, said there were enough speakers to continue talking against the measure until the pressure of other legislative forces proponents to shelve it. "I think we have got it beaten," said Senator Bailey (D-N.C.) "The longer it is debated, the more apparent it becomes it should not pass."

Some administration Senators, however, forecast that night sessions would be ordered soon and that such a step would cause the filibuster to collapse. A few even talked of limiting debate, although opponents desired they could block that proposal.

Senator Barkley of Kentucky, the Democratic leader, said he had not yet decided when night sessions might be had.

"So far," he asserted, "the debate has kept fairly close to the bill under consideration." He emphasized that "the administration is not taking sides" in the anti-lynching fight.

Barkley and other administration leaders have been hopeful some decision could be reached soon so that the government reorganization bill, next on the Senate calendar, can be taken up.

Passport Wins Old-Age Pension
Los Angeles (AP)—Back in 1844 old age pensions were not a live issue, but a passport of that date has just won a pension for an 81-year-old woman.

The passport was issued to her parents, enroute to Syria as missionaries. On their return in 1856 the present pensioner was born on the high seas, and the passport is the only document she has to prove the story of her American parentage.

It was accepted by Rex Thompson, county superintendent of charities.

Youth Confesses Attacking Couple Living In Trailer

Itinerant Showman Killed at Henderson; Wife Critical

DRIVER FOR PAIR HELD FOR CRIME

Robbery Theory Advanced by Chief Of Police Langston Following Investigation

Henderson, Jan. 17.—(AP)—Sheriff J. E. Hamlett announced today, a few hours after discovery of the badly-hacked bodies of an itinerant show couple, that a youth he booked as Clarence Fairbanks, 20, had admitted killing the man and wounding the woman officers said was his wife.

The sheriff quoted Fairbanks as saying he killed the man, named by the officers as Steve Good, with an axe after Good had struck him and had broken the axe handle over his head.

Fairbanks was quoted as saying he turned upon Mrs. Good after she entered the fray and struck him with a shoe.

Hamlett said Fairbanks told him the argument started at the trailer home of the couple last night.

The sheriff took Fairbanks to an unannounced jail. Mrs. Good was in a hospital, where her condition was described as critical.

Police Chief John Langston said Fairbanks led officers to the trailer and pointed out the bodies, saying he had discovered them upon returning from a restaurant where he had eaten.

DR. REYNOLDS PLAYING LEAD

Charged With Handling of the Reynolds Syphilis Fund

Raleigh, Jan. 17.—Dr. Carl V. Reynolds is playing a lead role in an ancient drama involving tragedy, suffering and death.

Other actors in the drama have been Christopher Columbus, Sir Walter Raleigh and Zachary Smith Reynolds. The theme is syphilis and the State Health officer is the only living principal character in this particular cast. He is holding out the hope of life and happiness to millions of supernumeraries. Of these 300,000 are in North Carolina.

Dr. Reynolds, armed with the income from a \$7,000,000 fund set up by the Smith Reynolds heirs, will wage relentless war on syphilis in this state. Incidentally, the health officer is not related to the tobacco Reynolds from whom comes the fund.

"The \$100,000 we have already received from the Reynolds Foundation for our campaign against syphilis in North Carolina will only enable us to scratch the surface the first few years, however," Dr. Reynolds said. "In fact, we estimated we will need the proceeds from this \$7,000,000 fund for at least 15 years in order to make any great headway in eradicating syphilis in the state."

CALL HEARING ON NOMINATION

Judiciary Sub-Group To Consider Reed For Court

Washington, Jan. 17.—(AP)—A Senate Judiciary sub-committee called a hearing today for Thursday on the nomination of Stanley Reed to the Supreme court.

The sub-committee was formally set up by the full Judiciary committee to consider the nomination. It is headed by Senator Logan (D-Ky.) who said the sub-committee would meet Thursday "to see whether anyone wants to be heard."

Members of the Senate Judiciary committee expressed certainty Reed would be confirmed as a Supreme court justice this week, enabling him to take his seat before any new cases are heard.

WPA SPENDING ADVOCATED AS BUSINESS AID

Program Suggested By Mayor LaGuardia of New York

URGES BUSINESS INVITE SPENDING

Witness at Senate Unemployment Committee Hearing Asks 'Break' for N.Y.

Washington, Jan. 17.—(AP)—New York's Mayor LaGuardia advocated today a new Federal public works spending program to meet the business recession.

He also urged business to keep prices down as a boon to private spending.

Bouncing up and down in the witness chair before the Senate Unemployment Committee, the mayor demanded a "better break" in the Works Progress Administration relief for employables in the nation's largest city.

Both LaGuardia and Mayor Harold Burton of Cleveland, urged expansion of the WPA program to take care of all jobless employables in the nation. The mayor of Cleveland said the government should keep out of the "boundless field" of direct relief.

LaGuardia recommended that in addition to launching a new public works program the Federal government prescribe for uniform work day and week standards.

He urged that the WPA take care of all employables who were out of jobs, that the United States Employment Service be brought under the Social Security Board and that steps be taken to provide the needy with food from the agricultural surpluses.

The accepted treatment now is one inoculation a week for 30 weeks of an arsenic preparation administered intravenously, followed by one "shot" a week for 40 weeks of a bismuth preparation, injected into the muscles.

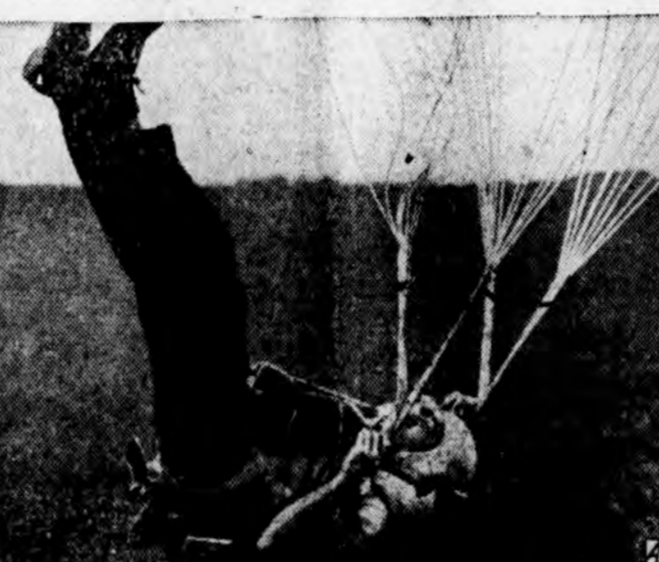

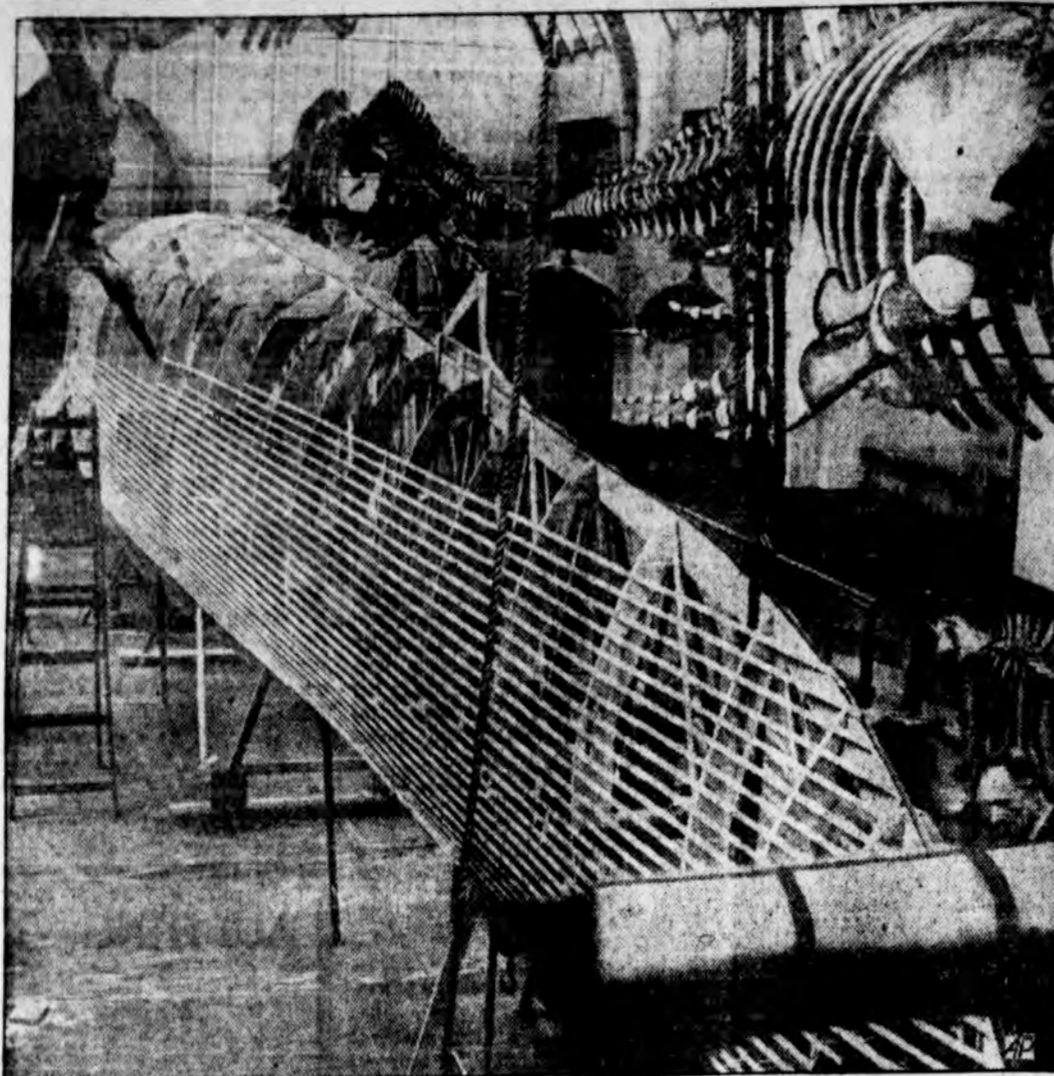

signing any more treaties, and notified the world she would be thru with agreements on January 1, 1937. Exactly a year ago, therefore, the race was on in earnest all over again.

There had been plenty of indications that the Japanese would be unwilling to sign up again long before she announced her decision. In fact, both the Japanese and British had been building up to the limits allowed by the treaties of 1921 and 1930. Uncle Sam, thanks to his geographical isolation, was slow to take alarm. He failed to build even all the treaty allowed him to have.

U. S. Gets Underway.
In 1934 circumstances conspired to draw the old boy back into the sea-saw naval race that even then was in the making.

War clouds were gathering in Europe and the Far East, and congress was trying to find somewhere to spend billions in relief money. On top of that, our navy was getting no younger.

Calculating the effective life of a battleship at 26 years, the first of our battleships would be too old to fight by 1938, half of them would be unfit for modern warfare by 1942 and the whole line of battleships would be obsolete by 1949. The rest of the fleet was aging accordingly.

So congress passed the Vinson-Trammell act—a law authorizing the navy to build up to par with the British fleet and justify our slogan, "a navy second to none." The navy got some \$300,000,000 to start building, and by 1939—if the whole program goes through—the navy will have spent more than a billion dollars for new ships.

A New Program.
To make our position secure, the navy now wants to finish the program started in 1934—and to start a brand new one besides. It is the request for new building that the President is passing to congress.

Navy experts say the Vinson-Trammell building program will merely give the United States a fleet in 1942 comparable to the British fleet of January 1, 1934—some five years behind the parade. Meanwhile other powers have put on another building spurt. The British are taking the lead with five new battleships. Nobody knows what the Japanese are doing now, but gossip says they are building three 44,000-ton battle-wagons. The United States is constructing two; and France, Italy, Germany and Russia account for the rest of a total of 20 battleships now building or about to start.

It looks as if the military music is going 'round and 'round—with no stop sign in sight.

defeat of the Ludlow War Referendum as the springboard from which to launch a statement almost putting her in the Senatorial race.

Troy T. Barnes laid \$100 on the line with the board of elections and announced himself prepared to lick the boots off Congressman John Kerr in the Second District.

Timous Valentine, famed for his strategic direction of other folks' campaigns, put up the ante needed to make himself a full fledged

candidate for Judge of the Second Superior Court Judicial District. Judge Walter Bone is the incumbent who has not yet made clear his intention with regard to the race.

Governor Heay said he'd like to have seen Supreme Court Chief Justice Walter P. Stacy appointed to fill the Sutherland vacancy on the U. S. Supreme Court bench. The entire Tar Heel Congressional delegation formally presented his name for consideration. Altogether it seemed to be labor in a hopeless cause, however, as appointment of a justice from the west is generally anticipated, making Stacy geographically impossible despite his recognized qualifications.

The Governor commuted the death sentence of Tommy Halls, Mecklenburg negro, and thereby stopped what would have been the first execution for first degree burglary in the last eight years.

Attorney General A. A. F. Seawell got himself lambasted by Sheriff David Jones of New Hanover county for saying that slot machine trouble must be attended to locally. In turn the A. G. countered by tagging the Jones tirade with the label "absurd."

The Highway Commission agreed to re-route Highway No. 1 through Raleigh, putting it back to its old path out Hillsboro street. This was done after great rowings and howlings by advocates of both routes.

Commissioner of Agriculture W. Kerr Scott started what may develop into an intensive campaign to aid North Carolina dairymen. His speech at Pinehurst is quite likely to result in more than a bit of recrimination before things get much further along.

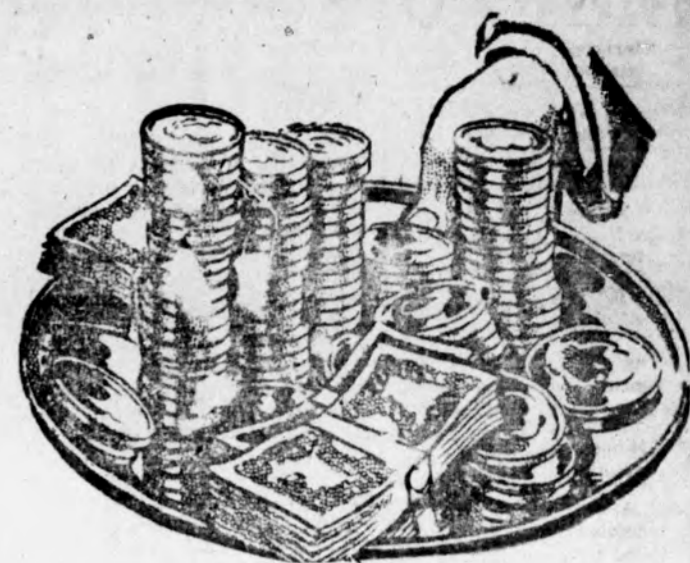
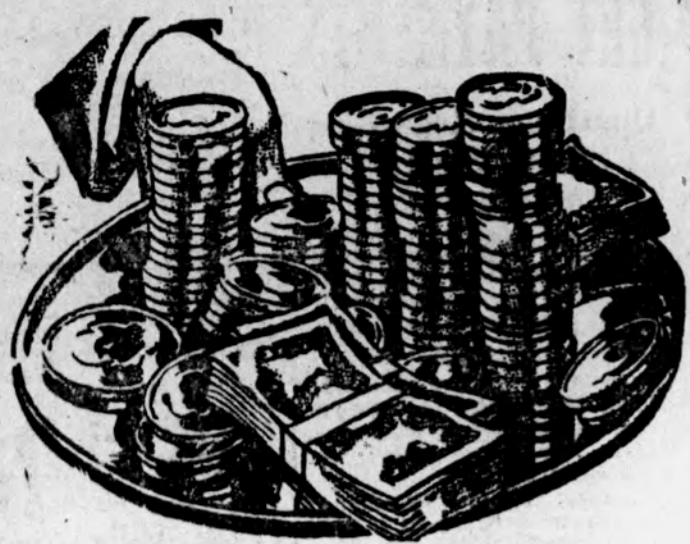

Hollywood Sights And Sounds

By Robin Coon

Hollywood—Now that all the critics have had their say about the past year's "bests" in the movies, it's interesting and revealing to check up on what the public had to say on the subject—at the box-office.

Oddy, in view of the legend to the contrary, the paying public and the non-paying critics were not too far from agreement. Before me now is a comprehensive chart on box-office strengths prepared by National Box Office Digest, a trade weekly issuing from Hollywood which rates the 1937 releases for monetary value.

"Saratoga" in First Place Box-office smash of the year (according to the Digest) was "Saratoga," which did 71 per cent above normal business. Not a "critic's picture," this had the pulling power of Clark Gable plus the "break draw" of Jean Harlow's posthumous appearance. Next came "After the Thin Man," included on at least one critic's "ten best." Then "Walkie Wedding"—Bing Crosby, Martha Raye, Bob Burns—and fourth "The Awful Truth," 61 per cent above normal and a popular "ten best."

The other "ten box-office bests" included "Thin Ice," "Maytime," "The Plainsman," "Lost Horizon," "One in a Million" and "A Star Is Born." Of these, "Lost Horizon" and "A Star Is Born" made many "critic's choice" lists. Below these, but far above normal, are found such films as "100 Men and a Girl," "Stella Dallas," "The Good Earth," "Captains Courageous," "The Prisoner of Zenda," "Dead End," "Stage Door," "The Life of Emile Zola," and "Camille," each of which has found its way to more than one critical "ten best."

Divergence on Starless Film Of course "Wee Willie Winkie" (Miss Temple) is rated equally with "100 Men and a Girl" and such underdogs as "Double Wedding" and "Artists and Models" have outdrawn — so far — both "Zola" and "Camille" and half a dozen other critically approved films.

Critics and public diverged most startlingly on "Make Way for Tomorrow," which is credited with a flop at 32 per cent under normal business. (It had no stars.) Films mentioned above are listed as costing "over \$500,000." In the cost bracket from \$200,000 to \$500,000 the smash hit was "Kid Galahad," 24 per cent above normal. In this group the critically lauded "Call It a Day" is rated as 14 per cent under, "They Won't Forget" 21 per cent under, and "Night Must Fall," picked by one reviewing body as the unqualified best of the year—17 per cent under.

EXPLAINS HOW GET PAYMENTS

Questions Regarding Social Security Answered

The following questions and authoritative answers are provided for the benefit of those desiring information regarding the Social Security:

Question: What are the requirements for obtaining unemployment compensation benefits under the North Carolina Unemployment Compensation Law?

Answer: The first requirement is that the person who seeks to receive unemployment compensation benefits must have been employed in an occupation covered by that law. Second, upon losing his job he must register with the employment service office for another job. If, after waiting the required number of weeks, which in North Carolina is two weeks, he has not been able to find a suitable job, he will receive unemployment compensation benefits for a limited number of weeks.

Question: I was 65 years old on December 18, and had a Social Security card, but haven't received my check yet. How do I go about getting what is due me under the Social Security Act?

Answer: You should get in touch with your Social Security Board Field office, give them all the information you can regarding your Social Security record, and make a formal claim for your old-age insurance. The amount you will receive will be 31-2 per cent of your total wages in covered employment since December 31, 1936, and the time you attained 65 years of age, which in your case was December 17. After the Social Security Board has determined, from the wage record kept under your Social Security account number, the amount due you, certification of your claim will be made to the Treasury Department. Your check will then be mailed to you from the Treasury of the United States.

Question: If my employer doesn't report my Social Security taxes, will I be able to collect my old-age insurance upon reaching 65 years of age, or if I should die, would my estate be able to collect it under these circumstances?

Answer: The amount which will be paid you under the old-age insurance provisions of the Social Security Act does not depend on the amount of taxes collected from you or paid by your employer under Title VIII of the Social Security Act. The amount you receive will depend on the total of your wages earned in covered employment after December 31, 1936, and before you become 65 years of age, or die. But the employer who does not obey the law and report the amount of wages paid each employee, puts his employees at a disadvantage because the Social Security Board will not have a record of those wages when it comes time to compute the amount the Board should pay each worker under the old-age insurance provisions of the law.
