HOUSE SLATED ACT PROMPTLY ON ARMS BILL

Expected Adopt Army-Navy Program By February 15

BEGIN HEARINGS ON NAVY MONDAY

Military Affairs Committee Chairman To Confer with War Department Heads

Washington, Jan. 29. — (AP) — Leaders said today they expected the House to pass President Roosevelt's huge army and navy expansion program by February 15.

Chairman Vinson (D-G) called the House Naval Affairs Committee to begin hearings Monday on a bill to authorize the \$800,000,000 naval building program.

He predicted a favorable report would be forthcoming after "two or three days."

The measure, carrying out Mr. Roosevelt's request for a 20 per cent increase in the navy's building limitations, would authorize 47 additional fighting ships, 22 auxiliaries and 1,000 airplanes. The President suggested that of the total, two battleships and two cruisers be started this year.

Chairman May (D-Ky.) of the House Military Affairs Committee said he would confer immediately with War Department officials to get their views on how best to fulfill the President's recommendation for strengthening land forces.

Members of a mid-western bloc in the House indicated, however, they would oppose the program set out in the President's special message yesterday.

Both House and Senate were in recess today and Southern Senator, held a caucus to review their night against the anti-lynching bill.

Meantime, some administration supporters in Congress said the President's forthcoming message on monopoly may suggest a long-range investigation rather than immediate legislation.

They said the complexity of the monopoly problem might make it desirable to set up a joint Senate-House committee to go over legislative suggestions and make recommendations for the next Congressional session.

Visiting Minister Speaks Tomorrow

Tomorrow morning at the eleven o'clock service in the local Presbyterian church, the Rev. Frank F. Baker, D. D., will speak. Dr. Baker, since 1931 president of Gammon Institute, Lavras, Brazil, one of the largest Protestant mission institutions in that country, is at present on furlough in this country and, through invitation, has included the Greenville church among those he is visiting in the interests of the foreign mission work of the Southern Presbyterian Church.

A native of Rowan county, North Carolina, and from the neighborhood of the old historic Thyra church, Dr. Baker was graduated from Davidson College with the class of 1913, going at once to Brazil where he taught in a mission school for four years. Coming back to this country for theological training and post-graduate work at Union Seminary, Richmond, Va., he again returned to Brazil where he became connected with Gammon Institute. Along with his administrative duties there as its president, he also carries a heavy schedule of evangelistic work.

Other Courts Set Next Few Months

Clerk of Court J. Frank Harrington declared today, following the completion of a one week's session of criminal court here yesterday afternoon, that the docket was in good condition.

He said that numerous old cases were removed and added that he believed the docket could be cleared at a two weeks' term scheduled for April.

A two weeks' session of Superior Court for Civil cases is scheduled for February and two weeks of mixed court are set for March. It is probably that the two weeks in March will be devoted entirely to civil cases.

Mr. Harrington explained that unless an unusually large number of cases are added between now and April the Criminal docket can be cleared in April and there will be no need in devoting one week of the March term to Criminal cases.

PAYNE-TURNER CASE NEAR END

Defense Offers No Testimony in Penn Murder Trial

Asheville, Jan. 29.—(AP)—Trial of Bill Payne and Wash Turner, charged with murder in the slaying of Highway Patrolman George Penn last August 22, neared the jury stage today.

Arguments of counsel were resumed at the opening of court after a session last night to complete arguments of three lawyers.

The State rested at 4:30 p. m. yesterday and the defense followed within a few minutes with an announcement that it would offer no testimony.

Cecil Jackson of defense counsel opened summation.

Charles Ross of Raleigh, attorney for the State Highway and Public Works Commission, who is assisting the prosecution, and Robert Reynolds, Jr., a defense lawyer, spoke at the night session.

Contending that an officer under the law was the "rightful aggressor," S. P. Fisher of the prosecution, was the first to speak today. He argued the shot fired at Penn's car showed an intent to kill.

Walter Haynes of the defense, who followed, said the pair had the right to shoot to defend themselves and added:

JAPS RESTRICT FOREIGNERS IN CHINESE AREA

Move Apparently Effort to Avoid New Incidents

ALLISON DENIES JAPANESE STORY

U. S. State Department Officials Await Reaction to Slapping of American

Shanghai, Jan. 29.—(AP)—Japanese today restricted the Shanghai area into which foreigners may go, apparently in an effort to avoid possible new "incidents."

A Japanese Embassy spokesman announced the regions prohibited to foreigners included Kiangwan, Tazang and Lihung, to the north of the city.

Japanese a week ago announced foreigners would not be permitted to visit Nanking, although foreigners already there were allowed to stay.

The Embassy did not explain the new restrictions, but they apparently resulted from a combination of circumstances, the wish to avoid possible "incidents," military activity in the areas, an effort by Chinese guerrilla units to disrupt Japanese supply lines about Shanghai.

A Japanese spokesman said there would be no further announcements on the slapping by a Japanese sentry of John Allison, U. S. diplomat in charge of the Embassy at Nanking.

Washington, Jan. 29.—(AP)—State department officials awaited with intense interest today Japanese reaction to formal representations by this country against the slapping of an American Embassy last night to Ambassador Joseph Grew at Tokyo, directing him to inquire as to what the Japanese government had done about one of its soldiers slapping the face of John Allison, third secretary of the Embassy.

Allison, himself, had furnished an account of the incident, which was officially published by the State Department. Flatly denying the official Japanese version that he had insulted a Nipponese officer, the diplomat asserted the attack was unprovoked.

Democrat Chosen to Senate Vacancy Salem, Ore., Jan. 29.—(AP)—Alfred E. Reames, Medford attorney, today was appointed by Governor Charles Martin, Democrat, to serve out the unexpired term of Frederick Steiwer as United States Senator from Oregon. Reames is a Democrat.

Reames will be 68 years old February 5. He is expected to go to Washington immediately to take the seat of Senator Steiwer, whose resignation is effective Monday and whose term had 11 months to run.

Steiwer resigned Thursday, after 11 years in the upper House, to become a member of a Washington law firm. He was one of the staunchest Republican critics of the Roosevelt administration.

Reames will be the first Democrat in many years to serve Oregon in the Senate. Oregon's senior Senator is Charles McNary, the Republican minority leader.

RETIREES FIRES HINDER RESCUE CREWS

Segni, Italy, Jan. 29.—(AP)—From 300 to 400 persons were believed to have been killed and injured today in a series of explosions which blasted one of Italy's greatest munitions factories.

Frantically working rescue crews had been able to drag but fifteen bodies from the wreckage. Firemen believed many more would be found when they were able to penetrate the smoldering ruins.

The explosion was blamed officially on the carelessness of a worker who broke a compress air tube. A communique announcing the disaster gave no definite casualty figures, but said there were "some dead and dozens injured."

Stores of wool used in making high explosives were burning in the cellars and prevented further rescue work.

Many persons were injured by flying splinters of glass and the tiles hurled from the roof tops of neighboring buildings by the force of the blast.

Two minor explosions occurred at 7:35 A. M. and 7:50 A. M. before the huge blast at 8:03 A. M. just as the day shift was relieving the night workers.

SEEK TO SPEED GRANARY BILL

Pressure Of Cotton Benefits Hastening Agreement

Washington, Jan. 29.—(AP)—Pressure of \$130,000,000 pending in bonus payments for cotton farmers is hastening agreement on the "ever-normal granary" program, congressional leaders said today.

Representative Fulmer (D-S. C.) and Doney (D-Miss.) said the \$130,000,000 voted by Congress last summer as a bonus on the 1937 crop had caused a "good deal of give-and-take in the conference."

"Cotton farmers can't collect that until they have complied with this year's farm program," Doney said, "and they can't hope to comply until we get a bill out of here before long."

"The cotton farmer stands to lose more than any other farmer unless we hurry up," Fulmer said.

The bill should be ready for final congressional consideration next week, they said.

Senator Bankhead (D-Ala.) said the conference group had agreed upon a "completely new method" of making cotton allotments to individual farmers.

Under previous Federal farm programs cotton allotments have been on a basis of past production records for the cotton on farms. Bankhead said the granary program would take into account the "total tilled acreage on a farm as well as cotton production."

Under the new plan, he explained, the total acreage on a farm in cultivated crops would be considered. This would include tobacco, wheat, corn, potatoes, etc.

Thus, on two farms of the same size in a county, if one devoted land exclusively to cotton and the other part of the acreage to home feed and food crops the first farmer would receive a smaller proportionate cotton allotment than the second.

Cites Needs For Market Channels

Raleigh, Jan. 29.—(AP)—Kerr Scott, Commissioner of Agriculture, today advocated more attention to distribution of crop surpluses and less stock controlling them.

"It seems to me there is a need for more study of marketing channels to find ways and means of getting our crop surplus to the one-third of our population that is ill-fed and ill-clothed," Scott commented.

Will Discontinue Raleigh Rail Bus

Officials of the Norfolk Southern Railroad Company today announced that the rail bus trains operated since 1935 between Washington and Raleigh would be discontinued on February 1.

The statement points out that the line has been operated at a great loss and the company found it necessary to discontinue the service.

For the three-year period, 1935-37, the line operated at a loss of \$16,732.17. During the first three weeks of January the line lost an average of \$327 each day it was operated. Based on the first three weeks of the year, the loss for the month of January will be \$1,004.43, and for the year 1938, \$12,005.16.

## Declares Freedom Of Speech Greatest Safeguard

Dr. A. D. Frank, head of the History department at East Carolina Teachers College, in an address before the Kiwanis club last night declared that one of the greatest safeguards against dictatorship is freedom of speech.

Dr. Frank said that any time an individual or group sets out to establish such a form of government one of the first objectives is to throttle the press, educators and ministers.

At the start of his brief address, Dr. Frank called attention to recent attacks made on the Nazi government and its dictator, Reichsfuehrer Adolf Hitler, and declared he was glad these tirades were made, even though they may not have been in the best taste.

He explained that in each instance protests had been made to the State department and Secretary Cordell Hull answered the objections by explaining that in this country freedom of speech was regarded as a constitutional right and he nor anyone else had any right to throttle it.

Dr. Frank observed, however, that in spite of the constitution, freedom of speech has been trampled under at various times in this country and wondered if it would not be opportune to stop and re-assure ourselves.

He recalled that the first instance of disregard for this right was during the administration of John Adams when a threatened war with France provoked the sedition act, making it unlawful to speak against the government.

The next such violation was in 1861, when freedom of speech was suppressed by both the Union and the Confederacy. The only other major instance was during the Wilson administration during the World war, when another sedition act was passed. Dr. Frank declared that some of Wilson's staunchest supporters had declared this to be the greatest mistake made by the war time president.

Since the Wilson administration, Dr. Frank observed, there have been only infrequent instances of suppression of freedom of speech and of the press.

The speaker pointed out that with the world moving toward Fascism, Nazism and other such forms of government, there was an increasing tendency to curb freedom of speech and press.

He added, however, that while many people in this country fear democracy is on the decline, "I have no fear if freedom can be maintained in the press, schools and pulpits."

A. C. Hammond, who recently came here from Alabama to assume the management of the local McClellan's store was accepted by the club as a new member last night, he was welcomed into the organization by B. E. Sugg.

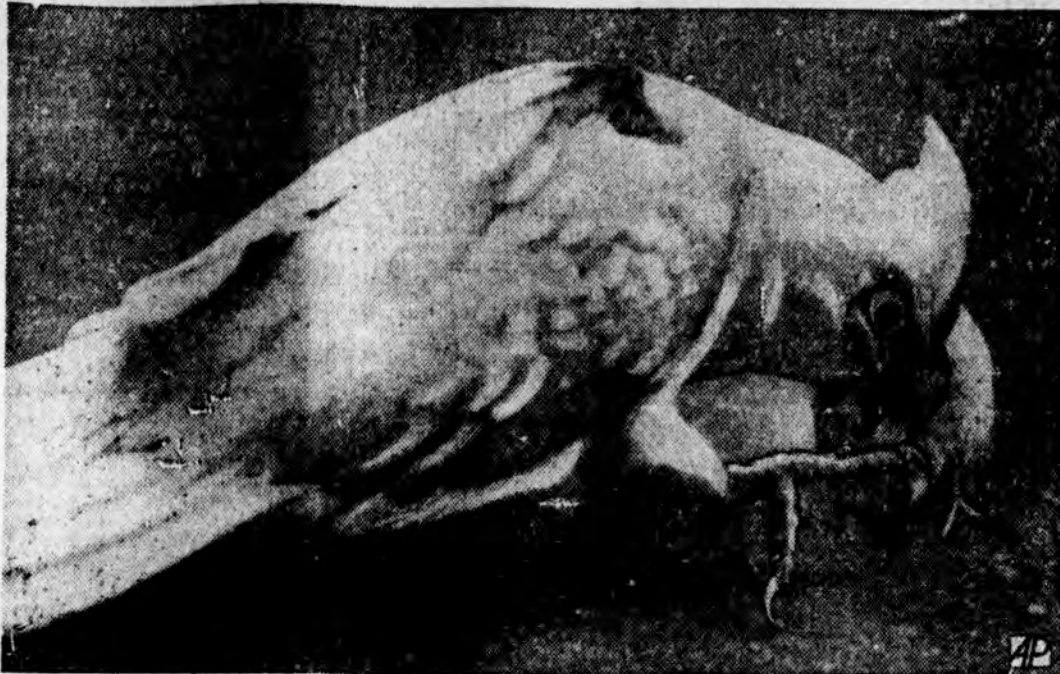

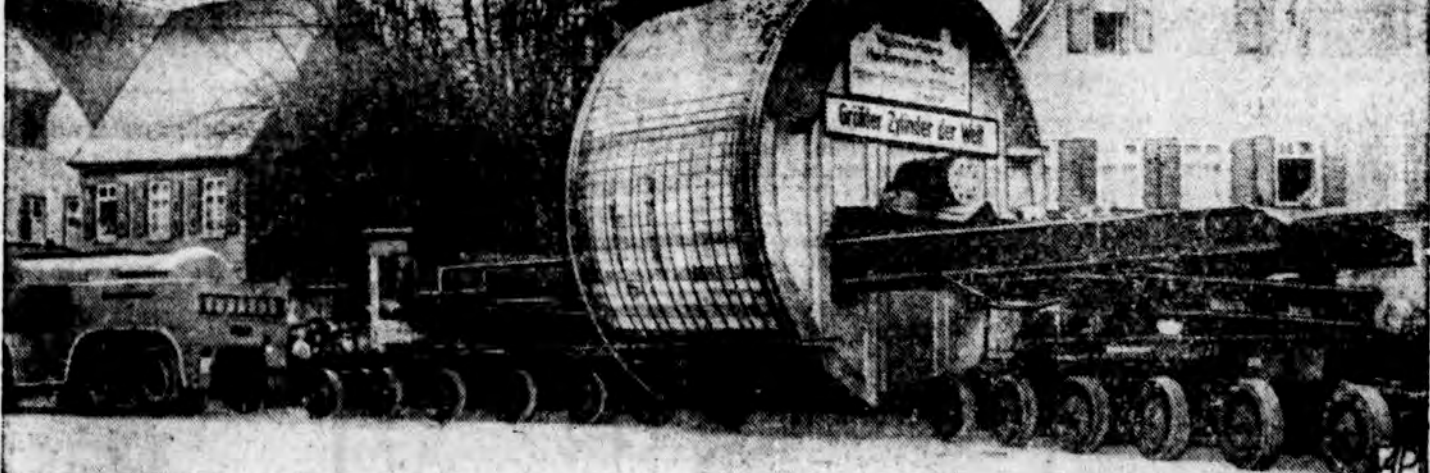

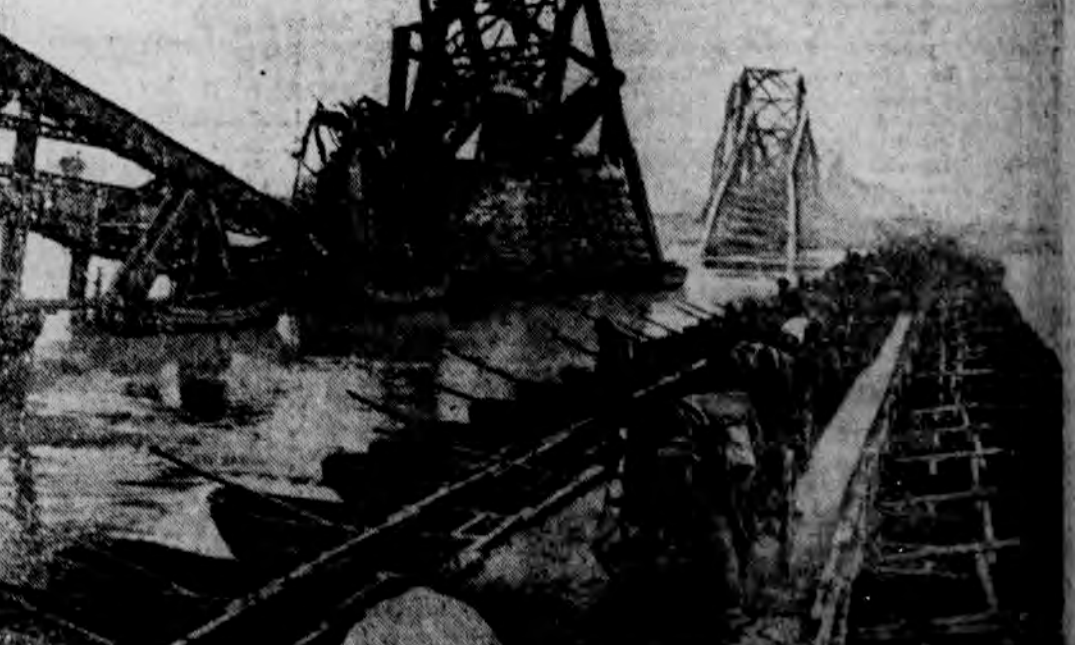

## SHORT SHOTS

By HENRY AVERILL

Raleigh, Jan. 29.—Another North Carolina "first" has come to light. This state, so far as can be learned, was the first to employ a state geologist. This occurred in 1823 when the Board of Agriculture employed Dennis Olmstead to make a geological survey of the state.

From his work was originated the North Carolina State Museum, at first a place for a collection of native rocks and minerals he gathered.

It appears that the Board of Agriculture then had functions which covered all fisheries, state advertising and immigration, as well as geology and agriculture.

The board's good intentions brought us, among other items, German carp, Angora goats and silkworm culture.

Hearing on Judge Wilson Warren's order restraining operation of Turf and Salsbury's bookmaking establishment, has been postponed until the week of February 21, when the judge will be holding a court term in the Rowan county capital.

The case is of statewide interest because similar establishments are operated openly in many other cities of the state. The District Solicitor is seeking to close the bookmaking place as a common gaming house and therefore a public nuisance.

Efforts to convict under the state's lottery and gambling statutes failed in numerous cities.

A \$300 fence around the baseball park at Tarboro was saved from destruction by fire by the quick work of County Fire Warden W. M. Haynes, who arrived on the scene with his truck 15 minutes after the fire had started, according to report of the forest fire control station of the State Forest Service.

Governor Clyde R. Hoey is a good lawyer as well as a well-informed public servant, yet even he doesn't know all about the laws of the state nor yet all his own duties and authority.

When it came time to name the new state board of elections, the Governor calmly sat him down and issued to be typewritten a statement in which he blandly announced that W. A. Lucas, Wilson, "is appointed" chairman of the election board.

But when the statement reached Raymond C. Maxwell, executive secretary of the elections board, things began to happen. Mr. Maxwell grabbed a telephone hastily to inform North Carolina's chief executive that he (the said chief executive) had exceeded his authority. Mr. M. gently pointed out that the law provides that the Governor shall name the members of the board, BUT THE BOARD SHALL NAME ITS CHAIRMAN.

And so the statement, as it reached news men, had the type-written phrase "is named" crossed out and the named insertion "is recommended for" in its place.

North Carolina's total of divorce revocations rose to 15,059 this week.

PLANT FEEDS ON INSECTS,

For the first time in history, gun boats were actually captured and destroyed by cavalry at Johnsonville, Tennessee during the War Between the States. In this epochal battle, GENERAL NATHAN BEDFORD FORREST, "wizard of the saddle", dealt Sherman a terrific blow by destroying the large fleet anchored there and capturing an enormous supply of military supplies valued at several million dollars. By an act of the Tennessee Legislature of 1929, a state park was established and named after the famous General. His monument, which commemorates the battle of Johnsonville, stands on Pilot Knob, the highest hill in Benton County. It was from this eminence that General Forrest directed the attack.

The green surface of the leaves of the SUNDEW, which grows in southern swamp areas, is studded with numerous, movable, sticky glandular hairs. Insects that alight on the leaf are heaved into the central area and the glands there affect the external tentacles so they bend slowly inward. The blade of the leaf often becomes hollowed and this forms a kind of cup in which the unfortunate prey is held while the glands pour upon it their viscid fluid. It is obvious that the more the quarry struggles, the less chance it has of escaping, for the more the glands are excited, the more fluid they pour out. After a long series of experiments, Darwin discovered that the Sundew actually digested the prey it captured.

**Garden Notes**  
Pruning and spraying the home orchard should be neglected no longer. Scale can be controlled only by spraying while the trees are dormant. Liquid lime-sulphur is very satisfactory as a dormant spray for fruit trees. Mix one gallon of the concentrated solution with eight gallons of water. If the liquid is not available, dry mix lime-sulphur may be used as directed on the package. This spray is for the control of San Jose Scale and leaf curl. The trees should also be fertilized. Compost is very good when used in sufficient quantities. If this is scarce use one-half pound of Nitrate of Soda on apple and nut trees one year old and increase the amount one-half pound per tree for each succeeding year. Handle peaches, pears, plums the same way, using one-fourth pound. Bearing trees should receive one-half pound of Nitrate of Soda or two pounds of 5-7-5 fertilizer per inch diameter of the trunk. This should be well scattered under the branches and well mixed with the soil.

Watering the garden with liberal applications of well rotted compost or fifteen hundred to two thousand pounds of 5-7-5. Plant the following seed this month: Carrots, beets, spinach, mustard and garden peas. Cabbage plants can also be set this month. Cabbage do best if all the fertilizer is put under the plants and thoroughly mixed with the soil

before setting. They may need a light side dressing of soda depending on the growth they make.

Irish potatoes should go in about the middle of the month. It is a good practice to rotate your garden crops just as your field crops. Such rotation will aid in the control of diseases and insects which give you larger yields of a superior quality vegetable.

# EMPIRE FOR A LADY

REMEMBER reaching out through all that, exactly as a man overboard might reach for a floating spar to cling to, and what I found without any shock or surprise, was the clear-cut image of Christine Forrester.

It was as if she had always been there—a dark-eyed girl waiting to steady a man so that he could meet without dishonor, just such an hour as this. Curiously, I could not hold it against her that she was the cause of all this; I could only be afraid of what would happen to her now. She could not make me forget my own danger, or Clyde's, or the fate of the Linkang, but she could add something more. That was because something seemed to go out of me, trying to reach down the sultry darkness of the Siderong, and speak to her aboard the yawl—speak to her so insistently that she would have to understand me through the hammering of the rigging and the whir-pee of the reef.

Go away, Christine, go away. Catch the ebb tide through Balingong pass. Get your helpless little vawl into the open sea, somehow before it's too late. In God's name get gone, Christine.

Clyde was finishing his speech now, bearing down with set face at every turn of the Malay phrases. Whatever he was saying, Mantusen seemed to disregard it.

"You have made me very happy, Tuan," the Rajah said. "When I learned you had sailed the jungle with these guns, I knew that this is the place and time that I will die. I do not mind that. But I was sorry to think that my kris would never taste your flesh. Now you have changed that. It is like a miracle. I feel that God is good."

My uncle turned his eyes toward me, and we exchanged a long glance. He spoke to me softly, "I have been a fool."

"Yes," said Mantusen.

"I suppose there is no hurry about this," Clyde said at last. "I see no reason why we should not sit down and talk this over in full."

"Now that we understand each other," the Rajah Mantusen replied, "I am sure I would enjoy it very much."

So we sat down. It was only a delay, which we could string out as long as the rajah felt social, and not any longer. I did not know anything about what kind of ceremony Malay rajahs go through when they put away an enemy of great distinction who is helpless in their hands. But we had no reason to think that there would be much postponement attached to the matter, other than for entertainment purposes. And the one thing I had never heard of was a Malay rajah who could be talked out of anything in any such circumstances as this. With the threat of superior power eliminated, you have surprisingly few points of contact with a Malay.

And there we were. Nothing is more difficult for a white man in dealing with Malays than the interminable slowness which impedes any conversation of any weight. Here we had to do with what represented the nobility of the breed—the proudest and most regal blood the archipelago had developed; and this multiplied the deliberation surrounding the pronouncement of any statement of any real account. Mantusen, in at once showing the rifle and the head, had exposed our position with what amounted to a savage abruptness. This in itself, coming from a chief who would have taken four days to discuss a hunting trip up a river, showed what an extreme pinch we had got ourselves into.

### Too Much Gunpowder

IN THE end we could, of course, get ourselves killed trying to escape. But the attempt meant, to begin with, the out and out abandonment of our boat. All Clyde could do, and what he now went ahead with, was to attempt the impossible job of talking our way out. And this meant that we had to sit stonily cross-legged on the mats for hour after hour, without any motion, not even fatigue permitted to show in our faces.

An awkward, trivial thing enters into a conference of that kind, between a white man and an Oriental on the Oriental's ground, and this thing has distorted the entire history of the East. It is that when a white man sits cross-legged on a mat for a long time he gets a terrible headache. Heaven knows how many wars have been started because an envoy developed such a

headache that he concluded in his report that the quickest way out would be to shoot the rajah.

Early in the first hour my back began to ache. Later I computed that we sat there between four and five hours; but by this time I did not understand why daylight did not come before we were through. It seemed to me that we sat there for weeks.

Yet, considering all this, the exact facts behind Mantusen's displeasure came out surprisingly clear and soon.

"I did not start this war," Clyde said. I knew that he stated this less in hope of convincing Mantusen than of finding out what was in Mantusen's mind. "I did not plan any war."

"I believe you," Mantusen said. "Then just what do you think I have done?"

"You have distrusted me too much," said Mantusen. "You have tried to be too safe. You have played with too much gunpowder. At the moment I did not understand this, but as they talked on it became very plain to me. You had undertaken to run guns to Mantusen in return for certain trade monopolies. Naturally, Clyde had considerable reason to fear that Mantusen, once armed, would repudiate his agreement. What the typical white trader liked to do, in such a case, was to provide a military threat of his own, to sustain his rights in the matter."

Mantusen conceived that this was exactly what Clyde had done. He thought that it was Clyde who had caused the Dyaks to gather. The excellent guns with which the Dyaks were now armed gave very strong evidence in support of this theory. In fact, if one threw out the possibility—as Mantusen did—that the two white ships were working against each other, the theory that Clyde had armed the Dyaks became inevitable.

"I still would have been a fool to attack Balingong," Clyde maintained. "You and I were in perfect understanding. No disagreement had come up. Why should I attack you?"

"I do not think you meant to attack me—yet," Mantusen said. "You should have known that you could not keep your Dyaks in hand if only you caused this. I do not say you control it now."

Mantusen's logic

SOME nature of the trap we had walked into was clearly defined. Mantusen thought Clyde had gathered the Dyaks as a threat an see-in-the-hole. The guns the Dyaks had were proof of it. He assumed that the Dyaks had then got out of hand while Clyde was away.

Cambridge, Mass. — Incredibly fine is the star dust which endearingly pelts the earth.

Star dust is made up of meteors. A thousand million meteors fall into the earth's atmosphere each twenty four hours according to the most recent studies, which are published on the Telescope, of Harvard Observatory, by Fletcher Watson.

Lumped together, this thousand million daily meteors, he estimates, would weigh only 100 tons.

# CONTEST SEEN FOR WINBORNE

## Herbert S. Falk Of Greensboro to Seek Office

By HENRY AVERILL  
Raleigh, Jan. 29.—Herbert S. Falk, Greensboro lawyer and civic leader, will oppose Utility Commissioner Stanley A. Winborne in this spring's primary, according to exceptionally reliable information reaching this bureau.

Falk's backing will come largely from the retail merchants of the state, although it is unlikely that he will be officially sponsored by the North Carolina Retail Merchants Association.

If the Guilford man enters the race, as it now appears certain he will, his principal platform will be a sweeping demand for reduced electric and power rates in the state, particularly in commercial power rates.

In June, 1932, Falk then serving as a director of the Greensboro Chamber of Commerce, prepared a report vigorously attacking high electric and power rates. This report is credited generally with having much to do with the sweeping reduction in existing schedules made in the fall of 1932.

The Greensboro lawyer has never been a candidate for any political office and his entry against Mr. Winborne will be his first effort to appeal to the voters. His friends declare he will make a red hot campaign and one calculated to make the voters sit up and take notice.

The theory that Mr. Falk will receive support of the retail merchants is predicted largely upon the fact that in December, 1935, he instituted, in behalf of the Retail Merchants Association, a proceeding before the Utilities Commission charging unfair discrimination in the matter of commercial electric rates.
