## BATTLE RAGES FOR JUNCTION OF RAILROADS

### Jap and Chinese Lines But 50 Yards Apart At Places

### GUNFIRE HEARD 22 MILES AWAY

### Barrage Believed Preliminary Assault To Chinese Positions On Another Front

Shanghai, March 22.—(AP)—Fighting raged today across a bloody Grand canal as Chinese and Japanese, their lines but 50 yards apart in some places, battled for possession of Suchow, vital junction point of the Lunghai and Tientsin-Pukow railways.

Gunfire was audible in Suchow, 22 miles from the battlefield as Japanese ranged their heavy artillery along the north shore of the canal and opened bombardment of the Chinese lines.

The barrage was believed to be preliminary to an assault of Chinese positions reaching from the swamps of Lake Weishan to Likouyih, on the north-south Tientsin-Pukow line where the bitterest fighting was taking place.

However, Japanese were in a position for an eastward flanking movement.

At Suchow they would cut the east-west Lunghai line connecting their North and Central China conquests and move into position for an easy advance by railway to Hankow, temporary Central Chinese government capital.

In other directions of the compass reports showed the Chinese launching desperate counter-attacks preventing Japanese reinforcements to the Suchow battle and adding confusion to the already mixed situation in five provinces.

## Requests Support Of Clean-Up Week

E. G. Lynch of the City street department today declared that many citizens were cooperating in the "Clean-up Week" but declared it was necessary to have the full cooperation to make the movement a decided success.

Raleigh, March 22.—(AP)—Representative Bayard Clark of Fayetteville, filed with the Elections Board today to seek re-nomination in the Seventh Congressional District in the Democratic June primary.

Also paying to enter the lists for the primary and general election were Solicitor Don Gilliam of Tarboro, seeking re-nomination from the second Judicial District, and Solicitor John R. Jones of North Wilkesboro, the Republican Congressional nominee in the Eighth district.

None of the three has announced opposition in the primary.

## PLANS TO PAY MANY TO SEEK OIL COMPANIES

Mexico City, March 22.—(AP)—L. L. Anderson, general manager of the Huasteca Oil Company, said he learned today another American oil man, Ed Borrero, had been held a "virtual prisoner" at Tampico until he paid a sum of money to oil workers.

Anderson, in a signed statement, said he talked by telephone with Borrero, superintendent of the Tampico refinery of Standard Oil of New Jersey, of which Huasteca is a subsidiary.

Mexico City, March 22.—(AP)—President Cardenas assured Mexican industry today that expropriation of foreign oil companies was "exceptional" and no similar measure was in prospect against other business.

As the treasury department took the first steps toward fixing the sums to be paid the 17 British and American oil companies for loss of their \$400,000,000 properties, President Cardenas gave his assurances to industry in general in a statement today.

"No other measures which might affect the confidence of the country will be taken against other business enterprises, bank deposits, valuations and other investments, which the government is ready to protect in accordance with the law."

The president said his government would take necessary steps to protect and encourage investments and business enterprises which might aid the economical development of the country and bring benefits of social character.

Secretary of the Treasury Suarez invited representatives of the 17 expropriated oil companies to confer with him on indemnity for the property and the terms of payment.

## N. C. Building Gains In February Over January

Raleigh, March 22.—Building construction in 21 North Carolina cities showed a gain of one-third in number of buildings affected in February over January; though the estimated cost slumped 17.1-2 per cent from the preceding month.

In both number of buildings and cost February of this year ran far behind construction of the corresponding month of 1937, according to figures of the State Department of Labor, just released.

In February, 1938, buildings affected totaled 457, with an estimated cost of \$26,574. In January, 1938, the corresponding figures were 343, \$1,124,241; while in February, 1937, they were 503 and \$1,104,745.

Last month there were undertaken 167 residential buildings, 67 non-residential and 223 additions, alterations and repairs, estimated to cost

## REBELS CLAIM FURTHER GAINS TOWARD COAST

### Government Troops Forced from Barricaded Trenches

### MEDITERRANEAN DRIVE RESUMED

### Loyalists Reported to Have Suffered 2,000 Casualties in Effort to Halt Foes

Hendaye, France, March 22.—(AP)—The Spanish Insurgents today reported that they had driven Government troops from five barricaded trench lines at Val-dealcorfo in fierce hand-to-hand conflict.

Resuming their drive toward Catalonia and the Mediterranean coast the Insurgents launched a smashing attack in the sector 10 miles southeast of Acanis and about 35 miles from the sea.

Government troops suffered 2,000 casualties in a futile effort to stop the offense said insurgent dispatches which reported capture of 300 machine guns.

The Insurgents command unleashed tanks and planes against Government defenders just west of Catalonia.

Mechanized forces based at Caldefers just west of Calalanda rumbled and rammied a line standing before the Alcaniz-Valencia road, where gathering resistance blocked the infantry stride to split Barcelona from the rest of Government Spain.

Three successive assaults headed by 47 tanks and a number of planes broke on this sector Monday, Government advices said.

Insurgent air raids behind the lines centered on Tortosa, Mediterranean coast objective.

Dispatches from Madrid said the Government was heartened by the stalling of the insurgent offensive.

## Income Tax Funds Exceed Estimates

Raleigh, March 22.—(AP)—Revenue Commissioner A. J. Maxwell, elated at reports that income tax receipts through Saturday aggregated \$9,928,738.31, to exceed collections to the same date a year ago, said today the outlook was "favorable" now for a new record for the levy.

Previously Maxwell had forecast the receipts would drop perhaps 10 per cent under the \$11,015,000 collected last fiscal year.

"It is obviously too early to predict with certainty," said the Commissioner, "but the outlook is favorable for the receipts to exceed those of last year. Probably at least another million dollars will come in."

A year ago on Saturday the income levy had yielded \$9,770,429.61.

## Southern Bell Shows Big Profit For 1937

Raleigh, March 22.—(AP)—The Southern Bell Telephone & Telegraph company reported to the Utilities commission today that it made a profit of \$1,127,059.43 on its 1937 North Carolina operations, compared with \$903,181.82 in 1936.

The company added a statement to its report, however, that the outlook now "is such that earnings for 1938 will nowhere near approximate those indicated in the report for 1937."

## Nazi Activity Prohibited Within Bounds Of Brazil

Rio de Janeiro, March 22.—(AP)—Efforts by the German government to regain free Nazi cultural activity for Germans in Brazil ran into a blind alley today.

It was ascertained at the foreign office that Foreign Minister O. Aranha had rejected flatly the latest series of representations against Brazil's ban on Nazi activities.

Carl Ritter, the German ambassador, acted for his government. It was said reliably that the foreign minister considered a note submitted by Ritter and couched in such strong language that he rejected it without further consideration.

Ritter has been conferring with high Brazilian officials for several days. He talked yesterday with Francisco Campos, minister of justice and of the interior, but nothing resulted to indicate any change in the situation.

President Vargas abolished all political parties when he set up his regime November 19.

He reiterated last week his determination not to permit Nazi activity among the 155,000 Germans in Brazil.

The German foreign office newspaper yesterday termed the Brazilian ban action "against Germanism."

## ROBBERS GIVEN PRISON TERMS

Several young Negroes convicted of a recent series of robberies in Greenville, were sentenced by Judge Henry A. Grady in Superior court here today after tendering pleas of guilty.

Willie Carr, James Carr and Willie Blow were given five-year prison sentences. Additional sentences of a like term were metered out in other cases but were suspended indefinitely upon good behavior.

James McGowan was given a three-year prison sentence upon conviction of breaking, entering and larceny. Among other charges McGowan was convicted of taking baseball equipment from a salesman's automobile while it was parked at the Country club recently.

Hugh Styron, Roy White and William Rhodes were given terms of 18 months on the roads, suspended for five years upon good behavior.

Harvey Moore, Negro, was convicted of operating a disorderly house, but sentence was not immediately passed.

Joe Peyton and Nina Peyton were convicted of larceny, but sentence was deferred. Offie Sugg, tried jointly with the two, was acquitted.

Albert Spruill and Snoot Henry, young Negroes, were convicted of assault with intent to commit larceny. Spruill was sent to the road for 18 months and Henry's case was transferred to the juvenile court.

## MAYOR HEARD BY CIVIC CLUB

**Discusses Proposed Recorder's Court For City**

Greenville's present Police Court was declared out of date last night by Mayor M. K. Blount when he spoke before the regular weekly meeting of the Rotary Club on the proposed Recorder's Court for Greenville. "Our police court is inadequate and was established in the 'horse and buggy' days when Greenville was a small town," he explained. He brought out the fact that D. M. Clark and J. C. Lanier when each was mayor tried to establish a Recorder's Court but only recently was the proper legislation passed by the state legislature to permit establishment.

"On March 28th the citizens of Greenville will be given an opportunity to vote on a Municipal Recorder's court. At the present time the Police Court is a J. P. court having limited jurisdiction trying only those crimes which carry a maximum punishment of \$50, or thirty days imprisonment," he said.

This gives the Police Court only jurisdiction over cases such as public drunkenness and disorderly conduct whereas the town Recorder's Court would have the same jurisdiction as the County Recorder's Court. He cited the fact that Ayden, Farmville, Wilson and Rocky Mount have Municipal Recorder's courts as well as many other cities in the state.

Advantages of a Municipal Recorder's Court are many he declared, and will keep Greenville abreast of the times.

"Establishment of a Recorder's Court will greatly aid in law enforcement and at the same time render justice by speedy trial to all defendants and persons charged therein with the violation of law. With the present limited jurisdiction of the Police court, in many instances, such as violation of the liquor laws, reckless driving, larceny, gambling and many others, the case is bound over on the

finding of probable cause to the County court. There the defendant, if he is unable to give bond, must remain in jail at the expense of the tax payers until a sitting of the County court. Sometimes that is for two or three weeks since the County court cannot use the Court room when the Superior court is in session for there is only one court room. This works a hardship upon those charged with crime, for in some instances they are found not guilty.

"Therefore, the defendant, as well as the State, in justice to all, is entitled to a prompt hearing and trial."

Existing courts would not be affected, he explained, except that cases usually bound over to County court from Police court would be tried in Recorder's court. The County court would still continue to function and have jurisdiction over those cases through the county where there is no Recorder's court.

"The officers of the Town and especially those on night duty some times spend two days in county court as witnesses in cases. These officers could spend more time at their duties where they are sorely needed. And the public would not lose great deal of time attending County Court," he went on.

The Mayor told of how the pres-

ent set up worked inconvenience on people from a distance. Being arrested for violation of some law they do not understand why they must first be tried in police court and then additional expense and cost of returning for a hearing in County court and the same thing applies to local citizens as well.

"This is the first time this question has been submitted a vote of the people, and this is done under the authority of a law of the State. The reason why this is being submitted and voted on at this time is due to the fact that we also have before us the issue of the Athletic Center, on which the voters will vote at the same time. It is expensive and inconvenient to the public to vote on issues and therefore the Recorder's court is being submitted, at the same time as that on the Athletic Center.

"Those who register and fail to vote on the Athletic Center proposal is a vote against. Under the Recorder's Court this does not apply. The law required a new registration on proposals to issue bonds for an unnecessary expense and that is the reason why the difference exists between the nature of the vote on these two proposals. In order to vote on the Recorders court it is necessary that you register on or before Saturday March 26th at the Court house or City Hall where the registration books are open every day.

"The citizens of Greenville are urged to give this serious thought and consideration for no longer is Greenville a small town and we need a court in keeping with its growth and progress and one that can give justice without delay and inconvenience to the witnesses and public," he emphasized in conclusion.

Following the Mayor, Fordy Harding inducted three new members into the Rotary club: W. G. Cherry, John Proctor, and Burney Warren. In his speech to the new members Fordy told of Rotary's growth from a local social club into an International organization with an ideal of service. He made the point that a benefactor today is one who will reach down to a strata below one and raise some one up just a little, even.

Dr. A. P. Kephart of Blowing Rock was a guest of the club. J. B. Kittrell, program chairman, announced an Inter-city meet of Bethel, Ayden, Farmville, Robersonville and Snow Hill Rotary club April 15th starting at 3:30 p. m. with entertainment and concluding with dinner at 6:30 p. m. These Inter-city meets are held all over the world where Rotary is found but it was the Greenville club that contributed the idea. Phil Goodson won the attendance prize given by Herbert Waldrop, Tom Grant the club president, presided.

# Hollywood

Sights And Sounds

Hollywood — In the movie poker game a pair beats a full house—to get a full house into the theaters.

That goes for writers, not for stars. The old movie custom of sending writers marching in platoons and regiments against a helpless film subject continues, not without many good pictures resulting. But little by little another idea is spreading. The work of special teams—one writer, one director—points to the wisdom of the newer practice.

The old mass literary attack has its uses, of course. A difficult subject with which many minds wrestle may not be conquered all at once, but in the wrestling each mind may leave behind a usable idea before retiring exhausted to the sidelines. "The Lives of a Bengal Lancer" was undeniably a hit, and it was a product of so many writers' work that in the end there wasn't room on the credit line for all of them. The four who had done the most work got billings.

But in many cases, a story that has had the benefit of "treatments" by all the writers on the lot doesn't hit the production stage. Too many cooks, or maybe there wasn't any broth there to begin with.

**How It Started**  
Director-writer teams aren't exactly new to be sure. Not when Cecil B. DeMille and Jeanie MacPherson were knocking off scripts together back in the days when most scripts came from the cuff. And in 1933 playwright Preston Sturges was a novelty sensation because he wrote a complete, final script of his own—"The Power and the Glory"—without even a director as collaborator.

But since Director Frank Capra and Writer Robert Riskin got together on films like "It Happened One Night," "Mr. Deeds," and "Lost Horizon," the scripting spotlight has been brighter on writer-director teams.

The man who's going to shoot the picture works directly with the man who's writing it—and the results speak from the screen.

Rocky Mount, March 22—Lump-sum payments under the old-age insurance provisions of the Social Security Act are being paid promptly to those eligible workers who have reached 65 since January 1, 1937, and to the relatives or estates of such workers who have died since that time, according to Geo. N. Adams, manager of the Rocky Mount Field Office of the Social Security Board.

"Persons who have reached age 65 and are eligible need not defer filing their claims because they continue to be employed," Mr. Adams said, "as such restriction will not be enforced until commencement of the monthly benefit payments in 1942."

Generally speaking, wives of deceased workers have a prior claim on lump-sum payments due their husband's estate. If no wife survives, the children or parents are generally the preferred claimants. The amount of the payments varies, of course, since it is based on the wages earned in covered employment from December 31, 1936, up to the date of the employee's death or the date that he attained age 65. The average amount of the lump-sum payments throughout the country at the present time, however, is approximately \$35, although this figure is increasing steadily.

Many persons who are eligible for lump-sum payments have not yet filed claims. Social Security Board Field Offices are located throughout the country for the convenience of such persons in obtaining information and assistance with regard to claims and other matters pertaining to the old-age insurance provisions of the Social Security Act. Persons who believe they are eligible to file claims should apply at their nearest Social Security Board Field Office. It will be very helpful if they know the account numbers, under which they believe claims are due them, as this will enable the Board to pay claims more promptly, Mr. Adams said. Social Security accounts represent cash when claims are due.

New York — Without any wish to be unfair to Hawaiian dancers now in New York, I must express the opinion that the hula is not the same since Meymo Holt went back to Honolulu.

Meymo had a lot to do with New York's fetish for softly twanging steel guitars, frosted drinks in coconut shells, and swaying grass skirts. As for Meymo, whose name rambles on and on for 23 syllables, and means, freely translated, something like "The sweet-spirit-of-the-Heavenly-Rains-in-high-bowers,"—she is a college lass, has a noted football-playing brother and speaks English with the meticulous perfection demanded by an Oxford professor. She too, is but part "island," the rest of her genealogy having to do, like the Seven Years War, with the English and the French.

Meanwhile the guitars are still strumming and the little grass skirt remains the symbol of Manhattan's after-dark entertainment. But New York won't be Hawaii until Meymo, a sprig of flinger between her teeth, deserts her island in the Pacific for the one we call Manhattan.

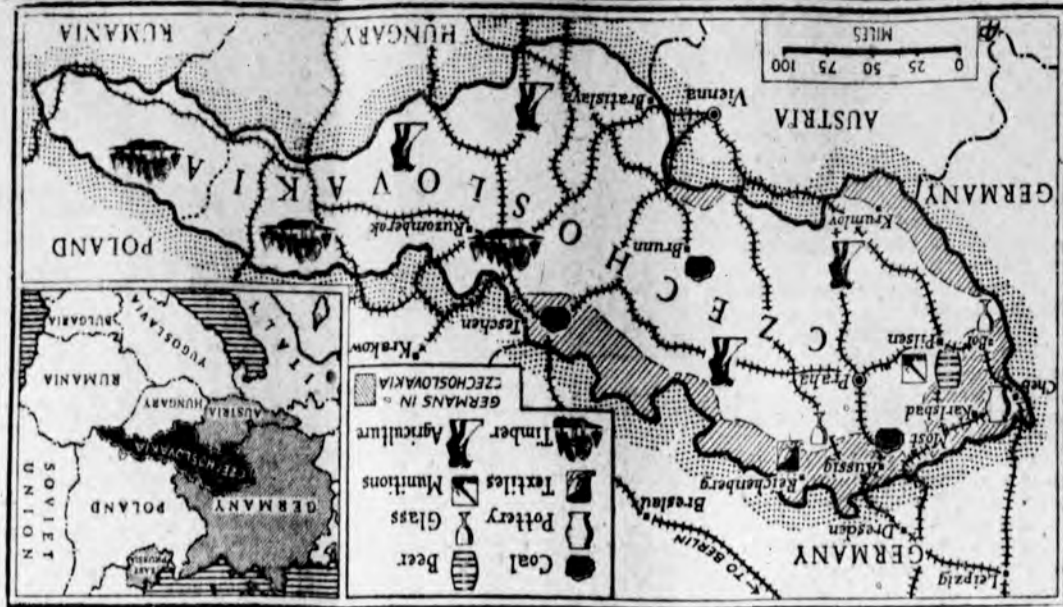

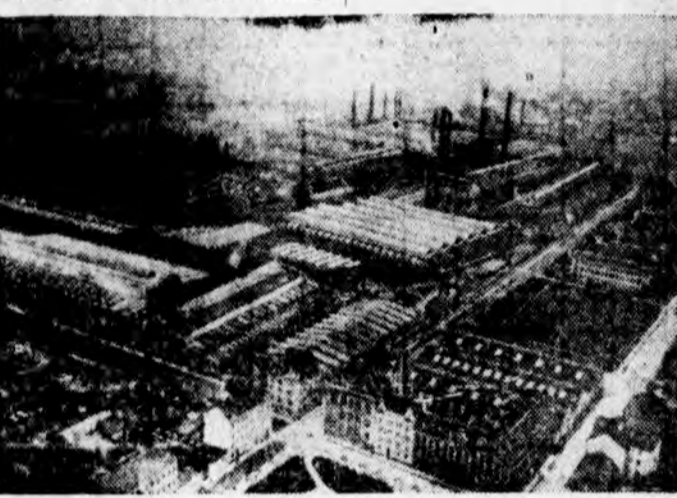

THE ARMY is small—180,000, with 1,000,000 men in reserve—but it is said to be well equipped. Realizing the next war is likely to be against civilians, citizens between the ages of 6 and 30, men and women, boys and girls, have been drilled in what to do in case of air raids, gas attacks and fire.

LET THE TRUTH COME OUT NOW Now that the matter of investigation of the sheriff's office has definitely come into the open in the form of indictments against Sheriff Sam Whitehurst and Deputy Herbert Harris, it is to be hoped that the court will lose no time in hearing the case in order to clarify the situation in this county.

### Boston's Ted Williams Tagged as Second Joe DiMaggio

Sarasota, Fla.—Ted Williams, Boston's young outfielder has yet to feel the sharp scrape of a keen razor and the glowing flush of a warm, wet towel banked about his jaws.

There's a bit of soft fuzzy down on his chin but the 19-year old outfielder from San Diego says he won't be in the market for a shave for some time.

Williams is the kid Pacific coast writers tabbed as a second DiMaggio. Tom Yawkey of the Red Sox unburied a roll of bank notes and a couple of players to outbid other clubs for him.

But Ted is a trifle upset by all this praise. He thinks the scribes poured it on too thick. "I'm just a punk trying to get along," he grins. "I've never even seen DiMaggio play but from all I have read about him, I know I'm not in his class yet."

Ted is a beanpole, 6-foot-3 and 175 pounds. But when he grows up and that lanky frame fills out he's going to be some pumpkin. He is just a year off the sandlots. Ted turned down a scholarship at the University of Southern California for a whirl with San Diego and woke up to find himself in a major-league uniform.

That long trip east was quite a sight-seeing expedition for him. He'd never been east of California before.

He feels he owes a lot to Lefty O'Doul, manager of the Seals. It's this way: Williams was doing quite a bit of bench sitting until O'Doul made an offer for him. Then San Diego suddenly realized he might be a fancy package and poked him into the outfield. If Lefty hadn't popped up with a bid Ted might still be getting bench splinters in his pants.

His biggest thrills last year came when he hit two home runs in a game three times. He was fifth in the league in runs batted in. And he hit 291, being out 25 homers. "I should have hit better, but I've got a lousy disposition and when the jockeys out there started riding me I got discouraged and for awhile just didn't give a darn."

He's a pull ball hitter. "They say I'm a wrist hitter. I take a medium sized cut at the ball and don't try to kill it every time."

He was a pitcher in Hoover high school in San Diego but when he turned pro they took a look at his batting average—439 for three years—and promptly directed him to the outfield.

Williams is afraid the Red Sox have too much outfield talent—Cramer, Chapman and Vossink—for him to break in as a regular this year.

"And if I can't get in games pretty regularly I'd rather they'd ship me to the minors for another season. I guess I could stand some more experience."

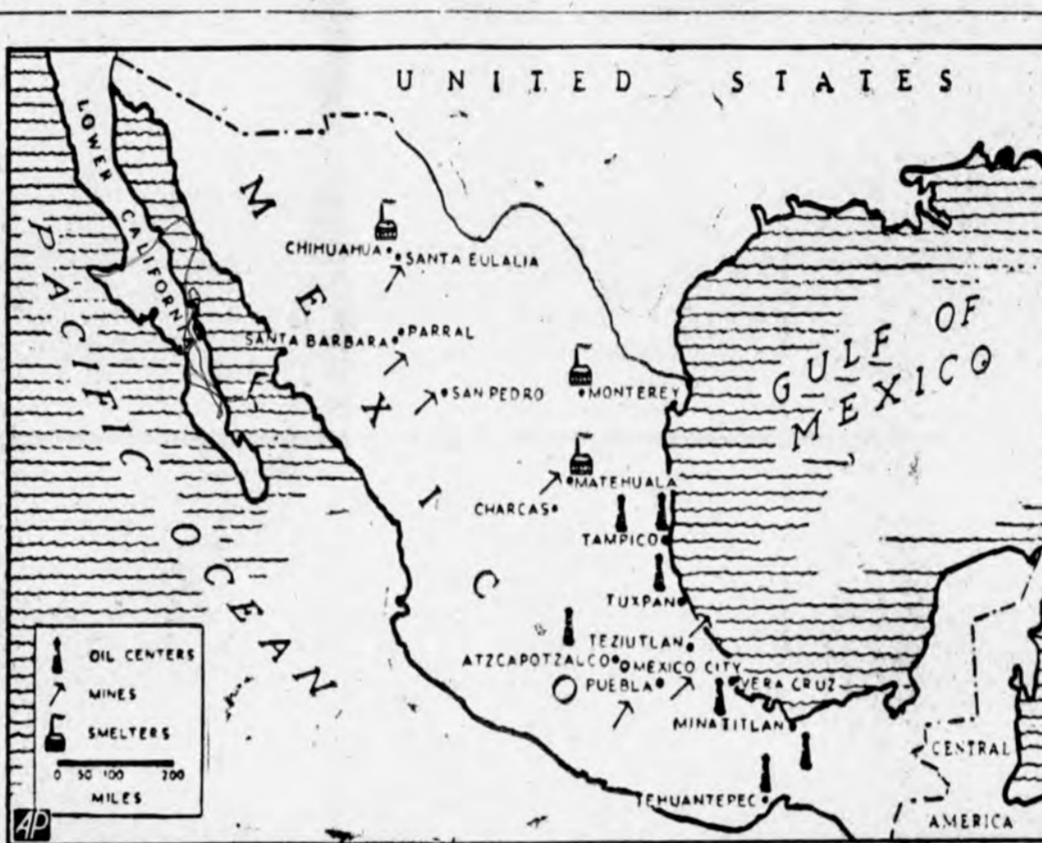
